FOREWORD

These articles were originally who been revised at the request of the En

of India. They present the Indian case. That these articles represent views universally held by Indians is evident from the fact that the editor has received letters from correspondents from all parts of India, all approving, some congratulating, but none dissenting. I am told that they produced quite a stir in the medical circles, so much so that all the issues of the "Servant of India" were sold out and request was made to reprint them in a pamphlet form. It is to meet this demand that the pamphlet is now published.

The topics discussed here have engaged the attention of the public from time to time and have formed the subject of many an official enquiry. The separation of the civil and the military side of the I.M.S.; the unification of the R.A.M.C. and the military side of the I.M.S. into one military service; the organisation of the I.M.D. branch—the Sub-Assistant surgeon, and the military assistant surgeon—into one service by raising their professional standard to that of the civil assistant surgeons; to improve the payer prospects of civil assistant surgeons to make them larger share of the provincial work of the possible fanatical appoint an Indian I.M.S. officer on the head of the passing the formation of an all-India medical association therefore the interests of the medical profession, are

But they are once more presented to the public and the authorities in order to draw attention to the grave state of affairs, which exists in the I.M.S. and the sullen discontent which prevails in the Indian members of the service. As an indication of the state of feeling in the country it, may be mentioned that these articles were referred to the Provincial Medical Unions for expression of opinion. All the unions without a single exception have intimated that they have lost all faith in the good intentions of the Government and that they do not believe in making representations which are destined to be ignored.

With the country in this frame of mind, and the profession being one of skilled and highly specialised labor, composed of highly educated and intelligent men, it does not require much stretch of imagination to conceive of an enterprising young man to rise and organise a successful boycott of the service. The British Medical Association and the I.M.S. men havea lready shown the way in that direction. It is therefore sincerely to be hoped that the Government will adopt a more conciliatory and sympathetic attitude.

With the inauguration of the new era all racial distinctions the service should have vanished. Instead of actless and untimely grant of Overseas allowing ropean members has made matters worse.

Expatriation allowance we find reference [msford despatch in the following terms.]

Para 322:—"It is desirable, and if possible, to avoid the differentiation maintained at present between the rates of pay drawn by European and Indian officials in the same service. We think that the standard scale for all services should be fixed with reference to Indians recruited in India at the rates sufficient to attract the best men available and give them income appropriate to their position. For persons recruited by reason of special qualifications obtained in Europe, an extra allowance should be given to them to compensate for the draw-backs and expenses of expatriation." It is conceivably reasonable to differentiate the scale of pay on the basis of qualifications which are not obtainable in this country. But with an ingenuity worthy of the Indian bureaucracy this has been twisted into domiciliary and colour qualification.

We hope that this hint will not be lost on the Indian leaders to make amends honorable, to their countrymen of the public services, whose interest they have bartered away in their excessive zeal for the Indian Reforms. They should insist that the terms of the despatch should be adhered to. The matter of indigenous systems of medicine was not touched in these discussions as it was not a service question. The public as well as the profession seem to have very nebulous views with regard to these systems. The public mind at present is swayed by that fanatical wave of anti-foreign feeling which unhappily is passing over the country. Its attitude on the subject is therefore reactionary.

The official attitude on the other hand is incomprehensible. On the one hand some provincial Governments officially recognise these systems by allowing the universities to spend public revenues on these systems and granting their alumni the grandiloquent titles of Visharad and Zubda tul-&c. In the legislative chambers on the other hand they adopt an attitude of lofty contempt. It would have been more judicio's if the Government had displayed a more open and less partisan mind, by appointing a small committee composed of one Indian and an European I. M. S. officer to enquire into the condition of these systems. The committee should visit all provinces, the local Governments to nominate one private practitioner, one hakim and one vaid to co-opt with the committee and assist them in local enquiries. In this way the curriculum of their education could be standardised. their defects brought to light and thereby the grain would be separated from the chaff.

In view of the invitation by the Rt. Hon. The Secretary of State for India to European Medical practitioners who must be British subjects of European descent to serve as Medical Officers with Indian troops and the offer to them of more favourable rates of remuneration than are given to Indian members of the Temporary Indian Medical Service, whatever seniority or qualification, I have the honour to request you to forward this letter to the Director of Medical Services requesting him to recommend the revision of remuneration to Indian candidates on the same lines as those offered to the European Medical Practitioners.

In doing so, I beg that the following facts may be given due consideration:—

1. It is a grave injustice to offer preferential terms to a European Medical Practitioner, who might have only just passed out, as compared to the many Indians who have served the Empire in times of crisis, stress and danger and on active service in the field of battle.

- 2. The Indian Medical Service being a Military & in which there is considerable uniformity in the mode of and standard of life of officers, costs one officer more the same a mount as another to maintain the prest dignity of a commission in His Majesty's Army.
- 3. The differences and variations are personal factors and not national or racial.
- 4. The cost of living has gone up in India and the Indian just as much as the European.
- 5. On account of the differences in the conditions of prevate practice in India and in the United Kingdom, the Indian loses more than the European by not settling down as early as possible Parternership, panel practice and practices for purchase are not the rule in India and each doctor has to build up his own practice against enormous difficulties.
