FILARIASIS IN INDIA

INTRODUCTION

Filariasis, commonly known as elephantiasis, is known to be prevalent in India from very ancient times. This disease has been recorded in all the States of India except Jammu & Kashmir, Himachal Pradesh, Punjab and Rajasthan. Nearly 5 crore people live in filarious areas of the country.

The disease leads to the permanent swelling of the legs and of certain other parts of the body, besides causing recurring attacks of fever and inflammation of the lymphatic system. Though the disease does not cause death, it is responsible for a considerable amount of preventable suffering and disability.

Although many forms of animal life are known to have filarial infections of different types, man is known to be the victim of chiefly six types of filarial infections transmitted by various blood-surking insects including mosquitoes. In India only two types of filarial infections are prevalent. They are, Wuchereria bancrofti and Wuchereria malayi and both of them are transmitted by mosquitoes. The possibility of inter-transmission of animal and human filariasis infection is under study.

The only effective measures against the disease known at present are those which are concerned with the control of carrier species of mosquitoes. The National Filaria Control Programme was launched in 1954 for controlling the carrier mosquito and administration of drugs on a mass scale in the filarious areas to reduce the reservoir of infection in human beings.

Scientific study of filariasis may be said to have commenced in 1863, when Demarquay in Paris first demonstrated the microfilariae, the embryos of the filarial worms, in the hydrocele fluid of a patient from Havana.

In 1866, Wucherer found microfilariae in the chylous urine of a Brazilian patient, and in 1872 Lewis in India recorded the microfilariae in the peripheral blood of a man. In 1876-77 the first lot of adult female worms (five in number) were secured from the lesions in the arm by Bancroft in Australia. Lichenstein reported that the microfilariae in a person from Achin, Sumatra was refractory to C. fatigans (the carrier of W. bancrofti) indicating the possibility of its being a new species. Following this, Microfilaria malayi was first reported by Brug in 1927. The adult worms of W. malayi were described by Rao and Maplestone in 1940 from specimens obtained from the former Travancore State.

The study of the transmission of filaria by Manson in Amoy (China) during 1878-79 led to one of the earliest discoveries incriminating an insect as a vector (carrier) of human disease. Two decades later, Ross unravelled the mystery of malaria transmission by mosquitoes.

At first, Manson thought that the fully developed infective larvae escaped into the water at the time the mosquitoes laid their eggs and then men contracted the infection by drinking such water. Low in 1899-1900 discovered that the larvae underwent further development in the mosquito and eventually passed on to man through the skin when the infected insect bites him.

In 1880, Manson also recorded the phenomenon known as "filarial periodicity" or the cyclic appearance and disappearance of the

microfilariae from superficial blood vessels of the infected persons. The microfilariae appeared during nights and disappeared during the day time. This necessitated the obtaining of blood samples for detecting filarial infection only at nights.

Geographical Distribution

The disease is known to be prevalent in various parts of the world. Wuchereria bancrofti has an extensive distribution and occurs practically throughout the tropical countries. It has been found in the western hemisphere as far as Argentina in South America and in the eastern hemisphere from southern Spain to as far south as Queensland, Australia. It is especially prevalent in India and South China extending up to Japan, Indonesia and other Islands in the Pacific where, in some localities, the incidence of the disease is known to be very high. It is reported that filariasis in American Samoa probably causes greater damage than any other disease by its disabling effects and the undermining of the general health which may expose the patient to other infections. Filariasis is common in West and Central Africa and is also prevalent in parts of Arabia.

Wuchereria malayi has been reported from Malaya, East Indies, Sumatra, Borneo, New Guinea, India (especially Kerala State), Indo-China, Ceylon, Thailand, South China and Japan. W. malayi is often associated with elephantiasis of extremities only, while W. bancrofti affects the external genitals also.
