

## SCHHEME FOR INDIA.

### Desirability of organising Educational Kinema Shows:

The power of the kinematograph over the child mind has been proved to be tremendous. A kinema exhibition of specially selected films will give the means of using this power under the right restraint and in the right direction.

### Extent of the use of the Kinema Exhibitions:

If these Exhibitions are organised, they must be used as part of school regular arrangements, and must not be used on rare occasions only. It is proposed to visit each centre of educational activity once every three months with three or four Educational Programmes.

### Films:

Hitherto Educational Films have been produced by business people; but in future educationists must be the guiding force. In the words of Sir James Yoxall "Films, if they are to be thought worth while, must bear directly & specifically upon those subjects and schemes of instruction which are laid down in the educational Code." The films selected will, as far as practicable, fit in with the school curriculum, and be approved by the Educational Department.

### Finance:

It is not possible that the Government will aid a Scheme of this kind in the near future. Unless, therefore, philanthropists come forward from time to time to bear the charges of a free day, a small fee of one anna per pupil will be charged for each exhibition.

### Practical working of the scheme:

The Headmasters of each locality will first meet and consider details of management: e.g. allotting particular hours to different schools, demonstrations to teachers, discipline of boys going to, remaining in, and coming from the Hall.

(A few opinions.)

Sir James Yoxall:-

Films, if they are to be thought worth while, must bear directly and specifically upon those subjects & schemes of instruction which are laid down in the education code, and by the regulations of the educational authorities for teaching in schools. Assuming that a manufacturer of films desires to supply these direct and specific aids to education by means of his films, he must get the latter specially planned and prepared, not merely selected from his large stock of what seems to him to be suitable. And such films will have to be planned and supervised in their execution by people who know what is required in the schools. ---What I will add is that I believe that cinematography has not merely come to stop, but to develop and become a mighty engine of instruction & civilisation.

Dr. Larie C. Stopes:-

The cinema is one of the greatest powers placed in the hands of humanity by scientific invention. Yet it is in the main a power prostituted. Myriads of lives are leached, and to some degree influenced by it daily; yet sociologists, scientists, authors, artists, all who have a serious and beautiful message to give to these myriads are scarcely represented on the films, or represented by travesties. At the same time "Penny Dreadfuls" and sentimental romances have sprung up in thousands of varieties, and are more prolific than ever. ---Why should our community tolerate a state of things which makes it possible for absolute rubbish, if not actually harmful stupidities, to be scattered broadcast up & down the land, & to tie by poverty the hands of those who have truth, wisdom & beauty to impart?

Mr. Ralph Hyams, Editor of "Education":-

For young children the cinematograph could be invaluable as an aid to the Geography, Nature-study, Elementary Science, and possibly other lessons. It would enormously widen their view of the world in which they live, & if properly handled by the teacher, stimulate their imaginations in useful directions.

The Editor of the "Educational Times":-

Of the films at present produced he regards two classes only as suitable for school use :- (1) Films dealing with Natural History, Plant or Animal Life; (2) Views of the Earth's surface or of industrial centres and processes, buildings, railways, harbours, canals, scenery etc. He regards fictitious films produced on stage as unsuitable for school purposes.

Mr. Alfred Percival Graves, M.A. the late W.L.I. of schools and chairman of the Representative Managers of the L.C.C. Elementary Schools. :-

Before the Kinematograph can be incorporated among our teaching apparatus, certain safeguards will have to be adopted; exciting scenes will have to be avoided; the films will have to be prepared by educational experts, they must not be passed too rapidly before the children's eyes; and therefore only a limited number of them should be employed for a single lesson. -- In lessons on nature study and science the children's own powers of observation should not be interfered with by presentations of growth and change in vegetable and animal life, which have not so far as possible, been followed by them. On the other hand such presentations of growth and change may well be used for the purpose of summarising a series of observations or where observation is impossible.
