PROCEEDINGS OF THE GOVERNMENT OF HIS HIGHNESS THE MAHARAJA OF MYSORE.

GENERAL AND REVENUE DEPARTMENTS.

READ-

Report on the working of the Co-operative Societies Regulation in Mysore during the year 1917-18, received with letter No. 3444, dated the 6th November 1918, from the Officiating Registrar of Co-operative Societies in Mysore.

Order No. 6231-80—E. C. 41-18-6, dated 8th January 1919. Recorded.

- 2. The general progress of the Co-operative movement continues to be satisfactory though the number of new societies started during the year was less than in the previous years. From the statement given by the Registrar in paragraph 16 of the report showing a classified list of Societies according to their woking capital and total transactions, it will be seen that there has been a steady increase under all the classes of societies, the largest rise being in the number of societies with a capital below Rs. 500. Out of 1,097 societies existing at the end of the year, 140 were new ones. Of these, 593 or 61% were classified as good as against 401 in the previous year. During the year under review the membership increased by about 9,000 and the working capital and total transactions by nearly Rs. $7\frac{1}{2}$ and $8\frac{1}{2}$ lakhs respectively. There was also increase of nearly Rs. 64,000 in total profits, while the total reserve fund was augmented by about one lakh of rupees. The Officiating Registrar reports that the fall in the number of new societies is due to the fact that greater attention was paid to the consolidation of the working of the existing societies during the year.
- 3. Among the prominent features of the year's administration may be mentioned the following:—
 - (a) The amendment of the Co-operative Societies Regulation of 1905. The rules under the new Regulation are under preparation.
 - (b) The re-organisation of the department by strengthening both the superior staff and the subordinate establishment. Three new posts of additional Assistant Registrars were sanctioned so that by diminishing the territorial jurisdiction of each officer, the duties of inspection and extension of co-operation may be discharged more efficiently. Two of these have been filled up. The remaining appointment is intended specially for the development of industrial and agricultural co-operation and will be filled up when this branch of co-operative work has safficiently expanded. The pay and prospects of the inspectorate and the clerical establishment were also improved.
 - (c) The passing of a new rule under the Regulation limiting the loans admissible to Committee Members of Co-operative Societies to not more than 25 per cent of the total loans outstanding against all members.
 - (d) Development of co-operation in the Malnad areas where the number of societies has been increased from 143 to 173. The bulk of these is of the credit type but attempts are also being made to start co-operative stores.
 - (e) Special encouragement of co-operation among the Depressed Classes.—
 The number of Societies for these classes has increased from 7 to 16 during the year while several of the existing societies have also admitted persons belonging to the Depressed Classes into their membership.

- (f) Expansion of industrial and agricultural co-operation.—The measures necessary for effective co-ordination of the efforts made by the Departments of Agriculture, Industries and Commerce, Co-operation and Economic Conference, in further stimulating this form of co-operation and arranging for the better working of the existing institutions are under consideration.
- (g) Arrangements for investigation on a larger scale into the economic condition of the members of Co-operative Societies.

4. The following statement shows the transactions of the Societies under loans during the year.

The figures in the report are incomplete but even these are sufficient to indicate that the outstandings are heavy in all the districts and that there is need for the adoption of special measures for recovering the arrears and enforcing punctuality in repayment. It is also not clear from the report what proportion of the increase in the total profits may be attributed to prompter recoveries of loans due by members and how much to the increase in total transactions. The Registrar of Co-operative Societies is requested to submit a special report on these outstandings and the measures recommended by him to reduce them.

- 5. Out of the total amount of Rs. 38,08,000 advanced as loans, Rs. 63.2% was for productive purposes, loans for discharging prior debts amounted Rs. 19,08,000 as against Rs. 16,01,000 in the previous year. The percentage of loans granted for miscellaneous purposes, some of which are of an unproductive character, decreased from 7 in the previous year to 4.9 in the year under review.
- 6. The registration of 18 societies was cancelled during the year, the reason assigned in most of the cases being the indifference of the people and unwillingness on their part to start work. This indicates the necessity for bestowing much care in selecting localities for the formation of new societies and the subordinate officers of the Department should be instructed not to encourage the starting of new societies in future without careful enquiry into their prospects of stability.
- 7. It is satisfactory to note that despite the adverse conditions of the money market that continued to prevail during the year, there was an increase of 18% in the amount of deposits attracted by the societies. The total amount of deposits outstanding at the end of the year was thus Rs. 20,63,000. The primary rural societies have as a rule not yet succeeded in attracting deposits except on a very limited scale and are mostly dependent on outside borrowings. The increase of deposits and the reduction of outside borrowing should be kept specially in view in future both by the staff of the Department, the office bearers of societies and others interested in the co-operative movement, and systematic efforts made to inculcate habits of thrift and saving among the rural classes through the medium of co-operative societies by more vigorous propaganda.
- 8. The Registrar estimates that the cheaper credit offered by the Co-operative Societies has resulted in a saving of Rs. 5,20,000 in the shape of interest to the

members of societies during the year. The elaborate investigation into the economic condition of the members of 180 societies conducted during the year has revealed that while the indebtedness of the members has more or less continued to be stationary, their total assets have increased by about Rs. 16 lakhs. The members are stated to have been enabled to pay up nearly half of Rs. 20 lakhs they owed to private money lenders. Though the investigation cannot be of said to be of an exhaustive character it has yet shown that the co-operative movement has considerably improved the economic condition of the members during the past ten years. In this connection Government regret to observe that the Maland Improvement Committee have not yet been able to publish the results of the enquiry into the agricultural indebtedness of the Malnad population conducted in two select hoblis of the Sagar Taluk last year. The Registrar is requested to take action at once in consultation with the Malnad Committee to publish the results before the end of March next.

- 9. The work of the Central Financing Institutions continued to expand during the year. The question of amalgamating the Bangalore Central and the Mysore Provincial Co-operative Banks and bringing into existence an apex Bank for the whole State is still under consideration. Government agree with the Registrar in his view about the limited scope of work possible for the Federal Banking Unions but as suggested by them in their last year's review it should be possible to convert these Unions into District Banks and in this manner make them more effective financing and supervising bodies and await his further recommendations in this respect.
- The number of non-agricultural societies increased by 8 during the year, the total number at the end being 152. Of these, 108 were purely credit institutions. The Stores Societies have done very useful work during the year in urban areas chiefly in meeting the difficulties due to high prices and deficient supply of food stuffs and piece-goods. There were 43 special types of productive societies, agricultral and industrial. The work of the Weavers' Societies shows improvement, the value of raw materials purchased and goods manufactured and sold during the year being Rs. 2,90,000 and Rs. 3,06,000, respectively, as against Rs. 1,47,000 and Rs. 1,36,000 in the year previous. The Government conisder that the scope for improving the economic condition of the weaver class is still vast. They have recently sanctioned a special loan of Rs. 50,000 for the Weavers' Co-operative Society in Bangalore to enable the weavers in the Bangalore City to tide over the present difficulties when the market for woven goods has lost its equillibrium. On the successful working of the scheme in the Bangalore City will largely depend the course of action which may in future be adopted in helping the weavers in other parts of the State. The Gudigars' Society and the Ivory Inlay Workers' Society are two new departures in societies for productive purposes and their future development will be watched with interest. one Lift Irrigation Society at Yelladabagi is working while the other at Kannaikanahalli has confined itself to credit operations owing to the difficulty of obtaining the requisite machinery. The Jaggery Manufacturing and Rice Hulling Societies are reported to be still in the experimental stage, while in a few cases societins newly formed with these oblects have not been able to start work for want of machinery. Some of these societies have been in existence for nearly five years. They should no longer be treated as mere experiments and with the combined efforts of the officers of the Co-operative and Industries and Commerce Departments, they should be placed at once in effective working order so that they may play a real part in stimulating agricultural and industrial development in rural areas.
- 11. There has been a noticeable tendency towards an increase in the number of suits filed in recent years. This is not satisfactory from the co-operative standpoint as recourse to such measures should be very rare. The Managing Committees of socities should be made clearly to understand that the efficiency of a society is in direct proportion to the ease with which obligations are met and that special care should be exercised to see that the amounts given to each individual do not exceed the limits of his credit. The number of suits pending disposal for more than six months and one year is large, being 140 and 112 respectively. The Registrar's recommendations to remedy this state of affairs are under consideration. The Registrar should take early action in communication with the Deputy Commissioners of Districts regarding the large number of decrees pending execution.

- 12. The audit work of the societies was as usual mostly done by official agency. The central financing institutions, viz., the two Central Banks at Bangalore and several of the Unions were able to audit the accounts of 213 societies affiliated to them. Separate orders have been passed on the recommendation of the Registrar about deputing some of the Senior Co-operative Inspectors solely for audit work.
- 13. The annual Provincial Co-operative Conference was held in Mysore during the Dasara Season, 1917, and 8 District and 70 Taluk Conferences were held in connection with the District and Taluk Conferences. An examination in Co-operative subjects was instituted in connection with the Local Service Examinations.
- 14. Government regret to observe that the bulletin on co-operation has ceased to be published. Though co-operation forms one of the important subjects dealt with in the Mysore Economic Journal and the Arthasadhaka Patrike, Government consider that a separate vernacular Journal exclusively devoted to popularise the movement is very desirable and they trust that the Registrar will, in consultation with the leading persons interested in the movement, take early action to revive the bulletin and to make it more popular and useful.
- 15. The number of days on which the Registrar (Mr. Chandy) and Officiating Registrar (Mr. R. Ranga Rao) were on tour during the year was only 111 which is scarcely satisfactory. The Officiating Registrar toured for only 21 days as Deputy Registrar, which is also unsatisfactory. The insufficient touring of this officer was commented upon in the last year's review by Government and it is hoped that there will be no room for complaint in future on this score. The number of societies inspected too, was very few being 74 and of these only 36 were rural societies. The movement requires constant supervision over subordinate staff and guidance and propagandist work—requiring frequent tours in rural parts and districts.
- 16. In conclusion, the Government desire to thank the large body of private individuals who have continued to work and help in promoting the cause of cooperation in the State. The Officiating Registrar (Mr. R. Ranga Rao) also deserves to be congratulated on the clear and concise report he has submitted, which shows that the working of the department during the year was fairly satisfactory. With the re-organisation and strengthening of the Department now sanctioned and with the increased co-operation of the non-official public, Government look forward to a much wider expansion of the movement in the coming year, more especially in the field of agricultural and industrial co-operation, in regard to which the Officiating Registrar is requested to devote particular attention.

SIR,

I have the honor to submit herewith the annual report on the working of the Co-operative Societies in Mysore during the year 1917-18.

I.—ADMINISTRATION AND TOURS.

Administration.—The office of Registrar changed hands several times during the first half of the year. Mr. M. A. Narayan Iyengar held the office from the 1st to the 3rd July 1917, I held it from the 3rd to the 9th July, and Mr. K. Chandy from the 9th July to the 22nd December. On Mr. Chandy's promotion as Excise Commissioner in Mysore, I was appointed Officiating Registrar and have been in charge of the office from the 22nd December 1917.

The post of Deputy Registrar which was held by me till the 22nd December 1917 was not filled up after my appointment as officiating Registrar. Mr. P. A. Krishnaswami Iyer continued to be Personal Assistant to the Registrar throughout the year.

The staff of the Department continued to be governed by Government Proceedings No. 896-945—B. 56-12-7, dated 31st October 1914. As against 30 Inspectors and 21 Clerks at the beginning of the year, there were 33 Inspectors and 23 Clerks at the end. Seventeen Inspectors and fifteen Clerks were permanent and the rest temporary.

2. As a result of the representations made by the Registrar, the Government were pleased to sanction a re-organization of the Department just towards the end of the year in their order No. 12180-6—I. and C. 66-17-53, dated the 18th June 1918. According to that order, the superior staff of the Department will consist of a Registrar and three Assistant Registrars. For the present only two Assistant Registrars will be appointed and placed in subordinate charge of the societies in the State. The Registrar, assisted by the Personal Assistant, will exercise general supervision over the work of the Assistant Registrars and will also be in direct charge of the development of Agricultural and Industrial Co-operation in the State. When the work under this head develops sufficiently, a third Assistant Registrar will be entertained, and the appointment of Personal Assistant will cease.

The Subordinate Establishment has also been suitably revised. A staff of 34 Inspectors and 25 Clerks has been sanctioned and the Registrar has been empowered to entertain an Inspector for every addition of 40, and a Clerk for every addition of

80, societies. The pay of the Inspectors now ranges from Rs. 50 to Rs. 150 per mensem and that of the Clerks from Rs. 30 to Rs. 80. It is hoped that, with these improved prospects, it will be possible to attract a superior set of men for work in the Co-operative Department.

- 3. Owing to the increase in the number of societies, the charge of the Inspectors had to be revised during the year. As against 28 Circles at its beginning, there were 31 at its close. These Circles consist of 30 to 40 societies each situated in two or three adjoining taluks. A list of the Circles with the names of the Inspectors in charge of them is given in Appendix A.
- 4. There were 56 Honorary Supervisors working at the beginning of the year. Eight of them were unable to devote sufficient attention to their honorary work and were therefore permitted to retire. One died and 4 new men were appointed. There were thus 51 Honorary Supervisors working at the close of the year. A list is given in Appendix B showing the names and the charges of the Honorary Supervisors.
- 5. The work of the Honorary Supervisors is confined mainly to organization of societies. They are occasionally called upon to help the Inspectors in the work of audit. The public spirited and unselfish labours of these gentlemen deserve commendation, but one could wish that their work was more systematic and energetic.
- 6. Tours.—The frequent changes in the office of Registrar during the first half, and the absence of an officer in place of the Deputy Registrar during the second half, of the year interrupted the work of the Department to some extent, especially in respect of touring as they necessitated my stay at head quarters. Mr. Chandy as Registrar toured for 56 days. I was on tour for 21 days as Deputy Registrar and 55 days as Registrar. The number of societies inspected by us was 74 of which 36 were rural and 38 urban. A map showing the societies visited by us is enclosed as desired by the Government.

The Inspectors toured on the average for 20 days and the Honorary Supervisors for 15 days in the month.

7. Cost of administration.—The cost incurred by the Government on the Cooperative Department, including allowances to the extent of Rs. 8,400 paid to the Honorary Supervisors, was Rs. 84,000 during the year as against Rs. 81,230 last year. This is '37 per cent of the total transactions of the societies, the same as for last year. The cost per society is Rs. 76'6 as against Rs. 83'4 last year. The societies themselves spent a sum of Rs. 1,34,243 on their establishment and contingencies besides about Rs. 30,000 on bonuses to office-bearers and auditors. This comes to about '73 per cent of the total transactions.

One thousand and thirty four societies were credit institutions, forty-six were societies for purchase and sale, two were productive societies, twelve undertook sale in addition to production and three were miscellaneous institutions.

10. The net increase in the number of societies was 123 which was the result of the registration of 141 and the cancellation of the registration of 18 societies.

^{11.} The progress achieved during the year was somewhat below that of previous years. This was because the attention of the Department was concentrated, in accordance with orders of Government expressed in their reviews on the

annual reports of the last 2 years, more on the consolidation of the working of the existing societies than on increasing the number of societies. A rough examination was made of all societies and the ones found backward were marked out for special attention. The measures adopted for improving their working were various. Among the more important of them may be mentioned the formation of satisfactory boards of management, the recovery of overdue loans, the expulsion of hopelessly unsatisfactory members, the filing of suits against confirmed defaulters and strenuous attempts to teach Committees of Management their duties, and general bodies their rights with respect to the working of their societies. It is too early to say how for these measures have been successful. I hope to be able to report the results next year. I may state, however, that several societies which were in a moribund condition revived their working, set about collecting capital and overdue loans, and generally made a considerable improvement in their working.

Of the 1,097 societies at the end of the year about 140 were new institutions and were engaged in collecting capital and making preliminary arrangements to start work. Of the remaining 957 societies, 593 or 618 per cent were classified as good, 240 or 25 per cent as fair and 124 or 129 per cent as bad as against 401 societies considered as good, 327 fair and 132 bad during the previous year. Of the 593 considered good 101 were very good as against 76 last year.

The great European War was another factor which prevented rapid expansion of the movement. It also, to some extent, hampered the working of the existing societies. With respect to credit societies the amount of deposits attracted by them, though in excess of that attracted last year, was still short of what might have been attracted but for the tightness of the money market. With respect to weavers societies, the very high prices of yarn and dyes and the reduced demand for cloths caused by abnormal increase in their prices brought the work of some of them to a stand-still. Several of the societies formed for such purposes as rice-hulling, jaggory-making, lift-irrigation etc., were unable to start work on account of the difficulty of getting the necessary machinery and of the enormous increase in their prices even if they were available.

The following iparagraphs contain brief explanations of some of the more important items of information contained in the foregoing statements.

Co-operation in Malnad tracts.—The spread of the movement in the malnad tracts of the State which are most in need of its benefits is progressing. The number of societies in these tracts increased from 143 to 173. The increase is entirely in the number of credit institutions. The suggestion has once or twice been made that Co-operative Stores should be developed largely in the malnad. But I fear that there are several difficulties in the way of such development. stores movement has as yet made but little progress in the State. Even in such arge places as Bangalore, Mysore and Kolar Gold Fields, where the existence of a large number of individuals with more or less standard requirements, afford favourable conditions, Co-operative Stores have not so far been very successful. Conditions are far less favourable in the malnad where people live in scattered dwellings and the climate makes the stocking of commodities rather difficult. In spite of these difficulties, however, some attempts are being made especially in places like Tirthahalli and its neighbourhood to start Co-operative Stores. Their work will be watched and, if successful, attempts will be made in other parts to develop them.

The large indebtedness of agricultural population in the malnad and the means of relieving it is another point upon which Government have asked this Department to concentrate its attention. A survey of indebtedness in two select hoblies in the Sagar Taluk has been completed but the Malnad Committee to whom the results were made over have not yet published their report. Suitable action will be taken after the publication of a report in the matter.

- 19. Membership.—The total number of members at the end of 1917-18 was 81,168 as against 74,906 at the end of the previous year. The Bangalore District continued to furnish the largest number of members, viz., 18,275. Next in order came Tumkur with 15,850, Mysore with 12,122, Kolar with 10,245, Hassan with 8,054, Shimoga with 7,665 while Chitaldrug and Kadur Districts furnished 5,264 and 3,693 respectively.
- 20. Receipts and disbursements.—The total receipts of all the Societies amounted to Rs. 1,12,19,060 as against Rs. 1,09,08,358 of last year showing an increase of 2'8 per cent. The total expenditure was Rs. 1,11,70,275 as against Rs. 1,05,93,882 or an increase of 5'4 per cent. The total transactions amounted to Rs. 2,23,89,334 as against Rs. 2,15,02,190 or an increase of 4'1 per cent.
- 21. Working capital.—The total working capital of all the Societies during the year was Rs. 65,04,642 as against Rs. 57,64, 024 last year. The average working capital per member increased from Rs. 769 to 801 during the year. The Bangalore District contributed the largest portion of the working capital viz., Rs. 27,68, 107. Next came Tumkur District with Rs. 10,47,403. The Mysore and Kolar Districts contributed Rs. 8,61,179 and Rs. 6,43,905 and the Hassan, Shimoga, Chitaldrug and Kadur Districts Rs. 3,86,418, Rs. 3,45,096, Rs. 2,37,692 and Rs. 2,14,827 respectively.
- 22. Deposits.—The total amount of deposits outstanding at the end of the year was Rs. 20.63 lakhs as against 17.39 lakhs which amounts to an increase of 18 per cent. The Societies in the Bangalore District attracted the bulk of these deposits, especially the Bangalore Central Bank which had a deposit of Rs. 6,04,134, the Mysore Provincial Co-operative Bank which had a deposit of Rs. 2,56,749, the Bangalore City Society which had a deposit of Rs. 1,31,532, and the Bangalore City Co-operative Bank which had a deposit of Rs. 1,04,442. The amount out-standing in this district was Rs. 13,04,281 as against Rs. 10,87,632 in the previous year. The following statement shows the amount of deposits outstanding in each district.

It will be seen that excepting in the Kadur District, there is an increase in the amount of deposits during the year in all the other districts. In view of the tightness of the money market and the difficulty of attracting deposits, this result may be considered satisfactory. The deposits attracted by central societies was Rs. 10,43,712, by non-agricultural societies Rs. 7,92,397 of which Rs. 5,81,606 was from members and Rs. 2,10,791 from non-members; and by agricultural societies Rs. 2,27,350 of which Rs. 1,31,503 was from members and Rs. 95,847 from non-members.

The average deposit per member works out at Rs. 19.3 in a non-agricultural society as against Rs. 14.3, and Rs. 2.6 in an agricultural society as against Rs. 2.3 in the previous year. The average deposit for the whole population of the State is Rs. 36 per head. These figures show the enormous scope that exists for progress in this direction.

- 23. Profits.—The total profits realized by all the Co-operative Societies during the year was Rs. 6,63,492 as against Rs. 5,47,747 of the year previous. The net profit amounted to Rs. 3,26,476 as against Rs. 2,63,205.
- 24. Amount of loans.—The total loans issued by all the Co-operative Societies during the year amounted to Rs. 60,19,977 in 90,679 cases as against Rs. 58,54,884 in 98,408 cases in the previous year showing an increase of 2'8 per cent.
- 25. Kinds of securities on which loans were granted.—Loans granted on mortgage of immovable property amounted to Rs. 22,47,278 in 13,546 cases as against Rs. 13,00,783 in 11,655 cases in the previous year. The amount of loans granted solely on the security of the honesty and character of the members amounted to Rs. 12,07,959 in 39,171 cases as against Rs. 12,15,716 in 35,529 cases during the previous year. It is a good sign that the number of cases in which such loans are granted is increasing year by year. Loans granted to members up to a certain proportion of their share-capital aggregated Rs. 13,68,282 in 22,932 cases as against Rs. 15,94,856 in 36,404 cases in the previous year. In other words, a sum of Rs. 13,68,282 out of a total share capital of Rs. 29,31,567 or 46.6 per cent was taken out by members as loans as against 63.3 in the previous year. This reduction is satisfactory and attempts are being made to dissuade societies from granting loans on the security of shares. Loans granted on the joint and several responsibility of the borrower and one or more sureties amounted to Rs. 10,10,433 in 13,325 cases as against Rs. 11,58,616 in 13,922 cases. The loans granted on the pledge of movable property amounted to Rs. 1,86,024 in 1,705 cases.
- 26. Purposes of loans.—The total amount of loans granted during the year for productive purposes was Rs. 38,08,806 or 63.2 per cent of the total loans as against Rs. 33,41,653 or 57 per cent in the previous year. Of this amount a sum of Rs. 3,10,979 was given for permanent improvement of land; Rs. 2,05,817 for cultivation expenses; Rs. 1,72,793 for purchase of cattle Rs. 65,277 for purchase of raw materials of industry; Rs. 3,34,500 for building, buying, or repairing houses; Rs. 3,83,463 for purchase of land and Rs. 12,14,811 for purposes of trade. A sum of Rs. 89,592 was given for payment of kandayam due to Government and Rs. 10,31,571 for purchase of food and other necessaries of life.

Loans granted for discharging prior debts amounted to Rs. 19,08,709 as against Rs. 16,01,170 of last year, showing an increase of 19.2 per cent.

The total amount of loans granted for miscellaneous purposes was Rs. 3,02,461 as against Rs. 3,76,910 of last year and this forms about 4.9 per cent of the total loans issued during the year as against 7 per cent during the previous year. Out of the sum of Rs. 3,02,461 a sum of Rs. 1,37,496 was given for marriage purposes and Rs. 1,64,965 for other purposes.

It is satisfactory to note that the amount of loans granted for productive purposes bore to those granted for other purposes a larger proportion than during

any previous period.

27. Rate of interest.—The average rates of interest charged by Co-operative Societies on loans granted to individual members underwent no change during the year. They were 9 per cent on mortgage loans, 10½ per cent on loans on personal security and 12 per cent on short loans, otherwise called 'hand-loans,' which are granted for periods not exceeding a month. The market rate ranges from 12 to 25 per cent according to the nature of the security offered and the conditions under which the amount is borrowed. The cheaper credit afforded by

the Co-operative Societies thus resulted in a saving of Rs. 5,20,000 as against Rs. 4,35,000 in the previous year in the shape of interest saved by the members of Co-operative Societies.

28. Investigation of the economic condition of the members of Co-operative Societies.—A rough survey of about 50 Co-operative Societies was made last year to ascertain how far rural credit societies had improved the economic condition of their members. The results, as given in the Report for 1916-17, were that the indebtedness of the members had not decreased, that the grip of the sowcar on the raiyat had not been appreciably relaxed, and that, beyond conferring some little benefits, Co-operative Societies had not materially improved the economic condition of their members.

A similar survey was conducted during the year under report on a larger and, I think, more accurate scale. The number of societies examined was 180, the operations of which extended over 700 to 750 villages with about 1,00,000 houses. The total population of these villages was 5,00,000 of whom 13,200 were members. of Co-operative Societies. Of these, 5,000 members had no debts of any kind either at the time they became members of Co-operative Societies or since, and they were left out of the investigation. The remaining 8,200 members had a total indebtedness, at the time they joined the societies, of Rs. 20,21,400 and their total assets amounted to Rs. 91,32,000. The total indebtedness of these members, at the time of the investigation, was Rs. 21,97,000 of which Rs. 10,50,000 was due to their societies and Rs. 11,47,000 to money-lenders, and their total assets amounted to Rs. 1,07,13,000. It will be seen from these figures that while the amount of the indebtedness of the persons examined remained practically the same, the conditions attaching to that indebtedness altered materially for the better. Out of the twenty lacs and odd due to money-lenders, nearly half was paid up and in place of the high rate of interest and onerous conditions to which that debt was subject, a reasonable rate of interest and easy conditions of repayment were The men were also put in possession of the means of carrying on their agricultural operations and they have actually increased their assets from 91 lacs and odd to 107 lacs and odd or by about 16 lacs. It is quite true that much more is possible and necessary, but these results are something. It should be remembered, too, that the investigation related to 180 out of a total of 1,097 societies and 8,200 out of a total of 81,168 members. When the investigation is completed, I venture to think that Co-operative Societies will be found to have materially modified the economic condition of the members.

III. WORKING OF SOCIETIES.

29. Central Societies.—The Bangalore Central Co-operative Bank and the Mysore Provincial Co-operative Bank continued to be the two principal central institutions for financing the Co-operative Societies in the State. The desirability of these two institutions amalgamating with each other has been pointed out to them and the matter is under consideration.

The Bangalore Central Co-operative Bank, Limited.—The membership of this Bank increased from 286 individuals and 118 Co-operative Societies to 371 individuals and 132 society members, the share-capital from Rs. 1,08,774 to Rs. 1,60,678 and deposits attracted from Rs. 5,03,454 to Rs. 6,31,501. For several reasons, the demand made upon it by societies for loans was considerably less than during the previous years and the Bank had therefore to invest a large part of its funds on loans to individual members. It accordingly granted loans to the extent of Rs. 2,39,277 to individuals and Rs. 99,356 to Co-operative Societies. The total amount outstanding against individual and society members at the close of the year was Rs. 3,01,408 and Rs. 4,53,199 respectively. The net profits of the Bank rose from Rs. 19,179 to Rs. 26,653 and its reserve fund from Rs. 17,377 to Rs. 24,330. A major portion of the reserve fund has been invested in war loan bonds. Towards the close of the year, the Bank applied for and obtained the services of one of the Inspectors of the Department for supervising affiliated societies and investigating loan applications from them. The management of the Bank continued to be very efficient. Lokahithotsuka Mr. D. Appu Rao, Secretary of the Bank, inspected 10 affiliated societies during the year.

The Mysore Provincial Co-operative Bank, Limited.—At the close of the 'year under report, the membership of this Bank was 676 individuals and 456 societies as against 631 individuals and 436 societies in the previous year, its share capital Rs. 1,25,234 as against Rs. 1,01,809 and the deposits attracted Rs. 2,56,749 as against Rs. 2,37,402. It issued loans to Co-operative Societies to the extent of Rs. 70,000. Its reserve fund amounted to Rs. 3,061. One of the Inspectors of Co-operative Societies whose services have been lent to this institution is its Assistant Secretary and he supervises and inspects the affiliated societies and investigates applications for loans from them. The total amount of loans outstanding against the societies affiliated to this Bank amounted to Rs. 4,10,098. The net profits of the Bank during the year was Rs. 14,243 as against Rs. 8,455 in the previous year. The Assistant Secretary of the Bank inspected 23 affiliated societies during the year.

30. District Central Banks.—The number of District Central Banks increased from one to two during the year, the addition being the Shimoga District Central Bank.

The Mysore District Central Bank had a membership of 97 individuals and 19 Co-operative Societies, a share capital of Rs. 40,035 and deposits outstanding to the extent of Rs. 68,637 and a reserve fund of Rs. 2,425. It granted loans to the extent of Rs. 20,125 to individuals and Rs. 22,160 to Co-operative Societies as against Rs. 22,870 to individuals and Rs. 16,400 to Co-operative Societies in the previous year. It inspected 5 of its affiliated Co-operative Societies during the year.

The Shimoga District Central Bank was registered in the latter part of the year under report and was engaged in collecting capital.

31. Federal Banking Unions.—The number of Federal Banking Unions remained the same as in the previous year, viz., 15. They had a membership of 367 individuals and 209 Co-operative Societies and their share capital amounted to Rs. 19,667. The deposits held by them from individuals and societies amounted to Rs. 2,06,739 and the loans granted by them during the year to Rs. 56,174. The total amount outstanding from the societies affiliated to them was Rs. 2,19,693. They inspected about 180 societies affiliated to them.

In the review on the Administration Report of the year 1916-17, the Government observed that sufficient attention was not being paid to developing the work of Federal Banking Unions, that such institutions were doing good work elsewhere and that it was possible to make them effective financing and supervising bodies. It is doubtful, however, if in Mysore institutions like our Federal Banking Unions which confine their operations to a single taluk can become really effective financing bodies. On the one hand they do not possess the large area of operations available to institutions like the larger central institutions in Bangalore. On the other, they do not possess the close touch with their clientele which primary societies maintain with their members. For these reasons the attraction of funds is necessarily a difficult matter for these institutions. The object could be considerably facilitated if, as the Government suggest, these Unions are converted into District Banks.

But as regards supervision, the Unions possess undoubted advantages over larger institutions. That our existing Federal Banks have not done more in this direction is due mainly to the fact that it is difficult for them to procure the services of a competent Supervisor for the comparatively small remuneration that they are in a position to pay. Here again, some improvement could be effected if by widening the sphere of the institutions, their custom, and consequently their profits, could be increased.

Altogether therefore it appears to me that the existing Federal Banking Unions can usefully be converted into District Banks and attempts will be made to convert the more promising of the existing Federal Banking Unions into District Banks.

- 32 Agricultural and Non-Agricultural Societies.—The bulk of the agricultural and non-agricultural Societies are credit institutions for promoting thrift and self-help and for providing capital to members at cheap rates of interest.
- 33. Agricultural Societies.—There are 926 agricultural societies i.e., those having agriculturists predominating in their membership, at the end of the year as against 812 in the previous year. Their membership increased from 45,021

at the beginning of the year to 48,836 at the end and the working capital from Rs. 22,70,636 to Rs. 24,80,062. Of the 926 agricultural societies, 907 are credit institutions. The majority of these are based on unlimited liability with a system of shares of the value of Rs. 5 to 10 each collected in instalments of annas four to eight. Dividends ranging from 6½ to 7½ per cent are paid on these shares. Agricultural Societies other than for credit are dealt with separately below.

- 34. Non-agricultural Societies.—The number of non-agricultural societies increased from 144 at the beginning of the year to 152 at the end. Of these the number of credit institutions remained the same as in the previous year viz., 108. The majority of these are of the limited liability type having shares of the value of Rs. 5 to Rs. 50 payable in monthly instalments of annas 8 to Rs. 2.
- 35. Stores Societies.—The number of stores Societies increased from 21 to 27 during the year. The number of members increased from 5,672 to 7,860. The value of articles purchased during the year amounted to Rs. 1.94 lakhs and the value of articles sold to Rs. 2.95 lakhs as against 2.21 and 2.17 lakhs in the previous year. Many of these stores are institutions which also do banking work. During the present season of high prices, several of the Stores Societies in Bangalore and elsewhere arranged to stock ragi, kerosene oil and fuel and sell them to the public at cost price.

It has been stated in para 18 above that the stores movement has not made as much progress in Mysore as might be expected. In the earlier stages of co-operative development, most of the stores did little or no work. Of late, however, they are getting to be popular and useful. The present period of abnormally high prices of food-stuffs and other articles of life have strikingly demonstrated to the public the advantages of Co-operative Stores and a few new stores have accordingly come into existence. It is intended to take advantage of this favourable change in the attitude of the public and develop the stores side of co-operative work in Mysore.

36. Special types of agricultural and non-agricultural societies.—The number of these Societies decreased by one and stood at 43 at the end of the year. The purposes served by these Societies are given below:—

37. The Weaver Societies had a membership of about 1,500 and a working capital of Rs. 82,000. They purchased yarn and goods to the extent of Rs. 2.90 lakhs and sold goods to the extent of Rs. 3.06 lakhs on behalf of the members during the year as against Rs. 1.47 lakhs and Rs. 1.36 lakhs respectively in the previous year.

The scope for applying co-operative principles and methods to weavers is vast in Mysore. Weaving forms one of the most important industries in the State and a large proportion of population is engaged in it. But the ignorance, illiteracy, and the backwardness of their general condition have frustrated all the attempts that have so far been made to bring them within the co-operative fold. In view, however, of the importance of improving the weaving industry, it is considered that every effort which at all contains a promise of success should be made to develop co-operation among weavers.

During the year under report it was decided that groups of weavers living in a compact neighbourhood should be taken up, and Societies started not merely for financing them but also for supplying them with yarn, looms, dyes and other materials required by them in their industry, and for finding a sale for the articles made by them. The result of this line of work will be watched and if, as it is hoped, it is found successful the scheme will be tried on a larger scale so as to bring under its operation as many weavers in the State as possible.

38. Jaggory manufacturing and rice-hulling societies.—There were 10 Societies of this kind working at the beginning of the year. No new societies were registered. Only three Societies, viz., the Bannur Rice-hulling Society, the Sabbenahalli Jaggory Society and the Sakrepatna Jaggory Society worked part of the year. The Channarayapatna Rice-hulling Society is still putting up its plant. The other Societies have shown no signs of activity.

The working of these societies is still in an experimental stage. Three Societies have been reported above as having been at work during the year under report. Two of them were working during the previous year but the conditions under which they carried on their work were such as were not likely to produce satisfactory or conclusive results. This matter however will form the subject of a separate report to Government.

Yelladabagi continued to work satisfactorily. The loan of Rs. 3,000 due by the society to the Industries Department on account of the machinery bought under hire purchase system has been fully repaid by the Society. The Kannaikanhalli lift-irrigation society has not collected the earnest money required for purchasing the machinery and desires to postpone its work till after the war. In the meanwhile, it proposes to do ordinary credit work.

An investigation was made during the year into the possibility of starting lift-irrigation societies on the banks of the Tungabhadra and the Arkavati. The Agricultural and the Industrial Departments are also investigating the possibility of lift-irrigation in the Tungabhadra valley and necessary action will be taken after their investigation is completed.

- 40. The Lacquerware Society at Channapatna continued to do good work during the year.
- 41. The Gudigars Society at Sagar which was started for the benefit of the sandalwood carvers is doing good work. It has a membership of 25 and a share capital of Rs. 124. A loan of Rs. 300 has been sanctioned to it out of State Funds and the Society is being supplied with sandalwood and other raw materials required by it through the Forest Department. The sale of the articles made by it is being effected through the kind assistance of the Director of Industries. The arrangement promises to be a success and it is proposed to extend it to the Gudigar's Society at Sorab and to the Ivory Inlayer's Society at Mysore.
- 42. Societies for depressed classes.—The number of Societies for depressed classes increased from 7 to 16 during the year and several of the existing credit societies admitted persons belonging to the depressed classes into their membership and extended their benefits to them.
- 43. The Government have observed in their review of last year's report that no special efforts were made by the Department to develop agricultural and industrial co-operation in the State. I beg to point out however that it was not for lack of effort but for the difficulties which beset such development that rapid progress in this direction has not been made. In a note which I have separately submitted I have suggested a co-ordination of the efforts of the Department of Agriculture, Department of Industries and Commerce, the Economic Conference and of this Department. If the main lines of action outlined therein are approved by Government definite action will be taken in the matter. In the meantime Societies for the supply of seed, of manure and of implements, and societies for artizans of different kinds are being started where conditions appear promising.
- 44. A brief account of the working of the Co-operative Societies in the several districts is given below:—

A. BANGALORE DISTRICT.

The number of societies in the district increased from 198 to 212. Of these 2 were Central Banks, 2 Federal Banking Unions, 4 Weavers' Societies, 2 Stores Societies and 5 stores combined with credit, 2 House-building Societies, 1 a Lacquerware Society, 1 a Sericulturists' Society, 1 a Jewellers' Society, 3 Grain Banks and the rest credit institutions.

The membership of all the societies in the district increased from 16,485 to 18,275, share-capital from Rs. 7,17,320 to Rs. 8,97,616 and total working capital from Rs. 23,80,071 to Rs. 27,68,107.

The deposits attracted by the societies during the year amounted to Rs. 16,87,611 and the total amount of deposits held at the close of the year was Rs. 13,04,281 as against Rs. 10,87,632 in the previous year.

Loans amounting to Rs. 19,28,937 were issued to members in 19,994 cases and repayments amounted to Rs. 15,71,099. The total loans outstanding against the members at the close of the year was Rs. 26,30,220.

The total receipts of all the societies in the district amounted to Rs. 48,24,599, their total transactions to Rs. 94,01,517, their net profits to Rs. 1,10,986 and their reserve fund to Rs. 1,05,028.

An account of the working of the two Central Banks in the District is already given in para 29 above.

The Nelamangala and the Magadi Federal Banking Unions in the district did not show any appreciable progress during the year.

Non-Credit Societies.

Stores Societies.—The 6 stores societies in the District sold food stuffs clothing and other house-hold articles to the extent of Rs. 2,47, 760 as against Rs. 1,86,026 in the previous year and realized a net profit of Rs. 17,049. One more such society was registered towards the end of the year, viz., the Closepet Stores.

House-building Societies.—The two building co-operative societies, viz., the Bangalore City Building Co-operative Society and the Gavipur Extension Building Co-operative Society did good business during the year. The Bangalore City Building Co-operative Society had a membership of 231 and granted loans amounting to Rs. 28,295 in 40 cases for building purposes. The reserve fund of the society amounts to Rs. 2,500. There is no share capital in the society but every member has accepted a liability of Rs. 250. The society gets all its working capital from the Bangalore Central Co-operative Bank at $7\frac{1}{2}$ per cent interest. The loans due by the society to the Central Bank amounted to Rs. 38,041 at the close of the year.

The Gavipur Building Society had a membership of 82 and a share capital of Rs. 1,571. It granted loans to the extent of Rs. 12,767 during the year. It has so far helped in the building of 32 houses out of the funds supplied by it. The society largely depends upon the Provincial Co-operative Bank for financial help. The amount due by the society to the Bank at the close of the year was Rs. 33,376. The loans granted by the society are repayable in 12 years and the instalments are being collected every month and repaid to the Provincial Bank.

The Jewellers' Co-operative Society.—This society was started during the year for the benefit of goldsmiths and silversmiths. It had a membership of 55 and a share capital of Rs. 934. The purchase of raw materials and the sale of articles made by the members form the chief objects of the society. The working of this society is watched with interest.

The Chennapatna Co-operative Lacquerware Factory.—This is the only productive society in the district. It had a membership of 18, eleven of whom were artizans engaged in the lacquerware industry. The society sold toys and other articles to the extent of Rs. 2,129 and earned a net profit of Rs. 113 during the year. It has a reserve fund of Rs. 615.

The credit societies continued to do good work during the year and the following societies deserve mention:—

B.-Kolar District.

General statistics.—The year opened with 107 societies. Twenty new societies were registered and the registration of two was cancelled, leaving 125 societies at the end of the year.

The membership of all the societies in the district was 10,245 as against 9,368, their working capital from Rs. 6,43,905 as against Rs. 5,88,153 during the previous year.

The deposits attracted amounted to Rs. 1,99,504 and the total amount of deposits outstanding at the close of the year to Rs. 1,34,704. Loans of the value of Rs. 8,51,729 were issued in 29,875 cases and repayments of loans amounted to Rs. 7,80,801. The total amount of loans outstanding against the members at the close of the year was Rs. 5,47,896.

The total transactions of all the societies amounted to Rs. 24.34 lakhs, their net profits to Rs. 32,548 and their reserve fund to Rs. 42,062.

Productive Societies.—Of the three jaggory manufacturing societies viz., Sabbanahalli (Goribidnur Taluk) Balareddipalli and Mallasandara (Bagepalli Taluk) the two latter did no work and it is intended to wind them up. The Sabbanahalli society did some work but its working is so far a failure. Steps are being taken to recover the sum of Rs. 12,000 advanced to it by Government for purchasing machinery.

Weavers' Society.—The Chikballapur weavers' society had 65 members and a share capital of Rs. 805 during the year. It purchased yarn valued at Rs. 5,445 for the use of the members and made a net profit of Rs. 97 in its transactions.

Sericulturists' Societies.—There are two such societies in the district.

The Sidlaghatta Sericultural Society which till recently was doing merely banking work took steps during the year for doing practical work in sericulture. The Superintendent of Sericulture rendered necessary assistance by supplying the society with disease-free eggs and giving suitable suggestions for work. The working of the society is promising. The other Sericultural Society at Kurigal is for the present doing only credit business for the benefit of the men engaged in sericulture.

Stores Societies.—The stores section of the Kolar Co-operative Society sold goods to the extent of Rs. 6,240 during the year. The membership of the society increased from 205 to 224 and its working capital from Rs. 21,599 to Rs. 23,788 during the year.

A new stores society was started at Bagepalli late in the year.

The Kudiyanoor Society which opened a stores branch during the year did not do any appreciable work.

C.—TUMKUR DISTRICT.

General statistics.—There were 166 Co-operative Societies at the beginning of the year, 14 were newly registered and the registration of 3 cancelled during the year leaving 177 societies at the close of the year. Of these 6 were Federal Banking Unions one a lift-irrigation society, 2 rice-hulling societies, 3 weavers' societies, 5 grain banks and the rest credit societies.

The total membership of all the societies in the District rose from 15,223 to 15,850 and the total working capital increased from Rs. 10,27,499 to Rs. 10,47,403 of which the share capital amounted to Rs. 4,38,327 and deposits to Rs. 2,33,108.

The loans issued to members amounted to Rs. 7,81,116 and repayments to Rs. 7,13,528 and the total amount of loans outstanding against the members at the end of the year was Rs. 9,98,079. The total transactions of all the societies amounted to Rs. 25,80,366, their net profits to Rs. 48,131 and their reserve fund to Rs. 67,135.

Central Societies.—The 6 Federal Banking Unions in the district had a total membership of 176 made up of 108 individuals and 68 societies. They financed the primary societies to the extent of Rs. 22,755 during the year chiefly for clearing the prior indebtedness of the members of the societies concerned.

The Tumkur Federal Banking Union continued to take the lead as in the previous years.

Stores Societies.—The Tumkur Co-operative Society which is a combined stores and banking institution did good work during the year. It had at the end of the year a membership of 1,003 a share capital of Rs. 53,558 and deposits to the extent of Rs. 47,224. It purchased goods to the value of Rs. 8,784. The value of goods sold amounted to Rs. 8,246 and the net profit in the stores branch to Rs. 496. The total net profit of the society amounted to Rs. 2,664 and its reserve fund to Rs. 8,447. It has resolved to invest about Rs. 5,000 of its reserve fund on a building for the use of the society.

The Sira Varthaka Sangha and the Sira Town Co-operative Society did very good work during the year both in banking and in the purchase and sale of cloths for the use of their members. Their total transactions amounted to Rs. 1,00,095 and Rs. 3,36,414 respectively, their net profits to Rs. 1,650 and Rs. 6,081 and their reserve fund to Rs. 323 and Rs. 7,455.

Three more societies opened stores branches, viz., those at Bellavi, Pavagada and Baragur with a view to afford some relief to the people in supply of necessary articles and provisions the prices of which went up very high towards the latter part of the year.

Weavers' Societies.—There were three such societies in the district. They had a membership of 218 and a working capital of Rs. 3,100. They purchased and sold yarn to the value of Rs. 10,782, and made a net profit of Rs. 320. Their reserve fund amounted to Rs. 242.

Productive Societies.—The two rice-hulling societies at Maddagiri and Kortagere did no work as they did not purchase the required machinery owing to the increase in the price of machinery on account of war. A mention has already been made about the Yelladabagi lift-irrigation society in the Sira Taluk in para 39 above.

The working of the credit institutions was satisfactory during the year and the following societies may be mentioned as having kept up a high standard of efficiency:—

D.—Mysore District.

The working of the Co-operative movement in the district received the special attention of the Department during the year owing to its backward condition in

the previous year. The number of Inspectors in the district was increased and greater supervision was exercised over the backward societies.

There were 110 societies at the beginning of the year, thirty-two societies were newly registered and the registration of 3 was cancelled leaving 139 societies at the end of the year. Of these one was a District Central Bank, 8 stores societies, 9 weavers' societies, 2 rice-hulling societies, 1 a dairy farming society, 1 an ivory inlayers' society, 1 a house-building society, 1 a ladies' society for the improvement of home industries and the rest ordinary credit institutions.

The membership of all the societies rose from 10,032 to 12,122 and their working capital from Rs. 7,10,871 to Rs. 8,61,179 of which the share-capital was Rs. 5,16,252.

The deposits attracted during the year amounted to Rs. 5,44,131 as against Rs. 2,34,436 and the total amount of deposits held at the end of the year was Rs. 1,95,442 as against Rs. 1,86,820 during the previous year.

The loans issued by the societies amounted to Rs. 14,63,143 and repayments of loans to Rs. 11,69,473. The total amount of loans outstanding against the members was Rs. 7,90,969.

The total transactions of the societies amounted to Rs. 46,33,163, their net profits to Rs. 70,632 and their reserve fund to Rs. 50,354.

Non-credit societies.—Of the 11 weavers' societies in the district at the beginning of the year, the registration of two was cancelled and the remaining nine had a membership of 621, a share-capital of Rs. 41,694 and a total working capital of Rs. 66,214. They purchased yarn and other raw materials and finished products to the extent of Rs. 2,59,043 and sold them to their members to the extent of Rs. 2,70,296 earning a net profit of Rs. 21,110 in their transactions. The Ramalingeswara Co-operative Society and the Lakshmisahayanidhi Co-operative Society in the Mysore City, the Hosaholalu weavers' society, Krishnarajpete Taluk, and the Thogatagere weavers' society, Heggaddevankote Taluk, did very good work.

Of the two rice-hulling societies, the one at Krishnarajpete did not begin work as another mill formed on joint stock principles has been opened at Krishnarajpete and the members of the rice-hulling society are waiting to see how this mill works. In the meanwhile the society is doing the work of a Stores Society.

The Bannur rice-hulling Co-operative Society did but poor work during the year under report mainly because of a very inadequate supply of paddy to the mill. The management of the mill leaves much to be desired. The question whether it is possible to reorganise the working of this society on sound business-like lines or whether the society should be wound up is under consideration and the result will be separately reported.

The ivory inlayers' society at Mysore began work during the year. The Director of Industries has kindly consented to help the society in the supply of raw materials and the marketing of finished products.

The Mysore City House-building Co-operative Society had a membership of 184 and raised a working capital of Rs. 8,947. The society is full of promise.

A specially interesting society that was formed at Mysore was 'The Mysore Vani-vilas Co-operative Society which is open only to ladies. The society is the first of its kind in the State and was started at the instance of Mrs. Rangamma, Assistant Inspectress of Schools. Its chief object is the encouragement of home industries. It had a membership of 69 ladies, a share capital of Rs. 603 and a deposit of Rs. 125 at the end of the year. The society is likely to become very useful and popular.

Another interesting society formed last year was the Maharaja's College Cooperative Society at Mysore. It was formed at the instance of Prof. Shah of the College and is intended to supply the requirements of the students of the College especially books.

Credit Societies.—Several of the credit societies that were languishing in the previous year considerably improved their working during the year. A large portion of the loans outstanding against the members was collected during the year

and arrangements made for their proper working in the future. The following are among the societies that continued to work efficiently during the year:-

E-HASSAN DISTRICT.

This district contained 139 societies at the beginning of the year, 13 fresh societies were registered and the registration of 3 cancelled. There were thus 149 societies at the end of the year. Of these, 4 were Federal Banking Unions, 2 Weavers' Societies, one a stores society, one a lift-irrigation society, 4 agricultural societies for supplying manures and implements, one a rice-hulling society, one a house building society and the rest ordinary credit institutions.

The total membership of all the societies decreased from 8,680 to 8,054 while their working capital increased from Rs. 3,56,093 to Rs. 3,86,418 the result, in both cases, of the efforts made by the Department to improve their working. The deposits held by them at the end of the year amounted to Rs. 74,381 as against Rs. 70,626 in the previous year.

Loans issued by all the societies amounted to Rs. 2,57,090 and repayments to Rs. 2,38,804 and the total amount of loans outstanding against the members at the end of the year was Rs. 3,70,651. The total transactions of the societies amounted to Rs. 9,38,817 their net profit to Rs. 14,905 and their reserve fund to Rs. 28,492.

There was no progress in the working of the Unions in general. The Hassan Union inspected 22 primary societies affiliated to it and collected dues from them to some extent

Non-credit societies.—The two weavers' societies at Grama and Hole-Narsipur continued to do good work. They had a membership of 114 and purchased yarn and finished products of the value of Rs. 25,000 and sold them to the extent of Rs. 26,000 and made a net profit of Rs. 935 in the transactions.

In addition to the one Agricultural Society for the supply of implements and seed at Hindalahalli, three societies for the supply of manures were started at Hassan, Belur and Halebid. The working of these societies will be developed during the current year.

The working of the Vasavamba Poshita Store Society at Hole-Narsipur which dealt in the purchase and sale of cloths of local manufacture was considerably improved during the year. It paid back all its dues to the Mysore Bank.

Productive Societies.—The Channarayapatna Rice-hulling Society has purchased the necessary machinery out of the loan of Rs. 15,000 sanctioned to it by Government and the installation of the machinery is proceeding.

Credit Societies.—Among the Credit Societies that did satisfactory work during the year the following deserve mention:-

F-SHIMOGA DISTRICT.

General statistics.—The development of the co-operative movement in this district during the year was satisfactory. The number of societies increased from 126 to 152. Of these one was a District Central Bank, one a Federal Banking Union, one a store society, one a weavers' society, two sandal wood carvers' societies, eleven grain banks and the rest ordinary credit societies.

The membership of the societies increased from 6,507 to 7,665 and their working capital from Rs. 2,80,857 to Rs. 3,45,096 of which Rs. 2,20,413 was share capital. The deposits attracted during the year amounted to Rs. 80,311 and the total amount of deposits held at the end of the year was Rs. 57,472 as against Rs. 40,342 in the previous year. Loans granted to members amounted to Rs. 3,24,439 and their repayments to Rs. 2,59,005 and the total loans outstanding against all the members at the end of the year to Rs. 3,36,525.

The total transactions of all the societies amounted to Rs. 9,08,930, their net profit to Rs. 20,043 and their reserve fund to Rs. 13,854.

Central Societies.—A District Central Bank was organised during the year at Shimoga and it was engaged in collecting capital.

The Channagiri Federal Banking Union did good work during the year. It had a membership of 79 of which 17 were society members and the rest individuals and a working capital of Rs. 25,804. It had accumulated a reserve fund of Rs. 202. It inspected all the societies affiliated to it.

Non-credit societies.—A Store Society was started at Tirthahalli during the year. It had jurisdiction over the whole of that taluk and is expected to supply a long felt want in the malnad in the matter of providing facilities for procuring provisions and articles of consumption. It was engaged in collecting capital during the year. The weavers' society at Isur, Shikarpur Taluk, did some business during the year.

The sandal-wood carvers' society at Sagar made considerable progress during the year. A reference to the working of this society has already been made in para 41 above. Attempts will be made during the year to improve the work of the Sorab Gudigars' Society on the lines of the Sagar Society.

Credit Societies.—The Shimoga Co-operative Bank continued to be the best managed non-agricultural society in the district. It had a membership of 919 and a working capital of Rs. 91,031 and earned a net profit of Rs. 6,591.

The Sagar Sri Ganapathi Co-operative Society, the Shikarpur Co-operative Society, the Channagiri Co-operative Society, the Honnali Co-operative Society and the societies at Kogalur, Araga, Kuruvalli, Melige, Jigalgode, Hakre, Nallur, and Thadagani continued to do good work during the year.

G-KADUR DISTRICT.

General statistics.—The number of societies increased from 52 to 59 during the year. Of these 2 were Federal Banking Unions, 3 stores, 1 a Jaggory Manufacturing Society and the rest ordinary credit institutions. The general progress of the movement in the District is very slow. The district was divided into 2 Co-operative Circles each under an Inspector during the latter part of the year with a view to secure a more uniform spread of the movement. The membership of all the societies at the end of the year was only 3,693, their working capital was Rs. 2,14,827 and their total transactions Rs. 5,47,806. Their net profits slightly increased from 13,078 to Rs. 15,074 and their reserve fund from Rs. 10,200 to Rs. 13,234.

Central Societies.—The two Federal Banking Unions at Chikmagalur and Kadur did some work. They had a membership of 59 and a working capital of Rs. 26,738. They inspected all the societies affiliated to them during the year.

Non-credit Societies.—Of the three stores societies only one, viz., the Basavana-halli Co-operative Stores did good work during the year. It had a membership of 37 and a working capital of Rs. 2,500. It sold goods to members to the extent of Rs. 8,700 and earned a net profit of Rs. 328. The Lakkavalli Stores has not yet commenced stores work and is doing only banking work.

The Chikmagalur Coffee Society which is a stores society did not improve its working during the year. It has a large amount of dues outstanding against the

members and steps are being taken to collect the same and if necessary wind up the society.

H.—CHITALDRUG DISTRICT.

General statistics.—The number of societies increased from 76 to 84 and an additional Co-operative Circle was formed during the year to effect a more uniform spread of the movement in the district and the number of Inspectors was increased from two to three in the latter part of the year. Of the 84 societies, 2 were stores combined with banking, one a rice-hulling society, 1 a weavers' society, 4 grain banks and the rest credit institutions. The membership of all the societies increased from 4,406 to 5,264, their working capital from Rs. 2,01,346 to Rs. 2,37,692 and their total transactions from Rs. 6,92,792 to Rs. 7,45,546. The societies earned a net profit of Rs. 14,146 and accumulated a reserve fund of Rs. 9,876 at the end of the year.

Non-credit societies.—The Weavers' Society at Molakalmuru (the Zahir-ul-Islam Co-operative Society) steadily progressed during the year. It had a membership of 98 and purchased and sold yarn and finished products to the extent of Rs. 9,271 and earned a net profit of Rs. 226 during the year.

The Rice-hulling Society at Nagasamudra (Molakalmuru Taluk) did not take steps to purchase machinery owing to the increase in the price of machinery due to War.

The stores branches of the Chitaldrug Co-operative Society and of the Chikbyaladakere Co-operative Society (Hosdurga Taluk) purchased and sold goods to the value of Rs. 8,856. The former did particularly good work in having helped the members and the general public in the supply of fire-wood and kerosene oil at considerably cheaper rates than those prevailing in the market when the prices of these articles went up very high during the latter part of the year. The Credit Societies did good work and the following societies deserve mention:

IV .-- RESERVE FUND.

The Reserve Fund of all the societies increased from Rs. 2,34,740 at the beginning of the year to Rs. 3,30,539 at its close. Of this, total amount accumulated by central financing institutions was Rs. 31,508, by non-agricultural societies Rs. 1,66,490 and by agricultural credit societies Rs. 1,32,541. The oldest societies have naturally the largest reserve. The following statement shows the accumulation of the Reserve Fund according to districts.

The question as to how the reserve fund should be utilized has received some consideration. Several of the societies have deposited their reserve fund in central institutions or Government Savings Banks; some of them have, with the Registrars' permission and subject to proper safeguards, invested a portion not generally exceeding 50 per cent of their total reserve fund on providing office buildings. The bulk of the societies are making use of their reserve fund as part of their working capital. It is not proposed to change this system but steps will be taken to see that an adequate amount is always maintained in an easily available form to meet sudden or unexpected demands.

46. The total working capital of all the societies is Rs. 65,01,632 and the following table analyses the sources from which it is derived:—

VI. DISPUTES AND LITIGATION.

47. At the beginning of the year there were no suits pending disposal by the Registrar and 603 suits of the value of Rs. 96,527-10-2 were pending disposal with

the arbitrators to whom they had been referred. The number of suits filed during the year was 1,031 involving claims to the extent of Rs. 1,51,142-5-5. The total number of suits for disposal during the year was thus 1,634 of the value of Rs. 2,47,669-15-7 as against 973 suits of the value of Rs. 1,14,889 during the previous year. Out of the 1,634 suits on the file, 1,067 cases of the value of Rs. 1,61,728-3-0 were referred for arbitration, of which 431 were disposed of. The Registrar took 242 cases on his file and disposed of 211 cases during the year. The total number of cases disposed of was thus 642 as against 342 during the previous year.

At the close of the year, 992 cases were pending disposal, out of which 31 were pending with the Registrar, and 636 with the arbitrators and, in the remaining 325 cases, preliminary notices had been sent to the societies concerned for being served on the parties. In the 31 cases pending on the file of the Registrar, notices of hearing had been sent to the respective societies for being served on the parties.

48. The number of decrees pending execution with the Deputy Commissioners at the beginning of the year was 166 and 258 more were sent to them during the course of the year, thus making a total of 424 decrees. Of these, 50 were executed and the rest are still pending execution.

- It will be noticed from the statement given above that there is considerable delay in the disposal of suits. It has to be pointed out, however, that the number of suits filed by Co-operative Societies is increasing so rapidly that it has become impossible for the existing staff to cope with the work. Means have to be found, however, for a prompt disposal of suits now in arrears and to ensure a speedy disposal of those that may be filed in the future. The measures adopted with this view are four-fold. Steps are being taken to reduce the number of suits filed by Co-operative Societies by effecting an improvement in their working. rules relating to the settlement of disputes by or against Co-operative Societies, especially those relating to arbitration proceedings, are undergoing revision with a view to secure greater promptitude in such settlement. The Government have, as stated in para 2 above sanctioned two Assistant Registrars who, when they are appointed and empowered to deal with suits, will be able to bring about a more expeditious disposal of suits. The Government have also recently urged on Deputy Commissioners the necessity of prompt execution of decrees referred to them by the Co-operative Department. The whole matter is receiving careful consideration and a separate report is being submitted to the Government on the subject.
- 50. There were two cases of criminal prosecutions launched under the Registrar's instructions against the Secretaries of two Co-operative institutions for misappropriation of funds. In one of these cases (Kudiyanoor Co-operative Society, Malur Taluk) the accused was convicted and sentenced to 6 months' rigorous imprisonment. The other case (Cauvery Reservoir Co-operative Society) was under trial during the year.

VII. AUDIT AND INSPECTION.

51. Audit and inspection work continued to receive attention during the year. The accounts of 692 societies were fully audited and 880 societies were inspected during the year of which 750 were test-audited. Fourteen Federal Banking Unions inspected the accounts of 180 societies and three Central Banking Institutions inspected 33 societies affiliated to them. The question of providing a more satisfactory system of audit is under separate submission to Government.

VIII. THE MYSORE CO-OPERATIVE SOCIETIES REGULATION AND THE RULES THEREUNDER.

- 52. In the year under report, a rule was passed by the Government under section 27, 2 (b) of the Mysore Co-operative Societies Regulation No. III of 1905 limiting the loans admissible to the Committee Members of a Co-operative Society to not more than 25 per cent of the total loans outstanding against all the members. The object of the rule is to prevent the loans from being monopolised by Committee Members. To meet possible hardship, the Registrar has been authorised to exempt particular societies from the operation of this rule.
- 53. The Mysore Co-operative Societies Regulation No. III of 1905 was amended during the year and Co-operative Societies are now governed by the provisions of Regulation No. VII of 1918. The framing of the Rules thereunder is under consideration.

IX. MISCELLANEOUS.

- 54. Statistical tables.—The statistics appended to this Report are in the form approved by the Government of India and are the same as those of last year.
- 55. Provincial Co-operative Conference.—The Seventh Mysore Provincial Co-operative Conference was held at Mysore during the Dasara of 1917 and was attended by 300 delegates and 200 visitors from 200 Co-operative Societies in the State. His Highness the Yuvaraja graciously opened the Conference and Rajakaryaprasakta Rao Bahadur Mr. M. Shama Rao, M.A., Inspector-General of Education in Mysore, presided at the deliberations. His Highness was at home to the delegates and enquired into the working of several societies.
- 56. District and Taluk Conferences.—The Government ordered during the year under report that Co-operative Conferences should form part of District and Taluk Conferences organized by the District Committees of the Economic Conference every year. Eight District and 70 Taluk Co-operative Conferences were held during the year. A report on the progress of the societies in the respective Districts and Taluks was read at each of those Conferences by the Inspectors of Co-operative Societies concerned and subjects of local interest discussed and doubts and difficulties felt by the societies cleared up at these Conferences.
- 57. Departmental Conference.—The Fourth Departmental Conference was held at the Registrar's office, Bangalore, on the 27th, 28th and 29th August 1917. It was attended by all the members of the Department, a few of the honorary workers, and by the Director of Agriculture, the Director of Industries and Commerce and the Secretary, Economic Conference. A full report has been separately published.
- 58. Inspection of Village Improvement Committees.—The Inspectors of Cooperative Societies inspected in the course of their tours 347 Village Improvement Committees and delivered lectures on Co-operation, Sanitation, Education and other subjects of village improvement.
- urging on the Registrar the desirability of providing a suitable training for persons who are engaged, or are likely to be engaged, in Co-operative work. A rough scheme was prepared and opportunity was taken of the several Conferences referred to above and of several annual general meetings of societies to consult those interested in the matter. The opinion was almost unanimous that, for the present, there was no scope for a Co-operative School, and that, in its absence, it should be considered an important part of the duties of Co-operative Inspectors to deliver lectures and train Managing Committees in the work of management. This is being done as far as possible and I fear that adoption of more elaborate measures has to be postponed.

In connection with the Mysore Local Service Examinations, an examination has been instituted called the "Co-operative Inspectors' Examination" and a pass in it has been made compulsory on all the Inspectors of Co-operative Societies and the Head Clerk of the Registrar's Office.

- 60. The Mysore Co-operative Bulletin which was being published during the previous year has ceased publication during the year under report owing to want of suitable men to conduct it. Attempts are being made to revive it under proper management. The "Mysore Economic Journal" and the "Arthasadhaka Patrike" regularly publish articles on Co-operation; the "Mysore Blue Book Quarterly" does so frequently and the English and the Kannada newspapers and magazines in the State do so occasionally.
- 61. Mr. C. Bhima Rao, Honorary Supervisor of Co-operative Societies, Channagiri Taluk, and Representative Assembly Member was awarded khillats by His Highness the Maharaja during the Dasara Durbar of 1917. The names of the following gentlemen who took special interest in the development of the Co-operative movement in the State was published in the *Mysore Gazette*:—

X. ATTITUDE OF THE PUBLIC AND ASSISTANCE RECEIVED.

- 62. The movement continued to receive at the hands of His Highness the Maharaja and His Highness the Yuvaraja the keen personal interest and support which it has been its privilege to enjoy since its introduction into Mysore. Financial assistance, special recognition of co-operative workers, presentation of khillats and other marks of approval, personal inquiries into the working of individual societies are the forms in which this interest is shown, and they serve not merely as gracious marks of appreciation for efforts made but also as powerful incentives for further efforts.
- 63. The Government of His Highness the Maharaja and its officers are equally sympathetic to Co-operation. During the tours of the Dewan in the districts of Tumkur, Chitaldrug and Shimoga, he inspected several Co-operative Societies and inquired into their working and usefulness. The Members of Council are extending to the movement their very kind support. The interest thus shown by the Head of the administration and by the Members of Council goes a long way in strengthening the confidence of the public in Co-operative Societies and facilitates their progress. The Deputy Commissioners of Districts, particularly Mr. M. A. Narayan Ayangar of Shimoga, Mr. K. Matthan of Mysore and Mr. Zahiruddin Mecci of Chitaldrug are keeping themselves in very close touch with the movement in their districts. Finally, the Director of Industries and Commerce, the Director of Agriculture, and the Secretary of the Mysore Economic Conference with whom the Registrar has to work in close co-operation have been ungrudgoing in their help and advice to him and the thanks of the Registrar are due to them for their unfailing courtesy and support.
- 64. The connection of Mr. K. Chandy, Excise Commissioner, with this Department was very short, but in the brief period of 5½ months for which he was Registrar, he introduced several new features into the movement. He systematised the touring of Inspectors, gave a great impetus to the extension of co-operation among backward classes, prescribed a system of periodical survey of economic conditions of members of Co-operative Societies, and introduced a deeper and broader view of the methods and objects of the movement.
- 65. The attitude of the educated classes and of the general public to the movement is one of approval. The money-lenders, small merchants and people of that class who, not very long ago, were distinctly opposed to the movement, seem to have realised that their opposition does no real and permanent harm to the movement and that they stand to gain more by contracting friendly relations with

Co-operative Societies than by taking up an attitude of hostility to them. Several of them are now members of Co-operative Societies and take a leading part in their working. The gain in prestige and in sound management which the association of Co-operative Societies with men of business produces is of immense value to the societies and it is hoped that before long, this combination will go a step further and that the surplus funds available with these classes will be put into the movement.

- 66. The frequent change of Registrars, the strenuous attempts made by the Department to improve the working of societies, the introduction of special surveys, and the altered economic conditions brought about by the war rendered the work of the Department during the year under report far more arduous than usual. It is satisfactory to be able to report that, following the example set by the Personal Assistant to the Registrar, the staff of the Department rose to the occasion and discharged their duties efficiently, promptly and cheerfully.
- 67. Finally, reference has to be made to the public-spirited and unselfish labours of a large body of men who, as office bearers and auditors of societies, have given their time and thought freely and ungrudgingly to the cause of co-operation. Large as has been their work in the past, it has to be larger in the future. The present programme of the Department includes a large number of important questions. Besides consolidation and extension of primary credit societies and the strengthening of their financial position, especially in its higher stages, the development of Agricultural Co-operation, of Industrial Co-operation and of stores, the application of Co-operative principles to house building, cattle insurance and cattle breeding, the extension of Co-operation among the backward classes, the creation of a Co-operative education, audit and supervision and the conversion of Co-operative Societies into local centres of economic, social and moral development are questions which call for immediate consideration and action. The scope for work is vast, but the workers are few. It is for men of position and of influence in the State to realise that Co-operation has just as good a claim to their support as any other public cause and that service rendered in furtherance of the movement is service of the highest order.
