were about six annas in one hundred Sicca Weight less in weight than those sent you before being of our own coinage and by us newly calculated for the benefit of the Honble Company to correspond with the Country Mints which were about that Time lowered in weight and much more so in their Touch, We were not then aware of any objections that could be made to them being well assur'd the said Rupees were as heavy as any of the Country Money then coined and full two Cent better in fineness, but since Your Honour &c^a. acquaint us of the difficulty of paying them to your Merchants, who we suppose receive them by weight and not by Tale as we presume all priv[. . .] payments are made, we will give orders in

our future coin[age], to make one Thousand Arcot Rupees weigh 367. 10 which wi[ll] be rather more than the weight of what consign'd to your [Honour]&c^a. by the more early Conveyances.

On the Brilliant who was dispatch'd to the West Coast in October we forward-ed the 500 Bags of Patcheree rice bro^t. us by the Princess Augusta and we purpose to [send] a further quantity by that ship for their service & agreeable to what you are pleas'd to mention we shall expect to see her soon.

We doubt not it will be very satisfactory to our Honble Masters the Resolution your Honour &c^a. have taken with respect to the disposition of their Shipping consign'd you this year as the Investments both with you and us have been attended with such circumstances as render'd it impossible to provide sufficient Cargoes for the dispatch of them all to Europe, The Heathcote we hope will be with us in a few days whom we shall detain no longer than to get her Bales aboard.

We have received the 8 Bales of Sannoos and the rice deducting the Number of Bags endors'd off the Bills of Lading of the Ships Duke & Montfort which were return'd.

As Your Honour &c^a. intend to keep the large Guns designed us by the Montfort for the use of your settlement we shall debt your Account for the Cost.

With our Letter address'd to your Hon^r. &c^a. under the 11th. of August we forwarded the Montforts Bill of Lading from Europe with several other Papers relating to that ship and we find it was N^o. 8 in that List.

Cap^t. Hindman has taken his oath to the Certificates which we have deliver'd to him.

The Sumatra is not yet Arrived from the Northward who we purpose to send away to you with all expedition after she has put ashore the Bales from those Settlements.

The 17th. Ships Duke and Montfort sailed out of our Road for Europe, on the former our late President Richard Benyon Esq^r. embarked and is succeeded accord- ing to the Honble Company's Appointment by Nicholas Morse Esq^r.

We send you by this Ship Mercury the 50000 Rupees received from Bombay by the Brilliant and which we did not chuse to venture to send you by the Princess Augusta on account of the lateness of the Season when that ship left us, The Winchester not arriving has occasion'd our stock to be but low and not more than we are in expectation of laying out in these Parts, that we cannot send Your Honour &c^a. any supply of Money at this time, But if we should find our selves disappoint- ed by the time your sloops may arrive we shall in such case send what possibly can be spar'd.

We have ordered the Dutch Dollars brought us by the Montfort to be coined into Arcot Rupees of the weight above described & shall send them to Your Honour &c'. on the Sumatra they not being ready for this Conveyance.

HON^{BLE} SIR & SIRs

1. Since our last of the 26 August the Brillant importing here the 17th. September brought us Your favour's of the 17th. & 18th. August inclosing Invoice & Bill of Lading for Cotton and Treasure sent Us on her for the Bay, & the Accounts of the Cost of and disbursements on that Vessel for which we have credited Your Presidency.

2. The Princess Augusta arriving so late from the Bay that we could not return her thither till the 14th. October we only sent the Cotton on her not chusing to risque the Rupees at that season, these last we forwarded thither also on the Mercury the 19th. of last month.

3. The Packet for England mentioned in your said Letter & transmitted Us from Tellicherry we forwarded by the Salisbury, which Ship sailed hence for Europe the 27th. September.

4. The Duke and Montfort sailed for Europe the 17^o. of last month and Heathcote will be dispatch'd in a few days on the former Ship our late President Richard Benyon Esq^r. took his Passage and is succeeded in this Presidency according to the Honble Company's Appointment by Nicholas Morse Esq^r.

5. By a Danish Ship from Europe to Tranquebar we have a report that the Princess Louisa Cap^t. Pinson outward Bound to Persia was lost near the Isle of May but no further particulars which we hourly expect from Tranquebar.

6. The Success Galley who was dispatchd from your side to Bengall fell to Leeward of the Point, and was obliged to bear away for Vizagapatam where she arrivd the 22^d. of October. The Chief & Council for the greater security of the Treasure landed it during her stay there and she proceeded to Bengall the beginning of January and was met in the river by the Vernon Cap^t. Munro the 18th. of last Month. Inclosed we send Your Honour & C^t. an Account of some Disbursements which Cap^t. Dunster applyd to the Chief and Council for amounting to Rupees Arcot 1080, for which sum we shall debt your Presidency.

7. The Harrington we are informed was safe arrived at Canton, where Commodore Anson had bro^t. in a Spanish Ship bound to Manilha with a considerable Treasure.

The Country for some days past has been alarmed with the News of the approach of the Mora[ttas] who are said to have been encamped on the Banks of the Kistna and within few Miles of Nizam al Mulk, our Shroffs have advices of a late date which mention that matters were in a fair way of being accomodated between them and that it was expected they would soon retire.

Our President returns his Thanks for Your Congratulations, and Inclosed are New Commissions to be delivered to the Lieutenants & Ensigns at your Place.

CHIEF & C^a. COUNCIL OF VIZAGAPATAM.

GENILEMEN

By the Sumatra Importing here the 27th. Ultimo we received Yours of the 25th. December inclosing Invoice & Bill of Lading for 180 Bales of Calicoes & the several other papers specified therein. Your other of the 2^d. Ultimo came to hand the 29th.

On the representation you make of the Necessity of rebuilding the House at Upparra we permit you to do it and depend on your promise not to exceed three hundred Rupees in the Cost.

You have omitted to send Us your Merchants Accounts in order to their being transmitted to England, agreeable to the directions sent from hence the 18th. October 1740.

Inclosed are Invoice & Bill of La[ding] for the Treasure, Wares and Stores we now send you on the Sumatra, which Ship you must not detain longer than is necessary to landing them after which she is to proceed to the Bay.

Of the thirty thousand Madrass Pagodas we now send you, fifteen thousand are for the occasions of Your own Investment, the other fifteen thousand for [Inger]am, which Residency we have debted for it, & you will send it thither as M^r. Saunders wants it; we chuse to deposite it at your place thinking it more secure there in case of troubles in the Country and direct that on no pretence you apply it to any other purposes. By the next proper Conveyance we shall send you a further supply.

You have herewith a List of Goods you are to provide this year agreeable to the last Directions rec'd from Europe and to which you must conform as near as possible we have for the encouragement of the Merchants at the several Settlements divided the Fine Cloth in equal Proportions and you are not to enlarge the Quantity till further Orders from us, by the next ships we expect to know to what extent the Company will permit us to invest in this Article, which as soon as we receive you shall hear further from us, in the mean Time you are to Observe what we now say in regard to this Part of Your Investment and Increase the quantity of Ordinary which of late has fallen short as the Fine has been enlarged.

We have been long in expectation of having an account from you of the Treatment M^r. Pitt met with from the Nabob so particularly set forth that we might have been able to have formed some Judgement on it and to have endeavoured to have obtained some redress for the Money taken from M^r. Pitt at Uppara, but for want of it we know not how to proceed.

SIR

We have received yours of the 9th. & 11th. Ultimo the first inclosing Invoice & Bill of Lading for 165 Bales of Calicoes sent us on the Sumatra, that Arrived here the 27th. of that month.

As you represent a Fence round your Compound, a Choultry for your Peons & Godowns for your Cloth to be so necessary to the security of the Honble Compy's Effects we permit you to set about them depending on your Care that the work be well performed & that the Expence do not exceed the five hundred Pagodas you Compute it at.

We shall supply you with the Packing Stuff you write for & the Wares & Stores you indented for the 19th. October as opportunity offers.

We send herewith a List of what Goods you are to provide this year conformable to the Directions last received from our Honble Masters and to which we expect a due compliance as far as the Circumstances of affairs will permit. We have divided the proportion of Fine cloth to each Settlement in order to encourage the Merch^{ts}. to bring in the Ordinary, this must be kept strictly to and you are not to suffer your Merchants to bring in any more Fine than what we have indented for till we have further orders from Europe and know whether a larger quantity will be acceptable there, the Ordinary we have received this year from your place is much inferiour to what was sent us last season and we expect you will call upon Your Merchants to bring in Cloth that is good and equal to what they have provided in former years particularly remind them of what has been often complaind of, that several of the inner Folds are extreamply thin and in all Respects endeavour to improve the Manufacture.

We now send on the Sumatra 15000 Madrass Pagodas to Vizagapatam for the Use of your Place as ₹ Invoice inclosed and the Chief & Council have our Orders to supply you with that sum whenever you have Occasion for it, but we would recommend to you [to invest] no more Money at a Time than what will be neces[sar]y to carry on your Business as we think Vizagapatam much more secure in case of any Troubles in the Country and therefore chuse to have it deposited there till your occasions require it, our chief aim in sending so large a sum at this time being to enable you to go on briskly with your Investment before the French have any supply to interfere with you and as we well know there are great advantages in doing business early in the season, We persuade ourselves that by Your Care & Diligence all these purposes will be effectually Answerd.

We debt your Residency for this remittance to you not Vizagapatam.

HONBLE SIR & SIRS

Our last was under the 19th. of January with its Copy by the Cornwall, since which we have been favour'd with your Letters of the 27th. December by the Heathcote, and 5th. January by the Princess Augusta; The former imported the 26th. Ultimo, & the latter the 27th. with the Particulars as mention'd in that Ships Invoice.

We observe Your Honour &c^t. have agreed to refer to Europe the difference of weight in the Lead by the Heathcote and that you had protested against her Commander for refusing to take in any more weighable Goods, we have near Completed her Lading and purpose to dispatch her the 10th. for Great Brittain.

We shall Credit your Presidency for the advances on Account of the Princess Augusta as we shall debt it for the Freight received for the Tutenague and Cotton she carryd from hence last year Agreeable to the several accounts your Honour &c^t. have transmitted us.

This waits on you by our Honble Master's Ship Sumatra Cap^t. John Taylor who has been survey'd and appears to want some Repairs, which we should be glad could be done in time so as she might return hither before the season is over, we have already requested Your Honour &c^t. to provide a Cargo for her of Patcharee Rice in our Letter of the 15th. November when we also forwarded an Indent of Sundrys for the service of the West Coast which if ready and this ship should not be refitted in time you will please to send us by the Sloops you may design up hither.

We have laden on this ship two chests q^{ts}. Rupees Arcot 11679. 8. — the Produce of the Dutch Dollars received from You by the Montfort and which You will find to weigh 367 10 ^{Oz} ^d 79 Mil as we acquainted you in our last should be the standard of what we coin'd hereafter and you will favour us with your Directions as early as you can concerning the Silver that may be expected from Europe this year, as also what Redwood you shall have Occasion for.

By the Ceres who arrived at Anjengo the 13 June from Canton we are advised that the Haeslingfield and Harrington were both there bound home and that Commodore Anson had taken a small Galeon belonging to Manilha with a Considerable Treasure.

We have Order'd this ship to call at Vizagapatam to put ashore some Treasure and a few Necessaries and the Chief & Council have directions not to detain her inclosed is a List of what Freight she has on board.

The Province has been lately alarmed with an account of the Morattas approach into these Parts & we are informed they were advanced three days March on this side the River Kisna & within fifteen Miles of Nizam al Mulk's Camp where they halted that after some small skirmishes they are at length entring into a Treaty and we are in hopes they will soon retire.

The 8 Instant we received yours of the 6th. with the several Papers inclosed, and immediately order'd the Gunpowder aboard the Sloop Experience who sailed the next evening and we suppose has arrived You before this time.

In our next you shall have our Directions concerning the Sloop Carolina who we find from the Gunners report is in a very bad Condition.

Our Shroffs have advices that the Morattas and Nizam are come to an accommodation and that they were retired and we have reason to be confirmed in this as they are sending back to Arcot and the other Towns the large sums they had brought in and deposited here on the News of their approach, we therefore are of opinion you may go on with your Business with security however we would recommend to you to get as good Intelligence as you can from the Parts adjacent to Tritchnopoly since if they should have any design, to engage them in these Parts it's believed the scene of action will be there and as the March of these People

consisting chiefly of Horse is very quick and their approaches sudden it may be necessary to be informed of what is doing there which your situation will afford you better opportunities of than ours.

W^{ORSH}^L. SIR & SIRs.

1. Our last was by the Brillant dated the 16th. October The 12th. November we received your's of the 18th. August by the Sumatra forwarded to Us from Vizagapatam where she arrived the 13th. October.

2. We come now to reply the needfull thereto under the usual heads.

FIRST CONCERNING SHIPPING.

3. We have called upon Captain Taylor of the Sumatra concerning the deviation you say he made in his voyage to your port which you assign as the Cause of the late dispatch of the Grantham for Europe, by what he has offered in vindication of himself from the Censure you have passed on him & his Journal of the Voyage it appears he only stay'd four days at Baroos to take in water & Refreshment and as your Accusation is in general Terms we have thought proper to send you a Copy of his paper & when we receive what you have more to say we shall be the better able to judge of the Case.

4. The dispatch of the Princess Augusta & Sumatra from your Coast these two years past has been so late in the season that they have both entered the Bay in the very height of the Monsoon, which is always attended with the greatest Risque and therefore we direct that in future you do not detain the ships bound to this Coast longer than the 15th. July.

5. As you have now a Vessel to perform the necessary business on your Coast and as we have also sent you fifty Lascars to navigate your Sloops & Vessels we are in hopes you will be inabled by this Assistance to have your Cargoes ready for a more early dispatch of the shipping to Europe. Inclosed is an Abstract of four month's Impress advanc'd them in Bengal & an Account of the disbursements for Provisions &c^t. for their passage amounts. to Arcot Rupees 2049--13--9 and at their request we have advanc'd them one month's pay more Arcot Rup^s. 382 to furnish them with some Cloaths & Necessaries, they acquaint us they shall be in want of. We send you also herewith a Copy of the Terms on which they have contracted with us to serve the Company which you will take care to comply with on your parts as we expect they do on theirs. We recommend to you that they be well treated, which may encourage them to stay with you their full contracted times, since it is not only difficult but very chargeable to the Company to engage people on such occasions.

6. The Sumatra will require some refitting in Bengal and we may not probably see her till the month of September and as Your Indents for Rice Salt & other bulky Goods will take up a larger Tonage than we have at present to send you we would have you return this ship to Us immediately that we may be in a capacity to furnish you with what you may stand in need of.

7. We shall debt your Acco^t. Pag^a. 91. 20. 65 for the Quarter deck Guns taken out of the Sumatra.

SECONDLY CONCERNING GOODS FROM EUROPE OR FROM ONE PART OF INDIA
TO BE DISPOSED OF AT ANOTHER.

8. On this ship we have laden Sundry Wares & Stores as ~~q~~ Invoice amounting to Pag^a. 4071. 20. 39 & you will find we have pretty near complied by her & the Brillant with your Indent at least as far as we are able, We have wrote to Bengal for the Ta[ffu]ties, Patna Chints & Canvas which we expect to receive from thence in time to send you by the first Conveyance.

9. You will let us know what further supply of Rice you will want this year & the Quantity you would chuse to have by the Europe Ship that may be sent you from Bengal.

10. There are, 4000, Gunney bags now sent and we shall order some on every ship.

THIRDLY, INVESTMENTS & FOURTHLY, COUNTRY GOVERNMENT.

11. We are to observe the Sultan of Anacksoongey has begun to bestir himself amongst his people & that thereby you conceive hopes that Country will be able to furnish more Pepper than it has of late you seen [*sic*] to think he was imposed upon by the reports of the Pepper Surveyors & we suppose the Resident has been in the same circumstances, it was surely the business of the Resident not to give implicitly into what the Sultan might tell him and to have had different persons to have gone on the survey from whom he might have learn'd [the true] state of the Country & condition of the Plantations and as this has been a growing Evil it was the more necessary. We are ready to beleive that part of the decrease has been occasioned from what you represent and these are calamities that will happen but we imagine if a stricter Eye had been kept over the Planters that Country would have been more beneficial to our hoñble Masters.

12. The Acquisitions you have made to the Southward will we doubt not convince the Hoñble Company of your readiness to promote their Interest and we hope you will meet with no Molestation from the Dutch or the Sultan of Bantam on this account.

13. The account you give of affairs at Benjar is very agreeable to Us and we hope our hoñble Masters will in future receive a considerable advantage from that Banch [*sic*] of their Commerce. We have sent by this Ship the two pieces of Gold Cloth as you desired for the Sultan & Two pair of Iron barrel'd Blunderbusses which are all we have of that s[ort].

FIFTHLY, OF FORTIFICATIONS, BUILD[INGS] REPAIRS AND REVENUES.

14. We are glad to read that the [. . .] Fort at Moco Moco is in such forwardness, though we could wish it had a more firm foundation if you are of Opinion the Italian Padre can be of any service in his advice for the better finishing the superstructure you will desire that of him & we leave it to you to make him such a gratification as you think he may deserve.

SIXTHLY, COMPANY'S SERVANTS, MILITARY AND THEIR ACCOUNTS.

15. Our late President Richard Benyon Esq^r. being gone for England on the Duke is succeeded in that station by Nicolas Morse Esq^r. according to the Honble Company's Appointment.

16. The request you make for our directions concerning the allowance to Ensign Brown's widow or for persons in the like circumstances we chuse to refer to the Honble Company, as we don't find any precedents of this kind to guide Us by.

17. We observe you have got a recruit of Buggueses from the Islands and that you intend to discharge the Malays who receive pay under that denomination & we wish they may prove serviceable to you. We have received this year so small a recruit of Military from England that our Garrison is not in a condition to afford you but a small assistance that way as we should very gladly otherwise have done, and there being so many people already on this ship we must deferr till another Opportunity the sending you any Topazes to releive those who have been three years on the Coast.

18. On this ship we send you James Dollison & Edward M^o. Cowan to serve in your Military and three Transports namely Gunnah, Kashee & Gollah Kistna.

The Method your Investment has for some years been in furnishes us with little more to say here on that subject than to recommend to your regard therein the Directions in the Letters from hence last year particularly in those of the 24 June & 5th. July which we doubt not your compliance with as near as the Circumstances of the times & your place will permit & to which we shall only add that our sentiments are the same, as then expressed, That is better to suffer some disappointment than to take in worse Cloths or at higher prices than those of late in which we hope the present confined state of your Neighbours will not be an unfavourable Circumstance.

Being about to return to your Residency we send with you on the Sloop Experience such Wares & Stores as you have indented for except the Packing Stuff wh^{ic}h will come hereafter, as w^{h} Invoice herewith, we send wit^h you also a present supply of five thousand 5000 Madrass Pagodas which is as much as we think proper to risque on this Sloop & on the William and Sarah, that will sail for Vizagapatam in few days, we shall send thither, as we think it will be more secure there in case of Troubles in the Country, a further supply of fifteen thousand, 15000, Madrass Pagodas for the particular service of your Investment, to be sent you from thence as you shall call for it but we would recommend to you to send for no more of it at a time than is necessary to carry on your business.

We hope our supplying you with so large a sum so early will enable you to go on briskly with your Investment and to comply with the List we herewith deliver you of Goods to be provided this year at your place & Metchlepatam, regard being had to the remarks we have thought proper to subjoin thereto.

We have divided the proportion of Fine Cloth to each of the Northern Settlements to encourage the Merchants to bring in the Ordinary, this must be kept strictly to and you must not suffer your Merchants to bring in any more Fine than we have indented for till we know from Europe whether a larger Quantity will be acceptable there. The Ordinary sent up this year from your place is much inferiour to what we formerly, received and we expect you will call upon your Merchants to bring in Cloth that is good & equal to what they used to provide, particularly remind them of what has been often complained of that several of the inner Folds are extremely thin and in all respects endeavour to improve the Manufacture.

In October 1740 it was ordered from hence that at the End of November every year an Account should be drawn out in proper Columns wherein should be incerted what Money had been advanc'd each of the Merchants & what number of pieces of each sort of Cloth had been brought in by them, with the value. On the reports we have here that the Morattas are infesting Metchlepatam & the parts adjacent we have engaged with Mier Angee the Master of Brig^{tn}e. Cauder Bux to lye in your River in readiness to take on board the Company's Effects & transport them & you to Vizagapatam if you see occasion, for which you are to pay him at the rate of twenty Pagodas w^{h} month, but if on your arrival you find all things in Quietness & no necessity for keeping the Vessel you will then put an end to that Charge.

The Distance that Salem is from you and being under the Misore Government we must allow puts that Part of the Investment on a more precarious Footing than the other and we are not therefore surpriz'd those who had made you some offers did not care to take that wholly on them, that Place for several years procured a large quantity of Cloth and particularly that sort which was so acceptable to our Honble Masters under the denomination of Porto Novo, on Account the Army of Nizam al Mulk and other Disturbances it was not judged safe to negotiate any Business there last year But as the circumstances of affairs are alter'd and the Troops retired we are in hopes to hear that Part of the Country is now settled and in such favourable circumstances as may enable Your Merchants to procure a good Number of Bales from thence, if you find it so, we doubt not you will spirit them up and as we are sensible of the extraordinary Risque that attends that Part of the Investment we shall not be unwilling to allow them some additional consideration for what they shall bring in surplus of the 300 Bales agreed for in hopes that this encouragement may encrease the Investment there beyond what seems to be their Design at present, It will be also very agreeable for us to hear they lose no opportunity of getting as much Cloth as possible from the other Weaving Towns before the French Brokers are supply'd with Money to interfere in the Business.

We are well pleas'd to read that you had come to an agreement with Andeapah for one Thousand Bales to be provided by him of which you imagine Three or four hundred will be Salem Cloth, as this Person is esteemed to be very capable of Carrying on the Investment of a fair character and to be depended on, we persuade our selves that there will not be any disappointment to be apprehended, unless occasion'd by such Means as it may not be in his Power to prevent and to that we must submit should it so happen but we hope Nazams Return into this Province will not prove of such ill consequence as to impede the Companys Business.

Inclosed is duplicate of what we wrote you the 9th. Ultimo by the Sumatra that sailed hence the 12th.

Some time in June last our Gentleman at Vizagapatam represented to us that the Nabob of Rajahmundrum besides treating his person very severely had forced the sum of 1700 Pagodas from M^r. Pitt a Company's Servant Residing at Upparra a place under the direction of that Chiefship, on Account of the Wreck of a ship that was lost about that time near Upparra, said to belong to M^r. Cotesworth Chief of Balasore. The Gentlemen at Vizagapatam urge that M^r. Stratton the then Chief crediting the report of the ships belonging to M^r. Cotesworth had applied to the Nabob for & obtained his Firman for taking possession of what could be saved of the ship & Effects [in] consequence of which M^r. Pitt had secured what he could, but the Nabob afterwards pretending to be informed that the ship did not belong to the English insisted that he had been imposed on & that the Wreck belonged to him and demanded of M^r. Pitt nine thousand Rupees for what he made the salvage amount to by a fallacious account he caused to be drawn out, and at last obliged him to pay him the seventeen hundred Pagodas beforementioned and to sign to two Papers which M^r. Pitt says he did not understand but was told they imported his Act of indemnification to the Nabob. Having some doubts whether if what the Nabob urged "That the ship did not belong to the English" twas true our Gentlemen had not taken too hasty a step in concerning themselves about it we determined to suspend our Application to the Superiour Powers for Redress till that matter was made more clear to Us and accordingly wrote to Vizagapatam for the fullest authorities they could give Us of the Grounds on which they had proceeded, an Account of what had been saved, to what amount & how disposed of, As to the last they are entirely silent nor have they given Us an Account of the other to our satisfaction wherefore we have repeated our Orders thither to that End We have indeed seen Copies of some Letters from Balasore of which other Copies are here inclosed signifying that the Ship was called the Jaggernaut Persand belonged to Gopanaut the Company's Mussudy and that there was English money lent on her at Respondentia, how far that invalidates the Nabob's pretensions we shall not enter upon here but hope Your Honour & c^t. will excuse the trouble we give you in requesting that you will order to be collected & sent Us such Vouchers as may be procured at Balasore & Calcutta of the amount & nature of the English concerns on board that ship as whether they were concerns in the [Ship] or at Respondentia.

The 5th. Instant we received by Peons yours of the 11th. February with the several papers it inclosed; among these is a long detail of M^r. Pitt, discribing the particulars of the insults offered his person but not answering what we proposed by our Letter to your place of the 1st. July last We principally wanted then & now direct that you send Us as soon as possible the best Information & fullest authorities you can concerning the Grounds upon which the application was first made to the Country Government for liberty to secure the Wreck of the ship Jaggernaut Persand, it appearing to Us that the pretence for it on our parts was that the ship belonged to the English, which is denied on that of the Nabob and which we think necessary to be cleared up before we use our Instances for Redress; You must also send us an Account of the particulars that were saved, to what amount & how they or their produce have been disposed of and if M^r. Pitt or any others under your Influence or Orders are yet possessed of any of the Money or other Salvage of that ship we would have you secure them on the Company's account till this affair be settled or you receive our further Orders, Entering the same in your Books under the head of Wreck of ship Jaggernaut Persand.

The Estimate you sent Us of the cost of building & repairing several parts of your Fortifications being so loosely drawn that, without some further Explanation, we could make no Judgement of it, we desired M^r. Stratton to give us his thoughts on the present state of them and what is necessary to be done to render them of proper security to the Honble Company's Estate at your place in these unsettled times. Inclosed is a Copy of the paper we received from him on that subject on which we shall only remark That he seems to think the necessary work may be done at a smaller Expence than you calculate, We do not positively enjoin your comp^liance with what M^r. Stratton there lays down but would have you consider it well, compare it with the design on which you formed your Calculate & transmitt us your sentiments thereon, with an Estimate better explained of the Cost of what you think most necessary to the End proposed of securing the Company's Estate; of which we may be able to judge more easily if you can, by the assistance

of M^r. Turnery, send us a Draught of your present Fortifications & the additions you propose which we apprehend you may do in time to receive our answer before you can have got together the Materials that must be wanted ; That your Buildings have been suffered to run so to decay as now, by your computation, to require near 1800 Pagodas. to repair them, must have proceeded from great neglect & bad husbandry and might certainly have been prevented by small proper repairs when the want of them first appeared and as the Evil will but encrease by further delays we would have you set about preparing materials, that what we shall direct to be done may be finished with the greatest dispatch.

We have received your favour of the 23^d. Feb^r. by the Ship Mercury with those under the 29th. of that month by the Sloops Porto Bello & Bombay.

The several particulars mention'd in the Invoice of Sloop Porto Bello have been delivered here, & this waits on you by her. The Bombay Sloop is now unloading & we purpose in few days to return her also.

The Arrack Your Honour & c^t. have sent Us we design to try at Outcry and in our next we [shall] advise you what it produces and likewise whether a further Quantity can be disposed of here.

As you desire to have no more than four thousand Maunds of Redwood sent you this season we shall make use of the Europe ships to supply you with that quantity which will save the trouble & Expence of landing & reshipping.

It would have been a particular pleasure to Us to have had it in our power to have supplied Your Honour & c^t. at this time with some Treasure for carrying on your Investment, but our Stock is so low that we cannot possibly spare any from our own necessary Occasions.

We advised Your Honour & c^t. under the 9th. February of the approach of the Morattas into these parts; an Army of about forty thousand met Nizam Al Mulck near the Banks of the Kistna in his return to Golcondah, about fifteen days after all matters between them were settled & he entertained twenty thousand of that body in his Own pay, the rest took their rout Northwards; however Nizam did not chuse to proceed on his way at that time but return'd into this province to a place called Gundicotah, distance from Arcot about eight days journey, where he remain'd till the 20th. of last month & then set out again for Golcondah, having before his departure appointed Anawerdee Cawn, late Nabob of Chicacul, to the Subahship of Arcot & we are in hopes the Country will now be settled if the Morattas who are to the Southward in the Misore Country don't prevent it.

We presume Your Honour & c^t. will have been acquainted by the Sumatra of a party of Morattas having passed Vizagapatam supposed to be designed for Cuttack in order to assist the late Nabob of that Country who was some time since obliged to leave it from the success of the Opposition made against him.

M^r. Henry Kelsall whom we mentioned to your Honour & c^t. the 12th. July last year labouring under a very ill state of health we have permitted him at his request to go to Vizagapatam, from whence on his recovery he will proceed to his station in Bengal pursuant to the liberty granted him from England.

We are now to acquaint you with the Arrival of our Hoñble Masters Ships the Lapwing and Prince William the 25th. and the Prince of Wales the 28th. Ult^o. The two latter left England the 2^d. December and the other the 13th. November.

Having not as yet received your directions about the coinage of the Bullion expected from Europe this year which you mention in your favour of the 29th. February should be forwarded to us overland we have judged it best in this circumstance to be guided by those we received from you in 1742 since we may imagine the Return of the Morattas to Bengall may most probably occasion affairs there to be much in the same situation as then, when you desir'd to have no Bullion on acco^t. of the Mint at Muxodavad being shut up, and as Your Honour &c^a. mention in your late advices that you were in want of all the Money we could possibly spare, We have for these reasons determind to coin what is designd for your Place, especially as the advantage to our Hon'ble Masters by the Arcot Rupees is very considerable and as it will place a sum of Money in your Hands for the more readily carrying on your Business, which perhaps the difficultys you might meet with in disposing of the Bullion might in some measure have retarded. These Resolutions will we hope be agreeable to your Honour &c^a. as it will be always a particular satisfaction to us to act in that Manner in all affairs in which we are engagd with your Presidency.

The coinage of the Prince William's Treasure has been done with all imaginable Dispatch & indeed has taken up little more Time than what was necessary for the refreshment of the ships company she now brings you fifty chests of Arcot & Madrass Rupees as ¶ Invoice thereof amounting to Pag^s. 119204. 7. 10 & Bill of Lading inclosed.

The Lapwing shall be sent away as soon as the rupees for her are ready, we purpose to lade on her thirty chests and, reserving only twenty for our selves, to send you the remainder which will be thirty more by the Montague or St. George, who are expected to call in here in their way to Bengall by the Lapwing we shall transmit you some directions received from Our Hoñble Masters concerning her proceeding to the West Coast.

John Misenor William Henry Draper Richard Oliver Jonathan Scarth and John Forbes or, in the absence of any of those Gentlemen the Orders of such of them as shall be Resident on the Spot.

As Your ship is dispatch'd in so good Time we do not in the least Doubt of your gaining your Passage to Canton but if by any unforeseen Accident the ship should loose it to that Port, you are in such Case to proceed to Bengall & to deliver the Cargo to the Honble President & Council of Fort William and obey their orders for your future Proceedings.

Having not as yet received from the President & Council of Fort William a full answer to what we wrote them on the subject of the Ship Jaggernaut Pursand, we cannot come to any determination at this Time about that Affair, But as we

observe from Mr. Pitt's Account of salvage there are some perishable Articles we would have them & all others immediately disposed of at Outcry and the Produce together with the Silver and Gold deposited in the Company's Cash Chest, till our further Orders.

From Your representation and that of Captain Tornery's concerning the condition of your Buildings and Fortifications we find there is Yet considerable to be done, But as you are not able to send us any Calculate of the Expence, we can give our Consent to no more than Your repairing such of them as are the most Necessary & Usefull, till you can send us a just Estimate of the Expence, and we can be satisfyd they will be of service, for by the Account you give us of two Buildings erected in 1742 that one is little so and the other not at all thô they cost Pag^s. 1128. 22. 40, and were then looked upon to be very proper additions to the Works and as this may happen to be the Case again thô perhaps in this last Instance the Sentiments only of Persons may differ. Yet it is incumbent on us to prevent the laying out the Company's Money on any Occasion but what shall appear to all absolutely necessary and may stand the Test of a future survey and this we think cannot therefore be done till some Capable Person can be sent to your Place to carry the works on in a regular manner.

The Indents for Wares & Stores shall be comply'd with by the first Opportunity.

We observe that the Farms are let at an advance this Year and your management therein give us great satisfaction.

As we may have Occasion to send home all the Cloth we may receive from you in September, we would have you half wash the Fine that we may lose as little Time as possible in preparing it for Embalming.

We are very sensible the high Price of Cotton must have a very bad effect upon Your Investment However we doubt not you will employ your utmost endeavours to procure as many Bales as possible, which are the more necessary at this time as the Return of the Morattas to Bengall will probably very much disappoint the Gentlemen there in their Cargoes for Europe.

In case any of our Honourable Masters Shipping from Europe bound to this Port shou'd accidentally pass by and call on you, and that they have any Military for this place we would have you take them ashore till we can send for them.

Instant by which we observe the Arrival of the Sumatra with you but not in time to be returned us ; as we have desired Your Honour &c^t. to put on board the Lapwing the several particulars indented for from the Gentlemen at Fort Marlbrô, you will please to fill up the Sumatra entirely with Patcharee rice and dispatch her to us as early as the season will admit.

We are very sorry to find the Morattas are again entered Bengall and that they are likely to give so great an Interruption to your business, we hope soon to hear matters between the Nabob and them are accommodated that the Investment may not suffer any longer from that cause which is of great Importance to our Hon^{ble} Masters, in regard to the large Tonnage sent out this Year, We shall endeavour to comply with your directions for the Coinage of the bullion into Madrass and Arcot Rupees, and it is a great satisfaction to us that the Measures taken with respect to the early remittances correspond so well with them.

If the Supra Cargoes to Mocha shou^d not be able to procure more than 2000 bales of Coffee and the Gentlemen at Bombay are not provided with bale Goods and Kintlage sufficient to load a ship early home, their Orders are to send her round hither in September to be filled up and as the Prince of Wales will require what Bales we may have ready at this Settlement by that time, exclusive of those at the Northern Settlements, which by contrary winds are some years, detained from us till October too late to be depended on for a September dispatch ; We have therefore judged it most for the Hon^{ble} Companys Interest, and to prevent any delay in the sending that ship away in time should she come hither, to take out of the Mountague the pepper consigned to Your Presidency from Tellicherry, The large Tonnage and the Circumstances of your Investment, will not we presume

Ultimo; This Waits on you by the Beaufort on whom we have laden the parcel of Copper which was on board the Prince of Wales for your Presidency, but on Weighing it here we have found a deficiency of 9. ^{qrs.} 3. ^{lb.} 12 which we endorsed on the Bill of Lading and shall be advised of to Europe that the difference may be demanded there.

We have also put on board this Ship part of the copper received by the York of the remainder we have had an opportunity of disposing of One hundred and fifty Candy at Outery at the rate of about Forty two Curr^t. Rupces $\frac{1}{4}$ Bengall Maund ready money which from the Price Currents we have seen is considerably higher than with you, and as we understand you have a considerable quantity in your Godowns besides what may be consigned you this year, We have kept one hundred Candies more which we shall put up to sale in January and are in expectation of as good a price. This will enable us to send a larger sum in ready money than we could otherwise have [sent up] from our necessary occasions, and as there may be probably a vent for such a quantity here yearly, we desire you'll favour Us by the shipping in February with your Opinion of what price may be expected the ensuing season at Bengall that we may Govern ourselves thereby in our future sales.

If the Circumstances of your Investment should require your Honour &c^a. to put on board the ships you may dispatch to us in December a Larger quantity of Salt Petre than Ordered you may please to let all such surplus be put in a Bill of Lading apart, that we may have it in our Power to take it ashore here, should we be in a capacity to fill up that Tonnage with Bales in the room of the Petre, this we take the Liberty to mention as we are se[n]sible the Tonnage to the Coast and Bay is very considerable this year, and as your Honour &c^a. thought it most proper to act in this manner the last on account of the great charge of Demorage in order to return the shipping.

In answer to which we are to acquaint you, that with respect to the Fine Cloth We have had a due regard in our Indents sent you to what our Honble Masters have been pleased to order therefore we cannot exceed the Quantity there mentioned, But if you are of opinion advancing something on the Last years prices will encourage your merchants to bring in [the] Ordinary, we permit you to give as far as Two Pa[godas] & Corge more for the Long Cloth, and one for the Sal[ampores] for all they may bring in after the Galatea's disp[atch].

The 5th. Instant arrived here [the Swift] Snow who left England the 12th. April; and bring[s advice] that War was declared with France the last of [March]. We shall send you our further directions relat[ing to the] Bales to be sent up in December by another Op[portunity] and now recommend to you to keep your Garri[son in] order to prevent any attempts from the Enemy.

We are much obliged to your Hon^r. &c^t. for the trouble you have taken in regard to the Ship that was lost at Uppara and for the papers transmitted Us; as our time has been lately employed on other Matters, We have not yet proceeded further on that Affair.

Your Letter directed to the Chief & Council at Tellicherry received by the Mercury was forwarded thither the 4th. instant, and today a Pattamar will set out with the Duplicate Letter received by the Sumatra.

We are heartily concerned to hear that the Nabob should occasion Your Honour &c^t. so much trouble in your business at a time when the well carrying it on, is of so great importance to Our Honourable Masters. It will be a great satisfaction to us to hear it was of no long continuance, and that you have yet been able to make [. . .] Investment. In our Letter by the Duke of [. . .]ted you what par[t of the] Tonnage we had expecta[tions of . . .] business having since gone in such a manner that we promise ourselves the being able to comply with the same.

The Box Packet Your Honour &c^t. sent us by the Mercury was forwarded by the Prince of Wales, who sailed the 7th. instant for Europe. That by the Sumatra we shall take the first opportunity of sending away agreeable to your desire.

The eight Bales of Jugdea Baftaes by the Sumatra, we have received.

The Princess Augusta's arrival from the West coast, we have waited for with some impations; But as she does not yet appear we imagine she may have passed our Port and proceeded to Bengal; If she should have arrived with you, and that upon opening the General Letter from that Settlement to this Place, you find they are in want of any particulars which are in Your Honour &c^{as}. power to supply them with, and you judge of consequence enough to send them directly, should you have dispatched the Lapwing before those advices reach you, in such case you will please to send the Princess Augusta thither, otherwise that you will send her up to us with Rice or what ever you may think proper to put on board her.

Your Honour &c^t. will before this have been acquainted of the declaration of War against France As frequent advices between the two Settlements may be of great service on this important Event & as they were found to be very much so in the late War, We have laid Tappey Peons on the Road as far as Ganjam, at the distance of about 25 English Miles from each other which we are informed was the then extent for those in pay of the Madrass Presidency & That from Balasore to Ganjam were appointed and received theirs from the Bengal Presidency. We shall accordingly continue this method of conveying Advices to and fro, as long as your Honour &c^t. and we shall judge they may answer there Purposes.

In case the Lapwing should not be sail'd, we request Your Honour &c^t. will send on her to the West Coast about Twenty or thirty Barrels of Gun Powder.

Our Honourable Masters have given directions to the President and Council of Fort William to send you from thence their Ship Lapwing, by which conveyance we have desired them to send you some stores and Patcharie Rice, part of your Indent received by the Sumatra: she will we suppose proceed to you in the usual season, and by the Cæsar you will have the necessary Orders relating to her Dispatch, and least any accident should have prevented your receiving them we now send you copy of their Commands to you under the 16th. December by that Ship.

3. We expected to have found the Sumatra on her arrival here from Bengal filled up with Patcharee Rice, but the Gentlemen there write us it was not to be had and that they could only send us the Ordinary, One thousand Bags of which is continued on board: We have put on board her some Long Cloth, Salt and other Stores as P Invoice herewith sent you, amounting to Pag^s. 3214. 21. 71, We also return you three Coffree Boys, who have been employed under Our Workmen here.

4. The 5th. instant arrived here the Swift Snow from England, who brings Advice of War having been declared against France the 31st. March. On this event it will be highly necessary to keep Your Garrison in a proper posture of defence against any designs of the Enemy.

5. Our President sends the Deputy Governour some directions to be delivered the Commanders of the homeward bound shipping, sent to him by the Secrit Committy.

6. The Neptune, Severn and Duke of Lorrain were safe arrived in England, but the Grantham was unfortunately lost off Folkstone with all her Cargo, but her Men were saved.

7. We observe you continue our Ships & Vessels Heads upon Your Books from Year to Year: This is not regular; We therefore direct for the future that you write them off, annually to Account Current Fort St. George. We would have you also constantly keep two Columns in our Account; One for Dollars, the other for Pagodas, a Method you have dropped in your last Books. In the Packet comes inclosed a List of our Adjustments with your Settlement, some of which being of long standing you'l take Care to be punctual in entering.

Since our last under the 10th. Ultimo we have received your Letter of the 26th. August and 7th. September. The former by the Galatea with 211 Bales of Calicoes which have been delivered here.

We shall supply you with some Fire Arms in the room of the Old ones you sent hither on the Galatia.

We observe what you mention relating to your Investment at Uppara, that since the French have advanced on the Prices, you have not received a single piece of Ordinary Long Cloth or Salampores from that place; you will find by our last that we were not insensible of the difficulties you would lye under on this Account & therefore on your first representation of this matter in your Letter of the 5th. August we lost no time in Acquainting you of our consenting to allow Your Merchants Two Pagodas & Corge more for the Ordinary Long Cloth and One Pagoda for the Salampores, which we hope will prove a sufficient encouragement for your Merchants to go on with the Business.

You will be able we suppose to provide conveyances for what Bales you may have to send up in December, by the hire of Vessels out of your own River. You will take care to dispatch them as soon as possible after the full Moon in December

which happens on the 8th. and as some French Cruisers may probably Appear on the Coast, you will be mindful to be as expeditious as possible in loading your Vessels that they may not lye long in the Road, with the Goods on board, and that the Masters have caution given them to speak with no Vessels at Sea nor trust to any Colours, & to make use of all Proper Means whatever to avoid an Enemy in the Passage hither.

The Owners of the William & Sarah have applied to us for the Freight of the Treasure sent on her for the Use of the Three Settlements; We have agreed to allow them Sixty Pagodas, which you are to pay to Captain Bright the Commander of her now with you, of which sum Vizagapatam is to be charged Twenty Pagodas, Ingeram Five, and Maddepollam Thirty.

We wrote you the 10th. Ultimo, since when we have received your severals of the 1st. 8th. 12th. & 18th. of that month.

The Morton imported the 18th. with the One hundred and two Bales laden on her; as soon as they are Washed and Sorted We shall send you our remarks thereon.

We are sorry to observe that on the cha(n)ge of Government in your parts the Officers should have given you so much trouble on this occasion, and not only in detaining the Ship several days but in stoping the Chay Goods that were designed to have been sent by her. Our President has wrote thereupon to the Nabob of Rajamundrum and the Fouzdar of Metchlepatam, which we shall be glad to find prove of any service; But as these Governments are now sold to the highest bidders, and the Nabob as well as Officers changed every two or three years, there appears to us very little hopes of obtaining redress from such Persons, who have nothing else in view but to extort what they can from every one during the time they continue in their Posts. This ill pollicy of the Moors must in few years terminate in the utter ruin of those Countries, when they will too late see their error. In the meantime there seems to be no other way left but, either to submit to some hardships, or withdraw from the reach of their Power.

We have taken into consideration what you write us about the Dutch advancing their Prices and therefore to prevent an entire stop being put to the Investment on that account we think proper to allow your Merch^{ts}. 2 Pag^s. ₤ Corge on the Long Cloth Ordinary and one Pagoda ₤ Corge the Sallampores Ordinary for all they bring in after the Moreton's Dispatch for this place last Month.

For fear of any miscarriage to Your Letter to them We shall in a day or two acquaint them of what you have wrote us on this Occasion.

We observe that the Hoñble Company have been pleased to confirm the Allowance of One hundred & forty Rupees ₹ Menssem to M^r. Smith, which shall be duely complied with.

The several Settlements on the Coast having on Account of the War desired to be furnished with a quantity of New Fire Arms, It is not in our power to comply with what the Gentlemen of Anjengo have desired of us, to send them Five hundred for the service of the King of Travencore, and could we have spared them any, there would have been no Conveyance offer'd to have forwarded them thither. We have received your Letter of the 6th. Inst^t. which came to hand last Night in which we observe the Nabob had sent for the Maldar of the Factory and insisted upon your taking 500 Timbers, as you had done 300 last year from the former Nabob and that you must either submit or might leave the Country, This is talking

in a strain very foreign from his real Desire, for he cannot but be sensible, that the greatest Part of his Revenues arise from the commerce the European Nations carry on in his Government, and particularly that of our Company and he would with concern see that Day, well knowing how greatly it would effect him, even for the short space he is like to hold the Government, and that such are his Expectations this Behaviour of his seems to be a convincing Proof, or otherwise we think he would not pursue such Measures. The absolutely refusing to take them will we suppose occasion an entire stop to the carrying on your Business and some further Insults, & therefore it is to be consider'd whether the Loss that may accrue on the sales of the Timbers be not of much less consequence than the other, the manner of doing it is indeed unwarrantable and so are all Impositions of what Nature soever, but this is not the first Instance by many of the ill treatment the Europeans have met with in these Countrys, which have at length obliged them to abandon their Settlements till Time & reflection had made the Nabobs and Rajahs wish, when they were pressing for their Return, for where Force is not made use of to keep such Persons in awe, if Interest does not prevail with them there is no alternative, you must either comply or take your leave we should be concern'd to find ourselves under this Necessity and we hope Matters may be so manag'd as to prevent their being carryd to that Extremity, our President wrote the Nabob lately and will in a few days send him another Letter, but we apprehend all the arguments that can be made use of will avail little with a Person who has paid to dear for his Post and who seems determin'd to lose no Opportunity to make it as advantageous to himself as possible for the short Time he may expect to have it. The present affair is not of so very great consequence & if he goes no further, the advantage of a good Investment will greatly overballance the Loss the Timbers may occasion and his Behaviour in future will determine our further Resolutions.

We are favour'd with your Letter dated the 17 Instant N.S. in which came inclosed Copy of some articles of agreement concluded between the Settlements of Mahie and Tellicherry in the years 1728 and 1742, as well as of a Proposal offer'd at this time by M^r. Geekie for confirming and extending the conditions thereof now War is actually broke out between our two Nations in Europe, the same to be ratifyd by the Respective Superiours, of Pondicherry & Bombay.

We have the honour to assure you Gentlemen that you judge perfectly right of our sentiments for concurring with any Measures calculated for the common Benefit, But as the Settlement of Tellicherry is subordinate to Bombay, it will be necessary for us to know their determination in this Point previous to anything to be concluded or by us, on the receipt of which we shall have the Pleasure to address ourselves again on this subject.

It is seldom or ever that it comes within our Province to send any of our Companys Shipping to the Malabar Coast, they generally proceed from Bengall and the Commanders receive their instructions from the President & Council of Fort William.

If it is thought expedient to send any of his Brittanick Majestys Ships of War abroad we shall with respect to them be under the same Circumstances, as you mention your selves to be with those of his most Christian Majesty, as they will act by authority independent of us.

The 25th. Instant we received the [accompa]nying Letter from the Governour and Council of Pondich[erry] address'd to your Honour & c^t. and we presume is on the sam[e] subject with one sent to us at the same Time in which they acquaint us that they had received Letters from their Company at Paris dated the 14th. April

1744 recommending to them th[e] maintaining an Harmony and good Intelligence with the Trading Nations in the Indies, upon which they have offer[’d] us a Proposal for establishing as they term it, a Tranquility between the English & French from this side of the Cape [of] Good Hope as far as China & beyond it and to that end [that] we should give Directions to our several subordinates as [well] as the Shipping both of the Companys and private not [to be] aggressors in any shape whatsoever against those of [*subsequent matter lost*].

[. . .] of Your Letter [of . . .] are pleased to communicate [. . .] your Superiours with Respect to the [maintaining an Harmony] and good Intelligence with the [. . .] of the Trading nations in the Indies expressed [in the Letter from] Paris of the 14th. April 1744 and your [proposal] thereupon to this as well as the other Presidencys of [. . .] and Bengall for establishing respectively a Tranquil[ity from this] side of the Cape of Good Hope as far as China [& beyond it] and to that End that we should give Directions to our several subordinates as well as the shipping both of the Companys & private not to be aggressors in any shape whatsoever against those of the French Nation as you Gentlemen are pleas’d to acquaint us you have already done on your Part, To which we beg leave to say for Answer that we have a perfect sense of the good Disposition of the Gentlemen at Paris as well as your selves with regard to the Trading Nations in India, But however conformable these Measures might be to our Sentiments yet as our Company have not hitherto furnished us with Power to enter into such an agreement as is propos’d by you, We hope till their Orders reach us, you will permit us to stand excusd from any such Engagements, as one of this Nature must necessarily be subject to their good Pleasure, But with a Permi[ssion] [*subsequent matter lost*].
