Notice being given us yesterday that the Indisposition of Chatoo Chitty was such as gave little hope of our seeing him by the 3d. or 4th. Instant, An Ola was wrote him by the Chief, desiring he would send hither his Partners for to Adjust their Years Accounts, & on their coming to Tellicherry this Morning, a Meeting was called where they gave their Attendance, and after some indifferent discourse, they acquainted us they were sent by their Partner Chatoo Chitty who was not able through his Indisposition to wait on us himself that they were Order'd by him to finish and Conclude the preceeding Years Accounts, & withall to let us know, that he hath agreeable to his promise made us in May last, Gather'd in what Pepper he was able but not a Quantity exceeding One hundred & Twenty Candys, that he had as good as Secured One hundred Candys more, which was [in the] Hands of the King of Cotata, & that both these parcells he would supply us withall by the End of this present Month (if we thought fit) but nothing under the price of Sixty six Rupees the Candy near which Rate it would cost them ere it could be Weighed off to us in our Warehouse, They were after this Declaration taken aside by our Linguist and further Question'd concerning the price, & whether a larger Quantity co'd not be had by the latter End of September or October, but would not alter from what they first had offer'd, however promised they wo'd proceed leisurely in Collecting the little that remaind Outstanding in the Country, & whatsoever Quantity it might be, it shod be Reserv'd for our Honble Masters Service, but at present they could not on any Consideration (by reason of the present Scarcity) venture to Contract with us for more than Two hundred & twenty Candys at the Rate of Sixty six Rupees & Candy, & the Money to be advanc'd them immediately, which Terms (& no others) were those they had to propose.

Considering therefore that the Opening of the Season is so near at hand, that fresh Demands may be expected from abroad for this Commodity, & that there is rather a prospect of it's rising than otherwise, 'till towards the Month of January next Ensuing, besides the Impossibility there is of our being Supply'd from other Hands with the like Quantity on so reasonable Conditions—The Board Unanimously Agreed to Accept their proposall. That is to

say, That We allow them at the Rate of Sixty six Rupees & Candy for Two hundred & twenty Candys of Pepper, to be deliver'd into our Warehouse at Tellicherry by the last of this Instant August, & the whole Amount [thereof,] to be immediately advanc'd them in Rupees.

DIRECTED therefore that the Treasury make payment of said Sum accordingly; The whole amounting to Rupees Fourteen thousand Five hundred & Twenty.

The Chief signified to the severall Members of the Board now assembled, his having private notice from Divers Quarters that the Dutch were endeavouring to Possess themselves of the Island Durmapatam, and to Fortifie there for which purpose they had made Proposals to the Prince Regent of these

Countrys, therein obliging themselves to Humble the Moors, and bring them to his Terms, putting the Fortifications about Cannanore now in possession of Ally Rajah's Heirs into his Hands, and afterwards to Rase their own Fort, and remove to Trentapatam, to Effect all which, vast Presents were preparing & suitable Messengers to Accompany the same.

As the Coldness shewn towards us by this Prince, since his being Denied Assistance from Bombay, and the Secrecy that seems to be regarded in carrying on this Fatall Negotiation gives but too just Cause to apprehend something of that Nature from a people who have all along given proof of their Intentions to deprive our Honourable Masters from having any share of the Trade of this Coast, and as their Gaining fcoting on Trentapatam will in a manner Render them Masters of the whole 'Tis Resouved (as this Business is of the utmost Importance to the Settlement and to our Honble Masters Trade on this part of the Coast) that the Chief Cause proper Spies to be sent, as well among the Dutch at Cannanore, as the Princes Ministers in order to find out the Certainty of these Reports, to the End We may hereafter be able to resolve on such Measures as seem most necessary to be taken, in Order to prevent this Treaty from being Concluded, & if any such is in Motion, that immediate Advice be render'd thereof to our Superiours at Bombay for our more Speedily obtaining such Orders as they may think fit to give us for our Guidance.

Resolved likewise that our Fort of Codolee be put in such a posture of Defence by Repairing the Ditch, and Ramparts, as to be able to Command the Mouth of that River by Planting thereon a Battery of Heavy Cannon since the Weather permits, and ere the Dry Season approach, when a Work of this kind cannot be carry'd on without Water, save at Double Expences, and out of regard to the positive Orders from the Honble the President and Councill which are to support the Honble Company's Title to the Mouth of that River, in Opposition to all Intruders whatsoever.

OUR Linguist acquaints us that after Discoursing our Merchant Chatoo Chitty on the Subject of Pepper he had at last brought him to make us a farther tender of One hundred and Seventy Candys to be Deliver'd in by the latter End of next Month, but that he had no manner of hope to reduce him to any thing under the Rate of Sixty eight Rupees P Candy; He was hereupon Order'd to Question him farther on this Head, to try if any Abatement could be made, but finding it impossible by reason of the present Scarcity, & in regard that our Orders without any Limitations to procure a much Larger Quantity for the Two Europe Ships expected at Bombay, & to be dispatch'd as We suppose in January next, It was Unanimously Agreed to Accept the same since no prospect offers of Compassing any further Quantity till the New Crop comes in, on the like Conditions, and whereas he insists that to the Amount of Six thousand Rupees or thereabouts be advanc'd him in part of this Contract.

DIRECTED that the Treasury Discharge the same in Rupees & Pagodas, The former to be Rated at Five & a Quarter Fanams as usual & those now by us of the Latter being of Negapatam at Sixteen which he likewise assented to.

MEANS having been found by our Linguist to bring hither a Braminee belonging to the Princes Palace, well skilled in their most private affairs: The Chief Acquaints us he took occasion to discourse him concerning their Transactions & Preparations against the Moors, which Led him into a Confession that a Braminee was Dispatch'd by the Prince in May last to the King of Cochin; with a Blank Ola under his Sign Manual accompany'd with another to Sd. King Signifying to him in the Mallabar Style as they were Brothers in Arms he hoped he would endeavour to prevaile on the Commandore of Cochin to send him what Assistance he could spare for to Humble the Moors, who after many Attempts made by him against them he found he was not able to Reduce to their former Obedience, adding withall that they had Broke down, & Defiled his Pagodas, Slain their Priests, and Committed many other Outrages; which he was resolved to Revenge at any rate, and therefore desired he would fill up the Blank Ola, which he had sent him Sign'd in such a manner & Style as he Judg'd requisite, pressing therein the Commandore to Afford him Succour, in return of which he would not faile to Gratifie the Dutch Company in any thing they might request within reason.

To this he assures us, no Answer is as yet come, but that the Prince is in daily expectation of one, however some advices receiv'd from Palliacatacherry from Suamy Putturah by the Chief seem positive in that one was preparing to be sent along with the Proposals mention'd in our Consultation of the 19th. which if Granted by the Prince Regent, must infallibly Destroy these Settlem^{ts}. and render the Dutch Nation Sole Masters of this part of the Coast, by giving them power over the Rivers Trentapatam, Bengatt, Durmapatam, and Codolee, from whence We have been chiefly Supply'd with Pepper and Cardamoms, since the time the French took possession of Mihie.

This Affair therefore is Judg'd of such Consequence by the Board, as to require an immediate Express to Bombay for Orders how to Govern ourselves in this Unfortunate Conjuncture, and ere the Settlement be entirely lost, being the only step We are able to take, since our Superiours are positively pleas'd to tell us, We are not to Engage in any Disputes, or Launch out any Sums to the Prince without their Immediate Direction.

ORDER'D therefore that Advices be immediately prepared, and sent by Tony Express to M^r. Thomas Pattle at Onore, recommending them to him to be forwarded forthwith by a Light Boat from thence.

OUR Linguist Domingos Rodrigues lays before us Translate of an Ola receiv'd by him this Morning from the Prince, being in answer to one he was Order'd to write by the Chief giving Information that the Moors expected Assistance from the Syddee, [sic] who 'twas reported would make an Attempt on Billiapatam early in the Season: He therein desires s^d. Linguist will provide him Carriages for Ten Guns, and, some Hatmen to Work them having been as he says, totally Deny'd any assistance, by the English and whatever hope he might have of Help for the time to come from others, yet at present he had no other way but this of Supplying himself and therefore desired an Immediate answer.

As the present Scituation of Affairs renders it absolutely necessary for us if possible to keep him in our Interest, and least his being deny'd such a Trifle should heighten his Resentment to a pitch that may in future prove very fatal to our Hoñble Masters Interest, and Induce him to Accept the Dutch Proposals when they Arrive, merely out of Pique & Design to prejudice this Settlement, and out of regard to his present Bad Disposition towards us, a Concession of this kind may probably Mollify him so far as to prevent his Gratifying the Dutch, till such time as Directions may be given from Bombay concerning this Matter; It is Agreed that with all the Secrecy imaginable he be supply'd with the Necessarys he wants, for Mounting, and a few of our Christian Inhabitants for Plying his Guns, since no other Method appears to us at present, whereby to prevent his totally Neglecting our Interest, and Siding with that of the Dutch Nation, who when once Settled with his Consent near enough to Annoy us, We are Sensible will soon render this Place of no Service to our Hoñble Employers, and themselves Masters of the whole Trade of these Parts.

ORDER'D likewise the Chief write him the following Ola, as his Answer thereto may in all likelyhood Discover something further of his Intentions.

"It having been reported to me that the Scyddee was preparing a Naval "Force to Invade your Highness's Territorys, & Assist the Moors, I immediately Order'd our Linguist to give you these Tidings by an Ola Express; He hath since laid before me your Highness's Answer, whereby I find you greatly "Dissatisfied at my not having been able to Afford you greater help from hence.

"I have before fully Manifested to your Highness that I cannot Exceed the "Orders of my Superiours, but that fresh ones may be obtain'd on this occasion, "I have dispatch'd a Light Boat Express to Bombay, and whatsoever here- after may fall within the Reach of my Disposall, I shall with great Heartyness and Zeal apply towards your Highness's Service. Your Highness's Letter to the Linguist signifies your being in want of Ten Gun Carriages, and some other Materials belonging thereto when your Highness acquaints me of what Dimensions you would have them I shall endeavour to provide them, and send them where you may think fit to Order.

"Hatmen what can be found here, and willing for your Highness's Service shall likewise be sent, for what else you may stand in Need of, I shall Govern my self therein according to the Orders I hope shortly to receive, having a great desire to be continued in your Highness's Favour.

WILLIAM JEYNSON.

The Chief lays before the Board the answer he receiv'd from the Prince Cunhi Homo to the Ola he wrote him the 23^d. Ins^t. in Substance as follows Viz^t.

"I have receiv'd your Letter; which gives me to understand you have no want of Inclination, but Authority from your Superiours to Assist me in my present Exigency, 'tis not possible for me to obtain the Orders you require, being only to advise the Chief of Tellicherry of what I stand in need, and on him it only rests to represent my requests.

"Tis now Four Years that I have been under these Publick Difficultys, in "all which time I have not been wanting to Communicate my Necessitys; If "'tis you that ought to procure me Succours, methinks—you have had time enough for it, but I am rather Inclined to believe what you have done, has been with very little Heartyness; Judging I could not stand in need of any great Assistance against a Vassall of my own; but the Case is now alter'd, for they now tell me a Powerfull Scyddee means to Assist these Rebells; I "Suppose the English Company would not willingly have me Excluded.

The King my Uncle, when he gave the Fortress, and other Priviledges to "the Company, had no other Interest, than an hope of being Assisted for the "time to come, against any of his Enemys, when it might be necessary; If 'tis "their Intention to Grant me any, now is the time, or never.

"All that I want to say is not necessary for me to Commit to writing, and "much more Improper for me to Trust with this Messenger, wherefore am "desirous of a Meeting with your Linguist, If you have a mind to send him to "Cherrica, I am there, and have Severall things to Communicate to you by "him.

"The Hatmen and Gun Carriages, if you have a mind to send them it "must be quickly; I'll send the Measure of the Carriages by a Soldier; The "rest I shall Impart to the Linguist if he comes."

And as he therein requests the Linguist may be sent to Cherrica; It is Agreed he wait on him forthwith in Order to learn what he has to propose, and that he acquaint us as soon as possible with the Substance thereof.

The Tony Dispatch'd to Onore the 21st. Ultimo returning this Evening bro't us a Letter from Mr. Thomas Pattle, wherein he informs us, that our Paquet for the Honble President & Councill of Bombay, recommended to his care, he was obliged to send to Carwarr to be Forwarded from thence, none of the Onore People being willing to Venture so far as Bombay, most of their Boats being taken last Year by Angria; and that he had Certain Advice our Two first Paquets were safely Arrived there.

Receiv'd a Letter from our Callicutt Linguist, advising that the Governour paid him the 22^d. Ult^o. on Account the Samorine's Debt to our Honble Masters Thirteen hundred Ninety six fanams, & Three Vis, and that he gives him hopes

of receiving in a month or two Fifty thousand Fanams from the Queen of Challaparat[e.] but that nothing farther remain'd Uncollected of the last Years Customs; The whole amount of which he had now faithfully paid into our hands agreeable to the King's Orders, to whom he had sent his Accounts; The Price of Coins are as follows Vizt.

Our Linguist being return'd from Cherrica, where he was Order'd to wait THURSDAY on the Prince the 29th. ulto. acquaints us that on his first Arrivall there, he perceiv'd a more than ordinary Coldness amongst the Ministers in Generall: that in about Twenty four hours he had an Audience with the Prince, who in publick made the following Declaration.

3ED.

"That for his part he was rather inclinable than otherwise to Accomo-"date with the Moors, how Treacherous soever they might have been, if to be "done on terms suitable to his Dignity, nor should he have much to Boast of; "was it even in his power to Overcome them, being the most Infamous and "Abject of all his Vassalls; As the English had free Liberty to Reside in his "Country, & Enjoy'd many Priviledges therein, he had hitherto hoped, they "would as far as in their power, assist him to Reduce these Rebells, or at least "advise him what steps to take in order to bring them to reason; The Moors "not only Attack'd them with Mallabar Weapons, but with people and Arms "from Abroad, against whom his Soldiers were not able to Defend themselves "under so great a Disadvantage; He well knew it was not in the power of the "Chief of Tellicherry to assist with Armys by Land and Fleets by Sea, "though in times past he had hopes of being assisted with a share of both "when in want thereof from the English, but as for Military Stores and Arms "which he could only have from Europeans, he knew not where to procure "them if Deny'd by us, as he could not put so particular a Confidence in any "other Nation, and could he but be Supply'd at this time with Stores sufficient. "it was equal to him whether he had them as a Friend or Merchant; That so "soon as he knew what might be resolved on this Head at Tellicherry, & had "an Answer from thence, he wo'd take the necessary Measures, for he was "Determin'd notwithstanding it might be at the Expence of his Treasure and "Subjects, to Protect them if possible & put them in Quiet Possession of their "Estates.

He tells us the day following he had a private Audience, where after some Discourse had passed, he found an opportunity of asking his Highness, if he expected any Assistance from other Europeans, & if any had been Offer'd, & upon what Terms, to which he answer'd him, but with great Coldness, that he had no hope of Succour through any such means, & after making mention of the Letter wrote the Commandore of Cochin, his Highness made answer, that he supposed the Dutch would Dissemble with him in the same manner as they had done at Bombay, & seem'd unwilling afterwards to talk on this Subject, from whence our S^d. Linguist Judges, the Prince either is Destitute of hope from the Dutch, or that he is inclinable to keep the same as a Secret from us, but most likely the latter, for when he afterwards came to Discourse with Cadalacar Putturah one of the Princes Chief Ministers, he was told in a very open & friendly manner, that the Commandore of Cochin had strenuously recommended it to the King of Mangatt, who is much in the Dutch Interest, for to procure a Grant from his Highness of the Island Durinapatam for that on being put in possession thereof, they would oblige themselves immediately to Drive the Moors from

Cannanore, deliver the Same to the Princes Mercy with all the Riches therein, pull down their own Fort, and retire to s^d. Island; The King of Mangatt not being well acquainted with the Scituation thereof, inform'd himself by a Braminee called Narran Putturah, if the Prince Cunhi Homo would Accept these Conditions, which he said in his Opinion he readily would, was it not for the small Pagoda that is Built on the Northernmost point, which he very much doubted, whether or no he would give up.

Afterwards a Meeting was held by the Comandore [sic] of Cochin, and the King of Mangatt, where the aforesaid Narran Putturah assisted, when a Mapwas produced, Describing the Scituation of that Island, & the Pagoda thereon, which the Commandore said he wo'd Separate from, by Cutting a Channell for the River to pass, provided the Dutch might be put in possession of the rest. With this Message Narran Putturah was immediately Dispatch'd to the Prince, with Assurance that every thing the Dutch had promised, would be put in full-Execution, if his Highness would but Signific his Assent by an Ola from the King of Mangatt, with which Advice his Highness seem'd highly pleas'd but did not however think it proper to write the King of Mangatt, but rather choose to make use of the King of Cochin, to whom he sent a Blank Ola only Sign'd by himself, desiring he would fill it up as he thought fit, but as yet no Answer was come thereto.

Our Linguist proceeded to ask him, what could be the reason of their Commencing a Treaty so prejudicial to the English Company, and if the King of Cotata had given his Assent to which he made answer, they would first advise us ere the affair was settled, and that the King of Cotata had not only given his Verball Consent, but would do it by Writing if necessary; that his Highness only waited an Answer from the King of Cochin, when he would Send Bangay Ray his Head Minister to finish this Affair.

The Generall Paymasters Account Disbursements, with the Warehouse-keeper and Storekeeper their Accounts of Receipts & Issues.

The Narrative presented us yesterday by our Linguist being read & the Princes Head Minister in Waiting for an Answer from the Board to what therein proposed by the Prince; The Question was put by the Chief what Reply was to be made, & what Steps likewise best to pursue to prevent his

wholly Disregarding the Honble Company's Interest, & Espousing that of the Dutch Nation, 'till such time as We may have Orders from our Superiours, how to Deport ourselves in so Critical a Conjuncture; And it appearing to us the most Effectual way possible to put a Stop to the Progress of our Enemys, for to bring about a Reconciliation, if to be done between the Prince & the Moors, since the former himself, seems rather inclinable thereto than otherwise.

After some Debate on both points, It was AGREED that We signifie to the Family of Ally Rajah, the Intentions of the Dutch, not only for to Drive them entirely off the Coast, but afterwards to Possess themselves of the most advantageous parts of their Territorys, which perhaps may Lead them to some better Reflection; And that a Civillanswer be made to his Highness, assuring him We are ready on our parts (as having a just sense of the Favours receiv'd from him by our Honble Employers) to supply him with any thing within the Reach of our Power so as not to Rob our Garrisons of their Necessary Defence, having no other means as We apprehend at present to keep him in our Interest, on which the Safety of this Settlement does so manifestly Depend.

And whereas they have further requested of us to Supply them with Forty musquets & Bayonets, besides the Gun Carriages & other Trifles formerly agreed to send them, for which no Mony was tender'd, The Question was put to the Severall Members of the Board, how far it might be Consistent with our Orders from Bombay, which positively Directs us only to spare them for Ready Mony, without making the least provision for Emergencys of this kind, who after Maturely Weighing the Evil Consequence of his being farther Disgusted at this time, do Unanimously Agree, since there is no other Interest Consulted on this occasion, but that of Hoñble Masters and since the Stores now required from us, cannot amount to any thing very Considerable, that s^d. Oders in Case no Ready Mony is tender'd be Dispens'd with, & the Amount of what Deliver'd brought to the Prince's Accounts & that the Forty Musquets & Bayonets aforemention'd, be deliver'd them accordingly.

He says that the Samorine has Dispatch'd some Ministers to the French at Mihie, to procure a Loan if possible of Twenty thousand Fanams, that Government seeming much straightned for Mony to Carry on their Charges of the Mamanga.

DIRECTED therefore that an Express be sent our S^d. Linguist, ordering that he immediately Contract for the aforesaid One hundred & fifty Candys on the best terms he can, if not to Allow the Merchants at the Rate of Twenty six Narodys the Candy, the Mony to be paid as the Pepper is deliver'd in, and that a sufficient Quantity of Fanams be remitted him for s^d. purpose by our Jangados over Land.

Besides the Military Stores Agreed to Supply the Prince in our Consultation of Yesterday a further Demand is made on us by his Head Minister of One thousand Cartridges, Four Barrells of Gun powder, Two hundred Shot of Sorts, with some other Trifling Articles; It is Agreed they be spared him on the same Conditions and for the reasons therein mentioned.

No Objections being made against the price of Pepper now tender'd, or the Party to be Trusted, It was Agreed the Offer of Sa. Chautoo Chitty be Accepted, & that the Amount of the affores. Pepper be advanc'd him at the Rate of Sixty five Rupees & Candy and Five & a Quarter ffanams & Rupee as usual, he promising to make Delivery thereof within the Space of Twenty days at farthest.

And as he so earnestly requests the full Amount of the Second Contract for One hundred & Seventy Candys may now be paid him, since a great part thereof is already deliverd; Tis further ORDER'D that in part of sd. Contract he be now advanc'd the Sum of Rupees Five thousand Seven hundred & fifty, being near the Amount of the whole when it is in.

By Four of our Callicutt Jangados made a Remittance thither of Twenty thousand New Fanams to be made use of there in payment for the Pepper lately bought for our Honble Masters Account.

THURS-DAY 17.

In a Letter from our Linguist at Callicutt of Yesterday's Date, We are inform'd that the Four Jangados sent hence the 12th. Instant, were arrived, and had made Delivery of the Twenty thousand New Fanams sent by them; That he had also a prospect of Procuring Twenty five Candys more Pepper from the Merchants of Tannore, besides the One hundred Twenty five already bought, but that it could not be had; for less than Twenty five Narodys the Candy: A Braminee, whom he had sent to Chittoa for to observe the Motions of the Dutch, gives him for Intelligence, that many Warlike Preparations were making there, & that although they gave out they were resolved to Build a Factory of Stone at Penany, yet was the Samorine resolved to Oppose them and that a War was expected.

Monday 21st.

MADE a farther Remittance to our Linguist at Callicutt by Four of our Jungados belonging to that Factory of Twenty thousand New Fan^a. to be made use of for the Pepper lately purchased.

He advises us by them that the Twenty five Candys he was in expectation to procure at Twenty five Narodys & Candy, was not now to be had under Twenty five & an half; The Merchants being under Apprehensions of Difficulty in bringing it in, but that he believ'd he sho'd be able to Secure it at that price, which he was Order'd to do, if possible in our Answer.

TUESDAY 220.

Mons^B. Louet the French Second of Mihie accompany'd with another of their Councill, & a Commission'd Officer came this morning to Visit us in a very formall manner, & deliver'd us a Letter from M^r. Tremisot & Councill in Substance as follows Viz^t. That They had the 1st. October N. S. receiv'd a Letter from the Governour & Councill of Pondicherry, advising that the French Company had Ratified and Confirm'd the Treaty made between us at Moylan the 28th. Aprill 1728 and Directed them to make us acquainted therewith, which they also desire We will not faile to do on our parts on having Notice how the same may be Approved by our Honble Masters.

We wrote them in answer that We would not faile to let them know what may have been Determin'd by our Superiours concerning s^d. Treaty, on having notice thereof.

WEDNES-DAY 23_D. By a Munchua belonging to our Linguist at Callicutt, & Laden with Sundry Necessarys for the Service of this Place, We are advised the Custom house Officers could hardly be prevailed on for to Suffer our Lading on Board S^d. Munchua the Materials now brought, such as Chunam, Bamboos, Coyr &c^a. Urging that the Governour was Absent, & had left them no Orders how Vessells under English Colours were to be Treated; that they had actually suffer'd the things now sent, for to pass without the Governour's Leave, which they could not do in future.

DITTO DIE. THE following Letter from the Chief was sent the Callicutt Governour and Directions given our Linguist to deliver the same, & require an immediate answer.

- "I was much Surprized to understand by one of our Munchuas from Calli"cutt that so much difficulty was made by your Officers in permitting the
 "Honble Company's Goods, and Merchandize to be Laden on her, giving no
 "other reason for their so doing than that you was absent, and had left them
 "no Orders how Vessells under English Colours and Protection should be
 "Treated.
- "I have full Assurance from his Majesty that the Honble Company shall "Enjoy their Antient Previledges in his Dominions, and on that Account his "Subjects have been Treated by us with the Usual Courtesy, to Drivers of whom

"Passes have been given for this present Monsoon; But I now perceive that "instead of continuing the Antient Practice of that Port, you are about to "Introduce New Customs whereto I am to assure you the English Nation will "on no Account be Subject.

A Letter from our Linguist at Callicutt, was this Night brought us under Tuesday the 26th. Instant by Two Nayrs of that Factory advising his having Contracted 29. for the Twenty five Candys Pepper with the Merchants of Tannore, (whereof mention is made in this Diary under the 21 Inst.) at the Rate of Twenty five & an half Narodys & Candy, desiring withall We would Remit him Ten thousand more New Callicutt Fanams for the payment thereof. The Twenty thousand sent him under the foregoing Date, being, as he says, come safe to his Hands, for which he had Debted that Factory accordingly.

He tells us that before receiving our last Advices the Callicutt Governour was return'd thither, with whom he had some Discourse on the difficulty that was made of Suffering Goods to be Embark'd on Munchuas under English Colours, but that he seem'd unwilling to give him any Direct Answer, further than that for these fifteen Years past they had Omitted to Examine English Munchuas, & other Vessels under their Colours for certain reasons: however he did the day following intend to Wait on the King at Penany, where this Affair would be consider'd, & on his Return he would give us a more Direct Reply, however in the Interim nothing should be offer'd that wo'd give us the least Disgust.

The Chief's Letter to Sd. Governour not Arriving in time he was obliged, after his departure to deliver the same to his Secretary, and a Braminee his Substitute, who took upon them to open it, and to assure him, no answer could be given by them thereto, however they would forward the same as directed, & Sollicit an Immediate Reply.

By return of the Two ffactory Nairs, remitted our Callicutt Linguist Ten Wednesthousand New Fanams for payment of the Twenty five Candys Pepper, he DAY 30^{III}. advises to have Contracted for, with the Tannore Merchants at Twenty five Narodys & an half # Candy.

It was Moved by the Chief, whether or no it might be most Expedient for to prevent the place being totally Deserted, that our Honble Masters on this occasion (who by this Calamity will be the greatest Sufferers) should not be at some small Expence for the Relief of these poor & Distressd People, who We find altogether Unable to Subsist, unless immediate Relief be given them.

Judging therefore that our Superiours can no wise Disapprove so necessary a peice of Charity, It is AGREED We give our Linguist Directions for to make a provision of Bamboos, and other Materials to raise Barracks for the Infected people, & that proper persons be likewise Entertain'd in pay, as well to Attend them as to Bury the Dead; so that he doth not Exceed the Sum of One thousand ffanams er'e he brings in his Account, when We shall consider, if necessary, further on this matter.

This Affair being Maturely Debated, and the Consequence of Disgusting him fully Consider'd on, It was Judg'd by all of us most for our Honble Masters Interest to spare him the Lead now Indented for, & as far as Five Candys Gun powder, least by Seeking it elsewhere, he Espouse an Interest, We are too Sensible, will soon Root out that of our Honble Masters, from any Pretensions on this part of the Coast in hopes our Superiours will put a favourable Construction on this our Resolution, since We have no Views of our own to Byass us, or any Ends to serve, but those of the Publick.

ORDER'D therefore that the following Ola be wrote the Prince by the Chief

"I observe the Preparations your Highness is making, for the Security of "your [country] wherein I wish you Success, The Lead your Highness resquire "for the] present Service I have deliver'd the Bearer, & shall send [you speedily] "what Powder We can spare, 'though We have seldom such Quantitys in reserve (save what is requisite for the Security of these Garrisons) as your "Highness's Messenger seems to Demand.

"I have not at present any News from Bombay of any kind, when it comes "your Highness shall be Inform'd of what is worth your Notice.

Nov-EMBER, SUNDAY 1ST. This morning the Chief had a Conference with the Prince Cunhi Homo at Moylan, and on his return laid before the Board the following Account thereof.

To Mr. WILLIAM FORBES. &ca. Factors at Tellicherry.

GENTLEMEN

'Tis with great pleasure I remark to you how well our Advices concerning the Dutch and their Attempts against this Settlement, have been understood by our Superiours at Bombay, and that they have given us so Considerable a Latitude for Securing towards our Honble Masters the Prince's Favour, & their Priviledges in his Dominions.

Least any Proposals from the Dutch sho'd come in, I did immediately on Arrivall of the Lethieulier, contrive proper means for to bring the Prince into these parts, and accordingly this Morning I had a Meeting with him at Moylan, the substance of which is now my Intention to lay before you, that something may immediately be Resolved on, for continuing or rather securing, or Enlarging our Honble Masters Priviledges in these Parts, and er'e he return to his Palace (Which I understand will be tomorrow in the Evening) altho' he hath promis'd me another meeting before his Departure, and tomorrow morning I propose to wait on him a second time to finish such matters as may be now Resolved on by this Board.

You very well know Gentlemen, that this Prince, ever since his being totally Deny'd Succours from Bombay of any kind, hath in a manner Ceased to Correspond with us, and that on the Notice I had of a Treaty between him, & the Dutch, I thought it necessary (if possible) to put a Stop to the same, which We have been in some measure Successful in, by sending our Linguist to him, and Supplying him with some Military stores, & by Soothing him with hopes, that our Superiours would do what lay in their power to assist his Highness under his present Necessitys, to whom I wrote I had sent an Express on purpose for farther Orders.

The hopes of my having receiv'd a favourable answer to the aforesaid Advices, Led him immediately on our Meeting, to ask me if the same was come to hand. I told him in the affirmative and that however so well inclined the Honble the Presid'. might be to assist his Highness at this Juncture, yet was it impossible to do it with any Succours of people, The focasion he had for them himself being to Manifest, however that he had given me Orders to Comply with any thing that might be proposed by his Highness within reason, so that these Garrisons thereby might not be render'd Defenceless. He immediately made answer, that were it only the Moors his Vassals he had to

Encounter, he sho'd not have been so pressing, but that as they were now about to be assisted by the Scyddee, it was high time for him to look for Relief from some Quarter or other, & such he must have either from us, or the Dutch, 'though a Rupee from the English was of an Hundred times more Esteem with him, than from any other Nation, what he wanted at present was, that We wo'd assist him with Mony sufficient to maintain Three thousand Nayrs for the Garrison of Billiapatam for Three Months, 'till the Scyddee might be gone off the Coast, & that sd. Garrison might be supply'd with sufficient Military Stores for it's Defence, all which if it could be Granted the Company would not faile of having the same Gratefully acknowledg'd by him, that for trifling matters he would not ask for them, nor even accept those already sent, could nothing farther be obtain'd, that if the Moors were to Triumph over him, he had rather they sho'd do it on him alone, than when assisted by us, for he did not want us to Bear any of the Share of the Disappointment.

I immediately dropt the Discourse, finding him a little Warm, and bid our Linguist change the Subject, & Entertain him a little with the Occurrences of the Country, and finding he was at last brought into Temper to hear other Arguments, I address'd him in the following manner; Judging it highly improper to make him any Offers, 'till I knew how far he wo'd Accede to what I had to propose; The better to find out this, I told him that the only Grant that the Honble Company had from his Highness's Predecessour, was that they sho'd Enjoy the Trade of his Country, exclusive of all other Nations, save the Dutch, that since giving the s⁴. Grants, The French Nation had possess'd themselves of a Considerable part of said Trade, by the assistance of some of his Higness's Rebell subjects and that there were other Nations likewise now endeavouring to withdraw his Highness's Favour from us, & to Deprive us from any share at all of the Trade of these parts, and perhaps not without his Highness's Approbation, that the Company could not spend any farther sums, on such Uncertain Foundation, and for the Preservation of priviledges so ill secured. This Led him immediately to make me the following Declaration, & in the following Words.

"I very well perceive the Drift of your discourse, and certain it is that the "Dutch Nation have strenuously endeavour'd to obtain a Grant of the Island "Durmapatam, and have actually promis'd to Drive the Moors out of the "Country, provided the same is put into their hands. I (not through any "Esteem I have of the Dutch Nation, or Disregard of yours, but as a person "Beseig'd by a Powerfull Enemy, without hope of Relief, & incapable of "Defence) desperately have Blown up my own Magazine; In this manner have "I consented to what the Dutch proposed, and have accordingly wrote to the "King of Cochin to finish the Business, but he tells me in answer that he desires to be excused, for he hath not so much Intimacy with those People as "I imagin'd, desiring withall that I would be Cautious what I did with a Nation of that sort, who would not faile to Grasp at the whole Dominion of my "Countrys, after having the least footing therein.

This he says was all that had passed between him and the Dutch, who he still was willing to Gratifie, provided he could by their means reduce the Moors to full Obedience, 'though that he had much rather We would undertake the Task, being a Nation he had better Experience of. I thereupon told him it was not the Companys desire to be possess'd of any part of his Highness's Territorys, but that We might be supported against all other Nations therein, & Sole Masters of the Pepper Trade, to which End they had been at a Vast Expence to Build severall Forts by the permission of his Royall Predecessours, for to Protect themselves against the Outrages of his Rebellious Subjects; Therefore least such a Vast Expence should be render'd Fruitless, and to prevent the Dutch Nation from becoming Sole Masters of the Trade of his Country; I did desire his Highness would give me his Royall Grant in Writing,

Excluding the Dutch from any Share of the Trade of Randoo Tarra, and from having any pretensions to the Island Durmapatam, Empowering us likewise that in Case they sho'd attempt to possess themselves by Force, of either of the s^d. Places, to Hoist our Flag either upon Trentapatam, or elsewhere, where We Judgd most Convenient, and Defend the same against all European Nations whatsoever.

This he immediately assured me he would do with great Readyness, but withall desired to know how far the Company would assist him in his present Exigencys; But this I could not take upon me to do without the Concurrence of the Board; wherefore do I desire you will be pleas'd to meet me Early in the Morning, & deliver me your severall Opinions in Writing, concerning the present Affair, Deputing likewise some Person of this Board with Authority, that he and myself may wait on his Highness to morrow in Moylan, and Settle our Honble Masters Priviledges on some Certain Foundation, and er'e their Rivals the Dutch can any wise be apprized of the matter in hand.

The Members of the Board deliver'd in to the Chief their Assent in Writing to the Proposals made by him Yesterday to the Prince Cunhi Homo, Judging such most Suitable at present to our Honble Masters Interest and in Conformity to the Orders lately receiv'd from our Superiours.

ORDER'D that M. William Forbes attend him this day for to wait on the Prince at Moylan, in order to finish the present Treaty in the manner they Judge most Suitable to the present Scituation of Affairs, and the Honble Company's Interest.

The Contagion still Encreasing in this District, and our Garrison being thereby so much Enfeebled, as to be obliged to do Double Duty, and the Honble President & Councill of Bombay, assuring us they can't afford us any Supply of People without putting themselves to the greatest difficultys imaginable.

AGREED We address ourselves to the Honble President and Councill at Fort S^t. George, by Two Pattamars Express, requesting of them a Supply of Forty to fifty Men, Europeans, Mustees and Topasses if possible to be sent us by the first opportunity that offers.

The Chief lays before the Board a Letter he has receiv'd from the Sultan of the Maldivies, Signifying his great desire, and Willingness to Correspond with us, as he has sent us about Seventy Cotas of Cowries, now in the hands of our Linguist at Calicutt.

AGREED he have our Directions to purchase them if to be had, under the price of Sixteen Fanams the Cota for our Honble Masters Account, & that the Chief write him a Courteous Letter in return, ordering his people now in Calicutt to be Treated with all the Civility imaginable.

Notice being brought us by some of our Inhabitants, that the Pickeroon Cutty Coilem, on whom Reprizal was made last Year, notwithstanding the promises made by him & his Family at his Enlargement, had actually made an Attempt some days past to Seize a Munchua, and Boat belonging to this Place.

AGREED that We send this Evening a Detachment of our Garrison Soldiers with Orders to Seize on their Tonys, whom We understand are only Two in number, to the End these Paultry Fellows may be Deterred from Insulting us in future.

The Chief accompany'd with M^r. William Forbes returning this day from Moylan, where they had a Meeting with the Prince Regent, agreeable to our Resolution of the 2^d. lay before the Board the following Narrative of their Transactions, which had our Generall Assent.

____ NOVEMBER 1730 ____

To M^R. Hugh Howard & M^R. William Jeynson Factors at Tellicherry.

GENTLEMEN,

Agreeable to our Resolution in Councill the 2^d. Instant, We did this day attend the Prince Cunhi Homo at Moylan, not being able to obtain a Meeting sooner.

After some Discourse had passed between us on the Business in Hand, We came to a Resolution of making him an Offer to the Amount of Twenty thousand Fanams in Military Stores, so far as our Garrisons were able at present to furnish (including in this Account what already spared him for These three Months past) with this he seem'd so highly pleas'd, that he immediately wrote an Ola with his own Hand, & deliver'd it the Chief, in Substance as follows.

"For the greater Security of the English Company, and their Trade & Dealings in our Dominions; Be it known to all whom these Presents may "Concorn, That I Ode Ormem Prince Regent & Governour of the Palace of Palley, by this our Royall Grant, do promise free Liberty to, and Authorize the aforesaid English Company, (and not to any other European Nation whatsoever) for to Trade & Traffick in, buy & sell the severall Goods, & Products of our Dominions; I likewise promise them not to Admit either the Dutch or French Nation, to make any Establishment, or carry on any Trade in the Country of Erebenadoo, Trentapatam nor Randoo Tarra; That in Case either the Dutch, or French Nation sho'd hereafter pretend to Traffick, or Settle themselves in any of the aforesaid Countrys, We do hereby give full Liberty to the English Company to Hoist their Nationall Flag, either on Trentapatam, or Randoo Tarra, in such Place as to them shall seem Conveneint. Given under our Royall Sign Manuall this 2d. of November in the Mallabar Year 906, and the Christian Year 1730."

He afterwards strenuously press'd us for a Loan of Ready Mony, and told us he did not expect any thing at our Hands on other terms, but kindly thank'd us for the Acceptable Present We had made him, for without a small Supply of Cash he could not possibly keep together the Army he had now raised, for to prevent the Scyddee in Conjunction with the Moors, from Pillaging and Destroying his Country; That provided We wo'd advance him a Sum on this Account, he wo'd not faile to Reimburse us in a Reasonable time, & so soon as he could Disengage himself from his present Difficulties.

After many Arguments were used by us to Convince him of the Impossibility there was for us to Anticipate a Sum any thing near sufficient for the Maintenance of his Armies, and that our Linguist had Discoursed his Ministers on the like Head, We thought it most adviseable to tender him a Loan of Ready Mony without Interest, to the Amount of Thirty thousand Fanams, which by what We can find so highly Contented him that he took Leave of us with Expressions of greater Heartyness than We have heretofore observ'd. This, Gentlemen, is the Substance of our Transactions, and herewith We deliver you the Original Ola, hoping it's Contents will both prove Satisfactory to yourselves, and our Superiours at Bombay, since our Honble Masters Priviledges in these parts, seem to be Establish'd thereby on a good & sure Foundation, and for an Expence, that We no wise judge can be thought unreasonable; and Confident We are our Rivals the Dutch, whose Designs are now overthrown, would not Stick at any Expence to Share any part of this Princes Favour, which now We apprehend so well secured towards us. Advices from our Callicutt Linguist under the 9th, from Beepore, inform us FRYDAY of his being retired thither, by reason, that the Pestilence was again Broke out in Calicutt more Violent than before; That the One hundred and fifty Candys Pepper which he had purchased on our Honble Masters Account was all in Warehouse ready Weigh'd off and Packed up; & that he had bought the Seventy Cotas of Cowries from the King of Maldiva's people at Fourteen fanams the Cota; which he would send up in a few days, with other Necessarys for the (service) of this place.

AGREED that the Chief write a Letter to the Governour of Mangalore setting forth, that the Passes given by the English to the Subjects of Canara, are with a Friendly Intent, & only to Signifie to the Honble Companys Cruizers, when they meet any, that such who have them are our Friends, and not to be Molested; That We are no wise Answerable for the Depredations Committed by Cota Marcar, who is a subject to the Samorine, & therefore ought on this occasion to be Apply'd to, & that We hope he will not on this Account, be so unjust, as to molest our People and Vessells in their Lawfull Trade.

And whereas it appears by our Warehousekeepers Accounts, that our Store of Rice is not sufficient for the next Months Expence; AGREED that We furnish ourselves with Two hundred Bales from the Linguist, of which he makes us an Offer at Ten ffanams ? Bale, the Currant Price of the Country, and that the same be Issued out to our Garrison Soldiers accordingly.

SUNDAY 15TH. The Munchuz Dispatch'd by us the 31st. Ulto. to provide Rice at Mangalore for the Service of this Garrison, being now return'd full Laded; The following Declaration was given us in by Dionisyo Pereira our Agent Vizt.

That on his Arrivall at Mangalore, the People in generall told him the Munchua, and her Effects would be made prize by that Government on Account She belong'd to the English; by reason that Cota Marcar had taken a Munchua of Canara with English Pass, they giving for reason that sd. Pass ought to Protect them against all Mallabar Pyrates; This occasion'd him to Hide his mony in the House of Pandera Anta Naique for fear of being Robb'd of it; some days after a Moor Man, a Considerable Merchant of that Place, advis'd him to Buy Rice, & Lade it, for that nothing would happen which he accordingly did; The Governour of Mangalore perceiving this, sent him Word, he had given Orders to stop him, and forbad him to proceed, untill the English had made Restitution, for the Munchua and her Cargo taken by Cota Marcar, and every Body without told him the same, that he could not possibly get out till Satisfaction was made.

Finding therefore there was no possibility of getting away by fair means, he came to a Resolution to Slip his Cable, & take the first opportunity of a Fresh Land Wind, which he accordingly did, er'e they could Gather their people together, or Fire any Guns upon him; He was no sooner over the Bar, but perceiv'd great Multitudes of people assembled on the Shore, & severall small Boats in pursuit of him, as he imagined, however by the help of the Fresh wind, they were not able to come up, so happily made his Escape, & believes from what he hath seen, that all Vessells under English Colours will not on this Account have Liberty to Trade in any of the Ports of Canara, but will be stopt by the Government, when once they can get them in their power.

Imported Ship Joey James Machgill Captain from Bengall, & sail'd the same Evening for Bombay by her receiv'd a letter from our Callicutt linguist advisg. the receipt of the Two thousand New & Eight thousand & ninety eight old Callicutt Fanams, remitted him the 5.th Instant overland.

Imported Betty Galley Capt: Thomas [Dixon] Commander, & Supracargo, FRYDAY & saild the same Evening to Goa. Likewise imported Ships Queen Carolina & Sarum, all three from Bengall, the former commanded by Captain William Tullie Mr. Josiah Holmes Supracargo sail'd immediately for Bombay & Persia, in company with the latter bound for Bombay & Scindy, whereof Mr. Richard Pearce is Captain & Supracargo.

Reced a Letter by Boat express from Mr. Thomas Puttle of Onore encloseing the Chief from the Honble President a relation of a Sea fight between the Honble Company's Cruizers & Angria's Grabbs the 25. Ultimo, wherein the Bengall Galley was unfortunately taken and her People cut off.

SATUR 12.

Answer'd said Letter, wherein we desired to know if he could procure us a Quantity of Champsall Rice for the use of our Garrison, by reason the Government of Mangallore threatned to seize al! Vessells belonging to this place.

SUNDAY 13.

And likewise if he could List us any Christians, or others, fit to bear Arms, We requested he would send them \$\beta\$ first opportunity.

The same day by a Private Pattamar dispatch'd for Fort St. George, wrote a Letter to the Hon'ble George Moreton Pitt Esqr. Govern. &c. Council there. and also transmitted the above Relation of the Sea fight between the Bombay Cruizers, and Angria's Grabbs of Colabbe the 25 November, with a Triplicate of our Addresses to them under the 2^d of said Month; and continue pressing them, if possible, to list us some Men.

> MONDAY 14.

This morning the Callicutt Govern'r., Head Custom Master, & the Samorine's head Secretary arriv'd here, & were immediately introduced by our Linguist to the Fort, where they did not stay above an hour for fear of the Contagion, but imediately return'd back. The Purport of their Message from the King was to desire, We would supply them with a quantity of Gunpowder, some Silks, & Velvetts, for his Majesty's Service at the now approaching Feast of Mamanga From which the Chief excused himself, alledging that neither of the two latter were procurable here; & that we could not spare any Gunpowder not having sufficient for our own & the Prince's service, even by the help of what we could provide at Callicutt. They said his Majesty would not fail after the feast was over, to enter on Measures for satisfying his large Debt to our Honble Masters: which he had hitherto been prevented from doing, through the unavoidable & large expences attending his coronation, the Anniversary of the late King, & the provision made for the ensuing Feast.

A Present was made them agreable to custom of Twenty five Rupees, after which they took their leaves.

The Linguist lays before us an account of Sundry Disbursements made by him in wood, Rice, & cloth &c3. distributed in part by our Order to the Soldier's & Mucqua's Familys, & others depending on us, amounting in the whole to one Thousand 500 Fanams, desiring withall payment of One Thousand Fanams in part of sd. Account being the Sum he was limited by us to expend

agreeable to our Consultation on the 13th. October last. The Necessity we have been under of releiving these poor & distressed People appearing to us such as could no wise be avoided, without runing the risque of a total disertion; 'Tis order'd that the aforesaid sum of one Thousand five hundred Fanams be paid him out of the Treasury.

And whereas many of our Garrison soldiers & others depending on us, do still labour under the greatest Calamities imaginable, by reason of the Contagion with we do not find any wise abated: 'Tis further AGREED, they be reliev'd by Charity, by him the sd Linguist to the amount of Five hundred Fanams more, in hopes by the time said sum be expended the Distemper may Moderate.

The Chief communicates to the Board sundry advices receiv'd this Morning from Canara informing him that three Munchuas under English pass & colours, belonging to the Linguist of this Place were detain'd by order of the Mangalore Govern'. two in the Port of Cumbia & one in that of Mangulore by the solicitation of Pyrate Cutti Cullum brought in here last year by the Bombay Galley.

Our Superiours in Bombay being in part advised of these Insults, & their last directions to us being not to enter on any hostile measures with the Carnatick Government, agreed we wait such orders as they may think fit to give us on this head.

One of our Linguist's Munchuas detain'd for some days past in the port of Cumbia arriving here this morning brings us information that the Govern. of Mangulore was at that port: where the Merchan. who had sold them Beetlenut had prevail'd on him by a present for to give free passage to said Munchua with her Cargoe; however that he had express'd his resolution in a very peremptory manner of detaining the other two Vessells who were to lade Rice, untill satisfaction was given for the reprisal made last year on the Pyrate Cutty Cullum, so that one way or other we find his purport is to insult us, & that from all occasions he will take opportunity to molest us, & the people under our protection trading to his country, the principal of which assures us they must sell their Vessells unless we can protect them in their lawfull commerce.

'Tis agreed since no other expedient offers for our Consideration. & to prevent, if possible, further inconveniences, that Mr. Hugh Howard one of our Honble Masters covenant Servants be sent with the Chief's Letter; & verbaly to expostulate with the Governour of Mangulore on the unreasonableness of these proceedings; & that in case he cant effect the release of the two Vessells now detain'd; that he endeavour to bring with him such of our Inhabitants as

are detained; & that the Chief draw up a Protest to be by him deliver'd in our Honble Masters Names, in case that either the Vessells, their Cargo; or their people be detain'd after this reasonable application is made.

ORDER'D that a proper conveyance be got in readiness for said M^r. Howard for his intended Voyage, & that a sufficient Guard & a proper Interpreter go with him for his security & assistance.

A Person named Cunhisceu & Nephew to Semoyne of Cottata the Cardimum Merchant met us here this morning not venturing to come nearer by reason of the contagion: he told us he was deputed by his Uncle according to the Antient friendship between us for to make us a tender preferable to all others of the Cardimums produced this season, which altho' inferiour both in quantity & quality to what gather'd in times past, yet did the Dutch of Cannanore press him very strenuously to ingross the whole quantity for the clearer Demonstration of which he produced two original Letters from the Chief of Cannanore, in very pressing terms requir^g. the whole produce of the season might be secured for the Dutch Company's account, assuring us withall that they had made him an offer of one hundred venetians \mathfrak{P} Candy: but nevertheless it wou'd be less inconvenient for him to bring them hither provided we wou'd allow him a price whereby he shou'd not suffer.

He told us the quantities his estate produced in times past, was from 60 to 65 Candys, but the present season wou'd not afford more than from twenty to twenty five Candys, that their quality he could not help, however such as they were, he wou'd give us the preference.

Our Linguist was thereupon order'd to discourse him a part as touching the price, who after some time spent in arguments of this kind, assuring us there was no possibility of reduceing it to any thing under Ninety venetians \$\psi\$ Candy & that the whole produce of the Country wou'd be secur'd to us at that rate & in consideration that our Superiours have not limitted us to any price & ordering a larger parcell than we have prospect of being able to provide.

We agreed to accept the conditions proposed by him, that is to say, that we allow him for 20 Candys of Cardimums of the Head Sort agreeable to muster, & for as much more as he can gather in not exceeding ten Candys at the

rate of Ninety Venetians (of twenty Fanams Tellecherry) & Candy, Cotata Weight, he to make delivery thereof within our District, & to receive the amount in Rupees, Venetians & Gubbers Viz.

matter I nevertheless on this occasion am under a necessity of asking some
farther Succour from you, & that you'll without fail send me as far as twenty
Thousand Fanams in Money, some Granadoes, Rice & Thirty Men with what
powder & shot you can spare: all which, I desire may be forwarded to Day:
And if God spares my Life to overcome these difficulties, I offer you the same
as a Pledge, that Due Satisfaction shall be made to the Company, for this &
what other Favours reced, at their Hands."

It appears to us from this, that the ten thousand Fanams extraordinary, we did as good as promise him at Moylan the 3d. of November last, it's now expected: & that we cannot possibly hereafter have any opportunity like this to fix him in our Honble Master's Interest: 'tis agreed that the same be now lent him on the same conditions as the former; & that the remaining part of the twenty Thousand Fanams which we was to spare him in Military Stores, be likewise now deliver'd his Messenger in hopes by this assistance he may be able to defend his Country from the attempts of the Sedee, who we judge cannot have time, or will even venture to Hazard a second attempt, shou'd they happen to be repulsed in the first.

A Letter from the Prince Cunhi Homo to the Cheif is laid before the Board, setting forth the Necessities to which he is reduced by the Seddee's invasion, that altho' he hopes their stay cannot be long; yet is he not in a condition to prevent his country from being intirely over-run by the Moors, unless we make him some farther Loan of money, he acknowledges with thankfullness the assistance he hath already received from us, but withal assures us he expects on this extraordinary occasion something farther be done on our Parts.

As we have already furnish'd him both with money & stores as far as we judged convenient at our last meeting with him, Mr. Braddyll took occasion therefrom to remark that he cou'd not agree to any farther loans, but with the greatest apprehensions imaginable of being reprimanded not only by our Superiours from Bombay, but the Honble Company themselves; who in times past have so loudly exclaim'd against such as have parted with any of their ready money: however that he would Govern himself in this according to their opinions.

Our Linguist being sent for, shews us a Letter likewise wrote from the Prince to him, but in so angry a stile as: plainly shews, we are in Danger of forfeiting his Interest, unless some farther means be taken to secure the same.

AGREE'D therefore that for the present we endeavour to satisfie him with a farther loan of Ten thousand new Callicut fanams: since permission has been given us for much larger Sums; & lest our Superiours shou'd blame us for not makeing timely use thereof.

Semoyne of Cottata having brought in Twenty one Candys of Cardimums, requests we would advance him farther to the amount of five thousand Rupees or thereabouts in part of his contract.

ORDER'D therefore that the Venetians now by us being Eight hundred & forty in Tale, & two Thousand Rupees be deliver'd him out of the Treasury.

The Chief acquaints the Board that he had receiv'd a letter yesterday from the Honble President of the Sixth Instant wherein he gives him to understand that as they are not in a condition at Bombay at this time, for to redress the Hardships we have lately fallen under thro' the insults of the Mangulore Government we must endeavour to accommodate with them on the best terms we can, for that [none] of the Cruizers can be spar'd for to bring us rice.

The stock of grain at present by us being so very small, as not to suffise above a month longer & the assurances given us by the Mangulore Govern. in his last letter to the Chief being such as if regarded, takes away all apprehensions of being molested for the future.

'Tis Agreed that we take up three of our Linguist's Munchuas on freight & dispatch them imediately, with a Stock of Six thousand Rupees, to Mangulore, under the care of Dionysio Periera, being what we judged sufficient for to purchase three thousand four hundred Bales.

But our Treasury not being in a condition to supply any such sum, or even to defray the present months expences.

AGREED we borrow from the Chief the Sum of Eight Thousand Rupees. Who now makes an offer of the same, & that a bond at Interest be given him on his paying that sum into the Treasury, since he is willing to receive it back on the arrival of the expected supply from Bombay.

River & detain'd them about fifteen hours, making Prisoners of three Braminys they had on board them express with Letters from the Gov^r. of Mangulore to the Chief: the purport of which was that neither the English at Tellecherry, the French at Mii, or any other part of the Mallabar Coast shou'd be supply'd with Rice at Mangulore until they had joyntly sent him what assistance they cou'd [agst] the King of Colastry, with whom they was at War.

Resolv'd therefore that an imediate express be sent to the Seddee's General soliciting the Enlargem^t. of said Braminys to prevent the Canarys from making any handle at their being deliver'd up by our People; & that we wait some time longer ere we risque any money to Mangulore, & until we have a better prospect that our people may proceed there with safety.

An offer being made us by our Linguist of 450 Bales or thereabouts of Champsal Rice, which he is willing to deliver into our Warehouse at the rate of Ten Fanams ? Bale.

Our Linguist Domingos Rodrigues signifies to us, that conformable to our orders given him the 9th. Instant, he had discoursed the principal Merchants of Cotata, & of this place concerning what then recommended, but found them in general unwilling to contract with us for any large quantity of pepper, by reason that the French of Myhu seem'd so busy with their Agents in all places, to engrose all they could, not minding the price they gave, provided they could but gain the quantity they wanted; which the country judged would be great as they had two empty Ships actually in their port-that they propos'd our advancing them money as the French had done, which they would lay out for us the best they could. Our Chitty being but just come from the Mamamga, he had not until now found an opportunity to talk with him, but recommended our applying to him for a quantity on certain terms, rather than to accept what proposed by the aforesaid Merchants.

AGREED therefore that a message be sent the sd. Chitty by our Liuguist, requiring him to give us a meeting either here, or at some distant place where he may be under no apprehension of their distemper, and that we endeavour to contract wth. him on the best terms we can, for such quantity of pepper as we have cash to purchase withal, after making a reserve for our expences, till the last of April when in all probability we may be supply'd with more.

Our Broker Chattoo Chitty comeing this evening to the House where the Linguist's Family hath been for some time retired by reason of the sickness, the Chief with Mess¹⁸. Forbes & Howard imediately met him there, where after some talk had pass'd on the Subject that occasion'd our Message to him. Our Linguist took him aside in order to know his proposalls with regard to pepper, and the Quantity he was now willing to contract for, & gave us for Answer, that not only the quantities bespoke by the French, but the open manner of their doing of it had greatly discourag'd the Merchants in general from entring on contracts for any quantities at a price certain, however that the Chitty had made him an offer of Five hundred Candys at Sixty Six Rup's. the Candy. So small a Quantity as this, & at so high a price, no wise answering our present purpose of the expectations of our Superiours: our Linguist was again order'd to try if he wou'd engage for one thousand Candys, & to know his ultimate resolution as touching the conditions but found that altho' he was willing to enter into a contract for one thousand Candys, there was no possibility of bringing him lower than the price of Sixty five Rupees—he to take Dollars at eleven Fanams. & two Vis; & Rupees at Five & a quarter Fanams—and one half the amount to be imediately advanced—concluding therefore that this commodity from the best information we can get, will rather rise than otherwise the ensuing season, &

that the present oportunity is the fittest for our entering on an investment of this kind, & that we cannot be supply'd any other way with the quantity of pepper now offer'd either on the like certainty, or on so favourable conditions.

'Twas agreed we accept the aforesaid proposalls, that is to say, that we contract with Chattoo Chitty for one thousand Candys pepper at the rate of Sixty five Rupees & Candy, & imediately advanced him one half the amount he to take Dollars at Fanams, Eleven & two Vis, & Rupees at five, one quart. Ditto as usuall delivering said pepper into our Warehouse at Tellecherry any time before the Rains.

Received advices from our Linguist at Callicutt giving notice that the Governour of that Port was dead of the small Pox; & that pepper though but to be had in very small quantities was fallen to Twenty four & a half Narrow-dies—He says that the Samorine had taken up Large Sums at Interest for carrying on the Charges of the Mamanga, & that it was talk'd he intended to pay off part if not all, of what so borrow'd from the Callicut Customs, which afforded him but a very bad prospect of recovering any thing this year for our Honble Masters. The Merchants he informs us are willing to contract with us for a quantity of fire wood at the rate of thirteen Fanams \(\beta\) Mil; landed at Tellecherry.

DITTO DIE Dispatch'd the following letter from the Chief [to] the Samorine Viz.

"I am not only assur'd by your Majesty's Royal word, but by your Ministers when last here; that after the publick ceremonies were ended means wou'd be taken towards satisfying your Majesty's debt to the Honble English Company, my Masters as the general feast is now over, I now accordingly put your Majesty in mind thereof, in hopes your Majesty will comply agreable to promise; at the same time remarking to your Majesty that we have not reced, save a very small part, of the second payment of two hundred thousand Fanams due the first of April last, whose Interest will amount to a very considerable Sum, besides the third payment for one hundred thousand fanams more becomes due the first of April next ensuing. This consider'd I suppose your Majesty will have some regard to your own Interest, by ordering the whole to be imediately paid off.

Wrote a Short letter to our Callicut Linguist directing him to forward the foregoing by our Jangadoes & to solicite an imediate answer.

ORDER'D him likewise to send us up as far as the amount of one hundred & fifty thousand Billets, fire wood, provided the Merchants still continue in the same disposition of leting us have it put ashore at Tellecherry at thirteen Fanams # Mil.

THE WORSPLL. JOHN BRADDYLL ESQB. CHIEF. WILLIAM FORBES. HUGH HOWARD.

This meeting was call'd by the Chief purposely to inform the other Members that the Prince Cuni Homo (who had for near seventeen days been at the Pagoda within our District, & with whom he had several interviews) had taken occasion frequently to represent the great distress he was in from the Canarees having invaded his Country with an Army of near Twenty Thousand Men that the Moors on this accident had taken fresh Courage & wou'd neither hearken to a Truce, or to an accommodation of any kind; notwithstanding everything on his part had been offer'd even to the giving up the Fort of Cadolai, which they had so treacherously taken from him—That as the greatest part of his force must now be withdrawn to oppose the Carnatick Rajah; he was very apprehensive the Family of Ally Rajah wou'd make some considerable attempts on the Country hereabouts, not only detrimentall to himself, but to our Trade & Interest, unless means cou'd be found to raise an immediate Sum for levying fresh Forces—For that all his ready Treasure was made use of as before mention'd. His Chief Minister being now present with us signyfies the same to us; & withal gives us to understand, that as the Chief had from time to time as good as made his Highness a denial of having anything further granted from us: he was now sent on a Message from sd Prince for to tell us, He was not only very thankfull for the Loans made him the begining of this season, but that he fully propos'd to discharge them, which he hoped yet, he shoud soon be able to do, on accommodating with the Moors, provided he cou'd but give the Canarees a repulse. That if it had not been for these new difficulties, he wou'd not on any accot. have troubled us further, but [as] the Case now stood, we must excuse the earnest manner in weh. he was bid to importune us, for that altho' he had no manner of Inclination for to apply to any nation but ourselves, yet in case of a total denial from Tellicherry, now in the time of the greatest distress that ever befell him, he must have recourse elsewhere, rather than suffer his Dominions to be torn out of his hands, for it wou'd be less dishonourable to him, to have the same in the hands of an European Nation, than that it shou'd be possess'd by his rebellious Subjects & usurping Neighbours: & that there were not wanting Europeans, sollicitous enough, towards obtaining an advantageous Settlement therein.

The Substance of the preceeding Message being fully weigh'd & consider'd, & the Consequence of sending away this Prince at so critical a time disgusted with us likewise maturely debated on. 'Twas moved whither or no we cou'd, upon any Authority from our Superiours, venture to make him a further Loan; & whither it might at this time be convenient to do it, & finding that on looking back into the orders from Bombay \$\Bigoplus\$ Ship Lethieullier, a Latitude was given us (even to present him, if we judged necessary) as far as One Hundred Thousand Fanams, & that not above Seventy Thousand of sd Sum had yet been spar'd him, & only part of that by way of Present. 'Twas Agreed we yet venture to spare him Twenty Thousand new fan'. more out of our Callicut money without Interest, least his present desperate condition drove him to attempt something, like to what was intended last Season, in hopes this our Resolution will be approved by the Honble the President, since no other Benefit, save that of the Publick, is hereby consulted.

Permission being given us in the last commands reced from Bombay & Ship Nassau for enlarging our Pepper Magazine at the Water side—Order'd that a Survey be made on the ground most proper to build them on, & that

Direction be given for providing stone, Timber, & such other materials as are requisite to carry up the Work, & that they be made Capable of containing near as much as our Present Bank shall which is now allmost full with One Thousand Candys of Pepper.

Wrote a Short Letter to Boyanore of Burgorah by our Braminy Messenger Tuesday desiring he woul'd not fail to send us by him the small Ballance due from him 11. to our Honble Masters.

Receiv'd an answer from Boyanore to the above Ola whose translate is as W_{EDNESD} : follows viz.

- "I have already satisfy'd the greatest part of what I ow'd the English "Company, on whose account & word I was at considerable charges & sustain'd great losses, for which I have not yet been anywise recompensed, although something was promised me by way of Gift.
- "The Ballance now due from me is but small, if therefore you have a mind "to look upon the same as already discharged 'tis well, if not, pleased to send "me word what it is I now owe, & return my Bond, now wth. you & the same "shall be immediately paid off.

Our Linguist Domingus Rodriguez informs us this Morning that he had, agreeable to late orders receiv'd from the Chief, sent a message to Chattoo Chitty & his Partners for to enquire of them concerning the Quantities of Pepper remaining in the Country & the Prices it might be afforded at; & that sd Chitty was now come to inform us thereof.—

It being our Joint opinion that the present time is the properest for compleating our new Investment, he was accordingly sent for & afterwards frankly told us that if it was our Intention to lay in any stock of this Commodity during the Rains, now was the properes time to set about it. That if we thought fit he wou'd engage to get us in Five hundred Candys by the middle of October, but that he cou'd not contract for any such parcell for less than Sixty five Rupees & Candy.

The Chief thereupon put the Question whether or no any of this Board cou'd propose any better method of laying in the Quantity order'd from Bombay, than by applying to the person now present, or whither the provideing it in small parcells from the Petty Merchants, as our Superiours seem to recommend, was most eligible; but was soon answer'd in the Negative.

Our Linguist was then order'd to propose to the Chitty our allowing him at the rate of 62 Rups. A Can: for 800 Cand. to be deliver'd us in all October, but could not bring him to anything under the Price of 63½ Rupees. He to take the several Coins now by us in the manner they were put off in our last contract, & to be advanc'd the whole amount.

—— MAY 1731 ——

The Board, after some debates on this matter judging the aforesaid Terms highly reasonable, considering the Prices given for this Commodity the begining of the Season, do unanimously AGREE to contract with him, if he thinks fit, on the following Conditions, that is to say, for Eight Hundred Candys of Pepper to be deliver'd into our Honble Masters Warehouse at Tellicherry in all October next, at the Rate of Sixty three & an half Rupees & Candy, he to receive what Dollars we have by us at Eleven Fanams & two vis, Venetians twenty & one Quarter, Gubbers at Twenty, Rupees at five & one Quarter & that we now advance him the Venetians now in Cash, & twelve Thousand Rupees, & the rest as we see occasion hereafter, this our Proposal, being signified to him by our Linguist, was after many arguments, at last accepted.

But the paying off what lately due to the Chief for what he supply'd us withal for the provision of Rice, & the Ballance of the Chittys account Curt. having drained our Treasury of above sixteen thousand Rupt. of the last supplys; & as we have not Enough by us without exchanging our Callicut Fanams to great Loss, & making use of the Silver Fifths which must be reser[ved] for the payment of the Garrison even to discharge the present Contract or to carry on our growing Expenses till the beginning of November.

AGREED we endeavour to take up at Interest the Sum of Twelve thousand Rupees, which the Chief made an Offer to supply us withal out of his private Cash.

ORDER'D therefore that on his so doing a Bond be given him on the usual terms for sd sum.

Was read the Ola reced from Boyanore of Burgora the 19th. Instant & observing thereby he expects a present from our Honble Masters for engaging in their Interest against the French—Agreed we be silent in this matter till such time as we may receive Orders from our Superiours concerning the same.

Linguist would make good here the 5 2 8 due from Pandara Anta Naik to our Honble Masters, wherefore they need not demand the same from him.

WED-NESDAY 9. The Heads of Ally Rajah's Family inform us by a Letter to the Chief that they had through the mediation of Calliadan Cora Nombier at last obtain'd the Princes favour; & that on Sunday next being the 13th their Style they were to be admitted into his Presence. The same is likewise confirm'd by a Letter from the Prince to our Linguist, importing his having given orders for Hostilities to cease against the Moors, for which they had now given him One Hundred Thousand Fanams, that four Months hence he would consider further concerning Durmapatam when they were to give him a hundred thousand Fanams more, which done he would resolve what should be found most necessary.

TUESDAY 15 The Moors having actually the 15th. Instant made their 'submission to the Prince, & as 'tis thought assisted him with a considerable Sum, the following

Letter was accordingly sent him this Day by the Chief.

"Your Highness well knows with what readiness you have been assisted by us in the late Troubles, & how solicitous I was my superiours should be made sensible of the difficulties that then offer'd themselves in oposition to your Government. As the Moors have now thought fit to subject themselves to your Highness's Obedience, my Duty obliges me to put you in mind of your promise, desiring that conformable thereto, you will order the making good the several sums borrow'd of the Honble Company for your Highness's service, of which I shall not now say farther relying on your Highness's Punctuality which now being made manifest will futurely engage us in your Highness's service.

SATURDAY 19 Reced the following Answer to the above Letter.

"I had no other end in treating with the Moors but to keep them quiet untill other Enemies were provided against, & when I was last at Tellecherry, "I told you 'twas my Purpose to Compound with them on any terms for the present.

"The Company's Interest hath been much regarded both by myself & "Predecessour, always depending they would favour us on any important occa"sion, I mean not by this but that I have benefitted by them, nay in a very
"high degree, & now last of all in the time of my greatest Necessity you have
"supply'd me with Twenty Thousand Fanams more, but I little expected at the
"same time you wou'd have demanded payment of the whole.

"The Moors have indeed promised me a Sum of money, but nothing is "yet paid, when it is 'twill not amo', to half what I owe the Company: on the "other hand you well know how much I am now Embarrassed.

"The present Treaty is only to give me a Breathing for four months, before the expiration of which I intend to be with you, when we will talk on what is farther to be done."
