To SAMUEL ARDLEY ESQ^r.

DEPUTY GOVERNOR OF FORT MARLBOROUGH.

SIR

We now dispatch the Ossterly to Bencoolen where we hope she will find you safe arrived with the Earl Temple and Plassey.

The Several Articles of Provisions which y^e. ships abovementioned could not receive are now sent in the Ossterly agreeable to the Invoice & Bill of Lading enclosed also seven Chests of Treasure which with the eight Chests returned in the Earl Temple will, we judge be sufficient for four months Disbursements at the West Coast, exclusive of the Purchase of Pepper which may be on hand at the Subordinates.

By the enclosed Extract from a Letter from the President and Council of Bombay you will observe that on a Report of two of the Enemy's ships of War having gone from the [. . .] to Batavia [as] Convoy to two others sent thither [. . .] His Majesty's ship [. . .] assisting in any service you may think necessary to recommend towards protecting the Company's affairs on that side.

By advices from Anjengo we learn that y^e. Medway & Panther with the Beliene and Seahorse passed that place in November.

We have been addressed by the Owners of the Success Snow Commanded by the late Captain Austin concerning some Engagements the Natives of your Coast entered into with Captain Austin (before the arrival of the Europe Ships at Marlborough) for Pepper in Barter for Goods he deliver'd to them which they are desirous we would give Orders may be duly performed Although we cannot gratify them in consenting to their having the Pepper, We are however of Opinion that they should have a reasonable Advantage upon the Goods they may have disposed of and deliverd, and that the Natives should pay for the same as the Prices [. . .] like sortm[ent . . .] usually purchased for [. . .] Quantity delivered [. . .] perfectly acquaint [. . .]

[. . .] Transactions As we understand Captain Austin was very assiduous in conciliating the difference subsisting between the Natives on his Arrival on the Coast, and encouraging them to keep their Plantations in good Order and to collect the Pepper, We would have you give all necessary Assistance towards the recovery of y^e. Amount of the Goods he disposed of to the Natives as abovementioned. The owners have likewise represented to us that some Presidents were made by Captain Austin to the Pangarans and other Head Men in the Company's Name and that he was at some other Expences on their Account at the request of Mr. Herbert. These you will obtain an Account of, and pay the Amount thereof to the Agent for the Owners of the Success Snow.

The Complement of the Ossterly's Crew having been exceedingly reduced by Sickness. The Surgeon of His Majesty's Hospital here has on our Application permitted such of the Seamen who are recovered and capable of doing Duty to assist on board the Ossterly [. . .] [ret]urn to the West Coast They are [the] number eighteen and [. . .] that they be returned by y^e. first opportunity [. . .] any of His Majesty's Ships that may touch [. . .] stores left their by the Norfolk and Duke of Richmond of which a List is enclosed of y^e. Military two deserted at Mallacca namely Godfrey Fillinger & Frederick Braulne.

Enclosed are such Accounts of Disbursements attending the Military and Stores at Atcheen and Mallacca as have been received from Mr. Frazer and Mr. Russel with the several vouchers transmitted therewith also Copies of y^e. Letters received from the Governour of Mallacca and Mr. Frazer, As it is intended that the Earl Temple should fetch from thence the remainder of the Stores, it may be necessary to instruct the Commander, or send some proper Person to settle all Accounts relative thereto at Mallacca you will please to observe that the Government there has been supplied with some Salt Provision which according to Mr. Frazers Letters will either be paid for or restored in kind, in which you [. . .] by your own Circumstances and on the [. . .] that D. 400 were advanced. Mr. Russell [. . .] after Mr. Frazers De [. . .] one of the wri[ters . . .] proceeds to his Station, in the Ossterly, enclosed is an Account of the Money which has been advanced to him at different times. The other two Gentlemen Mr. Russell and Mr. Manington were left at Vizagapatam, where the Leopard put in at, and was obliged to leave the Road in hard Weather.

On the Ossterly are embarked eleven more Coffrees for the Service of the West Coast.

[. . .] Company's ship Ossterly arrived here in November from the West Coast with her people so exceedingly reduced by sickness that she could not remain even in this Road with safety. We were under the necessity therefore of making Application to Mr. Price Surgeon of His Majesty's Hospital here to permit such of the Seamen who were recover'd and capable of Duty to assist on board that ship in navigating her back to the West Coast. He Thought the necessity of the service might justify his compliance with our request and eighteen of His Majestys Seamen were accordingly embarked, we have given possitive Directions to Mr. Ardley the Deputy Governour at Fort Marlborough to return them by the first opportunity or put them on board any of His Majesty's ships that may touch on that Coast, which we hope will meet with your Approbation.

Seamen who have been permitted to assist in Navigation your ship to the West Coast.

HONBLE SIR & SIRS

We wrote to you by the Syren Snow under date the 9th. November, and have since received your Letters of the 22^d. October and 7th. Ultimo, with the former came enclosed first Bill of Exchange drawn by Capt. Hart on the Commanding Officer of the 96th. Regiment for Arcot Rupees eight hundred which was omitted to be enclosed in yours of the 3^d. October and has been duely honoured.

In our Letter of the 12th. October We acquainted you in answer to [. . .] us the 7th. Sept^r. that we [. . .] the other five, we judged from this that your Honour &c^a. would have understood we meant to desire you to send us up that remaining ship to compleat her loading with those Bales.

If your Honour &c^a. should receive this in time to Order a ship here to take in about four hundred Bales we think it will be more for our Honble Masters Interest than it would be to load home from hence the Admiral Watson or Royal George. indeed that Number of bales would go but a Little way towards loading either of them and We have not a Bag of Salt Petre in Store. We shall be glad

to receive by the ships coming up at least three hundred Tons of this Article and if it did suit your conveniency it would be certainly proper to send us such a quantity as may leave us in store one or two hundred Tons more.

We acquiesce in your Request for the Reverend Mr. Samuel Stanely to occupy the vacancy occasioned by the Death of the Reverend Mr. Henry Butler late Chaplain at your Presidency untill the Companys pleasure be known.

The Earl Temple and Plassey sailed the 19th. of November for the West Coast with Mr. Ardley on board the former as provisional Deputy Governour. The Ossterly [dated the] 4th. Instant.

Th[. . .] Mr. John More ac[. . .] in answer as desired in your Letter of the 7th. December Mr. More before his Departure paid off the Bond he entered into with the Company for £100 at the time of his leaving England.

We desire you will inform us what Advances were made at your Presidency to John Aspiner an Artificer of the Fort Marlborough Establishment who came hither in the Syren Snow.

Agreeable to your Request We enclose Copy of the ship Plassey's Invoice from Europe.

We have the pleasure to acquaint you that our Honble Masters Ship the Norfolk imported yesterday the material Advices we have received since their last by the Coast and Bay; ships are contained in the Enclosed Extracts from their General Letter dated the 6th. May 1761.

As we observe by the Abstracts of the Norfolks and Chesterfields. Invoices for your Presidency that our Honble Masters have consigned to you a supply of stationery it will be unnecessary for us to send you any out of our Store which is but small.

The Prince Henry Packet from Madagascar with Slaves is now standing into the Road.

HONBLE SIR & SIRS

Since we wrote to you by the Patty the 19th. Octobr. we have received yours of the 12th. November.

In your letter of the 18th. January last Year you were pleased to acquaint us that the Fattee Salam was freighted for transporting some of His Majestys Troops, and to take in Provisions and stores for this place, and desire that we will give the Commander Orders to proceed to Anjengo and to follow such Directions as he may receive there from the Chief and Factors—The Chief and Factors at Tellicherry write the 4th. February that they had sent her to Mangalore to take in Masts for His Majestys Squadron and in a Letter of the 22^d. of the same Month they acquaint us that they then sent her round to the Coast with Masts & c^a. under convoy of the Earl Temple.

The 4th. of April she arrived here and the 14th. of that Month, we acquainted your Honour & c^a. that we thought the Fattee Salam a proper Vessel for one of the Transports then proposed to be sent to the Mauritius if your Honour & c^a. could prevail on the Owners to let her to Freight.

In the proceedings of your Committee of the 27th. May enclosed in your Letter to us of the 30th. of that Month you [. . .]. Owners of the Fattee Salam had relin[quished] [. . .] Maurituis [. . .] in that Place, and delivered her Loading except fifty five Pieces of Cannon, and 11700 Shot, as we were in want of such a ship to transport to Bengal His Majesty's 84th. Regiment Orders were given to the Captain to receive on board

Tons. qr. lb.

22. 6. 1. 20 of Redwood and to proceed thither, We thought this service might make some Amends to the Company for the long time that ship had laid unemployed, and that she might return from Bengal in time to leave this Coast at the proper season to have a good Passage round to Bombay. These were our motives for so employing her, and the Amount of her Lading being not more than about 250 Tons and the Camp Equipage of the Regiment, had we actually known she was a leaky ship we should not have expected that a Disaster so melancholy could have happen'd with the number of Men she had on board as you will learn by the enclosed Copy of a Letter from Captain Simmonds to the President and Council of Fort William. The Detachment she had on board from this Place of Colonel Coots Regiment together with a Company of French Voluntiers made in the whole near four hundred men.

The Earl Temple and Plassey a Country ship sailed the 21st. of November for the West Coast with Mr. Ardley on board the former as provisional Deputy Governour agreeable to what we wrote to your Honour &c^a. the 19th. October.

The Ossterly arrived here from Ben Coolen the 1st. November the Occasion of her coming hither will appear by the enclosed Extract from Captain Vincent to our President she sailed hence on her return [. . .]. 5th. Instant. We have the pleasure to acquaint you that the Norfolk imported yesterday she left England the 26th. of May in company with y^e. ships Boscawen, Earl of Elgin, True Briton, Calcutta and Royal Captain and parted from them the 8th. September after calling at Rio de Janeiro, The Material Advices received from our Honble Masters since their last by the Coast and Bay Ships are contained in the enclosed Extract from their General Letter dated 6 May 1761.

The Shaftesbury, Harcourt and Stormont arrived at Portsmouth under convoy of the Vanguard man of war a few days before the Norfolk sailed the Prince Henry Packet from Madagascar with Slaves is coming into the road.

By our last Advices from Bengal we have the satisfaction to learn that all our Honble Masters ships of last season were arrived there.

We request that you will by the earliest opportunities supply us as Plentifully as possible with Gunpowder such as may be depended upon for service that We last received from you having been very indifferent.

January from Madagascar with sixty slaves on board which are now sent on her for the service of the West Coast We have taken out here the remaining Part of her slaving Cargoes except a few Barrels of Gun Powder for the ships Use, and the Shackles &c^a. for the slaves The Packet received by the Prince Henry from the Court of Directors Directed to the President and Council of Fort Marlborough is forwarded herewith.

After having provided in the Article of Pepper for the Ossterly and Earl Temple as directed in our Instructions to you at your Departure from Madras you are to put in at the Prince Henry as much as she can receive, and Dispatch her to us by the 15th. of June at furthest.

You will observe by a Letter to the Resident at Batavia that we have sent four Chests of silver in the Fox for the purchase of Timbers &c^a. there and we consign to you on the Fox fourteen Chests to replace those landed here from the Ossterly agreeable to the Bills of Lading enclosed which you are to apply towards the Disbursements of your Garrison and the Occasions of the Investment.

Mr. Henry Russel and Francis Mannington belonging to the West Coast Establishment proceed to their Station by this opportunity and several of the Gentlemen who were taken by the Court D'Estaing, return also to settle their private Concerns a List of whom comes in the Packet. The Captains are to be allowed at the rate of thirty Pagodas each for their Passage as was settled for those who went in the Earl Temple and Plassey.

Enclosed We send you an Account of sundry Disbursements defrayed by the Supra Cargoes in China on Account the Stores and Military landed from the ships Duke of Richmond and Norfolk at Mallacca for which We have debited Fort Marlborough in our Books.

The Norfolk from England imported the 9th. of January and all the ships for Bombay were by our last advices from that side arrived, except the General Lawrence.

Admiral Cornish arrived here towards the end of January with his Majestys ships the Norfolk, Elizabeth, Lenox, Grafton, America, Weymouth and Falmouth and from what we have already said in the former part of the

Letter, the Letters address'd to the Commanding Officers of the Fleet and the Navy at the Islands enclosed in the Packet to you from Bengal are of no further use

SIR

The Ship *London* is put under your Direction, for the prosecution of the Voyage to Sooloo & we have appointed Mr. Thomas Kelsal in joint Commission with you for transacting affairs relating to the Cargo and in case of your Death, he is to have the sole Direction.

You are to proceed immediately in the *London* for Abai on the N.W. Coast of Borneo where you will provide Pilots for one of the Companys large ships which we intend to Dispatch shortly after you to Sooloo & leave such orders as you may find necessary for them to pursue, to prevent any accident which may attend their missing Abai, or not receiving your Orders, the like are to be lodged at Banguay.

It is necessary to be carefull that the large Ship be not detained so late as to make her Passage to Canton precarious, You will therefore give her as Quick a Dispatch as possible.

It will be necessary that you proceed to China yourself in the *London* that you may return to Sooloo with a full state of the Voyage & finally adjust that Account.

We think it necessary to take notice that if any difficulty should arise in regard to the manner of consigning & disposing of the Cargo at Canton You must insist that the whole be consigned to the Companys *Supra* Cargoes, as any other method may involve the Companys affairs & in such case we do empower you if you find it expedient to make an Allowance in the Terms of Contract for any Loss that the Sooloo's may sustain thereby in the Price of the Sales.

You will endeavour to conclude another Contract on the best Terms you can & transmit to us the earliest Intelligence for the timely provision of the Goods. We do not think it necessary to limit the terms, as we apprehend there is no doubt of such as are more than adequate to the Risque.

We have only to recommend that an Adjustment of the China Sales may be avoided by terminating the Contract at Sooloo and to observe that the greater amount you can Contract for the greater will be the Company's advantage & consequently our satisfaction.

As it is possible from the nature of the Place that the Natives may have Goods for the China [Market] to a greater amount than their present demand of Goods from hence, You are therefore empowered to make an agreement to Transport them to Canton on freight which however must not be less than 25 pr. Cent on the Gruff & 15 on other sorts of Goods to be paid in Kind & this Agreement we recommend to take place only after another valuable Contract is agreed to.

We leave it to your determination whether the London return directly here or to Bengal; the last appears most expedient if no other Conveyance offers to that Place as the means of obtaining the Bengal proportion of a Cargo for a future Voyage. In the present Instance we shall endeavour to procure for the ship which follows the Proportion of Bengal Assortments in the Contract & Musters of what others can be got.

You are empowered to Contract for any Quantity of Cinnamon, Pepper &c^a. and We recommend to you to encourage the Cultivation of them. A list of the several Articles which we think may be agreed for is enclosed. These articles you will use your Endeavours to secure for the Company till their Pleasure be known and the Commerce be put under their particular Regulations.

You will also endeavour to make an Agreement with the Buggueses for what Goods they may require, to be paid for in specie & other Commodities, and as turning the Bugguese Commerce into this Channel would be of infinite Benefit. You are to Consider it as a Chief Object of your attention.

In case you should find any Foreigners or Private Traders in the Sooloo Districts you are to take every measure for the Companys Benefit & insist on the Government adhering to the Treaty if you find it expedient.

Some instructions of a Private nature will be communicated by the President which we expect you to execute to the best of your abilities.

We do not stipulate any Commission to be allowed to you for your care & trouble in this Voyage, being persuaded that your good & faithfull services will meet with a more ample reward from our Honble Masters than we think ourselves authorised to promise you. We shall not fail to give them a just information of your Proceedings & recommend to you a full Confidence in their generous Consideration of your Zeal as the surest way to obtain their Favour.

As the Soolo Contract was on a Presumption, that the Cargo except the Europe Articles would be provided immediately by the Company which it has been impossible to do, it seems reasonable that an abatement be made in the stipulated Gain from hence to Soolo which you are accordingly empowered to do, as we think it by no means eligible to be too strict in this first agreement.

We also recommend to you to inform yourself, if short & narrow Cloths can be disposed of at Soolo at a proportionate Rate, as it would greatly facilitate our Europe Investments, could those improper for the Europe Market be vended elsewhere.

Enclosed is Invoice of the Cargo to Soolo by the London, Consigned to you & Mr. Thomas Kelsal as also a letter to the Supra Cargoes in China. in which we desire them to supply you with what money you may want for the Vessels

Expences, or for purchasing a returning Cargo either in China or at Sooloo, as you may determine, on consulting with the Supra Cargoes, at Canton, in case you should pay Port Charges.

We have directed you to encourage the Cultivation of Cinnamon, Pepper &c. at Soolo in a former Paragraph, We recommend to you to Consult with the Supra Cargoes at what Price to contract for those Articles which may turn out to Account in China tho we think you may agree at such a Rate as may according to the Common price in China yeild a Taile for a Dollar. In respect to the Articles not proper for China you will Contract for them on the best Terms you can, as well those you may get from the Buggueses as what are produced at Soolo. After the first experiment we shall be able to give more particular Directions.

We wish you a successfull Voyage and Date this in Fort St. George the 5th. June 1762.

Enclosed is Duplicate of our last dated the 3^d. Instant as also a Packet received from the President & Council of Fort William.

The Brittania Snow is arrived here & we will endeavour if possible to procure a Freight for her & return her to you as you desire early in October.

In our Letter dated the 25th. March we acquainted you that the Gentlemen in Bengal had consigned to us five Lacks of Rupees towards a Stock for the ships going to China. They have since sent five Lacks more, four of which we have received, & are in hourly expectation of the arrival of the Prince Edward a Country ship, on board of which is the remaining one Lack.

To this sum We think to add five Lacks more which will make a stock amounting to fifteen Lacks for the ships bound to China this season.

We have the pleasure to acquaint you that the Money we have received in part of payment of the Nabobs debt this Year will enable us to supply you with five Lacks of Rupees also, and you may draw for that sum whenever you Please.

The Gentlemen in Bengal in their Letter of 26th. April writing that the Godolphin having sprung a Leak was unable to proceed on her voyage to England and that if the Captain was not able to repair her they should want a ship to carry home her Cargo.

They tell us also that they have an overplus of goods sufficient to load home a small ship which we are sending the Admiral Watson to take in, & they add that if nothing disappoints their present hopes of a good Investment they shall have Loading for six ships, and desire that we will concert measures with you that they may be supplied.

By the above it appears there will be Six Ships destined for the Coast & Bay which are the number the Gentlemen at Bengal desire and as we may be able here to dispatch one ship home in October & another in February next there will be wanted two ships of the number consigned to you which We believe you may be able to spare as you will have on hand five ships besides the Winchelsea & a New ship Captain Rous directed particular Voyages which doubtless should not be regarded could they be loaded home.

Our Honble Masters having been pleased to direct in case of the Reestablishment of their Settlement on the West Coast, that Mr. Carter, the Council & the rest of the Companys servants Civil & Military belonging to that Establishment should be restored to their several stations, and Mr. Carter with such others of those Gentlemen who are now at Madrass being about to proceed thither in Consequence, We have put the Royal George under their Orders to carry them to Fort Marlborough. If that ship should be returned to us, in time to be dispatched to England early the next Year we shall in such case only have occasion for one ship from your side to be dispatched home but if her services should be wanted at Marlborough We shall then be in need of two ships as beforementioned.

HONBLE SIR & SIRS

Since writing to you the 17th. last Month of which Duplicate is enclosed, Our Honble Masters Snow Syren & the ship Fort St. George are arrived, and we have received your several letters dated 15th. March Duplicate of 29 March 1st. 8th. 9th. 15th. & 26 April. The Prince Edward does not yet appear which makes us anxious for her safety.

By the Syren & Fort St. George we have received the four Lacks of Rupees as advised in your Letter of 9th. April.

We have agreable to your desire from the advices received by the London Packet of the Ships taken up this Year, proposed measures to the Gentlemen at Bombay for supplying you with ships for the Tonnage you expect to have for Europe the ensuing season, enclosed is Copy of our Letter for your more particular Information.

The great inconvenience that attends our not being provided with Salt Petre to assist in the Tonnage of the Ships we may have to dispatch to Europe from hence induces us to enforce the repeated applications made to you on this subject, and we must intreat that you will send us by the earliest opportunity, as ample a supply as possible. Two Hundred Tons is the least we shall want to enable us to send home a ship in October & we must again remind you of Packing stuff for our Bales.

The True Briton arrived here from Bombay the 31st. May & will sail for China in a few days. The Gentlemen there acquaint us of their Intention to send The Royal Captain hither recommending if it should suit our Circumstances to dispatch her also to China which is our Intention, & We hope to have it in our power to add Five Lacks of Rupees to the Consignments you have sent us which if the Prince Edward arrives safe will make Fifteen Lacks for the ships bound to China this season.

We have employed the London Packet on the Voyage to the East Ward originally intended for the Royal George as mentioned in our Letter of the 5th May which last is destined to carry to the West Coast Mr. Carter & the other Gentlemen of that Establishment, The Admiral Watson We therefore purpose to send to you after her return from Trancamalee whither she has been lately Dispatched on the service of his Majestys Squadron And in case the Godolphin cannot be put in a fit condition to prosecute her Voyage to Europe, The Fox or the Osterly which are shortly expected from the West Coast shall be dispatched to you to proceed in her stead.

His Majestys ships the Seaford & South Sea Castle from the Cape of Good Hope arrived here the 10th. Inst^t. By them we learn that the Falmouth & Prince Edward which we dispatched hence to Europe in October arriv'd at St. Helena the 3rd. January.

You will receive herewith an Account of the Expences of the Snow Leopard.

In your letter of the 15th. Febr^y. you advise that you had sent us on the Sabut Jung the Copper & Lead that was consigned to us on the Plassey an Invoice of which you enclosed, The Articles turn out agreable to your Invoice but not comformable to the Plasseys Invoice from England. In the Lead there is a surplus of Slabs or Pigs but a deficiency in Weight and in the Copper there is a deficiency both of Plates & Weight, We Credit your Presidency for The Exact Quantity received, & for particulars we refer to the Import Warehouse-keepers Account enclosed.

We have ordered a Copy of the Accounts of the Camp Expences under Messrs. Walsh & Maummell in Bengal to be prepared and forwarded to you as you desire.

Enclosed is Packet received from Bombay for your Presidency.

GENTLEMEN

By the Royal George which arrived here the 8th. February we received a Letter from the Supra Cargoes of Council at Canton appointed for the year 1761 dated the 15th. Decr. last enclosing an Account of Expences for which this Presidency stands Indebted on your Books, amounting to Tales 3,999,600, you'll please to Credit Fort St. George by Account Curr^t. London for the amount of the inclosed Invoice and debit us to Account Curr^t. London for the Tales 3,999,600.

The Cargo consigned to us by the Royal George having been disposed of We enclose the Account Sales thereof & shall by the first opportunity transmit a Copy to our Hon^{ble} Masters agreeable to their Directions.

The True Briton arrived here from the Malabar Coast the 30th. of last Month she received at Bombay four hundred Bales of Cotton and one thousand Maunds of Surat Putchuck amounting to about Fifty thousand Rupees and at Tellicherry Two Hundred Tons of Pepper amounting to twenty two thousand four hundred & Twenty three Rupees, one Annae & Twenty Pice (22,423. 1. 20) To this we have added in Dollars & German Crowns to the amount of Pagodas 93,933. 30. 17 according to the Invoice & Bill of Lading enclosed.

We are in hourly expectation of the Royal Captain from Bombay, We shall dispatch her to you as soon as possible after her arrival under the denomination of a Casual ship & by her shall send you a Considerable supply of Treasure.

Mr. Ardley one of the Council having proceeded to Fort Marlborough in the Earl Temple last November to take the Management of our Hon^{ble} Masters affairs there untill Mr. Carter & the other Gentlemen of that Establishment could reassume their stations—and our Hon^{ble} Masters ship Fox & Osterly being also employed on that side, we have directed Mr. Ardley to return the two last mentioned ships to us as early as possible that they may also be employed this season to China as Casual ships, The Earl Temple is to proceed to China directly from Marlborough with Pepper.

The London Packet from England arrived here the 26th. April & the Tilbury the 26th. of this Instant. She sailed in company with the Clinton & Essex the 5th. Febr^y. and the Argo Frigate which arrived here the 27th. parted from those ships after she left Madeira. By the enclosed List of ships taken up for the present Year you will observe that three ships Viz^t. The Haughton, Essex, & Grosvenor. are destined for Coast & China, and the Court of Directors have recommended to us to consign to you on them in Treasure & proper Goods to the amount of £30,000, or at least £25,000 on each ship.

Since Writing to you the 30 June we have received your Letters dated 7th. and 28th. of that Month.

(2nd) We observe what you write concerning the great Repairs wanting to the Cuddalore Schooner and Leopard Snow. Their Long Detention was owing to very particular occasions when We can ever avoid the like again you may depend on our doing so.

(3rd.) It is very certain that the Company are much indebted to Mr. Coote and his Regiment for the Services he has done on the Coast, they are under the same obligations also to the other Regiments of his Majesty who have served here, but as all these Regiments came abroad without any contingent Money the Colonels of them Mr. Coote among the rest desired that We would supply their wants and promised to give us Certificates of our having done so. We had certainly therefore a right to expect he would leave it to the Government at home to make the remark he has done, His certifying to what he has received does not oblige the Government to pay the Amount if they think it improper. We must desire therefore that you will tender the Accounts again to him.

(4th.) Our Honble Masters Ships the Clinton and Essex arrived from Madiera the 11th. of last Month, & the Drake the 3rd. Instant directly from England she left Portsmouth the 25th. March in company with the Harcourt Elizabeth and Horsendon bound to China, The Hardwick for Coast & Bay, and the Winchelsea and Hector for Madiera. She parted from the Winchelsea and Hector the 12th. April in the Latt: of 39. 57 N^o. from the Harcourt, Elizabeth & Hardwick the 17th. May in Latt. 8-10 S^o. and from the Horsendon the 16th. June in Lattitude 35-55 South.

(5th.) The Grosvenor for Coast and China & to call at Madiera and the Walpole for Coast & Bay left England some time before these ships. The Drake fell in with the Grosvenor the 19th. June and parted from her the next day.

This Quantity with what we before had may make about One Hundred & Fifty Tons & will serve for our October Ship, but we much fear we shall be deficient, a hundred or a Hundred & Fifty Tons in Bale Goods, should Your Honour &c^a. be able to put that Quantity on board the Godolphin and Admiral Watson over & above their proper Europe Cargoes and permit those Ships to call here in the Month of September they may proceed home in Company with the ship We dispatch from hence. But in case you think it improper to send those ships We must beg you will dispatch to us the Leopard Snow with some Bales of your Investment and what Salt Petre She can take in as soon as possible that We may not run any Danger from the Ships laying here after the change of the Monsoon.

HONBLE SIR & SIRs

We have reced your Letters dated the 14th. July & 12th. August. In the latter you acquaint us of your Intention to send round two ships to be provided on this side with Cargoes for Europe. We are to acquaint Your Honor & c^a. that the Fox having arrived from Batavia so late that We apprehended the Season would be far advanced before she could be dispatched to China & as she had been one Season in India We detain her for our Oct^r. ship, & We have sent to Bengal the Clinton Tilbury Drake & Hardwick. We expect the Walpole & Earl of Ashburnham daily these if they arrive safe in Bengal with one Ship from your Coast will be as many as can be dispatched from Bengal & hence by March next. But as We shall want a ship much to go to Bencoolen or Perchance to Manilha; if you cannot dispatch home the second ship you mention We shall be glad to have her sent here & not to Bengal.

At present We have only Gold in our Treasury having sent to China all the silver procurable but should We be able to get any by the departure of the ships from hence in October We will send it to you by them. This is however doubtful that if any opportunity offers of making you a remittance [. . .] half Lacks We will make use of it.
