Subject.—Report on the working of the Settlements established under the Criminal Tribes Act in the Bombay Presidency.

Sir,

I have the honour to submit the Administration Report for the year ending 31st March 1926 for the settlements established under the Criminal Tribes Act, VI of 1924.

Charge.

2. Mr. H. T. Sorley, I.C.S., served as the Criminal Tribes Settlement Officer up to 30th October 1925 and I served for the remainder of the year in that capacity.

Population.

3. Appendix I gives the population as it stood on 31st March 1926 in each of the settlements. The total population in the settlements is now 12,477 as against 12,605 in the previous year. This shows a slight decrease in numbers. During the year 201 fresh registered members of criminal tribes have been sent by Government under Section 16 Criminal Tribes Act to settlements. represent persons of multiple convictions taken from Bombay City, or the districts or jails. Some of them have an amazing number of convictions recorded against them. In one case recently admitted a Manggarudi has ten convictions. He has two wives, one of whom has eleven convictions and the other has ten convictions. The dependents of these new registered settlers also added to the population of the settlements. On the other hand 36 registered settlers and their dependents have been discharged on probation during the year. Again a group of 121 Chapparbands and their dependents (a total of 546) who had been given sites and had built houses on land which formed part of the Bijapur Industrial Settlement, have been finally declared to be freed from all settlement control by virtue of their good conduct, and the area has been excluded from the settlement limits. This has resulted in a big reduction in the population of this settlement,

The organization of work amongst the Criminal Tribes in Bombay City has been proceeding steadily during the year. The police have practically completed their survey, and have selected those persons of the worst criminal records for internment in settlement. These cases have been enquired into by myself or by my staff and recommendation made to Government for placing them when necessary in settlement. Most have been sent to Ambernath settlement, but a few have been distributed among the remaining settlements. Work amongst the Criminal Tribes left in Bombay City has been continued and 573 Manggarudis who were living unauthorizedly in various open sites have been brought together in a colony at Dharavi, and day school and a night school and a dispensary have been opened for them. A mission committee under Reverend Edwards is looking after the Manggarudis and Bhamptas, and the Kaikadis are being cared for by the Social Service League. Both these organizations are doing excellent reformative work. Now that the worst members of these castes are being removed away to settlements, I confidently hope that the efforts of the above organizations for the reform of the people under their care will be successful and it will not be necessary to remove the majority of these people to a settlement.

Employment.

4. The problem of securing employment for the settlement people during the year was not very difficult. The rains of 1925 in the area where settlements are situated were fairly good. The main difficulty was felt in Bijapur Special Settlement where the incorrigible settlers are kept. These are not permitted to go in the town for securing work for themselves. Internal industries such as agriculture, weaving and building work form the source of employment. The weaving section shared in the depression of trade felt by most weavers, and for a time it was working at a loss. The numbers were reduced by the transfer of selected persons to work in Nira Projects Canal where they were kept under supervision similar to that exercised in the Special Settlement. Changes were made in the system of the weaving factory, and in the staff, and it is hoped that the factory will soon be self-supporting. Employment in mills continues to be the chief source of employment for the settlers as in previous years. The following figures show the number of persons from settlements who are employed in spinning and weaving mills, and in the Match Factory at Ambernath:-

There is again a welcome increase to 198 in the number of persons from Hubli Settlement employed in the Railway workshops. These workshops provide excellent opportunities of training as skilled artizans.

In all of the settlements the construction of the buildings is done by settlement people mainly through contracts taken by the Settlement Producers' Societies. The Executive Engineers and their staffs give us much assistance by way of technical advice. Many of the apprentices of carpentry and masonry have now finished their apprenticeship and are working independently. We have to take precautions not to train too many carpenters and masons in any one town.

Work on the Nira Right Bank Canal and its distributaries continues to provide employment for a number of settlers. I would like to emphasize the value of a settlement of this kind which provides work of an unskilled type, and in which the number of persons employed can be expanded or contracted according to the need of finding employment for settlers. Again there are many persons in the settlements to whom the temptations found in a big town of petty pickpocketing in the busy bazaar and of excesses in the liquor shops and brothels are too great. We are getting an increasing number of such persons, as the system of combing out persons of multiple convictions from Bombay City and other big towns becomes more effective. It is a great relief to a harassed Criminal Tribes Settlement Officer to have such a settlement where regular work on the spot is provided, and the temptations of a city do not exist. The difficulty of such a settlement is that not being permanent in any one position it is difficult make the settlement comfortable either for the staff or the settlers.

Housing and Sanitation.

5. The policy of housing the settlers in huts constructed by themselves is still continued in most settlements. This of course saves Government much expenditure, and the birth and death statistics given below are a proof that the health of the settlers does not suffer in consequence. Exceptions have to be made in the settlements having a heavy rainfall such as Dandeli, Khanapur, and Ambernath. Government have definitely decided to abolish Kalyanpur settlement which is in the heart of the town and to remove all its inmates to Umedpur the new settlement on the outskirts of the town. This transfer is being effected as the staff and school buildings are constructed. Already the population at Umedpur is greater than that at Kalyanpur. The Manager of the settlement and the Lady Superintendents in charge of the school and women's work are already in residence at Umedpur, and the transfer will be completed as soon as the remaining buildings are constructed.

Health.

6. The health of the settlers during the year under report has been eminently satisfactory. There have been no serious epidemics.

It will be seen that the birth rate per mille of population is 42.0 which is greater than the average for the Presidency whilst the death rate is 18.2 per mille which is less than the average for the Presidency.

The figures are an eloquent tribute to the effective and unobtrusive work amongst the women and children by the medical staff and by the Lady Superintendents and their helpers. They are also a proof that the policy of allowing the people to remain in their own huts flimsy and ineffective as a protection against the weather as they often seem to be, rather than constructing chawls for them, is not detrimental to their health.

Education.

7. Elementary education is free and compulsory both for boys and girls up to the age of 13 years and for all children who work as half-timers in the mills.

The following table gives the number of children attending day schools.

The attendance of the school children compared with the population in the settlements is more than double the corresponding figure for the Presidency. A few boys are going to other schools for higher education.

Much more attention is given to Manual Training in these settlement schools compared with the ordinary schools. 451 boys are now receiving manual training in wood work, tin work, tailoring or weaving.

The Committee of Direction for Technical Education, Bombay Presidency, are kindly holding the examinations in the manual training work.

In Sholapur, Bijapur, Bagalkot, Gadag, Hubli and Gokak Falls settlements there are carpentry workshops attached to the settlements. The furniture prepared by some of these workshops, notably that at Hubli, has made a name for itself. There is a slight drop from 558 to 491 in the number of lads in the night schools. This drop is due to a more careful enforcement of the rule that no one over 18 years of age should be compelled or urged to come to the night school. We feel it is important to concentrate our attention on the maintenance of literacy amongst those who have not left school long.

Boy Scout and Girl Guide work is encouraged. There are now 21 troops of Boys Scouts having 445 scouts and 9 companies of Girl Guides having 284 guides and Blue Birds. Where the work is carried on with energy and enthusiasm it forms a very valuable factor in settlement life, and also provides a useful link with the boy and girl life of the town. Bagalkot Settlement Scouts seem to have done specially well.

The seventh Annual Settlement Exhibition was held at Hubli in January. The standard of workmanship was quite maintained. The industrial shield was again won by Bijapur Industrial Settlement, and the shield now becomes the property of this settlement. The medal for the best piece of work in the exhibition was won by a Bijapur Ghantichor lad for an excellent model in stone of the Golgumbaz. The exhibition attracted much attention and in fact

was too crowded to be comfortable I fear for the visitors. A number of exhibitors from the settlements were also successful in the Bombay Art Society Exhibition held in Poona in August last.

Co-operative Societies.

8. The Co-operative credit and producers' societies established in the settlements have continued to flourish and their financial position is satisfactory for the most part. The total of share capital and reserve funds is now Rs. 24,776-11-1 compared with Rs. 22,452-3-1 last year and the total of deposits Rs. 46,958-0-3 as compared with Rs. 33,367-6-1 respectively of the last year. The only Society giving us anxiety is the Producers Society at the Special Settlement Bijapur. The persons of this settlement are chosen as being too troublesome or dangerous for the other settlements and hence any work amongst them has obvious disadvantages. The most profitable undertaking of the year has been the working of a fuel coupe by the Khanapur Society.

Convictions and Absconders.

9. During the year under report there have been convictions in 44 cases involving 61 persons under the Criminal Tribes Act, 79 cases involving 127 persons for offences against property, 8 cases involving 11 persons for other offences and 4 cases involving 4 persons under Chapter VIII of the Criminal Procedure Code, making a total of 135 cases involving 203 persons. The corresponding total figures in the last year were 93 cases and 157 persons. Thus there has been an increase. One cause is evident. An unusual number of habitual criminals from Bombay City and elsewhere have been accepted during the year, whilst an increased number of persons of good conduct have been discharged from the settlements. Thus while the total number of persons in the settlements has remained about the same; the settlement staffshave been faced with a more serious problem than in previous years.

The causes of the increase in convictions in Hubli Settlement are under detailed investigation. One cause has however already been made clear. The Hubli figures include a large number of petty cases. The rise is barely proportionate to the rise in Hubli town convictions, there being a sudden rise in the latter from 71 to 390 cases. The rises is evidently due mainly to a change in policy in relation to petty offences. Part of the problem is to decide the point below which a theft is regarded as too petty to be registered. This is being considered by the District Magistrate and is indeed a problem which affects the general administration of the whole Presidency. The settlements have special ways of dealing with minor offences. As far as my experience goes, the punishments given under the settlement rules and the other special steps taken such as removal to a Childrens Home or placing the offender under the special supervision of a probation officer, or removal to another settlement, where this particular kind of temptation is not so present, are more effective than the punishments usually given by Magistrates in such petty cases. Such procedure is however not without its difficulties, and its correlation to the normal methods of registration of cases is now under consideration. At the same time though one cannot hope to keep all the settlers from crime, I cannot feel satisfied with the results in this direction of the years work. I hope however that the organization of the settlement guards which is now under consideration of Government will be helpful in reducing crime. We are trying also to make a more intensive study of the causes and treatment of crime, and a fortnight's course of study on the bearing of European and American experience on the problems before us has been arranged for the Managers and other senior staff.

The total number of absconders remaining untraced on March 31st, 1926 was 162. Of these only 58 were registered men, and 17 were registered women. It would only be these people who would likely commit offences while absconding. The rest were dependents. The corresponding total figure at the end of last year was 103. The increase is explained mainly by the fact that a gang of sixty-four Kanjar Bhats absconded from Sholapur Settlement on 10th March 1926. Forty-five of this gang were however cleverly traced by the Poona Police on April 3rd. In any case 162 absconders out of a population 12,477 does not represent a serious proportion.

Roll-Call.

When they first enter the settlement they are placed on daily roll call. If their conduct is satisfactory their roll-call is changed to weekly and later on they are exempted from roll-call. If their conduct is unsatisfactory they are placed on a roll-call held twice a day (evening and early morning). Check roll calls are also held at intervals. At present there are 2,049 on daily roll-call (double or single) 863 are on weekly roll-call and 314 are exempted from roll-call.

Discharge from the settlements.

11. Thirty-six registered persons and their dependents (53) have been discharged on probation and have left the settlements during the year. Forty-three more registered persons and their dependents (106) have been permitted to leave the settlement on probation but have not gone. I refer again to these figures later on. During the year 8 persons and their dependents (10 persons) were re-called from probation for bad conduct. Of these only one has been re-called for a conviction for an offence against property. The others have been re-called on suspicion or for infringements of the conditions of probation relating to roll-call and passes.

Special Establishments.

12. There are now 87 children in the Childrens Homes at Hubli, Bijapur and Baramati. As there are 2,515 children of school going age in the settlements it will be seen that only in very extreme cases are children placed in the Homes. Such children

are either themselves beyond the control of their parents, or are orphans with no suitable relatives to care for them or are children of irreclaimable criminals. Fourteen young persons were discharged during the year from the Homes. The marriages of some of the boys and of most of the girls were arranged before they were discharged. The question of these marriages has given us much trouble and thought. It would be comparatively easy for us to arrange suitable marriages, but exceedingly difficult to carry such plans into execution successfully. Naturally and rightly these young people are still largely influenced by the wishes of their parents specially in such matters. Moreover in afterlife a marriage undertaken against the wishes of the parents will be specially liable to end unhappily. Thus we have limited our authority to the refusal of permission of unsuitable marriages and in such cases have asked the parents to search again for a more suitable bride or bridegroom.

Whilst on furlough recently in England I was visiting some Reformatory and Industrial schools and meeting other persons experienced in the control of delinquent and neglected children. I was impressed with the body of opinion in favour of a comparatively short periods in a Home, followed by supervision on probation. Therefore we are working more in this direction in the present organization of the Homes. Of course this cannot be applied to all cases. There will still be cases where the child will have to be detained until he is old enough to establish a Home of his own.

13. The Womens Home at Hubli which is a Rescue Home for women from all the the settlements continues to be a very valuable aid to settlement work. During the year 43 women were admitted and 41 discharged. At the close of the year 15 women were remaining in the Home. The opportunities of the Home are in some directions greater than those of most rescue homes, as compulsory residence for a sufficient time can be enforced, and afterwards in suitable cases through the various settlement organizations satisfactory marriages or re-marriages can often be arranged. This difficult and trying work has been under the capable and kind control of Miss Edwards. She has now gone to England on a much needed furlough and Miss Briscoe has taken her place.

The Hurs from Sind are still in Nira Projects Settlement. Considering the reputation they had of being exceedingly desperate and dangerous, they have given surprisingly little trouble. Most of them were unmarried and were not able to arrange brides from Sind. They therefore tried to find wives from local places and such facilities as were possible were afforded to them. Many have married and settled down happily. In a few cases they have married too hastily women of bad repute, and the marriages have been failures.

Finance.

14. The total recurring expenditure for the financial year 1925-26 under "25 Jails and Convict settlements" was Rs. 2,74,277-11-6

and under "8 Forests" (for Dandeli) Rs. 4,596-7-9 making a total of Rs. 2,78,874-3-3. This results in an average expenditure per settler of Rs. 22-1-0 per annum.

General Remarks.

Settlement work has now reached a stage at which it is advisable to pause and take stock of the position. In the early days the settlement population was obtained by taking complete gangs of wandering criminal tribes and selected individuals from the settled castes. Many of these people have now by their good conduct earned their right to freedom, and are fit for discharge. But that is not what they wish for. The figures of those discharged on probation during the year are important. It will be seen that during the year 43 heads of families and their dependents (106) persons though offered their discharge on probation preferred to remain in the settlements. Their point of view is that they have secured regular work in the town and they also appreciate the amenities of the settlement and the help of the settlement staff. This is satisfactory as showing that settlement life is not unduly irksome, but some solution must be sought or they and their off-spring will remain as an indefinite burden on the State. This indicates a serious position and I am now endeavouring to solve the difficulty by organizing free colonies adjacent to the settlement. Such free colonies have already come into existence by the side of Umedpur Settlement and there are now 255 persons from the settlement on them. In this particular instance the colonies are financed by the Mills who employ these people. This forms a very satisfactory solution of the problem as far as this settlement is concerned. In Bijapur a detached part of the settlement on which the Chapparbands of good conduct who originally belonged to the settlement had built their houses has now been excluded from the area of the settlement, so that it becomes an ordinary part of the town. This accounts for the drop in population of this settlement. One immediate result is to increase the cost per head for the remaining settlers, but steps are being taken to adjust the staff and other expenses to the new conditions. For other persons fit for discharge on probation I am investigating the organization of agricultural colonies in places where there are blocks of Government waste land available. The Director of Agriculture has kindly lent one of his experienced men on deputation to assist me in this investigation and in the organization of the training in agriculture which will be necessary before such persons can be entrusted to work their fields independently.

The conditions of admission into settlements have also been tightened up as a measure of economy. At present persons with their dependents are admitted only if they have at least five convictions or two convictions if the sentences total seven years imprisonment.

16. During the year the superior staff has been re-organized and a redivision made of their duties. The supervision over the settlements and the auditing of their accounts has become more effective

in consequence. Mrs. D. Lamb has continued her efficient supervision over the schools and womens work in the Government settlements. Mr. C. S. Devdhar and Mr. Hyam S. Israel, have been in charge of the Southern and Northern Circles respectively and have each done their work efficiently. The Office Superintendent Mr. V. R. Dhotrikar has also worked hard. Mr. P. M. Kadam, Manager of Khanapur Settlement and Mr. S. G. Shettye, Manager of Dandeli Settlement have done specially well in their settlements. Mr. R. S. Kolekar, of the Criminal Tribes Settlement Officer's Office has also put in a years hard and efficient service. The Managers of the settlements under voluntary agencies have done well. The work of Mr. Strutton who is in charge of Sholapur Settlement which is the largest in India is worthy of the highest praise.

I would like to record also my appreciation of the assistance given by other departments. Without the sympathy and support of the District Magistrates and District Superintendents of Police work would be very difficult. Dr. S. P. Kumbhakonum L.M. & S., has continued his very valuable honorary services as Medical Officer of Hubli Settlement.

The support of the millowners at Sholapur and of the Swedish Match Factory at Ambernath, and of the Railway workshops at Hubli and of the Public Works Department has been of the utmost importance and I feel very greatful to them and to the other employers of labour who have come forward and given employment to these people, and so opened out to them a new and brighter future.
