## RESOLUTION OF GOVERNMENT.

On the 3rd February, 1921, the Ahmedabad municipality resolved not to accept the Government grant for education, and on the 11th February the schools committee determined by a narrow majority that the annual examination and inspection of the municipal schools by the deputy educational inspector should not be permitted. On the 28th of February the municipality, in spite of a warning from their president that the course they proposed to adopt was illegal, ratified the resolution of the schools committee, and effect was subsequently given to this resolution by the refusal of the chairman of the schools committee to permit the deputy educational inspector to inspect a particular school.

2. Section 54 (1) (p) of the Bombay District Municipal Act, 1901, imposes upon every municipality the obligatory duty of establishing and maintaining primary schools, and section 52 lays down that all municipal funds shall be applied subject to the provisions and for the purposes of the Act. Again section 58 provides that the extent of the independent authority of any municipality in respect of public education, and their relations with the Government Educational Department, shall be prescribed by Government and rules have been made under that section which have the force of law. Rule 3 of these rules lays down, *inter alia*, that the municipal schools shall be open at all times to inspection and examination by the Government-inspecting staff. It is clear, therefore, that the municipality by passing the resolution referred to above exceeded their powers under the Act, and that by giving effect to the resolution they made default in performing the obligatory duty of maintaining their primary schools subject to the provisions of the Act and the rules made thereunder.

3. The illegality of the course they were adopting was pointed out to the School Committee, and through them to the municipality, by the president in February, 1921, and to the municipality in March 1921, by the Collector and the Commissioner, but the municipality committed further breaches of the law by disobeying regular orders under section 174 (1) and 174 (2) of the Act passed by the latter authorities. In Government Order, Educational Department, no. 1833, dated the 5th April, 1921, which dealt with a similar situation in Nadiad municipality, and in another published resolu-

tion, Educational Department, no. 430, dated the 23rd September 1921, Government endeavoured to make the constitutional position clear and brought certain considerations to the notice of the councillors and of the ratepayers of Ahmedabad, but these appeals to reason were unsuccessful.

4. On December 7th Government made an order under section 178 of the Act declaring that the municipality of Ahmedabad had made default as described above, and directing the Commissioner, to fix a period for the performance of the obligatory duty. The Commissioner fixed a period ending on December 17th, and as the municipality failed to comply he proceeded, with the full approval of Government, to take the further steps prescribed in that section, appointing the deputy educational inspector to manage the schools and directing the municipality to pay the expenses. This the municipality did not do, and accordingly the Commissioner issued an order under section 178 (3) directing the Imperial Bank to pay the necessary amount.

5. On January 6th the municipality passed a resolution contesting the legality of the Commissioner's orders and informing him that the schools committee would continue to manage the schools. The operation of the latter part of the resolution was suspended by an order of the Collector, modified by the Commissioner, but notwithstanding this the managing committee proceeded to the treasury on January 7th and obtained payment of certain cheques of the schools committee, thus overriding the powers which are vested by the Act in the president and the chief officer.

6. For these reasons the Government of Bombay (Transferred Departments) are of opinion that the municipality of Ahmedabad have persistently made default in the performance of a duty imposed upon them by the Act, namely, the duty of maintaining primary schools subject to the provisions of the Act, and that they have exceeded and abused their powers by passing resolution no. 884, dated the 28th February 1921, and by disobeying the statutory orders, approved by Government, of the Collector and the Commissioner. Government, therefore, hereby declare the said municipality to be in default and to have exceeded and abused their powers in the manner aforesaid, and hereby supersede them for a period of two years from the date on which this resolution is communicated to the president of the municipality.

7. The attention of the Commissioner, N. D., should be invited to the provisions of section 179 (2) (b) of the Bombay District Municipal Act, 1901.

## APPENDIX LLL.

*Copy of Clause 6 of the Barsi Light Railway Company's contract with the Secretary of State dated 7th October 1913.*

6. In addition to the rates and fares authorised by Clause 27 of the Contract of 1902 the Company shall be entitled to charge a pontage on passengers and goods traffic crossing the Bhima River subject to the following conditions, that is to say :—

(1) Such charge shall not exceed as a maximum the cost of carriage for 20 miles at the mileage rate quoted from the station of origin to the station of destination on the undertaking of the Company.

(2) The levying of such charge shall be optional with the Company but if such charge shall be levied on any particular item or description of traffic it shall be levied in both directions and charged on both through and local traffic, the charge in both cases being calculated at the same mileage rate and for the same distance.

(3) Any such charges which are intended to be levied must be notified in the traffic changes memoranda, and must be subject to the Conference Regulations in every respect as regards any changes in the rates and conditions that have once been notified.

## Sessions Court Jurisdiction.

## Sessions Case No. 33 of 1921.

At a Court of Criminal Sessions held at Karachi before B. C. Kennedy, Esquire, I.C.S., Judicial Commissioner of Sind, this 24th day of October 1921, the following accused persons :—

- (1) Mahomed Ali of Rampur,
- (2) Moulvi Hussein Ahmed of Deoband,
- (3) Dr. Saifuddin Kitchlew of Amritsar,
- (4) Pir Ghulam Majdid of Matiari,
- (5) Moulvi Nisar Ahmed of Cawnpore,
- (6) Bharti Krishna Tirathji *alias* Venkatraman,
- (7) Shoukat Ali of Rampur,

committed for trial by S. M. Talati, Esquire, City Magistrate of Karachi, are placed at the Bar and charged :—

(1) That you all the seven accused at some time or times between the months of February 1920 and September 1921, both inclusive, at Karachi and other places in British India were (with others) parties to a criminal conspiracy to seduce Mahomedan officers and soldiers in the Army of His Majesty the King Emperor from their duty and thereby committed an offence punishable under sections 120B/115 read with section 131 of the Indian Penal Code and within the cognizance of this Sessions Court.

(2) And you the said seven persons are further charged that in pursuance of the said conspiracy attempts were made by a member or members of that conspiracy in or about the months of July or August 1921 to seduce the Mahomedan Officers from their duty by sending leaflets in the form of Ex. 34 to such officers and you thereby committed an offence punishable under sections 120B/109 read with section 131, Indian Penal Code, and within the cognizance of this Sessions Court.

(3) And further that you Mahomed Ali on or about the 9th day of July 1921 at Karachi made a statement to wit that "it is in every way religiously unlawful for a Mussalman at the present moment to continue in the British Army or to enter the Army or to induce others to join the Army" with intent to cause or which is likely to cause Mussalman officers and soldiers in the Army of His Majesty to disregard or fail in their duty as such and thereby committed an offence punishable under section 505 of the Indian Penal Code and within the cognizance of this Sessions Court.

(4) And further that you (accused 2 to 7 inclusive) conspired with the said Mahomed Ali to commit the said offence under section 505, Indian Penal Code, which he committed in pursuance of that conspiracy and you thereby committed an offence under section 109, Indian Penal Code, read with section 505, Indian Penal Code, within the cognizance of this Sessions Court.

(5) And further that you Mahomed Ali on or about the 9th day of July 1921 at Karachi abetted the commission of an offence punishable under section 505, Indian Penal Code, and/or section 131, Indian Penal Code, by more than 10 persons in that you stated in the All-India Khilafat Conference that " it is the duty of all Mussalmans in general and the Ulema in particular to see that these religious commandments (referring to the words quoted above) are brought home to every Mussalman in the Army and thereby committed an offence under section 117, Indian Penal Code, and within the cognizance of this Sessions Court.

(6) And further that you (accused Nos. 2 to 7) conspired with the said Mahomed Ali to commit the said offence under section 117, Indian Penal Code, which he committed in pursuance of that conspiracy and you thereby committed an offence punishable under section 109 read with section 117, Indian Penal Code, and within the cognizance of this Sessions Court.

IN THE COURT OF THE JUDICIAL COMMISSIONER OF SIND.

Sessions Court Jurisdiction.

Sessions Case No. 33 of 1921.

The King Emperor

*versus*

Mahomed Ali and 6 others.

*Judgment.*

I accept the verdict of the jury in respect of the charges under sections 120-B and 131, Indian Penal Code. I have considered the opinion of the assessors as regards the other charges. I agree with the opinion of the majority of the assessors and find that accused No. 1 Mahomed Ali made a statement on the 9th July 1921 at Karachi calculated to cause the Mussalman officers and soldiers in the Army of His Majesty to disregard or fail in their duty, and that as he made it with the intention of causing such an effect, the truth of it is not material. I therefore find him guilty of an offence under section 505, Indian Penal Code.

Agreeing also with the opinion of the majority of the assessors, I am of opinion that all the other accused with the exception of accused No. 6 conspired with Mahomed Ali and agreed with him that he should make the statement that he did make with the intention of producing such an effect on the Mussalman Officers and Soldiers in the Army of His Majesty.

As regards accused No. 6, after hearing the opinion of the assessors I am of opinion that there is a fair doubt as to whether he conspired. This opinion would obviously be of little weight.

Agreeing also with the opinion of the majority of assessors, I am of opinion that the accused No. 1 Mahomed Ali at the same time and place in the same way abetted the commission of the offence punishable under section 505 by bringing that statement specifically to the notice of the public there assembled at the meeting and by urging them to bring it home to every Mussalman in the Army. I think therefore that he committed an offence punishable under section 117, Indian Penal Code, with 505 and 131, Indian Penal Code.

Agreeing also with the opinion of the majority of the assessors I find that all the other accused with the exception of accused No. 6 (Bharti Krishna Tirathji) conspired with accused No. 1 in the commission of this offence by agreeing with him that he should make the statement which he did make with the same intent, well knowing that it would so direct or incite the public to bring such statement to the notice of the Mahomedan soldiers and troops.

*The Sentence.*

(To accused No. 6). The Court accepts your explanation of your action and agreeing with the jury and the assessors, I find you not guilty and acquit and discharge you of all the charges.

(To the other accused). Agreeing with the verdict of the jury I find you not guilty in respect of the offences under sections 120B and 131 and acquit and discharge you as regards those offences.

I find you accused No. 1 guilty of an offence under section 505, Indian Penal Code, and sentence you to undergo two years' rigorous imprisonment.

I find you accused 2, 3, 4, 5, 7 guilty of conspiring with accused 1 to commit the said offence and sentence you under sections 109 and 505, Indian Penal Code to undergo rigorous imprisonment for two years.

I also find you accused No. 1 guilty of an offence under section 117 with 505 and 131, Indian Penal Code, and you accused Nos. 2, 3, 4, 5, 7 guilty of conspiracy in respect thereof with accused 1 under sections 109 and 117 with 505 and 131 and sentence you to undergo two years' rigorous imprisonment; the said sentence to run concurrently with those passed under the 3rd and 4th charges.

## APPENDIX TTT.

## PRESS COMMUNIQUE.

As notified in the *Bombay Government Gazette* of 15th December 1921, Government have sanctioned with effect from 1st January 1922 certain increases and surtaxes in the Docks and Bunder charges on goods, and in the Port dues on vessels, levied by the Bombay Port Trust.

The only permanent increases in wharfage charges are on raw cotton, and on coal *when landed in the docks*: these charges are to be doubled.

All wharfage charges, except those on oil which were enhanced earlier in the year, are to be subject to a temporary surtax of 50 per cent. Port dues on vessels are to be doubled, the existing surtax of 50 per cent. being abolished—the net effect being an increase of 33½ per cent. on the present scale. Thus Port dues at Bombay will in future be levied at the rate of two annas per registered ton, but they will still compare very favourably with the rate of four annas per ton levied at Karachi and Calcutta.

In forecasting their budget for the current financial year the Trustees were alive to the prospect that they would shortly have to consider an all-round increase in rates, but they decided to defer taking action until the need was proved. The figures now available show that without an increase in charges there will be a deficit of 30 lakhs on the current year's working; while it is estimated that an additional revenue of 60 lakhs will be required next year in order to make income balance expenditure. This state of affairs is due to—

- (1) heavy capital charges on new works which are not yet yielding any return,
- (2) falling off in imports and exports,
- (3) increase in cost of working.

As regards (1) it must be remembered that new borrowings now cost the Trust about 7 per cent. per annum, and that interest and sinking funds on capital borrowings have to be met from revenue. The principal new works on which the Trust are now engaged are the Cotton Depôt at Mazagon, estimated to cost 60 lakhs, the bulk oil pier at Trombay, estimated to cost 60 lakhs, and the surfacing up of the great storage depôts on the Mazagon, Sewree and Wadala reclamations. Moreover a large quantity of railway and dredging plant has been ordered. The New Cotton Depôt and Oil Pier may reasonably be expected to be in full use in 1923 and, given a normal revival of trade, the Trustees hope then to be in a position to review the situation and remove or reduce the increases now imposed.

As regards the falling off in trade it is of interest to note that while the tonnage of ships using the Docks and Harbour Wall in 1920-21 showed an increase of 47 per cent. over the 1913-14 figures, the tonnage of goods dealt with showed a falling off of 22 per cent.; in the meantime the dock accommodation had been doubled.

Bombay has been fortunate as compared with most other ports in the world in that it has been possible to postpone till now a general increase in charges. Most of the British ports found it necessary to enhance their charges soon after the outbreak of war by as much as 125 per cent. and it ~~only~~ within recent months that the reduction in labour wages in Great ~~Britain~~ has enabled some of these ports to reduce their surtax to 100 per cent.
