## Memorandum explanatory of the figures under each Major Head of Revenue and Expenditure.

FINANCE DEPARTMENT.

### INTRODUCTORY NOTE.

The accounts are presented in the same form as last year. It should be noted that the form is determined by the Government of India and that the Local Government is not competent to alter the form in any respect without the sanction of the Auditor General. Some important changes in the heads under which certain revenue and expenditure are required to be shown have been carried out in this budget by order of the same officer, for example, the transfer between Land Revenue and General Administration. Details have been given in subsequent notes.

2. In the final issue of the Civil Estimates of the current year 1923-24, the opening balance for the year is shown as Rs. 3,48 lakhs\*. This balance subsequently improved to 4,02 lakhs. This improvement of 54 lakhs is due to the reduction of expenditure in all Departments in 1922-23 which amounted to not less than 71 lakhs, so that although there was a net fall in the revenue of 17 lakhs we were able to show a very substantial increase in the balance with which we opened the year. The reduction of 71 lakhs in expenditure occurs under Stamps 2, Forest 5, Interest on Irrigation Works 3, Irrigation 13, Jails 2, Police 7, Education 5, Public Health 5, Civil Works 4, Miscellaneous 8, Advance and Loan Account 16 and other heads 5, counterbalanced by minor increases amounting to 4. The net fall of 17 in revenue is due to decreases under Taxes on Income 12, Land Revenue (including Irrigation) 15, Stamps 13, Forest 7, Miscellaneous adjustments 14 and other heads 2, counterbalanced by increased revenue under Excise 16, Police 6, Interest 4, Scheduled Taxes 3, Public Health, Civil Works, Superannuation and Miscellaneous 2 each, Loan and Advances Account 6 and minor heads 3.

3. This improvement is reflected in the closing balance of the current year which taken at 3,60 lakhs in the budget is now estimated to be 4,27 lakhs. In addition to the improvement of 54 lakhs due to the transactions of 1922-23 there is further improvement of 13 lakhs in the closing balance which is explained below :—

A decrease in expenditure has occurred under Irrigation 4, General Administration 21, Administration of Justice 3, Jails 2, Police 7, Medical 3, Miscellaneous 6, Loan and Advance Account 20, and other heads 7, counterbalanced by increased expenditure under Land Revenue 16, Public Health 3, Superannuation 7, a net fall of 47 lakhs. There has also been a reduction in receipts under Land Revenue (including Irrigation) 62, Stamps 26, Forest 8, Administration of Justice 3, Loan and Advance Account 10 and other heads 3, counterbalanced by increases in revenue under Excise 14, Scheduled Taxes 10, Interest 5, Police 3, Superannuation 3, Miscellaneous 3, Miscellaneous adjustments 12 and other heads 3, a net reduction of 59 lakhs. 25 lakhs will be added to the balance by transfer from the Famine Insurance grant.

4. We expect therefore to start the next year with an opening balance of 4,27 lakhs. Within this total is included the Famine Insurance Fund which now amounts to about 89 lakhs. It also includes 1,08 lakhs which will ultimately have to be paid to the Government of India under our Provincial Advances and Loan Account. Under Devolution Rule 23, we are repaying to the Government of India the advances made from the pre-Reform Provincial Loan Account at the rate of 29 lakhs per annum. Our recoveries from the borrowers hitherto have been in excess of our repayments. But we expect next year to draw on this accumulation of 1,08 lakhs to the extent of 29 lakhs in repaying our instalment to the Government of India. The total therefore of ordinary balances available for immediate use in emergency is 2,30 lakhs. This we do not propose to touch.

5. The Famine Insurance Fund is under the Government of India Act being built up out of the savings from the annual budget grant for famine relief which may not be less than 63,60. The statute permits us to utilise any part of this annual provision for constructing protective irrigation works as well as for other famine expenditure and we took advantage of this permission during the current year to meet 32 lakhs expenditure on irrigation works out of this grant. This year, in view of the general desire that we should hasten the building up of our Famine Fund, we have determined to leave the whole provision under the head 43, Famine Relief, the only exceptional expenditure that will be met from this head being 10 lakhs towards the interest on the Sukkur Barrage Loan. Incidentally it may be mentioned that we obtain interest from the Government of India on our Famine Fund, but not at present on our ordinary balances.

6. Loan money is provided for ordinary expenditure (that is to say other than for Development, which is dealt with in the appendices) as follows :—

A. *Irrigation, 389 lakhs.*—This includes 328 lakhs for the Sukkur Barrage Scheme, and the balance is for the completion of the big irrigation works in the Deccan, and for minor works throughout the Presidency :

B. *Civil Works, 97 lakhs.*—A list of new works which we have decided to undertake from loan is attached. The remainder of the loan is for the completion of the works in progress :

7. At the time of submitting the budget for the current year it was explained that while we continued to take advances from the Government of India to meet capital expenditure and were providing for regular repayment of those advances it was considered unnecessary to have an actual Sinking Fund Account, and a statement showing interest and sinking fund charges which were debited to each Department on account of unproductive expenditure from loans was submitted to the Council. It has now been determined that an actual sinking fund shall be established on account of the unproductive portion of our loan, and that each Department shall provide in its own departmental budget for its share of the sinking fund and of the interest due on the loan. Accordingly provision has been made under the expenditure head 21 and under deposit heads for the sinking fund. It has not been possible in this budget to show the distribution over Departments, since at the time of preparing the budget the actual expenditure on account of each department is not known. In future budgets the debit will be shown under the departmental heads. The total outstanding unproductive capital outlay from loan on Civil Works is 1,08,54. The provision of this fund will not only enforce economy on departments by creating an automatic break on demand for loans, but will at the same time by setting apart compulsory savings from revenue ensure that the safe limits of borrowing for unproductive works cannot be exceeded.

8. Coming now to the principal items in our budget, on the revenue side we anticipate Land Revenue receipts of 576 lakhs. This estimate, as does the current year's, includes extensive arrears of past years, and as reported in the current year's budget note, we cannot assume a normal land revenue of more than 507 lakhs. Under Excise there is an estimated increase from 402 lakhs in the current year's budget to 440 lakhs in the new budget, 23 lakhs of which is due to transfer to revenue of accumulated profits made in the manufacture of liquor. None of the other items calls for special comment, except under the head Irrigation. The changes therein are due to the account rules by which certain canals are from time to time transferred from the class of "works financed from revenue" to "works for which capital accounts are kept". Reference has already been made to the apparent changes

under the heads Land Revenue and General Administration (on the Expenditure side). This is purely an account transfer by which the Auditor General considered that the cost of certain village establishments would be more correctly allotted.

9. Enough has been said to indicate that the budget statement will prove that while our present financial position gives no cause for pessimism, yet it is equally clear that we have reached a stage at which our resources have ceased to maintain the steady rate of increase to which the pre-Reform provincial conditions had accustomed us, and that without additional sources of revenue we cannot further expand the administration. We have arrived at a balance of revenue and expenditure only by the most rigorous economy in all the Departments. It is of the utmost importance that we should retain the additional revenues which we obtain from the revised Stamp Act and Court Fees Act, the latter of which will expire with the current year.

## II, Taxes on Income.

10. Under revised rule 15 of the Devolution Rules the whole cost of income tax establishments is to be borne by the Central Government and Provincial Government is to receive from the Central Revenues a sum calculated at the rate of three pies in the rupee not on the assessed income for the year but on the amount by which the assessed income of the year is estimated to exceed the assessed income of the year 1920-21. In view of the decrease in income-tax receipts it is unlikely that this Government will get anything on this account during the current and next years.

*Revenue.*

11. The decrease in the revised as compared with the budget for 1923-24 for ordinary land revenue (including miscellaneous) is due to the fact that the



rainfall of the current year was unsatisfactory for kharif as well as rabi crops. This has necessitated the grant of suspensions and remissions of land revenue on a large scale in almost all parts of the Presidency. The increase in the revised land revenue due to irrigation is due to the classification of certain canals under "55, Construction of Irrigation, Navigation, etc.," and the consequent increased credit of irrigation revenue under the head "XIII". Refund is based on the latest figures furnished by district officers. The increase of 1,90 in the Assessment of Alienated Lands less Quit Rents is mainly due to the introduction of revision settlements in certain districts of the Central Division. For recoveries of service payments 30 has been entered in the revised under this head in view of the latest actuals.

12. There is an increase of 12,31 in the ordinary land revenue (including Miscellaneous) for 1924-25 as compared with the budget estimate for 1923-24. The increase is due to the expected recovery during next year of the bulk of the suspensions of land revenue granted during the current year and also to the revision settlements introduced into certain talukas. The next year's estimates are based on the assumption that the season will be a normal one.

13. The figures of estimated demand, collections, remissions and suspensions of ordinary revenue for 1923-24 and 1924-25 are given below :—

#### *Expenditure.*

14. The increase in the revised as compared with the current year's budget is chiefly due to (i) the transfer to this head of a fixed amount of 18,78 being the portion debitable to "5, Land Revenue" of Charges of District Administration except of the Collectorate of Bombay, which are wholly provided under "22, General Administration", (ii) the proportionate increase in the remuneration of village officers owing to the introduction of revision settlements in certain districts in the Central Division, and (iii) new provision for small works executed by departmental agency which according to the new system of accounts is shown under each major head. On the other hand, the increase is counterbalanced by decrease in expenditure due to savings in the provision for (i) pay of officers and establishment under "Survey and Settlement", and (ii) pay and allowances to District and Village Officers. Expenditure in England formerly debited to each major head is now provided under separate Budget Heads "Expenditure in England under the control of the High Commissioner and the Secretary of State", but for the sake of comparison, the figures are given under each major head at the end of the estimates.

15. *Charges of District Administration.*—The increase in the budget of 1924-25 as compared with the budget of 1923-24 is mainly due to transfer to this head of a fixed amount of 18,78 being the portion debitable to "5, Land Revenue"

of Charges of District Administration except of the Collectorate of Bombay, which are wholly provided under "22, General Administration". Charges on account of the Encumbered Estates in Sind which were hitherto provided under this minor head have been transferred with effect from 1924-25 to a new minor head. These charges are covered by a contribution from the Encumbered Estates, the amount of which is directly deducted from expenditure. The amount of contribution is generally higher than the immediate charges, as an extra amount is recovered on account of contributions for leave allowances and pension. The charges on account of Encumbered Estates for the year 1924-25 amount to 1,06 and the contribution to be recovered from the Estates is estimated at 1,17. This accounts for a *minus* entry of 11 against minor head No. (8).

16. *Survey and Settlement*.—The slight increase is chiefly due to the grant of usual increments of pay to officers.

17. *Land Records*.—The large decrease is due to the transfer to the head "22, General Administration" in accordance with the ruling of the Auditor-General, of the charges on account of the pay and allowances to District and Village Officers. But for this transfer there would have been an increase under this minor head owing to increase in expenditure for akarbard work and City Survey maintenance establishments and for pay of officers, establishment, allowances and contingencies.

18. *Allowances to District and Village Officers*.—The whole of this minor head has been transferred to "22, General Administration".

19. *Compensations*.—The decrease is due to decreased provisions for inams not exceeding Rs. 5,000 and for village servants useful to communities and devasthanans. It is partly counterbalanced by increases in the provisions for District and Village Officers and miscellaneous land revenue compensations.

20. *Expenditure in England*.—The budget provides for expected charges on account of freight and value of Europe stores for the Photozinc Office and payment of leave allowances and law charges in England.

## Revenue.

21. *Licenses and Distillery Fees, etc.*—The increase of 13,57 in the revised as compared with the current year's budget occurs mainly under (1) country spirit vend and license fees, (2) tree tax receipts, (3) vend fees for sale of toddy, (4) duty on Indian-made beer, (5) pass fees on foreign liquor and (6) opium vend fees, partly counterbalanced by a fall in (1) still-head duty and (2) duty on Indian-made wines and spirits. The increase of 13,59 in the ensuing year's estimate as compared with the current year's budget is due to higher receipts anticipated under country spirit, toddy and opium vend fees, toddy tree tax receipts, duty on Indian-made beer and pass fees on foreign liquor partially counterbalanced by a fall in still-head duty. The new budget follows as far as possible the current year's revised with variations where necessary.

22. *Gain on sale-proceeds of excise opium.*—The decrease of 1,50 in the revised as compared with the current year's budget is due to the high price of the drug and the consequent decline in consumption. The ensuing year's budget is based on the progress of actuals.

23. *Hemp Drugs.*—The increase of 1,57 in the revised as compared with the current year's budget occurs under vend fees. The increase of 1,81 in the ensuing year's estimate as compared with the current year's budget is due to higher receipts anticipated under duty on ganja and under hemp drugs vend

fees and is based on the progress of actuals. It also allows for the contemplated enhancement from 1st April 1924 of the duty on charas in Sind from Rs. 50 to Rs. 60 per seer.

24. *Fines, confiscations and miscellaneous.*—The receipts under this head are fluctuating. The increase of 62 in the revised as compared with the current year's budget is based on the latest actuals as furnished by the departmental officers. The increase of 40 in the ensuing year's estimate as compared with the current year's budget calls for no remark.

25. *Gain on sale-proceeds of country spirit.*—This represents the difference between the price (*ex duty*) at which country spirit is supplied to retailed vendors and the supply rate paid to distillery contractors. The receipts include arrears from the year 1921-22. Hitherto they were included in the general balances of Government but it has been decided to open a separate head. The figure 23,34 adopted for the purpose is approximate and subject to modification.

#### *Expenditure.*

26. *Superintendence and Presidency Establishment.*—In the current year the expenditure under the first minor head which includes the Personal Assistant to the Commissioner of Customs, Salt and Excise and the Commissioner's clerical establishment as well as the expenditure under the second head appear under "3, Salt" the provincial share (4/9th) being subsequently transferred to "6, Excise". The share so transferred is shown under the minor head "District Executive Establishment." The *minus* entry in 1922-23 (accounts) and 1923-24 (budget and revised) against the minor head "Presidency Establishment" represents the recovery from the Bombay Municipality of the leave and pension contribution in respect of the tobacco establishment which is, under the control of the Superintendent of Salt and Excise, Bombay Sub-division. With effect from 1st March 1924 the Salt and Excise establishments in the Presidency proper will be separated. The necessary provision has therefore been shown against the two minor heads. The amount under "Superintendence" represents two-thirds of the expenditure on account of the Commissioner of Customs, Salt and Excise and his Personal Assistant and office establishment. At present the pay and allowances of the Commissioner and his menial establishment and contingent charges of his office are debited wholly to 1, Customs (Central) and the pay and allowances of his Personal Assistant and clerical establishment are divided between "3, Salt" and "6, Excise" in the proportion 5:4. The excise share appears under "District Executive Establishment." The provision for 1924-25 shown under "Presidency Establishment" represents the cost of the Excise establishment in the Town and Island of Bombay.

27. *District Executive Establishment.*—The decrease in the ensuing year's estimates as compared with the current year's budget is due to the fact that the provision for the Presidency Excise establishment and for the Commissioner's Personal Assistant and the clerical establishment which now appears under "District Executive Establishment" will with effect from 1st March 1924, be shown under the first two minor heads as stated above. Inclusive of this provision the total comes to 20,77, *i.e.*, an excess of 1,70. Out of this increase 1,23 is due to the contemplated reorganization of the Combined Salt, Excise and Opium Department in Sind and revision of the ratio of distribution of the expenditure of this Department under which the share debitable to "6, Excise" will be raised from 3/7 to 3/4. The remaining increase is due to incremental salaries, provision (16) for the revision of the pay of Superintendents of Excise and increase from 18 to 37 of the amount transferred from "22, General Administration" on account of establishment charges of Collectors for excise work. But for this, there would have been a decrease owing to the separation of the Salt and Excise establishments in the Presidency proper.

28. *Excise compensations.*—The current year's budget includes 9,51 for the adjustments for the years 1914-15 to 1919-20 in respect of the Abkari revenue and for the quinquennium ending 1920-21 in respect of the hemp drugs revenue of the amounts of compensation paid to Indian States for the lease of their

Abkari and hemp drugs revenues in accordance with the terms of the agreements entered into with them. Against this the provision for 1924-25 is 75 on account of the adjustment of hemp drugs lease accounts for the years 1921-22 to 1923-24.

29. *Expenditure in England.*—The provision under this minor head is intended mainly for leave allowances payable in England and varies with the number of officers on leave. The decrease in the current year's revised and increase in the ensuing year's budget is due to this.

30. *Exchange.*—The variations under this minor head follow those under the foregoing minor head.

*Revenue.*

31. The current year's estimate includes 16,35 on account of receipts from the Bombay Entertainments Duty Act. In the next year's estimate this item has been provided under a new head "IX-A, Scheduled Taxes". Excluding this provision the revised estimate as compared with the sanctioned estimate shows a decrease of 10,00 which is mainly due to decrease in the sale of General Stamps and in the duty on impressing documents. This decrease is due to the general depression in trade. The next year's estimate is higher than the current year's revised by 6,50.

32. This estimate is based on the assumption that the trade conditions may not remain throughout the next year what they now are. Besides, some additional receipts are anticipated from the increased process fees in Sind and from increased sale of insurance stamps on account of the Workmen's Compensation Act which will come into force from 1st July 1924.

*Expenditure.*

33. Excluding from the current year's budget the provision of 35 on account of establishment charges for the administration of the Bombay Entertainments Duty Act which has been separately shown in the next year's budget under "9-A, Scheduled Taxes" the revised estimate shows a decrease of 59 which is mainly due to anticipated savings under 'Superintendence', smaller expenditure on sale of general stamps and transfer of 10 from the provision of "Expenditure in England" to the head "9-A, Scheduled Taxes". The increase in the next year's budget as compared with the current year's budget and revised estimates is mainly due to a greater provision under "Expenditure in England" and "Charges for sale of General Stamps". The provision under the former head is necessary as nearly two years' stock of stamps is to be received during the next year in order to avoid any possibility of shortage of stamps occurring during the period which may elapse between the termination of the contract with Messrs. De la Rue and Company (which takes place on 31st December 1924) and the commencement of the production of stamps in India. The increased provision under "Charges for sale of General Stamps" is required as stamp vendors in the mofussil have been allowed to sell stamps up to the value of Rs. 75 instead of Rs. 50 which will enable them to earn greater discount.

## Revenue.

34. *Timber and other produce removed from the forests by Government agency.*—The decrease (8,33) in the revised estimate is due to the slump in the timber market as a result of which the depôt sales have not fetched as much as was expected. The decrease is also due to the discontinuance of the fuel contract by the Hyderabad Municipality and to the sale of trees standing in High Forests for exploitation by purchasers, the resultant revenue being credited to the sub-head "Timber and other produce removed from the forests by consumers or purchasers". The system of departmental exploitation of these high forests in Kanara is to be resumed next year. The estimate for 1924-25 is based on the current year's budget and shows an increase of 78. It allows for the extra revenue (1,35) expected from the intensive departmental exploitation of High Forests in Kanara, Northern Division and in Sind.

35. *Timber and other produce removed from the forests by consumers or purchasers.*—The decrease (95) in the revised estimate is due to the poor prices obtained in Thana for forest and Gurucharan coupes. The decrease has been partly counterbalanced by better prices for coupes realised in Northern Division, Kanara, West Khandesh and Kolaba, by outstandings of past years recovered in



Central, Western and Northern Divisions of Kanara and by the enhancement of grazing fees in Kolaba and Bijapur. The next year's budget estimate shows a decrease of 2,91 as the system of selling trees standing in Kanara High Forests which has not worked very satisfactorily is to be abandoned and departmental exploitation resumed.

36. *Miscellaneous.*—The increase (1,18) in the revised estimate is due to the payment of fines by contractors and to larger receipts from the compounding of offences. The increase of 20 in the next year's budget estimate is based on actuals.

*Expenditure.*

37. *A.—Conservancy and works.*—The increase (84) in the revised estimate is due mainly to the extension of departmental exploitation and to the cost of supplying sawn timber to the Railways and the Military Department which was not fully budgetted for. As compared with the current year's budget the next year's estimate shows an increase of 2,48. The increase is due to the larger provision required (1) for supply of sawn material to Railways and for departmental fellings to be undertaken on a more extensive scale in Kanara, Sind, Dangs and Peint, (2) for purchase of sawmill stores and (3) for full supply of uniforms to the subordinate establishment, the next year being the first year of the contract period of four years.

38. *B.—Establishments.*—The decrease (1,48) in the revised estimate (which includes the charges under the minor head "General Direction") is mainly due to the savings expected in the provision for leave allowances of the subordinate establishment and to the reduction of establishments. The next year's budget estimate shows an increase of 45 which is mainly due to larger provision for salaries on account of periodical increments.

39. The estimate of 50,45 for 1924-25 is exclusive of 2,43 for productive works to be financed out of loan funds. The corresponding provision in the current year's budget is 6,68.

40. The decrease in the current year's revised and in the next year's budget estimates is due to the general depression of trade.

*Expenditure.*

41. The decrease in the current year's revised estimate as compared with the budget is mainly due to the transfer of 10 for the construction of a photo shed from "9, Registration" to "41, Civil Works" and saving in the grants for temporary establishment and pay of Sub-Registrars and clerks on account of the introduction of the photocopying system.

42. *Receipts.*—The Bombay Entertainments Duty Act came into force from February 1923 and the estimate of 16,35 was merely a very rough estimate. This accounts for the difference between the current year's sanctioned and the revised estimates. The revised estimate is based on the actuals for the first eight months and on anticipated receipts for the remaining four months. The next year's estimate is based mainly on the revised estimate of the current year.

43. *Expenditure.*—Excluding the provision of 10 made under "Expenditure in England" on account of Entertainment Duty Stamps the revised estimate shows a decrease of 12 in the expenditure mainly because the sanctioned estimate includes provision for two Supervisors for Bombay City whereas from the experience of the working of the Act, only one Supervisor is found sufficient for the City for the present. Also, in Karachi and Sholapur the additional establishment entertained during the current year has been discontinued as it is found that the work can be done by the existing clerical staff of the Collectors concerned.

44. The next year's estimate is slightly higher than the current year's revised estimate principally on account of the increase in the conveyance allowance of the Supervisor and entertainment of an additional Inspector for Bombay City for more efficient supervision in the interests of Government revenue.

**NOTE ON THE SYSTEM OF CAPITAL AND NON-CAPITAL  
ACCOUNTS OF IRRIGATION WORKS MAINTAINED IN  
THE PUBLIC WORKS DEPARTMENT.**

45. Irrigation works are divided into two main categories (1) works for which Capital accounts are kept and (2) works for which Capital accounts are not kept. All irrigation works, of which it is both desirable and possible to maintain accounts on a *quasi* commercial basis, are included in the former category and those for which the maintenance of such accounts is either impossible or unnecessary, either because they produce little or no revenue or because owing to their restricted size it is not worth while examining the returns paid by each individual work, are put under the latter class. The important criterion in the case of a *quasi* commercial undertaking is whether the work is remunerative or the reverse and it is therefore essential for this class of works to maintain a Capital account, since it is only by reference to the amount of capital expended that the value of the results obtained can be determined.

46. The works for which Capital accounts are kept are first divided to show (A) Irrigation and (B) Navigation, Embankment and Drainage Works, separately, each of which is again sub-divided into (1) Productive and (2) Unproductive Works.

47. The initial expenditure on the construction of an irrigation project for which Capital account is kept is charged to the Capital account of that project and such further expenditure after its completion as is necessary for the full development of the scheme is also added to that account.

48. The capital invested on the work includes (1) direct charges, *i.e.*, cost of works, Establishment and Tools and Plant, (2) indirect charges, *i.e.*, capitalised value of abatement of land revenue occupied by works and leave and pension allowances of establishment and (3) all arrears of simple interest, if any, *i.e.*, balance of total interest over total net revenue. This capital cost is commonly known as "sum at charge".

49. As soon as the work commences to earn revenue a Revenue account is opened for it. The revenue derived from the work is credited to that account and annual maintenance charges are debited to it. The difference between the gross revenue earned and the maintenance charges is the net revenue on the work.

50. Turning to the sub-divisions Productive and Unproductive works it may be observed that if the net revenue from a Capital work is expected to repay after 10 years from its completion the annual interest charges on the capital invested, *i.e.*, sum at charge at 6 per cent. or at such other rate as may be fixed by Government from time to time, the work is considered as "Productive" otherwise it is treated as "Unproductive". If any work for which a Capital account is kept and which is classed as productive fails at any time after the expiry of 10 years from its completion in three successive years to yield the relevant return, it is transferred to the Unproductive class. Similarly if a work though classed as unproductive succeeds in yielding for three successive years the relevant return prescribed for a productive work it is transferred to the productive class.

The same principle would apply to all extensions and improvements of an existing work.

51. The capital expenditure on irrigation works is booked in the accounts under one major head, *viz.*, "55, Construction of Irrigation, Navigation, Embankment and Drainage Works." Funds for these works may be provided from ordinary revenues, Famine Insurance Grants or from other sources outside the revenue of which the most important is loans, but the expenditure is booked under one major head "55" only. This major head is however intended to include only expenditure incurred from sources outside the revenue and it is therefore necessary to deduct from this head the capital expenditure defrayed from general revenues and to show it in the revenue section of the accounts. There will thus be two deductions in lump sums at the foot of the account of the

major head "55" and the amounts thus deducted from this head are booked, without details of works, under the major head "16-A Financed from Famine Insurance Grants" and "B—Financed from ordinary Revenues" according to the source from which funds are provided. The head "16" is therefore purely a transfer head. The net total of the major head "55" after the deductions above referred to have been made, represents that portion of the capital expenditure on irrigation works which is financed from sources outside the ordinary revenues. In this budget all the expenditure is to be met from loan.

52. The revenue derived from irrigation works for which capital accounts are kept and the annual expenditure on maintenance and working expenses on those works are respectively credited and debited to the revenue account of those works under a separate Revenue head "XIII-Irrigation, Navigation, Embankment and Drainage works for which Capital Accounts are kept", the divisions and sub-divisions of this account also being the same as those under the corresponding capital expenditure head "55" mentioned above.

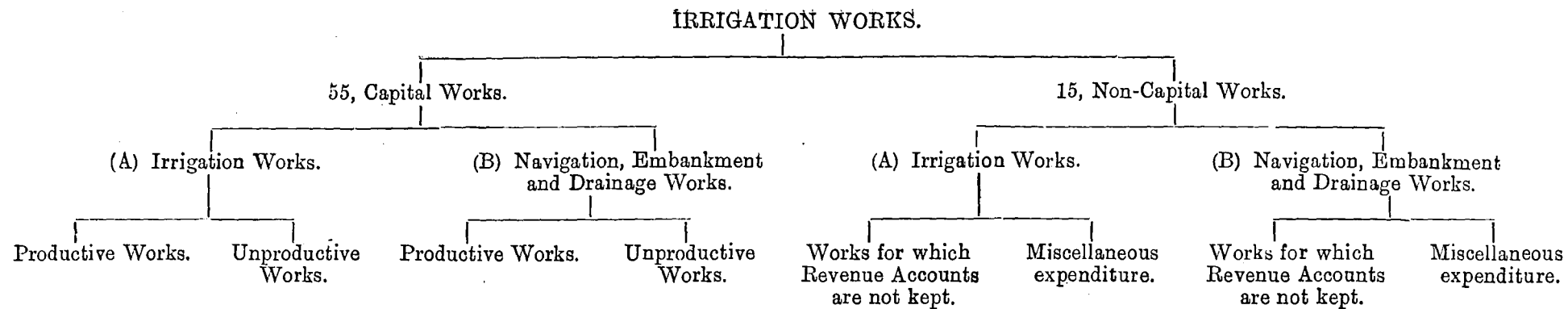
53. In the Budget Estimates of Revenue for Irrigation Works under the above mentioned head "XIII", the working expenses and maintenance charges of capital works are shown by a *minus* entry under *gross* revenue in order to show the estimated *NET* revenue, as the essential matter financially is the *net*, and not gross, revenue. Although these working expenses are shown under the receipt head, they are, of course, treated in all other respects as ordinary expenditure; they are subject to the same rules and conditions and, as in the case of other outlay, are included in the demand for grants.

54. There is one more *minus* entry to be made in the Budget Estimates of Revenue under the head "XIII" before the *net* revenue is shown and that is the "Refunds of Revenue". In the demands for grants, however, and for all purposes of sanction these refunds must still be treated as expenditure in order that the necessary sources and authority for their payment may be obtained.

55. The interest on capital expenditure is met from ordinary revenues and is shown under the head "14 Interest on works for which Capital Accounts are kept."

56. With reference to the second division of irrigation works, *viz.*, works for which *capital accounts are not kept* it may be observed that this division includes a very large number of works which, while collectively of great importance, are individually too small to make it worth while to maintain separate accounts for each. All expenditure upon such works whether upon the construction of new works or upon the extensions or improvements, maintenance or repairs of existing works—is accounted for under one major head "15—Other Revenue Expenditure." Since the works under this class are on a non-commercial basis and no capital accounts are kept for them there is no object in treating maintenance charges as a *minus* entry under revenue from these works as in the case of *quasi* commercial works, and therefore they are shown under the expenditure head "15". The only comparison here possible is that between the gross revenue (shown under Revenue head XIV) and the total expenditure of all kinds. In this division is also booked, under a separate sub-head, "Miscellaneous Expenditure" all expenditure upon the preliminary surveys of new projects and also the cost of famine surveys required for the preparation of the Famine programme. (The works in this division are financed from ordinary revenues of the year. Those works which have a protective aspect as well as surveys for the preparation of famine programmes may be financed from the Famine Insurance Grants.) The whole of the expenditure on all works under this class is, however, to be booked in the first instance under one major head "15" mentioned above without reference to the source from which the funds are provided and it is necessary therefore, as in the case of the major head "55" for capital works, to deduct at the foot of the account of the major head "15" a lump sum showing the amount financed from the Famine Insurance Grants, the residue representing the amount financed from ordinary revenues. The amount deducted from this head is booked without details under a separate major head "15 (1) Other

Revenue Expenditure financed from Famine Insurance Grants" which is merely a transfer head. The revenue earned by this class of works is shown under the Revenue Head "XIV—Irrigation, Navigation, Embankment and Drainage Works for which no Capital Accounts are kept" and the refunds of revenue are deducted from the gross receipts in order to show the net revenue for the works. In preparing the Budget Estimate for this class of works, the refund of revenue, though shown under revenue by a *minus* entry, is included in the statement of demand for grants as is done in the case of the refunds of revenue on Capital Works.



*Definitions—1. "Capital Works" are works for which capital and revenue accounts are kept on a quasi commercial basis. The capital expenditure is accounted for under the head "55", and funds for the works are provided from three sources (1) Ordinary Revenue, (2) Famine Insurance Grants and (3) Loans or accumulated Surplus revenue. Revenue realised from them is credited to the head "XIII."*

*2. "Non-Capital Works" are works for which individually neither capital nor revenue accounts are kept either because they produce little or no revenue or owing to their restricted size. The expenditure on these is accounted for under the head "15". Any revenue realised from them is credited to the head "XIV".*

XIII.—Irrigation, Navigation, Embankment and Drainage Works for which Capital Accounts are kept.

*Revenue.*

57. The revenue from irrigation works includes (a) direct receipts from sales of water, plantations and other canal produce, etc., and (b) the portion of land revenue due to irrigation in respect of productive and unproductive works.

The Note at paragraphs 45—56 explains the system of accounts under this head.

58. The budget and revised estimates of revenue for the current year and the budget estimate for the ensuing year are as shown below :—

59. The increase in gross revenue of 18,91 in the revised as compared with the budget estimate for 1923-24 is due to the transfer of a large number of canals from the head "15—Other Revenue Expenditure financed from Ordinary Revenue" to the head "55—Construction of Irrigation, Navigation, Embankment and Drainage Works" and the consequent credit of the revenue derived from these canals to the head XIII. The increase of 4,46 in "Working Expenses" is due to additional charges on account of establishment and tools and plant charges.

60. The increase in gross revenue of 17,57 in the budget estimate for 1924-25 as compared with that for 1923-24 is due to (a) the transfer of certain canals from the head "15—Other Revenue Expenditure financed from Ordinary Revenues" to the head "55—Construction of Irrigation, Navigation, Embankment and Drainage Works" and the consequent credit of their portion of land revenue to the head "XIII", (b) extended cultivation under the main canals in the Deccan and (c) sale proceeds of lac on the Jamrao canal.

61. The increase of 13,13 in Working Expenses is due to larger provision having been made for works and repairs on account of transfer of a large number of canals from the head "15" to the head "5." and the consequent debit of the "Working Expenses" of these canals to the head "XIII".



**XIV, Irrigation, Navigation, Embankment and Drainage Works for which no Capital Accounts are kept.**

*Revenue.*

62. The revenue under this head for works for which no capital accounts are kept include only receipts from sales of water, plantations and other canal produce, etc., and no credit is afforded to this class of works on account of the portion of land revenue due to irrigation.

The budget and revised estimates for 1923-24 and the budget estimate for 1924-25 are as shown below:—

63. The decrease of 40 in the revised estimate as compared with the budget estimate for 1923-24 is due to the transfer of a number of canals in Sind from the head "15—Other Revenue Expenditure financed from Ordinary Revenue" to the head "55—Construction of Irrigation Works". Consequently the revenue formerly credited to the head "XIV" is now shown under the head "XIII". The decrease of 50 in the budget estimate for 1924-25 as compared with the budget estimate for 1923-24 is also due to the same cause.

64. Under Rule 24 of the Devolution Rules the capital sum spent by the Governor-General in Council upon the construction of productive and unproductive irrigation works and of other works financed from loan funds is to be treated as an advance made to the local Government from the revenues of India. This advance is to carry interest at the rate of 3·3252 per cent. per annum in the case of outlay incurred up to the end of 1916-17 and at the rate of 5·48 per cent. per annum in the case of outlay incurred from 1917-18 to 1920-21. The amount of this interest comes to 32,44 and this amount is included separately under the head 19, *Interest* as interest on the advance in respect of Irrigation Capital expenditure. Since 1921-22 the capital expenditure on Irrigation is being met from the loans for general purposes and the amount of interest payable on these loans is also shown separately under the head 19, *Interest*. The head 14, *Interest* is merely a *pro forma* head to show the interest liabilities on Irrigation expenditure and credit of the amount shown as expenditure under this head is taken by deducting the same amount from the expenditure shown under the head 19, *Interest*. The actual provision made in the budget for Interest on account of Irrigation Schemes amounts to 51,99 as shown below :—

## Revenue.

72. The ordinary revenue represents the interest received by the Local Government on advances and loans from the Provincial Loan Account. This account, the capital transactions of which are outside the ordinary budget figures, provides for the grant of loans to agriculturists, local bodies, Indian States, etc. The present rate of interest is generally  $3\frac{1}{2}$  per cent. but is less in certain special cases. Interest on arrears of revenue is also credited to this head.

73. The increase in the revised estimates in (1) for current year as compared with the budget estimate for the current year is mainly under "Interest on advances to cultivators" and has been partially counterbalanced by the decrease under the sub-head "Interest on loans to Indian States" on



account of the closing of the loan account of Idar State. The decrease in the next year's estimate as compared with the current year's is partly due to the decrease in outstanding advances and partly to the estimates of recoveries of interest on advances to cultivators being low in view of the unfavourable condition of the last season.

74. *Refunds.*—The increase in the current year's revised and next year's budget estimate as compared with the current year's budget is due to the refund of income tax allowed to the Presidency Corporations in connection with interest on loans advanced out of Development Funds.

75. The other items of the Bombay Development Department shown under this head are discussed in the accompanying memorandum.

#### *Expenditure.*

76. In accordance with the change in classification of accounts interest on Provincial loans and interest payable to Central Government (a) on advances on account of Provincial loan accounts, and on advances in respect of Irrigation capital expenditure under Nos. 23 and 24 of the Devolution Rules respectively and (b) on other advances, is to be debited to "19, Interest on Ordinary Debt." Charges on account of management of Debt and other miscellaneous charges are also debited to this head. Credit is given to this head under the division "Deduct—Interest transferred to Commercial Departments" for the amount shown as expenditure under the head "14, Interest on works for which capital accounts are kept".

77. The expenditure of the Bombay Development Department shown under this head is explained in the accompanying memorandum.

78. *Interest payable to Central Government on advances on account of Provincial Loan Account.*—The decrease in the next year's estimate as compared with the current year's budget is due to the balance of the Provincial Loan Account being reduced. The rate of interest charged to the Local Government is 4.78155.

79. *Interest on advances in respect of Irrigation capital expenditure.*—The interest is calculated at the rate of 3.3252 on the capital outlay of 7,62,51 and at 5.48 on 1,28,09.

80. *Interest on other advances.*—Interest to be paid to the Government of India on the advances made and to be made by them for Development and other purposes is debited to this minor head. The figures for ordinary purposes are as follows :—

The rate of interest on the advances drawn up to the end of 1922-23 is  $6\frac{1}{2}$  per cent. and on the advances drawn and to be drawn with effect from 1923-24 is 6 per cent. The decrease in the revised estimate as compared with the current year's budget is due to the fact that the former provides interest at 6 per cent. for six months on the advance of 1,56,71 which is the revised estimate of advance to be obtained from Government of India whereas the latter provides interest at  $6\frac{1}{2}$  per cent. on the amount of advance then estimated. The next year's budget contains interest for 12 months on the advance of 1,56,71 to be taken this year and for six months on the proposed advance of 4,89,95.

81. *Deduct—Interest transferred to Commercial Departments.*—The figures are explained under “14, Interest on works for which capital accounts are kept”.

82. *Deduct—Interest met from Famine Insurance Fund.*—The figure is explained under “43-A,” Famine Relief.”

83. A provision of 9,39 equal to one per cent. of the loan of 9,38,91 raised in 1920-21 in connection with the Development of Bombay has been made in the current year's budget to form a depreciation fund. This has been repeated in next year's budget.

84. In the Introductory note it has been explained that it has been decided to maintain a regular Sinking Fund for the amortisation of the unproductive portion of the advances obtained from the Government of India for ordinary purposes. The provision of 7,68 made in the next year's budget represents the contribution for the current and next year necessary for a Sinking Fund improving at approximately 4 per cent. interest for 15 years. As the actual classification of unproductive works into 15 years' or 30 years' category was not ready at the time of the preparation of the budget, the contribution has been calculated on a 15 years' basis. Before actual investment is made, the amount will be re-calculated on a 15 or 30 years' basis according to the class of work.

85. *Staff and Household of the Governor.*—The decrease in the revised estimate of 1923-24 is mainly due to (i) transfer of the provision of 25 on account of Presents and Charities by His Excellency the Governor to the head "F—Discretionary Grants by Heads of Provinces", (ii) non-utilisation of the provision of Rs. 37,760 for furniture for new buildings at Government Houses, and (iii) savings anticipated under different units of appropriation under this head especially in the provision for Inauguration Grant for Furniture and Carpets. The decrease in the budget of 1924-25 as compared with the budget of the current year is chiefly due to the provision of 25 for Presents and Charities having been made under a different head and to a reduction in the provision for Inauguration Grant for Furniture and Carpets. As an expenditure of Rs. 30,000 is expected to be incurred during the current year from this Grant, the balance of Rs. 60,070 has again been provided in next year's budget.

86. *Tour Expenses.*—The increase in the revised as compared with the current year's budget is due to additional grants sanctioned during the current year under this head to meet extra tour expenses and expenditure for special trains for His Excellency the Governor.

87. *Legislative Council.*—The decrease in the revised of 1923-24 as compared with the budget of the same year is mainly due to savings anticipated from the special provision of 1,50 for current year for Preparation of Electoral Rolls and Expenses of General Elections. The decrease in next year's budget as compared with that of the current year is due to a provision of only 20 having been made for expenditure in 1924-25 on account of Electoral Rolls.

88. *Civil Secretariat.*—The decrease in the revised of the current year is due to savings anticipated in almost all offices in the Civil Secretariat in (i) provisions for pay of officers and establishments due to leave vacancies having not been filled up or to appointment of junior officers in place of seniors on leave, and (ii) provisions for allowances and contingencies. The increase in the budget of 1924-25 as compared with the budget of the current year is due to (i) provision for grant of normal annual increments of time-scale of pay to gazetted and non-gazetted staff in all Departments of the Secretariat, (ii) provision for the posts of an Additional Deputy Secretary, an Additional Assistant Secretary and a small extra establishment in the Finance Department, which have been sanctioned to cope with increase of work in the Department.

89. *Local Fund Audit Department.*—The estimates under this head are now under the control of the Government of India and are entered under the Central head "23, Audit". The provisions entered in the current year's revised and next year's budget represent the share of the cost of the Department to be paid to the Central by the Provincial Government.

90. *Settlement Commissioner and Director of Land Records.*—The decrease in the revised for the current year and budget for next year is mainly due to the excess provision for establishment during the current year. The decrease in the next year's estimate is also partly due to the transfer of provision for office expenses and miscellaneous to the head "5, Land Revenue".

91. *Commissioner in Sind and Commissioners of Divisions.*—The increase in the next year's budget over the current year's sanctioned estimate is due mainly to (i) the adjustment of charges on account of pay and allowances of Head Clerks who are graded with Mamlatdars and Mukhtiarkars, (ii) increase in charges for travelling allowance owing to the removal of restrictions on touring, and (iii) new provisions for the purchase of furniture and camp equipment.

92. *Charges of District Administration.*—The decrease in the revised estimates over the current year's sanctioned budget is mainly due to the fixed amounts to be transferred from this head to other major heads at the end of the year having been lately revised. The original amounts were based on pre-war costs, and the revised amounts have been fixed after taking into consideration increases in cost of establishment due to revisions of pay. Until

settlement of the revised fixed amounts, no sum was transferred to the head "5, Land Revenue", but now an amount of 18,78 has been provisionally fixed for transfer to that head. The increase in the next year's budget over the current year's budget is due to (1) the transfer to this head from "5, Land Revenue," and "26, Police" of all charges on account of pay and allowances of district and village officers and village police, (2) the increase in the salaries of gazetted and non-gazetted officers who are on incremental rates of pay, (3) the increase in travelling allowance owing to the removal of restrictions on touring, (4) the grant of compensatory allowance to officers serving in expensive localities, and (5) new provisions for (a) opening of the new treasury at Nawabshah (b) grant of bad climate allowance to the clerks in unhealthy localities and (c) revision of remuneration of village officers and servants. The increase is partly counterbalanced by (a) reductions made in leave allowances to gazetted and non-gazetted establishments and (b) transfer of fixed amounts on account of establishment charges from this to several other major heads. The sanctioned cadre of the Indian Civil Service officers is inclusive of leave reserve, and as provision for leave allowances payable in England has also been made under the head "Expenditure in England under the control of the High Commissioner," a lump deduction of 3,12 has been made from the provision for salaries for the Indian Civil Service officers.

93. *Discretionary Grants.*—The increase in the revised estimate of the current year and the budget estimate of next year is due to transfer of the provision of 25 for Presents and Charities by His Excellency the Governor to this head.

94. *Expenditure in England.*—The increase in the revised as compared with the budget of 1923-1924 is based on the latest estimates furnished by the Secretary of State and the High Commissioner for India. The increase is mainly due to (1) extra expenditure of 12 voted (£1,150) and 40 non-voted (£4,000) under the High Commissioner for leave allowances in England, (2) debit to the Local Government of 42 voted (£4,200) on account of the share in the charges of the High Commissioner's establishments, (3) grant of 20 (£2,000) to His Excellency the Governor for out-fit and passage allowance, the amount of which is fixed by the Secretary of State under section 85 (1) of the Government of India Act, 1919, (4) grant of 30 (£2,956) to His Excellency the Governor for purchase of motor cars under orders laid down by the Secretary of State, and (5) non-voted excess expenditure of 5 (£500) under the Secretary of State on account of sundry items. The increase in next year's budget as compared with the current year's budget is chiefly due to the inclusion of 46 (£4,600) on account of Local Government's share in the charges of the High Commissioner's establishments.

95. *Exchange.*—The variations under this minor head follow those under the foregoing head.

*Revenue.*

96. The principal source of revenue is general fees, fines and forfeitures. The decrease in the revised estimates as compared with the sanctioned estimates is due to crediting the process fees received in the shape of stamps to "VII Stamps" and not to this Major head. The increase in the estimates for next year over the sanctioned estimates and the revised estimates is chiefly due to the

opening of new Courts which may be expected to bring in larger revenues and also to larger receipts on account of "Sheriff's fees", and on account of increase of fines levied in cases of convictions obtained through the intervention of the Agents of the Society for the Prevention of Cruelty to Animals, Bombay.

*Expenditure.*

97. *High Court.*—The decrease in the revised estimates as compared with the sanctioned estimates is mainly due to charges for contingencies being paid out of Suitors' Fee Fund Interest Account and the temporary appointment of 9th High Court Judge not being created from the beginning of the year. The increase in the next year's estimates over the sanctioned estimates and the revised estimates is due to provision for a temporary appointment of 10th High Court Judge.

98. *Law Officers.*—The estimates for the next year though in excess of the current year's sanctioned estimates have in no case been allowed to exceed the past actuals.

99. *Administrator General and Official Trustee.*—The excess over the sanctioned and revised estimates for the current year is due to provision for rent of office of the Administrator General and Official Trustee, Bombay.

100. *Judicial Commissioners.*—The estimates for next year exceed the current year's sanctioned and revised estimates, as the former include full provision for the appointment of 4th Additional Judicial Commissioner of Sind and his establishment.

101. *Civil and Sessions Courts.*—The decrease in the revised estimates, as compared with the sanctioned estimates, is chiefly due to savings in (1) the lump provision of 2,16 for revision of establishment, (2) grant for "Officers" under Sub-Judges and (3) Contingencies, partially counterbalanced by increased expenditure against "Pay of Officers" under "District and Sessions Judges". The excess in next year's estimates over the current year's sanctioned estimates is due to provision for 4 new District Courts to be created at Alibag, Jalgaon, Nadiad and Nawabshah, and also due to the provision for purchase of copies of all series (except the Bombay Series) of the Indian Law Reports for supply to District Judges and other officers.

102. *Courts of Small Causes.*—The decrease in the revised estimates is due to reduced expenditure under "Contingencies". Estimates for the next year exceed the sanctioned and revised estimates due to provision for temporary appointment of an extra Judge in the Bombay Small Cause Court.

103. *Criminal Courts.*—The decrease in the revised estimates and the estimates for the next year as compared with the sanctioned estimates is mainly due to the abolition of certain posts of Resident and City Magistrates and reduced expenditure under "Contingencies".

104. The decrease in the revised estimate under head (2) occurs under "sale proceeds of jail manufactures".

105. The increase in the next year's estimate under head (1) over the current year's budget is due to higher receipts under "Hire of convicts". The decrease under head (2) is due to the transfer of receipts on account of quinine to the "Public Health" budget.

*Expenditure.*

106. The decrease in the revised estimate under head (1) is due mainly to the reduction in the expenditure under "Dietary" and other contingent charges and the postponement of the starting of the new Central Jail at Hindalgi, counter-balanced by the transfer of 35 from "41—Civil Works" on account of minor jail works. The decrease under head (2) is due to less expenditure on account of quinine.

107. The increase in the next year's estimate under head (1) over the current year's budget is due to an increased provision of over a lakh on account of the extensions of the Criminal Tribes Settlement, the annual increments in the pay of officers and the transfer of the provision of 40 for "Minor Works" from the Public Works Department budget. The decrease under head (2) is due to the transfer of the provision for quinine to the "Public Health" budget.

*Revenue.*

108. The increase in the revised for 1923-24 as compared with the budget for the same year is chiefly due to recoveries of contributions from Railways on account of the cost of Railway Police, which have been shown under a new minor head "Contribution for Railway Police" opened under this major head.

109. The increase in the budget estimate for the year 1924-25 as compared with the budget estimate of the current year is chiefly due to the provision of 2,42 made under this head on account of recoveries of contributions for the cost of Railway Police from the Railway Companies concerned. In the current

year's budget the estimate of such contributions was entered under "XL—Miscellaneous adjustments between the Central and Provincial Governments".

*Expenditure.*

110. *Presidency Police.*—The decrease in the revised for 1923-24 as compared with the budget for the same year is due to less expenditure under "Pay of Establishment" due to vacancies in the police force and under "Rents, Rates and Taxes" due to the non-payment of rent payable to the Bombay Improvement Trust on account of certain police accommodation schemes which were not completed by the Trust before the 15th September 1923. The decrease is partially counterbalanced by extra expenditure due to the creation of

- (1) two additional posts of Prosecuting Inspectors,
- (2) 11 posts of Sergeants to form a leave reserve, and
- (3) 3 posts of Deputy Inspectors and 6 of Sub-Inspectors for augmenting the Investigating Staff at the police stations.

The increase in the budget for 1924-25 as compared with the budget for 1923-24 is due to the provisions made for the new appointments mentioned above, and to the new provisions made for the following items:—

- (1) Purchase of remounts, etc., owing to the discontinuance of the system of purchasing horses from the Mounted Police Fund in the Bombay City, which is to be closed from 1st April 1924;
- (2) Increased provision for clothing charges to the Bombay City Police in accordance with the revised rates of clothing grants approved by Government;
- (3) Entertainment of an establishment for police notice and enquiry office in Bombay City;
- (4) Establishment for a second cattle pound to be constructed at the junction of Victoria Garden and Clark Road in Bombay City.

The increase is, however, partially counterbalanced by a lump deduction of Rs. 1,00,000 made under this head on account of probable savings.

111. *Superintendence.*—The decrease in the revised estimate of 1923-24 as compared with the budget for the same year is mainly due to less expenditure under the unit "Allowances, Honoraria, etc."

112. *District Executive Force.*—The decrease in the revised for 1923-24 as compared with the budget for the same year is chiefly due to less expenditure under (1) "Pay of officers" and "Pay of establishments" due to vacancies, and (2) Travelling allowance, cost of Railway warrants and hutting money. The increase in the budget for 1924-25 as compared with the budget for 1923-24 is due to additional provision made for the following items:—

- (1) Increased provision for clothing charges in accordance with the revised rates of clothing grants to District Police approved by Government;
- (2) Grant of conveyance allowance to Headquarters Deputy Superintendents of Police and Inspectors in charge of offices of Superintendents of Police in the Presidency;
- (3) Entertainment of 2 additional Sergeants at Ahmedabad;
- (4) Restoration of Mounted Police in the Poona and the East Khandesh districts;
- (5) Opening of 6 more primary schools for the children of the policemen at the Headquarters Police lines in the Presidency proper;
- (6) Revision of the pay of Prosecuting Staff in the Presidency including Sind;
- (7) Grant of duty allowances to writer head-constables and constables in the Presidency including Sind;
- (8) Entertainment of armed police escorts on running trains;

- (9) Increased provision under petty construction and purchase of land for extending rifle ranges and enlarging butts owing to introduction of new rifles of long range ;
- (10) Entertainment of additional police force at Borsad in the Kaira District.

The increase is partially counterbalanced by a lump deduction of 1,25 made on account of anticipated savings owing to separate provision for leave allowances to police officers made in the High Commissioner's budget estimate of Expenditure in England.

113. *Village Police.*—The decrease in the budget for 1924-25 as compared with the budget for 1923-24 is due to the transfer of the provision of 8,59 from "26-Police" to "22-General Administration" as decided by the Auditor General, as the village police partly perform revenue work and partly police work. The provision of Rs. 72,000 is however retained under this head for the pagis and village trackers in Sind who assist police in the detection of crimes and do not form part of the regular village police.

114. *Railway Police.*—The decrease in the revised for 1923-24 as compared with the budget for the same year is chiefly due to less expenditure under (1) pay of establishment due to vacancies and (2) travelling allowance. The increase in the budget for 1924-25 as compared with the budget for 1923-24 is due to the provision of a new item of 1,05 made for the entertainment of additional establishment for detective work, training courses, and night passengers guards on the Railways in the Presidency proper and Sind.

115. *Criminal Investigation Department.*—The decrease in the revised for 1923-24 as compared with the budget for the same year is mainly due to less expenditure under travelling allowance. The increase in the budget for 1924-25 as compared with the budget for 1923-24 is due to increased provisions made under "Pay of officers" and "Establishments" owing to increments due to them, and to the entertainment of additional clerks in the office of the Deputy Inspector General of Police, C. I. D.

116. *General remarks.*—The provisions under exchange and expenditure in England have been made on the basis of the latest estimates of the High Commissioner for India and the Secretary of State.

117. No provision has been entered under this head as receipts in respect of fees under the Native Passenger Ships Act, etc., will be credited to Central from the year 1923-24.

*Expenditure.*

118. Under the Reforms, ports, except such as may be declared to be major ports, and inland waterways, including shipping and navigation thereon, so far as they are not declared to be Central subjects, are Provincial subjects. The other subjects are Central.

119. The first two minor heads relate to charges in connection with the steamer *Jhelum* and the flat *Multan* which are used by the Commissioner in Sind for touring purposes.

120. Under the Reforms, the receipts in connection with the survey of inland vessels only and the cost of establishment thereof are to be treated as Provincial, while those connected with ocean-going vessels are to be treated as Central. Accordingly the expenditure in connection with the Marine Survey Department is treated on the whole as Central, 7 per cent. of the net cost being treated as Provincial. A provision of 4 on this account is made in the estimate under the third minor head.

121. The fourth minor head provides for the boat establishment of the Collector of Kolaba.

122. Absence of provision for the construction of a sea wall at Gogho under the fifth minor head accounts for the decrease in the total major head figure in the next year's budget estimate.

123. *Provincial Museums.*—Government have promised an annual grant of 30 towards the maintenance of the Prince of Wales Museum, Bombay. The Museum also receives an annual contribution of 25 from the Bombay Municipality. This contribution is in effect a grant from Government as it was taken as a set-off against the Municipality's share of the City Police charges which were taken over by Government in 1907. The increase in item (1) is due to the provision (20) on account of the Natural History section which was hitherto made under item (2).

## Revenue.

124. The decrease in the current year's revised as compared with the current year's budget is due to smaller fee receipts in Professional Colleges and Secondary and Primary Schools, partially counterbalanced by larger fee receipts in Arts Colleges and the inclusion of 25 for recovery of service payments.

125. *University*.—The slight decrease of 8 next year as compared with the current year is due to the reduced fee receipts anticipated in the Royal Institute of Science and the Karnatak College, Dharwar, counterbalanced by increase in other colleges.

126. *Secondary*.—The decrease of 12 in next year's estimate as compared with the current year's figure is due mainly to the closing of the additional classes temporarily opened in the Dharwar High School owing to one of the aided schools at Dharwar having non-cooperated.

127. *Primary*.—The decrease of 20 next year under this head is due to the correction of an error in the accounts under which receipts in *secondary* schools and the *English* classes attached to primary schools were in some places credited to the head "Primary" instead of "Secondary".

128. *General*.—The following receipts are credited to this head:—

*Expenditure.*

129. The main alterations in the revised estimates as compared with the current year's budget are :— (1) Decrease of 25 under " Grants to Universities " on account of the non-eligibility of the Bombay University to the compensation for the amalgamation of the Matriculation and School Final Examinations, (2) an increase of 4,00 for maintenance grants to non-Government secondary schools (*vide* remarks in paragraph 132 below), (3) an increase of 2,00 for building grants to non-Government Primary Schools, (4) an anticipated saving of 6,00 in " Grants to local bodies " under the head " Primary " (owing to the arrangements contemplated in the Primary Education Act, 1923, having not yet been given effect to) after allowing for an increase of 7,00 on account of the proposed revision of pay of primary school teachers, (5) an increase of 2,80 under " Special " owing to the transfer to this head of an advance to the V. J. Technical Institute, Bombay, from the provision under " Loans and advances by Provincial Government for other purposes," and (6) a saving of 1,00 under " Special " owing to retrenchments in training schools.

130. The budget estimates for next year have been entered at 1,92,27 against 1,89,84 of the current year. The former figure includes only 4,50 for carrying out the scheme of the Compulsory Primary Education Committee and the Primary Education Act against 16,00 for the same purpose included in the current year's figure of 1,89,84. The reduction of (16,00 - 4,50 =) 11,50 had perforce to be made owing to the continued financial stringency and the absolute necessity of making the requisite provision for (1) restoration of grants to secondary schools (4,00) and (2) revision of pay of primary school teachers (7,00). A few new items of an essential nature have also been included, this being made possible owing to the steps taken in the last and current years to retrench sanctioned charges.

131. *University.*—The following are the most important changes effected under this head :—

132. *Secondary.*—In view of the resolution recommending the restoration of grants to secondary schools passed by the Legislative Council in July 1923 Government decided to restore all grants to secondary schools as before in the *current year* by reappropriation. An extra provision of Rs. 4 lakhs has accordingly been entered in next year's budget on this account. Among the new items of expenditure provided for next year are the following :— (1) the establishment of a Provident Fund for teachers in European schools (25); (2) grant-in-aid to the Bombay Boy Scouts Association (15); and (3) conversion of the District Local Board Madressah at Naushahro into a Government High School (1). The balance (45) of the increase (4,86) under this head is due mainly to increments resulting from revision of pay and the transfer to this head from the head ' Primary ' of the provision (now reduced) for English classes to Primary schools (13).

133. *Primary.*—The next year's estimates under this head show a decrease of 4,60. This is chiefly due to a reduction of 11,50 in the current year's provision of 16,00 for carrying out the scheme of the Compulsory Primary Education Committee counterbalanced by the provision of 7,00 on account of the revision of pay of primary school teachers which is being sanctioned in the current year. The provision of Rs. 5,000 for supply of books, etc., to Mulla Schools in Sind has been transferred to this head from the head ' General ' owing to the abolition of the Sind Book Depôt, and an additional provision of 2 for the education of criminal tribes, including provision for a school in the new settlement at Ambernath, has also been entered.

134. *Special.*—The retrenchments under this head are chiefly (1) further reduction in the provision for scholarships in training institutions owing to the revision of the numbers to be admitted to the various classes in these institutions including the abolition of the third year course (52); (2) closing of the three primary training schools in the Northern Division (15); and (3) reductions in the expenditure on account of pay and allowances of staff and contingencies in connection with primary training institutions (5).



135. *General.*—This head comprises the minor heads, (a) Direction, (b) Inspection, (c) Scholarships and (d) Miscellaneous. The estimates for next year include provision for the following new items :—

(i) Scheme for special scholarship for Intermediate and Backward classes and Mahomedans (1,00).

(ii) Revision of the rates of fees to examiners, etc., for work in connection with the Vernacular Final Examination (9).

(iii) Institution of a separate Vernacular Final Examination for girls (2).

The lump deductions made in the current year on account of (1) the probable reduction in the Departmental inspecting clerical and menial staff owing to the contemplated transfer to the Local Boards of the management of local board schools under the Primary Education Act, 1923 (71) and (2) the probable savings on account of the pay of Indian Educational Service officers likely to be on leave in England (19) have not been repeated. On the other hand increased provision has been made mainly under pay and allowances of officers and establishments owing to increments due under the revised scales.

*Revenue.*

136. The decrease in the revised estimate as compared with the budget of the current year is mainly due to larger refunds as well as some small decreases under "Mental Hospital Receipts" and "Contributions". Owing to the abolition of the class for the Preliminary Scientific Course and the restriction of admissions of students to the Grant Medical College, the receipts under "Medical Schools and College Fees" are expected to be lower next year than the current year. The revenue under "Hospital Receipts" next year is based on the information supplied by the Medical Officers in charge of Medical institutions. The increase in the next year's estimate under this head over that of the current year is due to increased accommodation provided for at certain hospitals in the Presidency and the consequent increase in the number of paying patients.

*Expenditure.*

137. *Medical Establishment.*—The decrease in the revised estimate of the current year is due to decrease in expenditure on account of vacancies in the sanctioned cadre of Medical Officers and establishments. The decrease in the estimates for 1924-25 under this head is mainly due to decrease in expenditure on account of pay and allowances of officers owing to leave and other vacancies

in the cadres of the Medical Services. Several senior officers are expected to go on leave or retire and their places will be filled by junior officers.

138. *Hospitals and Dispensaries.*—The rise in the revised estimate of the current year is mainly due to additional expenditure on account of the proposed building grant of Rs. 2 lakhs to the Municipal Corporation, Bombay, for the King Edward Memorial Hospital and additional expenditure (24) on account of the arrangements made at the G. T. Hospital for practical instruction to students of the Grant Medical College. This additional expenditure is partly covered by savings from grants under "Medical Establishments" as well as Hospitals and Dispensaries. The increase of expenditure during 1924-25 under this head as compared with the budget estimate of the current year is largely due to additional expenditure on account of (i) the expansion of the G. T. Hospital in order to provide clinical material for practical instruction to students of the Grant Medical College (74), (ii) payment of arrears of increments to certain officers of the Subordinate Medical Service (13), (iii) increased grants-in-aid for nursing at certain hospitals (about 29), (iv) additional grants to the Civil Hospital at Sholapur on account of an increase in the accommodation by 71 new beds (15) and (v) an experimental scheme for providing medical aid for small towns and villages in rural areas (10).

139. *Medical Schools and Colleges.*—The decrease in the revised estimate is due to savings in the budget provisions for pay and allowances of officers who being on leave in England, draw their leave allowances in England. The rise in next year's expenditure over the budget of the current year is chiefly due to provision (about 31) being made in the estimates for 1924-25 for the establishment, with the aid of the Imperial Research Fund, of a Pharmacological Laboratory at Bombay for the investigation of indigenous drugs and annual increments in the pay of officers and establishments.

140. *Mental Hospitals.*—The revised estimate is a little lower than the current year's budget. The decrease is due to savings under "Pay of Officers" and "Establishment". There is a small increase in the estimate for 1924-25 as compared with the current year's budget under this head on account of the entertainment of establishment, purchase of furniture and other maintenance charges required in connection with the additional accommodation to be provided at the Mental Hospital at Yeravda.

141. *Expenditure in England.*—The increase in the revised estimates for current year as compared with the budget is due to larger provision for Europe stores required for Hospitals. The increase in next year's budget is due to larger provisions for leave allowances of senior medical officers expected to proceed on leave to England and the purchase of Europe stores required for the Civil Hospital at Hyderabad.

142. Sale-proceeds of quinine, Sanitary Surveyor's Examination fees and contributions for public health purposes are credited to this head. The increase in the revised estimate as compared to budget is chiefly due to inclusion in the revised estimate of recoveries on account of Pandharpur and Karad Water Works. The increase in the budget estimate for 1924-25 as compared with the current year's budget estimate is due to a larger anticipated sale of lymph from the Belgaum Vaccine Institute and to the provision for recoveries on account of water supply from the Pandharpur Water Works.

*Expenditure.*

143. *Public Health Establishment.*—The expenditure shown under this minor head relates mainly to (i) Director of Public Health, Assistant Directors of Public Health and their establishments, (ii) Inspectors of Sanitation and Vaccination, (iii) charges for the Public Health Laboratories, Poona and Sind, and (iv) Sanitary Engineer and his staff. The decrease of 33 in the revised estimates of 1923-24 is chiefly due to savings in the provision for "Sanitary Engineer and his Staff" and under "Public Health Laboratory" for Sind. The large increase of 1,40 in the next year's budget is due to (a) the provision

159. *Examination Fees.*—The fees on account of the Accountancy Diploma Examination and the fees recovered by the Civil and Military Examination Committee are credited to this head. The increase in the next year's estimate is due to the anticipated increase in the number of students for the Accountancy Diploma Examination and the proposed opening of a new examination centre in Burma.

160. *Fees for Inspection of Steam Boilers.*—The increase in the revised estimate of the current year and the budget estimate for next year under this head is due to the raising of the scale of inspection fees.

161. *Miscellaneous.*—The receipts of the Labour Office are credited to this minor head.

## Expenditure.

162. *Inspection of Factories and Steam Boilers and Commissioner under the Workmen's Compensation Act.*—The decrease in the revised estimate for 1923-24 as compared with the budget estimate under Inspection of Factories and Steam Boilers is under pay of establishment. *Revenue.*

156. The revised estimate for the current year shows a decrease which is due to the receipts in connection with the British Empire Exhibition for the current year having been estimated at too high a rate. Out of the estimated recoveries in connection with the Exhibition a major portion is expected to be recovered next year.

*Expenditure.*

157. The decrease is due mainly to reduced provision on account of the British Empire Exhibition.

158. *Expenditure in England.*—The increase in the revised estimate as compared with current year's budget is due partly to the leave allowances of Director of Industries and partly to the transfer of the provision of 14 to the High Commissioner's estimate from the lump provision of 1,80 for British Empire Exhibition under Indian Expenditure. The next year's budget provides 20 for British Empire Exhibition and British Industries Fair.



*Item (i).—Superintendence.*—The decrease in the revised estimates for 1923-24 and the budget estimate of 1924-25 is due to excess provision in the budget estimate of 1923-24 on account of the salary of the Director of Agriculture.

*Item (ii).—Expert Staff.*—The decrease in the revised estimates for 1923-24 is due to less expenditure on account of salaries of officers gone on leave to England whose leave salary is paid from the High Commissioner's budget. The increase in the estimates for 1924-25 over those of 1923-24 is due to incremental pay of officers and establishment.

*Item (iii).—Agricultural Education.*—The decrease in the revised estimates for 1923-24 is due to the deputation of several Provincial Service Officers for cotton research work financed from funds provided by the Indian Central Cotton Committee. The increase in the estimates for 1924-25 is due to incremental pay of officers and establishments and to the provision for the Surat Agricultural School (8), for the revival of the post of Inspector of Agricultural Schools and his establishment (6), for the development of land taken up for the Agricultural College (3), and to the transfer to this head of the provision for scholarships for Sind students from the head "Expert Staff." This increase is counterbalanced to some extent by the transfer of the provision on account of Lecturers at the Agricultural College to the head "Experimental Farms."

*Item (iv).—Experimental Farms.*—The decrease in the revised estimates for 1923-24 is due to closing down of certain farms, and that in the budget for 1924-25 to curtailment of expenditure under cultivation charges (9) and upkeep of machinery, etc. (3) and to the proposed closing of some more farms (9). This is counterbalanced by the transfer of the provision for Lecturers from "Agricultural Education" to this head.

*Item (v).—Special Experiments.*—The increase in the estimate for 1924-25 is due to provision for rice breeding experiments (6), Land Development Officer and his establishment (8), organisation of hunting parties for destruction of wild pigs (5) and import of improved varieties of wheat seed in Sind (5).

*Item (vi).—Miscellaneous.*—The increase in the budget estimates for 1924-25 is due to provision for campaign against rats doing damage to rice crops in Lower Sind (5) and for subsidy to Gaorakshans at Kandivli and Mulund for improvement of cattle (12).

152. *Veterinary charges.*—The decrease in the revised estimates for 1923-24 is due mainly to savings in the grants for travelling allowance and purchase of anti-rinderpest serum and discontinuance of horse breeding operations in the Presidency proper.

153. *Co-operative Credit.*—The increase in the budget for 1924-25 is due to the incremental salaries of officers and establishment (19), the increase (7) in the grant of the subsidy to the Central Co-operative Institute, the increase (8) in the provision for travelling allowance and contingencies and provision (15) for additional establishment, counterbalanced by increased provision (12) for recoveries from Societies, the Provincial Bank and the Central Co-operative Institute.

154. *Works.*—The decrease in the revised estimates for 1923-24 and budget estimates for 1924-25 is due to the retransfer of the provision (25) for the Poona Sewage Effluent Farm from "34-Agriculture" to "41, Civil Works."

155. *Expenditure in England.*—The increase in the revised estimates for current year and the budget estimates for next year is due to larger provision for leave and deputation allowances.

148. *Agricultural Receipts.*—The Agricultural College and Schools fees and sale-proceeds of farm produce, cotton seed and implements sold by the Agricultural Department are credited to this head.

149. *Veterinary Receipts.*—These consist mainly of the Bombay Veterinary College fees.

150. *Recoveries of Service Payments.*—These are on account of cash recoveries for service rendered in previous years which were hitherto credited under the head "XXXV-C.-Miscellaneous."

145. *Pasteur Institutes.*—The revised estimate for 1923-24 is 21 against the budget estimate of 11. The increase is due to an additional grant of 10 sanctioned for anti-rabic treatment. The provision proposed in next year's estimate is 21 against current year's provision of 11. The increase is due partly to the cost of establishment required to carry out the anti-rabic treatment work at the Bombay Bacteriological Laboratory.

146. *Works.*—The increase of 1,25 in the revised estimates for 1923-24 is due to the transfer of 1,25 from the reserve under "47, Miscellaneous" for the maintenance and repairs of the Pandharpur Water Works. The increase in the next year's budget estimates over the current year's provision of 3,07 is mainly due to the provision of 50 for maintenance and repairs of the Central Pumping Station, Poona Drainage (Government share), the provision of 34 for the maintenance and repairs of the Pandharpur Water Works and the transfer of the provision of 35 for boring experiments from the grant for village water supply to this minor head, partly counterbalanced by a decrease in the cost of maintenance and repairs to Poona Water Supply.

147. *Expenditure in England.*—The increase in the revised estimates for the current year as compared to current year's budget is due to increase in leave allowances and to larger expenditure for stores.

(65) for the purchase of quinine for sale at Post Offices which was hitherto made under "25—Jails and Convict Settlements", (b) the provision (56) for the contribution (one-fourth of the total cost) of the local Government towards the expenditure for Port Health Establishment, and (c) the provision (28) for the grant of pony allowance to vaccinators at higher rates. The charges of the Belgaum Vaccine Institute are also debited to this head, but the major portion of these charges is recouped by contribution from Local Boards, Municipalities, etc. The charges on account of Vaccination Establishments employed under the Local Bodies are almost wholly recovered from them.

144. *Grants for Public Health purposes.*—The increase in the revised estimates for 1923-24 is mainly due to the transfer of 1,45 from the reserve under "47, Miscellaneous" for the payment of a grant-in-aid to the Ahmedabad Municipality towards the cost of the new engine purchased for its water works. The main items of expenditure recorded under this head are the following :—

- (a) Grants for special expenditure in connection with Public Health.
- (b) Grant-in-aid to local bodies in connection with the employment of Health Officers and Sanitary Inspectors.
- (c) Grants to Village Sanitary Committees.
- (d) Charges on account of development and town planning schemes.
- (e) Grants for Village Water Supply.
- (f) Consulting Surveyor to Government.

*Item (a).*—The current year's provision for this item is 2,77. In the ensuing year's estimates a provision of 1,85 is made. It represents grants to Municipalities for their water supply and drainage schemes to which Government have been definitely committed.

*Item (b).*—Government pay to local bodies, subject to certain conditions, grants-in-aid equal to two-thirds of the pay of Health Officers and half the pay of Sanitary Inspectors employed in Mofussil towns under the revised scheme for the appointment of Health Officers and Sanitary Inspectors to Municipalities. The current year's provision of 1,15, which represents the full cost of the scheme is repeated in next year's estimates.

*Item (c).*—Government give grants to Village Sanitary Committees in the proportion of one-fourth of their expenditure, the other three-fourths being contributed by local bodies and villages. The provision proposed for grants to the Committees for next year is less than the current year's provision of 70 by 19. The reduction is due to the fact that some of the Village Sanitary Committees have been replaced by Village Panchayats in this year. This charge is expected to fall gradually accordingly as Panchayats take the place of the Committees.

*Item (d).*—A provision of 83 made in the ensuing year's budget estimates for town planning schemes is for carrying out the schemes the execution of which cannot be postponed and for expenditure to which Government are committed.

*Item (e).*—The provision proposed in the next year's estimates is 98 against the current year's provision of 1,20. The reduction is due to the provision for boring for village water supply being transferred to the Sanitary Engineer's grant for working boring plants under minor head "Works". Government give a grant-in-aid to local boards for improvement of village water supply in the proportion of one-third of the total expenditure, the other two-thirds being contributed by the local boards and villages.

*Item (f).*—The provision for the Consulting Surveyor to Government which is shown as a separate minor head in the current year's budget is included in the minor head "Grants for Public Health purposes". The provision represents the permanent recurring cost of the Consulting Surveyor and his staff.

169. Under Schedule IV to the Devolution Rules the Government of Bombay is required to provide every year in its budget 63,60 for expenditure upon relief of, and insurance against, famine. The amount may be spent upon famine relief or upon the construction of protective irrigation works or other works for the prevention of famine. Any portion of the amount which is not so spent is to be transferred to the Famine Insurance Fund of the Province.

170. Out of the statutory provision of 63,60 for the year 1922-23 an amount of 60,81 remained unexpended at the end of the year. Recoveries of 22 on account of certain famine expenditure were made during that year, which with the unexpended balance of the grant for the year formed the closing balance of the Famine Insurance Fund for the year ending 31st March 1923. The exact amount of the closing balance on that date was Rs. 61,02,997-5-1.

171. During the current year 1923-24 an expenditure of only 6,60 is expected to be incurred on account of famine fodder and other famine relief operations. The remaining amount of 25,00 out of the provision of 31,60 will be transferred to the Famine Insurance Fund. The amount of 25,00 has accordingly been included in the revised estimates for current year under "Debt, Deposits and Advances—Famine Insurance Fund (Receipt Side)". The balance of 32,00 out of the statutory provision of 63,60 is provided during the current year under the heads "15 (1) and 16, Construction of Irrigation Works".

172. For next year a provision of 33,60 out of the statutory amount of 63,60 is made under the sub-head "43-A, Famine Relief". Out of this provision of 33,60 Rs. 10 lakhs are for payment of interest on capital outlay for the Lloyd Barrage and Canals Construction Scheme, as it has been decided to pay the interest charge up to Rs. 10 lakhs for the first 20 years from Famine grants. The remaining amount of 23,60 will be available for expenditure on Famine Relief. Out of this latter amount, 2,86 will be transferred to "8, Forest" and 60 to "34, Agriculture" on account of famine fodder operations, and 35 to "34, Agriculture" for expenditure on development of boring. The balance of 30,00 out of the statutory provision is provided under the sub-head "43-B, Transfers to Famine Insurance Fund" and has accordingly been shown in next year's estimates under "Debt, Deposits and Advances—Famine Insurance Fund (Receipt Side)".

173. *Contributions for pensions and gratuities.*—The increase in the current year's revised and the next year's budget estimate is due to the difference of contribution to be recovered on account of the revision of establishments under District Local Boards, and the increased rates of contribution of officers in Foreign Service.

174. *Commuted value of pensions.*—The increase in the current year's revised is based on the latest actuals.

*Expenditure.*

175. *Superannuation and Retired Allowances.*—The increase in the current year's revised and next year's budget is based on the latest actuals and information available.

176. *Commuted value of pensions.*—The increase in the current year's revised estimate is based on the latest actual.

177. *Expenditure in England.*—The next year's provision of 5,11 is made up of 4,10 for pensions and 1,01 for commutation contingencies and passage gratuities. The expenditure on account of pensions of officers who drew their pensions outside India was an Imperial charge before the Reforms. All such pensions sanctioned on or after the 1st April 1921, which are to be paid outside India, will be debited to the Local Governments by whom the officers were employed.

## Expenditure.

178. *Government Presses.*—The increase in the revised for the current year is due to the fact that the contract grant of the office of the Superintendent of Government Printing and Stationery was found to be insufficient and had to be supplemented.

Until the current year all printing work for officers of the Central Government stationed in the Presidency has been done at the Provincial presses. From next year onwards the major portion of the printing work of these officers will, under the orders of the Government of India, be done at the Government of India Presses and accordingly the recovery from that Government on account of the overhead cost of the Provincial presses in the Presidency will be less than in the preceding years. Also, the printing done during the year for the Government of Bombay will be greater owing to the Press being freed from the work for the Government of India. The incremental scales of pay also increase the cost of running the presses during the first few years of their introduction. This Government has also now to pay for the publications of the Government of India which up till now they were receiving free of cost. These account for the increase in next year's estimate under this head.

179. *Stationery Stores.*—The decrease under this head is due to the fact that from next year onwards officers of the Central Government stationed in this Presidency, who hitherto used to obtain their requirements of Stationery from the Provincial Stationery Stores, will obtain them from the Central Stationery Stores, Calcutta. For the same reason no deduction on account of "recovery of stationery supplied to Central Departments" is made.

180. *Expenditure in England.*—The current year's revised and next year's budget show decrease over the current year's sanctioned estimate. The increase in next year's estimate over the current year's revised is on account of provision for printing machinery required for the Government Central and Yeravda Prison presses.

181. *Recovery on account of Stationery supplied to Central Departments.*—No estimate has been entered in the current year's revised as according to an agreement arrived at with the Government of India, the amount due to the Provincial Government on this account is to be taken as a set-off against the value of the stationery stores taken over by this Government from the Government of India on 1st April 1922.

182. *Unclaimed deposits.*—The decrease in the current year's revised and next year's budget is based on the progress of actuals.

183. *Fees for Government Audits.*—It was decided to levy audit fees from certain local bodies from the year 1921-22. The current year's revised represents fees for the audit of the accounts for the years 1921-22 and 1922-23.

184. *Miscellaneous.*—The increase in the current year's revised is mainly due to the recoveries on account of compensations for damages in the Malegaon Riot.

185. *Sale of land and houses, etc.*—The decrease in the current year's revised is due to smaller receipts anticipated from the sale-proceeds of Government lands under the scheme for the development of Sholapur town. The next year's budget contains provision on account of the sale-proceeds of Government lands under the schemes for the development of the towns of Poona and Sholapur.

*Expenditure.*

186. *Rewards for proficiency in Oriental languages and allowance to Language Examination Committee.*—The provision of 16 has been transferred to "37, Miscellaneous Departments" to which major head the charges are debitable.

187. *Donations for charitable purposes.*—The increase in the current year's revised estimate is due to grants sanctioned to the League of Mercy, Home for fallen women and the Infant Welfare Society, Bombay. The next year's budget contains a provision of 70 on account of grant-in-aid to the Salvation Army on account of construction of a Rescue Home and a provision of 30 on account of rescue work in connection with the prevention of prostitution.

188. *Charges on account of Vagrants.*—The increase in the current year's revised and the next year's budget is on account of additional grants required for the deportation of foreigners especially Pathans from the Bombay City.

189. *Special Commissions of Enquiry.*—The increase in the revised estimate is due to the expenditure in connection with the Bombay Stock Exchange Committee.

190. *Contributions.*—Under Section 119 (2) of the Bombay Local Boards Act, 1923, Government will have to pay grants-in-aid equal to 2/3rds of the salaries of (1) Chief Officers or Engineers and (2) Health Officers. A provision of

Rs. 2,94,000 has been proposed on this account in next year's budget against the current year's sanctioned estimate of Rs. 2,08,000. Next year's estimate also contains an additional provision of 25 on account of subsidy to the Bombay Municipality in connection with the abolition of tolls leviable on vehicles entering the City from Salsette for which the payment is due before the close of the next financial year and also provision of 25 on account of grant-in-aid to the Viramgaon Municipality for the construction of a Municipal Hall. A provision on account of the last item was made in the budget for 1922-23 but the grant was not drawn by the Municipality.

191. *Miscellaneous unforeseen charges.*—The decrease in the current year's revised is due to the transfer of funds from the provision of 15,00 from reserve to other major heads for expenditure under those heads. During next year it is proposed to provide 20 lakhs for the Reserve. A provision of 3 lakhs is made in next year's budget for granting compensatory allowances to officers under other major heads. As the portion debit to each head has not been fully worked out a lump provision is made under this head.

The current year's budget as sanctioned by the Legislative Council in March last provides 10,19,50 for advances to be obtained from the Government of India for Development and 1,70,27 for general purposes. Further it was decided to obtain 56 lakhs for Lloyd Barrage and to meet it from the advances for Development. The Development figures are explained in the accompanying memorandum. Out of the total advance of 2,26,27 for general purposes including Lloyd Barrage it has been decided to draw only 1,56,71 and the Government of India have been informed accordingly. In order to meet the cost of productive irrigation, including the Lloyd Barrage Scheme, and some other large works, the expenditure on which cannot conveniently be met from one year's revenue, it is proposed to take an advance of 4,89,95 next year from the Government of India for general purposes in addition to an advance of 6,25,00 for Development. Under Rule 23 of the Devolution Rules any money which on the first day of April 1921 was owing to the Governor General in Council on account of advances made from the Provincial Loan Account is to be treated as an advance to the Local Government from the Revenues of India and the Local Government has to pay to the Governor General in Council in each year an instalment in repayment of the principal amount of the advance. The annual instalment has been fixed at 29,00.

200. After the issue of the budget, a supplementary grant of 56,00 was sanctioned by the Legislative Council for the Lloyd Barrage and Canals Scheme. The total grant for the current year under the head "55" is thus 1,38,72. The decrease of 24,04 in the revised as compared with the sanctioned grant is mainly due to savings in the grants for the Nira Right Bank Canal Project, Lloyd Barrage and Canals Scheme, Head Regulator over Baghar Canal and Regulator over Western Nara below Abad Bridge.

NOTE EXPLAINING THE CAUSES OF THE EXCESS OF 2,33,38  
OVER THE ORIGINAL ESTIMATE OF 2,57,73 FOR  
THE NIRA RIGHT BANK CANAL PROJECT.

The excess of 2,33,38 works out to 90·5 per cent. on the cost of the original project. The main causes contributing to the excess are:—

- (1) Increase in the cost of labour and materials, and
- (2) Changes in design of the dam and canal.

Both are extraordinary factors which could not be foreseen by the framers of the original estimate. The reasons for the increases under these heads have been summarised below:—

(1) INCREASE IN THE COST OF LABOUR AND MATERIALS.

*Excess 1,60,18 or 62·1 per cent.*

The original estimate sanctioned by the Secretary of State in 1912 was framed in 1910 at a time when the rates for labour and materials were fairly stable. In 1877 the rate of coolie (man) was 3 annas per day. In 1910 it had risen to 4 annas—a percentage increase of only 33½ in 33 years. The rates adopted in the original estimate had made provision for the normal increase.

Between the years 1910 to 1920, however, the daily rate for a coolie rose from 4 annas to 9 annas, that is to say, there was an increase of 125 per cent. The increase in the case of a female labourer was even more striking. These unprecedented increases followed as a result of the general upheaval of conditions brought about by the Great War and took place mostly between the years 1916 and 1918. Similarly during the same period the cost of materials increased from 18 to 150 per cent. and the cost of iron and steel work from 50 to 300 per cent. A careful analysis of the figures of the revised estimate shows that out of the total excess of 90·5 per cent. 62 per cent. can be allocated to these causes.

(2) CHANGE IN DESIGN OF THE DAM AND CANAL.

*26,60 or 11·1 per cent.*

The original proposal was to raise the old dam at Bhatghar by 60 feet so as to increase its storage capacity from 5,300 to 24,300 million cubic feet. Soon after construction was commenced, an alternative proposal for constructing an entirely separate dam was put forward by the Bombay Engineers. The Inspector General of Irrigation (Sir Michael Nethersole) after thoroughly discussing the matter with the local Engineers on the spot came to the conclusion that additional outlay in building a new dam was justifiable, because

- (1) it would undoubtedly simplify construction,
- (2) ensure an uninterrupted maintenance of supply to the existing Nira Left Bank Canal and the large area of sugarcane and other valuable crops dependent thereon during the long period of construction of the new works, and
- (3) remove all apprehension of danger to the structure.

Finally the Secretary of State, acting on the advice of his expert advisers, accepted the change in design as desirable. Out of the excess of 90·5 per cent. fully 11 per cent. is due to change in design.

From the above, it is clear that by far the major portion of the excess is attributable to causes which could not be foreseen in 1910. It is only necessary to add that out of the balance, 25,88 or 10 per cent. is due to the provision made in the revised estimate for extra items found necessary in the light of recent experience obtained on (a) the Godavari and (b) the Pravara Canals. For instance, a provision of Rs. 14 lakhs or 5·4 per cent. has been made in the revised estimate for concrete lining in order to prevent seepage in the murum tract where intensive cultivation is anticipated. This is an item



remunerative in itself, for it not only prevents water-logging and deterioration of land but also results in the saving of a considerable volume of water. Advantage has been taken of the results obtained from special study and experience, and the designs of masonry works on canals and distributaries have been modernised in accordance with recent methods. The excess due to these causes is, although small, an important consideration in taking a comprehensive view of the case. The excess due to unforeseen items not provided for in the original estimate is only 18,72 which represents 7.3 per cent. on the amount of the original estimate. This is well within the limit of 15 per cent. up to which the Governor in Council is competent to sanction excesses over original estimates under the Reforms Scheme. The Government of India have expressed the opinion that taking all the circumstances into consideration the excess is justifiable.

**EXPLANATORY NOTE ON THE NIRA VALLEY  
DEVELOPMENT PROJECT.**

This project provides for the complete development of irrigation in the Nira Valley on the lines decided upon in consultation with the Government of India. The Nira Right Bank Canal scheme aims at irrigating lands on the right bank of the Nira river, mainly the arid areas of the Sholapur Collectorate. For this purpose, the new Lloyd Dam at Bhatghar will impound 24,198 million cubic feet of water from the Yelwandi river, one of the tributaries of the Nira. There is, however, a large scope for extending irrigation on the existing Nira Left Bank Canal where the advantages of canal irrigation are well known and appreciated and where there is a keen demand for larger supply. This demand can be met by storing the water flowing in the Nira river from sources other than the Yelwandi by means of another dam to be erected on the Nira at Vir below the confluence of all the main tributaries, and by enlarging the Nira Left Bank Canal to the maximum economical limits. The proposed dam at Vir will impound 8,759 million cubic feet of water which will be sufficient to irrigate 35,500 acres of crops including 7,000 acres of sugar cane. This scheme combined with the Nira Right Bank Canal scheme is called the Nira Valley Development Project.

The Nira Right Bank canal system by itself will cost Rs. 491.11 lakhs. The combined scheme will cost Rs. 618.70 lakhs. The extra cost will therefore be Rs. 127.59 lakhs and this amount will be spent on the following works :—

Of this amount a yearly net revenue of Rs. 6.2 lakhs is anticipated on the basis of the water rates proposed to be levied on the existing Deccan canals from next year. The return on the capital outlay will thus be nearly 5 per cent. It is proposed first to take in hand the enlargement of the Nira Left Bank Canal at a cost of Rs. 36.42 lakhs, the idea being that, while irrigation on the Nira Right Bank Canal is being developed, the spare water from the storage at Bhatgar can advantageously be utilised on the Left Bank Canal and that later, when the Right Bank Canal is nearing development, work in Vir Dam may be started.

The project for the extra expenditure of Rs. 127.59 lakhs will shortly be submitted for the sanction of the Secretary of State through the Government of India and on receipt of this sanction, work on the enlargement and remodelling of the Nira Left Bank Canal will be taken in hand.

**MEMORANDUM EXPLANATORY OF THE FIGURES UNDER MAJOR HEADS OF REVENUE AND EXPENDITURE RELATING TO THE BOMBAY DEVELOPMENT SCHEME.**

With a view to undertaking development work in Bombay City and the areas immediately adjoining it, a Directorate of Development was established in 1920 as a Department of Government. The scope of the Directorate's work includes *inter alia* (a) the carrying out of the Back Bay Reclamation Scheme and the Scheme for housing the poorer classes; (b) the collection of information regarding, and, if necessary, the organisation of the supply of, building materials in Bombay City and the Bombay Suburban Division; and (c) all questions relating to development works and schemes, public works, supply of water and electricity and communications in the Bombay Suburban Division.

The estimate of Rs. 13.16 lakhs for 1924-25 for rents from properties comprises Rs. 13.02 lakhs estimated receipts from rents of Directorate chawls, and Rs. 14,000 miscellaneous rents.

The receipts from cotton cess are the amounts estimated to be realised under Act XX of 1920. The revised estimate for the current year is slightly raised in view of the high receipts realised during the first four months of the current year. The estimate for the next year is also similarly raised.

(iv) The difference between Rs. 11.75 lakhs shown against Sinking Fund deposits, and Rs. 939 lakhs shown on the expenditure side against 21, Sinking Fund, represents the estimate of receipts from interest on investments already made, and likely to be made this and next year.

(v) This comprises the loan to be borrowed from the Government of India for development purposes and for local bodies. The next year's estimate of Rs. 625 lakhs comprises Rs. 275 lakhs to be borrowed for Government purposes (which is made up of Rs. 270 lakhs for development and Rs. 5 lakhs for proposed loans to Co-operative Societies) and Rs. 350 lakhs for local bodies.

(vi) This represents anticipated repayments of loans by local bodies.

*Explanation of figures on the Expenditure side.*

(i) This includes the interest, payable to the public and income tax payable to the Government of India, on the development loan of 1920 and interest payable to the Government of India on the sums borrowed, and to be borrowed, from that Government for development purposes and for loans to local bodies.

(ii) This represents one per cent. of the total realisation of the development loan of 1920, set apart as sinking fund under the terms of the prospectus of that loan. As the financial requirements in 1922-23 and 1923-24 are, and will be, met by advances from the Government of India, which will be repaid as development surpluses fall in, no sinking fund is provided in regard to these borrowings.

(iii) This represents the investments made, and to be made, out of the amount set apart as sinking fund and the interest accrued thereon.

(iv) "59, Bombay Development Scheme" includes salaries of officers and establishments, work charges (including cost of land) and other miscellaneous expenditure of the Department, as set forth in details in the appendices B, C, D, E, F and G hereto.

*S-12—Suburban Trunk Roads.*—In the previous budgets this scheme was called the Bandra-Ghodbunder Road Scheme, but it has now been expanded to include all the Trunk roads in Salsette, such as the Bandra-Ghodbunder Road, Malad-Marve Road, Kolwada-Borla Road, and other similar roads, in this scheme. The name of the scheme has therefore been altered to the Suburban Trunk Roads Scheme, and expenditure on trunk roads in Salsette will be debited to this scheme.

*G. (2) (d) Acquisition of land for industrial housing outside existing housing schemes.*—In order to enable the Development Directorate to carry on the

scheduled programme of constructing 50,000 one-room tenements for housing the poorer classes during the year 1924-25 it will probably be necessary to purchase from the Improvement Trust lands in their Dharavi, Sewri—Wadala and Haines Road Schemes. The budget provision of Rs. 18,15,000 is intended for the purchase of these or similar sites.

In the year 1916 Government sanctioned the Commissioner in Sind's proposals (1) that the four Bhal dehs of Bablo, Padwari, Takro and Betri should be surveyed as soon as funds were available for the work, the assessment being levied by bighoti measurement till the survey was made, (2) that in the remaining three dehs, Nind, Joshewari and Kalikot, the paka land should be similarly surveyed as soon as this was feasible, while in the kachha land all makans and holdings should be roughly demarcated and all land marks shown with a view to a regular survey later, and (3) that in no case should leases be renewed. As provision was made for this purpose in the budget of 1918-19, the Commissioner in Sind was asked in April 1918 to carry out the work in that year. Extra temporary establishment required in connection with this work together with incidental charges, was sanctioned by Government in October 1918. Subsequently in 1919 it was reported by the Superintendent of Land Records in Sind to the Commissioner that it was not possible to demarcate 13,900 acres of *kacha* lands in these dehs and that the survey operations were therefore confined to sub-dividing 13,176 acres of *paka* land into small survey numbers. On completion of the measurement operations in May 1919, it was found that there was still a considerable area of cultivable land in the tract that could be surveyed. The establishment and other charges in connection with this were sanctioned in November 1919. The survey was completed in 1919-20. Since the completion of the survey, very little has been accomplished in the matter of the preparation of the record of rights for this tract. A provision of Rs. 1,500 was proposed for this purpose in the budget of 1922-23 but was cut out owing to the necessity for retrenchment of expenditure. The attempt to carry on the work with the existing staff has not been successful. The work cannot be put off still further without a risk of losing the results of the survey. Moreover the expenditure is remunerative and will

as the change introduced in the Press involves greatly increased work for the store-keeper and his assistant. The value of the stores and the importance of the correct keeping of accounts regarding them require that the men should be adequately paid.

Originally a village map was drawn by hand by a draftsman and it was then photographed. From the photos copies were printed. One copy was reserved and after a lapse of some years various corrections and alterations having been made in the survey numbers, these corrections were made in the printed copy and they were again photographed. From this a fresh reprint was made. At each repetition there is a slight decrease in the sharpness of the lines. Consequently many of the maps are now becoming almost illegible. It is therefore necessary to have corrected up-to-date copy of the map redrawn by draftsman again. It is not possible to entrust this work to the ordinary draftsmen of the Photozinc Press as their normal work occupies them fully. It is necessary to have an extra staff of two men. It is proposed to have this establishment sanctioned for one year in the first instance, but it is likely that the work will continue for a considerable number of years.

The introduction of city surveys at various places in this Presidency has been sanctioned by Government. The cost of the introduction is recoverable from the land-holders. As soon as the inquiry work is finished, maintenance work commences, otherwise the result of the survey would be lost. The cost of such maintenance is borne by Government. To some extent it is recouped by levy of fees and fines. Recently Government have had under consideration the question of covering the cost of

An expenditure of Rs. 1,640 for labour charges and contingencies for the Karachi City Survey will also be required. In order to bring the total provision to a round sum, this item has been taken at Rs. 1,705. Thus a lump provision for Rs. 25,000 in round figures will be required:

The introduction of the city survey at Dahanu was sanctioned in June 1922. The enquiry was finished at the end of April 1923 and if the work done at the survey is not maintained, the result would be lost. It is therefore proposed to begin maintenance work from the next financial year. The supervision of the work is to be entrusted to the Sub-Registrar, Thana, in addition to his duties. This is the most economical arrangement for the maintenance work. The expenditure has been calculated for eleven months from 1st April 1924.

This is the only service in which a time-scale of pay does not exist. The advisability of introducing it was brought to the notice of the local government by the Secretary of State as early as 1917.

2. The revision has failed to achieve the object in view *viz.*, improvement in pay to meet the rise in the cost of living and more than half the number of Superintendents have derived no benefit from it. The revision has thus served to accentuate the discontent already prevailing among the majority of the officers at the time of its introduction. Those Superintendents who previously belonged to the Salt Department have an additional grievance inasmuch as on the amalgamation of the Salt and Excise Departments, they lost certain important privileges which they formerly enjoyed, *viz.*, acting promotion from grade to grade, exchange compensation allowance and free quarters. In a small cadre like that of the Superintendents of Salt and Excise vacancies are infrequent and consequently there is a serious block in promotion with its resulting hardships. The only remedy for the present unsatisfactory position is the adoption of a time-scale as in the case of all other services, and it is proposed to adopt the following scale. Any lower scale would not only give no relief to the

In 1920 the Auditor General drew attention to the inefficiency of the working of the Hyderabad Treasury, where the number of irregularities in 1916-17, 1918-19 and 1919-20 was the highest for the whole Presidency. The Collector of Hyderabad pointed out that owing to the fact that the Hyderabad Treasury had to do the work of Nawabshah District, work was too heavy for the present staff and an increase would be necessary. In the meantime the Accountant General pointed out that the Auditor General desired that a treasury should be opened in the Nawabshah District considering apart from all other considerations the fact that the revenue of Nawabshah District was Rs. 15 lakhs, and that the Hyderabad Treasury was 100 miles distant rendered a separate treasury at Nawabshah necessary. The matter was further examined by the Accountant General who again in 1922 pressed the opening of this treasury on the Local Government and pointed out that under Treasury Order No. 4 there should be a treasury in every district, unless the Auditor General directed otherwise.

It is therefore necessary to open a New Treasury at Nawabshah. As is shown below this will result in some saving in establishment in Hyderabad Treasury instead of additions to the Hyderabad establishment which would otherwise have been necessary. It is proposed that the Treasury should be in charge of a Huzur Deputy Collector, and provision for 11 months for this post at the minimum pay of Rs. 300 a month of the lowest grade of Deputy Collectors is proposed. The details of the other establishment required for the new Treasury are as follows:—

The net financial effect of the above proposals is (Rs. 1,751 - 568 = 1,183 x 11 months =) 13,013 on average rates of pay. The total cost of the establishment at the initial rates of pay after taking into account the reduction also at initial rates amounts to (Rs. 1,271 - 360 = 911 x 11 months =) 10,021. It is proposed to provide Rs. 11,000 for the establishment for 11 months of next year, as some hands with previous experience of Government Treasuries will be required for the new Treasury and it may not be possible to entertain all clerks on initial rates of pay. Numerous questions were asked from time to time in the local Legislative Council as to the steps taken or intended to be taken by Government for improvement in the remuneration of such village officers as Patels and for such inferior village servants as Mahars, Jaglias, Rawanias and others. Accordingly in September 1921, Government asked the Commissioners of Divisions to consider the question of increasing the remuneration at present allowed to these classes of servants and to submit a joint report on the subject embodying their recommendations. This joint report has been received and considered by Government. The question of revision of pay of village officers and servants presents very great difficulties. Apart from the heavy expenditure involved in any such revision, which cannot be undertaken in the present financial situation without most careful consideration, the variations in the pay and conditions of service in different districts are so numerous and so complicated that it is impossible at the present stage to pass general orders which can be made applicable to all Districts in the Presidency. The present rates of remuneration which are paid to the watandar village officers and servants are determined by a system which is not based on economic wage for full time duties. So long as this system with its part-time

I. Revision of remuneration of Patils and Mahars in the Ratnagiri and Kolaba Districts.

*Ratnagiri Patils.*—The remuneration of Patils in this district consists of:—

- (a) Fixed allowance ranging from Rs. 4 to Rs. 24 per annum based on population, and
- (b) Special allowances of Rs. 10, 20, 30 and 40 for Patils of important villages with large bunders or halting places on roads.

According to the revised proposals the fixed allowances vary from Rs. 12 to Rs. 48 per annum. The present annual cost of Patils' remuneration (excluding special allowances which are not to be revised) is Rs. 21,380, while the cost according to the scale now approved by Government is Rs. 28,292. The extra cost per annum will be

*Ratnagiri Mahars.*—The remuneration of Mahars in this district, who are Patils' orderlies, is half that of the Patils. According to the revised proposal the allowances will remain in the same proportion as at present, and they will be paid at half the rates sanctioned for Patils. The annual cost according to the existing scale of remuneration is Rs. 10,690, while at half the scale sanctioned for Patils it would be Rs. 14,146. The extra cost per annum will be Rs. 3,456

*Kolaba Patils.*—They do both revenue and police work and their remuneration consists of:—

- (a) A certain percentage on land revenue collections of the village.
- (b) Fixed allowance (potgi) ranging from Rs. 5 to Rs. 20 per annum based on population, and,
- (c) Special allowances of Rs. 20 and 10 per annum in the case of Patils of important villages, e.g., market and camping places.

The present scale of percentage allowance based on land revenue is not to be revised, as it automatically rises every 30 years, but it is proposed to raise by 50 per cent. the scale of fixed allowance based on population. This will involve an additional expenditure of about Rs. 4,000. It is also considered necessary to revise the rates of special allowances paid to Patils of important villages, e.g., market and camping places, and to fix them at Rs. 30, Rs. 20 and Rs. 10 for taluka headquarters, Mahal stations and camping places, and for places of importance, respectively

Contingent allowance to Kolaba Patils for stationery. With a view to saving the trouble of storing the articles of stationery at, and distribution from, taluka and mahal offices to Patils, the Patils will be given contingent allowances of annas 8 and rupee one based on population. *Mahars in the Kolaba District.*

They get at present—

- (a) A certain percentage on land revenue collections of the village, and
- (b) Fixed allowance:—

A minimum of Rs. 6 for villages containing upwards of 150 souls and Rs. 3 for villages with a smaller number.

The existing scale of percentage remuneration is not to be revised. As regards fixed allowance, in the large majority of villages nothing at all is paid and in others sums ranging from 8 annas to Rs. 5, but on no fixed principle, the larger villages being often omitted and payment made in smaller ones. At present a sum of only Rs. 599-8-0 is paid annually as fixed allowance. The existing scale is now to be adopted in all villages and the annual cost will be Rs. 7,239. The extra cost will be Rs. 6,639-8-0.

At present Rs. 5 only is paid in the whole district for special allowances. But the Mahars have a good deal of running about to do in connection with camps and deserve extra remuneration. It has therefore been decided that in villages selected for special allowances, mahars should be paid at half the rates allowed to the patils in the district. This is in accordance with the practice followed in Ratnagiri. The extra cost on account of special allowances will be Rs. 265 per annum. The total extra cost on account of fixed and special allowance will be Rs. 6,904-8-0 per annum

2. Revision of the rates of remuneration of Ravanas in the Kaira District.

There are at present 1,263 Ravanas (inferior village servants) employed on cash remuneration varying from Rs. 6 to Rs. 8 per mensem and their total remuneration comes to Rs. 93,192 (Rs. 62,880 plus Rs. 30,312 on account of extra allowance) per annum. It is proposed to reduce their number by 181 and to fix the remuneration of the remaining Ravanas at Rs. 8 and Rs. 10 per mensem, the latter rate being allowed for head-quarter towns and a few big centres and the former rate being allowed for the remaining villages of the District.

The sanction of the Secretary of State to the scheme for the constitution of separate District and Sessions Judgeships for the Revenue Districts of Kaira, Nawabshah, Kolaba and East Khandesh was received in 1921. Effect could not, however, be given to the scheme in the years 1921-1922, 1922-1923 and 1923-1924 owing to acute financial stringency. The necessity for starting the new District Courts is now more pressing, and was the subject of discussion in the last Council meetings. It is proposed to start District Courts at Alibag and Jalgaon from 1st April 1924 and those for Nawabshah and Nadiad from 1st November 1924. Arrangements have been made for temporary accommodation for the District Judges and for office establishments. The Secretary of State for India has been addressed with a view to all the four District Judgeships being listed but to the first two being given for the present to members of the I.C.S. in order to relieve the block on the Judicial Side of the I.C.S. Provision for District Judgeships for Kolaba and Jalgaon will, therefore, be non-voted.

It has been represented to Government that there is much congestion in the record rooms of the District Courts, and that, unless special steps are taken to dispose of the large accumulation of useless records, Government will be faced with the necessity of building new record rooms. The work of destruction of records has increased beyond the capacity of the existing staff. It is, therefore, proposed to recruit men from among the experienced clerks in the Districts for the work of sorting and destroying records, and a special establishment, as detailed below, for each of the three Divisions, Gujarati, Marathi and Kanarese, is proposed to be

It is a very important junction station with a large mercantile and railway population, and owing to various industries, which are being started in the town and adjoining villages, there is a large increase in the magisterial work. The Mamlatdar of Kalyan is unable to cope with the increased work and needs urgent relief. The proposal involves an annual expenditure of Rs. 6,197, of which expenditure to the extent of about Rs. 5,375 will be recurring and the rest non-recurring.

On account of acute financial stringency, several appointments of Resident and City Magistrates were reduced in 1922 as a measure of economy and the appointment of the Resident Magistrate at Nawabshah was one of the appointments so retrenched. The District Magistrate, Nawabshah, subsequently reported that the abolition of the post of the Resident Magistrate caused very great inconvenience and expense to the public, and pressed for the revival of the appointment. The Commissioner in Sind supported the proposal, and after full consideration, Government have decided that a Resident Magistrate should be reappointed at Nawabshah. The proposal involves a recurring expenditure of Rs. 4,812.

The Railway Police Committee appointed by the Government of India in 1921 had made several recommendations to the Government of India with a view to preventing and detecting thefts on railways and the Government of India have recommended some of these for the consideration of Local Governments. Government have after careful consideration administratively approved the proposal to abolish the separate grades of Prosecuting Inspectors and Sub-Inspectors and to name the whole staff as Police Prosecutors and to revise the pay of the staff as shown below :—

The proposed pay is recommended with a view to securing competent and qualified pleaders in this special branch of the Police Department who can deal tactfully and successfully with important cases in the Courts. The extra cost involved during the next year on account of the proposed pay approximately amounts to Rs. 5,200 including Sind.

It has been reported to Government that considerable discontent prevails amongst Writer Head Constables and Constables working in the offices of the Police Inspectors and Sub-Inspectors. The writing work in these offices is often heavy and of a multifarious nature. In addition to the writing work, Writer Head Constables and Constables have to assist the Police Station Officer in the investigation of offences and it is on them that the punctual despatch of all the routine work of a Police station depends. They have thus to work long hours every day and they are not allowed holidays granted to clerks of all other departments. The natural consequence is that these men constantly apply for transfer to the executive line and it becomes difficult to refuse such applications for transfer. Owing to the prevalence of illiteracy among the constabulary competent men to succeed them are not easy to find. Hence,

G. I. P. Railway. On the B. B. & C. I. Railway the whole cost of the force was recovered from the villages concerned in the Anand Taluka of the Kaira District. As the entertainment of the additional Police force has resulted in lessening crime on both the railways, the force has been continued during the current year also, and in view of this successful experiment Government have decided to entertain permanently an armed police force of 12 head constables and 36 constables as escorts for trains on the G. I. P. and the M. & S. M. Railways and the same force on the B. B. & C. I. Railway. The total cost of this Police force amounts to Rs. 57,672 (Rs. 53,832 recurring on account of pay and allowances of the force plus Rs. 3,840 non-recurring for purchase of 96 arms). It has also been decided that as the proposed additional force will be useful to Government for purposes of law and order, Government should bear  $\frac{1}{3}$ th of the total cost mentioned above and the remaining cost should be recovered from the railway companies concerned.

The arms at present supplied to the Police force in the Bombay Presidency are not considered satisfactory and the Government of India have therefore sanctioned during the current year the supply of modern rifles (the Lee-Enfield .303) to the Police force in this Presidency. These arms will be ready for issue to the Bombay Police before the end of the current financial year. The proposed provision is necessary to lengthen rifle ranges and enlarge butts at District Headquarters and to purchase land for extending rifle ranges so as to make them suitable for the new arms.

Owing to the Criminality of Borsad Taluka it has been found necessary to draft a large additional force of Police into the Taluka. The strength of Police employed will vary according to circumstances but it is estimated that it will be necessary to spend at least Rs. 1,00,000.

Government desire that this popular and valuable movement should be, so far as possible, financed by public subscriptions and in response to an appeal by Sir George Lloyd in 1921 a sum of 1 lakh of rupees was collected. Of this sum only a small portion remains unexpended and Government have therefore decided to ask the Legislative Council to make provision of Rs. 15,000 in the budget for assisting the movement until it becomes entirely independent of financial help from Government. Rs. 15,000 is required partly for providing the Provincial Secretary with an Indian Assistant, for propaganda work, for vernacular literature and for the training of more Scout masters by means of divisional camps instead of the central one at Lonavla. The cost of equipment alone amounts to about Rs. 15 per boy which is rather a heavy tax upon the resources of those classes whose participation in the movement is particularly desirable. It is felt that the State should bear a share in the expansion of the movement which is distinctly educational and is being taken up by the people.

Government have sanctioned the payment of grants to aided colleges at the rate of  $\frac{1}{4}$  of the admitted expenditure or  $\frac{1}{3}$ rd of the assets (whichever is less) owing to a reduction in the allotment it has not been possible to pay grants at the sanctioned rate this year. The additional provision is necessary to enable the Department to pay aided colleges at the sanctioned rate as far as possible.

The advisory Committee has gone into this question very closely and they have come to the conclusion that Rs. 3½ lakhs would be required to equip the Institute satisfactorily. About 2½ lakhs have already been spent and a further Rs. 1 lakh is required to complete the equipment.

rhœa among new born babies, it has been arranged that the babies' linen should be washed daily. These arrangements involve a considerable extra work to the Hospitals' dhobies who are also not paid higher rates than usual for washing heavy clothings such as carpets, blankets, etc. The dhobies have therefore requested for increases in the rates at present paid to them. Their request is reasonable. The importance of properly washed clothes at hospitals and especially at women's hospitals dealing with maternity cases hardly requires emphasis. It is therefore proposed to increase the grant for washing charges of the hospitals from Rs. 150 per mensem to Rs. 250 per mensem from 1st April 1924.

Grants in aid of nursing at hospitals are fixed for a period of three years at one-half of the total expenditure of the nursing associations. The present triennium expires on 31st March 1924, and proposals have been received for increasing the grants in aid of nursing at hospitals mentioned below. Provisions have been proposed for the increase in the grants which are based on the estimates of expenditure for the years 1924-25 to 1926-27.

The additional contract grant is asked for for the reason that expenditure on contract contingencies specially on "bedding and table linen"—would increase on account of the additional accommodation for patients provided for at the hospital.

New blocks are built providing additional accommodation for Europeans and Anglo-Indians and female patients. It is estimated that the blocks would accommodate about 70 patients. It is necessary to furnish these blocks according to their minimum requirements. It is estimated that it would require about Rs. 6,150 to furnish them.

With the introduction of professional nursing, the quantity and quality of food given to patients at the European General Hospital, Aden, have much improved. The cost of free rations to the nursing staff is also included in the charges under the head "Diets". Owing to these reasons as well as the usual rise in prices of food stuffs the expenditure under 'diets' has increased considerably. An additional grant of Rs. 5,000 for the purpose is therefore absolutely necessary. The figures of actual expenditure on contract contingencies during past years render it necessary to increase the contract grant of the hospital by Rs. 1,000. Owing to rise in

Government towards the Scheme, the balance of the cost being met from the donation referred to above.

The total estimated cost of the Kapadvanj Water Supply Scheme is Rs. 5,13,434. The Municipality has raised a sum of Rs. 2 lakhs by public contributions and is placing it immediately at the disposal of the Sanitary Engineer for the execution of the project. According to the usual policy of Government to give 50 per cent. of the cost of water works and drainage schemes as a grant-in-aid Government have decided to give to the Municipality a grant-in-aid of half of the cost of this scheme and a provision of Rs. 15,000 is in the first instance proposed in partial payment of the grant-in-aid.

The Sanitary Board have been authorised to sanction projects costing up to Rs. 20,000 and to make grants up to a limit of Rs. 10,000 for any work and it has been decided that for the latter purpose such amount not exceeding Rs. 2 lakhs as the state of provincial funds permits should be placed at the disposal of the Board. A sum of Rs. 30,300 is accordingly proposed to be placed at the disposal of the Board next year.

investigation of the problem. It is proposed to depute a competent officer to study the habits of the rats in the first instance to clear a group of villages and thereby gather data for a more extensive campaign in future. The work is expected to last one year.

In connection with the question of improving the cattle of the Bombay Presidency it was suggested that some of the Gaorakshans and Pinjrapoles in the Presidency could be induced to assist Government in the work. The authorities in charge of several such institutions were approached and some five institutions were visited by the Deputy Director of Agriculture for Animal Breeding. The results of the investigations have up to now been favourable in two cases, and the authorities concerned have agreed to co-operate with the Agricultural Department to the fullest extent.

The Director of Agriculture has accordingly drawn up a scheme, the aim of which is to produce a nucleus herd of first class Gir cattle for the supply of breeding bulls in the various parts of this Presidency. The details of the scheme are as under :—

- (a) A herd of forty first class Gir cows should be established, twenty animals being supplied by the Gaorakshan and twenty by Government.
- (b) A first class bull for the use of this herd to be supplied by Government.
- (c) The cost of a Manager to be appointed by the Gaorakshan with the approval of the Deputy Director of Agriculture for Animal Breeding to be paid by Government, the Manager to keep all the herd records which are required.
- (d) The male progeny of the herd should belong to Government, and be used for putting out on the premium system. The female stock will belong to Gaorakshan.

The scheme is expected to furnish after three years about fifteen bulls a year for distribution.

Agriculture during the current year as a temporary measure. It is proposed to continue the appointment for one more year pending the reorganization of the office establishment of the Director.

The Committee appointed to consider measures for the protection of crops from wild animals was of the opinion that damage by wild pig could be practically eliminated in certain areas by organising hunting parties for the purpose. Such parties were organised in the Nira Valley area during 1919-20 and 1920-21 at Government cost but with the co-operation of the cultivators. The results were very promising and the damage done was reduced to almost negligible extent. The cultivators are very willing to co-operate with Government in the work. It is proposed that two such parties should be maintained in the next year under the control of the Agricultural Department in the Deccan Canals areas at a cost of Rs. 5,000 each per annum on the condition that cultivators pay half the cost of their maintenance.

One of the most successful improvements in agriculture in Sind during the last few years has been the introduction of improved varieties of wheat seed known as "Punjab 11" and "Pusa 12". It has now been found necessary to import this seed on a large scale so to extend its use rapidly and thus make the Province self dependent for its seed supply in course of time. Transport charges make the seed a little dearer than the indigenous varieties and the people are not at present willing to take up the improved seed at higher cost. The Director of Agriculture therefore proposes that Government should undertake the import on a large scale and bear the small loss that may accrue on account of the freight charges. In view of the great importance of the improvement it has been decided to accept the Director's proposal and a provision of Rs. 5,000 has been made.

In the case of new dispensaries opened during the period of revision the officers concerned were empowered to sanction grants not exceeding Rs. 600 in the case of first class dispensaries and Rs. 450 in the case of second class dispensaries, subject to budget provision. The rate has now been reduced to Rs. 350. Five new dispensaries are likely to be opened during the ensuing year at Chikhli and Olpad in the Surat District, Jamner in East Khandesh, Dohad in the Panch Mahals and Taloda in West Khandesh. A provision of Rs. 1,750 has been made for grants-in-aid to these dispensaries.

Government have decided that on the separation of the Sind and Baluchistan Veterinary charges and the appointment of a full time Superintendent for Sind the post of Deputy Superintendent should be abolished and in his place two Veterinary Inspectors should be appointed. The Sind and Baluchistan charges have since been separated and as Khan Bahadur S. G. Haji, the present Deputy Superintendent, will retire from service from 1st April 1924 the opportunity is taken to abolish the latter's post from that date and appoint two Inspectors in his place. The duties of the Inspectors will be:—

- (1) Inspection of Veterinary dispensaries quarterly;
- (2) Checking of the work done by Veterinary Assistant Surgeons in the district and at the hospitals;

To enable the Bombay Central Co-operative Institute to carry on its various activities an annual subsidy is granted to it. In the February sessions of the Legislative Council a grant of Rs. 15,000 was sanctioned for the current year. The Institute has now six Divisional Branches and has engaged a staff including in each case a propagandist Secretary with pay of about Rs. 100 to Rs. 120 a month. The Central Institute in Bombay has a well-staffed office with a permanent Secretary on Rs. 300 a month. In addition to the charges for establishment and on conferences, the Institute publishes the Bombay Co-operative quarterly and also monthly or quarterly vernacular magazines. The expenditure on the magazines is particularly heavy but this work which is of the utmost importance to the development of the co-operative movement must be maintained at its present stage of efficiency. The Registrar has recommended a grant of Rs. 22,000 for the year 1924-25, based on the income of the Institute for the year 1922-23. Government have accepted the policy of getting as much of co-operative propoganda and development work carried on through unofficial agency as possible. As the movement develops, more and more of its work, particularly that of propaganda and instruction, will devolve on non-officials, and the Institute, as the centre of non-official co-operative effort in the Presidency, deserves strong financial support from Government. Government have therefore approved a grant of Rs. 22,000 for next year.

The growth of overdues within the Agricultural Co-operative movement in this Presidency has been causing increased anxiety for the last three years. In the year ending 31st March 1923 the overdues amounted to Rs. 31 lakhs or over 18 per cent. of the working capital. The main cause of the growth of overdues and the mismanagement in Primary Societies which they connote, is want of sufficient instruction

The Co-operative Conference of 1919 recommended that Government should allot a grant for clerical assistance to Co-operative Societies composed of back-ward and depressed classes in rural areas where illiteracy is prevalent and funds are not available for paid Secretaries. Government have approved this recommendation, and an annual grant of Rs. 720, equivalent to the pay of Rs. 25 per mensem *plus* fixed travelling allowance of Rs. 5 for two Secretaries, is now made for clerical assistance to the Bhil Societies in the Dohad and Jhalod talukas of the Panch Mahals District. Since the grant was sanctioned, intensive development of Co-operative Societies has been taking place in the two talukas. The Provincial Co-operative Bank has opened a branch at Dohad, which is doing effective work; a sub-branch of the Bombay Central Co-operative Institute has been opened at the same place; and a Special Mamlatdar has recently been appointed for Gujarat, whose main work will be to develop the two talukas in question. The number of Societies in the two talukas is at present 56 and it is likely that it will go up to 75 by the end of this year and to 95 by 31st March 1925. As one Secretary is not able to work satisfactorily for more than 6 societies it is estimated that 15 Secretaries would be required during the year 1924-25. It has, however, been arranged that three-fifths of the cost of the Secretaries should be met from contributions from the Societies and that two-fifths should be borne by Government. The additional cost to be borne by Government will therefore amount to Rs. 120 per mensem. Government have approved of the additional grant with effect from 1st April 1924. Provision has been made for eleven months of next year.

proposed that the scale of pay for this appointment should be the same as that already sanctioned for the present incumbents of the posts of Special Auditor. The pay of the clerk and peon is on the usual scale. Provision is proposed for eleven months of next year.

The continuous large percentage of overdue debts in the Sholapur District has engaged the serious attention of Government for some time and in their Resolution reviewing the report on the working of Co-operative Societies for the year ending 31st March 1922 they asked the Registrar of Co-operative Societies to submit a special report regarding the position and to suggest measures for improving it. On 30th November 1922 the working capital of all agricultural societies in the district was (in thousands of rupees) 12.83 and overdues were 3.98 or 31 per cent. of the working capital. Subsequent reports showed no improvement, and the position is as serious as ever. The greatest part of the overdues is owed to depositors and next to them the heaviest creditor is the Sholapur District Central Bank. One main cause of overdues is the prevalence of bad seasons in recent years. Grant of lavish credit also induced members to borrow beyond their capacity instead of seeking to increase their earnings by work. Next to famine the most serious cause of overdues has been mismanagement on the part of Managing Committees. This emphasises the importance of inspection. The Registrar accordingly proposed that a Special Mamlatdar should be engaged to reduce overdues and organise training classes for two years. Government have approved the appointment for a period of one year in the first instance from 1st April 1924 and provision for the Mamlatdar, his clerk and peon is made for eleven months of the next year.

In September 1921 Government sanctioned a grant-in-aid of Rs. 25,000 to the Virangam Municipality towards the construction of a Municipal hall, as a compensation for the Municipal property destroyed in the Virangam riots of 1921. The necessary provision was made in the budget for 1922-23 but the grant was not drawn by the Municipality. As the Municipality has now commenced the construction of the hall it requires the amount sanctioned to it as a grant-in-aid. Government have been definitely committed to the expenditure and the amount of Rs. 25,000 is proposed to be provided next year.

The current year's provision on this account is Rs. 2,08,000. Government are liable, however, to increased grants under the Local Boards Act, 1923. Every Local Board is now to have an elected non-official President and under section 119 (2) of the Act grants at 2/3rds of the salaries of Chief Officers (or Engineers) and Health Officers have to be paid by Government.
