

INTRODUCTORY NOTE

Section A of this Note is a short review of the accounts for 1948-49, and Section B of the revised estimates of 1949-50 (based on the first eight months of the year). A brief indication of the receipts and expenditure for 1950-51 is given in Section C. Further details will be found in the body of the publication.

SECTION A: 1948-49 (ACCOUNTS)

2. A nominal surplus of Rs. 6.42 lakhs was assumed in the budget. The accounts, as they stand at present, show a surplus of Rs. 285.37 lakhs.

This surplus, however, will be converted into a deficit of Rs. 151.63 lakhs when an adjustment amounting to Rs. 437 lakhs, on account of the State share of food subsidy in respect of imported foodgrains, which at this stage is shown under the Debt Section, is finally carried out in the Revenue Section of the accounts.

3. Some of the more important variations in the estimates are explained below :—

(a) RECEIPTS

IV-Taxes on Income (+ Rs. 240 33 lakhs)

The increase is due partly to the inclusion of Rs. 120 lakhs on account of arrears pertaining to the pre-partition period and partly to the collections having been larger than anticipated.

VIII-Provincial Excise (-Rs. 52 55 lakhs)

The fall in receipts is due to smaller consumption of country spirit.

IX-Stamps (+Rs. 22.63 lakhs)

The increase is due to larger receipts from probate duties and larger sales of stamps on account of the establishment of the City Civil Court at Bombay and of the functioning of Debt Adjustment Boards.

X-Forest (+Rs. 35.82 lakhs)

The betterment is due to increased receipts from sales of coupes, kurans and minor forest produce.

XII-Receipts under Motor Vehicles Act (+ Rs. 43 53 lakhs)

The increase in revenue is mainly due to (i) registration of, and (ii) issue of temporary permits for, a larger number of motor vehicles.

XIII-Other Taxes and Duties (+249.97 lakhs)

XXI-Administration of Justice (+Rs. 31.34 lakhs)

The increase is mainly due to (i) larger receipts from magisterial fines, and (ii) crediting of copying and comparing fees of section writers to Government.

XXIII-Police (+Rs. 31.92 lakhs)

• The larger receipts are mainly due to increase in (i) the contribution received for the Railway Police, and (ii) the recoveries of fees, overpayments, etc.

XXIX-Agriculture (+Rs. 45.41 lakhs)

The betterment is due partly to a change in the accounts procedure whereby subsidies from the Government of India are shown as receipts instead of as deductions from expenditure, and partly to increased earnings from agricultural and farm produce.

XXXVI-Miscellaneous Departments (+Rs. 26.82 lakhs)

The increase is mainly due to a transfer of Rs. 60 lakhs from the Godown Reserve Fund, partly counterbalanced by smaller receipts from the Cloth Dealers' Licensing Order, 1940.

XLVI-Miscellaneous (+Rs. 33 63 lakhs)

. The betterment is mainly due to larger receipts on account of unclaimed deposits, recoveries of overpayments and the crediting of the cash balances of certain merged states.

LI-Extraordinary Receipts and LII-A-Transfer from Revenue Reserve Fund (--Rs. 1,78.12 lakhs)

The decrease is mainly due to smaller subventions from the Government of India towards Post-War Development Schemes and National Highways.

7-Land Revenue (+Rs. 20.81 lakhs)

The increase in expenditure is mainly due to (i) introduction of revised scales of pay and rates of dearness allowance, (ii) employment of additional temporary establishment, and (iii) additional expenditure on account of akarband work etc.

12-Charges on account of Motor Vehicles Acts (+Rs. 34 94 lakhs)

The increase under this head is mainly accounted for by a larger transfer to the Provincial Road Fund as a result of larger receipts.

25-General Administration (+Rs. 95 20 lakhs)

The excess is on account of increased expenditure on (i) revision of pay and allowances, (ii) employment of additional staff, (iii) merger of states, and (iv) preparation of electoral rolls.

27-Administration of Justice (+Rs. 36.67 lakhs)

. . . .

The increased expenditure is mainly due to (i) establishment of the City Civil Court, (ii) establishment of additional Criminal Courts, (iii) appointment of a larger number of Civil Judges for debt adjustment work, and (iv) revised pay-scales and allowances.

28-Jails and Convict Settlements (+Rs. 31 59 lakhs)

The increased expenditure is due to additional posts of Superintendents, increase in office establishment, larger number of prisoners, high prices of food stuffs and higher cost of jail manufactures on account of increased prices of materials.

29-Police (+ Rs. 1,10[.] 66 lakhs)

The increased expenditure is mainly due to revision of pay and allowances, strengthening of the police force, reorganisation of the Criminal Investigation Department and expansion of the Home Guards Organisation.

'40-Agriculture (+Rs. 40.37 lakhs)

The increase is due mainly to larger expenditure on the construction of $ne\pi$ wells and tanks.

43-Industries (- Rs. 22.66 lakhs)

The decrease is mainly due to smaller expenditure on Post-War Reconstruction Schemes.

50-Civil Works (-Rs. 91.62 lakhs)

The decrease is explained by smaller expenditure on National Highways and postponement of expenditure on certain works. 1111

56-Stationery and Printing (+Rs. 48.02 lakhs)

The increase is mainly due to (i) purchase of machinery for Government presses, (ii) larger purchase of stationery for various offices including those oin the merged and integrated states and (iii) additional expenditure on overtime allowance. S roof

57-Miscellaneous (-Rs. 36.63 lakhs)

The decrease is mainly due to the provision of Rs. 150 lakhs made under this head for revision of pay-scales being later distributed under the various major heads; partly counterbalanced by increased expenditure on account of payments of compensation to sufferers in the Godhra and Kolaba disturbances, larger grafits to District Local Boards, and expenditure on displaced persons.

5. The revised estimates based on the latest actuals available show a deficit of Rs. 10.34 lakhs as against a surplus of Rs. 45.02 lakhs anticipated in the budget.

6. The merger of states took effect on 1st August 1949. Thereafter, all receipts and expenditure pertaining to these areas, which had till then been accounted for under the Debt Section, were brought to account under the regular service heads in the Revenue Section, with the result that there are large variations in that section on the receipts side as well as on that of expenditure. For the increases on the payment side, various supplementary grants have already been sanctioned by the Legislature. Some of the more important variations are explained below :----

(a) RECEIPTS.

IV-Taxes on Income (+ Rs. 35.49 lakhs)

The increase is based on the latest intimation from the Government of India.

VII-Land Revenue (+ Rs. 1,44.33 lakhs)

The betterment is mainly due to additional revenue from merged states from 1st August 1949.

X-Forest (+ Rs. 72.12 lakhs)

The larger receipts under this head are mainly due to good prices realised for coupes, kurans and minor forest produce, increased production of logs and sleepers, and additional revenue from merged state areas.

XII-Receipts under Motor Vehicles Acts (+ Rs. 24.68 lakhs)

The improvement is mainly due to registration of new vehicles and additional fees from the merged states.

XIII-Other taxes and duties $(+ \text{ Rs. } 4,99 \cdot 14 \text{ lakhs})$

The betterment is mainly due to larger receipts from sales tax, sugar cane cose and electricity duty.

XXVI-Education (+ Rs. 26.77 lakhs)

The improvement is mainly due to increase in receipts from fees, revenue from merged state areas, and a subsidy of Rs. 10 lakhs from the Government of India for social education.

XLVI-Miscellaneous (+ Rs. 34.06 lakhs)

The betterment is mainly due to the crediting of cash balances of certain states.

LI-Extraordinary Receipts (+ Rs. 1,38 25 lakhs)

The larger receipts under this head are mainly due to the inclusion of a central subsidy on account of merged state areas, provisionally estimated at Rs. 2,13 lakhs, partly counterbalanced by a reduction in the Central subsidy for Post-War Reconstruction Schemes and smaller expenditure on National Highways.

(b) EXPENDITURE.

7-Land Revenue (+ Rs. 42.98 lakhs)

The additional expenditure under this head is mainly due to merger of states, revised rates of allowances and larger outlay on acquisition and improvement of lands for village sites.

10-Forest (+ Rs. 37 34 lakhs)

The larger expenditure is mainly due to the creation of a new working-plan subdivision, payments for grass supplied to scarcity areas, expenditure on enumeration of cyclone-damaged trees and employment of staff in merged state areas.

12-Charges on account of Motor Vehicle Acts (+ Rs. 24. 62 lakhs)

The increased expenditure is mainly on account of a larger transfer to the. Provincial Road Fund.

13-Other Taxes and Duties $(+ \text{ Rs. } 68^{\circ} 46 \text{ lakhs})$

The excess is mainly due to a larger transfer to the Sugar Cane Cess Fund than anticipated.

25-General Administration (+ Rs. 1,25.76 lakhs)

The increase in expenditure is mainly on account of additional establishment, including establishment for merged state areas, and increased rates of dearness allowance, etc.

27-Administration of Justice (+ Rs. 28.9 lakhs)

The increase is mainly due to establishment of civil and criminal courts in the newly created districts.

28-Jails and Convict Settlements (+ Rs. 43.91 lakhs)

The larger expenditure under this head is mainly due to merger of states, introduction of jail reforms, higher cost of food stuffs and raw materials and increased rates of dearness allowance, etc.

29-Police $(+ \text{ Rs. } 1,31 \cdot 17 \text{ lakhs})$

The large increase is mainly due to additional establishment pertaining to the District Executive Force, Police Training School, Railway Police and Criminal Investigation Department, revised rates of dearness allowance etc. and entertainment of staff for merged areas.

37-Education $(+ \text{Rs. } 1,84 \cdot 31 \text{ lakhs})$

There is a considerable increase in the expenditure under this head on account of payment of additional grants to universities and colleges, additional staff for colleges, larger expenditure on secondary and primary education necessitated by the merger of state areas and, lastly, the extension of revised rates of pay and dearness allowance to primary teachers.

38-Medical (+ Rs. 48.52 lakhs)

The larger expenditure under this head is mainly due to revision of pay-scales, additional establishment sanctioned in consequence of merger of states, higher prices paid for supplies and enhanced rates of dearness allowance.

39-Public Health (+ Rs. 42, 90 lakhs)

The increase is mainly due to grant of permanent travelling allowance and dearness allowance at enhanced rates, absorption of state vaccinators and their peons, and larger expenditure on Village Water Supply Works.

40-Agriculture (+ Rs. 1,28 59 lakhs)

The increased expenditure is mainly on account of the larger amounts required in connection with seed, manure and other schemes. It is also due to revision of pay-scales and increased rates of dearness allowance. Further, there was an increase of expenditure on account of merger of state areas.

The increase is mainly due to merger of states, additional provision required for Sarvodaya schemes and Lift Irrigation schemes and higher rates of dearness allowance, etc.

47-Miscellaneous Departments (+ Rs. 1,20. 67 lakhs)

The larger expenditure under this head is mainly due to (i) an increase in the State share of imported foodgrains, as the result of a larger allotment from the Centre for merged areas and of arrear payments for the previous year, and (ii) reintroduction of rationing in the districts and extension of rationing to certain places in the merged state areas.

54-Famine (+ Rs. 41.13 lakhs)

The increase is due to scarcity conditions and relief measures.

54-A-Political Pensions (+ Rs. 81.66 lakhs)

The expenditure recorded under this head relates to the privy purse of Rulers and allied cash allowances pertaining to the merged areas. The current year's revised estimate includes some arrear payments.

c56-Stationery and Printing (+ Rs. 48.15 lakhs)

The excess under this head is mainly due to large purchases of paper for election work, expenditure on merged state areas, revision of pay and allowances, purchases of machinery, introduction of a second shift at the Government Central Press, and expansion of the activities of the Yeravda Prison Press.

57-Miscellaneous (- Rs. 1,76.00 lakhs)

The decrease is mainly due to the fact that the budget provision of Rs. 2 crores on account of increased rates of dearness allowance has, in the revised estimates, been distributed under the respective major heads. This is partly counterbalanced by the increase in the grants-in-aid payable to mofussil municipalities on account of dearness allowances.

8. After taking into account the measures announced in the Budget Speech of the Hon'ble the Finance Minister, the receipts and expenditure for 1950-51 are estimated to be as follows :---

The individual estimates on which these figures are based provide for a full year's revenue or expenditure, as the case may be, in respect of the former Indian State territories which have merged in the State of Bombay.

There are certain important variations, under specific heads of receipts, **،** ، 9. between the budget estimates and the eight-monthly estimates of 1949-50. On' account of the introduction of total prohibition at the commencement of the next financial year, there is a decrease of Rs. 383.65 lakhs under VIII-Provincial Excise, the budget estimate being Rs. 113.23 lakhs as against the revised estimate of Rs. 496.88 lakhs. The estimate of Rs. 17,96.06 lakhs under XIII-Other Taxes and Duties includes an amount of Rs. 980.56 lakhs on account of receipts from sales tax (on commodities other than petrol) levied under the Bombay Sales Tax Act, 1946. The corresponding revised figure for the sales tax receipts of • the current year is Rs. 13,25.00 lakhs. The reduction involved (Rs. 3.44.44 lakhs) is consequent on certain restrictions which the new Constitution imposes on the levy of sales tax. The revised and budget estimates under LI-Extraordinary Receipts are Rs. 4,60.56 lakhs and Rs. 3,28.30 lakhs, respectively, The reduction of Rs. 132.26 lakhs in the budget is mainly due to the absence of a subvention from the Government of India for development purposes (apart from Rs. 33.12 lakhs for Grow More Food schemes). While the three items just mentioned involve a substantial reduction in the budget estimates as compared with the revised estimates of the current year, there are also certain counterbalancing items of improvement in the budget estimates. A "food bonus" of Rs. 145 lakhs, representing a subsidy from the Government of India based on the volume of procurement of foodgrains within the State, has been taken into account under the receipts head XXIX-Agriculture. It is provisionally estimated that an amount of Rs. 50 lakhs, including arrears, will be received next year from the Government of India as additional compensation to this Government for the loss involved in abstention from levy of sales tax on tobacco and tobacco products. This figure is included in the estimate under XIII-Other Taxes and Duties. The budget estimate of receipts from income-tax shows an improvement of Rs. 27.72 lakhs over the revised estimate of the current year. The subsidy from the Union Government on account of the merger of States is provisionally estimated to be Rs. 236 lakhs for 1950-51 as against Rs. 213 lakhs for the current year.

10. An amount of Rs. 4 crores is proposed to be withdrawn from the Post-War Reconstruction and Development Fund for purposes of financing capital expendi-For technical reasons of accounting, this amount appears both on the ture. receipts side and the expenditure side, viz. LII-A-Transfer from Revenue Reserve Fund, and 50-Civil Works and 52-A-Other Revenue Expenditure. Excluding this item, the total estimate of expenditure in the budget is Rs. $135 \cdot 69$ lakhs less than the corresponding revised estimate for the current year. While there is increased expenditure under certain heads, notably 29-Police (Rs. 47.19) lakhs) and 37-Education (Rs. 1,08.80 lakhs), there are substantial decreases under certain heads. The most important of these is a decrease of Rs. 300 lakhs[•] in the amount payable as the State share of the subsidu in respect of imported foodgrains. The reduction is based on the assumption that there will be a large curtailment in next year's allocation of imported foodgrains to the State. A contraction in the volume of the operations in the personal ledger accounts pertaining • to 40—Agriculture is responsible for a decrease of Rs. 106 lakhs, which is reflected in the lower estimate adopted for next year's expenditure under that head. The budget estimate under 54-Famine provides for more normal conditions than have been prevalent during the current year and is Rs. 79.24 lakhs less than the revised estimate. A relief of Rs. 43.48 lakhs to the revenue section of the budget, as compared with the revised estimates, has resulted from the fact that a larger number of items of special repairs to communications are proposed to be financed from the Provincial Road Fund.

11. The net capital expenditure which has been provided for in the budget and which has to be met from loans or funds is nearly Rs. 10 crores. As already stated, it is proposed to finance part of this expenditure by withdrawing Rs. 4 crores from the amounts earmarked for the Post-War Reconstruction Fund. The balance may have to be met by raising a development loan. Other reductions in the budget estimates of expenditure as compared with the 8-monthly estimates of the current year are largely due to the measures announced in the Budget Speech. 12. On the basis of the revised and budget figures referred to above, the estimated cash position of the different funds at the close of the year 1950-51 is as follows:---

1. Under Section 280 of the Constitution of India Act, 1950, the President of India has been empowered to constitute a Finance Commission within two years from the commencement of the Constitution and thereafter at the expiration of every fifth year or at such earlier time as the President considers necessary, to make recommendations to the President on the distribution between the Union and the States of the net proceeds of taxes which are to be, or may be, divided between them and the allocation between the States of the respective share of such proceeds. Pending the appointment of such a Finance Commission, an expert award has been made in regard to the allocation of receipts from income-tax between the various States. Under the award the share of income-tax allocable to the Bombay State remains 21 per cent. According to the intimation received from the Government of India the share of income-tax allocable to this State is 9,56,34 for the current year and 9,84,06 for the next year's Budget.

Revenue.

2. Ordinary Revenue.—The receipts under this head are inclusive of the portion of land revenue due to irrigation, which is subsequently transferred to the irrigation heads (XVII and XVIII). The increase in the current year's revised estimate and the next year's budget estimate is mainly due to receipts from merged States areas.

3. Sale proceeds of waste lands and redemption of land tax.—The receipts are of a fluctuating nature, depending upon the demand for land. The revised estimate is based on the current actuals.

4. Recoveries on account of survey and settlement charges.—These receipts are of a fluctuating nature. The current year's revised estimate is based on the past and current actuals. The increase in the next year's estimate is mainly due to the merger of States.

5. Recovery of cost of maintenance of boundary pillars.—These receipts are of a fluctuating nature and the revised estimate is based on the current actuals.

6. Recoveries of overpayments.—The estimates under this head relate to adjustment of excess payments debited to "7-Land Revenue" in the previous year. The current year's revised estimate is on the basis of the current actuals. The next year's budget estimate is based on the progress of past actuals.

7. Redemption of summary settlement cess.-The revised estimate is based on the current actuals.

8. Collection of payments for services rendered.—Recoveries on account of land acquisition work done on behalf of public bodies by the Consulting Surveyor's Department and the payments received for the the management of estates are accounted for under this head. The receipts are of a fluctuating nature. The revised estimate is on the basis of current actuals and the next year's budget estimate is based on the progress of past actuals.

9. Miscellaneous.—Receipts under this head include quarry fees, items of miscellaneous land revenue and the annual contribution from the Government of India in lieu of abatement of non-agricultural assessment on private lands used for the manufacture of salt. These receipts are of a fluctuating nature. The revised estimate is based on the current actuals and the next year's budget estimate is based on the progress of past actuals.

10. Deduct Refunds.—This is a fluctuating item. The current year's revised estimate is based on the current actuals and the next year's budget estimate is framed on the basis of past actuals.

Expenditure.

11. Charges of Administration.—The increase in the current year's revised estimate is mainly due to the merger of States, revised rates of allowances and larger expenditure incurred for acquisition and improvement of kend and village sites. The next year's budget estimate provides for normal expenditure of acquisition and improvement of land and village sites.

[°]12. Land Records.—The increase in the current year's revised estimate is mainly due to the merger of States, revised rates of dearness allowance and travelling allowance. The next year's budget estimate provides for expenditure on account of merged States for the full year.

13. Assignments and Compensations.—The increases in the current year's revised estimate and the next year's budget estimate are mainly on account of the new districts formed out of the merged States 'areas:

15. Country Spirits.—The increase in the current year's revised estimate is mainly due to higher auction bids during the current year. The decrease in the next year's budget is due to the prohibition policy of Government.

16. Country Fermented Liquor.—The increase in the current year's revised is chiefly due to higher bids realised at the current year's auction for toddy shops and booths and recovery of the licence fee. No budget estimates on this account have been framed for the next year owing to the prohibition policy of Government.

17. Wines and Spirits (foreign liquor other than Beer, medicated wines and commercial spirits).— The decrease in the current year's revised and the next year's budget estimates is mainly due to fall in the purchase of Indian-made foreign liquor by licensees as a result of the enhanced rates of duty.

18. Receipts from commercial spirits including denatured spirits and medicated wines.—The current year's revised estimate and next year's budget estimate are based on the progress of current year's actuals. The decrease is due to imposition of restrictions on the imports from outside and issues from distilleries of denatured spirits as a result of the prohibition policy of Government.

19. Opium.—The increase in the current year's revised estimate is due to higher receipts from merged state areas. The decrease in the next year's budget estimate is due to smaller number of permits in view of the prohibition policy.

20. Duties on Medical and Toilet preparations containing alcohol, opium, etc.—The increase in the current year's revised estimate is due to assessment duties raised in the beginning of this year and higher receipts from state areas. The assessment duties have since been revised and reduced and the reduction in the next year's estimate is due to this reason.

21. Hemp and other drugs.—The current year's revised estimate is based on the progress of current actuals and the increase is also due to receipts from state areas. Next year reduced permits will be issued in view of the prohibition policy.

22. *Receipts from Distilleries.*—The decrease in the current year's revised estimate is due to restrictions on the sale of potable spirits and ample stock of imported foreign liquor being available with the licensees. Next year's estimate takes into account receipts from preparation and sale of power alcohol.

23. Fines, confiscation and miscellaneous.—The next year's estimate is based after taking into account likely reduction due to prohibition policy.

24. Refunds.—The revised estimate of the current year is based on the current actuals.

Expenditure.

25. Superintendence.—The increase in the current year's revised and the next year's estimates is due to the increased activities of the Provincial Prohibition Board as a result of enforcement of the Prohibition Policy.

26. District Charges.—The increase in the current year's revised and the next year's budget estimates is due to (i) scheme for the development of Palm Products and Nira and (ii) employment of additional • establishment for merged state areas and other districts.

27. Distilleries.—The decrease in the current year's revised estimate is due to restriction on manufacture and issues of foreign liquor and progressive closure of the distilleries as a result of the prohibition policy. Next year's estimate takes into account increased expenditure on purchase of liquid molasses for preparation of power alcohol.

28. Departmental and Commission Shops.—The decrease in the current year's revised and the next year's estimates is due to closure of some of the departmental depots and shops due to prohibition.

29. Purchase of Ganja and other drugs.—The current year's revised estimate is based on the past actuals. The decrease in the next year's budget estimate is due to the prohibition policy.

. 33. Timber and other produce removed from the forest by Government Agency.—The increase in the current year's revised is due to (i) sale of pre-empted timber in North Eastern Circle, (ii) extra production of teak and Jungle wood logs and sleepers and (iii) sale of firewood and charcoal and grass supplied to scarcity areas. The increase in the next year's budget estimate as compared with this year's revised is mainly due to pre-emption of timber in Thana Division and the sale of Sandalwood.

34. Timber and other produce removed from the forests by consumers and purchasers.—The increase in the current year's revised estimate is mainly due to good prices realised for coupes, Kurans and minor forest produce farms. The increase in the next year's budget estimate as compared with the current year's revised is due to (i) merger of the State areas, (ii) revenue from cyclone damaged trees in Thana. Division and (iii) increased sale of bamboos and temburni leaves.

35. Revenue from the forests not managed by Government.—The increase in the current year's revised and next year's budget estimate is mainly due to recovery of Judi on material removed from Inam Forests.

36. Miscellaneous.—The increase in the current year's revised estimate is due to (i) recovery of fines for breach of agreement terms and extension fees, (ii) recovery of second bonus paid to subordinates in 1947-48 and (iii) recovery of shipping expenditure incurred by Government on behalf of the Assistant Housing Commissioner. The increase in the next year's budget estimate over the current year's budget estimate is on account of merger of States.

Expenditure.

37. General Direction.—The decrease in this year's revised and the next year's budget estimate is due to the fact that no student from 1949 onwards has been or will be sent to the forestry college at Coimbatore or Dehru Dun for training as a new College has now been opened at Dharwar.

38. Conservancy and Works.—The increase in the current year's revised estimate is due to (i) increased production of teak, hardwood logs and sleepers, (ii) expenditure on account of the enumeration of cyclone damaged trees, (iii) payment of bonus to Khatedars of Malki teak, (iv) increased payment of Khoti share bills in Central Circle and (v) acquisition of a depot plot at Karjat. The next year's budget estimate provides for (i) higher rates for extraction and delivery of timber, sleepers etc. from the departmental contracts, (ii) expenditure on work for improvement of water supply at Dandeli, (iii) pre-emption of Timber and (iv) merger of State areas.

39. Establishments.—The increase in the current year's revised and the next year's budget estimate is due to absorption of officers and staff of the merged State areas.

•• 40. Feet-War Reconstruction and Development Programme.—Variations under this minor head have been explained in the separate issue of Post-War Reconstruction and Development Programme Estimates.

Revenue.

41. The increase in the current year's revised estimate and the budget estimate for the next year over the budget estimate of the current year is mainly on account of receipts anticipated from the merged State areas, partly counterbalanced by less receipts due to fall in the registration of documents consequent on the application of the Agricultural Debtors' Relief Act, Bombay Tenancy and Agricultural Lands Act and the Transfer of Property Ordinance.

Expenditure.

42. The increase in the current year's revised estimate and the next year's budget estimate over the budget estimate of the current year is mainly on account of (i) re-organisation of the office of the Inspector General of Registration consequent upon the merger of States, and (ii) opening of sub-registries in the merged State areas.

Revenue.

43. Receipts under the Indian Motor Vehicles Acts.—The increase in the revised estimate of the current financial year and the budget estimate for the next year over the budget estimate. of the current is due to (1) fees recoverable in the case of appeals and copies of documents, (2) fees recoverable in the respect of vehicles from merged States and (3) registration of a large number of new vehicles.

44. Receipts under the Provincial Motor Vehicles Taxation Act.—The increase in the current year's revised estimate is due to the tax recoverable on new motor vehicles, and on the vehicles previously registered in the States which have now merged in this Province.

45. Fees and other receipts (Indian Motor Vehicles Act).—The increase in the provision for the next financial year over the budget estimate of the current year is due to fees recoverable on vehicles from the States merged in this Province.

Expenditure.

46. Charges of Collection.—The increase in the revised estimate of the current year over the budget estimate of the current year is due to the increase in the staff and the establishment of the offices of Regional Transport Officer and Assistant Regional Transport Officer at Baroda and Kolhapur respectively. The decrease in the next year's budget is due to the fact that certain temporary establishment is not expected to continue next year.

47. Inspection of Motor Vehicles.—The increase in the revised estimate of the current year and the budget estimate for the next year over the budget estimate of the current year is due to the establishment of the offices of R. T. O. and Assistant R. T. O. at Baroda and Kolhapur respectively, and the sanction of additional staff.

48. Transfer to the Provincial Road Fund.—Provision on account of the amount transferred to the Provincial Road Fund under section 9 (3) of the Bombay Motor Vehicles Tax Act, 1935, is made under this head. It depends upon the receipts under the Act and the cost of the transfer as shown below :—

Revenue.

49. Receipts from Electricity Duties.—The increase in the current year's revised estimate and the next year's budget estimate is mainly due to the merger of States.

50. Receipts from Tobacco Duties.—The Government of India imposed Central Excise. Duty on tobacco with effect from 1st April 1943, and as compensation for the complete withdrawal and abstention from all forms of taxation on this commodity within the Province offered the Government of Bombay an annual sum of Rs. 29 lakhs for a period of five years at the end of which the position was to be reviewed. The offer was accepted by this Government and a compensation of Rs. 29 lakhs was being paid till 1948-49. This Government has, however, represented to the Government of India for a review of this compensation with a view to increase it and it is anticipated that the compensation will be increased to some extent with effect from 1949-50. The next year's budget estimate includes the increased compensation and the arrears for the year 1949-50.

51. Receipts under the Sales Tax Acts.—The current year's revised estimate is based on the current actuals. The increase has been partly contributed by the merger of States. The decrease in the next year's budget estimate is due to certain constitutional restrictions on the levy of sales tax under article 286 of the constitution.

52. Prize competitions.—The current year's revised estimate is based on the current actuals and the next year's budget estimate is on the basis of progress of past actuals.

53. Receipts under the Bombay Sugarcane Cess Act, 1948.—The increase in the current year's revised estimate is mainly due to the recoveries of arrears of the sugarcane cess for the period from 1st January 1948 to 31st March 1949, during the current year, which also explains for the decrease in the next year's estimate compared with the current year's revised estimate. The increase in the next year's budget compared with the current year's budget is to a certain extent attributable to the merger of States.

54. Newspaper Advertisement Tax.—The revised estimate is based on the current actuals. The decrease in the next year's budget is mainly due to exemption from the tax granted in the case of certain classes of advertisements appearing in specified categories of newspapers.

Expenditure.

55. Collection charges—Sales Tax.—The increases in the current year's revised estimate and the next year's budget estimate are mainly due to the inclusion of provision on account of the merged States areas.

56. Transfer to the State Sugarcane Cess Fund.—The figures represent amounts of receipts of the sugarcane cess transferred to the State Sugarcane Cess Fund after deduction of collection charges. The increase in the current year's revised estimate is due to the collection of arrears of the sugarcane cess for the period 1st January 1948 to 31st March 1949 during the current year. Hence there is a larger amount to be transferred during the current year than in the next.

NOTE ON THE SYSTEM OF CAPITAL AND NON-CAPITAL ACCOUNTS OF IRRIGATION WORKS.

57. Irrigation works are divided into two main categories (1) works for which capital accounts are kept and (2) works for which capital accounts are not kept. All irrigation works, for which it is both desirable and possible to maintain accounts on a quasi-commercial basis, are included in the former category and those for which the maintenance of such accounts is unnecessary, either because they produce little or no revenue or because owing to their restricted size, it is not worthwhile examining the returns paid by each individual work, are put in the latter class. The important criterion in the case of a quasi-commercial undertaking is whether the work is remunerative or the reverse and it is, therefore, essential for this class of works to maintain a capital account, since it is only by reference to the amount of capital expended that the value of the results can be determined.

58. The works for which capital accounts are kept are divided into (A) Irrigation and (B) Navigation, Embankment and Drainage Works separately, each of which is again sub-divided into (1) Productive and (2) Unproductive Works.

59. The initial expenditure on the construction of an irrigation project for which capital accounts are kept is charged to the capital account of that project and such further expenditure effer its completion as is necessary for the full development of the scheme is also added to that account.

60. The capital ivested on the work includes (1) direct charges, i.e., cost of works, establishment, tools and plant and pensionary charges, (2) indirect charges, i.e., capitalised value of abatement of revenue from land occupied by works and audit charges, and (3) all arrears of simple interest, if any, i.e., balance of total interest over net revenue. This capital cost is commonly known as "sum-at-charge".

61. As soon as a work begins to earn revenue, a Revenue Account is opened for it. The revenue derived from the works credited to that account and annual maintenance charges are debited to it. The difference between this gross revenue earned and the maintenance charges is the net revenue of the work.

62. If the net revenue from a capital work is expected to repay after ten years from its completion, the annual interest charges on the capital invested, i.e., sum-at-charge, at 4 per cent. or at such other rate as may be fixed by Government from time to time, the work is considered as "Productive"; otherwise it is treated as "Unproductive". If any productive work for which a capital account is kept fails at any time after the expiry of ten years from its completion in three successive years to yield the relevant return, it is transferred to the unproductive class. Similarly, if a work though classed as unproductive succeeds in yielding for three successive years the relevant return prescribed for a productive work, it is transferred to the productive class. The same principle applies to all extensions and improvements of an existing work.

63. The capital expenditure on irrigation works is booked in the accounts under one major head, viz., "68, Construction of Irrigation, Navigation, Embankment and Drainage Works". Funds for works may be provided from ordinary revenues, Famine Fund or from other sources outside the revenue of which the most important is loans, but the expenditure is booked under one major head "68" only. This major head is, however, intended to include only expenditure incurred from sources outside the revenue and it is therefore necessary to deduct from this head the capital expenditure defrayed from general revenues and to show it in the revenue section of the accounts. There will thus be two deductions in lump sums at the foot of the account of the major head "68", and the amounts thus deducted from this head are booked, without details of works under the major head "19A, Financed from Famine Relief Fund" and "B—Financed from Ordinary Revenues" according to the sources from which funds are provided. The net total of the major head "68" after the deductions referred to above have been made, represents that portion of the capital expenditure on irrigation works which is financed from sources outside the ordinary revenues.

64. The revenue derived from irrigation works for which capital accounts are kept and the annual expenditure on maintenance and working expenses on these works are respectively credited and debited to the revenue accounts of those works under a separate revenue head "XVII-Irrigation, Navigation, Embankment and Drainage Works for which Capital Accounts are kept", the divisions and sub-divisions of this account also being the same as those under the corresponding capital expenditure head "68".

65. In the budget estimates of revenue for Irrigation Works under "XVII", the working expenses and maintenance charges of capital works are shown by a *minus* entry under gross revenue in order to show the estimated net revenue, as the essential matter is the net and not gross revenue. Although these working expenses are shown under the receipt head, they are, of course, treated in all respects as ordinary expenditure; they are subject to the same rules and conditions and, as in the case of other outlay, are included in the demand for grants.

66. There is one more *minus* entry to be made in the budget estimates of revenue under the head "XVII" before the net revenue is shown and that is "refunds of revenue".

67. The interest on capital outlay is shown under the head "17, Interest on Works for which Capital Accounts are kept".

68. The second division of irrigation works, viz., works for which capital accounts are not kept includes a very large number of works which, while collectively of great importance, are individually No-II Bk H 2003-5a


too small to make it worthwhile to maintain separate accounts for each. All expenditure upon such works-whether upon the construction of new works or upon extensions or improvements, maintenance or repairs of existing works-is accounted for under one major head "18, Other Revenue Expenditure". Since the works under this class are on a non-commercial basis and no capital accounts are kept for them, there is no object in treating maintenance charges as a minus entry under revenue as in the case of quasicommercial works, and therefore, they are shown under the expenditure head "18". The only comparison kere possible is that between the gross revenue (shown under revenue head "XVIII") and the total expenditure of all kinds. In this division is also booked, under a separate sub-head "Miscellaneous expenditure", all expenditure upon the preliminary surveys of new projects and also the cost of famine survey's required for the preparation of the famine programme. (The works in this division are financed from ordinary revenues of the year. Those works which have a protective aspect as will as surveys for the preparation of famine programme may be financed from the Famine Relief Fund.) The whole of the expenditure on all works under this class is, however, to be booked in the first instance under one major head "18" without reference to the source from which the funds are provided and it is necessary, therefore, as in the case of the major head "68" for capital works, to deduct at the foot of the account of the major head "18" a lump sum showing the amount financed from the Famine Relief Fund, the residue representing the amount financed from ordinary revenues. The amount deducted from this head is booked without details under a separate major head "18(1), Other Revenue Expenditure financed from Famine Fund ".

69. The revenues earned by this class of works are shown under the revenue head "XVIII-Irrigation, Navigation, Embankment and Drainage Works for which no Capital Accounts are kept" and the refunds of revenue are deducted from the gross receipts in order to show the net revenue for the works.

Definitions 1.—" Capital Works" are works for which capital and revenue accounts are kept on a quasi-commercial basis. The capital expenditure is accounted for under the head "68". Revenue realised from them is credited to the head "XVII".

2.—" Non-Capital Works" are works for which individually neither capital nor revenue accounts are kept because they produce little or no revenue owing to their restricted size. The expenditure on these is accounted for under the head "18". Revenue realised from them is credited to the head "XVIII".

NOTE SHOWING THE MAIN IRRIGATION WORKS COMPLETED.

• 70. Cultivation in this Province depends chiefly upon rainfall, and advantage is taken of irrigation mainly for growing valuable crops (e.g., sugarcane) or to counteract the effects of drought. The larger irrigation schemes necessarily involve the construction of storage reservoirs on rivers for feeding the canals supplying water to the irrigated areas. The principal irrigation works are mentioned below.

71. Lower Panjhra River Works, Kadwa River Works and Krishna Canals.—The oldest of the Govefnment irrigation works in the Deccan are the Panjhra River Works in Khandesh. They date from 1851-52 and were constructed at a cost of about 5 lakhs of rupees. Next to these among many small works are the Kadwa River Works in the Nasik District and the Krishna Canal in Satara District which came into operation in 1869. They were constructed at a cost of about Rs. 101 lakhs and Rs. 91 lakhs respectively.

72. Mutha Canals.—The Mutha Canals system consist of a large storage reservoir called Lake. Fife, on the Mutha River at Khadakwasla near Poona, and two canals, the Mutha Right and Left Bank Canals. It came into operation in 1874–75 and has cost about 70 lakhs of rupees.

73. Ekruk Tank and the Hathmati Canal.—The Ekruk Tank in the Sholapur District and the Hathmati Canal (which was the first and is still the most important work in Gujarat) came into operation in 1872–73 and 1873–84 and about $13\frac{1}{2}$ and $13\frac{1}{4}$ lakhs of rupees, respectively, have been spent on them.

74. Nira Right and Left Bank Canals.—The Nira Right and Left Bank Canals in the Poona and Sholapur Districts receive their supply partly from the Nira River and partly from the reservoir at Bhatgar (called Lake Whiting) on one of the tributaries of that river. The Left Bank Canal was opened in 1885 and has cost about 147 lakhs of rupees (including Shetphal Tank). The Right Bank Canal was opened in 1924 and has cost about 412 lakhs of rupees.

75. Gokak Canal.—The Gokak Canal in the Belgaum District is a small canal taking off direct from above a weir on the Ghataprabha River without a storage work. It was opened in 1884 and over Rs. 15½ lakhs have been spent on it.

76. Girna Canal.—The Girna Canal in the Nasik District is fed from the Chankapur Tank. It was constructed at a cost of Rs. 20²/₄ lakhs and was opened for irrigation in 1909.

77. Godavari Canals.—The Godavari Canals system includes a storage reservoir (Lake Beale) on the Darna River and pick-up-weir at Nandur-Madhmeshwar on the Godavari from which take off the Right and Left Bank Canals. This project has cost about 106 lakhs of rupees and was brought into operation in 1912. The canals irrigate lands in Nasik and Ahmednagar Districts.

78. Pravara River Works.—The Pravara River Works system comprises (i) a storage reservoir, called Lake Arthur Hill, in the Ahmednagar District on the Pravara River at Bhandardara, (ii) a pick-upweir at Ojhar and (iii) two canals named the Pravara Right and Left Bank Canals. The project was sanctioned by the Government of India in 1907. Work was commenced in 1908 and both the dam and the canals have been completed. The capital cost of the whole scheme, including the dam, amounts to over Rs. 151 lakhs. The masonry dam or the storage reservoir is 274 feet high above the river bed at its highest point and about 1,600 feet in length. It is one of the highest dams in the world.

79. In addition to the above schemes, there are many other small canals and tanks which collectively irrigate large areas of lands.

81. The revenue derived from irrigation works for which capital accounts are kept is classified under two heads, viz. (a) direct receipts and (b) that portion of the land revenue which is credited to irrigation. The former head includes the sale proceeds of water supplied for irrigational and non-irrigational purposes, the cale proceeds from canal plantations and other canal produce (e.g., wood, grass etc.), while the latter represents the irrigation share of land revenue.

82. The working expenses of the works for which capital accounts are kept are deducted from the total receipts under the two heads mentioned above, in order to show the 'net revenue 'earned.

83. The figures of gross and net revenue for the years 1948-49 and 1949-50 and the budget estimate for the year 1950-51 are shown below :---

The expenditure under this head is deducted from the expenditure under "22, Interest" under which provision is made for interest charges on the consolidated debt including irrigation debt. For computing the interest on capital outlay on irrigation works, the capital outlay is looked on as irreducible, unlike debt which is usually redeemable after a fixed term of years; capital outlay can only increase and never diminish, whereas debt may be completely repaid.

100. Interest received by the Local Government on advances and loans made through the Provincial Loans and Advances Accounts (to agriculturists, local bodies, Presidency Corporations, etc.), is credited to "XX-Interest". ------

101: (1) Interest on loans to Presidency Corporations .- The decrease in the next year's budget estimate "is due to repayment of capital during the current year.

(2) Interest on other loans and advances by the Provincial Government.-The current year's revised estimate and next year's budget estimate are based on the progress of actuals and the estimates of Departmental officers.

(4) Interest realised on investment of Provincial balances .- The increase in the current year's revised estimate and next year's budget estimate, is due to receipts of interest on securities accrued to State of Bombay, consequent upon merger of Baroda, Kolhapur, Janjira and other Deccan and Gujarat States. These interest receipts are expected to be about Rs. 10 lakhs during the current financial year and Rs. 15 lakhs during the next financial year. These increases are partly counterbalanced by smaller investments in Treasury Bills by the State of Bombay.

104 Sinking Funds.—Under this minor head are recorded the amounts appropriated from revenue for maintaining a Sinking Fund and a Depreciation Fund, in respect of the loans floated by the State Government-

(a) 3 per cent. Bombay Government Loan, 1955.—The annual contribution (5,31) to the Depreciation Fund is provided at 12 per cent. of the total nominal amount (3,54,23) of the loan. The fund is to be used, if necessary, for purchasing securities of the loan for cancellation.

It has been decided that the minimum contribution to the Sinking Fund in any one year should be such that together with the amount put in the Depreciation Fund, it should suffice to liquidate the loan in 20 years. The maximum contribution to the Sinking Fund should be related to amortisation of the loan on 13 years' basis. Provision was made for the contribution to the Sinking Fund of the maximum amount, viz. 19,65 till the year 1948-49. An amount which together with the accumulation in the Sinking Fund till 1948-49 would be adequate to redeem the loan on maturity had been contributed to the Debt Redemption and Avoidance Fund. In view of this it had been decided not to make any further contribution to the Sinking Fund from 1950-51.

(b) 3 per cent. Bombay Government Loan, 1956.—Provision for the Depreciation Fund contribution (5,25) is made at $1\frac{1}{2}$ per cent. of the total nominal amount (3,50,00) of the loan, and the Fund is to be used, if necessary, for purchasing securities of the loan for cancellation.

The decision regarding contribution to the Sinking Fund referred to above applies to this loan also, for the same reason.

(c) 3 per cent. Bombay Government Loan, 1958.—Provision for the Depreciation Fund contribution (5,16) is made at 11 per cent. of the total nominal amount (3,44,00) of the loan and the Fund is to be used, if necessary, for purchasing securities of the loan for cancellation.

The decision regarding contribution to the Sinking Fund referred to above applies to this loan also, for the same reason.

(d) 3 per cent. Bombay Provincial Development Loan, 1962.—The annual contribution (9,00) to the Depreciation Fund is provided at 1½ per cent. of the total nominal amount (6,00,15) of loan. The fund is to be used, if necessary, for purchasing securities of this loan for cancellation.

It has been decided that the maximum contribution to the Sinking Fund in any one year should be such that together with the amount put in the Depreciation Fund, it should suffice to liquidate the loan in 13 years. Provision for contribution to Sinking Fund in the year 1950-51 is made on these basis.

105. Other Appropriations.—Under this minor head are recorded the amounts appropriated from revenue for reduction or Avoidance of debt other than specific appropriations for regularly constituted. Sinking Funds :—

(i) The consolidated debt referred to in paragraph 103 (8) under the head "22" is replivable by equated half-yearly instalments including principal and interest over 45 years commencing from 1937. The principal portion of the instalments is debitable to the head "23". The increase in next year's budget estimate is due to decreasing amount of interest included in successive equated instalments on account of progressive reduction of the principal outstanding.

(ii) With effect from the year 1944-45, a fund called the "Debt Redemption and Avoidance Fund" has been created with a view to accelerate the rate of amortisation of the three public loans of this Government and to provide for repayment in 1960 of the whole, or as large a part as practicable, of the balance of the consolidated debt then outstanding. It was decided to make contributions to the Fund from revenue at the rate of Rs. two crores per annum for five consecutive years. The last contribution was made in the year 1948-49. The Fund may, in certain circumstances, be utilised for the avoidance of new debt. The contributions to the Fund are suitably invested.

106. Transfers.—Deduct.--The consolidated debt mentioned above includes three long-dated loans of the Bombay Municipal Corporation, loans utilised to finance the expenditure under "83, Payments of Commuted Value of Pensions" and loans utilised to finance the Provincial loans and Advance Account. The reasons for showing repayments in respect of these loans as deduct entries under the head "23" are explained below :—

(i) The repayment made by the Bombay Municipal Corporation in respect of its long-dated loans is credited in the first instance to the head "Loans and Advances by Provincial Government" (receipt side) in the debt section, but in order to utilise it towards the repayment of the consolidated debt which is provided in gross under the minor head "B—Other Appropriations", a corresponding credit is given to this head by a deduct entry.

(ii) Part of the loans included in the consolidated debt has been utilised for expenditure under "83—Payments of commuted Value of Pensions." The expenditure debited to "83", is being written back to revenue by equated instalments including principal and interest over a period of 15 years by debit to "55" and by credit of the principal portion to the capital head "83" and of the interest portion to "22."

(*iii*) The consolidated debt includes the loans taken to finance the Provincial Loans and Advance Account. With effect from 1940-41 it has been decided to utilise towards repayment of the consolidated debt, recoveries arising from the operations of the Provincial Loans and Advance Account to the extent necessary to repay the principal portion of the outstanding Provincial Loans and Advance Account debt on 1st April 1937 over a period of 45 years, with interest at 41 per cent.

Expenditure.

107. Salary of the Governor.-- The decrease in the current year's revised estimate is due to voluntary surrender of 15 per cent. of the pay by His Excellency from November 1949. Pending receipt of further intimation the next year's budget estimate has been framed without taking this cut into account.

108. Secretarial staff of the Governor.— The decrease in the current year's revised estimate is mainly due to the non-utilization of the provision for leave salary.

109. Staff and Household of the Governor.— The increase in the current year's revised estimate is due to the debit in the current year's account under "Bodyguard Establishment" for some claim for the year 1947-48 which was under investigation. The increase in the next year's budget estimate as compared with the current year's revised estimate is due to the provision having been made for maximum grants admissible under the Governor's Allowances and Privileges Order 1950.

110. Expenditure from Contract Allowance.— The increases in the current year's revised and the next year's budget estimates are within the sanctioned maximum grant and take into account enhanced rates of dearness allowance.

111. Tour Expenses.— The decrease in the current year's revised and next year's budget estimates is due to the two Railway saloons being returned to the Railways resulting in saving in maintenance charges.

112. Ministers.— The increase in the current year's revised estimate is mainly due to the creation of two additional posts of Ministers and their personal staff, two additional Parliamentary Secretaries and their personal staff, extensive touring by the Honourable Ministers, enhanced rates of dearness and travelling allowances and provision for new cars for the Honourable Ministers.

The decrease in the next year's budget estimates as compared with the current year's revised estimate is due to the absence of provision for cars for the Honourable Ministers.

113. Provincial Legislative Assembly.— The increase in the current year's revised and the next year's budget estimates is mainly due to nomination of additional members from merged states and for postage stamps utilised by them.

114. Provincial Legislative Council.- The reasons given under "Provincial Legislative Assembly" applies in this case also.

115. Elections for Legislatures.— The decrease in the current year's revised estimate is due to the fact that the Government of India has agreed to pay to this Government the expenditure incurred on account of preparation for general elections. The increase in the next year's budget estimate is due to provision made for the general election.

116. Civil Secretariat.—The increase in the current year's revised estimate is due to additional establishment, enhanced rates of dearness allowance, and traveling allowance, increased expenditure on service postage stamps and telegrams due to heavy correspondence and to purchase of National flags for distribution in the Province for Independence Day Celebrations. The decrease in the next year's budget estimates as compared with the current year's revised is due to the absence of provision for purchase of National flags.

117. Public Service Commission.- The increase in the current year's revised and the next year's budget estimates is due to the appointment of Additional Member for the Commission, additional staff and enhanced rates of dearness and travelling allowances.

118. Settlement Commissioner and Director of Land Records.—The increase in the current year's revised estimate is due to extensive touring.

119. Local Fund Audit Establishment.—The increase in the current year's revised and the next year's budget estimate is due to the recovery of average cost of pay and dearness allowance at the revised rates and due to entertainment of additional staff.

120. Commissioners.—The increase in the current year's revised and the next year's budget estimates is due to additional staff and increased rates of dearness and travelling allowances.

121. District Administration.—The increase in the current year's revised and the next year's budget estimates is due to the merger of States and enhanced rates of dearness and travelling allowances.

122. Miscellaneous.—The decrease in the current year's revised estimate is due to less number of ξ . A. S. candidates allotted to this province than anticipated. The provision for the next year is tor 5 candidates.

123. Expenditure from Rural Reconstruction Grants.—The increase in the current years estimate is due to the merger of States and enhanced rates of dearness allowance and travelling allowance. The increase in the next year's budget estimate compared with the current year's revised is due to the full year's provision made for the staff for merged State areas, and increased provision under contingencies.

124. Post-War Reconstruction and Development Programme.—Vide explanation given in the Detailed Estimates and Explanatory Memorandum of the Post-War Reconstruction and Development Programme for the year, 1950-51.

125. Charges in England.—The increase in the current year's revised estimate is due to more officers going on leave to the United Kingdom.

The decrease in the next year's budget estimate as compared with the current year's revised estimate is due to lesser number of officers going on leave to the United Kingdom.

126. The increase in the revised estimate for the current year and the budget estimate for the next year is mainly under "General fees, fines and forfeiture", "Sale proceeds of unclaimed and escheated property" and "Miscellaneous fees and fines". The increase under the first minor head is due to larger receipts from Magisterial fines in profiteering cases and establishment of additional magisterial courts. The increase under the second minor head is due to establishment of additional civil and criminal courts and the increase under the third minor head is mainly due to larger cash receipts of the record rooms.

Expenditure.

127. A—High Court.—The increase in the current year's revised and the next year's budget estimate is mainly on account of (i) the additional staff sanctioned for Registrar's Office, (ii) revision of the rates of dearness and house rent allowance and (iii) increased expenditure under "Contingencies" due to high cost of stationery articles and railway charges.

128. B.- Law Officers.- The increase in the revised estimate for the current year and the budget estimate for the next year is mainly due to increase in the number of civil and criminal cases in mofussil Courts due to the merger of States, heavy fees paid to counsels engaged for conducting important cases, and provision for Law Officers and establishment under them for the new districts.

129. C.—Administrator General and Official Trustee.—The increase in the current year's revised and the next year's budget estimate is mainly on account of the revision of the rates of dearness allowance and additional establishment sanctioned.

130. F.—Coroner's Court.—The increase in the next year's budget estimate is mainly due to the revision of the payscale of the post of Uoroner.

131. G.—Presidency Magistrates' Courts.—The increase in the revised estimate is mainly due to (i) establishment of two additional Courts of Presidency Magistrates (ii) revised rates of dearness allowance and house rent allowance and (iii) increase in expenditure incurred on payment of road and diet money paid to witnesses.

The increase in the next year's budget estimate over the current year's revised is on account of establishment of a Presidency Magistrates' Court at Bombay Central for trying Railway Cases.

132. H.-Civil and Sessions Courts.-The increase in the revised estimate is mainly due to (i) establishment of additional Courts of District and Sessions Judges and Civil Judges in the newly created districts, (ii) bifurcation of the judicial Districts of Thana, and Broach and Panch Mahals, and (iii) revised rates of dearness allowance.

The next year's budget estimate includes full year's provision for staff in the merged areas.

133. I.—Courts of Small Causes.—The increase in the revised estimate is due to (i) the provision for continuance of 2 temporary Courts with requisite staff at the Court of Small Causes at Bombay (ii) creation of one additional Court at Bombay and (iii) revised rates of dearness allowance.

The next year's budget estimate includes provision for the Small Causes Court at Baroda.

134. J.—Criminal Courts.—The increase in the revised estimate is due to the revised rates of dearness allowance and increase in expenditure on payment of "Road and Diet money to witnesses."

The next year's estimate provides full year's provision for the newly created Courts of Resident Magistrates in merged areas.

135. L.—Charges in England.—The increase in the revised estimate is due to the fact that more officers than originally expected went on leave to the United Kingdom and provision for their leave salaries etc. had to be made subsequently.

The next year's estimate is based on the latest report received from the High Commissioner.

136. M.—Post-War Reconstruction and Development Programme.— See explanation in the "Detailed Estimates and Explanatory Memorandum of the Post-War Reconstruction and Development Programme for the year 1950-51.

137. Jails.—The decrease in the current year's revised and the next year's budget estimates is due to discontinuance of convict labour supplied to railways.

138. Jail Manufactures.—The increase in the current year's revised and the next year's budget estimates is mainly due to sale proceeds of jail made articles by jails in merged States and increased orders received for chappals, and carpets etc., by some Central Jails.

Expenditure.

139. Jails.—The increase in the current year's revised estimate is mainly due to increased staff on account of the merger of States, introduction of Jail reforms, increased populations in jails, higher rates of foodstuffs and grant of dearness allowance at higher rates. The decrease in the next year's budget estimate as compared with the current year's revised estimate is mainly under "Dietary Charges" in Presidency, and District Jails and Other Jails and Lockups, estimate for which for next year has been reduced on the basis of actuals.

140. Jail Manufactures.—The increase in the current year's revised estimates is due to rise in prices of raw materials and larger requirements of clothing, dead stock articles, etc., on account of increased population in Jails. Most of this type of expenditure is of a non-recurring nature and is not expected to be provided for in next year.

143. Receipts and recoveries on account of Presidency Police. - The estimates under this head arcs of a fluctuating nature and have been framed on the basis of progress of current and past actuals.

144. Cash receipts under the Arms Act .- The increase in the revised estimate for the current year is due to the addition of seven more districts created out of the merged states and the issue of more arms licences.

145. Fees, Fines and Forfeitures .- The increase in the current year's revised and next year's budget estimate is due to the enhanced rate of license fee under the Public Conveyance Act.



161. The increase in the current year's revised estimate is mainly due to (i) anticipated expenditure on pre-empted timber and collection of seed under "B-Forests" and (ii) provision included on account of additional establishment in the Collector's office under "D-General Administration".

165. A—University.—The increase in the revised estimates of the current year and the budge estimates for the next year is mainly due to the increased rates of fees and the rise in the number of students consequent on the merger of State Colleges in the Province. The decrease in the next year's budget as compared with the current year's revised is due to expectation of smaller attendance of students.

166. B—Secondary.—The increase in the revised estimates of the current year and the budget estimates for the next year is mainly due to the increased rates of fees and the merger of State Secondary Schools in this Province.

167. C—Primary.—The increase in the revised estimates as compared with the budget estimates of the current year is due to the fees being charged in the upper standards of Primary Schools in Baroda merged areas. The absence of provision under budget estimates for 1950-51 under this head is due to the fact that no receipts are expected as the Primary schools are expected to be handed over to the Local Bodies in the merged areas next year.

168. D-Special.-The increase in the revised estimates compared with the budget estimates of the current year is mainly due to---

(i) the increased rates of fees in training schools and the Architectural Section of the School of Art and;

(ii) duplication of classes in the Architectural Section of the Art School. The decrease in the next year's budget estimate as compared with the revised estimate of the current year is due to the fact that next year fees from duplication classes of Architectural Section of Arts Schools have not been taken into account as these classes have been sanctioned for one year.

169. E-General.—The increase in the revised estimates as compared with the current year's budget estimate is mainly due to the subsidy of Rs. 10,36 sanctioned by the Government of India for Social Education and due to the larger amounts of recoveries likely to be effected from the advance grants paid to the local authorities. The decrease in the next year's budget estimates as compared with the current year's revised estimates is mainly due to the fact that the subsidy from the Government of India is for the current year only and it is not likely to make recoveries of advance grants from local Authorities next year on the same scale as in the current year.

Expenditure.

170. A—University.—The increase in the revised estimates compared with the budget estimates of the current year is mainly due—

- (1) to the payment of the additional grants to Universities;
- (2) to grants to the Deccan College Post-Graduate and Research Institute; and
- (3) to the additional staff, and grants for Government colleges including those in state areas.

The increase in the next year's budget estimates compared with the revised estimates for the current year is mainly due to the additional provisions made on account of grants to the Baroda University and colleges and new item No. 12 Post-War Reconstruction.

171. B—Secondary.—The increase in the revised estimate over current year's budget estimate is on account of secondary schools in the merged State areas and enhanced rates of dearness allowance partly counterbalanced by the savings due to the transfer to the Government Anglo-Urdu High Schools to private agencies and award of Free-studentships to children of poor classes. The increase in the next year's budget compared with current year's revised estimate is on account of additional provision of grants to non-Government secondary schools mainly on account of Secondary Schools from merged State areas and new item Nos. 41, 42 and 8, 14, Post-War Reconstruction.

estimates is mainly due to—

(1) the payment to primary teachers in the merged State areas according to the revised rates of pay and dearness allowance;

(2) the payment of grants to approved schools in merged State areas; and

(3) the payment of grants for construction of schools buildings in the new districts added to this Province.

The increase in the next year's budget is on account of (1) additional provision for grants for opening of schools in schoolless villages with a population of 700 to 1,000; (2) grants for introduction of compulsory elementary education in all places with a population of 1,000 and; over and (3) introduction of elementary education in Backward areas in Thana District; (4) grants to Local Authorities on account of Craft Education partly counterbalanced by a reduction in grants for the construction of Primary School buildings and (5) mainly due to the additional provision made for grants to Local Bodies for Primary Education in merged State areas.

173. D—Special.—The increase in the revised estimates compared with the budget estimates of the current year is mainly due to the grant of enhanced rates of dearness allowance and larger expenditure; (1) on payment of additional grants to (a) Physical Education Association and Gymnasia, (b) pre-primary schools, (c) training institutions; and (2) on visiting staff an other establishment of the School of Art. It is also due to expenditure on short-term courses in Physical Education having been debited to this head. The increase in the next year's budget compared with the current year's budget is mainly due to the increased expenditure on (1) training schools; (2) Grants for Special Education; (3) Social Education; and (4) Sir J. J. School of Art.

174. E-General.—The increase in the revised estimate compared with the budget estimates of the current year is mainly due to the excess of expenditure (1) in the office of the Director of Public Instruction on account of (a) additional post of Deputy Director and (b) the staff sanctioned owing to merger of States and (2) grant of enhanced rates of dearness allowance; (3) revision of pay-scales under Inspectoral staff; (4) appointment of the Secondary School Certificate Examination Inquiry (committee and (5) opening of additional hostels for Backward Classes and the increase in the value of stipends to Backward Class teachers under Training counterbalanced by savings due to the reduced expenditure on printing and publication of Departmental Text Books and on account of educational concessions to children of Ex-service personnel.

The increase in the next year's budget estimates as compared with the revised budget estimates is on account of (1) additional grants to the institutions in merged State areas, (2) additional grants to libraries, etc., on account of merged State areas.

175. F-Charges in England.—The increase in the revised estimates and the next year's budget estimates compared with the current year's estimates is due to the increase in expenditure on account of stores and Government Scholarships.

176. Medical School and College fees.—The increase in the current year's revised and the next year's o budget estimates is due to increase in fees and also due to increase in the number of students.

177. Hospital Receipts.—The increase in the current year's revised and the next year's budget estimates is mainly due to receipts from merged States.

178. Mental Hospital Receipts.—The increase in the current year's revised and the next year's budget estimate is due to increase in the number of patients and the rates of maintenance charges.

179. Bacteriological Laboratory Receipts.—The decrease in the current year's revised and the next year's budget estimates is due to less demand for vaccines.

180 Contributions.—The increase in the current year's revised and the next year's budget estimates is mainly due to receipts from merged States.

181. Recoveries of Overpayments.—The increase in the current year's revised estimate is due to recovery of the excess grants drawn by Nursing Associations.

182. Miscellaneous.—The increase in the current year's revised and the next year's budget estimates, is mainly due to larger receipts realised under the Drugs Act. It also includes receipts from the Merged States.

183. Transfer from Special Development Fund.—The estimate under this head is equal to the expenditure on Schemes under "Special Development Programme" under "38, Medical".

Expenditure.

184. A—Medical Establishment.—The increase in the current year's revised and the next year's budget estimates is mainly due to (i) revision of pay scales and allowances of Gazetted Officers and (ii) additional establishment sanctioned.

185. B—Hospitals and Dispensaries.—The increase in the current year's revised estimate is due to (i) revision of pay-scales and allowances of gazetted officers, (ii) additional establishment sanctioned in consequence of the merger of States, (iii) higher prices of supplies, (iv) additional grants sanctioned to certain Hospitals and Schemes and (v) payment of dearness allowance at enhanced rates.

The increase in the next year's budget estimate as compared with the current year's revised estimate is due to (i) additional establishment sanctioned mainly in consequence of the merger of several States (Please see New Item No. 54), and for the improvement in Nursing Services at Government Hospitals (New Item No. 50), (ii) payment of grant to the Society for the Rehabilitation of Disabled and crippled children for maintenance of a Children's Orthopaedic Hospital (New Item No. 51) (iii) purchase of surgical and other equipment in Government hospitals (New Item No. 56) and (iv) larger expenditure on (a) medicines and instruments and (b) diet to patients under contingencies.

186. C—Grants for Medical Purposes.—The increase in the current year's revised estimate is mainly due to the grants sanctined for mobile hospitals, B. C. G. Vaccination works for anti-tuberculosis campaign and mobile eye-clinic at Patan in Baroda State area.

187. D—Medical Schools and Colleges.—The increase in the current year's revised and the next year's budget estimate is mainly due to (i) additional establishment sanctioned, (ii) increased rates of dearness allowance and (iii) higher prices of supplies. The current year's revised also includes expenditure on deputation of candidates for Unani Courses in Tibbia College, Delhi.

188. E—Mental Hospitals.—The increase in the current year's revised and the next year's budget estimates is mainly due to (i) additional establishment sanctioned, (ii) revision of scales of pay and allowances of nurses and (iii) higher prices of supplies. The next year's estimate also takes into account a reduction in contingent expenditure on the basis of actuals.

189. F—Special Development Programme.—The decrease in the current year's revised estimate is mainly due to the delay in the opening of sub-centres of Village Medical Aid in Backward Class Areas. The next year's provision is intended for providing village Medical Aid to Backward Class Areas.

190. *H—Bacteriological Laboratories.*—The increase in the current year's revised estimate is mainly due to (*i*) increased rates of dearness allowance, (*ii*) higher prices of supplies and (*iii*) transfer of the expenditure pertaining to Nutrition Department to this head, from "47, Miscellaneous Departments".

The decrease in the next year's budget estimate as compared with the current year's budget and revised estimates is mainly due to reduced provision made under contingencies on the basis of the progress of past actuals.

191. I—Post-War Reconstruction and Development Programme.—The variations under this minor head have been explained separately in the Post-War Reconstruction and Development Programme Estimates.

192. J-Charges in England (Ordinary).—The revised estimate of the current year and the budget estimate of the next year represent the actual requirements of the High Commissioner.

193. Sale-proceeds of sera and vaccine.—The decrease in the current year's revised estimate and the," next year's budget estimate is mainly due to the decision to credit the sale-proceeds of sera and vaccine realised by Superintendent of Excise to "XXVII—Medical" instead of to this head.

194. Contributions.—The increase in the current year's revised estimate and the next year's budget estimate is mainly due to larger contributions for vaccination from local bodies in Baroda State Area.

195. Recoveries of overpayments.—The increase in the current year's revised estimate is based on the progress of actuals.

196. Transfer from the Special Development Fund.—The amount provided under this minor head corresponds to the estimated expenditure under "Special Development Programme" under "39, Public Health".

197. Miscellaneous.—Receipts from Government Water Works are credited under this head. The increase in the current year's revised estimate and the next year's budget estimate is mainly due to the receipts anticipated from Water Works in the merged States.

Expenditure.

193. Public Health Establishment.—The increase in the current year's revised estimate is due to (i) grant of permanent travelling and dearness allowances at the enhanced rates, (ii) absorption of the State Vaccinators and their peons, (iii) transfer of the expenditure pertaining to District Health Officers of Nasik, Ahmednagar, East Khandesh, West Khandesh, Satara and Dharwar to this head, from the head "Post-War Reconstruction and Development Programme". The increase is counterbalanced to some extent by larger recovery anticipated on account of percentage charges of establishment, as a result of a larger number of new deposit works taken up for execution by the Public Health Engineer.

The increase in the next year's budget estimate as compared with the current year's revised estimate, is mainly due to (i) anticipated smaller recovery of percentage charges of establishment as a result of a smaller number of new deposit works, expected to be taken up for execution by the Public Health Engineer and (ii) additional establishment sanctioned under the District Health officers' Scheme, in consequence of the merger of several States.

199. Grants for Public Health Purposes.—The increase in the current year's revised estimate is due to grants sanctioned during the current year by Government to various Associations and Societies doing Public Health Services.

The next year's budget estimate includes increased provision made for payment of rebate grant to Municipalities in respect of the works executed through the agency of the Public Work's Department. -

200. Expenses in connection with Epidemic Diseases.—The increase in the current year's revised estimate is mainly due to (i) payment of daily wages to Havildars and Sepoys etc. in Malaria Organisation at enhanced rates, and (ii) larger expenditure on plague and cholera vaccines due to prevalence of epidemics in several districts.

The increase in the next year's budget estimate as compared with the current year's revised estimate, is due to (i) extension of the Malaria Control Scheme to the districts of Panch Mahals and West Khanlesh (Please see New Item Nos. 63 and 64) and (ii) increased provision made for inoculation against Plague, Cholera and other epidemics. The increase is counterbalanced to some extent by (i) reduced provision made under contingencies for the Malaria Organisation, and (ii) transfer of the Scheme for distribution of quinine to Private Medical Practitioners, Hospitals, Dispensaries, etc. to "38-Medical".

201. Works.—The current year's revised estimate is framed on the progress of actuals. The next year's budget estimate includes (i) additional grant sanctioned for maintenance and repairs of various Government Water Works in the areas of merged States and (ii) the provision made for the Scheme for the supply of water to Leper colony at Kolhapur (Please see New Item No. 62).

202. Special Development Programme.—The current year's revised estimate is based on the progress of actuals.

203. Post-War Reconstruction and Development Programme.—The variations under this minor head have been explained separately in the Post-War Reconstruction and Development Programme Estimates.

204. Agricultural receipts .- The increase in the current year's revised estimates is due to the additional sale of farm produce at the experimental farms of the merged states. The increase in the next year's budget estimates-is mainly due to the receipt of the procurement food bonus from the Government of India.

205. Recoveries of overpayments .- The increase in the current year's revised estimate is mainly due to the repayment of the amount drawn by the Agricultural Engineer to Government for payment of . advance to District Local Board, Ahmedabad. The next year's budget estimates are based on the progress of recovery other than the one mentioned above made during the current year.

,206. Transfer from the Special Development Fund.-The amount provided under this minor head is equal to the estimated expenditure under "Special Development Programme " under " 40-Agriculture ", • • •

C-Subordinate and Expert Staff.-The increase in the current year's revised estimates and next year's budget estimates is mainly due to (i) inclusion of the additional staff sanctioned for merged state areas and (ii) increased rates of dearness allowance. - The next year's estimate provides for full year's cost for staff for merged areas.

210. - D-Experimental Farms .- The increase in the current year's revised estimate is due to the provision required for the farms of the merged states. The decrease in the next year's budget is. due to the transfer of the provision of Husbandry Section to "41-Veterinary".

211. E-Agricultural Demonstration and Propaganda.-The increase in the current year's revised estimates is due to (i) increased contingent expenditure due to additional staff for the merged areas, (ii) heavy loss in Personel Ledger Account in connection with Seed and Manure Schemes and (iii) provision for certain additional schemes not provided for in the current year's budget. The decrease in the next year's budget estimates is mainly due to reduced provision being made on account of loss in .P.L.A. in connection with Seeds and Manure Schemes. It is also due to the provision for loss of Groundnut Cake Scheme being shown in the Post-War Reconstruction estimates. 13,5

212. F-Agricultural Experiments and Research.—The increase in the current year's revised estimates. is mainly due to (i) revision of pay-scales and increased rates of dearness allowance and (ii) provision for certain Schemes not covered by the current year's budget provision. The decrease in the next year's budget estimate as compared with the current year's revised estimate is mainly due to the transfer of the provision for Animal Husbandry Section to "41-Vety.". It is also due to the abolition of some Schemes, viz. (i) Scheme for Research on small Millets, (ii) Scheme for sowing of grass-legumes and Sorgham Seeds, (iii) Seed Multiplication Scheme at the Cereal Breeding Station, Niphad and absence of expenditure for the schemes, (iv) Additional staff for the Central Laboratory under the Soil Physicist to Government, (v) additional staff for the extension of Mulegaon farm under the Dryfarming research station, Sholapur and (vi) Scheme for investigation of Band disease of Areca Palm.

G-Agricultural Education.-The increase in the current year's revised estimates is mainly due to Agricultural Schools of Baroda, Kolhapur and other merged states being taken over by this Government. The decrease in the next year's estimate as compared with the current year's revised estimate is due to the provision for these schools being made in the Post-War Reconstruction estimates. It is also due to the provision for Animal Husbandry Section being transferred to "41-Vety.".-

214. H-Agricultural Engineering .- The increase in the current year's revised estimate is mainly due to the purchase of engine drovers, oil engines, installation charges of electric fitting and pay and allowances of menials. The decrease in the next year's budget when compared with the current year's revised is mainly due to the absence of expenditure for purchase of oil engines, engine drovers etc. in the next year's budget.

215. J-Grant-in-aid contribution .--- The increase in the current year's revised estimate is due to (i) revision of pay-scales, (ii) increased rates of dearness allowance and (iii) provision for grant-in-aid to certain institutions for which no provision existed in the current year's budget. The decrease in the next year's budget is due to the transfer of the provision of Animal Husbandry Section to the head "41-Veterinary",

216. M-Special Development Programme.-The increase in the current year's estimate is due to the provision required for certain schemes sanctioned after the budget. The decrease in the next year's estimate is due to the transfer of the Animal Husbandry Section to the head "41-Veterinary".

218. Veterinary College and School Fees.-The decrease in the current year's revised estimate is due to smaller number of students attending the Bombay Veterinary College. Next year, better attendance of students is expected.

219. Other receipts.-The increase in the current year's revised estimate is due to (i) sale, proceeds of empty serum boxes and bottles, (ii) credit of donations received from the public of Kopargaon towards the construction of a Veterinary Dispensary and (iii) increased share of expenditure recovered from the Indian, Council of Agricultural' Research owing to the merger of Baroda State. 220. Transfer from the Deposit account of the Special Development Fund.-The estimates under this head correspond to the expenditure provided in the expenditure side.

221. Superintendence.—The increase in the current year's revised estimate is mainly due to . (i) increased expenditure on the purchase and carriage of Sera and Vaccines, (ii) the adjustment in the 'current year of the bills worth Rs. 81,500 for the previous year, (iii) grant of special pay to the Director ... and (iv) the merger of States. The decrease in the next year's budget estimate compared with the current year's revised estimates is accounted for by absence of provision for item (i) and (ii) above.

222. Veterinary Education and Research.—The increase in the next year's budget estimate as compared with the current year's budget and the revised estimate is due to inclusion of provisions on account of (i) experimental farms, (ii) office of the Poultry Development Officer, Poona and (iii) reorganisation of Poultry Development Section which have been transferred from 1950-51 from "40 Agriculture" to "41 Veterinary"

223. Sub-ordinate Establishment.—The decrease in the current year's revised is due to the fact that some posts of Veterinary Assistant Surgeons and Stockmen were not filled up during the current year. The increase in the next year's budget as compared with the current year's revised estimate is due to inclusion of provisions for (i) Animal Husbandry Section, (ii) Poultry Development Officer, Poona, and (iii) Dairy Development Officer, Poona, under "41 Veterinary".

224. Hospitals and Dispensaries.—The increase in the current year's revised and the next year's budget estimate is due to taking over of the Veterinary Dispensaries in the merged State areas.

225. Breeding Operations.--Various schemes under "Breeding Operations" have been transferred to "41---Veterinary" from "40--Agriculture".

226. Other Charges.—The increase in the next year's budget estimate as compared with the current year's budget and the revised estimate is mainly due to (i) scheme for introduction of breeding by artificial insemination for rapid improvement of livestock (vide New Item No. 73), (ii) taking over of the scheme for establishment of Laboratory for Wool Analysis at Patan, Baroda, (iii) expenditure on account of Veterinary Investigation Officer, Baroda, and (iv) grant-in-aid to Goshalas, Local Bodies: Associations, etc., hitherto shown under "40-Agriculture".

227. Special Development Programme.—The next year's budget estimate provides for expenditure on various schemes such as (i) scheme for establishment of centres for sheep farming and wool products in Backward Class Tracts in Bagalkot and Bijapur Talukas, (ii) scheme for establishment of Central Poultry Farms in Backward Tracts in Thana and West Khandesh Districts, (iii) scheme for supply of premium cows for Harijans in Satara District and (iv) scheme for supply of premium cows free of cost to Harijans in Sholapur District, hitherto shown under "40—Agriculture".

228. Post-War Reconstruction and Development Programme.—Variations under this minor head have been explained in the separate issue of Post-War Reconstruction and Development Programme Estimates.

229. Chargss in England.—The increase in the next year's budget estimate is due to (i) increased expenditure on books and periodicals and (ii) deputation pay and allowances, etc., to an officer of sheep-to-breeding section.

230. Audit fees.—The increase in the current year's revised and the next year's budget estimates is due to the increase in the number of co-operative societies.

231. Miscellaneous Receipts.—The increase in the next year's budget estimates is mainly due to larger receipts anticipated under "Receipt from Cottage Industries" on account of the provision for schemes thereunder [Item Nos. 76, 78, 79, 83, P. W. R. 39 and P. W. R. 46].

232. Transfer from the Special Development Fund.—The amounts provided under this head are equal to the estimated expenditure on Special Development Programme under "42-Co-operation","100

233. Direction.—The increase in the current year's revised estimate is due to the appointment of additional staff and increased rates of dearness allowance and travelling allowance and larger expenditure under "Contingencies". 234. Superintendence.—The increase in the current year's revised estimate and the next year's budget estimate is due to the merger of states and increased rates of dearness allowance and travelling allowance.

235. Grant-in-aid.—The increase in the current year's revised estimates is mainly due to Sarvodaya Scheme, Lift Irrigation scheme, Ahmednagar Housing Scheme, and merger of states. 236. Other charges.—The increase in the current year's revised and the next year's budget estimates is due to the merger of states and enhanced rates of dearness allowance and travelling allowance.

250. Deduct-Refunds.-The increase in the current year's revised is on account of refunds made under various civil supply schemes.

Expenditure. 251. Inspector of Factories.-The increase in the next year's budget estimates is due to (i) the extension of the Factories Act to the merged state areas and (ii) revision of the Act to extend its scope to all factories having 10 or more persons.

252. Labour.-The increase in the current year's revised is mainly due to ---

253. Miscellaneous.-The increase in the current year's revised estimate is due to (i) larger expenditure under "Capitation grants for Juveniles" "Dietary charges of children in Remand Homes" and "Grant-in-aid to the Children's-Aid Society" and additional staff sanctioned for the Industrial Schools,-(ii) larger provision on account of Provincial share of the subsidy payable to the Government of India on account of selling imported foodgrains as a result of lager allotments from the Centre for merged areas and arrear payment for the previous year, (iii) Re-introduction of Rationing in the districts and extension of the same to merged state areas and (iv) increase in the rate of dearness allowance.

The decrease in the next year's budget is mainly due to the reduction in the provision on account. of the "Provincial share of the subsidy payable to the Government of India on account of selling imported. foodgrains at the existing level of prices in the rationed towns "."

254. Government Transport Service.-The increase in the current year's revised and the next year's budget estimates is mainly due to larger expenditure under "Contingencies" owing to incease in the cost of tyres, tubes and spare parts of vehicles as a result of "Devaluation".

255. Post-War. Reconstruction-and Development Programms.-Vide explanations given in the Post-War Reconstruction and Development Estimates for the next year.

256. Special Development Programme .-... The decrease in the current year's revised and the next. year's budget estimates is due to Nil provision for "Subsidy to Backward Classes in connection with Building Societies to Individuals " partly counterbalanced by increase under "Contingencies " on account of grants to aided Backward Class Hostels in respect of pay and allowances of Superintendents and increase in the rates of stipends to the inmates of the B. C. Girls Hostels.

258. Rents.—The increase in next year's budget is due to inclusion of receipts from merged States for the full year.

259. Recoveries of Expenditure.—The increase in the revised estimate is due to recoveries of establishment and tools and plant charges on village water supply works and relief camp works for displaced persons, carried out through the agency of the Public Works Department.

260. Miscellaneous.—The increase in the revised estimate is due to larger receipts on account of the merger of States. The increase in next year's estimate is mainly due to anticipated receipts of 6,66 on account of donations for certain major works.

261. Transfers from Central Road Fund.—The estimates under this minor head are equal to the estimates of expenditure on "Works" and "Grant-in-aid" under "50-Civil Works" met from the Central Road Fund.

262. Transfers from Special Development Fund.—Special Development Fund has ceased to operate with effect from 1946-47 except in the case of tackward class schemes. MC-III Bk H 2003-12a

Expenditure.

• 263. Explanations for variations in the estimates under the minor head "Post-War Reconstruction and Development Programme" are given in the separate estimates for that programme. Variations in the estimates under other minor heads are explained below :---

264. Civil Buildings (Ordinary).—The increase in the revised estimates is due to taking up of works in the States merged with this State and also due to certain urgent works undertaken during the course of the year.

265. Communications (Ordinary).—The increase in the revised estimate is due to certain urgent road works undertaken during the course of the year and also owing to taking up of urgent road works pertaining to the merged States during the current year.

266. Communications (Central Road Fund).—The increase in the revised estimate is due to the authorisation of expenditure on certain urgent works undertaken during the course of the year.

267. Miscellaneous.—The increase in the revised estimate is due to certain urgent works taken up in the current year.

268. Repairs (Ordinary).—The increase in the revised estimate is due to urgent additional repair works undertaken during the current year and also due to taking up of certain special repair works due to damage caused by floods. The decrease in the next year's budget estimates is due to the fact that the special repairs in respect of roads are to be financed from "Provincial Road Fund".

269. Establishment.—The increase in the revised estimates is due to the opening of 2 Circles, 6 Divisions and 27 Sub-Divisions on account of the increase in the engineering activities and also due to the taking over of works in the States which have since merged with this State. The decrease in the next year's budget estimate as compared with revised estimate is due to the proposed curtailment of engineering activities on account of financial stringency.

270. Deduct-Establishment charges under other Public Works Department heads.—The charges vary with the works expenditure under other Public Works Department heads. The increase in the revised estimate is due to more expenditure on works under the head "81-Civil Works". The increase in the next year's budget as compared to the current year's budget is due to more expenditure on works mainly under "68" and "81".

271. Tools and Plant (Ordinary).—The decrease in the revised estimates is due to less machinery and articles of tools and plant likely to be received during the current year. The increase in the next year's budget estimates is due to the provision for the purchase of machinery from foreign Countries.

272. Deduct—Tools and Plant charges under other heads.—The charges vary with the works • expenditure under other major heads. The decrease in the revised estimate is due to slowing down of the works to meet the need of the present financial situation.

^c 273. Grants-in-aid (Ordinary).—The increase in the revised and budget estimates is due to the additional expenditure being authorised for payment of grant-in-aid to the District Local Boards to meet the expenditure on road works in their jurisdiction.

274. Charges in England.—(i) The decrease in the next year's budget is due to less expenditure on leave salary and deputation pay and also less expenditure on books and periodicals.

275. (ii) Deduct-Establishment charges under other Public Works Department heads.-The increase in the revised estimate is due to more expenditure on works under "81-Civil Works". The increase in the next year's hudget estimate as compared with the revised estimate is mainly due to more expenditure under "68-Construction", "18-Irrigation", and "81-Civil Works".

NOTE ON THE BUDGET PROVISION AND FINAL DEBIT OF EXPENDITURE ON PUBLIC WORKS DEPARTMENT ESTABLISHMENT AND TOOLS AND

PLANT CHARGES.

276. The staff of the Public Works Department does work which is accounted for under many major heads, e.g., revenue heads "XVII", "18", "39", "50", "51", "52-A" and "XLI", capital heads "68", "70", "80" and "81", deposit heads such as the Provincial Road Fund. In order to account for the establishment and tools and plant charges under each head, the following procedure is in force.

Where any special establishment and tools and plant are required under one head only they are booked direct under that head. So far as deposit heads and works for other Government excepting Defence Department works are concerned, the establishment and tools and plant charges are first debited to "50" and then recovered on a definite percentage basis, namely 24 per cent. establishment and 3 per cent. tools and plant which represent the average of the incidence of such costs. In respect of Defence Department Works establishment and tools and plant charges have been levied at only 18.5 per cent. and 2 per cent. respectively. For the remainder, the establishment and tools and plant charges are debited, in the first instance direct to head 550 Civil Works 70 and are then distributed to each major head on a percentage basis.

However, in making the distribution for establishment charges the cost of works and repairs under di XVII " is doubled in order to allow for the cost of supervising the work of the purely revenue establishment. The share of the establishment and tools and plant charges debitable to "39", "54-A" and "70" which are not Public Works Department heads is treated as a recovery of expenditure under "50-Civil Works" and the domand in respect of these charges is shown under the respective heads concerned or As regards the remaining heads with which the Public Works Department is directly concerned, the demand for the ordinary establishment, etc., charges is made under "50-Civil Works" only.

With a view to maintenance of separate accounts for expenditure on Post-War Reconstruction Schemes and National Highways, new minor heads "Post-War Reconstruction and Development Programme" and "National Highways" were opened. As, however, there are now no separate Establishment and Tools and Plant exclusively for the Post-War Reconstruction and Development Programme Works, it has since been decided that all the gross Establishment and Tools and Plant charges hitherto shown separately under the minor heads. Ordinary," and 'Post-War Reconstruction and Development Programme' should, hereafter, be recorded under the head "50. Civil Works Ordinary." These charges are, however, exhibited separately under 'Ordinary and 'Postwar Reconstruction is proportion to the corresponding Works Expenditure under the major head "50-Civil Works" for the purpose of distribution and accounting procedure only. The charges for National Highways have, however, been shown separately.

As irrigation is treated as a commercial department, the heads "XVII", "18" (Public Works Department) and "68" are also debited with pensionary charges calculated at a certain percentage fixed by Government every year on the cost of the ordinary establishment charges by a credit to the head "55-Superannuation, etc." where pensions of all Government servants are initially debited.

The cost of Special Establishment and Tools and Plant under "XLI" is initially debited to that head and then distributed under the heads. "XLI" and "81-A-Ordinary" in proportion to the works expenditure under these heads, as the staff under "XLI" does work for both the heads. In addition to this, secretariat and supervision charges are also levied under these heads on cortain percentage basis.

The cost of Special Establishment and Tools and Plant of the Electric Grid Department is initially debited to the major head "52-A—Other Revenue Expenditure connected with Electricity Schemes—Post-War Reconstruction and Development Programme", and then distributed under the major heads "52-A—Other Rovenue Expenditure etc.— Post-War Reconstruction and Development Programme" and "81-A—Capital Outlay on Electricity Schemes—Post-War Reconstruction and Development Programme in proportion to the Works expenditure under these two major heads, as the Special Establishment and Tools and Plant are for both the heads. In addition to this, Secretariat charges at 1 per cent: on the Works expenditure are levied under both the major Heads: Secretariat (iii)

Item 1.—Total establishment charges excluding pensionary charges.—The increase in the revised estimate is mainly due to the opening of two Circles, six Divisions and twenty-seven Sub-Divisions on account of the increase in the engineering activities and also taking over of works in the States which have since merged with this Province. The increase in the next year budget as compared with the revised estimate is due to the reasons as stated above.

Item 2.—Deduct establishment charges recoverable from other Governments, Departments, etc.—The charges vary with the works expenditure under other Public Works Department heads. The decrease in the revised estimate is due to less works expenditure under the several heads especially under 39-Village Water Supply and National Highway Works than budgeted for. The increase in the next year's budget estimate is due to more works expenditure on works under the several heads especially Under Provincial Road Fund.

. 281. Rent from Properties.—The estimates for the current year's revised and the next year's budget have been framed on the basis of progress of current and past years' actuals.

.

232. Sale of Electricity.—The increase in the next year's budget estimate is due to anticipated increase in demand for electricity.

233. Miscellaneous Receipts.—Increase in the revised estimate for the current year is due to recovery of rent from the Military Department for 1948-49 to be adjusted during the current year.

234. Transfer from the Special Development Fund.—The estimate under this minor head is equal to the expenditure on the Scheme under "Special Development Programme" under "51, Bombay Development Scheme".

Expenditure.

235. Original Works.—Increase in the revised estimate for the current year is due to certain urgent works taken up during the year.

233. Repairs.—Increase in the revised estimate for the current year and the budget estimate for the next year is on account of payment of additional taxes to the Bombay Municipality.

237. Establishment (Special).—Increase in the revised estimate for the current year is due to payment of dearness allowance at enhanced rates and payment of arrears of house rent allowance. The small decrease in the next year's estimate as compared with the current year's revised is due to the absence of provision for arrears.

233. Special Development Programme.—The next year's budget estimate under this minor head represents expenditure on the works, viz., Survey, layout, construction of small roads and filling in low-lying plots in connection with the "Kherwadi Scheme". (Please see new Item No. 113.)

289. For the purposes of appropriation, establishment charges (1,98 voted) and tools and plant (16 voted) have been included under "50-Civil Works" and the remainder, viz., 14,60 has been included under this head.

290. A-Bhatgar Hydro-Electric Supply Scheme. The increase in the budget estimate for the next year under "Gross Receipts" is due to the increased consumption of electricity by the present consumers.

For purposes of appropriation, out of the total provision of 21 under "Deduct—Working Expenses" for the next year, ordinary establishment and tools and plant charges of 4 have been included in the demand under the head "50, Civil Works" and the remainder, viz., 17 has been included in the demand under this head.

291. B—Hubli Electric Supply Undertaking.—This Undertaking has been taken over by Govern; ment in the year 1944-45. The budget estimates of expenditure and revenue of this Undertaking, upto 1946-47 were shown under the head "81-A, Capital Outlay on Electricity Schemes". It was then decided that revenue accounts in respect of this Undertaking should be opened under the head "XLI".

The budget estimate for "Working Expenses" for the current year is 1,58. The increase in the revised estimate is due to special repairs to the plants at the Hubli Electric Supply Undertaking and expenditure on stock. The increase in the next year's budget estimate is due to additional provision for meeting the increase in the work charged staff and consumption of diesel oil and other stores.

292. Sub-Major Heads C to R.—The current year's revised estimates and the next year's budget estimates under these heads represent receipts and expenditure on account of the State owned power houses in the merged States areas.

293. S—Electric Grid Schemes.—It has been decided that the revenue receipts in respect of each Electric Grid Scheme should be recorded under "XLI" from the year 1949-50. The budget estimate for the next year under this head represents receipts on account of the Electric Grid Schemes. The receipts in respect of these Schemes for 1949-50 are, however, shown under the head "81-A—Capital Outlay on Electricity Schemes—Deduct—Receipts and recoveries on capital account".

Deduct—Working Expenses in respect of these Schemes have been provided for under "52-A—Other Revenue Expenditure connected with Electricity Schemes" and "81-A—Capital Outlay on Electricity Schemes" respectively.

297. The amounts representing interest and other recoveries of famine relief expenditure in the Famine Relief Fund are transferred to the revenue account under the head "XLIII, Transfers from Famine Relief Fund" for meeting the direct and indirect expenditure on Famine in each year. The current year's revised estimate and next year's budget estimate are based on the amounts of the famine fund receipts which will be available for this purpose.

Expenditure.

293. 54-A, Famine Relief.—The increase in the current year's revised estimate is due to prevalence of acute famine conditions in the State. Famine conditions are not expected during the next year, except in some parts of Mehsana and Ahmednagar districts.

299. 54-B, Transfer to Famine Relief Fund.—Under Section 7 (1) of the Bombay Famine Relief Fund Act, the accounts of the fund shall be made up at the end of each financial year, the securities belonging to the fund being valued at their market value on the last day of each year. Section 7 (3) of the Act provides that if the accounts so made up show that the balance in the fund at the end of such year falls short of Rs. 63 lakhs, the deficiency shall be made up from the revenue of the province. No provision was made in the current year's budget as it was not possible to forecast the market value of securities so far in advance. For the same reasons no provision has been made in the next year's budget estimates. The current year's revised has been placed at 'Nil' as it is expected, on the basis of the information available at present, that there will be no deficit in the Fund at the end of the current year.

300. In all 55 States (including Baroda and Kolhapur) and 254 estates and talukas have merged with the State of Bombay. Rulers of all the States and also 9 Talukdars who have expressed their option to that effect are eligible for privy purses. The amounts of these privy purses have been fixed by the Government of India, Ministry of State. The privy purse of H. H. the Maharaja of Baroda has been fixed at Rs. 26,50,000 per annum and that for H. H. the Maharaja of Kolhapur has been fixed at Rs. 11,00,000 per annum inclusive of Chhatrapati allowance of Rs. 1,00,000 per annum. The remaining States and Talukas can be divided into three categories, *i.e.*, (*i*) those whose rulers are in 'receipt of privy purse in excess of Rs. 1,00,000 per annum, (*ii*) those whose rulers are in receipt of privy purse exceeding Rs. 50,000 per annum, and (*iii*) the remaining States whose rulers are in receipt of privy purse exceeding Rs. 50,000 per annum, and (*iii*) the remaining States whose rulers are in receipt of privy purse annum. There are 18 States in the first category, 11 States in the second category and 31 States and Talukas in the third category. In case of certain Rulers, the privy purses were fixed during the year 1949-50, and therefore the revised estimate provides for the payment of arrears of the privy purses for the year 1948-49.

301. According to Article 291 of the Constitution of India the payment of privy purses guaranteed or . assured by the Governmet of India is charged on and payable out of the Consolidated Fund of India > and where the territories of an Indian State are comprised in a State such contribution is recoverable from the State, as may be determined by the President. Pending the settlement of the procedure for payment of privy purses in the light of the provision of the Constitution, the full provision is made in the Bombay State budget on that account and expenditure is shown as "charged". The expenditure on account of allowances to relatives and cash allowance and political pensions is shown as voted. In addition provision has also been made for allowances and jiwais to certain relatives of Rulers. The provisions under the major head represent expenditure on privy purse of Rulers and allowances to their relatives and cash allowances and political pensions of Rulers.

Equated payments of commuted value of pensions transferred from capital.-Since 1926-27, the capital expenditure debited to the head "83-Payments of Commuted Value of Pensions" together with the interest accruing thereon is being repaid from revenue by equated payments spread over fifteen years. These equated payments are debited to this head. The next year's estimate is based on equated instalments in respect of actual expenditure from 1934-35 to 1948-49 and the estimated expenditure in 1949-50. 305. Compassionate allowances.—The increase in the revised and the next year's budget is on account of provision required to meet the expenditure on allowances sanctioned by the former State Governments to families of deceased Government servants.

306. Donations to Provident Funds.—The revised estimate and the next year's budget include provisions representing Government contributions to Provident Funds in respect of the State servants who opted for Contributory Provident Fund.

307. Post-War Reconstruction and Development Programme.—Necessary explanation is included in Detailed Estimates and Explanatory memorandum of the Post-War Reconstruction and Development Programme.

308. Charges in England.—The current year's revised and the next year's budget estimates are based on the latest report received from the High Commissioner.

309. Deduct—Actual amount of pensions recovered from other Governments.—The pension charges pertaining to the period prior to 1st April 1936 are being shared by Bombay and Sind in the manner specified in the Government of India (Constitution of Sind) Order, 1936. Broadly speaking Sind has to pay to Bombay the amount by which the total payment from Bombay treasuries in respect of pre-separation period exceeds 85 per cent. of the total liability of both the provinces for the period. Due to the partition of the country, the question of financial settlement of outstanding questions between this Government and Sind Government is separately under consideration. This Government is still getting recoveries from Sind Government. The estimates for the current year's revised and the next year's budget are based on the progress of current actuals.

310. Deduct—Pensionary charges transferred to Commercial Departments.—The pensionary charges which are debitable to the accounts of the Irrigation Department are shown as deductions from charges under this minor head. These charges depend upon the establishment charges and on works expenditure in a year.

Revenue.

311. Stationery Receipts.—The increase in the current year's revised estimate is due to larger supply • of articles of stationery to the private bodies than anticipated. The next year's estimate represents • normal receipts under this head.

312. Sale of gazettes and other publications.—The increase in the current year's revised estimate is mainly due to the large sale of publications of public interest. The next year's estimate represents normal receipts under this head.

313. Other Press Receipts.—The increase in the current year's revised estimate is due to supply of paper to some private bodies and the increase in work received for printing.

Expenditure.

314. Stationery Office and Stores.—The increase in the current year's revised estimate is mainly due to (i) the payment of certain amount of leave salary to the permanent Superintendent, Government Printing and Stationery, (ii) the continuance of certain temporary establishment for which no provision was made in the budget, (iii) the creation of certain temporary posts, (iv) the payment of arrears of pay and allowances to the staff according to their revised pay scales and allowances against the provision made for the same according to the old rates and (v) the increase in the supply of stationery articles to the several officers in the Province created as a result of the merger of States.

315. Purchase of Stationery Stores.—The increase in the current year's revised estimate is due to the purchase of paper required for (1) printing of publications like Bombay Code, etc., (2) Election work, (3) merged states presses and (4) levy scheme and also due to the purchase of typewriters etc. for the offices newly created in the merged areas. The next year's estimate is based on the assumption that there will be less expenditure in that year.

316. Government Presses.—The increase in the current year's revised estimate is mainly due to (1) the revision of pay and allowances of the staff of certain Government Presses in the Province, (2) the heavy purchase of machinery, (3) the introduction of second shift at the Government Central Press, Bombay, and the purchase of motor lorry, pully block, furniture, store articles and type cases required in connection with the expansion of the Yeravda Prison Press, Poona, (4) the printing of Government work entrusted to the private presses. The decrease in next year's estimate is due to the absence of provision for arrears of revised pay and allowances.

317. Printing at Private Presses.—The current year's revised estimates are based on the progress of expenditure incurred by the Commissioners of Divisions on printing of Government work at private presses.

318. Charges in England.—The current year's revised and the next year's budget estimates are based upon the report of the High Commissioner for India in London.

Revenue.

319. Unclaimed Deposits .--- The estimates have been framed on the basis of past and current actuals.

320. Sale of Old Stores and Materials.—The estimates under this head are of a fluctuating nature depending on old stores and materials available for sale.

321. Other fees, fines and forfeitures.—The receipts under this minor head are mainly on account of cattle pounds. The increase in the current year's revised estimate and the next year's budget, over the current year's budget is mainly due to receipts anticipated from the merged State areas, on account of Cattle pounds.

322. Recoveries of overpayments.—The revised estimate is based on the progress of actuals in the current year. The budget estimate for the next year has been framed on the basis of past and current next actuals.

323. Miscellaneous.—The increase in the current year's revised estimate is mainly due to the collection, during the year of cash balances with States merged in the Bombay State. The increase in the next year's budget estimate over the current year's budget is mainly due to receipts from Custodian fee.

Expenditure.

324. Donations for Charitable purposes.—The increase in the revised estimate is due to increase in the payment of gratuitous relief to sufferers during the heavy rains in this State in the current year.

325. Special Commission of Enquiry.—The revised estimate is mainly due to the cost on account of (i) Legal Aid Committee to consider the question of giving legal aid to the poor at Government cost and (ii) Mofussil Forward Markets Enquiry Committee.

326. Contributions.—The increase in the revised estimate of the current year is mainly due to (i) grant-in-aid to Mofussil Municipalities on payment of dearness allowance, (ii) financial assistance to Bombay Flying Club, (iii) grant-in-aid to Sarvodaya Kala Mandir and (iv) grants to "B" Class Municipalities and Lunawada Municipality.

The next year's estimate registers an increase over the current year's budget mainly under the following items :---

(i) Grant-in-aid to Mofussil Municipalities, equivalent to 50 per cent. of expenditure incurred by them on payment of dearness allowance to their staff, 75 per cent. of non-agricultural assessment, and 15 per cent. of land revenues excluding non-agricultural assessment collected in their areas,

(ii) grant-in-aid to District Local Boards on account of expenditure incurred by them on payment of dearness allowance to their staff,

(iii) grant-in-aid to District Local Boards equivalent to (a) 15 per cent. of the land revenue collected in their areas and (b) 2 per cent. of gross forest revenue in their areas,

(iv) grant-in-aid to Local Bodies on account of revenues from fines credited to Government.

and

(v) grant-in-aid to the Bombay Flying Club.

327. Charges in connection with the Village Panchayats Act.—The current year's revised estimate is based on the progress of actuals.

The increase in the next year's budget estimate over the current year's budget is mainly under the following items. (i) Grant-in-aid on account of pay and allowances of Village Panchayat Secretaries, (ii) charges in connection with Village Panchayat elections and (iii) grant-in-aid to Village Panchayats on account of expenditure incurred by them on payment of dearness allowance to their staff.

The increase in the next year's budget under items (i) and (ii) above, is on account of (a) addition of new districts due to merger of States and (b) increase in the number of Village Panchayat Secretaries in view of policy of Government to establish Village Panchayats in all villages having a population of 1,000 and above and even in villages with a population below 1,000 provided 50 adults express a desire to have a Panchayat. The increase in the next year's budget under item (iii) above, is due to the absence of the provision in the current year's budget on account of grants equal to 50 per cent. of the expenditure incurred by Village Panchayats on payment of dearness allowance to all their employees except the Secretary.

328. Miscellaneous and Unforseen charges.—The decrease in the current year's revised estimate is mainly because of absence of provision of Rs. 2 crores on account of increased rates of dearness allowance, for which expenditure has now been spread over the respective major heads, partly counter-balanced by increase based on past and current actuals.

329. Expenditure on displaced persons—The increase in the revised estimate for the current year and the budget estimate for the next year is mainly due to (i) part of expenditure on Relief measures for displaced persons viz. Staff under the "Directorate", under the Collectors and under the Superintending Engineers being debited to this Government, (ii) entire expenditure on "Custodian of Evacuee Property" being borne by this Government and (iii) 50 per cent. of expenditure on the pay and allowances of the non-displaced persons, employed in connection with the "Rehabilitation Schemes" duly approved by Government of India, being debited to this Government.

Revenue.

331. Officers of the Provincial Government who are district authorities under the rules framed under the Petroleum Act, 1934, and the Indian Explosives Act, 1884, administer these Acts and collect the license fees. Up to 1938-39 these fees were credited direct to Provincial revenues as agency fces. The Government of India, in consultation with the Auditor General, decided that these fees should be credited to central revenues as they were a part of central revenues and that it would pay an equivalent amount to this Government as payment for the work done by Provincial officers. According to this decision, the Accountant General, with effect from 1938-39, credits the total amount of fees received in the Province each year to central revenues by debit to the heads "IX, Stamps" and "XXIII, Police" to which fees are first credited and an equal amount is credited to this Province under this head. The current year's revised estimate and the next year's budget estimate represent this adjustment, equal amounts having been deducted from the receipts under "Stamps" and "Police".

Expenditure.

332. This Government has accepted the Government of India's offer of an annual sum of Rs. 29 lakhs as compensation for the complete withdrawal of, and abstention from, all forms of taxation on tobacco within this Province from the 1st April 1943. This Government has also agreed to make over to the Government of India, the total net receipts realised under Provincial Tobacco taxation measures from the 1st April 1943. The current year's revised as well as the next year's budget estimate on account of the amount to be paid to the Government of India is nil.

333. Subvention from the Central Government—(a) Post-War Development Schemes.—The current year's revised estimates represent the share of the Government of India in respect of Post-War Reconstruction Schemes undertaken by this Government. The decrease in the next year's budget estimates is due to the decision of the Government of India to confine its grant to the G. M. F. Schemes.

334. Subvention from the Central Government—(b) National Highways.—The expenditure on National Highways is provided under "50, Civil Works" and is wholly recoverable from the Government of India. The current year's revised estimates and the next year's budget estimates show the recovery from the Government of India on account of National Highways which is credited under this head.

335. Subvention from the Central Government—(c) Subsidy on account of the Merger of States.—The current year's revised estimates and the next year's budget estimates represent the subsidy expected from the Government of India on account of the merger of States.

Expenditure.

336. Expenditure on account of restoration of property confiscated during the Civil Dis-obedience Movement of 1942.—The current year's revised estimate is based on the progress of actual expenditure recorded under this Sub-head.

The "Post-War Reconstruction and Development Fund" has been created to provide part of the finance for the expenditure on schemes of reconstruction and development including those comprised in the Post-War Reconstruction plan with the main object of raising the economic level of the country side and improving the conditions in various aspects of social economic and cultural life in the State. The fund is to be credited with sums which can be set apart from the balances and general revenues. The provisions made for transfer to the Fund are shown under this head.

338. It is proposed to withdraw a sum of Rs. 4 crores from the balance in the Post-War Reconstruction and Development Fund to finance capital expenditure to that extent in 1950-51. This sum has therefore been shown on receipt side for 1950-51.

339. No amount is available for transfer to the Fund during the next year.

The revised estimate represents the amount debited to the Special Development Fund in 1946-47 and transferred to this head in 1949-50.

340. The estimates provide for the Provincial share of A. R. P. receipts expected from the sale of A. R. P. furniture, stores etc, which are to be apportioned between the Central and State Governments in the same proportion in which A. R. P. expenditure was allocated between them.

341. Deduct.-Share paid to the Central Government.-Thecurrent year's revised estimate provides for the payment of a sum of 15 which had remained to be paid to the Government of India on account of its share in the total receipts credited by this Government in the past.

Expenditure.

342. The expenditure provided for under the minor heads " Expenditure in connection with interning of enemy subjects" "Expenditure in connection with Registration of Foreigners' Act, 1939" "Expenditure in connection with examination of activities of Foreigners" are wholly recoverable fro the Government of India. A part of the expenditure under ' Motor Spirit Rationing Scheme is to be borne by this Government and the remaining by the Central Government.

343. The revised estimate under A. R. P. has been placed at 18 on the basis of current actuals which are mostly on account of adjustment of past transactions.

344. The increase in the current year's revised and the next year's budget estimates under ' Motor Spirit Rationing Scheme ' is mainly due to (i) additional staff sanctioned for new offices at Baroda and Kolhapur and (ii) increased rates of dearness allowance.

345. Deduct-Share recovered from other Governments Departments, etc.-The increase in the current ar's revised and the next year's budget estimates is mainly due to the larger recovery expected from the Central Government under ' Motor Spirit Rationing Scheme.'

68, Construction of Irrigation, Navigation, Embankment and Drainage Works not charged to Revenue.

Expenditure.

Provision for capital expenditure on irrigation works for which capital accounts' are kept is made under the head "68". The capital expenditure on these works may be defrayed from the general revenues of the Province, or from the Famine Relief Fund, or from other sources, such as loans, accumulated balances of the previous years, etc., but the major head "68" is intended to include only such expenditure as is incurred from the sources outside the ordinary revenues, and for this reason the provisions made from ordinary revenues, or from the Famine Relief Fund, are deducted in a lump sum from the gross provision made under this head and shown under a separate head, viz., "19".

349. Item I-A.—The next year's budget estimate represents the amount of annual instalment for the purchase of the Kirkee Water Works from the Government of India.

350. Item I-B.—The estimate under this head provides for expenditure on the diversion of the Sadar Bazar Nala, Sholapur. The decrease in the revised estimate for the current year is due to the delay in starting the work owing to difficulties in acquiring land for the work.

351. Item I-C.—The next year's provision is intended for the new work of constructing staff quarters and two-seated acqua privy at the Bund Bridge Pumping Station, Poona.

352. Item I-E.—The increase in the revised estimate for the current year is due to larger expenditure on the work of providing an additional electrically driven pumping set at the Bahiroba Pumping Station.

353. Item I-G.—The increase in the revised estimate for the current year is due to larger expenditure on the Yervda Colony Drainage Scheme (Stage I).

354. Item I-L.—The revised estimate for the current year represents expenditure on the Miraj Water Supply Scheme. The next year's provision provides for expenditure on the scheme including purchase of meters.

355. Item I-M.—The revised estimate for the current year and the budget estimate for the next year provide for expenditure on the Kundgol Water Supply Scheme.

356. Item I-N.—The revised estimate for the current year represents expenditure on the Kolhapur Water Supply Project.

357. Item I-O.—The revised estimate for the current year provides for expenditure on the Emergency Water Supply to Dombivli.

358. Item I-P.—The revised estimate for the current year represents expenditure on the Vijaynagar Housing Scheme.

359. Items II-A and B.—Explanations given in the Post-War Reconstruction and Development estimates for the next year.

360. Sulphate of Ammonium Factory at Sindri in Bihar. —During the current year, this Government was not required to pay its contribution towards the Factory and hence the saving. It is not proposed to provide more than 18.75 lakhs next year to bring down other requirements for capital expenditure.

361. State Company for the manufacture of Penicillin, Sulpha Drugs and Anti-Malarial Drugs. The Government of Bombay has agreed to participate in the scheme for the manufacture of penicillin, sulpha drugs and anti-malarial drugs; along with the Government of India. Under this scheme the Union Government is to contribute 51 per cent. of the capital required. The balance of 49 per cent. is to be contributed by the Government of Bombay. According to the estimates of the capital requirements of the proposed factory submitted by the Committee constituted by the two Governments, the total amount required is Rs. 4 crores. It is proposed to make a provision of 38,50 during 1950-51 as this Government's contribution to the capital outlay on the Scheme on the basis mentioned above. (Vide New Item No. 121)

362. Post-War Reconstruction and Development Programme. -Variations under this minor head have been explained in the separate issue of Post-War Reconstruction and Development Programme Estimates.

80, Bombay Development Scheme,

363. All activities of the Development Department were originally financed from loan funds under the capital expenditure head "59 (now 80), Bombay Development Scheme", the capital receipts realised therefrom being taken in reduction of expenditure under the same head and the revenue receipts being shown under the head "XLII-Bombay Development Scheme". From the year 1927-28 revenue heads "42 (now 51) and XXXI (now XL)-Bombay Development Scheme" were opened for those schemes of the Development Department, on which capita! expenditure was complete, and the Industrial Housing Scheme was transferred to those heads. During 1928-29 two more schemes of water and electric supply • were transferred to the revenue heads. The Development Department was abolished from the 1st March 1930 and all charges pertaining to the schemes of the Department except those of the Back Bay Scheme. were transferred to the revenue heads with effect from 1930-31. Revenue accounts for the Back Bay Scheme have been opened with effect from 1939-40. The receipts and expenditure of a revenue nature in respect of that scheme appear from that year under the heads "XL" and "51" respectively. Only capital expenditure on that scheme required for the completion of the works already undertaken, and capital receipts are now recorded under this capital head.

364. The original plans for the reclamation of Back Bay provided for a sea wall from Chowpatty extending as far as Colaba Point and enclosing 1,100 acres of reclaimed land, this area being divided into eight blocks. Block No. I starts from opposite the Marine Lines Station and extends up to the Churchgate Station. Block No. II extends from the Churchgate Station to near the Back Bay Swimming Baths. The area from this point, past the old Cuffee Parade reclamation and beyond the Afghan Memorial Church at Colaba, is divided into five Blocks Nos. III and VII, while Block No. VIII admeasuring 245 acres abuts on the lands at Colaba point. A small portion of old reclaimed land near the Marine Lines Station had also been included in the Scheme.

In accordance with the decision of the Legislative Council in 1927, work in connection with the Back Bay Reclamation Scheme has been restricted to the reclamation and development of Blocks Nos. 1, II and VII and the reclamation of Block No. VIII without development with a connecting road along the existing foreshore between Blocks Nos. II and VII.

Blocks Nos. I and II comprising over 150 acres have been fully reclaimed and the plots in this area are now available for building purposes. Block No. VII comprised about 135 acres out of which about 47 acres at the east end have been fully reclaimed, leaving about 88 acres partially reclaimed. The partially reclaimed area is being completed by the slow but cheap process of filling with suitable building debris. At present the dry filling operations have been suspended. Block No. VIII comprising 245 acres was reclaimed and sold to the Government of India for Rs. 2,06,53,000.

The project estimate of the curtailed scheme sanctioned in March 1932 amounted to Rs. 7,23,06,000. Out of this, a sum of Rs. 4,77,000 is now being met from Revenue under "51-B.D. Scheme". Against the modified project estimate, the total expenditure (excluding interest) incurred to end of March 1949 is Rs. 6,22,93,441 leaving a balance of capital expenditure of Rs. 95,35,559 to be incurred. Government has at present no intention of embarking on any works in Block No. VII, beyond filling it up with suitable building debris. It has been found necessary, however, to incur expenditure on the development of Blocks I and II, viz., the provision of roads, drains and lights, as otherwise reclaimed land would have been unsaleable. These works are estimated to cost about Rs. 403 lakhs and have been started from 1934-35. An expenditure of Rs. 29,98 lakhs has been incurred to the end of 1948-49.

The revised estimate for the current year under "Works" represents expenditure on certain works in connection with the improvement of the Back Bay Reclamation area.

The decrease in the current year's revised estimate under "Receipts of a capital nature" is due to smaller sales of lands in the suburban areas for industrial uses. The next year's budget estimate under this minor head is framed after taking into account advance payments of premia in respect of certain plots in the Back Bay Reclamation Scheme.

For purposes of appropriation, ordinary establishment and tools and plant charges are included in the demand under the head "50-Civil Works". As no works are expected to be carried out during 1950-51 under "80", these charges are nil.

366. A-Ordinary.- The increase in the current year's revised estimate is mainly due to expenditure on (i) purchase of the property including structures and furniture etc. belonging to the Western India Turf Club, Poona, (ii) construction of Semi-permanent bungalows for Class I and II officers in Block No. III of the Back Bay Reclamation Scheme, Bombay and electric installation therein, (iii) construction of temporary quarters for the refugees at Godhra, (iv) construction of Sanad-Vichhia-Aniali-Road and (v) other urgent works taken up during the year.

The decrease in the next year's estimate as compared with the current year's revised estimate is majnly due to slowing down the progress and postponement of certain works decided upon by Government.

368. For purposes of appropriation, all ordinary establishment and tools and plant charges are included in the demand for grant und ir "50-Civil Works". It has, however, been decided by Government to finance part of the Capital expenditure from the Post-War Reconstruction Fund. 374. Payments on account of commutation of pensions are accounted for under the capital head "83, Payment of Commuted Value of Pensions" and are repaid from revenue by equated payments of capital and interest spread over fifteen years. The equated payments in respect of commutations sanctioned in each year commence from the next following year. The total equated payments in respect of each year's commutations are debited to the head "55—Superannuation Allowances and Pensions and credits are transferred (a) to the Capital head "83" for the capital portion of the Payments and (b) to "22—Interest on Debt and other obligations" for the interest portion.

375. Payments of commuted value of pensions.—The revised estimate for 1949-50 takes into account payment in respect of applications for commutation of pensions actually received. The budget estimate for 1950-51 is based on anticipated demands based on past actuals.

376. Deduct—Capital portion of equated payments out of revenue.—The revised estimate for 1949-50 shows repayment from revenue of the principal portion of the equated instalments in respect of actual expenditure incurred on commutation of pensions from 1934-35 to 1948-49 while next year's estimate shows such re-payment in respect of actual expenditure from 1935-36 to 1948-49 plus the estimated expenditure in 1949-50.

377. In accordance with the Auditor General's suggestion, Government has opened with effect from the 1st April 1943, a new capital major head of account, viz., "85-A, Capital Outlay on Provincial Schemes connected with the War, 1939" to record disbursements and receipts from schemes connected with the last war. The nomenclature of this major head has been changed to "85-A, Capital Outlay on Provincial Schemes of State Trading" with effect from the 1st April 1946. Personal Ledger accounts were opened for these schemes and advances were sanctioned for them by debit to "Advances Repayable" in the Debt Section of the Accounts. The Personal ledger accounts have been retained under the new procedure which has been devised not only to provide the essence of control, but also to combine the advantages of a final head of account with those of personal ledger accounts without undue complications in accounts. 19378. The minor heads opened under this head are "Grain Supply Schemes", "Standard Cloth Schemes" "Other Miscellaneous Schemes" and "Post-War Beconstruction and Development

Schemes", "Other Miscellaneous Schemes" and "Post-War Reconstruction and Development Programme." The third minor head includes such schemes as "Scheme for the Purchase of seed for the Grow More Food Campaign", "Scheme for the purchase of Iron and Steel", "Scheme for the Distribution of Cloth and Yarn—Bombay City and Mofussil" etc. Two new sub-heads, viz., (1) "Scheme for the purchase and distribution of Iron, Steel and Cement for agricultural purposes" and (*ii*) "Government Cloth Shops" have been opened under this minor head with effect from the current year. The fourth minor head is intended to record transactions pertaining to the "Bombay Milk Distribution Scheme".

379. The transactions of the various schemes are recorded under the following detailed heads :---

- (1) Cost of Purchase.
- (2) Advances.
- (3) Suspense---
 - (a) Personal Deposits.
 - (b) Insurance Fund.
- (4) Deduct-Receipts and recoveries on Capital Account-
 - (a) Repayment of advances.
 - (b) Other receipts.
- (5) Deduct--Capital expenditure financed from ordinary revenues.

When a scheme is worked out without the aid of advance the expenditure is to be debited to (1). Since advances are provided for all the schemes, except the scheme for the purchase and sale of Gur, no expenditure is recorded under this detailed head in respect of the other schemes. (2) is intended to provide for advances granted for the working of the schemes. A corresponding credit is given to (3) (a) which also records the subsequent incomings and outgoings of the personal edger accounts. The amount set apart to cover possible losses by fire, etc., appears on the credit side under (3) (b). The debit side of this detailed head records the withdrawal from the fund, if and when necessary, to cover losses. All recoveries, including those of advances and ultimate profits, if any, are to be accounted for under (4) and any losses under (1). On the winding up of a personal ledger account, the final result would either wipe out the original issue or, if not, the balance may be either left to the debit of the capital account under (1) or written off to revenue account against (5). 380. Grain Supply Scheme.—The current year's revised estimate is based on the actual progress of transactions. The worsening as compared with the current year's budget is mainly due to larger allotment of overseas foodgrains from the Centre for the merged areas and better procurement in the Districts. The next year's estimate is based on the progress of current actuals.

381. Standard Cloth Scheme.—The scheme has already been closed. The betterment in the revised estimate is due to the expectation that the current year's provision for payment of arrears will not be utilised, as accounts have not been finalised. The next year's provision is intended for payment of these arrears.

382. Other Miscellaneous Schemes.—The large betterment in the current year's revised estimate is mainly due to larger receipts under the "Scheme for the distribution of Cloth and Yarn." The betterment is partly offset by the worsening under the (i) Scheme for the purchase of sceds for the "Grow More Food" Campaign and (ii) Government Cloth Shops Scheme.

Government accepted the donations of Rs. 9 lakhs and Rs. 6 lakhs, respectively, for establishment of the Anand Institute from the Trustees of Sheth Mansukhlal Chhaganlal and Sheth Mungalal Goenka Trusts on certain conditions, one of these being, that Government should pay to Governing Body of the Institute, interest at 3½ per cent. on the donations, after deducting therefrom, the actual expenditure on buildings and equipment of the Institute. The Trustees accordingly paid Rs. 13.50 lakhs out of which a sum of Rs. 10-38 lakhs stands invested in long-dated securities, in order to reimburse to Government. the amount payable to the Governing Body as interest. The balance of the donation namely Rs. 1.50 lakhs was received in 1940-41. In 1946-47, Government accepted a further sum of Rs. 5,00,000 by way of donation from Sheth Amritalal Hargovandas towards the building and equipment of the College of Agriculture to be started at the Institute of Agriculture, Anand. Out of this, a sum of Rs. 4,00,000 was paid to the Governing Body of the Institute in 1946–47. The balance of Rs. 1,00,000 was paid to the Institute in 1947-48. In the revised estimate a sum of 33 has been provided on the basis of progress of actuals. A provision of 2,35 on the receipt side represents receipts from the sale of securities for expenditure so far incurred. In the next year an amount of 1,75 will be required for permanent water works, bungalow for the Director, and for construction of wells, installation of pumping plants, etc., and hence a provision equal to that amount has been made in the next year's budget on the disbursement side. Since this will involve sale of securities, an equal amount has been provided on the receipt side in the next year's budget.

Under section 9(3) of the Bombay Motor Vehicles Tax Act, 1935, as amended by the Bombay Charged Expenditure Act, 1939, if the net proceeds of the tax in any year exceed the sum of Rs. 26,57,000, the excess amount shall be entered in a separate account and shall be expended in such manner as the local Government may determine solely on the construction improvement and maintenance of new and existing roads including roads vesting in, belonging to, or managed by, any local authority. The expenditure from the Provincial Road Fund is to be treated as charged. The head "Provincial Road Fund" has been opened to record expenditure incurred therefrom.

Receipts.

404. The amounts entered on receipt side show the surplus realised in 1948-49 and the estimated surpluses for the years 1949-50 and 1950-51 together with the amounts credited to this head on account of refunds of grants, popular contributions, etc.

Disbursement.

405. The expenditure from the fund during the current year is mainly on Vindoli-Kim-Mandvi-Bansda Road, Surat-Dhulia Road, construction of a submersive causway over the river Indrayani at Dehu and other Roads and on Approach Roads to Villages. Next year provision of 94,98 has been made for works in progress and special repairs to existing Government roads, 16,40 have been set apart for approach roads to Villages and 2,20 for grants to Bombay Municipality for providing traffic amenities in Bombay City.

406. The "Special Development Fund" was created at the end of 1938-39. Contributions were made to the Fund by transfers from the revenue balances in each year from 1938-39. The fund was utilised till the end of 1946-47 for financing schemes of a beneficient or nation building character e.g., development scheme of agriculture, education or public health, including experimental schemes. It has also been laid down that expenditure from this Fund should either be non-recurrent or spread over a limited period not extending beyond five years. The main object in creating the Fund is to ensure that it will remain available only for specified purposes and that unutilised grants lapse not to the general revenues but to the Fund itself. In order to ensure this, the following accounting procedure has been laid down. Expenditure on different development schemes is recorded in the revenue section under the major heads concerned and equivalent credit is given at the same time under the corresponding receipt heads or under the head "XLVI-Miscellaneous" with a per contra debit to the Fund in the deposit section.

407. Government has decided that with effect from 1947-48, the Special Development Fund should cease to exist as a means of financing miscellaneous and largely unconnected schemes of development since most of the schemes can appropriately be regarded as part of the co-ordinated and general programme of development which is designated Post-War Reconstruction. But special development in context of the general plan has real significance if meant to describe that part of the programme which is for the special uplift of backward classes. The fund will, therefore, continue to operate with regard to schemes for the special uplift of backward classes. The next year's provision for receipts and expenditure have been made on the basis indicated above.

This head records the receipts of the amount transferred to the Post-War Reconstruction and Development Fund by the debit to the head "64-A, Transfer to the Revenue Reserve (Post -war Beconstruction and Development) Fund" (vide paragraph 337). It is proposed to withdraw a sum of Rs. 4 crores from the Post War Reconstruction and Development Fund during 1950-51 to finance certain capital works under "81-Capital Account of Civil Works outside the Revenue Account" and "81-A-Capital outlay on Electricity Schemes". The amount to be withdrawn will be credited under the Major Head "L-II-A-Transfer from the Post-war Reconstruction and Development Fund" (vide paragraph 338).

413. Though the transactions of the Dangs District form part of the Public Account of this Government, these are taken against the accumulation of the Dangs revenue in accordance with the intention of Government to keep the receipts and payments on account of the Dangs District separatefrom the accounts of this State with a view to utilising the surplus, if any, realised from the Dangstowards the amelioration of the condition of the Dangs people. The following procedure of accounting has, therefore, been prescribed for the Dangs District.

414. The receipt and expenditure of the Dangs Area will be recorded in the Revenue Section in lump separately on the Receipt and Expenditure sides of the State Section of the accounts of the Government of Bombay. Any difference between the Receipt and Expenditure sides will be transferred at the end of each year to a Deposit Fund (Reserve Fund) in the Deposit Section of the State Government accounts. The balance of the reserve transferred from the Government of India will also be credited to this deposit head. The debt and remittance transactions of the Dangs will be recorded direct under the relevant debt and remittance heads in the State section of the Government accounts. The investments transferred from the Government of India and any other investments made hereafter from the Dangs District Reserve Fund will be debited to a separate head of account in the Deposit Section.

415. In accordance with the above procedure an amount of 7,30 representing the anticipated deficit during the current year has been transferred to the Dangs District Reserve Fund and an amount of 3,61 representing anticipated deficit in the next year has been transferred from the Dangs District Reserve Fund to meet the estimated excess expenditure of the Dangs Administration during 1950-51. The Receipts of 22,76 during the current financial year represent the balance of the Reserve Transferred from the Government of India.

418. The annual petrol tax receipts allocated to state Government are held by the Government of India until they are actually required by state Governments for expenditure. Thus the state Government can ask for the allotment from the Government of India only after utilising the unspent balance at the end of the previous year. The amounts received from the Government of India are credited on the receipt side under this head and the expenditure is shown in the disbursement side. The actual expenditure is, however, recorded in the first instance in the revenue sections under the head "50-Civil Works" and a corresponding credit is given to the receipt head "XXXIX-Civil Works" in the revenue section by transfer from the Fund. The amount estimated to be received during the current year is 9,37, while the anticipated expenditure is 11,92. The expenditure on petrol tax works, during next year has been estimated at 7,47 and the same figure has been adopted for the estimate on the receipt side.

419. The transactions relating to the grants of the Indian Central Cotton Committee appear both on the receipts and disbursements side of the state Accounts, with effect from 1937—38. They are of the nature of transactions in a personal deposit account and do not affect the revenue section.

420. The Accounting procedure for subsidies from the Imperial Council of Agricultural Research, Sugar Excide Fund and Indian Central Oil-seeds Committee is similar to that followed in the case of subvention from the Central Road Fund, the relevant heads in the revenue section being "XXIX and 40, Agriculture", "XXX and 41, Veterinary", and "XXXI and 42, Co-opration".

421. A new minor head designated "Deposit account of grants from the Indian Central Sugarcane Committee" has been opened and the grants from the Committee provisionally accounted for under the two minor heads "Deposit account of the grants made by the Imperial Council of Agricultural Research," and "Deposit Account of grants for the Sugar Excise Fund" have been adjusted.

422. A new minor head designated "Deposit Account of the grant made by the Indian Central Tobacco Committee has been opened from the year 1947—48. The accounting procedure is similar to that in the case of subvention from the Central Road Fund, the relevant heads in the revenue section being "XXIX and 40, Agriculture".

423. New minor head designated "The Private Donations and Contributions Fund" has been opened with effect from the year 1947—48. The Fund is formed from the donations given by the public for general or specific purposes and is to be utilised for the schemes and objects for which the donors have given their subscriptions. The donations will be credited in the first instance to the Fund in the Deposit Section of the Account. The expenditure incurred from the Fund will be entered under the relevant service major heads by opening suitable sub-heads and detailed heads for the purpose with due regard to the general principles of accounting as laid in Article 30 of the Account Code, Volume I, while an equivalent amount will be transferred to the corresponding revenue head of account by debit to the Fund in cases where control over expenditure rests with Government. In other cases the expenditure will be debited direct to the Fund.

424. It was decided to maintain separate accounts for the integrated states collectively till merger, of States. For the purpose, one account is maintained for the Deccan States, one for the Janjira State one for the Gujerat States, and one for Baroda State. The transactions are shown in lump in Monthly Cash Account and List of Payments under the minor heads "Accounts of Deccan/Gujerat/Janjira States" under the major head "Other Accounts" in the section "P-Deposits and Advances —Part II— Deposits not bearing Interest-C-Other Deposit Accounts". Expenditure on such items as I.S.F. Port Okha, etc., regarding which Government have not yet taken any final decision are continued to be recorded under these minor heads even after merger of the States.

430. Under the minor heat "Suspense Account" and "Local Public Works Expenditure" is recorded the expenditure on purchase of stores, road materials, etc., and the amounts expended are cleared by credit when the stores, etc., are issued to departments by debit to the proper head.

431. Under the head "Central Accounts Office Reserve Bank Suspense" are recorded transactions relating to Reserve Bank Suspense which show credit and debits on behalf of the Government of India, other State Governments, Indian Stores Department and Charges in England. It has been decided by the Auditor General that with effect from 1941-42, the system of showing the credit by " minus debit " instead of "plus credit" should be followed by all State Governments. The effect of this decision is that the debit side is expected to be mostly cleared by the reductions due to credit and consequently no provision is required in the budget.

432. Under the head "Cash Balance Investment Account" are recorded transactions of the State Government by way of investment of its cash balances in short and lorg term loans, e.g., the Treasury Bills of the Government of India, or of other State Governments and the Government of India, Securities or loans of other State Governments. The profits derived from such investments are credited as receipts under the head "XX-Interest-Interest realised on investments of Provincial balances" in the revenue section. The amounts appearing under this head on the disbursements side is the total of the amounts invested for short or long periods from time to time during the course of the year, and on receipts side the total amounts realised on maturity (less the discount earned or interest derived therefrom) during the year.

433. The head "Departmental Adjusting Account" is intended for recording the provisional adjustments of departmental receipts and payments and inter-departmental transfers.

434. The head "Recoveries of service payments" is intended for recording the recoveries made in the course of audit before they are finally brought to account.

The loans advanced to the Bombay Municipality have been divided for purposes of repayment into four classes viz.(i) loans utilised for improvement purposes, granted to the late Improvement Trust, (ii) those utilised for general purposes, (iii) loans for development purposes and (iv) loan for the construction of the Vihar Lake and Water Works. The outstandings on 31st March 1937 of loans advanced in 1931-32, 1932-33 and 1935-36 under (i) have been included in the consolidated debt referred to in paragraph 103 (8) under "22, Interest on debt and other obligations" and are being repaid by the Bombay Municipality in equated half-yearly instalments over 44 years from 1937-38. The other loans under (i) are being paid by fixedinstalments of principal spread over 30 years with accrued interest on the outstanding amounts. The Municipality is repaying (ii) by equated annual instalments of principal and interest over 30 years. The loans under (iii) for development purposes were taken by the Municipality in 1923-24 and 1924-25. In both cases it repaid on 2nd April 1929 the accumulations in the sinking funds maintained by it. The balance of the 1923-24 loans outstanding at the beginning of 1934-35 is being repaid by equated annual instalments of principal and interest spread over a total period of 30 years the last instalment being payable on 31st March 1954. The balance of the 1924-25 loans is being repaid by equated annual instalments of principal and interest spread over 30 years from 1929-30. The loan of 82,67 advanced in 1935-36 to liquidate the portion of the Bombay Development Loan outstanding with the Bombay Municipality is being repaid by equated instalments of principal and interest spread over 15 years. The loan under (iv) was given by the Central Government, but the amount of 13,30 outstanding on 31st March 1937 has been transferred to this Government on that date. The loan is repayable in monthly instalments of 9 with interest for a period of sixty years beginning from 1893.

439. 1. Loans to Municipalities, district and other Local Fund Committees for Public Works.—The provision of 10,87 in the current year's revised estimate of advances is on account of 2,00 to Islampur Municipality, 60 to Bandra Municipality, 25 to Nacik Municipality, 14 to Dharwar Municipality, 22 to Navalgurd Municipality, 41 to Mehmedabad Municipality, 1,20 to District Local Board, Ahmedabad, 1,05 to Agricultural Troduce Market Committees and 5,00 for loans to local bodies for financing the capital cost of water supply works in the merged areas of Bareda State. The next year's budget estimate under recoveries includes repayment of 1,06 by Municipalities and 6 by Agricultural Producee Market Committees.

2. Locans and Advances in connection with Post-War Reconstruction and Development Programme.—Vide explanations given in the Post-War Reconstruction and Development Estimates for the next year.

3. Loans to Landholders and other Notchilities.—The current year's revised estimate includes advances to Saranjam Estate, Hubli; and recoveries from the Thakore of Amod, Sardar L. N. Helikar and Kumar Saheb Pratapsinhji. Next year's revised estimate includes recoveries from Sheth Maneklal. Parshotamdas in addition to the recoveries from persons mentioned above.

4. Loans to Cultivators.—The increase in the current year's revised estimate is due to larger demands for tagai advances from cultivators, demand for tagai advances from cultivators in merged state areas and tagai advances in connection with potato cultivation scheme, mixed manure scheme and relief to cultivators for distress caused by Cyclone.

6. Loans for the purposes of Co-operative Societies Act.—The increase in the current year's revised estimates under advances and recoveries is on account of temporary advances granted to Bombay Provincial Co-operative Land Mortgage Bank. These advances are repayable during the current financial year. The current year's revised estimate under advances also includes advances to co-operative societies in connection with Lift Irrigation Scheme. A portion of latter advances is expected to be recovered during the financial year 1950-51.

7. Loans to Co-operative Multipurpose Societies.—Increase in the next year's budget estimate is on account of provision for advances to Co-operative Societies for building warehouses under the Warehouses Act.

8. Loans to Non-agriculturists in flood affected areas.—The current year's revised estimate under advances includes provision of loans to sufferers of heavy rain in Bijapur and Sholapur and of loans to sufferers of oyclone.

10. Loans to Co-operative Housing Societies in flood affected areas.—The provision of 3,00 in the current year's revised estimate of advances is on account of the scheme sanctioned by the Government in order to enable the victims of the flood affected areas in Ahmednagar District to construct houses through the agency of Co-operative Housing Societies.

12. Loans for Development of Fisheries.—The next year's budget estimate under advances includes 1,30 on account of loans in connection with the Post-War Scheme of establishment of ice plant, etc., as against a provision of 3,20 in the current year's revised estimate.

13. Loans to other Small Industries.—The decrease in the current year's revised estimate under advances is due to lesser demand for loans under State-Aid to Industries Rules.

16. Advances in connection with relief and rehabilitation of displaced persons. The increase in the current year's revised estimate and the next year's budget estimate is on account of a large demand from displaced persons for loans for Crafts, etc., and for construction of houses. The loans will be given from the advances to be granted by the Government of India to this Government for the purpose.

17. Loans to Cottage Industrics.—Increase in the current year's revised estimate and next year budget estimate is on account of increased demands from trained artisans for the purchase of tools and appliances through Co-operative Societies of artisans.

18. Other Miscellaneous Loans.—In addition to several small advances, the current year's revised estimate includes following advances :—

1,00 Advances in connection with the scheme for financial assistance to small-scale dairy farmers.

Remarks.--The Bombay Suburban District is mainly an urban district and has its importance on account of its situation near the city of Bombay. Since the constitution of this district in 1920, there has been a regular tendency on the part of the holders of lands to convert agricultural lands into non-agricultural holdings without the permission of proper Government authority and to commit breaches in the terms of the non-agricultural agreements. This tendency has ever been on the increase and with the present revenue staff of the district which is absolutely necessary for the normal work, it is not possible to check and detect unauthorised non-agricultural use of agricultural lands and breaches of non-agricultural use authorisation in the Bombay Suburban District properly and adequately. In order, therefore, to take up a systematic review work and to deal with the cases of the type, mentioned above, adequately and expeditiously an additional establishment of 1 Mamlatdar, 1 Aval Karkun, 2 surveyors, 2 survey coolies and 2 peons is proposed to be entertained for a period of one year in the first instance. The estimated cost of the establishment per annum is as shown below :--

Remarks.—With a view to ameliorating the conditions of mill workers and weaning them away from drink by providing healthy refreshments at reasonable rates a canteen has been started at the corner of Sayaney Road and Elphinstone Road under the auspices of the City Prohibition Committee from 21st August 1949. The Indian Tea Market Expansion Board has given the free services of its staff from some time and has promised all co-operation in running the canteen. To begin with, the following staff has been appointed :—

1 Cook on a basic salary of Rs. 55 per mensem plus two free meals or As. 12 in lieu thereof.

2 Assistant Cooks on a basic salary of Rs. 40 per mensem each plus 2 free meals or As. 12 in lieu thereof.

3 Order boys on a basic salary of Rs. 30 per mensem plus 2 meals or As. 12 in lieu thereof.

2 Table boys on a basic salary of Rs. 25 per mensem plus 2 free meals or As. 12 in lieu thereof.

1 Cleaner on a basic salary of Rs. 20 per mensem plus two meals or As. 12 in lieu thereof.

The expenditure on the above staff is estimated at Rs. 6,000 per annum. In addition it is necessary to appoint one Manager and two Assistant Managers on Rs. 80 and 50 per mensem respectively plus free meals when the Indian Tea Market Expansion Board withdraws its staff. The expenditure on this staff will be Rs. 3,550 per annum. The annual recurrent expenditure on staff will be Rs. 9,550 plus Rs. 2,100 for rent and Rs. 1,000 on Electricity and Sundry bills, *i.e.*, a total of Rs. 12,650 per annum. The annual expenditure on raw materials has been estimated at Rs. 40,000 bringing the total annual expenditure to Rs. 52,650. As against this expenditure the canteen is expected to yield about Rs. 54,000 per annum by sale proceeds and Rs. 1,800 by way of rent bringing a net profit of Rs. 3,150 per annum.

Remarks.—Government created temporarily in July 1947 a post of the Director of Archives, Bombay, in the Secretariat Record Office, Bombay, with a view to putting the scheme of the reorganisation of the Secretariat Record Office on a sound basis. The pay scale attached to the post is Rs. 500—25—700—E.B.—50—1,150. The Director is not only in the charge of the Secretariat records but his jurisdiction has been recently extended to whole of the State thus putting him virtually in charge of all Government records except those in the Alienation Office, Poona, which is in the charge of the Commissioner, Central Division. The Director is however in charge of the research, preservation and publication of the Alienation Records. As the Secretariat Record Office in the process of its reorganisation is beginning to function as the archival centre for the province and as its functions are accordingly gradually increasing, the need to keep it permanently in charge of a separate officer of outstanding archival experience has become inevitable. Remarks.-With a view to facilitating efficient administration of certain heavy talukas of the Kolaba District, Government considered it expedient to adjust the boundaries of talukas of Karjat, Pen and Panvel in Kolaba District and to create a new taluka called the Khalapur Taluka for a period of two years in the first instance with effect from 1st August 1945. Accordingly the following staff was sanctioned for this new taluka for a period coterminous with the period of the taluka :----

Remarks.—The cadre of Civil Judges (Junior Division) consisted of 112 Judges prior to 1931. In 1931-32 as a measure of economy ten of these posts were retrenched by abolishing or linking certain courts. The ten posts though retrenched were not abolished but kept vacant. Subsequently in 1934-35 with the increase of work six of the ten posts were revived permanently. In 1939 due to heavy arrears in the Districts two more posts were temporarily revived; these two posts have been continued from time to time and the present sanction expires on the 28th February 1950. The institution of suits has been on the increase with the result that arrears have piled up. On the recommendation of the High Court it is now proposed to restore the two posts permanently to the cadre of Civil Judges (Junior Division). The pay scale of the posts is Rs. 300-300-320-20-500-30-650.

Remarks .- The Section-writers on the Appellate Side of the High Court are at present being paid from their earnings received from the parties and they are not considered as Government servants. They are therefore not entitled to the privileges which Government servants enjoy. The Section-writers on the Original Side of the High Court were absorbed into Government service in 1942, while the section-writers in the molussil were absorbed into Government service in 1948. The High Court therefore recommended that section-writers on the Appellate Side of the High Court should also be absorbed into Government service and that six posts of section-writers in the scale of Rs. 75-5-140-Efficiency Bar-8-220 should be created for the purpose. Government has accepted the recommendation of the High Court and has decided to sanction six posts of section-writers in the scale of Rs. 75-5-140-Efficiency Bar-8-220 and to absorb the existing section-writers in those posts. It is estimated that an expenditure of about Rs. 10,080 under "Pay of Establishment" and Rs. 3,600 under "Dearness Allowance" will be incurred during the financial year 1950-51.

Remarks .-- The Bombay City Civil and Sessions Court was established on the 16th August 1948. Four posts of Judges (including the Principal Judge) were created for the Court. The post of Principal Judge is permanent and the remaining three posts are temporary, having been created for a period of one year in the first instance. The Principal Judge assumed charge of his appointment on the 16th August 1948 and the remaining Judges on the 1st September 1948. The work in the Court has steadily increased with the result that it has become necessary not only to continue the three temporary posts of Judges up to the 28th February 1950, but also to sanction one more post of Judge for a period of one year in the first instance. Judging from the working of the Court, during the past year, it seems that four Judges (including the Principal Judge) is the barest minimum required for the proper working of the Court. It is, therefore, proposed to make permanent, with effect from the 1st March 1950, the three posts of Judges which have been continued further up to the 28th February 1950. The average annual cost of the proposal comes to Rs. 72,000 (recurrent) as shown below :--

Remarks.—The Jail Reforms Committee appointed by Government in September 1946 recommended inter alia the installation of power-looms in Jail Factories. The recommendation was accepted by Government and the Inspector General of Prisons was requested to prepare a detailed scheme in this connection. The Inspector General of Prisons in consultation with the Director of Industries, Bombay, submitted a scheme for the introduction of power-looms in the four Central Prisons at Yeravda, Ahmedabad, Belgaum and Nasik Road and the three District Institutions, viz. the Arthur Road Prison, Bombay, the Thana District Prison and the Borstal School, Dharwar. Government administratively approved the scheme. The scheme envisaged starting of a power-loom factory with 12 power-looms at each of the four Central Prisons and with 4 power-looms at each of the three District Institutions. Government has, however, now decided to start a power-loom factory only at one Prison, viz. Ahmedabad Central Prison. The scheme is not only self-supporting, but is expected to be profit-yielding also. Apart from improving the production of textiles in the Jail and making it more paying, the scheme will provide training to prisoners in the operation of power-looms, etc., so that they could readily get work in mills on release. The provision required on account of the staff proposed to be sanctioned and on account of the power-looms, etc., for the scheme during the year 1950-51 is as shown below :—

Remarks.—The Jail Reforms Committee appointed by Government in September 1946 made a recommendation inter alia for the erection of one leather factory in one of the Jails, to be equipped with modern machinery and providing both manufacture and training. The Director of Industries was requested to consider the question of starting a leather factory on the lines of the recommendation of the Committee at the Yoravda Central Prison, and to submit a detailed scheme, regarding the type of leather goods, which could be manufactured, the machinery and equipment, the staff, the provision for training etc. The Director of Industries accordingly submitted a detailed scheme. The Inspector General of Prisons scrutinised the scheme and suggested modifications to it to a certain extent. Government accorded administrative approval to the scheme as modified by the Inspector General o Prisons. It is now proposed to start the leather factory at the Y. C. Prison from the 1st April 1950. The machinery proposed to be installed is the minimum required for an economic unit and is capable of producing 200 pairs or chappals per day. The scheme is not only self-supporting, but is expected to be profit-yielding also. Apart from this, the scheme has an additional attraction of employing and training prisoners who will be able to earr a living as skilled men on release. The provision required on account of the staff proposed to be sanctioned and or account of the machinery, etc., for the scheme during the year 1950-51 is as shown below :--

Remarks.—A staff of 2 Sub-Inspectors and 22 Head Constable Writers was sanctioned in 1941 for postal interception duties at the various Post Offices in Greater Bombay. This staff has been continued since then on a temporary basis and is looking after the postal interception work. The strength of this branch has since been augmented to cope up with the increased interception work. By means of such interception the Special Branch of the Criminal Investigation Department obtains very valuable information, whereby it is possible to take adequate steps to prevent breach of law. Subversive activities are in these days on an increase. It is therefore necessary that this staff should be made permanent.

A staff of 4 Head Constable-Writers and 5 clerks was sanctioned in 1944 and 1941 for the Record Office, Special Branch I and for the Special Branch I Office, respectively. The work of the Special Branch has increased considerably and there is no sign of any decrease in work. It is therefore necessary to make this staff permanent.

Remarks.—With a view to encourage the enlistment of educated men in the Police Force Government had sanctioned the scheme of grant of advance increments of pay to constables of the Bombay District Police Force in proportion to educational qualifications. The principle of offering inducement by service advantages to educated men having once been accepted it could not be withheld in the case of the Bombay City Police men, as the necessity for such a concession in the Bombay City Police Force is as keen as it is in the districts. The policy of Government is to encourage, as much as possible, recruitment of educated men to the Police Force. Several measures have been taken towards achieving this, the grant of advance increments of pay being one of them. Government, therefore, proposes to sanction the scheme of grant of advance increments of pay to constables of the Bombay City Police in proportion to educational qualifications as in the case of the Bombay District Police Force, with slight changes. The number of advance increments proposed to be given is 3 to Matriculates and above, 2 to those who have passed the Vth and VIth Standards English and 1 to those who have passed the IIIrd and IVth Standards (English) and Standard VII (Regional).

The population of the Dangs is 24,576 comprising mostly of Bhils and Konkani Kunbis with an admixture of Warlis, Gamtas and others. The "Dangs" is "Bhagat Minded" and it is considered that it would be necessary for some time to come at least to take medical aid to him at his door rather than expect him to approach a medical centre when required. It is, therefore, proposed to start two mobile dispensary Units for the District with effect from 1st April 1950 to cater to the needs of the population with the staff as shown in the statement below.

Government has sanctioned a scheme for the current year at an estimated cost of Rs. 29,790 (Recurring Rs. 14,890, Non-Recurring Rs. 14,900). Under the scheme, Committee has opened one main centre and six sub-centres for development of village industry. The main activities consist of training in spinning and weaving, oil pressing, bee-keeping, etc. The Committee intends to extend the scheme during the next year and the total provision asked for is Rs. 59,180 (Recurring Rs. 46,380, Non-Recurring Rs. 12,800) as detailed below :--

Remarks.—The question of the abolition of all undergraduate teaching from the Royal Institute of Science and of leaving it to concentrate its attention on post-graduate and research work was engaging the attention of the Advisory Committee of the Institute for many years. In the year 1943 the Advisory Committee resolved not to recommend the abolition of Junior and Senior B.Sc. Classes but at the same time expressed its opinion that the ultimate object should be to convert the Institute into a purely research Institute and that in order to intensify the training in research and to accelerate the output of research work, Government should take immediate steps to create new posts of Research Assistants and to appoint to these posts persons of high research qualifications and experience. A post of a Research Assistant in Chemistry was accordingly created for a period of two years in the first instance from June 1944 and it has been continued since then. A similar post of a Research Assistant in Physics was first created for the academic year 1947-48 in the first instance and it has also been continued since then. A second post of Research Assistant in Organic Chemistry was created for a period of one year in the first instance up to 10th March 1949 and has also been continued since then. The tenure of the three posts of Research Assistants expires in March 1950. Such periodical continuance of the posts of Research Assistants unsteady and also hampers the research work. It is, therefore, proposed to sanction the posts on a permanent basis.

Remarks.- In view of the shortage of trained graduates for appointment as Assistant Masters in Government Secondary Schools and Training Institution³, Government sanctioned, as an experimental measure, a scheme for the training of 25 teachers (15 men and 10 women) at the Government Secondary Training Colleges at Government cost annually with effect from 1947. This experiment has proved to be successful and the institutions concerned are now in a position to maintain a fairly satisfactory percentage of trained graduates. In view, however, of the establishment of new Training Colleges, and also of the increase in the inspecting staff the need for trained graduates is still felt. It is, therefore, proposed to make a provision of Rs. 15,000 in the next year's budget and to continue the scheme with such number of teachers as can be deputed within that provision.

The Institute is also paid recurring grants in connection with the maintenance of a medical social work section. Remarks.—One of the greatest draw backs of our educational system is that vocational guidance and information service is completely lacking. The question of building up such a service has been engaging the attention of Government for some time. The establishment of a vocational guidance bureau is assential from the point of view of (1) supplying information to pupils regarding the various trades and professions available and (2) of determining the pupils aptitude for particular jobs.

2. The immediate objectives of this organisation would be-

(i) the collection of information relating to different occupations and its dissemination to pupils;

(ii) standardisation of psychological tests with a view to ascertain aptitudes for different vocations of boys in secondary schools in this Province;

(iii) preparation of standard record cards with the object of instituting a proper system for the collection of suitable data in respect of secondary school boys.

3. In order to carry on this work, a small nucleus organization would be necessary. The organization contemplated is-

(a) 1 Class I Officer;

(b) 2 Non-Gazetted posts in the grade of Rs. 160-10-250. These persons will be trained M.A.s and B.A.s possessing special aptitude for this kind of work.

(c) 1 Qualified Typist Cierk in the grade of Rs. 75-5-200.

It is proposed to sanction the scheme and the staff in connection therewith for three years in the first instance. The proposal involves recurrent and non-recurrent cost as shown below :---

Remarks .- So long the nursing staff at the various Government Hospitals in the State was under the control of the Nursing Associations and as the financial position of these Associations was not satisfactory, the Associations provided very inadequate staff at these hospitals. Since 1947, the nursing arrangements at all Government Hospitals have been taken over by Government and the staff is now entirely under the Government control. The nursing staff at the various Government Hospitals in the State is quite inadequate to provide efficient nursing of patients at the hospitals. The condition at a majority of the Government hospitals in the mofussil especially, is very unsatisfactory. The Health Survey and Development Committee (which is widely known as Bhore Committee) in its report which was made after great deliberations and mature considerations has recommended that the scale of nursing staff to beds should be one nurse to 2.5 beds, if the existing condition of understaffing the hospitals with consequent overwork is to be improved with due consideration of the existing unsatisfactory condition and in order to provide adequate nursing arrangements at these hospitals for the efficient working of the hospital in the interest of patients it was proposed to Government to provide nursing staff at a ratio of one nurse to 2.5 beds where training schools for nurses and midwives exist and at other hospitals at the rate of one nurse to every 5 beds. In view of the financial stringency it is not possible for Government to give effect to the above proposal at once at any of the institutions to the proposed revised rates. Government have however decided to give effect to the part of the proposal. For this purpose, it will be necessary to create the following additional appointments on the nursing establishments at the Government Hospitals :---

Remarks.-The Society for the Rehabilitation of Disabled and Crippled children has been working since 1947 and is doing very useful work in the treatment of Poliomyelitis. It may be recalled that recently there was a sudden outbreak of the disease in the city which caused considerable anxiety to the public and it is feared that it may start again during the next monsoon. The Society proposes to construct a children's Orthopaedic Hospital and has asked for a grant of Rs. 5 lakhs for the purchase of land and equipment and the construction of a building required for the Hospital and a maintenance grant of Rs. 1,80,000 per annum for it. Government has sanctioned a grant of Rs. 5 lakns to the Society during the current year for the above purposes on the following conditions :-

(1) the grant shall be utilised only for the purposes mentioned above,

(2) the plot to be purchased must be approved by Government in the first instance,

(3) plans and estimates of the buildings to be constructed on the plot should be subject to the previous approval of Government,

(4) the buildings constructed on the plot of land shall always be used for the purposes of the Children's Orthopaedic Hospital for the rehabilitation of disabled and crippled children. If, at any time, they cease to be so used the buildings, as well as the plot, shall vest absolutely in Government. For the purpose of this condition, the decision of Government as to whether the buildings are being used for the purposes of the children's Orthopaedic Hospital for the rehabilitation of disabled and crippled children or not shall be final and conclusive, and no reference in this respect shall lie to a Court of Law,

(5) the affairs of the hospital shall be managed by a Managing Committee on which Government should have the right to nominate at least 1/4th of the total number of members.

It is also proposed to give to the Society for the maintenance of the proposed Orthopaedic Hospital a recurrent grant equal to 1th of the approved expenditure minus the fees received from patients, subject to a maximum of Rs. 75,000 with effect from the next year, if the Government of India contribute a similar amount, subject to the following conditions :--

(1) the hospital shall be open for inspection by the Surgeon General or by any other officer whom he or Government may depute for the purpose;

(2) admissions to the hospital shall be made irrespective of caste, creed or community;

(3) the schedule of fees to be charged at the hospital and any amendment or addition thereto, shall be subject to the previous approval of Government;

(4) the conditions of service, including pay and allowance, honoraria, benefit of pension or contributory fund..... etc., of the staff of the hospital shall be subject to the previous approval of Government;

(5) the grant will be calculated only on expenditure approved by the Surgeon General;

(6) the affairs of the hospital shall be managed by a Managing Committee on which Government shall have the right to nominate at least 4th of the total number of members.

The grant will be sanctioned for a period of one year in the first instance, the position being reviewed thereafter.

Remarks.-Most of the existing surgical and other equipment in the Government Hospitals in Bombay and Poona has become very old and unserviceable, as very little has been spent on this item during the last seven or eight years. Extensive replacements of equipment have, therefore, become absolutely essential and new types of equipment and instruments are required to be purchased immediately in order to ensure the smooth and efficient working of these hospitals and to keep the teaching hospitals abrest of the times. It is estimated that a sum of over Rs. 51 lakhs is necessary to equip all the Government Hospitals in Bombay and the Sassoon Hospitals, Poona, properly, but as it is not possible to find all the funds required in one year, it is proposed to add to the equipment gradually by sanctioning special grants for the purpose annually. A special non-recurring grant of Rs. 46,000 is therefore proposed in the next years budget as shown below :---

Remarks .- On the recommendation of the Ad Hoc Committee appointed by Government in 1942 for considering ways and means for ameliorating the conditions of the Backward Classes, Government decided to provide annually in the budget estimates an amount of Rs. 30,000 for slum clearance in Backward areas. The provision of Rs. 30,000 was first made in the budget estimates for 1943-44 and has since been made every year. In the year 1949-50 the provision of Rs. 30,000 was made in the budget as usual and an additional provision of Rs. 1,70,000 was also made as Government felt that the time had come to make a proper beginning in the matter of slum clearance in backward areas. On account of absence of proposals from local bodies it has not been possible to utilise the provision made every year, and so far, no progress has been made in the matter of slum clearance in backward areas. Recently some municipalities have come forward with their schemes of slum clearance for backward classes and the Board of Health has recommended that such municipalities should be paid grants in-aid up to 50 per cent. of the cost of the schemes. Government, therefore, feels that during the next year more municipalities would come forward to take advantage of this provision and undertake slum clearance schemes in their areas. Government proposes to make in the next year's budget a total provision of Rs. 2 lakhs including the usual provision of Rs. 30,000 for grants to municipalities for slum clearance schemes in Backward class areas. Additional funds to the extent of Rs. 1,70,000 will be thus necessary during the next year.

Remarks.— There is a leper colony at Kolhapur, known as the Shenda Park Leper-Colony in which 115 lepers are accommodated. There is accommodation for 400 lepers in the colony but it has not been possible to utilise this accommodation owing to the difficulty of water supply. It has not been possible for Government to implement its Post-War Reconstruction Scheme regarding the establishment of leper colonies in this Province for want of suitable sites and it is considered that the existing leperhomes should be expanded to the fullest possible extent. The Public Health Engineer to Government was therefore asked to draw up a scheme for the supply of water to the Leper Colony at Kolhapur. While drawing up the Scheme, the Public Health Engineer found that the Tanners colony and other developing areas enroute, which are clamouring for supply of water, could also be included in the scheme. He has therefore drawn up a scheme for the supply of water to the Leper Colony. The Scheme is estimated to cost Rs. 2,38,800 and to bring in an annual revenue of Rs. 37,950. It is proposed to take up the work during the year 1950.51, and to make a provision of Rs. one takh in the budget estimates for 1950-51.

Remarks.— The question of successfully tackling malaria in this State has been engaging the attention of Government for several years. A permanent malaria organisation has been established in the State and it has carried out malaria surveys and started anti-malaria measures in Kanara, Dharwar, Poona and Thana Districts. Anti-malaria measures have also been started in the current financial year (1949-50) in the Districts of Ahmedabad, Bijapur and Kaira. The malaria survey in *Panch Mahals* was carried out during the year 1948-49 and comprehensive scheme for control in the *Panch Mahals* has been formulated. Panch Mahals is a backward District and the incidence of Malaria is very high. Survey work alone is of no benefit to the people unless it is followed by control measures. The expenses incurred on survey work, will therefore be wasted unless control measures are introduced, without delay. Remarks.-The question of successfully tackling malaria in this State has been engaging the attention of Government for several years. A permanent malaria organisation has been established in the State and it has carried out malaria surveys and started anti-malaria measures in Kanara, Dharwar, Poona and Thana Districts. Remarks.—With a view to control the quality of fruit products manufactured in India, the Government of India have promulgated the Fruit Products Control Order, firstly under the Defence of India Rules and later continued under the Essential Supplies Temporary Powers Act. This Control Order seeks to control the quality of the various products manufactured in India on the basis of certain specifications which have been laid down. Since 1st July 1946, when the Control Order Scheme was enforced, the operation of this Order has rested with the Central Government. As development of agriculture and horticulture and of industries ancillary to it, like fruit preservation, is primarily a concern of the State Governments, the Government of India have with effect from the 1st March 1949, transferred to this Government the work of the enforcement functions under the Order as far as the Province of Bombay is concerned. The Government of India, however, continue to co-ordinate the activities in all the Provinces by suggesting and laying down quality standards and also handle other matters of all India importance such as imports and exports, tariff, freight, cess, etc.

Remarks.—The post of Horticulturist to Government in the Indian Agricultural Service, which was formerly held by Dr. G. S. Cheema, was held in abeyance on Dr. Cheema's appointment to officiate as Director of Agriculture, and a temporary post of Horticulturist to Government in the Bombay Agricultural Service, Class I, was created and Mr. S. R. Gandhi appointed to it from the 28th January 1946. The post of Horticulturist in Class I of the Bombay Agricultural Service has since been continued on a temporary basis and its present sanctioned period will expire on the 28th February 1950. It is now proposed to continue this post on a permanent basis with effect from the 1st March 1950. The main duties of the Horticulturist to Government are (i) teaching of Horticulture at the College of Agriculture, Poona, (ii) research work in horticulture and (iii) supervision of the horticultural work in the State. As these duties are not only very important but are also of a permanent character, it is essential to make the post permanent. The ultimate annual recurrent cost is Rs. 13,200.

Remarks.—It is well known that our farmers prepare farmyard manure out of the daily wastes collected from their cattle byres, etc. In many cases, the method adopted by the farmers is unscientific and unhygienic, which needs to be improved to a great extent. The farm refuse such as weeds, stubbles, stalks and trash is either burnt or thrown

away. Similarly the cattle urine which is very rich in nitrogen is almost completely wasted. Cattle dung is partially used for fuel purposes by most of the cultivators. The available dung and litter is either thrown in heaps or in irregular pits at any vacant place in the village near the cattle byre, thus spoiling the village sanitation.

The resulting manure is not only poor in quality but is quite meagre in quantity. The proper method of preparing farm-yard manure consists in utilising all the available farm and house-hold wastes, as bedding under the cattle, for absorbing the valuable urine.

With a view to improving the quality and output of farmyard manure in the State, Government has sanctioned, in October 1949, a scheme at an estimated cost of Rs. 35,14,177 spread over a period of two years and five months from October 1 of this year to February 29, 1952. The scheme is designed for improvement of cattle byres, conservation of all organic refuse from fields and villages and its use as bedding under the cattle for absorbing urine which is rich in nitrogen and systematic construction and filling of manure pits.

A subsidy of Rs. 2 will be granted for every new pit dug.

The scheme is calculated to produce about 1,05,00,000 tons of farmyard manure per year and to bring about an increase of 50 per cent. in the quantity and of 0.7 to 1.3 per cent. in the nitrogen content of the manure produced in the State. The additional production of foodgrains by application of the manure will be about 56,000 tons.

Remarks.—In order to give practical training in animal husbandry under the revised course of studies for B.So. (Vety.) degree of the Bombay University, extra mural training for a period of three months has been made compulsory during the 3rd and 4th year of the course before a student can appear for the final year examination of the veterinary course. The students are required to go for extra mural training to various dairy cattle breeding farms, etc., at Malad, Palghar, Poona, etc. From previous experience, it is found that it is difficult for the students to manage this expenditure within the amount of stipend. It is, therefore, proposed to grant, each year, to students in the 3rd and 4th year of the B.Sc. (Vety.) degree course, Rs. 50 per mensem each *extra* during the period of mural training for three months and also III Class Railway fare and actual bus fare for journey in this connection. The expenditure involved on account of this proposal, during the year 1950-51, will be Rs. 7,000 as shown below :---

Remarks.-Artificial Insemination has 'come to be 'recognised as the most scientific and expeditious method of breeding improved livestock of the desired type. The method is being successfully employed for improvement of all kinds of livestock in Europe as well as in America and the process may be said to have passed the experimental stage. It is, therefore, proposed to introduce this remarkable method of building up improved livestock in our State. Government has accordingly decided to start an Artificial Insemination Service Scheme. To extend the benefits of the service, it is proposed to open centres and sub-centres in various intensive dairying and cattle breeding tracts of the State. Since survey work of Poona proper and of the villages round about supplying milk to Poona has been completed by the Dairy Development Section of the Agricultural Department it is proposed to start the work of artificial insemination by opening a centre at Poona (at the Boat Club buildings, Kirkee) and then slowly to spread the service to other parts of the State. In addition there will be two more artificial insemination centres one at Aarey and the other at Anand. The work of these centres will be co-ordinated by the proposed main centre at Poona. It is estimated that there are about 10,000 animals in Poona and the round about villages. In the beginning, one-third of this number, i.e., about 3,000 animals, would be brought under the scheme. The cost of the scheme is estimated at Rs. 1,75,878 (non-recurring Rs. 49,280 and recurring Rs. 1,26,598) spread over a period of three years. It is proposed to charge a fee of annas 8 for members of co-operative societies and Re. 1 for non-members for each animal receiving service under the scheme. The total cost involved during 1950-51 will be Rs. 88,958 as shown below :----

Remarks.—In paragraph 5 of Chapter VII of its report, the Agricultural Credit Oragnisation Committee has recommended that Government should contribute towards the cost of the salaries of the secretaries if the Societies are unable to do so on condition that Societies registered on unlimited basis distribute no dividend in respect of the years for which grants are given and contribute all they can towards their secretarial expenditure without increasing their lending rate beyond 6.25 per cent. The Committee has further recommended that this assistance should be available for a period upto the first ten years of their existence. After careful consideration of the proposal submitted by the Registrar of Co-operative Societies and Director of Agricultural Marketing and Rural Finance in this connection, Government has approved the following proposals for two years in the first instance and directed that the position of rural credit societies after the end of the Co-operative year 1950-51 should be reviewed with a view to seeing whether any modifications are necessary in the light of the experience gained :—

A grant to the extent of one per cent. of the total working capital of the primaries should be placed at the dispos of the Registrar at the beginning of the Co-operative Year commencing from 1st July 1950 and the Registrar empowered to give subsidy as indicated below upto a maximum of 2.5 per cent. of their working capital :---

(a) Societies which are of not more than 10 years' standing at the commencement of the Co-operative Year, in respect of which assistance is claimed, will be eligible for a subsidy towards their secretarial cost with effect from 1st July 1949, subject to the condition that the contribution to the Reserve Fund by such societies shall not exceed one per cent. of the working capital for the years in respect of which the subsidy is granted;

(b) Societies which are of more than 10 years' standing will be eligible for a similar subsidy for a period of five years, beginning with 1st July 1949, subject to the condition that the assistance so made available shall be limited to the actual deficit i.e. deficit arrived at without contributing anything towards the Reserve Fund for the years in respect of which the assistance is claimed.

(c) In case of societies with limited liability, subsidy on the above scale shall be granted subject to the condition that the provision for payment of dividend of their share capital shall not exceed the Bank rate or 3 per cent. per annum, whichever is less for the years in respect of which subsidy is granted.

2. The total expenditure on the above account estimated on the basis of one per cent. of the total working capital of the rural primaries is Rs. 4,17,000 per annum and grants will be payable to the Societies after 30th June 1950.

(Central) to consider and report to Government on measures necessary for promotion of rural handicrafts and industries. The Committee under Chapter 4 of its report recommended that village industries centres should be established in selected villages. The scheme in question is on the lines recommended by the Committee. The two wool works centres to be opened at Jumnal and Javla in the districts of Bijapur and Sholapur respectively will be training *cum*-production centres. To begin with it is proposed to train 80 persons in each of the two centres on payment of daily wages—to be considered as stipends during the period of training for three months. These centres are expected to become self-supporting within a period of three years.

Remarks.—One of the best means of raising the standard of living particularly in the rural areas is through the means of Co-operative Organisation. The question of bringing home to the masses the benefits of Co-operative Organisation through some adequate means of publicity has been engaging the attention of Government. The Provincial Co-operative Council to which the matter was referred to, resolved that wide publicity to the Co-operative movement is needed so as to make the public co-operative minded, particularly through the medium of advertisements in the press, radio, posters, leaflets and films and requested Government to give adequate assistance financial aid or otherwise to the Bombay Provincial Co-operative Institute for the purpose. The Institute was, therefore, consulted as Co-operative Education and propaganda are two of its most important functions. The Institute considers, that the work of publicity could be done with additional staff taken up for the purpose. The Institute's office in Bombay is to act as a full fledged co-operative information service diffusing the infomation gathered by it to the regional co-operative schools by means of suitable press notes and bulletins. It is proposed to employ an additional officer who is a graduate with some experience of co-operative matters in the Institute's Bombay Office. Similarly

Remarks.-The six tanning Demonstration parties under the control of the Industrial Co-operatives and Village Industries section of the Co-operative Department are being continued from year to year for the last ten years. These demonstration parties are doing very good work in the matter of development of tanning industry in this State. These parties are visiting important centres and training the artisans in improved methods of curing, tanning, dyeing and finishing of hides and the use of improved appliances. On completion of training the trained artisans are organised on Co-operative basis in many centres and necessary assistance in the form of technical advice and financial help, assistance in securing plots of land, raw materials etc. are being made available to tanners and their Societies. Tanning and leather working as cottage industries in this State are next in importance to the hand-loom weaving industry both from the point of view of turnover and the number of persons employed. Although considerable spade work has been done towards the revival of village tanning industry the work done so far has only touched the fringe of the problem. Moreover methods of production also change and as such Government does not visualise a point of time when it can be said that the villagers have been taught all that could be taught and no further training is necessary. It is therefore considered necessary that instead of continuing these parties on temporary basis from time to time as is being done from 1938, they should be converted into permanent features the technical staff attached to them being made permanent and pensionable with effect from 1st April 1950. Remarks.—The scheme for development of marketing and establishment of regulated markets and formation of co-operative sale societies was administratively sanctioned in the year 1944. The staff for the scheme in question was first sanctioned in the year 1945 and was continued from time to time. Government had already indicated its plan of comprehensive development of Marketing in the State as a whole and accordingly has fixed the target to regulate approximately 110 major markets during the period of 5 years ending 31st March 1952. So far, 65 markets have been established. In view of the merger of various States in the Doccan and the north of this State, it is very likely that more number of markets may have to be regulated over and above the target fixed. With the increase in the number of regulated markets and merger of various States in this Province, considerable increase of work in marketing is visualised. The staff is being continued on temporary footing from time to time and the sanctioned period expires on 28th February 1950. It is also unlikely that the reason for which the staff was created will cease to exist in future. The grades of the staff together with the average cost are as follows :—

Remarks.—The Nanawati Committee appointed by Government to consider the question of Agricultural Finance had recommended that there should be closer control over supervisors and for this purpose there should be a committee for each district. This was ratified by the Provincial Co-operative Conference held at Bombay from 11th to 13th April 1948. Accordingly the Registrar was directed to take steps for the organisation of District Supervision Committee. These Committees are to work under the direct control of the Provincial Board of Supervision and are invested with the work of superintendence, direction and guidance of supervision staff. The Committees are also authorised to recommend in appropriate cases transfer or disciplinary action against the supervisors to the Deputy Registrar or the Assistant Registrar. Each Committee consists of the following members :—

1. Assistant Registrar of the division concerned.

2. Chairman of the District Central Co-operative Bank or of the Provincial Bank or his nominee.

3. Chairman of the District Co-operative Board.

4. One representative of supervising unions in the district.

5. One representative of the non-credit Agricultural Institutions. The Chairman of the District Supervision Committee should be elected by the members and the District Co-operative Officers should be the Secretary.

In accordance with rule 13 of the Rules Governing the constitution of the Committee, the non-official members are to be paid travelling allowance, daily allowance, etc. It is, therefore, necessary to place at the disposal of each District Supervision Committee Rs. 500 per year to meet its expenditure regarding travelling allowance, dearness allowance, contingencies etc. An aggregate provision of Rs. 13,500 should be made in the next year's budget.

Remarks.—With a view to have effective supervision on the Co-operative Societies affiliated to the Supervising Unions, the Supervisors working under the Unions were treated as temporarily transferred to Government service in the corresponding cadre in the Co-operative Department for a period of five years with effect from 1st April 1946. The number of Supervisors as on 1st April 1946 when they were given status of temporary Government servants was 160 and subsequently 23 posts were sanctioned as the number of societies increased. The number of societies have all the while been increasing and on 30th June 1949 there were 6,833 societies affiliated to the Supervising Unions. On an average a supervisor can supervise 25 societies and hence 273 posts of supervisors are required to carry out the work effectively. It is therefore proposed to create 90 posts of Supervisors comprising of 60 posts of Supervisors and 30 posts of Assistant Supervisors for one year in the first instance with effect from 1st April 1950.

Remarks.—Since April 1946 Government has ordered that for a period of five years, of the Supervision staff of Co-operative Societies, the senior supervisors, supervisors and assistant supervisors, are to be treated as temporary Government servants. The scheme of Supervision aims at effective supervision over its affiliated societies by giving proper guidance in the matter of its business and other transactions and seeing that accounts, etc., are properly maintained and the working of the societies is conducted in conformity with the principles of co-operation. The staff for supervision will require to be augmented as a result of the merger of States in the Province and it is therefore necessary to make enhanced provision in order to meet it. A provision of Rs. 1,40,000 has already been made in the budget estimates for 1950-51 on the existing basis. It is necessary however to provide an additional amount of Rs. 50,000 for the reason stated above. The scheme of supervision is very important from the point of view of successful and efficient working of the affiliated co-operative societies.

Remarks.—The main functions of the Bombay Provincial Co-operative Institute is to impart education in Co-operative matters to members of co-operative societies and workers in the Co-operative field and to publish literature relating to Co-operative matters as means of propaganda for spread of the movement. The two main sources of revenue are donations from sympathisers and subsidy from Government. This means that Government has to pay grants to the Institute to cover the deficit in its budget after all other sources of revenue are taken into account. The budget of the Institute is, therefore, subject to Government approval.

2. The functions of co-operative education and propaganda in the districts are at present being carried on by the District Co-operative Boards which are financed by the Institute. Under the new scheme District Co-operative Boards are to be set up in each district. The Institute has proposed that the Boards be given enhanced grants in order to increase their activities in the field particularly of propaganda. Government has approved the setting up of these Boards.

- 3. The three main items for which the Institute requires Government grants are :---
  - General Work,
  - Education Work,
  - District Co-operative Boards.

As regards education work the Institute is separately subsidised for its Co-operative College and regional schools set up in accordance with the recommendations of the Co-operative Education and Training Committee in 1946 as approved by Government. The present grant is required for general work and District Co-operative Boards in addition to the usual amount of Rs. 50,000 provided in the budget estimates for 1950-51 under "42-Co-operation-C-Grants-in-aid Grants to Supervising Unions." Under the heading of general work comes the holding of conferences functions and celebrations publication of journals and other cognate literature, maintenance of reading room and library, the staff and premises of the Institute and general expenditure. So far as the District Co-operative Board are concerned, subsidy is required for salaries of Training Inspectors, staff, secretary of Training Classes, printing and stationery, postage, travelling allowance of members, library, furniture, etc.

It is estimated that an amount of Rs. 35,400 would be required during 1950-51 on the above account.

For similar subsidies in other States areas which are also backward it is estimated that an amount of Rs. 9,000 would be required. So far as the rest of the province is concerned it is estimated that an amount of Rs. 35,000 would be required for giving subsidies to village societies, in order to encourage and foster their growth. The total amount required, therefore, comes to Rs. 79,400 of which an amount of Rs. 29,800 has already been provided in the normal course in the budget for next year. Co-operation is playing a very vital part in the development of the rural areas and it is necessary that in the early stages at least Government aid is made available. It is, therefore, necessary to provide the remaining amount of Rs. 49,600 for the above purpose in the next year's budget.

Remarks.—The Fisheries Section attached to the Department of Industries was reorganised into an Independent Department for a period of five years from April 1945. The period of five years of the reorganised department thus expires in April 1950.

The Department has from its inception made rapid progress. It has successfully achieved—to a great extent the main object of development of the Provincial fisheries and the cultural and economical development of the backward fishing community. It controls at present 36 fish curing yards, 9 schools and a well-equipped technological [aboratory producing popular fish products, viz. Bombay-Brand Shark Liver Oil, Elasmin liquid and pearls, fish meal, gelatine, etc. Their manufacture is undertaken on a commercial scale.

The Department has also begun work on several Post-War Reconstruction Schemes the most outstanding of which is the establishment of the Taraporévala Aquarium at Bombay, which will soon be thrown open to the public. It will not only be a centre of popular instruction and enlightenment to the lay-public but also an institution for research by serious scientific workers.

The Department has been able to fulfil one of the main objects underlying its establishment. Increase in the City's supply of fish has been one of its foremost responsibilities, and this the Department has been able to attain it to a large degree. The present quantity of fish landed is thrice as much as that in 1933, when the Department was begun on a small scale. The fish curing industry has also received a great fillip ever since the Department assumed control of the fish curing yards from the Salt Department.

The Department has, however, touched merely a fringe of the great field yet lying unexplored and much useful work remains to be accomplished.

The great volume of fruitful work achieved for the benefit of the fishermen and the public shows that it has steadily gained in influence and prestige. There is little doubt that the Department's record to date encourages the hope that its continuance on a permanent basis will place on an enduring basis the means of its ever-growing the beneficial work. It is, therefore, proposed to make permanent the temporary posts indicated in the enclosed Statement "A".

(i) King Edward VII Technical School, Dhulia.-The students of this school have been using the machinery of the Government of India Technical Training Centre since its start. With the closure of this Centre and consequent shifting of its machinery, the students are facing difficulties in their practical work. The provision of Rs. 26,000 made during the current year is totally inadequate looking to the number of students and courses. A supplementary provision of Rs. 20,800 is, therefore, necessary.

(ii) School of Industry, Sholapur.-At present the school is housed in Municipal Buildings and it is proposed to shift the school to the North-Cote Technical High School compound with effect from March 1950. It was presumed that the Sholapur Municipality would make a free gift of the equipment of the school to the Government. However the Municipal Authorities have decided to do so. Hence a provision of Rs. 5,000 only for the minimum essential equipment is necessary.

(iii) School of Industry, Satara.-The present equipment for the foundry, smithy and handloom Weaving Sections is totally inadequate in view of the number of students and hence a provision of Rs. 18,000 is necessary.

(iv) School of Industry, Ratnagiri.-The present equipment for the foundry, smithy and handloom Weaving Sections is totally inadequate in view of the number of students and hence a provision of Rs. 1,200 is necessary.

Remarks.—The question of the housing of Harijan employees of local bodies has been engaging the attention of Government for some time in the past. In 1940 Government advised the municipalities to take vigorous steps to provide sanitary dwellings for their Harijan employees. For this purpose Government had type plans and estimates advised the municipalities to raise loans, if necessary, to finance such projects. An enquiry made as to how many municipalities had provided such quarters revealed that very few of them had been able to do anything substantial assumed urgent importance on account of (i) the appelling conditions under which the Harijans live at present and the serious consequences involved and (ii) the growing discontent among conservancy staff of municipalities resulting in strikes and inefficient and indifferent work. With a view therefore to tackling the question of housing of Harijans of local bodies immediately and effectively Government has announced the following concessions to local bodies etc. except the Bombay Municipal Corporation.

(i) Free grant of Government sites wherever such sites are available if no suitable land in the ownership of the local body concerned is available.

(ii) Subsidies at the following rates :--

(a)  $33\frac{1}{3}$  per cent. of the total cost of the project inclusive of the cost of site in the case of borough municipalities;

(b) 50 per cent. of the total cost of the project inclusive of the cost of site in the case of District Municipalities, Village Panchayats, District Local Boards and Notified Area Committees, individuals or bodies interested in the welfare of Harijans such as Social Service Associations, Co-operative Housing Societies, etc.

(c) Free advice of Expert Government Officers such as Executive Engineers, the Consulting Surveyor and the Director of Public Health in the preparation of plans and estimates.

(d) All possible help to local bodies, associations, etc. for obtaining the necessary building materials.

An amount of Rs. 5,00,000 has been included in the current year's budget, on account of the scheme. It is proposed to repeat the same provision for the year 1950-51.

Remarks.—In the 49th meeting of the Backward Class Board held on the 11th December 1948, it was resolved that in addition to the maintenance grants on the capitation basis now paid to Backward Class Hostels for boys, grants in respect of a reasonable proportion of the salary paid to Superintendents of such Hostels should be paid to those Hostels which employ Superintendents with suitable qualifications approved by Government. This will encourage Backward Class Hostels to employ qualified persons as Superintendents, and thereby improve the quality of the ho tels. There are at present 149 aided Backward Hostels which have been recognised by the Backward Class Department for the purpose of paying grants-in-aid under the Hostel Rules. These Hostels can be classified into the following sategories :—

Remarks.-The Bombay Habitual Offenders Restriction Act was passed in 1947. This legislation was undertaken by Government for restricting the movements of Habitual Offenders in the State of Bombay, for requiring them to report themselves and for placing them in settlements. Section 15 of the Act confers on Government the power to establish industrial, agricultural or reformatory settlements. Government proposes to start settlements in different areas in the State. For this purpose, it is proposed to utilise the Criminal Tribes Settlements, which have been closed down and are being transferred to the Juvenile and Beggars Department. As a beginning, Government sanctioned opening of a settlement at Bijapur for Habitual offenders with effect from the 1st April 1949. Similarly, it is now proposed to start a settlement at Ahmedabad. The Naroda Settlement at Ahmedabad under the Criminal Tribes Act has been closed down as a result of the repeal of the Criminal Tribes Act and part of the settlement is being taken over for the establishment of a settlement under the Bombay Habitual Offenders Restriction Act. The necessary additions and alterations will be carried out before the settlement is rendered suitable for accommodating Habitual offenders. It is proposed to utilise the settlement for familied settlers. The settlement will be started from the 1st April 1950. But for making the preliminary arrangements, a skeleton staff consisting of one Superintendent, one Junior Clerk, one Havildar, two Guards and one peon was sanctioned from September 1949 up to the end of March 1950. It is now proposed to sanction the entire staff required for the settlement, including the skeleton referred to above, for a period of one year in the first instance, with effect from the 1st April 1950.

Remarks.—In Ahmedabad, a fully equipped and well staffed engineering workshop has been established for imparting training in turning, fitting, smithy, and mouldering, tailoring, carpentry and painting to young apprentices and adult men either in or out of employment as alternative occupations. A qualified Superintendent is in charge of this workshop and there are special instructors for each trade. It is proposed to add on more section an Automobile Engineering section to enhance the utility and popularity of the workshop. The details of recurring and non-recurring expenditure for the proposed Automobile Mechanical section were discussed by the Technical Advisory Board at Ahmedabad. By equipping the Automobile section with staff and tools as recommended by the Board it will be possible to turn out really qualified motor mechanics for whom there is an increasing demand. In view of the prevailing unemployment among the textile workers of Ahmedabad as a result of the recent closure of mills, the Automobile section, if started, would enable the textile workers to secure Government jobs without any delay. The object of the section is to impart instruction in repairs and maintenance of internal combustion engines, motor cars, motor cycles, gas plant, etc.

that stage, it will be necessary that a responsible organisation should look after the flood lighting of the entire working area and other equipment, such as electrical pumps, colony lighting and various electrical machines for efficient and economic working. Moreover, the Dam is being constructed by means of costly machines, and hence the organisation, which is required to keep pace with the intensive outturn, has to be adequate in strength so that the outturn would not be impaired.

2. The Dam is to be completed by June 1952. It is necessary to complete by that date the construction of the Canals at least in its upper reaches so that the storage of lake can be utilised with the canals. It is also proposed to start the construction work on the Niphad Adgaon Road from the next year and to complete it within a year and half, as the Nasik Harsul Road will be submerged in the lake. The traffic on the latter road will, therefore, be diverted to the former one. The Sub-Divisional Officer on the Dam Construction will be fully busy with the work of the Dam itself, it will not be possible for any of the Dam Sub-Divisions to undertake this work.

3. In the circumstances stated above, it is necessary to open the following four Sub-Divisions under the Gangapur Storage Division :----

1 Electrical Sub-Division.

2 Canal Construction Sub-Division.

The establishment is proposed to be sanctioned on a temporary basis for the period from the 1st April 1950 to the 28th February 1951 in the first instance. The cost involved during the year 1950-51 is Rs. 56,800 as detailed below (for 11 months) :--

a training Class for Overseers and Sub-overseers for the specialised works of survey and construction of Land Drainage Projects. The overseers will be given training for the period of four weeks, thereafter they will be put in charge of sections of the proposed canal Drainage Sub-Division. The period of training for the Sub-overseers will be for simmonths. It is proposed to train 36 candidates annually (11 Departmental and 25 outsiders). The Departmental candidates will receive their pays during the period of training, but they will have to pay the boarding and lodging expenses to Government to the extent of Rs. 35 per mensem. As regards non-departmental candidates, it is proposed to give a stipend of Rs. 5 per mensem to each in addition to free boarding and lodging which will cost to Government Rs. 35 per mensem per candidate. It is also proposed to engage some teaching staff. The annual expenditure on account of stipend to the outside trainage at Rs. 40 each per mensem will be Rs. 6,000 and that on account of the teaching staff about Rs. 1,000. The classes will be con lucted for a period of about ten years, as the general project of the drainage schemes extends over that period. The annual recurring expenditure during the year 1950-51 will be Rs. 7,000.

Remarks.—The printing work at the Government Printing Presses has increased considerably and is continuously increasing since the last few years. The main burden has fallen on the Government Central Press, Bombay, where all timed publications and emergent requirements of Government are printed. In spite of all efforts made by the management the arrears are mounting up and they show no sign of reduction with the result that there is a very heavy congestion of arrears accumulating at that Press. One of the measures adopted by Government to improve the situation is to introduce a second shift at that Press. The second shift has been working since 7th February 1949 and has since been expanded by appointment of additional staff from time to time. It is now proposed to continue the staff mentioned in the accompanying statement for a further period of one year in the first instance. The proposal involves a recurring expenditure of Rs. 3,46,956 as shown in the statement.

Remarks.—The scheme as designed by the Miraj State authorities envisaged sale of water by house connections and general water cess. The Miraj Municipality has declined to take up the maintenance of the distribution system and the selling of water to consumers. Government will, therefore, have to sell water to consumers direct and collect revenue. Consequently water will have to be sold by meter and hence arises the necessity of purchasing meters. The necessary meter rent will be recovered from the consumers.

The estimated cost of the meters is Rs. 87,800 (net) and with centage charges at 27 per cent, it works out to Rs. 1,11,506 (gross).

ITEM 120. Constructing staff quarters and two seated acqua privy at Bund Bridge Pumping Station, Poona, and acquisition of land therefor.

Remarks.—The Pumping Station is situated away from the city and is being run continuously all day and night to cater to the needs of Yeravda area, Central Jail, Mental Hospital and Aerodrome, etc. The Station was constructed in 1943-44 as a temporary expedient for supply of water required for all the Military camps located in Yeravda area and beyond up to the Dighi camp including Lohogaon and Tata Air Factory. It was thought that this expedient was intended as a temporary measure during the war. After the war, conditions did not come to normal and the Military camps and the consequent demand for water have come to stay as a permanent feature. The demand is constantly increasing. Quarters for the staff are therefore of an urgent necessity. Utility concerns should have staff quarters. The plans and estimates for the work have been approved administratively. The total estimated cost of the work together with 27 per cent. centage charges amounts Rs. 33,900. A provision of Rs. 26,700 for the work is proposed accordingly.
