MEMORANDUM

BY THE

UNDER-SECRETARY OF STATE FOR INDIA

RELATING TO THE

ACCOUNTS of the GOVERNMENT OF INDIA (Central Government) for 1921–22 and the ESTIMATES for 1922–23 and 1923–24.

I.—INTRODUCTORY.

SEPARATION OF CENTRAL AND PROVINCIAL FINANCES.

The Government of India Act, 1919, was designed inter alia to secure a greater measure of independence for Provincial Governments, and to this end provision was made, in the Act and in Rules subsequently published under authority of the Act, for the delimitation of the functions of Government, as between the Government of India and the chief Provincial Governments, and for the definite assignment to each of these Provincial Governments. of specific revenues of their own. Effect has been given to these measures of devolution in the nine "Governors' Provinces" viz.: Bengal, Madras, Bombay, the United Provinces, the Punjab, Bihar and Orissa, the Central Provinces, Assam and Burma. As regards these nine provinces the functions of Government have been classified as either "central subjects" or "provincial subjects." A general authority to control all matters coming under the latter head, subject to certain expressed provisos, is devolved upon the Local Governments concerned.

The sources of revenue which have been given to Local Governments for the purpose of defraying their administrative charges consist, in the main, of the receipts accruing from provincial loans and from those provincial subjects which are revenue-producing, the principal heads being Land Revenue, Irrigation, Stamp Duties and Excise. In addition, a local Government is given a share in any expansion of Income Tax (otherwise a

"central" source of revenue) due to an increase of the assessed incomes within the Province; the amount allocated is, in effect, three pies in the rupee on the amount by which the total of assessed incomes in any year exceeds the total thereof in the year 1920-21.

When the division of the sources of revenue was made between the Central and Provincial Governments it was realized that the Central Government would be left insufficiently provided. It was therefore arranged that an annual contribution should be made by eight of the nine local Governments to the Central Government. The annual contributions fixed at the outset aggregated 983 lakhs of rupees. They were not, except in case of emergency and with the sanction of the Secretary of State, to be subject to increase, and should reduction of the aggregate be found possible reductions were to be made in fixed proportions from the quotas of the several Provinces. The general policy which it is intended to pursue in the matter is a progressive reduction of provincial contributions with a view to, their ultimate cessation.*

The revised financial arrangements outlined above came into force from the 1st April, 1921, as from which date all "provincial" revenue and expenditure ceased to be included in the estimates and accounts of the Central Government. The annual volumes of the "Finance and Revenue Accounts of the Government of India," commencing with that for 1921–22, exhibit in separate tables the revenue and expenditure of the Provincial Governments as well as that of the Central Government. The Central Government and each Provincial Government issues annually a separate volume containing its own budget estimate for the forthcoming year and revised estimate for the closing year. This Memorandum, however, deals with the Accounts and Estimates of the Central Government only, except where otherwise stated.

EXCHANGE.

Conversion Rate.—Since the 1st April, 1920, sterling transactions have, for the purpose of the Accounts and Estimates, been converted into rupees on a uniform basis of Rs. 10 to the £. The actual market value of the rupee, however; has varied considerably from that rate, e.g., the average rate during 1921-22 was slightly above Rs. 15 to the £, and the average rate assumed (for purposes of the Budget) for 1923-24 is Rs. 15 to the £. As a result, the rupee figure shown for any item of English expenditure (as converted at Rs. 10 to the £) does not correctly represent the actual charge incurred in making that expenditure. For instance, when a disbursement of £1,000 is made in England, the amount shown in rupees in the accounts as a disbursement in England will be Rs. 10,000. But (at the rate of Rs. 15 to the £ assumed for

As a special measure, the annual contribution of Rs. 63 lakks made by the Province of Bengal has been remitted for three years with effect from 1922-23.

1923-24) a disbursement of £1,000 represents a real charge of Rs. 15,000. The balance of Rs. 5,000 is treated as a disbursement on account of "exchange," and for accounting purposes is regarded as a "disbursement in India." The procedure by which this is effected is described in the following paragraph.

Method of Accounting.—All exchange credits or debits arising in respect of remittances and cognate transactions, owing to the remittances, etc., having been effected at rates differing from the conventional "conversion rate," are recorded in the first instance under a suspense head. The portion attributable to the revenue and capital accounts in respect of outlay incurred in England, is then transferred to the respective accounts, these transfers being made monthly on the basis of the average telegraphic transfer rates (Calcutia on London). As regards the amount transferred to revenue account, the procedure formerly adopted was as follows:—the portion which relates to net outlay in England on commercial services (Railways, Irrigation, and Posts and Telegraphs) was carried to the respective heads, the balance being shown under the General Revenue and Expenditure Head "Exchange.", With effect, however, from the Accounts for 1921-22, the exchange relating to the revenue account is being distributed over all the individual Heads of Revenue and Expenditure concerned, both commercial and non-commercial.

After making the above transfers to the several heads, the balance outstanding in the Suspense Account is normally held against the possibility of opposite results in succeeding years. (It is estimated that at the end of 1923-24, a net credit balance of Rs. 14,19 lakhs will be held in suspense on this account.)

Non-commercial Revenue Heads.—The net exchange debit in respect of non-commercial revenue heads is now distributed, as explained in the previous paragraph, over the individual heads. But at the time of the preparation of the Budget for 1922-23 the old procedure of entry under the single Revenue and Expenditure Head "Exchange," was still in force. As a result, the figures shown in this Memorandum, under individual heads, for the 1922-23 Budget, are not strictly comparable with the corresponding figures for 1921-22 (Accounts), 1922-23 (Revised), and 1923-24 (Budget).

Rates of Exchange for the three years under review.—The average of the daily rates (telegraphic transfer, Calcutta on London) for 1921-22 was Rs. 15:1431 to the £. The respective rates assumed for the purpose of compiling the Estimates have been:—

For the Budget Estimate of 1922-23, Rs. 15.0 to the £. For the Revised Estimate of 1922-23, Rs. 15.0* to the £. For the Budget Estimate of 1923-24, Rs. 15.0 to the £.

II.—REVENUE, AND EXPENDITURE CHARGED TO REVENUE.

GROSS REVENUE AND EXPENDITURE.

.The Gross Revenue and Expenditure of the Government of India for the three years to which this Memorandum refers are as follows:—

In these figures all receipts are included in the total of revenue and all outlay in the total of expenditure, with the main exceptions that the working expenses of railways, irrigation works and posts and telegraphs, and the surplus profits paid to certain railway companies are treated not as expenditure but as a deduction from revenue.

NET REVENUE AND EXPENDITURE.

The figures of Gross Revenue just given include the net receipts of railways and other commercial undertakings without any deduction on account of interest charges, the total receipts from the sale of opium, and the receipts of certain spending departments; while the figures of Gross Expenditure include the interest charges of commercial undertakings, and the cost of cultivation and manufacture of opium. This method of compilation may cause the revenue available for administrative purposes and the expenditure on such purposes to appear greater than they really are. A statement of the net revenue and expenditure of the Central Government for the three years under review is therefore given in the table below, which shows the net revenue derived from commercial undertakings. after deducting all expenditure including interest charges, and net figures under other heads of revenue and expenditure obtained by deducting (1) the cost of cultivation and manufacture of opium from sale receipts, and (2) the receipts of the spending departments from the gross expenditure incurred by them. The cost of the establishments maintained for the collection of revenue is not shown as a deduction from revenue, but as a separate head of expenditure.

ACCOUNTS, 1921-22.

It will be seen from the table that the final accounts for 1921-22 show a deficit of Rs.27,65,01,700.

REVISED ESTIMATE, 1922-23.

The Revised Estimate of 1922-23 shows a deficit of Rs.17,25,35,000 as compared with a deficit of Rs.9,16,28,000 in the Budget Estimate. This is attributable to the revenue falling short of that estimated under the heads Customs, Taxes on Income, Railways and Posts and Telegraphs; although there were reductions in expenditure, both civil and military, and in interest on debt; there were also increased receipts under opium and salt.

BUDGET, 1923-24.

In 1922 a Retrenchment Committee was appointed under the Chairmanship of the Rt. Hon. Lord Inchcape, "to make recommendations to the Government of India for effecting forthwith all possible reductions in the expenditure of the Central Government, having regard especially to the present financial position and outlook." The Committee held its first meeting in November, 1922, and submitted its Report to the Government of India in February, 1923. In framing their Budget for 1923-24, the Government of India took account of these recommendations, and made additional reductions in their estimates in the light of the retrenchments recommended, in so far as it was estimated that effect could be given to them in 1923-24.

In the non-military portion of the Budget, excluding interest, the Retrenchment Committee recommended reductions aggregating about Rs.8½ crores with reference to the Budget Estimate of 1922-23, on which their calculations were based. The retrenchments actually introduced in the Budget for 1923-24 represent Rs.6.6 crores, as compared with the total contemplated by the Committee, the difference, amounting to less than Rs.2 crores, representing the allowance which it has been thought necessary to make for the fact that many of the recommendations, even if accepted, cannot be in full operation during the year.

The Retrenchment Committee further recommended that the net military Budget for 1923-24 should be fixed at Rs.57\(^3\)2 crores, subject to any necessary addition for unavoidable delay in effecting reductions and for terminal charges. The net military Budget fixed by the Government of India for 1923-24 amounts to Rs. 62 crores, the difference of Rs.4\(^4\)2 crores being due to special expenditure in Waziristan and to the fact that the reductions could not in any case be fully realized in the current year. As a result, the net military Budget for 1923-24 exhibits a decrease of Rs.5 crores as compared with the revised estimate for 1922-23.

The revenue forecast assumed a small growth in revenue, indicated by prevailing trade conditions. In the Budget as originally presented, the expenditure was estimated at Rs.2043 crores and the revenue (on the basis of existing taxation) at Rs.1984 crores, leaving a deficiency of about Rs.54 crores.

With a view to meeting the deficiency, the following measures have been taken, viz.:—

- (i) In addition to crediting to revenue the interest on the securities in the Paper Currency Reserve (as was done in 1921-22 and 1922-23), it has been decided to credit to revenue in 1923-24 the interest also on the £40,000,000 in the Gold Standard Reserve, which is expected to amount in the year to Rs.1,59 lakhs.
- (ii) To meet the remaining deficiency (expected, in the original Budget estimate, to amount to Rs.4½ crores) the salt tax has been raised from Rs.1½ to Rs.2½ a maund (82½ lbs.). This is estimated to yield Rs.4½ crores in 1923-24. The new rate of tax is imposed with effect from 1st March, 1923, until 31st March, 1924. The Indian Finance Act, 1923, in which provision for the raising of the salt duty was made, was passed under the provisions of Section 67B of the Government of India Act. (Vide Parliamentary Paper H.C. 74 of 1923.)

As a result of discussion in the Legislature, certain further modifications were made in the original Budget estimates of expenditure. The Legislative Assembly made reductions totalling Rs.1,76 lakhs, of which Rs.1,17 lakhs was restored by the Governor-General in Council, a provision of Rs.9 lakhs being also made for supplementary grants in respect of certain of the other reductions.

In the Budget, as finally passed, the net revenue and expenditure were estimated as follows:—

As compared with the Revised Estimate for 1922-23, these figures show an increase of Rs.13,58,21,000 in net revenue, a decrease of Rs.4,48,00,000 in net expenditure, and an estimated surplus of Rs.80,86,000, as compared with a deficit of Rs.17,25,35,000.

IV.—DEBT TRANSACTIONS AND CAPITAL EXPENDITURE.

DEBT TRANSACTIONS.

1922-23. The Government of India issued a loan in India of unlimited amount in the form of five and ten-year Bonds at par, bearing interest at 6 per cent., free of Indian income-tax, and maturing in 1927 and 1932, respectively.

Conversion facilities were provided for Indian War Bonds, 1922, and arrangements were made for subscriptions to be received at the London Office of the Imperial Bank of India.

Two Sterling Loans were issued during 1922-23. Facilities for subscriptions from India were provided for both issues. An issue of £12,500,000 was made in June, 1922, in the form of $5\frac{1}{2}$ per cent. stock repayable at par in January, 1932, the issue price being £96 per cent. This issue was consolidated with the previous issue of £10,000,000 $5\frac{1}{2}$ per cent. stock. The proceeds of the issue were to be utilised for Indian Railway purposes. A further Sterling Loan issue of £20,000,000 $4\frac{1}{2}$ per cent. stock, redeemable 1950-55, was made in October, 1922, at a price of £85 per cent. The proceeds were to be utilised for Indian Railway and general purposes. The amount allocated to the former was £13 $\frac{1}{2}$ millions and to the latter £6 $\frac{1}{2}$ millions.

Rs.121 crores of the Permanent Debt in India was discharged during the year, including Rs.31 crores War Bonds, 1922, converted into the Rupee Loan of 1922. £400,000 Indian Railway Debentures were discharged in England.

The issue of Treasury Bills was continued during 1922-23 with the exception of the period June 6th to September 13th. The amount outstanding on 31st March, 1923, was Rs. 71,28,45,000, of which Rs. 49,65,00,000 was held on account of the Paper Currency Reserve. The corresponding figures on 31st March, 1922, were Rs. 1,11,85,70,000 and Rs. 57,99,00,000 respectively.

1923-24. The Budget provided for a capital outlay of Rs. 38'64 crores on railways, of which Rs. 8'64 crores is carried forward from the previous year, Rs. 94 lakhs on Posts and Telegraphs, Rs. 1'97 crores on the new Capital at Delhi; for the discharge of:—

Rs. 5,50,00,000 Treasury Bills held by the public;

Rs. 1,44,59,000 $5\frac{1}{2}$ per cent. War Bonds, 1923;

Rs. 2,87,19,000 4 per cent. loans;

Rs. 89,44,000 5½ per cent. War Bonds, 1920, 1921 and 1922, which were not presented for repayment on maturity; and

Rs. 1,02,35,000 5 per cent. War Loan, 1929-47, and Rs. 74,45,000 5 per cent. Income Tax free Loan, 1945-55, by the operation of the Depreciation Fund.

It further assumed the receipt from a Rupee Loan in India of Rs. 25 crores, and from the issue of Sterling Loans of £15,000,000.

A sterling issue of £20,000,000 $4\frac{1}{2}$ per cent. stock, repayable at par in January, 1950-55, and to be consolidated with the previous issue of October, 1922, was made in May, 1923, at £90 per cent. It was announced at the time of issue that the proceeds would be utilized for Indian railway and general purposes. The amount allocated to the former was £17 millions, and to the latter £3 millions. Facilities for subscriptions from India were provided.

The Rupee Loan, which was limited in amount to Rs. 24 crores, opened on 4th July, 1923; and, the amount required having been fully subscribed, the lists were closed on the 9th July. The loan was issued in two forms: (a) ten year bonds at Rs. 97 per cent., carrying interest at 5 per cent. per annum, free of Indian Income Tax; and (b) long term loan at Rs. 96 per cent. repayable at par not earlier than 15th October, 1945, or later than 15th October, 1955, and carrying interest at 5 per cent. per annum, free of Indian Income Tax. Subscriptions were admissible in cash, Indian Treasury Bills and Indian War Bonds, 1923, 1925 and 1928, but the 1925 and 1928 War Bonds were only convertible into the long-term loan. Subscriptions were receivable both in India and in London.

In April, 1923, a new series of Post Office Five-year Cash Certificates was issued. These Certificates improve in value at the end of the first year and thereafter quarterly, and will earn at maturity a bonus of 6 per cent. compound interest free of Indian Income Tax on the amount invested, instead of 5½ per cent. as previously allowed. They are issued in denominations of Rs. 10, Rs. 20, Rs. 50, Rs. 100 and Rs. 500.

RAILWAYS.

On the 31st March, 1922, the length of railways in India open for traffic was 37,265 miles, of which 247s miles were opened in the preceding twelve months. The total route mileage under construction, or sanctioned for construction, at the close of the year was 1,823½ miles. (See App. II. (b) (i).)

POSTS AND TELEGRAPHS

In the Budget for 1923-24 provision has been made of Rs.94 lakhs for capital outlay on the Indian Postal and Telegraph Department. The corresponding figures for 1922-23 were:—Budget Estimate, Rs. 1,45 lakhs; Revised Estimate, Rs. 1,10,36,000. Prior to 1921-22 all expenditure on the Department, inclusive of capital outlay, was charged to Revenue.

CLASSIFICATION OF PUBLIC DEBT.

Immediately prior to 1921-22 the debt of India was classified as (1) Railway Debt, (2) Irrigation Debt, (3) Initial Expenditure on the New Capital at Delhi, (4) Bombay Development Scheme, (5) Ordinary Debt, and (6) Treasury Bills and Short-term loans.

In the table below items (3) and (4) are included under Ordinary Debt.

With effect from 1921-22, the classification has been re-cast, owing to the application of borrowed funds to capital expenditure in the Telegraph Department, and to capital works undertaken by Provincial Governments in exercise of the borrowing powers conferred on them under the Reforms Scheme. The heads under which the debt has been re-cast are as follows:—

- (1) Debt debited to Commercial Departments, sub-divided into (a) Railways, (b) Posts and Telegraphs, (c) Irrigation, and (d) Forests.
- (2) Ordinary debt, and
- (3) Treasury Bills and Short-term loans.

The amount shown against Ordinary Debt for 31st March, 1922 in the table below includes Rs. 6,17,27,161 and Rs. 3,74,27,802 for the New Capital at Delhi and the Bombay Development Scheme, respectively.

The portion of the Public Debt shown as incurred for Commercial Departments is determined with reference to the actual capital outlay in those departments provided from Government resources, irrespective of whether it has been financed by loans raised by Government or otherwise, e.g., by the use of surplus revenue deposits or miscellaneous funds. The funds devoted to capital expenditure in any year normally exceed the money raised for the purpose. When this is the case, the adoption of the method explained above for calculating the amount of debt utilised for Commercial Departments results in the increase of the amount of

this debt and an equivalent decrease in the ordinary (or unproductive) debt, corresponding roughly to the extent to which funds raised otherwise than by borrowing are devoted to capital outlay on commercial undertakings. The operation is reversed in any year in which, owing to unfavourable financial conditions, funds obtained by loans are used in the ordinary disbursements of Government.

In the following table, which includes the public debt of the Central and the Provincial Governments, the sterling and rupee debts of India have been combined at the rate of Rs. 10=£1.

MISCELLANEOUS LIABILITIES AND ASSETS.

There are also other obligations of the Government of India, including Post Office Cash Certificates (which are treated in the Government of India's Accounts as unfunded debt), Savings Bank balances, Judicial and Departmental deposits, balances of Service Funds, etc., amounting on 31st March, 1923, to Rs. 89,13 lakhs, and the various railway annuities, representing in 1922-23 an expenditure of Rs. 5,03,62,000. But of this last-mentioned sum, Rs. 1,17,65,000 was devoted to redemption of capital liabilities. The total liability redeemed by these annual payments amounted on 31st March, 1923, to Rs. 20,53,15,810.

On that date, also, the Government of India had lent Rs. 8,91,20,485 (net) to Native States, Corporations, Agriculturists, etc. Other assets included the Gold Standard Reserve, consisting of sterling securities of an estimated value of £40,043,831, and £3,658 in cash; the cash balances in India, Rs. 25,93,35,000; and the Treasury balances in England, £9,590,232.*

The figures in the final sentence are actuals, and hence differ from the "Revised Estimate" figures in the following statement

VI.—GOLD STANDARD RESERVE.

In accordance with the recommendation made by Sir Henry Fowler's Committee, it was decided that, with effect from 1st April, 1900, the net profit from the coinage of rupees should not be treated as Revenue, but should be held as a special reserve (now called the Gold Standard Reserve).

The principal objects for which the Reserve is maintained are (1) to provide funds from which the Secretary of State for India can finance his requirements at times when he cannot conveniently sell Council drafts on India, and (2) to furnish resources against which, in normal times, sterling drafts may be sold by the Government of India to remitters in India, with a view to preventing a depreciation of the exchange. The earlier history of the Reserve is described in the Explanatory Memorandum for 1922-23.

In 1921-22 and 1922-23 the assets of the Gold Standard Reserve in excess of £40,000,000 on the basis of current market prices, were appropriated in reduction of the outstanding fiduciary currency, but in 1923-24 the corresponding assets will be appropriated to revenue.

The large decrease in the Revised Estimate, as compared with the Budget, for 1922-23 was due to a decline in respect of the import duties on sugar, cutlery and hardware, railway plant and rollingstock, matches, spirits, machinery and "other manufactured articles," and of the excise duty on cotton manufactures. These decreases were, however, to some extent set off by increases from the import duties on cotton piece-goods, metals, and articles of food and drink, and the new excise duty on kerosene.

The Budget estimate for 1923-24 allows for a slight growth of revenue under the more important tariff heads. It also provides, as a result of certain minor adjustments in the tariff schedule made in the Indian Finance Act (1923), for small increases of revenue in respect of saccharine and tea-chests, and small decreases under railway materials, machinery, and the export duty on hides and skins.

Details of the receipts obtained or expected to be obtained under the respective heads are given in the table below.

Excess Profits Duty.—The Revised Estimate for 1922-23 represents the collection of arrears thrown forward from former years.

Super-tax and Income-tax.—The Revised Estimate of net revenue for 1922-23 shows a decrease of Rs. 4½ crores as compared with the Budget Estimate, mainly owing to a reduction in the profits

of 1921-22 and to heavy refunds necessitated by the adjustment of provisional assessments made on the basis of the previous year's income. This adjustment system has now been abolished, and the Budget Estimate for 1923-24 provides for a decrease of Rs. 3\frac{3}{4} crores in refunds; but this improvement is expected to be largely counterbalanced by the effects of lower profits during 1922-23.

. Share of Provincial Governments .- Under rule 15 of the Devolution Rules. Provincial Governments receive a share in the income-tax collected within their jurisdiction at the rate of three pies on each rupee brought under assessment in respect of which the income-tax assessed has been collected. In consideration of this allocation, the Provincial Governments make fixed annual assignments equivalent to the amount which would have accrued to them in the year 1920-21 if the three-pie rate had been in force in that The explanation of the large decrease (over 3 crores), in the "share of Provincial Governments," shown in 1922-23 and 1923-24, as compared with 1921-22, is as follows. Prior to 1922-23, the revenue accruing to the Central Government from taxes on income was shown partly under the head "Taxes on Income," and partly (under the procedure outlined above) under the head "Contributions and Assignments between the Central and Provincial Governments." Under revised rules, which came into force on the 1st April, 1922, the above procedure was discontinued, and the whole revenue accruing to the Central Government in respect of taxes on income now appears under the head "Taxes on Income."

Under the Indian Finance Act, 1923, the duty on salt imported into, and produced in, India was increased with effect from the 1st March 1923, from Rs. 1-4a. to Rs. 2-8a. a maund. Allowing for the operation of the credit system of sales, which is in force in Bengal, Madras and Bombay, the extra revenue from the doubling of the duty is estimated at Rs. 25 lakhs in 1922-23, and Rs. 4,50 lakhs in 1923-24.

Opium is supplied at fixed prices to certain foreign Governments, principally the Straits Settlements, the Netherlands Indies, and Siam; the balance is sold by auction at Calcutta. In respect of opium consumed in India only the amount charged to Local Governments as cost of production is credited under this head, the difference between actual price of issue and cost of production being credited to Provincial revenues under the head of Excise.

As a result of an increased demand for opium in the Far East, the number of chests disposed of by auction during 1922-23 was much greater than had been anticipated in the Budget.

State Railways.—The profit derived by the State from the railways arises from the State lines, under which head are included not only the lines worked by the State (of which the most important are the North-Western, Eastern Bengal, and Oudh and Rohilkhand systems), but also lines which, while classified as State railways, are worked by companies receiving guaranteed interest on their share capital and a share of the surplus profits. Among the most important of the lines included in the latter class are the East Indian, Bengal-Nagpur, Bombay Baroda and Central India (including Rajputana-Malwa), Madras and Southern Mahratta, South Indian, Great Indian Peninsula (including the Indian Midland Railway), Assam-Bengal, and Burma Railways.

The Revised Estimate, as compared with the Budget, for 1922-23 shows a decrease of Rs. $7\frac{1}{2}$ crores in Gross Receipts, attributable to a decline in both goods and passenger traffic owing to the general economic factors of poor trade and increased cost of living. This decrease is partially set off by a decrease of Rs. $2\frac{1}{4}$ crores in Working Expenses.

In the Budget for 1923-24, the Gross Receipts have been estimated at Rs. $95\frac{1}{2}$ crores, being Rs. $3\frac{1}{2}$ crores more than the Revised Estimate for 1922-23. This is based on the fact that the enhanced fares, which it was not practicable to bring into effect from the commencement of 1922-23, will be in force throughout the year, and on the assumption that trade may be expected in some degree at any rate to revive. Provision is also made, in the Budget, for a decrease in Working Expenses of Rs. $2\frac{3}{4}$ crores, as compared with the Revised Estimate for 1922-23.

Indian Postal and Telegraph Department.—The Revised estimate of Gross Receipts for 1922–23 falls short of the Budget by Rs. 1,18 lakhs, owing partly to depression in trade and partly to reduction in correspondence in the early months of the year as the result of the increased rates of postage introduced by the Indian Finance Act, 1922; the decrease would have been more but for larger realisations on account of rent of telephones and miscellaneous receipts. The Budget for 1923–24 provides for increased receipts of Rs. 57½ lakhs over the Revised estimate for 1922–23. The Indian Finance Act, 1923, provides for the continuance during 1923–24 of the increased postal rates introduced by the Finance Act of 1922.

The Budget estimate of working expenses for 1923-24 has been framed with general reference to the recommendations of the Indian Retrenchment Committee, and is Rs. 63² lakhs less than the Revised estimate for 1922-23.

In the Revised Estimate for 1922-23, as compared with the Budget provision for that year, increases on account of abnormal expenditure in Waziristan, maintenance and retirement of surplus personnel, and higher non-effective charges, were rather more than counterbalanced by savings due mainly to continued shortage in establishments, lower hospital charges, fall in prices of food-stuffs, etc., larger consumption of surplus stocks, and larger receipts from the sale of stores.

The Budget for 1923-24 includes provision of Rs. $100\frac{1}{2}$ lakhs for special expenditure in Waziristan and (under Expenditure in England) £415,000 for the retirement of surplus officers of the Indian Army.

The net expenditure on Military services provided for in the Budget of 1923-24 is less than the Revised Estimate for 1922-23 by Rs. 5,08.78 lakhs (see also page 9).
