MEMORANDUM

BY THE

UNDER-SECRETARY OF STATE FOR INDIA

RELATING TO THE

ACCOUNTS of the GOVERNMENT OF INDIA (Central Government) for 1922–23 and the ESTIMATES for 1923–24 and 1924–25.

I.—INTRODUCTORY.

SEPARATION OF CENTRAL AND PROVINCIAL FINANCES.

The Government of India Act, 1919, was designed inter alia to secure a greater measure of independence for Provincial Governments, and to this end provision was made, in the Act and in Rules subsequently published under authority of the Act, for the delimitation of the functions of Government, as between the Government of India and the chief Provincial Governments, and for the definite assignment to each of these Provincial Governments of specific revenues of their own. Effect has been given to these measures of devolution in the nine "Governors' Provinces" viz.: Bengal, Madras, Bombay, the United Provinces, the Punjab, Bihar and Orissa, the Central Provinces, Assam and Burma, and in the Province of Coorg. As regards these provinces the functions of Government have been classified as either "central subjects" or "provincial subjects." A general authority to control all matters coming under the latter head, subject to certain expressed provisos, is devolved upon the Local Governments concerned.

The sources of revenue which have been given to Local Governments for the purpose of defraying their administrative charges consist, in the main, of the receipts accruing from provincial loans and from those provincial subjects which are revenue-producing, the principal heads being Land Revenue, Irrigation, Stamp Duties and Excise. In addition, a local Government is given a share in any expansion of Income Tax (otherwise a "central" source of revenue) due to an increase of the assessed incomes within the Province; the amount allocated is, in effect, three pies in the rupee on the amount by which the total of assessed incomes in any year exceeds the total thereof in the year 1920-21.

When the division of the sources of revenue was made between the Central and Provincial Governments, it was realized that the Central Government would be left insufficiently provided. It was therefore arranged that an annual contribution should be made by eight of the local Governments to the Central Government. The annual contributions fixed at the outset aggregated 983 lakhs of rupees. They were not, except in case of emergency and with the sanction of the Secretary of State, to be subject to increase, and should reduction of the aggregate be found possible, reductions were to be made in fixed proportions from the quotas of the several Provinces. The general policy which it is intended to pursue in

the matter is a progressive reduction of provincial contributions with a view to their ultimate cessation.

The revised financial arrangements outlined above came into force from the 1st April, 1921, as from which date all "provincial" revenue and expenditure ceased to be included in the estimates and accounts of the Central Government. In the case of Coorg the separation was made on 1st April, 1924. The annual volumes of the "Finance and Revenue Accounts of the Government of India," commencing with that for 1921-22, exhibit in separate tables the revenue and expenditure of the Provincial Governments as well as that of the Central Government. The Central Government and each Provincial Government issues annually a separate volume containing its own budget estimate for the forthcoming year and revised estimate for the closing year. This Memorandum, however, deals with the Accounts and Estimates of the Central Government only, except where otherwise stated.

Exchange Accounting.

The Government of India's accounts are now kept in rupees. Since the 1st April, 1920, sterling transactions have, for the purpose of the Accounts and Estimates, been converted into rupees on a uniform basis of 2s. to the rupee, equivalent to Rs.10 to the £. The actual market value of the rupee, however, has varied considerably from that rate. As a result, the rupee figure shown for any item of English expenditure (as converted at Rs.10 to the £) does not correctly represent the actual charge incurred in making that expenditure. For instance, when a disbursement of £1.000 is made in England, the amount shown in rupees in the accounts as a disbursement in England will be Rs.10,000. 'But (at the rate' of 1s. 42d. to the rupee assumed for the Budget Estimate of 1924-25) a disbursement of £1,000 represents a real charge of Rs.14,328. The balance of Rs.4,328 is treated as a disbursement on account of "exchange." The procedure by which this is effected is described in the following paragraph.

All exchange credits or debits arising in respect of remittances and cognate transactions, owing to the remittances, etc., having been effected at rates differing from the conventional "conversion rate," are recorded in the first instance under a suspense head. The exchange credits or debits arising from outlay incurred in England in respect of the various heads of the revenue and capital accounts are included in the respective accounts, being calculated monthly on the basis of the average telegraphic transfer rates (Calcutta on London); and those relating to Provincial Governments are charged against those Governments.

The suspense head of account referred to above is then reduced by the totals of these exchange adjustments arising from outlay in England; and it is considered with reference to the circumstances of each year whether the resulting balance should be written off to revenue or kept in suspense against the possibility of opposite results in succeeding years. It was estimated that at the end of 1923-24 a net credit balance of Rs.8,79 lakhs would be held in suspense on this account.

As a special measure, the annual contribution of Rs. 63 lakes made by the Prevince of Bengal has been remitted for three years with effect from 1922-28.

Rates of Exchange for the three years under review .- The average of the daily rates (telegraphic transfer, Calcutta on London) for 1922-23 was Rs.15.2246 to the £. The respective rates assumed for the purpose of compiling the Estimates have been:-

II.—REVENUE, AND EXPENDITURE CHARGED TO REVENUE.

GROSS REVENUE AND EXPENDITURE.

The Gross Revenue and Expenditure of the Government of India for the three years to which this Memorandum refers are as follows:-

In these figures all receipts are included in the total of revenue. and all outlay in the total of expenditure, with the main exceptions that the working expenses of railways, irrigation works and posts and telegraphs, and the surplus profits paid to certain railway companies are treated not as expenditure but as a deduction from revenue.

NET REVENUE AND EXPENDITURE.

The figures of Gross Revenue just given include the net receipts of railways and other commercial undertakings without any deduction on account of interest charges, the total receipts from the sale of opium, and the receipts of certain spending departments; while the figures of Gross Expenditure include the interest charges of commercial undertakings, and the cost of cultivation and manufacture of opium. This method of compilation may cause the revenue available for administrative purposes and the expenditure on such purposes to appear greater than they really are. A statement of the net revenue and expenditure of the Central Government for the three years under review is therefore given in the table below, which shows the net revenue derived from commercial undertakings, after deducting all expenditure including interest charges, and net figures under other heads of revenue and expenditure obtained by deducting (1) the cost of cultivation and manufacture of opium from sale receipts, and (2) the receipts of the spending departments from the gross expenditure incurred by them. The cost of the establishments maintained for the collection of revenue is not shown as a deduction from revenue, but as a separate head of expenditure.

It will be seen from the table that the final accounts for 1922-23 show a deficit of Rs.15,01,76,392.

REVISED ESTIMATE, 1923-24.

The Revised Estimate of 1923-24 shows a surplus of Rs.2,06,07,000 as compared with a surplus of Rs.80,86,000 in the Budget Estimate. The Revised Estimate would ordinarily have shown a deficit of Rs.37½ lakhs, but this has been converted into a surplus of over Rs.2 crores, owing to the fact that a sum of £3¼ millions, representing profits from the control of enemy ships, which has been lying at credit of a suspense head, became available for credit of revenue. The amount credited to revenue in 1923-24 under this heading was nearly Rs.244 lakhs, and as regards the remainder, Rs.25 lakhs has been included in the 1924-25 Budget to meet ex gratia compensation to individuals who have suffered from enemy action during the war, and Rs.2 crores has been reserved for refund to railway companies of customs duty on stores if the appeal against a decision of the Bombay High Court should be unfavourable.

BUDGET, 1924-25.

In framing the Budget for 1924-25 the Government of India estimated that, on the basis of existing taxation and the continuance of the crediting to revenue of the interest on the securities in the Paper Currency Reserve and in the Gold Standard Reserve there would be a surplus of Rs.336 lakhs. It was stated in the Legislature that, if the Salt Tax, which stood at Rs.25 per maund, and had been doubled in the previous year in order to balance the Budget, were reduced to its previous figure of Rs.11 per maund, the estimated surplus would become a nominal one of about 4 lakhs, and an estimated further deficiency of Rs.216 lakhs would ensue in the following year. If the Salt Tax were reduced to Rs.2 per maund, it was estimated that there would be a surplus of Rs. 154 lakhs in 1924-25. The Government of India left the final choice to the Legislature, but recommended that the Salt Tax should be reduced to Rs.2 per maund and that Rs.150 lakhs of the remaining surplus should be devoted to the reduction of the provincial contributions. The provinces thus benefiting under the Devolution Rules would be Madras, Rs.80 lakhs; the Punjab. Rs.38 lakhs; the United Provinces, Rs.30 lakhs, and Burma Rs.2 lakhs approximately.

No new taxation was proposed, and in addition to the reduction of the Salt Tax, the Government of India proposed to reduce the duties on motor spirit from 6 annas a gallon on motor spirit produced in India and $8\frac{1}{2}$ annas on imported motor spirit to $4\frac{1}{2}$ annas a gallon for both kinds. A specific duty on certain imported materials used in the match industry was proposed in order to safeguard the customs revenue.

The Legislative Assembly refused Rs.4,72,02,100 of the Demands for Grants, including the whole of the demands under the heads Customs, Taxes on Income, Salt and Opium, which amounted to Rs.4,47,02,000. This latter amount was restored by the Governor-General in Council as essential to the discharge of his responsibilities.

The Finance Bill as introduced into the Legislative Assembly provided inter alia for the reduction of the Salt Duty from Rs.2½ to Rs.2 per maund. Owing to the Legislative Assembly refusing to take it into consideration, a fresh Bill was submitted in a form recommended by the Governor-General. Leave to introduce the Bill into the Legislative Assembly was refused; the Bill was then introduced into and passed by the Council of State and became an Act on certification by the Governor-General, under the provisions of Section 678 of the Government of India Act (vide Parliamentary Paper H.C. 85 of 1924). This Act reduced the Salt Tax to Rs.1½ per maund and provided for the existing postal rates

and rates of Income Tax and Super Tax, and for the imposition of a specific duty on certain materials for match manufacture, but the proposals for reducing the Excise and Import Duties on motor spirit and other minor changes in the customs tariff were omitted from the Act in its recommended form.

In the Budget, as finally passed, the net revenue and expenditure were estimated as follows:-

As compared with the Revised Estimate for 1923-24, these figures show an increase of Rs.1,49,57,000 in net revenue, an increase of Rs.3,37,17,000 in net expenditure, and an estimated surplus of Rs.18,47,000 as compared with a surplus of Rs.2,06,07,000 in 1923-24.

For the purpose of calculating the payment per head, the figures of population have been based on the Census of 1921 (247,003,293), an annual increase of population at the rate of one-half per cent. being assumed.

IV.—DEBT TRANSACTIONS AND CAPITAL EXPENDITURE.

DEBT TRANSACTIONS.

1923-24.

In May, 1923, a Sterling Loan was issued by the Secretary of State of £20,000,000 $4\frac{1}{2}$ per cent. stock, repayable at par on any half-yearly interest date between May, 1950, and May, 1955, the issue price being £90 per cent.

This issue was consolidated with the previous issue of £20,000,000 4½ per cent. stock in October, 1922. The proceeds of the loan were to be used for Indian Railway and general purposes. Facilities for subscriptions from India were provided.

In July, 1923, the Government of India issued a loan in India, limited to Rs.24 crores, in the form of ten-year Bonds at Rs.97 per cent. and long-term loan, maturing 1945-55, at Rs.96 per cent., both forms bearing interest at 5 per cent., and free of Indian Income Tax.

Conversion facilities were provided for Indian War Bonds, 1923, to both forms of the loan and for Indian War Bonds, 1925 and 1928, to the long-term loan only.

Arrangements were made for subscriptions to be received simultaneously in India, including Post Offices, and in London.

The amounts of War Bonds, 1923, 1925 and 1928, included in the above figures were Rs.8,17,700, Rs.1,400 and Rs.32,300, respectively.

Rs.5 crores of the Permanent Debt in India was discharged during the year, including Rs.8½ lakhs War Bonds, converted into the Rupee Loan of 1923. £715,500 Indian Railway Debentures were discharged in England.

Treasury Bills were only offered for sale in 1923-24 during April and from 14th November to 28th January. The amount outstanding on 31st March, 1924, was Rs.51,78'3 lakhs, of which Rs.49,65 lakhs was held on account of the Paper Currency Reserve, and Rs.212'2 lakhs by the public. During the year Rs.1946'7 lakhs (net) of the public issue of bills have been paid off, the holding on account of the Paper Currency Reserve remaining unchanged.

The net receipts from Post Office Cash Certificates, of which a new series was introduced in April, 1923, was Rs. 5,29,80,601.

1924-25.

The Budget provides for a capital outlay of Rs.30 crores on railways, Rs.1'74 crores on Posts and Telegraphs, and Rs.1'47 crores on the new Capital at Delhi; for the discharge of:—

Rs.2,13,00,000 Treasury Bills (i.e., the total held by the public);

Rs.22,00,000 4 per cent. loans;

Rs. 26,00,000 5½ per cent. War Bonds, 1920 to 1923, which were not presented for repayment on maturity;

Rs.48,93,000 5 per cent. War Loan, 1929-47, and Rs.85,00,000 5 per cent. Income Tax free Loan, 1945-55, by the operation of the Depreciation Fund; and

£451,000 Indian Railway debentures in England.

It further assumes the receipt from a Rupee Loan in India of Rs.20 crores, and net receipts of Rs.6 crores and Rs.1½ crores from Savings Bank deposits and Post Office Cash Certificates respectively. The estimates do not provide for the issue of a Sterling Loan.

In July, 1924, the Rupee Loan, subject to a maximum of Rs.15 crores, was issued. The lists were closed on the 16th August and the subscriptions amounted approximately to Rs.13½ crores. The loan was issued in two forms: (a) nine-year bonds at Rs.98½ per cent., carrying interest at 5 per cent. per annum, free of Indian Income Tax; and (b) long-term loan at Rs.99 per cent. repayable at par not earlier than 15th October, 1945, or later than 15th October, 1955, and carrying interest at 5 per cent. per annum, free of Indian Income Tax. Subscriptions were admissible in cash and Indian War Bonds, 1925 and 1928, the War Bonds being convertible into the long-term loan only. Subscriptions were receivable both in India and in London.

In December, 1924, when the East Indian Railway will come under State management, the Secretary of State will take over the liability for the £18,500,000 debenture stock of the East Indian Railway Company.

The new series of Post Office Five-year Cash Certificates issued in 1923 is being continued, with the addition of Certificates for Rs.1,000. The Budget for 1924-25 provides for a net receipt of Rs.1½ crores from these Certificates.

RAILWAYS.

On the 31st March, 1923, the length of railways in India open for traffic was 37,618 miles, of which $381\frac{5}{8}$ miles were opened in the preceding twelve months. The total route mileage under construction at the close of the year was $862\frac{3}{4}$ miles. (See also App. II. (b) (i).)

The capital expenditure on railways shown in the Government Accounts for 1922-23 and Estimates for 1923-24 and 1924-25, is as follows:—

Posts and Telegraphs

In the Budget for 1924-25 provision has been made of Rs.1,74 lakhs for capital outlay on the Indian Postal and Telegraph Department. The corresponding figures for 1923-24 were:—Budget Estimate, Rs.94 lakhs; Revised Estimate, Rs.97 lakhs. Prior to 1921-22 all expenditure on the Department, inclusive of capital outlay, was charged to Revenue.

CLASSIFICATION OF PUBLIC DEBT.

Immediately prior to 1921-22 the debt of India was classified as (1) Railway Debt, (2) Irrigation Debt, (3) Initial Expenditure on the New Capital at Delhi, (4) Bombay Development Scheme, (5) Ordinary Debt, and (6) Treasury Bills and Short-term loans.

In the table below items (3) and (4) are included under Ordinary Debt.

With effect from 1921-22, the classification has been re-cast, owing to the application of borrowed funds to capital expenditure in the Telegraph Department, and to capital works undertaken by Provincial Governments in exercise of the borrowing powers conferred on them under the Reforms Scheme. The heads under which the debt has been re-cast are as follows:—

- (1) Debt debited to Commercial Departments, subdivided into (a) Railways, (b) Posts and Telegraphs, (c) Irrigation, and (d) Forests.
- (2) Ordinary debt, and
- (3) Floating Debt, i.e., Treasury Bills and Short-term loans.

The portion of the Public Debt shown as incurred for Commercial Departments is determined with reference to the actual capital outlay in those departments provided from Government resources, irrespective of whether it has been financed by loans raised by Government or otherwise, e.g., by the use of surplus revenue deposits or miscellaneous funds. The funds devoted to capital expenditure in any year normally exceed the money raised for the purpose. When this is the case, the adoption of the method explained above for calculating the amount of debt utilised for Commercial Departments results in the increase of the amount of this debt and an equivalent decrease in the ordinary (or unproductive) debt, corresponding roughly to the extent to which funds raised otherwise than by borrowing are devoted to capital outlay

on commercial undertakings. The operation is reversed in any year in which, owing to unfavourable financial conditions, funds obtained by loans are used in the ordinary disbursements of Government.

In the following table, which includes the public debt of the Central and the Provincial Governments, the sterling and rupee debts of India have been combined at the rate of Rs. 10=£1.

MISCELLANEOUS LIABILITIES AND ASSETS.

There are also other obligations of the Government of India, including Post Office Cash Certificates (which are treated in the Government of India's Accounts as unfunded debt), Savings Bank balances, Judicial and Departmental deposits, balances of Service Funds, etc., amounting on 31st March, 1924 to Rs.972 crores, and certain terminable annuities in redemption of a capital sum for purchase of railways of which the amount outstanding on 31st March, 1924, was £60,095,485.

On that date, also, the Government of India had lent Rs.8,69,33,144 (net) to Native States, Corporations, Agriculturists, etc. Other assets included the Gold Standard Reserve, consisting of sterling securities of an estimated value of £39,999,059, and £941 in cash; the cash balances in India, Rs.31,14,37,000, and the Treasury balances in England, £10,166,581.*

VI.—GOLD STANDARD RESERVE.

In accordance with the recommendation made by Sir Henry Fowler's Committee, it was decided that, with effect from 1st April, 1900, the net profit from the coinage of rupees should not be treated as Revenue, but should be held as a special reserve (now called the Gold Standard Reserve).

The principal objects for which the Reserve is maintained are (1) to provide funds from which the Secretary of State for India can finance his requirements at times when he cannot conveniently arrange for remittance of funds from India by selling Council drafts on India or otherwise, and (2) to furnish resources against which, in normal times, sterling drafts may, if necessity arises, be sold by the Government of India to remitters in India, with a view to preventing a depreciation of the exchange. The earlier history of the Reserve is described in the Explanatory Memorandum for 1922-23. [Command Paper 1766 of 1922.]

In 1921-22 and 1922-23 the assets of the Gold Standard Reserve in excess of £40,000,000, on the basis of current market prices, were appropriated in reduction of the outstanding fiduciary currency; but in 1923-24 the corresponding assets were appropriated to revenue, and a similar appropriation is proposed for

1924-25.

The large decrease in the Revised Estimate, as compared with the Budget, for 1923-24 was due to a decline in respect of the import duties on sugar, cotton piece-goods, railway plant and rolling-stock, cutlery and hardware, iron and steel, other metals and "other manufactured articles," and of the excise duty on cotton manufactures. The only heads which show a material increase in revenue are the import duty on yarns and textile fabrics other than cotton manufactures and the export duty on jute.

The decline in revenue under sugar was the result of insufficient allowance made in the Budget for the reduction in the tariff valuation which came into force from the 1st January, 1923. The revenue from railway plant and rolling-stock was affected by a decision of the Bombay High Court that stores imported by railway companies working State lines fall within the term "Government Stores," and are not, therefore, liable to duty. An appeal has been preferred to the Privy Council against the decision, but pending the result of the appeal, the stores in question are being passed free of duty.

Fall in prices has affected the customs revenue in the case of articles liable to *ad valorem* duties, and the cotton excise duty has suffered from the adverse conditions which existed in the Bombay cotton mill industry.

The Budget Estimate for 1924-25 allows for an improvement in trade conditions generally and under sugar for the increased tariff valuation which came into force from January, 1924. The Sea Customs Act has been amended so as to make Government stores liable to customs duties with effect from the 1st April, 1924.

The collections in Bombay are expected to be less by Rs.91 lakhs owing to the depressed condition of the mill industry, and in Bengal by Rs.47 lakhs owing mainly to the revenue for 1923-24 including arrears; on the other hand, increases are expected in Burma (Rs.45 lakhs) and Bihar and Orissa (Rs.12 lakhs) from the collection of arrears thrown forward from the current year.

Share of Provincial Governments.—Under rule 15 of the Devolution Rules, Provincial Governments receive a share in the income-tax collected within their jurisdiction at the rate of three pies on each rupee brought under assessment in respect of which the income-tax assessed has been collected. In consideration of this allocation, the Provincial Governments make fixed annual assignments equivalent to the amount which would have accrued to them in the year 1920-21 if the three-pie rate had been in force in that year.

The Revised Estimate for 1923-24 falls short of the Budget Estimate for that year by over Rs.3 crores.

This decrease is mainly due to traders in January and February, 1923, taking large quantities of salt in excess of the normal issue in anticipation of an increase in duty from the 1st March, 1923, and allowing their stocks to run as low as possible in 1923-24 in expectation of a reduction of duty from the 1st March, 1924.

With effect from the 1st March, 1924, the duty on salt imported into, and produced in, India has been reduced from Rs.21 to Rs.14 a maund. It is expected that there will be a rapid replenishment of stocks on account of the reduction of duty, and allowing for the operation of the credit system of sales in Bengal and Madras, the Budget estimate of net revenue in 1924-25 has been placed at Rs.9,0462 lakhs.

Opium is supplied at fixed prices to certain other Governments, principally Malaya, the Netherlands Indies, and Siam; the balance for export is sold by auction at Calcutta. respect of opium consumed in India only the amount charged to Local Governments as cost of production is credited under this head, the difference between actual price of issue to licensed vendors . and cost of production being credited to Provincial revenues under the head of Excise.

As a result of a slightly increased demand for opium in the Far East, the number of chests disposed of by auction during 1923-24 was greater than had been anticipated in the Budget.

These figures are arrived at after charging in the Account all interest charges, payments in redemption of capital which are made partly through sinking funds and partly through the annuities created for the purchase of various railways, except that, with effect from 1924-25, the capital portions of the annuity payments are excluded from the railway account and are charged under the head "Reduction or Avoidance of Debt."

State Railways.—The profit derived by the State from the railways arises from the State lines, under which head are included not only the lines worked by the State (of which the most important are the North-Western, Eastern Bengal, and Oudh and Rohilkhand systems), but also lines which, while classified as State railways, are worked by companies receiving guaranteed interest on their share capital and a share of the surplus profits. Among the most important of the lines included in the latter class are the East Indian, Bengal-Nagpur, Bombay Baroda and Central India (including Rajputana-Malwa), Madras and Southern Mahratta, South Indian, Great Indian Peninsula (including the Indian Midland Railway), Assam-Bengal, and Burma Railways. The East Indian Railway will come under State management after December, 1924.

The Revised Estimate, as compared with the Budget, for 1923-24 shows a decrease of Rs.1\frac{1}{3} crores in Gross Receipts, due to traffic not coming up to expectations during the autumn months and to interruption of traffic as a result of flood damages to several railways. This decrease is more than set off by a decrease of Rs.2 crores in Working Expenses.

In the Budget for 1924-25, the Gross Receipts have been estimated at Rs.97 crores, being Rs.23 crores more than the Revised Estimate for 1923-24. This is based on anticipations of normal conditions of trade and a favourable harvest. Provision is also made, in the Budget, for an increase in Working Expenses of about Rs.5½ crores, as compared with the Revised Estimate for 1923-24.

Indian Postal and Telegraph Department.—The Revised Estimate of Gross Receipts for 1923-24 falls short of the Budget Estimate by Rs.441 lakhs. The latter estimate was, however, based on the Revised Estimate of the previous year, which included erroneous adjustments of Rs.22 lakhs provisionally made under this head. The estimate for 1923-24 was therefore vitiated to this extent and the real deficit in the Revised Estimate may be taken at Rs.22 lakhs. This deficit is due mainly to continued trade depression, which is particularly shown in the falling off in the receipts for foreign telegrams. Diversion of traffic owing to the re-opening of the Indo route to Europe and of the Aden-Colombo cable to the Far. East is also responsible for a decline in receipts.

The estimate of revenue for 1924-25 provides for an increase of Rs.27\(^3\) lakes over the Revised Estimate for 1923-24. Allowance is made for normal growth and in expectation of improved trade conditions in 1924-25. Increased revenue will be received from the revised rates for insurance of postal articles in the inland post, from the enhancement of fees for purpose of Customs formalities of foreign parcels, and from anticipated increases in the charges made to railway and canal administrations for the maintenance of their lines.

Currency.

The greater part of the net revenue receipts shown under Currency arises from the interest on the securities in the Paper Currency Reserve. Under the Indian Paper Currency Act this interest was earmarked for reduction of created securities in the Paper Currency Reserve. This provision has, however, been temporarily suspended since 1921-22, and the interest credited to revenue.

Contributions.—It was provided by the Devolution Rules, made under para. 45A of the Government of India Act, that in the year 1921-22 contributions of specified amount, and in future years similar contributions or such smaller sums as might be determined by the Governor-General in Council, should be paid by the Local Governments to the Government of India. If for any year the total of the contributions were reduced, reductions should be made in respect of those Local Governments only whose last previous annual contribution should have exceeded the proportion specified below of the smaller sum so determined as the total contribution; and any reduction so made should be proportionate to such excess.

The Budget of 1924-25 also includes a contribution of Rs.12,000 from Coorg, under the Coorg Devolution Rules, 1924, towards the pay of the Chief Commissioner and his establishment.

Assignments.—The assignments made to central revenues by each Provincial Government, under Devolution Rule 15 (2), in consideration of the grant to them of a share in the income-tax collected within their respective jurisdictions, were prior to 1922–23 accounted for under this head. They have since been transferred to the head "Taxes on Income."

The Budget for 1924-25 includes Rs.22 lakhs, under Miscellaneous Assignments, for assignments to Provincial Governments in respect of Customs duty on stores imported by them.

The large increase shown under this head in the Revised Estimate for 1923-24 is due to the inclusion of Rs.244 lakhs out of profits from the control of enemy ships, and Rs.37 lakhs profit from the sale of £2 millions of gold from the Paper Currency Reserve.

The Budget figure for 1924-25 of Rs.34,10,000 includes about Rs.25 lakhs of the profits from the control of enemy ships, reserved for payment of ex gratia grants to private individuals who suffered from enemy action during the war.

Owing to the improved state of the Government securities market, it has been unnecessary to utilise any portion of the additional provision of Rs.80 lakhs made since 1921-22 for the purpose of supporting the two long-term 5 per cent. rupee loans. In the Budget for 1924-25, however, additional charges are included for the capital portion of the annuities in purchase of railways and the railway sinking funds, both of which have in previous years been a charge under the head of railways. The debt head in 1924-25 also includes a new provision of Rs.11 lakhs for avoidance of debt, being the equivalent of the Customs duty collected from State Railways on stores imported by them for capital purposes.

The receipts include interest received in England on the balances of the Secretary of State and in India on loans granted by the Central Government to Native States and to Railway Companies. The amount "chargeable to Provincial Governments" includes interest on the outlay to the end of 1920-21 on irrigation works transferred under the Reforms Scheme to those Governments.

In the Revised Estimate for 1923-24, as compared with the Budget provision for that year, increases on account of retention of additional establishments in Waziristan, charges on account of surplus officers of the Indian Army, and higher non-effective charges, were more than counterbalanced by savings due mainly to shortages and reductions in establishments, increase in credits from consumption or disposal of surplus stores, savings in proficiency pay of British soldiers due to fewer recipients, reduction of British cavalry and artillery units which had effect during a portion of the year, and the fall in prices of foodstuffs.

The Budget for 1924-25 includes (under Expenditure in England) £800,000 for the retirement of surplus officers of the Indian Army and £250,000 for payment to the War Office of the balance of their claim in regard to exchange concession on war gratuities of British officers and soldiers.

The net expenditure on Military services provided for in the Budget of 1924-25 is greater than the Revised Estimate for 1923-24 by Rs.50.81 lakhs.
