P R E F A C E.

The second all-India Conference of the Moderate party held in the Town Hall of Calcutta under the Presidency of Sir Sivaswamy Aiyer proved an unqualified success in every way. From the point of view of the number of delegates and of the visitors present the Conference left nothing to be desired. The Conference commenced its session on Tuesday the 30th of December, 1919, at 1-30 p.m. when the spacious Hall was packed to its utmost capacity. Immediately after the Conference copies of Resolutions passed at the Conference were forwarded to the Secretary of State, to the Government of India and to all the Provincial Governments. They were also sent out for circulation to all the Provincial Moderate Organisations. The Secretaries greatly regret the delay in publishing the full Report of the Proceedings but it was due to causes which were beyond their control.

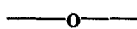
