INTRODUCTION.

(i.) METHOD OF COMPILATION.

The particulars given in this Return, respecting the regulations concerning Commercial Travellers and their samples in India and the Colonies, have been obtained from the Indian and Colonial Governments, through the India and Colonial Offices, in consequence of a suggestion made by the Commercial Department of the Board of Trade in correspondence with the Offices named, in May, 1898. The following are copies (a) of a letter received by the Board of Trade from the India Office on the 18th May, 1898, and (b) of a Circular sent by the Colonial Office to the various Colonial Governments on the 6th June, 1899.

India Office to Board of Trade.

India Office, Whitehall,

Sir, London, S.W., 17th May, 1898.

WITH reference to your letter, dated the 4th May, 1898, regarding regulations for commercial travellers, I am directed by the Secretary of State for India to inform you that he has invited the Government of India to state whether they have any rules regarding, or concessions in favour of, commercial travellers, of which the publication might be useful or interesting to traders in the United Kingdom.

I HAVE the honour to transmit to you copies of a Return (C. 8396) presented in 1897 to the House of Commons, giving particulars concerning the licenses or other documents which have to be obtained by British commercial travellers or agents of British firms before they can trade or solicit orders in foreign countries.

Information of a somewhat similar character to that given in this Return was supplied to the Board of Trade by various Colonial Governments in reply to my predecessor's Circular Despatch, dated 6th January, 1890, and I should be glad if you will inform me whether the particulars then supplied still afford an accurate description of the regulations affecting the matter, and, if not, in what manner, and to what extent the regulations have been modified.

It is proposed to embody the replies to this despatch in a Return which will be presented to Parliament.

(ii.) SUMMARY OF INFORMATION RECEIVED.

It may be convenient to summarise briefly the information which has been received by the Board of Trade as the result of the applications made to the Indian and Colonial Governments:—

India

There are no regulations in British India specially affecting commercial travellers and their calling, and they are not required to take out licenses.

Travellers resident in Calcutta are not called on to pay the

regular municipal license-tax.

In Native States also there are no special rules or regulations on the subject: but in Kashmir all Europeans, other than civil and military officers of the British Government, whether they are commercial travellers or not, are required to provide themselves with a pass from the Resident before entering the Maharaja's territories; and in Nepal the general prohibition against Europeans visiting Nepal without the permission of the Darbar applies to representatives of European firms.

With regard to the treatment of commercial travellers' samples and patterns, no special regulations exist in British India; but it may be said generally that import duty is charged on import and refunded on re-export to the extent of seven-eighths, and that samples of no marketable value are exempted from all payment.

Wherever octroi is levied, whether in British or Native India, on merchandise brought into towns, the duty applies to samples of merchandise as to goods generally, if the samples are of taxable value.

As regards the treatment accorded to samples of merchandise in Native States, no duty is levied in Gwalior when samples are imported and exported again unsold; and it appears that, generally speaking, the same ruly prevails in all the States of Central India. In cases where the concession is not provided for by existing regulations, it could probably be secured without diffi-

culty by application to the Political Officer concerned. There are apparently no rules for the treatment of commercial travellers' samples in the other Native States of India.

Ванамав.

There are no laws or regulations affecting commercial travellers in the Bahamas. No Customs regulations exist as to the introduction of travellers' patterns or samples: it is customary to admit such articles free of duty, provided that they are of no great value.

BARBADOS.

No license-duty or other tax is imposed on commercial travellers

carrying on their business in the Island.

A bona jide commercial traveller receives drawback of the duty paid by him on any sample or specimen of goods imported into Barbados and subsequently taken away again, provided that it is shown to the satisfaction of the proper officer that such sample or specimen has been re-shipped and is the same as that on which duty has been previously paid.

BERMUDA ISLANDS.

No special regulations are in force in this Colony affecting British commercial travellers. Their patterns and samples, when of no intrinsic value, have hitherto been admitted without payment of Customs duty, although these articles are not expressly exempted by the tariff.

It is to be noted that commercial travellers are specially exempted from the operation of the Bermudan "Pedlars' Act" of 1894, which requires pedlars to take out licenses for the prosecu-

tion of their business.

BRITISH GUIANA.

Commercial travellers bringing goods for sale in the Colony are required to take out a shop license, at a cost of 48 dollars (£10), unless, with the knowledge and consent of the Comptroller of Customs, they transfer such goods, by instrument in writing,

for sale to some person holding a store or shop license.

Samples and patterns may be landed free of duty, if, at the ad radorem rate of import duty, the collective amount payable on the goods landed would not be more than 3 dollars (12s. 6d.). Larger importations of samples and patterns may be permitted on some local firm undertaking to satisfy the Customs Department that the articles in question shall be re-exported and not be brought into consumption within the Colony.

BRITISH HONDURAS.

Every commercial traveller is required to take out a license costing 5 dollars (£1 0s. 10d.), and on his arrival in the Colony is notified of this regulation by a Customs officer. Patterns or samples brought by a commercial traveller are landed at the Custom House where a note is taken of them, and they have again to be brought to the Custom House and examined previous to shipment from the Colony.

BRITISH NEW GUINEA.

No restrictions of any kind are imposed on British commercial travellers in British New Guinea.

CANADA.

Section 83 of the Canadian Customs Act, c. 32 (Revised Statutes), provides that, during regular warehouse hours, and subject to such regulations as the Collector or other proper officer of Customs at any warehousing port sees fit to adopt, the owner of any warehoused goods may take therefrom moderate samples, without present payment of duty on entry; but it should be noted that under Section 84 of the said Act duties are payable in all cases on the quantity and value of the warehoused goods, as ascertained and stated on the first entry or as originally warehoused.

With regard to the entry of dutiable commercial samples from the United Kingdom or other British country, accompanying a commercial traveller through an intermediate country into Canada, it has been provided (by a Government Notice, dated the 9th June, 1900) that the same may be entered at the Custom House under the British Preferential Tariff, upon proof by certificate or affidavit to the satisfaction of the Collector at the port of entry that the samples are bonâ fide the produce of the manufacture of the United Kingdom or other British country admitted to the benefits of the British Preferential Tariff.

As regards commercial travellers' licenses in Canada, the following particulars have been received from the several Provinces of the Dominion:—

British Columbia.

No license-taxes or other restrictions are imposed by the Provincial Government of British Columbia upon commercial travellers, whether British or foreign or from other Provinces of the Dominion. Municipalities, however, are empowered by the Legislature to levy upon commercial travellers of all nationalities a tax not exceeding 50 dollars for every six months.

In the city of Victoria all persons are free to solicit orders for trade without being taxed in any way; but in certain other cities of the Province a license-fee is imposed.

Manitoba.

Commercial travellers of any nationality selling goods in Manitoba are not required to pay any tax whatsoever, except in the case of a commercial traveller selling wines or liquors, who is subject to both provincial and municipal taxation.

New Brunswick.

There are no regulations in force affecting commercial travellers in New Brunswick, nor are such travellers required to provide themselves with licenses.

North-West Territories.

Municipalities are empowered to impose a tax on commercial travellers doing business within their respective limits. Otherwise, there seems to be no legislation affecting commercial travellers in the North-West Territories; and they appear to be exempted from the operation of the Ordinance imposing licensefees on hawkers or pedlars, by the definition of a hawker or pedlar as "any person . . . selling or offering for sale any "goods, wares or merchandise . . . to any person not being "a wholesale or retail dealer in such goods, wares or merchandise."

Nova Scotia.

There are no regulations in force in the Province of Nova Scotia with reference to commercial travellers.

In some of the incorporated towns a license-fee is sometimes imposed; but this fee is apparently not applicable to commercial travellers selling to merchants on behalf of wholesale establishments, but only to such travellers as make direct sales to their customers. No incorporated town has yet imposed license-fees upon commercial travellers who only do business as agents of wholesale establishments.

Untario.

In the Province of Ontario no licenses have to be obtained by commercial travellers before they can trade or solicit orders, nor is any tax imposed upon such persons.

:Prince Edward Island.

Commercial travellers in any goods except spirits and intoxicating liquors are required to pay to the Provincial Treasurer of the Province an annual license-fee of 20 dollars; and travellers

engaged in the liquor-trade are liable to a license-fee of 200 dollars. Licenses granted on payment of those fees remain in force for one year from the date of issue. For selling or taking orders for goods without a license, a traveller is liable to a fine of 200 dollars, and for refusing to show his license to a Justice of the Peace or other official, to a fine of 50 dollars.

Quebec.

Commercial travellers in this Province are specially exempted from taxation by municipalities, but commercial corporations and their agents are liable to provincial taxation. The agent of a commercial corporation is obliged to file a declaration giving certain details; and dealers in intoxicants require provincial licenses to trade.

CAPE COLONY.

The agent of a firm not belonging to Cape Colony (defined as "any person other than an importer, who sells or offers for "sale by sample or otherwise goods of a firm whose place of "business is not in this Colony; but not including a person who "sells or offers for sale goods consigned to him by a foreign "firm"), must provide himself with a license at the cost of £25, which license, irrespective of the period of the year at which it may be taken out, expires on the 31st December then next. If, however, the license be issued on or after the 1st July, the charge therefor is reduced by one-half.

Commercial travellers' licenses are not transferable even from one agent of a foreign firm to his duly authorised successor; and no refund of duty is made in the case of an agent who does not make use of his license for the full period for which it is is small.

Commercial travellers are allowed free conveyance by rail for 200 lbs. of samples (including personal luggage), provided that such samples are not for sale.

With regard to the Customs treatment of commercial travellers' samples in Cape Colony, Section 41 of the Customs Act, 10 of 1872, empowers the Collector or other principal officer of Customs, under such regulations as he may deem fit, to permit moderate samples to be taken by the importer or his agent of any warehoused goods, without entry and without payment of duty, except as the same shall eventually become payable as on a deficiency of the original quantity. [For the regulations framed under the provisions of this Section, see pp. 60, 1.]

CEYLON.

No Customs regulations exist in this Colony with reference to the admission of commercial travellers' samples and patterns. Samples of no commercial value are admitted without payment of duty, and those of value are allowed to pass free on condition that some approved firm guarantees their re-exportation.

CYPRUS.

No laws or regulations exist requiring commercial travellers to take out licenses, but the Municipal Councils of the principal towns have power to levy what are known as "trade rates" on persons exercising any trade, profession or calling within the municipal limits. At present no rates have been specially fixed for commercial travellers, but they might be classified for purposes of taxation under the following heads viz:—

- "Merchants" ... 3s. to £1 per annum. "Travelling Merchants" 1s. 4½d. per annum. "Commission Agents" 5s. to 15s. per annum.
- The Customs Laws do not provide for the exemption from duty of commercial travellers' samples; but the practice is to register on importation all samples of marketable value, and to assess the import duty thereon at the ordinary rates. The importer deposits at the Custom House of the port of entry the amount of the duty chargeable, and his deposit is subsequently returned to him, either in full or in part, according to whether the whole or only a portion of the samples be re-exported. In the case of patterns or samples having no commercial value, no import duty is charged and no deposit is necessary.

FALKLAND ISLANDS.

No restrictions or conditions of any sort are imposed upon commercial travellers soliciting orders in the Colony, nor are there any Customs regulations in force respecting the introduction of patterns or samples.

Ful.

No license or other document is required by commercial travellers in Fiji. Customs duties have to be paid on all samples of commercial value, but they are refunded in respect of such samples as are subsequently re-exported.

GAMBIA.

No licenses are required by commercial travellers doing business in Gambia, and no restrictions of any sort are imposed

upon their soliciting orders or trading. Samples and patterns of no intrinsic value, brought by such travellers, are allowed to be imported free of duty, but they are inspected by the Customs on arrival and a list made of them, with a view to subsequent inspection and check upon their being taken away from the Colony.

GIBRALTAR.

There are no regulations in force affecting British commercial travellers or the introduction of trade patterns and samples.

GOLD COAST.

Commercial travellers are not required to take out licenses; nor, generally speaking, are any fees recoverable from them. If, however, they elect to land their goods after office hours or on holidays, they are charged the usual fees paid by all importers in like cases.

There are no special Customs regulations affecting commercial travellers' samples: but the practice is to allow such articles, if of no intrinsic value, to be passed without any entries being made; or, if the samples appear to be saleable and of ascertainable value, to require a deposit on importation equal to the amount of the duty recoverable thereon. This deposit is refunded to the owner on certificate of the exportation of the same goods.

GRENADA.

No formal regulations exist affecting commercial travellers doing business in the Colony. Samples of no intrinsic value are admitted free of duty: other samples brought by commercial travellers are inspected on entry into the Colony and a list of them is taken by the Customs authorities. The samples are again inspected and checked against this list prior to their being reexported.

Hong Kong.

There are no regulations in force in Hong Kong affecting British commercial travellers or agents of British firms.

JAMAICA.

By a recent enactment (Law No. 36 of 1899) a commercial traveller—defined as "any person not otherwise licensed under "the Trade License Law (Law No. 18 of 1867), who carries on a

"business of soliciting orders for goods, or of effecting sales from "samples,"—is required to take out a license costing £22 10s, if he deals in spirits, or £12 10s, if he deals in any other kind of goods. The above licenses are valid for one year, and should be renewed on each succeeding 5th April, or within fourteen days thereafter.

There are no Customs regulations affecting commercial travellers; but in practice their samples, if of no intrinsic value, are admitted into the Colony free of import duty. When, however, such samples appear to be saleable, they are valued by the Customs officer, and a sum of money equal to the amount of the duty is lodged with the Collector and placed on deposit; or else a warrant is passed for the samples, and the duty paid in the ordinary way. In the former case, on the departure of the traveller with his samples, the amount of the deposit is returned; in the latter, drawback is allowed according to the usual regulations.

LABUAN. .

No licenses or other documents have to be obtained by British commercial travellers or agents of British firms before they can trade or solicit orders in the Colony.

LAGOS.

No licenses or other documents appear to be required by British commercial travellers or agents in Lagos.

LEEWARD ISLANDS.

No special regulations exist in any of the Presidencies forming this Colony with regard to the introduction of commercial travellers' patterns or samples, but it is usual to admit these articles free of Customs duty. In the case of jewellery or other articles of intrinsic value, a money-deposit, returnable upon reexportation of the samples, or some other form of security, is demanded.

MALTA.

No fees or license-duties are levied on commercial travellers in Malta, and their samples, as a general rule, are exempted from payment of import duty. Samples of wine and spirit exceeding four bottles of ordinary size are, however, subject to duty under the Customs tariff, and samples of manufactured grain (biscuits, &c.), whose weight is in excess of 7 lbs., are also subject to duty at the tariff rate.

MAURITIUS.

A license, costing 100 rupees, and valid for six months, is required by a "commission merchant—agent who buys or sells "or orders from abroad goods on account of others—whether "the goods are imported in his own name or not." Commercial travellers, therefore, are subject to the above license-duty, if they are paid by commission.

As regards the Customs treatment of samples in the Colony, the Collector of Customs is authorised, under such restrictions as he shall see fit, to permit moderate samples to be taken of any warehoused goods, without entry and without payment of duty, except as the same shall eventually become payable as on a deficiency of the original quantity.

NATAL.

A commercial traveller, being "the agent or representative "who, in Natal, solicits orders for the purchase of the goods or "things of any person, firm, or company which does not itself carry "on a licensed business, and also have a place of business in "Natal," is required to take out a license at the cost of £10. Every such license expires on the 31st December of the year in which it is taken out, but it is provided that a stamp of £6 is sufficient for licenses issued on or after the 1st July in any year. If a commercial traveller disposes of his samples in the Colony, he renders himself liable to the charge of £5, which is imposed upon any "hawker or itinerant trader of imported goods, and "for each person, agent, or servant so employed."

With regard to travellers' patterns and samples there are no formal regulations in Natal; but the practice is to admit such patterns free of duty on receipt of a deposit, returnable to the traveller, if, on his departure from the Colony, he can show that none of the goods have been sold. Patterns or samples of no intrinsic value, such as strips of cloth or old boots and shoes, are regarded as free of import duty, but patterns or samples sold in the Colony are charged with duty.

Commercial travellers are allowed 150 lbs. free luggage on the railways if travelling second class, and 200 lbs. if travelling first class.

NEWFOUNDLAND.

No tax is levied upon or license required by any commercial traveller or agent of a British firm, and no distinction is made between the agents of foreign and British firms.

NEW SOUTH WALES.

No license is required by a commercial traveller in this Colony. In ordinary cases no duty is charged upon commercial travellers' samples; but all goods imported in excess of the ordinary requirements for sample purposes, and having a saleable value, are treated as merchandise and subjected to duty at the tariff rates. [As to treatment of commercial travellers' luggage and samples on the New South Wales railways, see pp. 42, 3.]

NEW ZEALAND.

No information has been received from New Zealand in reply to the application made to that Colony. It appears, however, from a communication received from the Agent-General, that commercial travellers representing New Zealand firms are subject to no restrictions, nor is any license-fee imposed upon them.

Travellers' samples of no commercial value, such as cut samples of drapery, are not charged with import duty; but the full duty is charged on finished articles, such as articles of clothing, boots and shoes, articles of plated ware, jewellery, hardware, &c. In the case of a traveller passing through the Colony, the full duty is collected at the port of arrival, and at the port of departure an account is taken of the samples in his possession, and, on proof of exportation, the amount of duty paid on these latter is refunded.

QUEENSLAND.

There are no special regulations affecting commercial travellers in Queensland, and such persons are not required to be licensed.

As regards the admission of samples and patterns, the custom is to collect duty on dutiable goods alleged to be samples, and to allow a drawback of the amount paid if the goods are re-exported intact. The minimum amount of drawback that can be paid is £2; and if any portion of the goods has been sold in the Colony, drawback is refused on the whole parcel. On certain goods drawback is not allowed, viz., ships' stores, grain, tobacco, spirits, wine, beer and jewellery. Cut patterns of no commercial value are admitted free of duty.

St. Helena.

Any person may sell or offer for sale goods of any description without first obtaining a license so to do; and all goods are

subject to a small wharfage rate of 1s, on cases measuring 3 cubic feet, which cases may contain goods to the value of £500. A license, however, is necessary for the sale of liquor but if the liquor in question be the property of any person on board of any vessel at anchor in the harbour and has been imported in such vessel, or if it be consigned for sale to any licensed dealer by any person whether resident in the Colony or not, it may be sold by auction, provided that an exact account of the liquor intended to be sold be given in writing to the Police Sergeant at least 24 hours before the sale takes place.

St. Lucia.

Commercial travellers are not required to take out any license, nor are there any special Customs regulations relating to them in St. Lucia. Their patterns and samples are dealt with under the general provisions of Customs legislation which authorise the free admission of samples.

ST. VINCENT.

No restriction or duty is imposed on commercial travellers or

agents of firms from outside the Colony.

Customs duties according to the tariff are charged on all samples of marketable value imported by a commercial traveller, the duty being refunded to him on his departure from the Colony, less the amount of duty on any samples which he may have sold during his stay.

SEYCHELLES ISLANDS.

A commercial traveller or agent of a British firm trading in Seychelles is required to take out a license, the cost of which varies according to the nature of the trade in which the traveller or agent is engaged. (See pp. 85-7 for a table of these fees.) Licenses remain in force for six months from the date of issue; but the Collector of dues and taxes is authorised under certain circumstances to issue licenses for shorter periods at proportional rates of duty.

SIERRA LEONE.

There are no special laws or regulations in force in this Colony affecting commercial travellers. Certain licenses, however, are required by persons dealing in spirits, wine, and beer, and municipal licenses have to be taken out by persons carrying on any trade or business in the city of Freetown.* Similarly in the Protectorate special

licenses are required for the keeping of stores and the sale of spirits; but the enacting Ordinance does not affect traders who do not reside more than four months in any year in any one place within the Protectorate.

The duty paid on samples and patterns imported into the Colony by commercial travellers may be refunded on re-exporta-

tion if such samples and patterns are intact.

South Australia.

No license-fees are payable by commercial travellers in this Colony. Such travellers have to pay duty on imported samples and patterns according to the tariff, but drawback is allowed on the samples being re-exported. Samples may, however, be delivered on deposit of double the amount of the tariff duty, the deposit being refunded in full when the goods are re-shipped. Cut samples of dutiable articles are admitted free.

STRAITS SETTLEMENTS.

No regulations are in force in the Straits Settlements affecting British commercial travellers, or the introduction of their samples and patterns.

TASMANIA.

A license costing £25 is requisite for every wholesale vendor of wines and spirits, but except in this particular no license-fee is payable by commercial travellers in this Colony. Commercial travellers are subjected to the ordinary tariff as regards their samples and patterns generally; but cut samples of no marketable value are admitted free of duty.

TRINIDAD.

Commercial travellers are allowed to clear as baggage such samples as are necessary for transacting their business, duty being paid on all goods that are liable to duty. But dutiable goods brought as samples may be delivered on deposit of a sum sufficient to cover the duty, provided that the duty involved does not amount to more than £5. The deposit in such cases is returnable on the re-shipment of the goods. If the amount of duty on the goods exceeds £5, the Collector's authority must be obtained. The deposit on such samples will only be refunded on

production of the Tide-Surveyor's certificate to the effect that he has seen the goods on board; and this certificate must be endorsed on the receipt for the deposit, which is to be retained when the deposit is returned.

VICTORIA.

No restrictions are imposed on commercial travellers either on their entry into Victoria or with regard to their business operations in the Colony; and they may take orders for all classes of goods (including spirits, etc.) without any license being required.

Their samples are either admitted on deposit of the duty payable thereon, in which case the deposit is refunded on reexportation, or the duty is charged and the samples stamped or marked in such a way as to be easily identified, so that they can subsequently pass in and out of the Colony without hindrance. No duty is charged on samples, such as cut patterns, &c., which are of no commercial value.

WESTERN AUSTRALIA.

No license-charges of any kind are imposed on commercial travellers in Western Australia.

The total duty payable upon samples and patterns is decided by examination when they are entered inwards; and at the same time a list of the goods is made out for purposes of comparison on re-exportation of the samples. The traveller deposits the amount due, which is refunded to him pro rata on any balance of the shipment re-exported within two months from the date of entry; if no refund be claimed within the period named, the total amount deposited lapses to the Government. No refund of duty can be allowed on samples chargeable on importation with an ad valorem duty if the total value of such samples be less than £50; and under no circumstances will the duty be refunded, except when the samples are exported in the original packages and when the consignment exported exceeds £50 in value.

In the case of jewellery and watches, either the duty must be paid in the first instance, or the goods must be bonded.

WE have the honour to transmit the information obtained in answer to the enquiries made on receipt of Your Lordship's despatch, dated the 19th May, 1898, requesting to be informed of any regulations regarding, or concessions made to, commercial travellers in India that could with advantage to British traders be published in England.

The information is contained in the papers noted in the annexed schedule. It will be seen that there are no regulations in force in British India specially affecting commercial travellers and their calling, and that they are not required to take out licenses. In Calcutta also commercial travellers are not called on

to pay the regular municipal license-tax.

In Native States also there are no special rules or regulations on the subject; but in Kashmir all Europeans, other than civil and military officers of the British Government, whether they are commercial travellers or not, are required to provide themselves with a pass from the Resident before entering the Maharaja's territories; and in Nepal the general prohibition against Europeans visiting Nepal without the permission of the Darbar applies to representatives of European firms.

There are no special regulations for the treatment of samples of merchandise. But it may be said generally that

import duty is charged on import and refunded on re-export to the extent of seven-eighths. Where samples are of no value, no import duty is charged. Wherever octroi is levied, whether in British or Native India, on merchandise brought into towns, the duty applies to samples of merchandise as to goods generally, if the samples are of taxable value.

On the railways commercial travellers are allowed to carry packages of samples with their luggage on all lines, except the Darjeeling-Himalayan, at half the rate for parcels, at owner's risk, but no free allowance is given by any passenger train, nor are commercial travellers' luggage and samples carried at half parcels rate by mail trains on the Bhavnagar-Gondal-Junagadh-Porbandar, Great Indian Peninsula, and Nalhati State Railways. The concession as to the carriage of luggage and samples at half parcels rate is allowed on the East Indian Railway mail trains when the distance to be travelled is not less than 250 miles.

As regards the treatment of samples of merchandise in Native States, we learn that in the Gwalior State no duty is levied when samples are imported and exported again unsold; and it is believed that, generally speaking, the same rules prevail in all the States of Central India, and that probably in cases in which the concession is not provided for by existing rules and regulations, it could be secured without difficulty by application to the Political Officers concerned. There are apparently no regulations for the treatment of samples in the other Native States in India.

With reference to Mr. Robertson's memorandum, dated 29th June, 1898, I am directed to state for the information of the Government of India, that no regulations are in force in this Presidency affecting commercial travellers and their calling, nor are they required to take out any licenses. Any samples of goods brought by them, which have a marketable value, are subject to the payment of Customs duty, but drawback is admissible on re-export of those articles under the provisions of Chapter VI. of the Sea Customs Act, VIII. of 1878.

From E. N. Baker, Esq., C.S., Officiating Secretary to the Government of Bengal, Financial Department, to the Secretary to the Government of India, Finance and Commerce Department. (Dated 13th September, 1898.)

I am directed to acknowledge the receipt of the Finance and Commerce Department Resolution, dated the 29th June, 1898,

forwarding, for report, a copy of a despatch from the Secretary of State for India, in which he desires to be furnished with copies of any regulations regarding, or of concessions made to, commercial travellers in India that could with

advantage to British traders be published at home.

In reply I am directed to say that commercial travellers in Bengal, like all other importers, have to pay Customs duty at the rates fixed in the tariff before they can obtain delivery of their goods. There are no special regulations on the subject, but under the practice at present obtaining at the Calcutta Custom House free entry is allowed in the case of samples of no value (e.g., cut specimens of cotton, silk and other piece-goods, of Berlin wool, of ribbons, odd buttons, odd socks, &c.), also of samples of less value than 10 annas on which the duty chargeable is less than 6 pies.

I am further to say that, under Section 4 of the Income Tax Act, II. of 1886, all commercial travellers are liable to pay Income Tax on any income or profits which they may receive in India, subject to the condition laid down in Section 5 (j) that an

income of less than Rs. 500 a year is exempt.

Foreign commercial travellers residing in Calcutta do not pay any municipal license-tax.

From the Honourable Mr. G. S. Forbes, I.C.S., Secretary to the Government of Madras, Revenue Department, to the Secretary to the Government of India, Finance and Commerce Department. (Dated 8th November, 1898.)

In acknowledging the receipt of endorsement, dated 29th June 1898, referring, for report, a despatch from the Secretary of State on the subject of regulations or concessions made in respect of samples imported by commercial travellers, I am directed to state that no special recognition is accorded here in this respect.

His Excellency the Governor in Council is disposed to think that it is open to consideration whether special provision should not be made for the exemption from Customs duty of bend fide samples of dutiable goods brought into the country by commercial travellers. The Collector of Customs, Madras, and the Board of Revenue, however, deprecate the exemption on the ground that samples are eventually sold in the market, and that it would be difficult to distinguish between bond fide samples and goods brought out for sale.

No. 13.

Office Memo. from the Foreign Department to the Finance and Commerce Department. (Dated 2nd May, 1899).

In reply to the office memorandum from the Finance Department, dated the 17th September, 1898, the undersigned is directed to forward the following information obtained from Political Officers relative to the licensing of commercial travellers:—

- (i.) Kashmir.—There are no rules or regulations in force in Kashmir or Jammu except that Europeans, other than civil and military officers of the British Government, are required to provide themselves with a pass from the Resident before entering the Maharaja's territories.
- (ii.) Rajputana.—There are practically no special regulations in the Rajputana States. Octroi is, however, levied on all goods sold in Alwar by merchants or commercial travellers, and in Jaipur dutiable goods are not charged unless actually sold. It is believed that the same practice prevails in the other States in the Agency.
- (iii.) Hyderabad.—There are no special regulations in force in this State.
- (iv.) Central India—In this Agency commercial travellers have no special status and are subject to no special conditions or regulations, but only to the same rules and conditions as the ordinary members of the mercantile community and the public generally. In Gwalior no duty is levied when samples are imported and exported again unsold. It is believed that, generally speaking, the same rules prevail in all the States of Central India, and that probably in cases where the concession is not provided for by existing rules and regulations, it could be secured without difficulty by application to the Political Officers concerned.
- (v.) Nepal.—There are no regulations regarding commercial travellers, but representatives of European firms are not allowed to enter the country under the general rule which prohibits Europeans visiting Nepal without the permission of the Darbar.
- (vi.) Baroda.—There are no special regulations, but commercial travellers are subject to the general regulations and laws in force in Baroda.
- (vii.) Mysore.—The system of issuing licenses to commercial travellers for the sale of their goods is unknown in Mysore, and there are no rules or regulations on the subject.

In reply to your Circular Despatch of the 6th June, 1899,
I have the honour to state that Governor Sir Ambrose Shea informed your predecessor, Lord Knutsford, in a despatch of the 24th February, 1890, that he had furnished the Board of Trade with the information respecting any regulations affecting British commercial travellers and the Customs regulations with respect to the introduction of their patterns and samples into this Colony.

I have not been able to find any copy of Sir Ambrose Shea's despatch to the Board of Trade, but from the Minutes which passed between the Governor and the Treasury filed in the Governor's office, I find that Sir Ambrose Shea must have informed the Board of Trade that there are no laws or regulations in the Colony affecting commercial travellers, nor any Customs regulation in force as to the introduction of travellers' patterns or samples which it was customary to admit free of duty, provided they are of no great value.

Since Sir Ambrose Shea wrote his despatch abovequoted, nothing has been changed in the conditions attecting

commercial travellers which remain as described above.

By Section 13 of the Tax Ordinance (6 of 1888), commercial travellers bringing goods for sale in the Colony would have to take out a shop license, paying \$48 for the same, unless they "with the knowledge and consent of the Comptroller of Customs" transfer such goods, by instrument in writing, for sale to "some person holding a store or shop license."

Travellers only bringing samples and patterns to show are allowed to land the same free of duty, if the collective value of such goods would not, at the ad valorem duty, give more than \$3 duty. Larger importations of samples and patterns may be introduced to be re-exported on some local firm undertaking to satisfy the Customs Department that such goods shall not be brought into local consumption.

The Transient Traders Act of 1895 provides that a person who visits the Island temporarily for the purpose of selling goods shall procure a license from the Vestry of the Parish of St. Michael on payment of such sum, equivalent to the vestry rate on local traders, as the vestry shall determine; but commercial travellers are specially exempted from the operation of this Act, Section 3 (2) providing that "Nothing herein contained shall prevent any commercial traveller or other person from merely seeking orders for goods."

mercial value are always allowed to pass free of duty.

The general rule is that when the traveller has satisfied the proper authority that the articles which he brings with him are bona fide samples, and not intended for sale, they are passed duty free on a declaration, and no conditions or restrictions are imposed. It has always been understood by this Department that the policy of the Government has been, and is, to afford every facility to commercial travellers, and no distinction whatever has been made between British commercial travellers and those belonging to other nationalities.

Commercial travellers from abroad are not required to take out licenses in this Colony.* The licenses to be taken out annually by commission agents under Law 18 of 1867 do not apply to commercial travellers. There have been cases where persons from abroad have arrived with goods which they have carried about for sale, and such persons have been required to take out licenses as hawkers and pedlars.

There are no Customs regulations affecting commercial travellers. It has been the practice when the samples brought by such travellers are of no intrinsic value to deliver them to their owners and to take no further notice of the transaction.

^{*} But see paragraph 1 of despatch of 27th July, 1899, above. † NOTE.—The charge for these licenses, under Law 41 of 1867, is £2.

When the samples are of such a character as to be saleable, they are valued by the Customs Officer, and a sum of money equal to the amount of duty is lodged with the Collector, and placed on deposit, or a warrant is passed for the samples, and the duty paid in the ordinary way. In the former case, on the departure of the traveller with the samples, the amount of the deposit is returned, and in the latter drawback is allowed on the usual regulations.

A Law to amend The Trade License Law (18 of 1867).

The information given in the Professional Handbook is not

quite complete and correct.

Schedule 2 of the Natal License and Stamp Act, 1898, quotes the license for a "Commercial traveller, being the agent or "representative who, in Natal, solicits orders for the purchase of "the goods or things of any person, firm, or company which does "not itself carry on a licensed business, and also have a place of "business in Natal-£10."

Clause 12 of the Act states :-

"Every such license, when taken out, shall expire on "December 31st of the year in which it is taken out. Provided, "however, that a stamp of three-fifths of the value specified in "the second schedule of this Act shall be sufficient for licenses "duly taken out on or after July 1st in any year."

The Act also provides that, if such commercial traveller disposes of his samples in the Colony, he becomes liable to pay the charge which is imposed upon any "hawker or itinerant trader of "imported goods, and for each person, agent, or servant so

"employed - £5."

The information contained in the Professional Handbook for April, 1899, is incorrect in quoting 100 lbs. as the allowance for luggage of commercial travellers travelling second class-the weight allowed being 150 lbs.

The following information respecting commercial travellers in Natal is quoted from a later edition of the "Professional Handbook" than that referred to in the above despatch:-

There are no written regulations as to commercial travellers in Natal; but there is an established practice here equivalent to a lex non scripta, that travellers' patterns or samples are allowed to be received under the deposit system, that is to say, the traveller makes a small money deposit with the Collector, varying in amount according to circumstances and the discretion of the Collector, and when the traveller leaves the Colony he receives his deposit back if he can show that he has not sold any of the goods.

Patterns or samples of no intrinsic value, such as strips of cloth or old boots and shoes, are regarded as free of import duty; but patterns or

samples sold in the Colony are charged with duty.

The annual license fee of a commercial traveller, being the agent or representative, who, in Natal, solicits orders for the purchase of the goods or things of any person, firm, or company, which does not itself carry on a licensed business and also have a place of business in Natal, is £10. Every such license expires on 31st December of the year it is taken out; if the license is taken out on or after July 1st in any year, the license is only £6. (Stamp Act, 1898.) A commercial traveller is allowed 150 lbs. free luggage on the railways if travelling second class, and 200 lbs if travelling first class.

COMMERCIAL TRAVELLERS' LUGGAGE.—Commercial travellers are allowed to carry with them by passenger train, free of charge, (personal luggage or patterns only) 2 cwt. if a first-class and 11 cwt. if a second-class passenger; and the same allowance will be made to the assistant on presentation of the recognised printed certificate from the Secretary of the Commercial Travellers' Association. All samples in excess of these weights will be charged full goods rates on outward journey, and be sent by goods train unless specially requested to be forwarded by passenger train, in which case full parcel rates must be charged. On production of railway receipts certifying that full rates have been paid on the outward journey the samples will be returned free by passenger or goods train, as may be most convenient to the Department, to the station from which they were originally forwarded. If the traveller requires his samples which were booked by goods train on the outward journey to be returned by passenger train, the difference between goods and parcels rates must be enforced. Samples carried as passengers' luggage must be contained in tin cases, baskets, or leather packages, of a handy size, and must be fully addressed. If contained in cases or other packages in which merchandise for sale is generally packed, ordinary parcels rates will be charged.

Samples will be booked through from starting point to destination, and must travel in a continuous up or down direction, as the case may be, from point of departure to final destination, and any additional journey will be charged for. Freight must be charged separately when booked over branch lines. Should the weight be found to have increased at any intermediate point on the down journey, all undercharges must be paid. In the event of a consignment of samples being offered for transit on the return trip and receipts not being produced, full rates will be charged.

Bona fide commercial travellers between Sydney and Melbourne will be allowed to take with them, free of charge, 1½ cwt.

of samples if first-class, and 1 cwt. if second-class.

Sample Bicycles carried by Bicycle Agents.—Agents representing recognised bicycle agencies of New South Wales are to be allowed one case containing not more than two bicycles free of charge (independent of personal luggage), providing that the cases are of a convenient size, capable of being readily handled, and the total weight does not exceed that allowed to commercial travellers.

The following extract from the "Professional Handbook" contains the particulars referred to in Sir Julian Salomon's letter:—

No license is required in New South Wales by a person who sells or offers for sale, by sample or otherwise, goods of a firm whose place of business is not in the Colony; and all goods imported in excess of ordinary requirements for sample purposes, and having a saleable value, are treated as merchandise Commercial travellers are allowed 2 cwt. of luggage free in the first-class, and 1½ cwt. in the second; holders of yearly railway tickets pay £5 per cwt. per annum on excess luggage (Bye-law of 21st December, 1899). The import tariff of New South Wales is based on free trade, and the duties are now confined to intoxicants, tobacco, cigars, opium, tea, sugar, molasses, treacle, biscuits, confectionery, dried fruit, jams and jellies, and preserves.

Commercial travellers' samples will be conveyed by passenger train at parcel rates on the forward journey, provided that there is room in the brake-van therefor and the train will not be delayed thereby. Half parcel rates will be charged on the return journey on presentation of the receipt showing the upcarriage to have been paid. Provided that, 168 lbs. for a first-class passenger and 112 lbs. for a second-class passenger, including personal luggage, will be carried free on the forward and return journies.

The following information with regard to commercial travellers in Queensland is extracted from the "Professional Handbook":—

There are no special regulations affecting commercial travellers, either from the United Kingdom or elsewhere, in force in Queensland, nor are such persons required to be licensed. Respecting the admission of samples and patterns, the custom is to collect duty on goods alleged to be samples when such are liable to duty; if they are re-exported intact, to allow a drawback of the duty paid on importation. If any portion of the goods is sold here, drawback is refused on the whole parcel. The minimum amount of drawback that can be paid is £2. Cut patterns of no commercial value are admitted duty free. Drawback is not allowed on the following goods, viz.: ships' stores, grain, tobacco, spirits, wine, beer, and jewellery. Commercial travellers are allowed 168 bs. of free luggage in the first-class and 112 bs. in the second, these quantities including personal luggage.

WITH reference to your Circular Despatch, dated 6th June last, concerning licenses which have to be obtained by British commercial travellers before they can trade with foreign countries, I have the honour to state that there has been no change since the reply which was sent to your predecessor's Circular Despatch of 6th January, 1890.

It is open to any person to sell or offer for sale goods of any description without first obtaining a license so to do, and the Customs Tariff allows any goods, by any person, to pass on payment of a small wharfage rate, viz., 1s. for a case measuring three cubic feet. (The case may contain goods of the value of £500.) There is no ad valorem duty upon anything, nor is any license necessary to sell goods, except liquor. But liquor the property of any person on board of any vessel at anchor in the harbour and imported in such vessel, or consigned for sale to any licensed dealer by any person, whether resident in the Colony or not, may be sold by auction, provided only that an exact account of the kind and qualities of the liquor intended to be sold by auction is first given to the police sergeant in writing at least twenty-four hours before such sale.

Minute from Treasurer.

Commercial travellers are not required to take out any license in this Colony, nor are there any special Customs regulations relating to them. Their patterns and samples are dealt with under the general provisions of the Customs Ordinance, which authorises the treasurer "to permit moderate "samples to be taken of any goods warehoused, without entry and without "payment of duty, except as the same shall eventually become payable as a "deficiency of the original quantity."

The treasurer is also authorised under the same Ordinance "to permit "the owner of any warehoused goods, under the supervision of a revenue "officer, to sort, separate, pack, and repack any such goods, or to make such "arrangement of them as may be necessary for their preservation or for their "sale, shipment, or legal disposal."

1st August, 1899. SIR. I HAVE the honour to acknowledge the receipt of your Circular Despatch of the 6th June last, asking for information concerning the licenses or other documents which have to be obtained by British commercial travellers before they can trade or solicit orders in this Colony.

On reference to the records of the office I cannot find that any reply was ever sent to Lord Knutsford's Circular Despatch of

the 6th January, 1890.

At the time that Circular was received "The Licenses Ordinance, 1886," imposed a license-duty of £10 a year on every "transient trader," under which term was included any person, not a resident in the Colony and paying income tax, who carried on any trade in the Colony. It only applied to commercial travellers if they actually disposed of any of the samples which they brought with them.

This duty led to constant questions, and it was seldom possible to enforce it, and it practically brought in no revenue at all. It was therefore omitted from the schedule of licenses when the law was consolidated and amended by "The Licenses

Ordinance, 1896" (No. 10 of 1896).

There is now no restriction or duty on commercial travellers

or agents of firms from outside the Colony.

As regards Customs duties, a commercial traveller is expected to make an entry and pay the Customs duty according to the tariff on all samples with a commercial value which he brings to the Colony. The duty is refunded to him on his departure from the Colony, less the amount of duty on any samples which he may have disposed of during his stay.

Commercial travellers receive every consideration in South Australia. They, of course, have to pay duty according to the tariff, but may obtain drawback on re-exportation. They may also, on application, have their samples delivered on deposit of double the amount of duty, and, after exhibiting them, may, on re-shipment, obtain a refund in full. Cut samples of dutiable articles are not charged duty. No license-fees are required. Luggage up to $1\frac{1}{2}$ cwt. is free on first-class tickets, and up to 1 cwt. on second-class tickets, and excess is charged at parcel rates on the down journey, and is free on the up journey: by parcel rates the carriage of 112 lbs. costs 4s. 8d. for 100 miles, and 8s. for 300 miles.

WITH reference to your Circular Despatch of the 6th June, calling for information concerning the licenses or other documents which have to be obtained by British commercial travellers or agents of British firms before they can trade or solicit orders in Sierra Leone, I have the honour to inform you that under Ordinances Nos. 13 and 14 of 1874 certain licenses are required to be taken out and paid for by any person dealing in spirits or in wine and beer in the Colony, and under Ordinance No. 6 of 1893 municipal licenses have to be taken out by persons carrying on any trade or business in the City of Freetown. By Ordinance No. 11 of 1897 special licenses are required for keeping stores and for the sale of spirits in the Protectorate, but by Ordinance No. 15 of 1897 store licenses are not required by traders who do not reside more than four months in any year in any one place in the Protectorate.

Copies of the 1874 Ordinances and extracts from the 1893 and 1897 Ordinances, as far as they relate to licenses, are annexed to this despatch.

There are no special laws or regulations in operation in Sierra Leone for commercial travellers, and should such travellers arrive in Sierra Leone and carry on business within the meaning of the above-mentioned Ordinances, it would be necessary for them to take out the prescribed licenses.

It is possible, however, under the existing Customs Laws, to give special facilities to travellers in the matter of the introduction of patterns and samples. Section 77 of the "Sierra Leone Customs Ordinance, 1880," lays down that "the Collector of "Customs at Freetown, subject to the assent of the Governor, may "permit the entries of any goods, either for importation or "exportation, as the case may be, in such form and manner, and "on such conditions as he may direct, to meet the exigencies of "any case to which the general laws and regulations may not be

"strictly applicable." Under this section I should permit a refund of import duties paid by travellers for patterns and samples on the travellers leaving the Colony with these patterns and samples intact.

An Ordinance to further amend the laws relating to the Title. sale of spirituous liquors in this Settlement.

Whereas it is expedient to further amend the laws relating to Preamble. the sale of spirituous liquors.

Be it enacted by the Administrator-in-Chief and Legislative Council of this Settlement as follows:—

1. It shall be lawful for any person who shall be desirous of License for selling spirituous liquors to be drunk or consumed either in or selling out of the house or place specified in the license hereinafter Spirituous mentioned to obtain a license for that purpose, and in every Liquors to be drunk or specified in the license which application shall be made to application for such license, which application shall be made to consumed the Colonial Treasurer at the Treasury Office in Freetown, there either on or shall be specified, set forth, and inserted the christian name and off the surname of the party applying for such license, and a description premises. of the house or place in or at which spirituous liquors are intended to be sold, together with the christian names and surnames and the occupation and residence of the persons who shall be proposed as sureties for the party applying for such license; and it shall be lawful for the Colonial Treasurer and he is hereby authorised and required, within ten days after application shall have been made for the same, and upon execution by the party and his sureties of the bond mentioned in the Schedule, marked B, to an Ordinance intituled "An Ordinance to amend the Laws relating to the sale of Spirituous Liquors in this Colony," dated the 14th day of March, 1854, and at any time after, upon the execution of such bond, to issue such license to the party applying for the same, the said party first paying for such license the sum herein set forth, and every such license shall be according to the Schedule A., annexed to this Ordinance.

II. There shall be paid for the license granted pursuant to the last preceding section unto Her Majesty, her heirs and successors, the following duties or sums of money, that is to say:—

For every license for the sale of Spirituous Liquors beyond the limits of the parish of Saint George, Freetown ... £20 half yearly £12 quarterly.

Proviso for reduction in certain cases. Provided nevertheless that it shall be lawful for the Colonial Treasurer, and he is hereby authorised and required, in the case of any party applying for a license under section I of this Ordinance, who shall at the time of the issuing of such license be possessed of a license under the said Ordinance dated the 14th day of March, 1854, to make a reduction in the above mentioned duties or sums of money calculated in respect of the period which would have elapsed before the expiration of such last mentioned license, and the proportion of the amount paid for such license which would be attributable to the period so unelapsed, but in every such case the said last mentioned license shall be delivered up to the Colonial Treasurer.

This Ordinance incorporated with Ordinance of 14th March, 1854, relating to the sale of Spirituous Liquors.

Short Title.

III. This Ordinance, and so much of the said Ordinance dated the 14th day of March, 1854, as has not been repealed by this or any other Ordinance, shall be read together and construed as one Ordinance, and sections V, VI, IX, X and XI of the said Ordinance dated the 14th day of March, 1854, be deemed to include and apply to any license granted in pursuance of this Ordinance and the person obtaining the same.

IV. This Ordinance may for all purposes be cited as "The sale of Spirituous Liquors Amendment Ordinance, 1874."

An Ordinance for the imposition of licenses for the sale Title. of Wine and Beer.

Whereas it is expedient that licenses should be imposed in Preamble. respect to the sale of Wine and Beer.

Be it enacted by the Administrator-in-Chief and Legislative Council of this Settlement as follows:-

I. From and after the passing of this Ordinance it shall not Imposition be lawful for any person other than a person holding a license of License. for the sale of Spirituous Liquors to sell Wine or Beer without having first obtained a license for that purpose according to the form in the Schedule annexed to this Ordinance, which license may be obtained upon personal application to the Colonial Treasurer at the Treasury Office in Freetown, who is hereby authorised and empowered to grant the same upon payment of the duties or sums of money hereinafter set forth; but such license shall not authorise the person obtaining the same to sell Wine or Beer at any other house or place than the house or place named in such license.

II. There shall be paid for the license granted pursuant to the Duties paylast preceding section unto Her Majesty, her heirs and successors, able for the following duties or sums of money, that is to say :-

For every license for the sale of Wine and E5 per annum.

Every person committing any breach of this Ordinance shall, upon being convicted thereof before any Police Magistrate or Justice of the Peace sitting for him or the Manager or Justice of the Peace of any district, in such district, be fined any sum not exceeding ten pounds nor less than two pounds; and in default of payment shall be imprisoned for any term not exceeding three calendar months or until payment of the penalty and costs; and shall upon being convicted a second time forfeit his or her license.

V. This Ordinance may for all purposes be cited as "The sale of Wine and Beer Licensing Ordinance, 1874."

Enclosure III.—Extract from "THE FREETOWN MUNICIPALITY ORDINANCE, 1893."

Part V.—Municipal Licenses.

- 18. (1) It shall be unlawful for any person to exercise, carry on, Business or practise in any house, warehouse, store, shop, building, yard or other premises, or part thereof respectively, of which the annual assessed value (as shown by the valuation list for the time being in force) is not less than £6, any trade, business, or profession, without having first taken out a license for that purpose, and paid for such license a sum equal to one shilling in the pound on the annual value of such house, warehouse, store, shop, building, yard, or other premises, or part thereof.
- (2) The preceding provisions of this section shall not apply to any trade, business or profession set forth in the first part of the

fourth schedule.

- (3) It shall be unlawful for any person to exercise, carry on, or practise in the city any of the trades, businesses, or professions set forth in the first part of the fourth schedule without having first taken out a license for that purpose. Provided that this sub-section shall not apply to any public officer who does not exercise, carry on, or practise his business or profession otherwise than in the service of the Imperial or Colonial Government.
- (4) The owner of any vehicle mentioned in the second part of Licenses for the fourth schedule, who shall reside in the city or therein Vehicles. exercise, carry on, or practise any trade, business, or profession, shall take out a license for every such vehicle, and pay for such license the duties or sums of money set forth in the second part of the fourth schedule; provided that it shall not be necessary for licenses to be taken out in the following cases, namely-

- (a.) For any vehicle belonging to the Imperial or Colonial Government; or
- (b.) For any vehicle being or forming part of the stockin-trade of a builder, manufacturer or seller of vehicles; or
- (c.) By an officer in the service of the Imperial or Colonial Government who is in receipt of hammock allowance;
- (d.) By any Government contractor who may supply hammocks solely for the use of the Imperial or Colonial Government.
- (5) It shall be unlawful for any person to do in the City any Licenses for of the acts or things mentioned in the third part of the fourth menta. schedule, without having first taken out a license for that purpose, and paid for such license the duties or sums of money set forth in the third part of the fourth schedule.

Commencement of Section.

(6) The provisions of this section shall not come into operation until the first day of June, 1895.

Penalties.

- 121. (1) Any person exercising, carrying on, or practising any trade, business, or profession, or being the owner of any vehicle, or doing any of the acts or things mentioned in the third part of the fourth schedule, who shall, upon demand being made by the Inspector General, any Inspector of Police, or Police Constable, refuse or fail to produce and show his license for exercising, carrying on, or practising any such trade, business, or profession, or for such vehicle, or for doing any such acts or things, shall be liable on summary conviction to a penalty not exceeding five pounds.
- (2) Every person committing any breach of the provisions contained in this part shall for every such offence be liable, on summary conviction thereof, to a penalty not exceeding fifty pounds, and in default of payment to imprisonment with or without hard labour for any period not exceeding six months.
- (3) Any person who shall let out, hire, or lend his or her license, or who, not having taken out a license under this Act, shall produce, exhibit or use any paper with intent to cause it to be believed that he or she has duly taken out a license as aforesaid, shall for every such offence be liable, on summary conviction thereof, to a penalty not exceeding twenty pounds, and in default of payment to imprisonment with or without hard labour for any period not exceeding three months.

The Principal Ordinance shall be, and the same is, hereby amended as follows:--

In section L. by adding the following words after the word "purpose" in line 5 thereof:—

Provided always that no person shall be exempt from payment of such license merely by reason of changing his place of business, should he have used any other house or building for purposes of trade within a radius of twenty miles of any such building so originally used by him for periods amounting in the whole to over four months, within twelve months from the first day of January in each year.

Commercial travellers in Tasmania pay no license fee, and no distinction is made between them and other importers, except in regard to small quantities of tobacco as samples which the ordinary importer is prohibited from introducing into the Colony. All cut patterns of no value except as samples are admitted free of duty. A license of 25*l*, to sell wholesale is needed by every vendor of wines and spirits.

Enclosure.—Extract from Customs Regulations dated 5th April, 1884.

509. Commercial travellers may be allowed to clear as baggage such samples as are necessary for transacting their business, duty being paid on any part of them liable to duty.

510. On the written application of commercial travellers, which is to be filed in the baggage warehouse when the cashier's receipt for it on deposit is obtained, the landing waiter examining their baggage may, without reference to the Collector, deliver goods liable to duty brought as samples, on a deposit sufficient to cover the duty being made with the cashier, to be returned on the shipment of the goods, provided the amount of duty involved does not exceed five pounds. If it exceeds that amount, the Collector's authority must be obtained. Owners of such goods are to be warned that the deposit will only be returned on production of the Tide Surveyor's Certificate of having seen the goods on board, such certificate to be endorsed on the receipt for the deposit, which is to be retained by the cashier when the deposit is returned.

There are no license charges to commercial travellers, and, beyond what I have referred to above, no regulations or legislation on the subject, so far as I am aware.

Commercial Travellers' Samples.—Half through-parcel rates; minimum 1 cwt.

By adopting this means of transit to and from Albany, instead of the steamers, merchants would effect a considerable saving in time of delivery, also obviate risk of damage through excessive handling.

Free Goods.—For goods requiring clearance at Customs at Albany, the appointment of some reliable firm to act as agents

is strongly recommended in all cases.

Commercial Travellers' Luggage.—Commercial travellers will be allowed, free of charge, at owner's risk, of personal luggage and samples:—

For each first class ticket ... 2 cwts. For each second class ticket ... 1½ cwts.

All excess weight of luggage over and above the weight allowed free, and not exceeding 10 cwt., is charged one-third parcels rate (minimum 1 cwt.), and provided there is room in the brake van of the train, and that the train will not be delayed thereby.

10 cwt. and over.—Over 10 cwt. a carriage truck must be employed at sixpence per truck per mile, minimum 30 miles, and maximum weight 50 cwt.

Bicycle tickets held by commercial travellers will be treated in the same way as commercial travellers' excess luggage tickets.

Samples can be booked through and the journey may be broken by the traveller with his samples on his so arranging at the stations from which he starts, provided he travel by the same train.

In all cases carriage must be prepaid.

The following extract from the "Professional Handbook" contains the information referred to in Mr. Wittencom's letter:—

Commercial travellers and others will be allowed to pass their samples in Western Australia on deposit of the duty due, the amount of duty to be decided by the examination of the samples when entered inwards, a list of the goods being then taken. When entered outwards for drawback, the shipment is again to be examined and compared with the list, the full duty deposited on importation being refunded pro ratio on any balance of the shipment, provided it be exported within two months from day of entry inwards. The deposit, or the balance thereof after any refund, will be carried to the credit of the Government immediately the goods or the balance thereof shall have been exported. If no refund be claimed within two months from date of entry, the whole of the deposit will be carried to the credit of the Government. No refund of duty can be allowed on samples chargeable on importation with an ad valorem duty, when such samples are of a less total value than £50. The duty on jewellery and watches must be paid in the first instance, or the goods must be bonded. In no case will any refund of duty be allowed, except when samples are exported in original packages, and when the consignment exported exceeds £50 in value. Commercial travellers are allowed free of charge 2 cwts. of personal luggage and samples free in the 1st class, and 1½ cwts. in the 2nd class; excess luggage up to 10 cwts. is charged one-third parcel rates (minimum 1 cwt.).

ADDITIONAL INFORMATION WITH REGARD TO CERTAIN OF THE COLONIES SPECIFIED IN SCHEDULE B OF THE COLONIAL OFFICE LETTER OF THE 25TH SEPTEMBER, 1899. (See p. 27.)

CAPE COLONY.

The following extract from the "Professional Handbook" contains information with regard to commercial travellers in Cape Colony:—

In Cape Colony under the provisions of Section 3 of Act 33 of 1887, an agent of a foreign* firm is defined as "any person other than an importer, "who sells or offers for sale by sample or otherwise goods of a firm whose "place of business is not in this Colony; but shall not include a person who "sells or offers for sale goods consigned to him by a foreign firm." In Schedule II of same Act under "Tariff of licenses, annual," it is provided that "For every agent of a foreign firm the charge for license-duty shall be £25, "and by clause I. of this schedule it is further provided that all of the above " (annual) licenses shall, no matter at what period of the year they may be "taken out, expire on the 31st December then next. When any such license " shall be issued upon or after the 1st July, there shall be payable only one-" half of the appointed sum (which in the case of an agent of a foreign firm " for a license taken out on and after the 1st July would amount to £12 10s.). "If taken out at any time before the 1st July there shall be no deduction." · A license taken out at Cape Town enables the licensed agent to travel to every town in the Colony during the currency of the license. The license being personal cannot be transferred from one person to another. Therefore an agent of a foreign firm who leaves the Colony before the expiration of the license, and who is succeeded by another duly authorised agent of the same firm, cannot pass the license to his successor for the unexpired term of such license. No refund of license-duty can be made in respect to a license which is only used for a period less than that mentioned in the license, the owner of which either returns to Europe or continues his journeys to other countries, or who is succeeded by another agent. Under the same Section (3) an "importer" means every person who imports any goods other than the produce of South Africa for the purpose of trade or barter; provided that such importation shall be of the value of at least £1,200 during the year ending 31st December. The charge for license-duty is £12 over and above his license as a general dealer, auctioneer, broker, or dealer in gunpowder, or any other license he may hold, subject to the provisions above quoted as to yearly and half-yearly licenses.

An agent of a foreign firm who was not a bond jule importer, that is, one who imported goods not of the value of £1,200 in any one year, and who sought to evade the payment of the higher duty (£25) by taking out licenses as an importer (£12) and general dealer (£3), would render himself liable to a penalty of five times the amount of the license-duty (or £125), under the provisions of Section 6 of Act No. 13 of 1870, for trading as an agent of a foreign firm without a heense.

A "broker" under Section 3 of the Act is defined as every person (other than an importer or agent of a foreign firm) who shall in this Colony carry on the trade or business of making bargains and contracts between other persons in matters of trade, commerce, or navigation for a remuneration commonly called a "brokerage." The license-duty is £5 for the whole year, commencing 1st January, or £2 10s. for the half year, commencing 1st July.

Commercial travellers are allowed free conveyance of 200 lbs, of samples by rail (including personal loggage), provided that such samples are not for sale

^{*} The word "foreign" is used to describe anyone not belonging to this Colony; consequently the expression "agent of a foreign firm" includes "agent of a British firm" or "agent of a British Possession firm."

The following particulars respecting the treatment of samples have been extracted from the Customs regulations of the Colony:—

Section 41 of the Customs Act 10 of 1872 provides:—

It shall be lawful for the Collector or other principal officer of Customs, under such regulations as he shall see fit, to permit moderate samples to be taken by the importer or his agent of any goods so warehoused, without entry and without payment of duty, except as the same shall eventually become payable as on a deficiency of the original quantity.

Regulations.

Samples will be permitted to be taken under the following regulations:-

Application in writing is to be made to the warehouse-keeper, stating the name of the ship, importer, date of warehousing, and the marks and numbers of the packages from which samples are required.

The warehouse-keeper will then authorise the locker to deliver such moderate samples as may be necessary, the locker to endorse on the authority the fact of the package having been opened and re-secured, and the quantity taken therefrom as a sample.

The following are the quantities that may be taken as samples:—

No bottles entered as containing wine are to be opened for the purpose of taking a sample unless the officers have reason to suspect that the bottles contain spirits or other articles chargeable with a higher rate of duty, and then only with the sanction of the officer in charge of the port; the corks to be replaced when the contents are ascertained, and the bottles to be returned to the packages.

With reference to a Circular from the Secretary of State for the Colonies, dated 6th January, 1890, containing instructions to furnish the Board of Trade with information as to any regulations affecting British commercial travellers in Malta and respecting any Customs regulations in force as to the introduction by them of patterns or samples, I have the honour to state that no fees affecting commercial travellers are levied in Malta, nor are any licenses taken out by them.

Malta, nor are any licenses taken out by them.

Travellers' samples of articles subject to duty are, as a general rule, free from import duty in Malta. Samples of wines and spirits, however, when exceeding four bottles of ordinary size, are subject to the import duty levied by the Customs tariff, viz.: spirits at the rate of 24s. per Maltese barrel, or 9½ imperial gallons, and wine at 3s. 2d per dozen bottles.

Samples of manufactured grain (biscuits, &c.), when exceeding 7 lbs., are subject to the duty of 6s. per Maltese cantar, equivalent to 175 lbs., according to the tariff above referred to.

CYPRUS.

The following particulars were supplied to the Board of Trade in 1890, in compliance with Lord Knutsford's Circular Despatch referred to above:—

With reference to Lord Knutsford's Circular Despatch of the
6th January, 1890, I am directed to inform you that there are no laws or
regulations in force in Cyprus requiring commercial travellers, coming to this
country, to take out licenses, or in any way affecting the freedom of their
operations, but the Municipal Councils which are established in the principal

towns have power by law to levy what are known as "Trade Rates," that is rates charged on persons exercising any trade, profession or calling within the municipal limits.

So far no rates have been specially fixed for commercial travellers, but they might be classed under the following heads for which various rates are in force as stated against each, viz. :--

" Merchants" 3s, to £1 per annum.

"Travelling Merchants" ••• · 1s. 43d.

"Commission Agents" ... 5s, to 15s, ","
With regard to the Customs regulations in force affecting travellers' patterns or samples, I am directed to state that the Customs laws provide for no exemption from taxation of such patterns or samples, but the practice in Cyprus is to register on importation, and assess the import duty at the ordinary rates on all patterns and samples which have a marketable value, the importer depositing at the Custom House of the port on entry the amount of the import duty. If subsequently the patterns or samples are taken out of the Island, the amount of import duty so deposited is returned. Should only a portion of the patterns or samples be withdrawn, a proportionate amount of duty is returned.

In the case of patterns or samples of no marketable value, no charge is

made, and no deposit is required.

There are no restrictions regarding commercial travellers themselves as regards their entry into Victoria or doing business in this Colony.

In regard to samples, the rule is as follows. Samples may be admitted on deposit of duty thereon, which duty is refunded when the samples are taken away, or duty is taken on the samples and they are then stamped or marked in such a way as to identify them. Such samples when so stamped or marked can pass subsequently in and out of Victoria without hindrance.

Duty is not charged on samples when they are not of any commercial value, e.g., cut patterns, &c. As regards railway concessions I presume the Railway Department will be con-

sulted.

I may add that commercial travellers can take orders in Victoria for all classes of goods (including spirits, &c.) without license.

The Provincial Government of British Columbia does not impose a license, tax, or other restrictions upon commercial travellers, whether British or foreign, or from other Provinces of the Dominion.

Municipalities, however, are empowered by the Legislature (61 Victoria, chapter 144, R. S., section 171, sub-section 13) to levy a tax not exceeding \$50.00 for every six months upon commercial travellers indiscriminately.

In the City of Victoria all are free to canvass for orders for the trade without being taxed in any way; but in some of the cities of the Province a license-fee is imposed.

An Ordinance respecting Auctioneers, Hawkers, and Pedlars.

THE Lieutenant-Governor by and with the advice and consent of the Legislative Assembly of the Territories enacts as follows:—

Interpretation "Hawker" 'Pedlar." 1. In this Ordinance the expression "hawker" or "pedlar" means and includes any person who (being a principal or any agent in the employ of any person) goes from house to house selling or offering for sale any goods, wares or merchandise or carries and exposes samples or patterns of any goods, wares or merchandise, to be afterwards delivered within the Territories to any person not being a wholesale or retail dealer in such goods, wares or merchandise; but shall not mean or include any person selling meat, fish, fruit, agricultural implements, sewing machines or farm produce by retail.

License to pursue certain callings. 2. No person shall follow the calling or pursue the business of an auctioneer, hawker or pedlar within the Territories without having first obtained a license therefor, which license shall be issued by such person as the Lieutenant-Governor in Council may authorise.

Application for license.

3. Every applicant for a hawker's or pedlar's license shall, as part of his application for such license, furnish a statement in writing containing a full description of the goods, wares and merchandise which he proposes to sell or offer for sale under such license.

Fees payable.

- 4. On every application for a license under this Ordinance there shall be paid:
 - (a) For a hawker's or pedlar's license the sum of \$25;
 - (b) For an auctioneer's license, on first application therefor, the sum of \$10, and on every subsequent consecutive application the sum of \$5.

5. No hawker or pedlar shall sell or offer for sale any goods, Hawker's wares or merchandise other than those set forth in his application sales limited. for license.

6. Every license issued under this Ordinance shall expire on Duration of the thirty-first day of December of the year in which it is issued. license.

7. Any person violating the provisions of this Ordinance shall Penalty. be liable, on summary conviction thereof, to a fine not exceeding \$100 and costs of prosecution.

8. The provisions of this Ordinance shall not apply within a Municimunicipality, nor shall any license be issued under the provisions palities thereof in any such municipality.

REFERRING to the despatch received by you from the High Commissioner for Canada intimating that the Colonial Office were asking for information as to the regulations affecting commercial travellers in British Colonies, I beg to say that in the Province of Nova Scotia there are no provincial regulations in respect of commercial travellers. In some of the incorporated towns a license-fee is sometimes imposed, but I think that this does not apply to commercial travellers selling to merchants on behalf of wholesale establishments, but only to commercial travellers who are making direct sales to parties. So far as I am aware, no incorporated town has yet imposed license-fees upon commercial travellers only doing business on behalf of wholesale establishments.

WITH reference to the despatch of the Under-Secretary of State, dated 17th July, 1899, respecting commercial travellers, I find that through some oversight no reply appears to have been heretofore made.

I have now the honour to state that I am advised that in the Province of Ontario no licenses have to be obtained by commercial travellers before they can trade or solicit orders, nor is a tax of any nature imposed upon them as such. I am informed that some of the Provinces claimed the right under the B.N.A. Act, whether correctly or not, of imposing on such persons a license, fee, or tax, or something of that kind payable to the Province; but I am not aware that this claim was made by any of the Ontario Ministers. I believe that in some of the Provinces, or perhaps all, in which a license, fee, or tax was imposed, it has been abolished as being detrimental to the municipalities.

Commercial Travellers' Act.

An Act to impose a Direct Tax on certain classes of Traders.

[Assented to May 9th, 1894.]

Be it enacted by the Lieutenant-Governor and Legislative Preamble. Assembly, as follows:-

- 1. From and after the passing of this Act, every casual trader Tax or not permanently residing in this Province doing business within License-Fee this Province, commonly known as "commercial travellers," and of 15 dols. on every person not permanently residing in this Province, and who commercial sells, either for himself or any other person, any goods, wares or travellers, merchandise in this Province, or solicits or canvasses for orders, etc., not per-either for himself or any other person for the sale analysis. either for himself or any other person, for the sale, exchange or residents. purchase of any goods, wares or merchandise within this Province, either by the production of samples, photographs, catalogues, printed or written matter, or simply by word of mouth without the production of samples, photographs, catalogues, printed or written matter, shall, before he or she enters upon the business of so selling any goods, wares, or merchandisc, or soliciting or canvassing for such orders, pay to the Provincial Treasurer of this Province an annual license-fee or direct tax of fifteen dollars.*
- 2. Upon payment of the said license-fee or direct tax, the License said Provincial Treasurer shall grant a license authorising the good for one person therein named to sell goods, wares and merchandise in year only. this Province, and to solicit and canvass for orders for the sale, exchange or purchase of goods, wares and merchandise within this Province; such license shall be granted and remain in force for the space of one year following the date upon which the said license shall be granted and no longer.
- 3. Any such commercial traveller or person not permanently residing in this Province, as aforesaid, who, after the passing of selling or this Act, shall sell any goods, wares or merchandise, or solicit or taking orders canvass for orders for the sale, exchange or purchase of any for goods goods, wares or merchandise in any manner aforesaid within without license. this Province without having first paid the said license-fee or direct tax, and obtained the said license, shall for each and every occasion upon which he or she shall sell any goods, wares or merchandise, or solicit or canvass for an order for the sale, exchange or purchase of any goods, wares or merchandise, as aforesaid, be liable to pay the sum of two hundred dollars to the said Provincial Treasurer.
- 4. Any such commercial traveller or person not permanently Penalty for residing in this Province, as aforesaid, and who sells any goods, refusing to

wares or merchandise, or solicits or canvasses for orders for the sale, exchange or purchase of any goods, wares or merchandise within this Province, and who upon demand by any justice of the peace, sheriff, constable, or by any person appointed by the Provincial Treasurer or the Lieutenant-Governor in Council, or by any person to whom he shall sell any such goods, wares or merchandise, or from whom he shall solicit or canvass for an order for the sale, exchange or purchase of any goods, wares or merchandise, shall refuse to produce his license under this statute, shall pay to the Provincial Treasurer for every such refusal the sum of fifty dollars.

5. It shall be lawful for the Provincial Treasurer under his

Prov. Treas. may authorize others to receive payment of fee.

made by appointees first day of every month.

hand and seal to authorize any person or persons in this Province to receive payment of the license-fee or tax hereinbefore imposed. Every person so appointed shall be bound on the first day of every month to make a return to the Provincial Treasurer showing the number of licenses issued by him and the amount of Returns to be money received by him, and also to pay over the money so received. In order to facilitate the checking of such return, the Provincial Treasurer shall furnish each such person with blank forms of such licenses, signed by said Provincial Treasurer numbered consecutively, and with each return above required the person so appointed shall send a statement of the number of blank licenses still in his hands, and their numbers. licenses before being issued shall be countersigned by the person actually issuing same. Each person so appointed, as aforesaid, shall give a bond with sufficient sureties to the Queen for the due execution of his duties.

Tax may be recovered with costs in County Court of any County by writ of summons or capias.

6. The tax hereinbefore imposed, and also the sums payable respectively under sections three and four of this Act, may be recovered with costs by suit in the County Court in any County of this Island, irrespective of which County the cause of action may have arisen in. Such action may be commenced either by writ of summons or capias, and the proceedings in any such suit shall in all respects be similar to the proceedings in other suits over which said Courts have now jurisdiction. The suit shall be brought by the Provincial Treasurer without mentioning his name as Plaintiff.

Nature of affidavit to obtain capias.

7. The affidavit to obtain a capias for the arrest of any defendant may be made by the Provincial Treasurer or by his assistant or by any other person. It shall be sufficient in such affidavit to state that the cause of action exists to the best of the knowledge, information and belief of the person making the same, and it shall not be necessary to state the source of his knowledge or his information, or to state either that the defendant has parted with or assigned his goods and chattels since the debt was contracted, or to state anything as to the defendant being about to leave the Province.

8. An affidavit in the following form shall in all cases be Form or affidavit. sufficient.

1. Section One of the Act Fifty-seven Victoria, Chapter Four, intituled "An Act to impose a Direct Tax on certain classes of Traders" is hereby repealed, and the following section inserted

in lieu thereof: "From and after the coming into force of this "Act every casual trader not permanently residing in this "Province, doing business within this Province, commonly "known as "Commercial Travellers," and every person "not permanently residing in this Province and who sells "either for himself or any other person, any goods, wares, "or merchandise (not being liquor) in this Province, or "solicits or canvasses for orders, either for himself or any "other person, for the sale, exchange or purchase of any goods, "wares or merchandise (not being liquor) within this Province, "either by the production of samples, photographs, catalogues, "printed or written matter, or simply by word of mouth without "the production of samples, photographs, catalogues, printed or "written matter, shall before he or she enters upon the business of "so selling such goods, wares or merchandise (not being liquor), or "soliciting or canvassing for such orders, pay to the Provincial "Treasurer of this Province an annual license-fee or direct tax of "twenty dollars; and every casual trader not permanently "residing in this Province, doing business within this Province, "commonly known as "Commercial Travellers," and every person "not permanently residing in this Province and who sells, either "for himself or any other person, any liquor in this Province, or "solicits or canvasses for orders, either for himself or any other "person, for the sale, exchange or purchase of any liquor within "this Province, either by the production of samples, catalogues, "printed or written matter, or simply by word of mouth, without "the production of samples, catalogues, printed or written matter, "shall before he or she enters upon the business of so selling any "liquor, or soliciting or canvassing for such orders, pay to the "Provincial Treasurer of this Province an annual license-fee or "direct tax of two hundred dollars." The words "goods, wares and merchandise" where they occur in Sections Two, Three and Four, of the said Act Fifty-seven Victoria, Chapter Four, shall be taken to mean and include liquor.

2. Section Eight of the said Act is hereby repealed, and the following inserted in lieu thereof:—

"An Affidavit in the following form, or as nearly thereto as circumstances "will admit, shall in all cases be sufficient: 'I, A. B. of swear is, to the best of my knowledge, information and belief. 3. The preceding Sections shall be construed and read as incorporated in and forming part of the said Act Fifty-seven Victoria, Chapter Four, and as if the same had originally been

inserted in the said Act, but nothing herein contained shall apply to or affect any license issued under the provisions of the said Act before the coming into force of this Act.

- 4. And whereas, in order to restrict the sale of liquor in Charlottetown, and to provide for the proper enforcement of the laws pertaining to the liquor traffic, it is desirable that a tax be imposed upon all persons engaged in the business of selling liquor:—Be it therefore enacted that every person, selling or desirous of selling liquor in the City of Charlottetown after the passing of this Act, shall register in the office of the Provincial Secretary of this Province a notice containing the full name, description and street address of such person selling or desirous of selling liquor in the said City, and a description by metes and bounds or by abuttals of the house or building in which the room or apartment where such liquor is sold or intended to be sold is situated.
- 5. Every person so applying for registration shall pay to the Provincial Secretary of this Province a registration fee of one hundred dollars. The fees so paid to the Provincial Secretary shall form a fund for the payment of an Inspector, to be appointed under the provisions of this Act, and of the expenses of enforcing this or any other Act or Acts now in force, or which may hereafter be in force in this Province, and which has or have for its or their object the restriction or regulation of the traffic in liquor.
- 6. Upon compliance by the applicant for such registration with the provisions of Sections Four and Five of this Act, as hereinbefore set forth, the Provincial Secretary shall issue to the applicant a certificate of registration, which certificate unless forfeited under the provisions of clause Eight of this Act shall be granted and remain in force for a period of six months, which said period of six months shall be calculated either from the first Tuesday in June or from the first Tuesday of December in each year, but no such certificate shall protect the person obtaining the same from prosecution or liability for any sale or sales made by him previous to the date of issue of such certificate. Any person desirous of continuing the sale of liquor after the expiration of his certificate may take out a new certificate of registration, and the application for such new certificate and the issue thereof shall be upon the same terms and subject to the same conditions and the payment of the same fee as was the application for and issue of the first certificate.
- 7. The certificate so issued shall contain the name of the person to whom issued, a description sufficient to designate the room or apartment where such liquor is intended to be sold, the date of issue, and the date from which the time of such certificate being in force shall run, and the date when it shall expire. Such certificate shall not be transferable.

- 8. Any person convicted of a violation of Section Eleven of this Act, or of any Act regulating the sale of liquor in Charlottetown now in force, shall not be entitled to receive a certificate of registration as hereinbefore provided for a period of one year from the date of such conviction, and any certificate granted to such person and in force at the time of such conviction shall thereby be forfeited and become null and void.
- 9. The said certificate shall be hung or posted upon a conspicuous place on the wall of the said room or apartment in which liquor is proposed to be sold.
- 10. Only one certificate shall be granted for any one period to any person, and that only for the sale of liquor in one place.
- 11. Any person not having a certificate of registration in accordance with the provisions of this Act, who shall sell or expose liquor for sale within the City of Charlottetown, shall, upon summary conviction thereof before the Stipendiary Magistrate of the City of Charlottetown, be liable to a penalty not exceeding two hundred dollars for each offence exclusive of costs; and in default of payment thereof, forthwith the said Magistrate shall by warrant commit the offender to the common jail of Queen's County, in said Province, for any period not exceeding six months with or without hard labour, unless the said penalty and all costs and charges and all costs of commitment and of carrying of the offender to the said jail be sooner paid.
- 12. In describing offences against Section Eleven of this Act in any information, summons, conviction, warrant or other proceeding, it shall be sufficient to state the unlawful sale, exposing for sale, disposal or delivery of liquor, simply, without stating the name or kind of such liquor, or the price thereof, or any person to whom it was sold, bartered or delivered, and it shall not be necessary to state the quantity of liquor so sold, bartered, disposed of, exposed or kept, and it shall not be necessary in any such summons or conviction, warrant or proceeding, to negative the circumstances the existence of which would make the act complained of lawful.
- 13. Summonses to persons against whom information is laid for an offence or offences against Section Eleven of this Act, and to witnesses, may be served anywhere in this Province, and a warrant against such person or against a witness, also a warrant for the arrest of a person who has been convicted under this Act, may be executed anywhere in this Province, by the Constable, Police Officer, or other Peace Officer holding the same without endorsement by a Justice of the Peace for the County in which such person or witness is found, and, upon

an arrest, such person or witness may be brought to the City of Charlottetown to be dealt with according to the requirements of such warrant.

- 14. Any Police Officer or Policeman of said City or Inspector or Inspectors appointed under the provisions of this Act may at any time enter into any room or apartment or into any house, shop, warehouse or other place wherever liquor is sold or reported to be sold, and make such searches in every part thereof, and of the premises connected therewith as he may think necessary, and it shall be the duty of any Police Officer or Policeman of the said City to report all infractions of this Act and to aid and assist the Inspectors appointed under the provisions of this Act in the execution of their duties.
- 15. All fines and penalties recovered under this Act shall be paid to the City Clerk of the said City for the purpose of enforcing this Act.
- 16. The Lieutenant-Governor in Council may, and he is hereby authorised to, appoint an Inspector or Inspectors, whose duty shall be the enforcement of the provisions of this Act. The salary of each Inspector shall be such amount not exceeding five hundred dollars per annum, as the Lieutenant-Governor in Council may appoint.
- 17. One third of the fees paid to the Provincial Treasurer, under Section Five of this Act, shall be paid by the said Provincial Treasurer to the City Clerk of the said City, on or before the thirty-first day of December in each year.
- 18. The word "Liquor," when used in this Act, shall mean and include all spirituous and malt Liquors, in any and every quantity, and all combinations of Liquors and drinks which are intoxicating; and the word "person" in this Act shall include any person, firm or corporation.
- 19. Nothing in this Act contained shall be construed to affect in any way any of the provisions of the Act passed in the Fifty-fifth year of Her present Majesty's Reign, Chapter Thirty-two, cited as "The Charlottetown Liquor Regulation Act," or any Act or Acts in amendment thereof, passed at this or any future Session of the Legislature of this Province which are not inconsistent with this Act.
- 20. This Act shall not apply to the sale of liquor by druggists.
- 21. This Act shall come into force on the first day of June next A.D. 1899.

Report upon the Despatch of the Honourable the Secretary of State for Canada of 17th July, 1899, to His Honour the Lieutenant-Governor.

The following statement would be a sufficient compliance with the requirements of said despatch: -

- 1. Foreign Companies as such are not specially taxed in the Province.
- 2. Commercial travellers as such are especially exempted from all municipal taxation.
- 3. Commercial Corporations are obliged through their agents to file a declaration giving certain details.
- 4. Commercial and other Corporations and their agents are liable to Provincial taxation.
- 5. Dealers in intoxicants and others require provincial licenses under the Quebec License Law; the rates fixed are those given in article 878 of the Revised Statutes.
- 6. These dealers are liable to pay municipal assessments also but not to exceed the figures fixed by article 927b of the Revised Statutes.
- 7. Benefit Associations and Friendly Societies, &c., incorporated outside of the Province, may be licensed when complying with certain conditions.
- 8. Insurance and Benefit Associations, &c., are liable to Government inspection, and to pay a certain sum for the expense thereof.
- 9. As to Loan and Investment Societies incorporated under the laws of the Parliament of Great Britain and Ireland, they have to receive a license from the Provincial Secretary authorising them to carry on business within the Province, under the

provisions of articles 5470 to 5476 of the Revised Statutes as amended by 62 Vic. cap. 46.

Customs Treatment of Samples in Canada.

The following particulars with regard to the treatment of samples have been extracted from the Canadian Customs Regulations:—

Section 83 of the Customs Act, c. 32 (Revised Statutes),

provides-

During the regular warehouse hours, and subject to such regulations as the Collector or other proper officer of Customs at any warehousing port sees fit to adopt, the owner of any warehoused goods may sort, pack, re-pack, or make any lawful arrangements respecting the goods warehoused, in order to the preservation or lawful disposal thereof, and may take therefrom moderate samples, without present payment of duty or entry.

Section 84 of the same Act provides—

Duties shall be payable in all cases on the quantity and value of the goods in the warehouse, as ascertained and stated on the first entry or as originally warehoused.

The subjoined special regulations have recently been issued (Government Notice No. 1496, dated June 9th, 1900) respecting the entry of commercial travellers' samples under the British Preferential Tariff:—

Dutiable commercial samples (from the United Kingdom or other British country), accompanying a commercial traveller through an intermediate country into Canada, may be entered at the Custom House under the British Preferential Tariff, upon proof by certificate or affidavit to the satisfaction of the Collector at the port of entry that the samples are bond fide the produce of the manufacture of the United Kingdom or other British country admitted to the benefits of the British Preferential Tariff in Canada.

From the Legal Adviser to His Honour the Administrator.

The law regulating licenses in Seychelles is Regulation 1 of 1880.

2. Under Section 12 every person carrying on a business, profession, trade, art, or calling, must take out a license, unless specially exempted by the Regulation.

The system which now obtains is one of half-yearly licenses, the cost of which is fixed under Schedule A of the Regulation.

- 3. Persons exempted from the obligation of taking out licenses are enumerated in Section 13. That section does not include commercial travellers or agents of firms.
- 4. Under Section 14 any business, profession, trade, art, or calling, not specially mentioned in the Regulation, can only be exercised after payment of a license-duty to be fixed by the Administrator.
- 5. In certain cases, and under certain circumstances, the Collector and Treasurer is empowered to issue licenses for a shorter period than six months (Section 18).

6. Any single unlicensed act in a licensed profession is made

punishable under Section 75.

7. So that commercial travellers and agents of British firms trading in Seychelles would therefore have to take out a license which would be regulated according to the nature of the trade, and issued either under Schedule A or under Section 14 of the Regulation.

The following is the text of Sections 12 and 14 of Regulation 1 of 1880 above referred to, and of Schedule A appended thereto:—

- 12. Every person carrying on a business, profession, trade, art, or calling, shall take out a license under this Regulation, unless such person be specially exempted by law from so doing, and every person convicted of not having complied with this provision shall be liable to a fine not exceeding five hundred rupees.
- 14. The Chief Civil Commissioner may authorise the exercise of any business, profession, trade, art, or calling, not specially mentioned in this Regulation, on payment of such license-duty and under such other conditions as the Chief Civil Commissioner may deem proper to fix. In every such case the Collector of Dues and Taxes shall issue special license for the exercise of such business, profession, trade, art, or calling, on payment of the prescribed duty.
