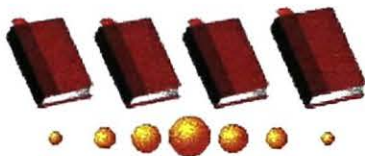

INTRODUCTION



The Gokhale Institute of Politics and Economics shares the Library of the Servants of India Society who are the trustees of the Institute. The Library was established in 1905.

The Institute has been mainly responsible for building it up during the period of last seven decades or so since 1930 when the Institute was established.

The Library today possesses more than 2,54,000 volumes in social sciences, sciences and humanities. It receives 468 current periodicals titles including almost all leading national and international periodicals in Economics and related subjects published in English language. It also possesses the back volumes of about 2000 periodical titles.

The library collection includes not only books but also other types of materials like maps, atlases and non-print materials like microfiche, microfilms, CDs etc.

MAJOR SUBJECT AREAS



1. SPECIALIZATION:

The Library specializes in all branches of Economics and other related Social Sciences like Sociology, Political Science, History, Geography, Education and so on. It also possesses materials on such disciplines as Mathematics, Statistics etc. which are useful for social science research.

2. SPECIAL HOLDINGS:

The Library possesses a rare collection of old British Parliamentary Papers of the 18th and 19th centuries, about almost unbroken series of the proceedings of legislatures in India, both Central and States; and a large collection of reports of commissions and committees appointed by the Government of India, U.K., U.S. etc. It also possesses the union budgets right from 1799 to 1805 and 1874-75 to till date, the budgets of princely and provincial states of pre-independence period and unbroken series of the budgets of state governments after the formation of states on linguistic basis. The census publications of government of India and states right from 1872, first census of India to till date, also form a very valuable part of our collection. Special holdings also include gazetteers, Maharashtra state gazettes and Gokhale papers microfilms etc.

3. DEPOSITORY AND OTHER COLLECTION:

During the time of the erstwhile League of Nations, the Library was depository library of its publications. It is at present a depository library of the United Nations, World Bank, the European Communities, The International Court of Justice and the Government Canada. It is also included in the exchange mailing lists of International Monetary Fund, the Library of Congress, the Food and Agriculture Organization and other similar international bodies. It receives United States Congressional Records in microfiche form. The Library is on free mailing lists of the Lok Sabha, the Rajya Sabha and all state Legislatures in India. The exchange relations also exist between the Institute and several universities and research institutions in India and abroad.

4. The Library also has a specialized collection of books and periodicals on the East European Socialist Economics.

5. The Library is having complete and unbroken series of volumes of quite a good number of journals in economics and related social science subjects.

5.1. FORTNIGHTLY LIST OF ARTICLES ON INDIA :

The Articles list indexes all articles on India, which have appeared in all national and international journals and newspapers received by the Library under broad subject headings viz. Economics, Education, Politics, Sociology, Science and Technology, Media, Social Sciences, History, Public Administration, Language and Literature etc. Every year, more than 100 journals are indexed for this list alongwith four financial newspapers. The Library possesses annual cumulations of this list right from 1967 onwards to till date.

5.2. FORTNIGHTLY LIST OF ADDITIONS :

The library's additions list gives information regarding the latest acquisitions of the Library under the following heads:

1 . Books
2. Government Publications
2.2. Publications of other Corporate Bodies
3. Depository Publications : (United Nations, Canada, European Countries, and its specialized agencies)

This list too is cumulated annually and the library has the annual cumulations from 1965 to till date.

A] ADMISSION TO THE LIBRARY

1. Persons wishing to make use of library should apply to the librarian in the prescribed form
2. As a general rule under-graduates are not admitted to library.
3. The librarian has full discretion in accepting or rejecting the applications.

4. The Library offers three types of membership as follows :

| 1. Annual Membership Rs. 150.00 per annum |
| 2. Casual Membership Rs. 10.00 per day |
| 3. Institutional membership Rs. 1500.00 per annum |

5. The membership fee for **foreign nationals and non-resident Indians will be five times** of that for Indians.
6. Membership should be renewed every year by paying a renewal fee according to the Readership Category allotted to a library member.
7. The library accounting year is from the 1st of April to 31st of March.

B] LIBRARY DEPOSIT

1. One book can be borrowed on borrower's ticket, against a deposit of Rs.500/-. Maximum two books can be borrowed against deposit of Rs.1000/-
2. Deposit will be refunded only after the accounting year is over, & after checking the outstanding dues, if any.
3. Borrower's tickets will have to be surrendered before applying for the refund
4. Casual members shall not have borrowing facility
5. **Deposits not claimed within three years of the expiry of membership will be forfeited**

C] RECOMMENDATION FOR MEMBERSHIP

Those who wish to become a member of the library are required to get the recommendation of any of the following mentioned designators

- I. Head of a University Department
- II. Principal or Vice-Principal of a College
- III. Employer of the applicant
- IV. A member of the Research staff of the Gokhale Institute of Politics and Economics

D] RULES FOR THE USE OF THE LIBRARY

1. Persons wishing to enter the library to access books etc. will have to sign his/her name and address in the register kept at the security gate counter for the purpose
2. The attendant at the entrance is authorized to examine everything that passes into and out of the Library. Sticks, umbrellas, bags, brief cases, over-clothes, jerkins, wind cheater etc. and books not belonging to this library, should be left with the attendant at the entrance.
3. Silence should be observed in the Library.
4. Smoking in the Library premises is prohibited
5. Cases of incivility or failure in service should be reported immediately to the librarian or his/her deputy.
6. Working Hours: **Monday to Friday 10.30 am. to 6.00 pm. & Saturday 7.30 am. to 12.00 noon.** However Ground floor & Circulation Counter will remain open from **8 a.m. to 8 p.m. from Monday to Friday & 7.30 a.m. to 3 pm. on Saturday** for annual members & staff of the Gokhale Institute. For casual Members Working Hours will be **10.30 am. to 6.00 pm. on Mondays to Fridays & 7.30 am. to 12.00 noon. on Saturdays.** The entire library building will remain open during this time.
7. Books, not more than five, may be taken out from the stacks to the reading hall, after entering the details of the same in the register at the issue counter
8. Books from each floor should be referred to on their respective floors only.
9. Before leaving the library, the reader should leave on the reading table, any books etc. taken from the stacks, for a week only, or return them at the issue counter
10. No person shall write upon, damage, or make any mark upon any book, manuscripts, map or any material belonging to the Library
11. No tracing or mechanical reproduction should be made without the express permission of the Librarian.

E] LOAN FACILITY

1. Books apart from the reference material listed below can be borrowed for the period of fortnight

I. Old and rare books

II Books of reference section

III. Reports of Committees and Commissions

IV. Dictionaries, Directories, Year Books, Encyclopaedias, Gazetteers, Census Reports, Bibliographies etc.

V. Publications of international organizations, and such other material received on depository and exchange basis

VI. Bound volumes or loose issues of periodicals, debates of legislatures, other important material, and

anything also classified as reference material.

VII. Text-books recommended for M.A. (Economics)

Course of G.I.P.E.

2. A loaned book may be re-issued for a further period of a fortnight provided :

I. The renewal application reaches the Librarian not less than three and not more than six clear days before the date on which the book is due back in the library and

II. No other reader has put a claim on the book in the meantime. No sub-lending of books borrowed from the Library is permitted.

3. All books on loan must be returned within a fortnight from the date of issue. An overdue charge of Re. 1/- per book per day will be charged on overdue books. Loan may at any time be terminated by order of the Librarian.

4. Before leaving the counter, the member shall satisfy himself/herself as to whether the book lent to him/her is in a sound condition. If the book is found defective in any respect, he/she should immediately bring the matter to the notice of the Librarian or his/her deputy. Should the book be found damaged when receiving it back, the member returning it will be held responsible for its replacement at his cost. If one book out of a set is spoiled or lost, the whole set will have to be replaced by borrower at his cost.

5. **Loss of books** : If a member loses a book borrowed from the Library, he will be liable to repay the replacement cost of the book plus a penalty of 10% of the replacement cost.

6. **Loss of Ticket** : If a member loses the borrower's ticket, a new ticket will be issued only after -one month from the date on which the application intimating the same has been received, on charging a fee of Rs.5/- per ticket.

M.A. LIBRARY RULES AND REGULATIONS



1. Overnight books will be issued only on overnight cards.
2. Overnight Cards are not transferable, others will not be allowed to use the cards.
3. Single copy titles are reserved for Hall-reading only and will not be issued for overnight
4. Question paper files or any loose material (unaccessioned material) etc. will not be issued out or given for photocopying.
5. Only the C.R. or other nominated students are allowed to take the books for outside photocopying.
6. Books for photocopying will be issued against I.D. Cards and they are to be entered in the photocopying register properly.
7. Text books will be given out for photocopying only with prior permission of the Librarian/Assistant Librarian.
8. Books for Hall-reading will be issued against the I.D. Card only.
9. No text-book will be issued on borrower's card for Hall-reading.
10. No student will be allowed to use others' I.D. Card or borrower's ticket.
11. Before leaving the Reading-hall the student should return the books at the counter and should collect their I.D. Cards.
12. I.D. Cards, Overnight Cards which are not collected from the counter shall be fined.
13. Students who are found handling circulation records shall be punished.
