Of Summary Trials

¹[236. (1) Notwithstanding anything contained in Power to try summarily.

(a) the District Magistrate,

(b) any Magistrate of the First Class specifically empowered in this behalf by Government, and

(c) any Bench of Magistrates invested with the powers of a Magistrate of the First Class and especially empowered in this behalf by Government,

may, if he or they think fit, try in a summary way all or any of the following offences.—

(a) offences not punishable with death or imprisonment for a term exceeding six months;

(b) offences relating to weights and measures under sections 240, 241 and 242 of the Cochin Penal Code;

(c) hurt, under section 303 of the same Code;

(d) theft, under section 359, 360 or 361 of the same Code, where the value of the property stolen does not exceed fifty rupees;

(e) dishonest misappropriation of property under seciton 383 of the same Code, where the value of the property misappropriated does not exceed fifty rupees;

(f) receiving or retaining stolen property under section 391 of the same Code, where the value of such property does not exceed fifty rupees;

(g) assisting in the concealment or disposal of stolen property, under section 394 of the same Code, where the value of such property does not exceed fifty rupees;

(h) mischief, under section 407 of the same Code;

(i) house-trespass, under section 428, and offences under sections 431, 433, 434, 436 and 437 of the same Code;

(j) insult with intent to provoke a breach of the peace, under section 484, and criminal intimidation, under section 486, of the same Code;

(k) abetment of any of the foregoing offences:

(1) an attempt to commit any of the foregoing offences, when such attempt is an offence;

(m) offences under section 20 of the Cochin Cattle Trespass Act, III of 1071.

(2) When in the course of a summary trial it appears to the Magistrate or Bench that the case is one which is of a character which renders it undesirable that it should be tried summarily, the Magistrate or Bench shall recall any witnesses who may have been examined and proceed to rehear the case in manner provided by this Code.

237. Government may confer on any Magistrate or Bench of Magistrates power to try summarily all or any of the following offences.—

(a) offences against the Cochin Penal Code, sections 253, 254, 255, 261, 262, 265, 266, 268, 269, 270, 303, 314, 316, 321, 332, 406, 427 and 484;

(b) offences against the Cochin Municipal Act, XVIII of 1113, the conservancy clauses of the Police Act, I of 1058, the Hackney Carriage Act, II of 1098 and offences under the Nuisances Act, IV of 1098 which are punishable with fine or with imprisonment for a term not exceeding one month with or without fine;

(c) abetment of any of the foregoing offences;

(d) an attempt to commit any of the foregoing offences, when such attempt is an offence.

Whereas it is expedient to make provision for the supply and use of electrical energy; We are pleased to enact as follows:----

Provided, that, if, at any time after the expiration of seven years from the commencement of the licence, Our Government considers that the maxima so fixed or approved as aforesaid should be altered, it shall refer the matter to an Advisory Board and, if the Board recommends any alteration, may make an order in accordance with such recommendation, which shall have effect from such date as may be mentioned therein.

33. I[(1) Subject to the provisions of sub-section (1-A), Levy of in each of the ports mentioned in the first schedule such port-dues. port-due, not exceeding the amount specified for the port in the third column of the schedule as Government direct, shall be levied on vessels entering the port and described in the second column of the schedule, but not oftener than the time fixed for the port in the fourth column of the schedule.

(1-A) The Government may, by notification in the Cochin Government Gazette, alter or add to any entry in the first schedule.]

(2) Whenever the Government declares any other port to be subject to this Act, it may, by the same or any subsequent declaration, further declare,—

(a) in the terms of any of the entires in the second column of the first schedule, the vessels which are to be chargeable with port-dues on entering the port.

Every authority exercising any powers or jurisdiction in, or relating to any port to which this Act for the time being applies, shall, if so required by an officer authorised by general or special order of the Government in this behalf, co-operate in such manner, as such officer may direct, in carrying out any manoeuvres in connection with any scheme or preparations for the defence of the said port in time of war, and for this purpose shall, if so required, temporarily place at the disposal of such officer the services of any of its staff and the use of any of its vessels, property, equipment or other material:

Provided, firstly, that if any vessels are placed at the disposal of such officer in accordance with this section, the

When a Municipal Council shall have determined subject to the provisions of section 72 to levy any tax for the first time or at a new rate, the executive authority shall forthwith publish by a notification in the Government Gazette and by beat of drum, specifying the rate at which, the date from which and the period of levy, if any, for which such tax shall be levied.

The property tax

Description and classes of property tax.

74. (1) The property tax which shall be levied at a consolidated rate on all buildings and lands within Municipal limits save those exempted by or under this Act or any other law, shall comprise a tax for general purposes and may also comprise—

(a) a water and drainage tax to provide for expenses connected with the construction, maintenance, repair, extension or improvement of water or drainage works heretobefore provided or hereafter to be provided;

(b) a lighting tax to provide for expenses connected with the lighting of the Municipality by gas or electricity;

(c) a scavenging tax to provide for expenses con-. nected with the removal of rubbish, filth or the carcasses of animals from private premises.

(2) The tax for general purposes, the water and the drainage tax, the lighting tax and the scavenging tax shall, save as otherwise provided in this Act, be levied at such percentages of the annual value of all lands or buildings or both as may be considered by the Municipal Council sufficient to provide for the expenses which the taxes are intended to meet. > The Government may pass such orders as they 113. think fit upon the budget estimates submitted to them under section 112 and such orders shall be binding on the Municipal Council. When the Government pass orders under this section, they shall have due consideration for the liabilities in respect of loans contracted by the Council. and for the maintenance of a working balance.

114. The Government shall appoint auditors of the accounts of receipts and expenditure of the Municipal Such auditors shall be deemed to be public fund.

CHAPTER VIII

Scavenging

(a) the regular sweeping and cleansing of the streets and removal of sweepings therefrom;

(b) the daily removal of filth and the carcasses of animals from private premises; and

(c) the daily removal of rubbish from dust-bins and private premises; and with this object it shall so far as the funds at its disposal admit provide—

(i) depots for the deposit of filth, rubbish and the carcasses of animals;

(*ii*) covered vehicles or vessels for the removal of filth;

(iii) vehicles or other suitable means for the removal of the carcasses of large animals and rubbish; and

(iv) dust-bins for the temporary deposit of rubbish.

7. The Karanavan shall maintain a true and correct inventory of all the movable and immovable properties belonging to the illom. The original or an attested copy of the inventory shall be available for inspection by the major anandaravans once in a year throughout the month of Kanni, and any such anandaravan may take copies of or extracts from such inventory.

8. The Karanavan shall be entitled at the end of the year to appropriate for himself besides his maintenance an amount not exceeding 25 per cent but subject to a maximum of Rs. 900 out of the illom income which remains after meeting all the illom expenses including interest on illom debts.

9. Except with the written consent of the majority of all the major members of the illom, no Karanavan shall sell, ¹[lease, mortgage or pledge illom property, movable or immovable,] or grant renewals of kanam for a period of more than twelve years or give discharges of mortgages or pledges:

(2) A motor vehicle already registered under any enactment in force in Cochin State at the commencement of this Act shall be deemed to be registered under this Act '[until such date as Government may by notification in the Cochin Government Gazette, specify in this behalf] and on the application of the owner before that date shall be registered under this Act without payment of any registration fee.

(3) Government may, by rules made under section 38, provide that within a préscribed period certificates of registration of any prescribed class of transport vehicles deemed to be registered under this Act by virtue of subsection (2) shall be presented to a prescribed authority for the entry therein of all or any of the particulars specified in section 35.

The profits and gains of any business of insurance other than life insurance shall be taken to be the balance of the profits disclosed by the annual accounts, after adjusting such balance so as to exclude from it any expenditure other than expenditure which may under the provisions cf section 13 of this Act be allowed for in computing the profits and gains of a business. Profits and losses on the realisation of investments, and depreciation and appreciation of the value of investments shall be dealt with as provided in rule 3 for the business of life insurance.

7. The profits and gains of companies carrying on dividing society or assessment business shall be taken to be 15 per cent of the premium income of the previous year, or in the case of non-resident companies 15 per cent of the Cochin premium income of the previous year.

8. The profits and gains of the Cochin branches of an insurance company not resident in Cochin, in the absence of more reliable data, may be deemed to be the proportion of the total world income of the company corresponding to the proportion which its Cochin premium income bears to its total premium income. For the purpose of this rule the total world income of life insurance companies not resident in Cochin whose profits are periodically ascertained by actuarial valuation shall be computed in the manner laid down in these rules for the computation of the profits and gains of life insurance business carried on in Cochin.

9. These rules apply to the assessment of the profits of any business of insurance carried on by a mutual insurance association.

CHAPTER II

Establishment and Constitution of Village Courts
