THE COLLECTOR OF POONA.

Poona, 26th September 1898.

SIR,

I have the honour to submit, through you, for the consideration of Government, proposals for the original settlement of the village named in the margin of the Khed Taluka of your Collectorate.

- 2. This is one of the Vinchurkar's Jahágir villages which lapsed to Government in the year 1892 in the circumstances explained in Government Resolution No. 2629, dated 20th April 1892. It was measured in the year 1893-94 and classed in 1895-96 under orders from the Survey Commissioner.
- 3. The result of the survey operations is given below under the different heads of land:—

4. Rása is situated in the southern portion of the táluka and is almost surrounded by Government villages of the 1st group with a maximum dry-crop rate of Rs. 2-8-0.

These villages are described in paragraph 43, page 13, of the Report on Khed included in Government Selection No. CCXXV.

Immediately south of Rása are two alienated villages, namely, Kelgaon and Alandi, which have also on revision in 1889 been rated at Rs. 2-8-0 in respect to dry-crop land.

5. The factors taken into consideration at the revision settlement of the adjacent villages of the 1st group of this taluka are fully noticed in the Report already alluded to in Government Selection No. CCXXV, and all that appears necessary now is to see whether the condition of Rasa differs in any material respect from that of the neighbouring villages.

From the situation of the village and the returns furnished, I think, it can fairly be held that its circumstances are in every way favourable, and I, therefore, propose to include it in the 1st group with a maximum dry-crop rate of Rs. 2-8-0 and a Patasthal garden land rate of Rs. 10. There is no rice land in this village.

6. The estimated result of the proposed rates is given below for easy reference:—

- 7. The revenue collected under the Mámul system was Rs. 1,510, while according to the survey system it works out to Rs. 1,386, which gives a total difference of Rs. 124, equivalent to a reduction of 8.2 per cent. The Mámul assessment includes other items than the revenue on occupied land paying assessment to the Jahágirdar. Rs. 35 per khandi, or Rs. 1-12-0 per maund of the produce, were exacted from the cultivator in the case of good soil, and Rs. 26-4-0 and Rs. 1-5-0 per khandi and maund, respectively, in the case of Mál land, and it is hardly necessary to make any comment on this practice, or to compare it with the survey system of field by field classification.
- 8. I have no hesitation in recommending that the proposed rates should be sanctioned and guaranteed to expire concurrently with those of the other villages of the taluka in the year 1918-19.
- 9. The usual appendices accompany this report. A settlement map has not been prepared, as the situation of Rása can easily be seen on the map attached to Government Selection No. CCXXV.

2. It will be seen from paragraph 4, clause 3, of Mr. McIver's further report (No. 361 of 1898) in these papers that the Kamúl land revenue proper of the village is Rs. 1,417 and not Rs. 1,510. The proposed survey assessment on occupied lands amounts to Rs. 1,386, i.e., short of the Mámul revenue by Rs. 31 only. The rates proposed are those already sanctioned by Government for neighbouring villages and have the approval of the Deputy Superintendent and the Collector of the District. The undersigned, therefore, trusts that the proposals will meet with the approval of Government.

2. The undersigned regrets that there has been considerable delay in replying to the reference from the Survey Commissioner.

- 3. The papers furnished for the purposes of the report contained no explanation of the miscellaneous items shown as levied by the Jahágirdár and the reasons for the remissions noted in columns 5 and 6 of Appendix Q.
- 4. On reference to the Mámlatdár of Khed he reports that owing to the death of the permanent Kulkarni of Rása he has found it difficult to procure a complete and reliable explanation on the points in question, but from enquiries of the people and on reference to the local records he has submitted the following remarks:—
  - (1) The system of assessment is to levy a rate per each khandi of produce. The fixed "Kamál Akár" shown in the returns is excessive and can never be collected in full from the cultivators; a fixed lump sum is, therefore, demanded from each registered occupant on the whole of his land. The "Kamál" thus collected in 1895-96 fell short by Rs. 114 of the fixed "Kamál Akár." This is the remission referred to in column 5 of Appendix Q.
  - (2) The amount shown in column 6 of the Appendix is the total of the yearly remission of from 4 to 6 annas granted to each cultivator after inspection of the crop grown in the field has indicated that the crop is deticient on account of failure in the rainfall, ravages of insects, or other causes which affect the out-turn.
  - (3) The actual collections amounting to Rs. 1,510 are composed of the following items:—

12 12 0 Collected by Inamdar as "Kharedi Kasar" (which appears to be a tax on the grain sold or purchased.

79 0 10 Remuneration of Kulkarnis collected proportionately from each registered occupant.

O 12 O Land estimated to yield 10 maunds of produce was set apart as "Kuran Liláváchi Jamin, or land the grass on which is sold by auction. Instead, however, of putting up the right to the grass to auction, a fee of 12 annas, which is cultivated at the rate of Rs. 1.8-0 per khandi, is taken from the cultivators and credited to the Jahágirdár.

The total of these items amounts to Rs. 1,509-8-10, but in order to avoid fractions of a rupee the odd sum of 8 annas and 10 pies is shown in the returns as one rupee, and thus the grand total of Rs. 1,510 is arrived at.
