## PREAMBLE.

### Sections.

1. Short title, extent and commencement.

- (2) Appeal against order of Amildar or Deputy Amildar or holder exercising the powers of Amildar or Deputy Amildar.
18. Disposal of appeal by officer who passed original order.
19. Power to call for and examine the records and proceedings of subordinate officers and to refer questions to the Chief Court.
20. Dismissal of suits, etc., instituted, etc., after the period of limitation.  
 Limitation in case of suits the cause of action for which accrued before the commencement of this Regulation.
21. Application of certain sections of the Limitation Act.
22. (1) Government may make rules on certain subjects.  
 (2) Until such rules are made, existing rules to be in force.
