Whereas, I Bhalchandra Trimbak Talim, the Arbitrator appointed under Government Notification, Local Self-Government and Public Health Department, No. TPM-3754, dated 11th January 1955, in respect of the above scheme, having done all that is required by me in that behalf under sub-section (1) of section 32 of the Bombay Town Planning Act, 1954, and rules thereunder; and whereas the Board of Appeal having met as provided under the Act, have given their decision in all matters arising out of clauses (v), (vi), (viii), (ix), (x) and (xiii) of sub-section (1) of section 32 of the said Act, I hereby draw up the Final Scheme as required under clause (xiv) of sub-section (1) of section 32 read with sub-section (2) of section 43 of the said Act and thereto affix my hand and seal.
