PLAN FOR EDUCATION IN ORISSA

Summary of recommendations on Planning of Schools for all Categories in Orissa State

So far there has been no well-regulated plan for determination of number and types of schools, number of qualified teachers and location of the institutions at proper places in different districts. The result is general lack of qualified teachers, accommodation and equipment and all-round deterioration in the standard of education, mushroom growth of schools and sudden increase in the number of scholars. To prevent such a state of affairs, an attempt has been made to prepare a plan and to spread the expansion of education over a period during which implementation will be possible within the financial resources of the State. Estimates are based on the Census figures of 1951 as well as established principles gained through experience and laid down by eminent educationists. In order that the estimates are precise and workable, an educational survey on the spot may follow, as some variations may occur in the plan based on Census figures and on actual survey. It is therefore recommended that a sample survey of selected areas, both urban and rural, may be undertaken.

The estimates have been prepared on the following among other considerations :---

(1) The Government must undertake the responsibility of providing at least Primary (Junior Basic) Education for all school going children of age group 6-11.

The number of such children is estimated to be 18,01,446. The Statement I total number of Primary or Junior Basic schools for them will be 25,873 of which 13.884 will be 3 grade schools and 11,989, 5 grade schools as against 9,614 L. P., 1,056 U. P. and 555 Sevasrams, i.e., as against 11,225 Primary Schools. They have been distributed districtwise (a statement is enclosed). But in the main report and the plan optials for each police-station have been worked out.

The total number of teachers will be 59,963 (47,974 non-matric Statement II and 11,989 matric trained teachers) as against 18,917 (8,312 trained and 10,605 untrained) teachers. The total number has been calculated districtwise (a statement is enclosed).

The ultimate cost on Primary Education when the scheme of universal, free and compulsory Primary Education comes into operation will be Rs. 4,58,60,180 but minus present expenditure the figure will stand at Rs. 3,93,76,887. This estimate is exclusive of recurring expenditure on inspection and supervision, training of teachers, scholarships and non-recurring expenditure on furniture and other grants. Subsidy for construction of building has been included at varying scales ranging from Rs. 80 to Rs. 750 according to the type of the schools. The current expenditure will be Rs. 2,58,68,267, i.e., Rs. 3,21,50,540 minus Rs. 62,82,273 (present expenditure).

This is based on the pupil-teacher ratio 30:1 and the proposed uniform scales of pay for non-matric and matric trained teachers-scales being Rs. 35-50 for non-matric and Rs. 50-90 with a starting pay of Rs. 60 for matric-trained teachers. For a five grade Primary school, there will be one trained matriculate teacher and others will be trained non-matriculate teachers. For a three grade Primary school all teachers will be non-matriculate trained teachers.

(2) It should aim at introducing universal, free and compulsory Primary (Basic) Education for the children of 6—11 age group within a period of twenty years but if finances improve at a later stage, the scheme may be spread over a lesser period but in no circumstances it should be given up. This period may be divided into four units of five years each. The first five-year may be devoted to bringing the educationally backward districts at par with other districts as far as possible and the next three five-year units for gradual improvement of education throughout the entire State. As the entire planning has been drawn up on the basis of population, it would be necessary to review the position after implementation of the first five-year programme with a view to see how far the programme of work should have to be modified in relation to local demand, increase of population during the past five-year period and such other factors as would be relevant to the issue.

(3) The duration of the period of the system of school classes should be as under----

(i) Primary or Junior Basic Schools, Standards I to V-5 years,

(ii) Middle or Senior Basic Schools, Standards VI to VIII-3 years; and

(iii) High or Post-Basic Schools, Standards IX to XI-3 years

(4) In urban areas where the conditions permit, the same school buildings may be utilised for two shifts.

(5) The basic minimum salary of a trained teacher as shown in the uniform scales of pay should not be reduced.

(6) Single teacher schools should be avoided as far as possible.

Primary Education has not thrived well under the local bodies nor could such a vast responsibility be successfully shouldered by any agency other than the State. With the Anchal Sasans coming into being, it may be necessary to empower them to maintain and manage the schools and to shoulder the financial responsibility. Inspection, supervision and syllabi should be left in the hands of the Educational authorities.

SECONDARY EDUCATION

The number of Middle (Senior Basic) and High (Post-Basic) schools required for children of age groups 11-14 and 14-17 will be 2,684 and 454 respectively as against 598 and 207 including 31 Asram schools. Statement drawn up districtwise is enclosed. 20 per cent of the children of age group 6-11 will come in the first five-year period to Middle schools and 20 per cent of the children in the Middle schools will likely come to High Schools in rural areas. The position is, however, different in schools situated in urban areas where 40 per cent of children of age group 6-11 is likely to come to Middle Schools and 90 per cent of the children in the Middle Schools to High Schools. Estimates are based on the figures mentioned above. The ultimate cost on Secondary Education after universal, free and compulsory Primary Education comes into full operation is Rs. 4,06,61,102 but minus present expenditure the cost will stand at Rs. 3,43,78,829. In this estimate twenty posts of headmasters in the scale of Rs. 200-700 have been provided. The rest is in the uniform scale of pay of Rs. 175-350 for headmasters of High Schools. This estimate is exclusive of recurring expenditure on supervision, training of teachers, scholarships and inspection and non-recurring expenditure for building, furniture and other grants.

The cost will be different if all the schools are converted into aided schools. At the present rate, i.e., two-thirds of the total cost of aided schools, the ultimate cost will come up to Rs. 2,71,07,402 but minus present expenditure it will stand at Rs. 2,08,25,129.

The ultimate cost of expenditure on Secondary Education, if the Government schools or schools managed by Government are allowed to continue and the rest are aided will amount to Rs. 2,16,23,643 after deduction of the present expenditure.

Estimate of cost on Secondary Schools has been prepared with a view to avoiding duplication of classes in High schools but as a matter of fact duplication of classes will be inevitable in urban areas. Calculating on that basis, i. e., allowing duplication of all classes in schools existing in urban areas, it is found that in case of 39 towns and a few subdivisional headquarters included among rural areas 58 schools will have their classes duplicated thus reducing the total number of High Schools in the State to 396 and at least 4 Middle Schools will have to be amalgamated with 4 High Schools. This step will reduce expenditure both on current and ultimate side by $6\frac{1}{2}$ and $8\frac{1}{4}$ lakhs of rupees respectively.

The estimates are based on-

(1) Uniform scales of pay for teachers in all types of schools managed by Government, local bodies, etc., which was unknown before.

(2) Scales of pay have been upgraded

(3) Standard staff has been strengthened by inclusion of more trained Graduates, craft teachers and teachers possessing Sahityacharya qualification.

INSPECTORATE

⁴ The existing number of inspecting officers—Sub-Inspectors of Schools and Assistant Sub-Inspectors of Schools for inspection of Primary schools-is 185, i.e., 111 Sub-Inspectors of Schools and 74 Assistant Sub-Inspectors of Schools. The inspecting staff at the present moment appears to be unsatisfactory, due mainly to inadequacy of qualified personnel and consequent lack of effective supervision and regular inspection. The Assistant Sub Inspectors of Schools who are recruited from among the teachers of Primary schools have not proved as successful as was expected. With the introduction of universal, free and compulsory Primary (Basic) Education, attendance will have to be rigorously enforced. In the present financial position of the State, it may not be possible to appoint separate Attendance Officers. If at a later stage it is found that inspection suffers because of work of enforcement of attendance by the Inspecting staff, the question of having one set of inspecting officers for inspection and supervision and another set of officers for enforcing attendance may be considered. The number of Primary schools to be assigned to each officer may be less or more according to the nature of the area (plains or agency) and the present number should in any case be reduced according as the or finances permit. The Sub-Inspectors of Schools circumstances and Assistant Sub-Inspectors of Schools should be designated as Sub-Inspectors of Schools-cum-Attendance Officers and the Assistant Sub-Inspectors of Schools as Assistant Sub-Inspectors of Schools-cum-Attendance Officers. Even this recommendation is made with reluctance as I am convinced that no other course will be practicable in the present circumstances. With the increase of Primary (Basic) schools, the number of inspecting officers will be progressively increased. Ι understand Government have decided to open 1,200 one-teacher Primary schools and appoint 24 Sub-Inspectors of Schools this year, that is to say, for 50 schools there will be one Sub-Inspector of Schools. The co-operation of local educationists and educational workers may be sought for supplementing the work of inspection.

The number of inspecting officers for the proposed number of Primary schools numbering 25,873 in the whole State will now stand at 750, i.e., 250 trained graduates and 500 trained matriculates for the posts of Sub-Inspectors and Assistant Sub-Inspectors of Schools respectively.

The ultimate cost on this head will be Rs. 17,84,450 (recurring) and Rs. 75,000 (non-recurring).

TRAINING OF TEACHERS

Any scheme of Education, however flawless and ideally perfect, will hardly flourish unless it is worked out by a well-educated, trained and contented body of teachers. At present teachers are generally speaking insufficiently educated, untrained and very inadequately paid. Such teachers are not expected to make any scheme of Primary or

Secondary Education successful. Teachers should have a good general education and be trained. They should also be suitably remunerated. It is proposed to introduce uniform scales of pay within the financial resources of the State which may attract persons of the right type and correct attitude. There has been a general policy towards the conversion of existing Primary schools into Basic schools. Such conversion is bound to be a long-term process. The implementation of the programme will depend on availability of suitable trained teachers. Our State has tried to expand facilities for training and the number of trained teachers has in fact increased. The expansion is, however, not equal to the number in the new schools and the enrolment of pupils. Wherever new training schools are going to be started, they should be of the basic type. Even the old type of training schools should be given basic bias with a view to permit introduction of crafts into the Primary schools. The first three or four years of basic schools are preparatory and not so productive and the last four years are more valuable and may pay their way. Necessary facilities, such as land, water and fencing should be provided. One of the main difficulties in transforming ordinary Primary schools into basic schools has been the difficulty of making the ordinary Primary school teacher take to basic methods. This should be overcome by giving them a short course of intensive training in basic bias, ideology of basic education and craft in the atmosphere of basic training institutions.

An estimate of cost and the number of trained teachers and institutions is indicated below :---

If the scheme is spread over 20 years, two years are required for initial arrangements. So a period of 18 years is left for production of trained teachers.

Annual output is to be $4,406 \div 18 = 245$

This can be had from the two Training Colleges by raising the numbers of seats to 120 each. One college is now in existence and another is going to be opened shortly at Angul.

The ultimate cost of expenditure on the number of training schools to be opened is Rs. 28,18,341.

The financial implications involved in the scheme will go to show that the cost of education like that of other essential services will ultimately fall on current revenues and that this is not possible unless the taxable capacity of the State is increased many times. It may be possible to reduce the liabilities substantially or avoid the liabilities if all Primary and Middle Schools be converted into Basic Schools and new Basic Schools are started where there is none at the moment.

In order to determine the actual number of schools and scholars for the age-groups 6-11, 11-14 and 14-17 and the number of teachers of requisite qualifications competent to teach the children, the following procedure has been adopted. The Census figures of 1951 policestation-wise have been assumed to be the basis. Each district is a unit of calculation and has been divided into police-stations. All police-stations under a subdivision have been grouped together and similarly all subdivisions under a district. Figures in respect of each district have been tabulated and shown under a table in order that one can conveniently find out at a glance different figures under different age ranges. First of all children of 3 different age groups who are available in the total population for education in the Primary, Middle and High stages have been obtained, the required percentage having been indicated on each page of the tables, no matter whether all children of the age groups would be brought under schooling or not. It is presumed that, universal, free and compulsory Primary (Basic) education should be provided for all children of school-going age of 6-11. There are 48,398 inhabited villages and 39 towns including a city and it is not physically, economically and financially possible to equip each village with a Primary or Basic school.

It has already been said that in order to assess the actual educational needs of the people and the different areas of the State, an Educational Survey is necessary. In absence of such a survey for calculation of exact figures village-wise, a sample survey from the Census figures of 1951 has been made, taking one police-station from

each of the districts shown on the margin and an attempt has been made to calculate the exact figures in respect of different types of schools of 3 and 5 grades to be opened village-wise. The total number of schools of each category, viz., 1 teacher, 2 teacher or 3 teacher schools each of 3 grades and 5 teacher schools of 5 grades being thus found out, relative proportion of these schools have been computed with a view to determining the proportion of 3 grade to 5 grade schools and the actual number of teachers required in each case.

Following figures for a group of 55,000 children of school-going age give the calculated result in a tabular form :---

Hence for a group of 55,000 school-going children the proportion of 3 grade to 5 grade schools is roughly 423: 367 and that of the number of teachers is 590: 1,245.

Of the 1,245 teachers in the 5 grade schools 367 are to be trained matriculates and 878 non-matric trained teachers. The proportion of trained non-matriculates to trained matriculate teachers in this group is 1,468 : 367.

Number of 3 or 5 Grade schools necessary for the different districts of the State calculated have been computed police-station-wise in the light of the said figures as exemplified below :

In all calculations figures below •5 have been neglected and the next higher number has been taken where the fractional portion has exceeded •5.

MIDDLE SCHOOLS (SENIOR BASIC) SCHOOLS

The number of Middle Schools (Senior Basic) have been calculated police-station-wise on the basis of 120 students per school and the surplus figures of each police-station have been adjusted in the bordering ones in calculating the number of such schools. But where the surplus figure is 5 per cent or less, it has been ignored for the purpose of calculation.

HIGH SCHOOLS (POST-BASIC) SCHOOLS

The number of High Schools has also been calculated police-station-wise on the basis of 240 students per school. Where only 120 students are available for High School education, establishment of one three class High School would have been possible. But on financial and educational grounds it is safer to amalgamate the three class High School with one of the nearest Middle Schools to make it a High School of six classes. Duplication of classes in High Schools has been avoided as far as possible on grounds of fair geographical distribution and convenience of pupils. In some areas the number of High Schools which have already been established is in excess of the requirement of that area. Pupils have been admitted to such schools from neighbouring areas where schools do not exist at the moment. But when schools will be distributed on a planned basis, it may be necessary to rearrange the High Schools according to the plan. In urban areas, however, as the number of schools calculated to be established appears to be more conspicuous, it would curtail number of such schools and reduce expenditure to a considerable extent if classes are allowed to be duplicated in deserving cases. This fact has been taken into account in determining the number of High schools in urban areas.

An attempt is being made to prepare 13 District Maps showing the location of the existing number of Primary, Basic, Middle and High Schools by means of numerical figures and symbols with other particulars. To each map is attached a list of names of Primary, Basic, Sevashrams, Ashram Schools, Middle Schools and High Schools which are now in existence.

Since art and craft will figure prominently in the reoriented courses of studies for Middle and High Schools, provision for appointment of art-cum-craft teachers, whole-time craft teachers, craft materials and equipments and facilities for land, water and fencing has been made. Since Middle Schools (Senior Basic) and High Schools (Post-Basic) are going to be integrated with Agricultural farms, forest institutes, public health centres, pisciculture centres and industrial schools and institutes now in existence in the whole of Orissa State, reoriented syllabuses to suit the requirements of High Schools having diversified courses of studies are under preparation.

The total expenditure on education at the Primary and Secondary stages has been calculated for the whole twenty-year period programme. But in order to give an idea as regards the annual expenditure involved an estimate has separately been-prepared and is enclosed. The recurring portion of the annual expenditure as shown in the statement will increase progressively, as the institutions opened year by year will have to be continued.

BUILDING AND NON-RECURRING GRANTS

As the total number of Primary, Middle and High Schools is 25,873, 2,684 and 454 respectively in the whole State, it is not

financially possible for Government to pay a substantial grant for construction of buildings to each and every individual school. So far as Primary schools are concerned, it should be the responsibility of the villagers and people living in towns to construct buildings and undertake annual repairs. The State can at best grant a subsidy varying from Rs. 80 to 750 in the case of one teacher, two teacher and three teacher three grade schools and three teacher and five teacher five grade schools respectively. The subsidy at sliding scale has therefore been included in the standard cost of each school.

But so far as Middle and High Schools are concerned, Government generally give grant at the rate of half of the cost if the management applies with a plan and estimate to be approved by the department and is willing to pay the other half. This principle lands the State Government in financial difficulties and should be replaced. It should be the policy of Government to give a grant to a Secondary School not exceeding half of the cost. The type and design of the school building and the total cost must be fixed by Government in consultation with Works Department. The cheaper the building, the better for the poor State of Orissa. No amount has been included under building and any other non-recurring grant in the present estimate. If and when the policy of Government is decided, the estimate will be prepared and added on to the total cost on non-recurring side or annual non-recurring cost.

An estimate of annual expenditure on Training Institutions for production of teachers

Of the eight Secondary and seven Basic Training Schools, it is proposed to open two Secondary and one Basic Training School in the first year and one Secondary and two Basic Training Schools in the second year alternately. At this rate it will be possible to complete opening of the full number of Secondary and Basic Training Schools in course of five years. The thirty-five Elementary Basic Training Schools should have to be opened in course of five years at 7 per annum. It is essential that the training institutions should be opened as early as possible in order to reach the target number of trained teachers required per annum in course of the first five-year limit.

The annual target of production of teachers will thus be reached in the 5th year after which the annual requirement is likely to be met fully. Hence during the first 5 years demand of trained teachers will be met only partially and untrained teachers will have to be appointed and they will be given opportunities to get themselves trained in due course.
