FOURTH PLAN—PLANNING GROUP ON MACHINERY INDUSTRIES—WORKING GROUP ON MINING AND DRILLING EQUIPMENT

Pursuant to the decision taken by the Planning Group for Machinery Industries, the Working Group for Mining and Drilling Equipment was formed to report on the equipment required for Mining, drilling and other equipment for coal, mineral ore and oil industries including beneficiation of ores and coal preparation and washing. The Working Group comprised of—

2. The general terms of reference of this Working Group were:---

- (i) To make an estimate of the requirements of equipment falling within the scope of the Working Group, having regard to the production programmes and investment in the Sectors requiring such equipment envisaged during the Fourth and Fifth Plans, in so far as they are relevant to the establishment of capacity for the manufacture of such equipment during the Fourth Plan. In making this estimate, the requirements of replacements and possibility of exports should be taken into account.
- (ii) To make an analysis of these requirements, in terms of category of equipment and value.
- (iii) To work out in detail the requirements of each category of equipment, by type and by range, during each of the years of the Fourth Plan.
- (iv) To recommend the capacity and production targets for 1970-71, for each category of equipment by type and by range, to the extent indigenous manufacture is considered feasible and desirable.
- (v) To make an assessment of the production capacity of existing and projected manufacturing facilities and to work out the gaps for each category of equipment.
- (vi) To investigate the best manner in which the gaps could be covered to the extent feasible and desirable by the end of the Fourth Plan; and to make specific proposals to this end, by way of expansion or new projects etc.
- (vii) To make an estimate of the investment and foreign exchange on capital and maintenance account required for implementing the production programmes as recommended.
- (viif) To make an estimate of power, fuel, transport, and other requirements of a significant order.

- (ix) To make an estimate of raw materials, components, etc. required for the manufacture of such equipment and to suggest measures for the indigenous manufacture of such items.
- (x) To recommend measures by which utilization of manufacturing capacity and programmes of production in the consuming sectors are co-ordinated to the fullest extent.
- (xi) To make such other recommendations as may be relevant.

3. The Working Group considered the various aspects of this problem and met on number of occasions between October 1963 to November, 1964. The Report of the Working Group is enclosed for the consideration of the Planning Group for Machinery Industries and the Department of Heavy Engincering.

REPORT ON COAL MINING AND DRILLING EQUIPMENT

Coal Target

At the time of submitting the interim report, the Working Group on Mining and Drilling Equipment did not have available with it reliable estimates of production targets of coal as those were under examination. Estimates of production target for the Third and of the Fourth Plan have now been made available by the Coal Controller along with the break-up of production between N.C.D.C., Singreni and private sector colleries. A break-up, according to the method of mining and secondly within the underground mining by development and depillering have also been given. These details are attached in Annexure I. Briefly, these details for the end of the Third and Fourth Plans are given and summarised below:—

The Working Group was given to understand that the target of production according to present indication may not exceed 130 to 140 million tonnes by the end of the Fourth Plan. As it takes a very long time to develop mining capacity it was felt that to achieve this production a substantially larger capacity would be required and for the purpose of planning machinery requirements it was decided that capacity should be created for 150 million tonnes of production of coal by the end of the Fourth Plan. For a perspective of the requirement, it was assumed that by 1975-76 the demand for coal may be of the order of 200 million tonnes. Subsequently information has been made available that the target of production for 1970-71 has been further reduced to 136.00 million tonnes.

Its break-up between N.C.D.C., Singreui and private sector as well as between opencast and underground (separately for development and depillering) is stated below:-

Since this would not affect materially the capacity target of 150 million tonnes by 1970-71 assumed by the Working Group and since the requirements of machinery and investments would be related to capacity the Working Group has retained the figures of the requirement of machinery ctc. worked on the basis indicated earlier. However, if there is any further significant reduction in coal target the requirement of machinery would further go down.

Output per Man Shift

The Coal Controller has furnished the average output per man shift (OMS) in the coal industry in our country. This is given below:

It will be seen that an average rate of increase in the OMS for 1951 to 1961 was at the level of about 0.013 tonne per year. It is now intended to be stepped up to 0.03 tonne per annum

during the 4 years from 1962-1966 and further increased to 0.04 tonne per annum thereafter till the end of the Fourth Plan. The increase in OMS is intended to be achieved by (a) greater mechanisation, and (b) to some extent also by improving on the performance of existing plant and machinery. The increased OMS of 0.80 tonne envisaged in 1971 is still low compared to countries like U.K., West Germany, Poland, France who have achieved an OMS of 1.84, 2.00, 1.54 and 1.34 tonnes respectively. The Working Group felt that it would be desirable to attempt a better OMS than envisaged above particularly since the mining conditions in our country as pointed out by CMA are stated to be more favourable and that it would be difficult to offset the rising cost of labour and material without resorting to greater mechanisation. It was considered that even from the point of view of the hazards to which mining labour is subjected it would be desirable to reduce it to the minimum. However, taking into account the limiting factors that (a) introduction of a more quickened pace of mechanisation may not be absorbed particularly in the existing mines in the private sector which would be responsible for over 50% of the output from underground mining even at the end of the Fourth Plan, (b) any large scale retrenchment of labour has to be avoided, and (c) the resources required for greater mechanisation would be too high it was felt that OMS as suggested by the Coal Controller would be practicable and may be accepted for the purpose of planning during the Fourth Plan. It would be seen from the later discussions that there would be an excess of capacity for underground coal mining machinery over its requirement by 1970-71. To the extent the industry can afford greater mechanisation for improvement of OMS, plant and machinery from indigenous sources would be available to it.

The trend in the use of machinery in coal mines would be apparent from the following table:—

It is apparent from the above that our progress towards mechanisation has been slow and the number of various items of machinery in use at the end of the Third Plan would be much smaller than what was envisaged earlier. This has been taken into consideration for assessing the replacement demand. The details of demand as worked out by the Coal Controller on the basis of the above assumptions with a break-up between NCDC, Singareni and Private Sector and between original demand and replacement demand have been shown.

These are summarised in the following pages. The estimated total machinery required in 1970-71 for underground coal mining including replacement requirements adds up to 31,000 tonnes. Excluding electrical items namely transformers, clectric motors, switch gear and gate-end boxes the demand was placed at around 30,000 tonnes.

The Working Group felt that estimating the requirements of machinery on the basis of 1000 tonnes for every million tonne of coal currently in production could not be relied upon and would lead to an unrealistic assessment of machinery requirements.

The table below gives an estimate of coal mining machinery required per million tonne of coal from fully mechanised mining based on the project reports recently furnished by forcign experts. This is on the basis of fully mechanised mining.

On the basis of the above estimates also the Working[•] Group came to the conclusion that for stepping the production at the rate of about 8 to 10 million (the rate of development of underground coal mining during the Fourth and Fifth Plan periods) tonnes per annum during the Fourth Plan, the additional demand will be of the order of 30,000 to 32,000 tonnes of machinery per annum.

(ii) Capacity in the Private Sector

In addition, certain capacities have been licensed in the Private Sector as indicated in Annexure III. It is understood that satisfactory progress is being achieved in most of the cases and a capacity of about 8,000 tonnes on conservative estimates would be available by 1970-71.

(iii) Total Capacity

The combined capacity of CMMP, Durgapur and private sector would thus be over 50,000 tonnes per annum by 1970-71 against an early requirement of about 30,000 tonnes of underground coal mining machinery.

No need for establishing further capacity

The Working Group, therefore, came to the conclusion that in view of the reduced target of coal production there would be no need for establishing further capacity for underground coal mining equipment for meeting their demand during the Fourth Plan and early Fifth Plan. On the other hand, it would be essential for the CMMP, Durgapur, to examine what further items of machinery particularly as part of the mining equipment for minerals other than coal can be taken up by it and necessary adjustment in the production pattern carried out. The Working Group has noted that out of a capacity of 45,000 tonnes, 7,000 tonnes is expected to be utilised for the manufacture of coal washery equipment. It should be possible to step up the production of conveyors and perhaps also take up some items of screening equipment. Further, in view of a cushion in the capacity of the plant it may be desirable that they proceed with their proposal to produce some of the items of electrical equipment such as flame proof electrical motors of integral and smaller types and gate-end boxes based on their existing casting and machining facilities.

Other items needed for underground coal mining as considered by the Working Group are indicated below:—

Electrical items

Electric Motors, Transformers, Switch Gear and Gate-End Boxes.

The above requirements of electric motors are in Nos. and weight as furnished by the Coal Controller. It would be helpful if the requirements of electric motors in KW as given by the CMMP, Durgapur are also indicated. Their requirement corresponding to a full rated capacity of 45,000 tonnes would be for flame proof motors aggregating an output of 80,200 KW of which 18,000 KW is for motors of above 100 KW and 62,200 KW for motors of 100 KW and below. Of 62,200 KW integral types would constitute 18,550 KW.

It would be essential that capacity and suitable designs for flame proof motors, gate-end boxes and mining type transformers will have to be developed keeping pace with their demand by CMMP, Durgapur and other producers of mining equipment.

Mills and Accessories

Compressors and Rock Drills

(a) Compressors.—It was noted that the requirements will be met by the private sector units as 13 firms have been licensed to manufacture a total of about 7,500 Nos. per year for capacity up to 1000 cft. per minute. For compressors of higher capacity the demand will have to be met either by diversified production or some of the licensed units in private sector or by the proposed public sector plant for heavy pumps and compressors.

(b) Rock Drills.—The requirements of rock drills for underground coal mining are indicated as 462. Taking into account some additional requirements for opencast mining and for other minerals the requirement was estimates at less than 600. The following capacity for rock drills has been licensed which inter alia is likely to meet the above requirements also:

It would be reasonable to envisage that by 1970-71 these units would have marginally expanded their capacity and that the requirements of electric coal drills can be met by the above units. With regard to drill panels further capacity would need to be created.

Opencast Coal Mining Machinery

The assessment of coal to be raised from opencast mining at the end of the Third Plan and at the end of the Fourth Plan is indicated on page 1 and the increase in output amounts to 9.25 million tonnes during the Fourth Plan period. The requirements of machinery for meeting these requirements are indicated on the next page. The equipment is mainly earthmoving machinery.

Some of the items such as compressors and drills have been discussed earlier along with underground coal mining machinery. It is understood that adequate capacity would be in existence to meet the requirements of such items as road rollers, low bed trailers, jeeps, pick-ups, 5 tonne trucks and pumps. The capacity licensed for earthmoving equipment in private sector is already given in Annexure II. One unit has been licensed in the public sector namely Bharat Earth Movers of HAL which expects to produce about 150 motorised scrapers, 125 rear dumpers and 150 haul packs.

It is understood that manufacturing programme of shovels by TELCO and Hindustan Motors is progressing satisfactorily. In addition, HEC, Ranchi, has also programmed the manufacture of shovels at Ranchi. One unit namely, Tata Robin Fraser has been licensed for the manufacture of processing equipment such as jaw crushers, hammer mills, gravity breakers, vibrating equipment, conveyors, washing trommels etc. and it is expected to commence production in 1965. This would contribute to some extent also to the surface coal processing equipment. It is, therefore, felt by the Working Group that capacities of various equipment already under implementation would by and large meet the requirements of opencast mining of coal including Neyveli Lignite (as given in Annexure III).

Earth moving machinery

On recommendation of the Chairman, Main Planning Group, D.G.T.D., took up an overall assessment of the demand and programming of the production of earthmoving equipment during the Fourth Plan period. Their report has been finalised. The salient features of the report are indicated below:—

Coal washery equipment

The detailed requirements of coal washery equipment are indicated in the Interim Report of the Working Group, Α statement of washerics which are in operation or under construction or proposed to be installed by 1970-71 are detailed in Annexure IV. The number of new washeries planned for the public sector in the Fourth Plan is 15. This includes Kargali extension, Kathara, Gidi and Sawang orders for which have been placed. The new washeries requiring plant and machinery is thus reduced to 11. TISCO is expanding its existing washery and setting up a new washery. Thus the total number of new washeries which have to be considered for placement of orders on new parties is 13 (NCDC 11 and TISCO 2). The NCDC has already placed an educational order for four washeries on the HEC. Accordingly maximum number of new washeries that may be further available for placement is reduced to 9.

The units licensed for the manufacture of washery equipment in the private sector are:

(1) McNally Birds Engineering Co.

- (2) Britannia Engineering Co.
- (3) Tata Robins Fraser.
- (4) Argent Engineers Ltd.

Their total manufacturing capacity when in full production is estimated at 5.5 washery plants per annum. This together with the capacity with H.E.C. including CMMP, Durgapur would be considerably in excess of requirements and it may be necessary for some of the above units to diversify their production. To avoid idle capacity on one hand and over diversification on the other hand leaving inadequate capacity for washery equipment, the Working Group recommends that the requirement of individual washeries may be tied up at the earliest with the manufacturing programme of HEC and the existing units. One of the main difficulty in placing orders with indigenous sources so far has been their inability to provide cyclone washeries of Dutch State Mines (DSM) design preferred by NCDC. The Working Group hopes that the question of manufacture of suitable cyclone washers will be satisfactorily sorted out to avoid expenditure of foreign exchange on the import of complete washery equipment from HEC is expected to finalise shortly a collaboration abroad. agreement with Poland for the production of 4 Nos. washeries for which it has secured an order. It is hoped that arrangements for the manufacture of cyclone washers of suitable design will also be finalised by them soon. They are also negotiating with Poland for setting up a design and technical bureau to enable HEC to design and coordinate supplies for a washery plant and take it up on a turnkey basis. It is expected that these steps would enable HEC to manufacture and supply washery equipment on a sustained basis.

A wide variety of equipment is needed for coal washery. Their details have been circulated with the Interim Report. The increase in washeries capacity during the Fourth Plan is expected to be of the order of about 20 million tonnes of input. Broadly, the requirements of washeries may be taken as $1\frac{1}{2}$ washeries per annum by 1970-71 to increase to about 2 washeries per annum during the Fifth Plan. No further capacity however needs to be licensed for coal washeries equipment during the Fourth Plan.

Drilling rigs

(a) Core Drilling (Diamond) Rigs

Core Drilling Rigs, while penetrating any strata recover a continuous core of rock or ore which is brought to the surface analysed and measured to determine the mineral content, the size and the value of the vein or deposit located. They are used for prospecting and for drawing sub-surface contour maps. These can be used with the primemover either as diesel engine or electric motor or compressed air-drive. They can be either skid-mounted or otherwise as required.

The licensed capacity for core Drilling Rigs along with their production in 1963 is indicated below:

There are 4 units which are licensed of which 3 are in production so far. Total value of production for these 3 units in 1963 was Rs. 75.65 lakhs against a licensed capacity of Rs. 265 lakhs for the 4 units. The production is expected to pick up rapidly during the current and the coming years.

(b) Well Drilling Rigs

Only one unit namely M/s. Reliable Water Supply Company, Lucknow is so far licensed to manufacture these drilling rigs as per the following details:

- (i) Reverse circulation 16" to 60" dia. hole up to a depth of 600'.
- (ii) Reverse circulation 12" to 30" dia. hole up to 500' depth.
- (iii) Reverse circulation up to 8'' dia. hole \times 350 ft. depth.
- (iv) Direct Rotary 6" dia. × 1500' depth
- (v) Percussion drill 8" to 15" dia. up to a depth of 700 ft.

Rs. 65 Lakhs. Licensed 9th August 1963 43 Nos. and likely to go into production before end of 1964.

(c) Oil Drilling and Prospecting Rigs

In addition to the above drilling rigs are those required for Oil and Gas Drilling and prospecting. These Drilling Rigs are included in the manufacturing programme of Heavy Engineering Corporation, Ranchi, where Oil Well Drilling Rigs totalling 5,500 tonnes are to be produced out of the envisaged production of 80,000 tonnes when the plant reaches full capacity. This would be equivalent to about 50 rigs per annum. It has at present order for only 3 Nos. drilling rigs from O.N.G.C.

The requirement of drilling rigs for different end-use and by the different organisations is discussed in the following paragraphs:

(i) Indian Bureau of Mines.—The requirements for drilling rigs (for Metalliferrous Mines) have been indicated to the Working Group by the D.G.T.D. and are reproduced below. The entire requirement is of Core (Diamond) Drills:

It would be seen that the Fourth Plan requirements of Indian Bureau of Mines total 125 Nos. These have been phased for a single year during the plan *i.e.*, for procurement in 1967-68. These can be all met from the indigenous source, but it would be desirable to rephase the requirements to spread uniformly during each year of the Fourth Plan and to tie up with the manufacturing programme of the several units.

(ii) National Coal Development Corporation.—The total requirements during the Fourth Plan are indicated as 15 Nos. comprising of 5 Nos. core diamond drilling rigs with a capacity of 1500 ft. depth, 3" dia. and 10 Nos. for deeper drilling. These are envisaged to be procured in 1966-67. Some phasing of these requirements may be advisable. In addition to complete drilling rigs NCDC has indicated a requirement of about Rs. 50 lakhs of components and spares during each year of the Fourth Plan for the maintenance of its stock of drills expected to number 118 by the end of the Third Plan.

(iii) National Mineral Development Corporation.—The stock of drills expected to be held by the NCDC by the end of the Third Plan is anticipated as 29 Nos. and further requirements during each year of the Fourth Plan (excluding deep hole blast drills which can be met by indigenous producers of drills) have been indicated to us as 16 Nos. per year totalling 80 Nos. during the Fourth Plan.

Irrigation

Drilling rigs for agricultural sector.—The Working Group on inter-relationship between agriculture and industry has estimated the demand for well-drilling rigs as 400 Nos. with yearwise requirements as indicated below:

Taking into account about 20 per cent for replacement of the existing rigs including spares, the total requirements have been estimated at 400 divided into the following categories:

The Working Group has assumed an average price of Rs. 1.5 lakhs per drill *i.e.*, totalling Rs. 600 lakhs and Rs. 120 lakhs per annum. With the slow development of manufacture of these drills in the country, the Working Group had placed the imported components at Rs. 540 lakhs.

The Irrigation Adviser in the Ministry of Food and Agriculture was also consulted regarding the assessment of rigs for well drilling. We were informed (on 27th July 1964) that

In view of the emphasis on minor irrigation for quick augmentation of agricultural production, we have assumed that it would be desirable to plan a capacity of 400 rigs as it would be preferable to have some built-in extra capacity for meeting the demand for an item of this importance.

Of the total, the requirement of core (diamond) drilling rigs is 30 Nos. With regard to the requirements of the well drilling rigs (other than core drilling) the requirement during the Plan would be 370 including replacements (Neyveli Lignite Corporation would also require about 10 drilling rigs of this type during the Fourth Plan).

It has also been observed that within the total numbers of drilling rigs required, there is considerable divergence in the requirements of different categories of drilling rigs as indicated by the Working Group on Inter-Relationship of Agriculture and Industry and the Irrigation Adviser. It is felt by us that the manufacturing programme of the existing producer and the new capacity is likely to have flexibility to meet any shift in demand from one to the other type.

At present, there is only one company, namely M/s. Reliable Water Supply Service of India Limited which has been licensed for the manufacture of well drilling rigs. Its licensed capacity is 43 Nos. per annum. They had an existing factory where they were producing drilling rigs in the past on small scale basis. They are expected to commence production on large scale before the end of 1964. The progress of the unit needs to be carefully watched. New capacity (preferably by diversification of the manufacturing programme of one of the reputable units producing drilling rigs of the other types) should be created or in case there is no ready response capacity in a new unit to the extent of 50-60 rigs per annum has to be established as early as possible. The total investment at approximately 1:2 investment/ output ratio (due to a considerable portion of parts being bought-out) is estimated at Rs. 50 lakhs of which about Rs. 20 lakhs investment may be assumed to be made by 1965-66. The rest of the investment of about Rs. 30 lakhs will have to be made during the Fourth Plan.

The maintenance import requirement may be assessed at approx. 20% of the value of output *i.e.* at about Rs. 20 lakhs per annum.

Oil and Natural Gas Commission and Oil India Limited

The basis of the assessment of the requirement of drilling rigs has been indicated in our Interim Report in paragraph 6.6, 6.7 and 6.8.

In order to achieve its drilling target of about 2.38 million metres during the Fourth Plan, it will be necessary for ONGC to keep 50 rigs in continuous operation throughout the Plan period; in addition another 15 rigs will be required in reserve on assumption of a rig circulation coefficient of 1:1.3. At present, ONGC owns 43 rigs as per following details:

Of these, the 'C' category rigs are operating at present only in Gujarat. The 'B' category rigs are operating both in Gujarat and other regions while the 'A' category rigs are operating in areas other than Gujarat.

The ONGC has already placed orders for 6 more rigs making a total of 49. Out of these 49, 14 rigs which are already worn out or likely to be worn out in the near future will have to be replaced. This deficiency of 14 rigs as proposed to be made good by importing 10 new rigs and by re-conditioning 4 rigs out of the useful parts and assemblies, which would be written off. Thus, a net of 10 new rigs will be required in replacement. The category-wise requirement of rigs before the commencement of the Fourth Plan is desired by ONGC to be as below:

In addition to the existing 4 structural rigs ONGC proposes to obtain 4 more structural rigs so that during the Fourth Plan period it will have 8 structural rigs. Out of these 8, 6 rigs are expected to be in operation and to drill about 92 wells during the Fourth Plan period. It also proposes to procure 15 additional work-over rigs and 50 drill stem testing sets.

The entire requirements of about 30 additional rigs are indicated for procurement before the commencement of the Fourth Plan. It would be necessary to take action for the import/indigenous manufacture/re-conditioning of rigs immediately. Some thought, however, needs to be given for re-phasing the requirements which may be advantageous both from the point of view of ONGC as well as the suppliers.

The Heavy Machine Building Plant at Ranchi has made a provision to include 5,500 tonnes of drilling rigs in a total production of 80,000 tonnes per annum. This may be equivalent to about 50 rigs per annum. Discussions have already taken place between the Heavy Machine Building Plant at

Ranchi and ONGC as far back as July 1963 as a result of which the HEC is understood to have obtained necessary documentation for BU 75 drilling rigs of Russian design. The HEC is in an immediate position to execute the structural work. Items like engines, pumps, generators etc. could be procured by it from other indigenous firms. In view of considerable expense incurred by HEC in procuring documentation for BU 75 which may not be put to use it is keen to ask for documentation and take up manufacture of drilling rigs of ONGC after placement of firm orders. It is understood that orders for 3 Nos. drilling rigs have now been placed with HEC but the ONGC is reluctant to place further orders till it is satisfied with the performance of 3 rigs when supplied by HEC. As the manufacturing capacity has been set up by HEC at such heavy investment and since it has available with it the technical know-how, documentation and even supervision by Russians the Working Group does not share the views of ONGC and recommends that orders for their entire demand should be placed with HEC who could then firmly programme a phased manufacture of these rigs. Even after placing of order for entire demand of ONGC there will be substantial surplus capacity left with HEC. It is recommended that they should take immediate steps to investigate manufacture of alternative items so as to utilise their manufacturing as fully as possible. The Working Group is of the view that immediate steps may be taken to tie up the requirement of ONGC with the manufacturing programme of HEC.

The requirement of Geological Survey of India for core (diamond) drilling rigs for the Fourth Plan desired to be procured at the commencement of the Plan are:

There would be some additional requirement from the State and Private Agencies. The requirement of core drilling rigs can be met indígenously from the capacity already licensed and likely to be established by 1965-66. Verhaps, some marginal adjustments to meet the specifications of the customers may be necessary. In conclusion, the Working Group would like to recommend:

- (4) Immediate steps should be taken for establishment of additional capacity for 50.60 well drilling rigs per annum for which the additional investment in the Fourth Plan will be about Rs. 30 Jakus.
- (2) Immediate effort should be made to the up the requirement of ONGC with that of the manufacturing programme of HEC Ranchi on the basis of firm orders.
- (3) The requirement of IBM. NCOC and NMDC. ONGC. OIL etc. should be properly phased for each year of the Fourth Plan instead of the entire requirements being hunched for a single year by each of these organisations. The requirements should be tied up with the manufacturing programme of the producers.
- (4) The requirement of accessories, components and spares should be met by and large from indifferous sources. A close liaison should be established between the producers and the users of defiling rigs to coordinate the manufacturing programme to suit to and phase it to the requirement of customers. Adequate attention will have to be paid to ensure the supply of items like engines, generators, pumps etc. and components and spares required in large quantities and to effect any diversification desired.

Rock Drilling

In addition to the above drills, substantial capacity has been created for rock drills which could be both electric as well as pneumatic. These are used in mining as well as for such other purposes as construction and road building etc. The licensed posizion regarding the rock drills is indicated below. It is expressed that this capacity would be by and large adequate:

Minerals other than Coal

Requirement of machinery and equipment for mining industry, other than coal.

The most important programme in this field would be with that of iron ore. The other minerals are: limestone, bauxite, copper, lead and zinc ore, manganese, chromite etc.

Iron Ore.—The Third Plan envisaged a capacity target of 32 m. tonnes and a production target was fixed in the context of the requirements of the steel programme which was estimated at 10 million tonnes and an export target (without taking into account exports from Goa) of 10 million tonnes. As against this target of 30 million tonnes, current estimates place the production in 1965-66 at about 22 million tonnes. The shortfall will be due partly to delay in the implementation of steel expansion programmes and the demand for the steel industry not materialising as originally envisaged and partly due to the export programme not going according to schedule.

For the Fourth Plan, the Committee of Secretaries recommended a target of 25 million tonnes for export, though for the purposes of planning mines, as well as the transport and port facilities, a figure of 30 million tonnes was kept in view. This target of 25 million tonnes is inclusive of the exports from Goa which is currently running at between 5 and 6 million tonnes. The main sources from which these 25 million tonnes are to be drawn are:

The balance is to be obtained from other minor deposits. Although the World Bank is in favour of more modest target of export of 18.20 million tonnes, it may be advisable for the purpose of making provision for machinery to go on the basis of higher targets.

Besides the requirements for export, the Planning Group on Minerals other than coal and oil, had estimated the requirements of iron ore for the steel programme at 35 million tonnes by 1970-71. In this case also, there is a possibility of steel target being somewhat modified which would affect the iron ore requirements. The Working Group, however, feels that in view of the considerable time lag between supply and installation of machinery and the achievement of full rated production of iron ore, and to ensure continued increase of production during early 5th Plan, it would be advisable to take into account the more liberal estimates and capacity which may therefore be assumed at about 60 million tonnes to be established by 1970-71.

The revised requirement of machinery for iron ore programme is indicated in Annexure IV. These may be categorised as below. (Drills and compressors have been left out as these have been taken into account earlier). Requirements for the plan period

Limestone.—The quarrying capacity for limestone is expected to rise from about 25 million tonnes at the end of the Third Plan to about 60 million tonnes at the end of the Fourth Plan. Details about the specific type and quantity of equipment required for this programme could not be obtained. As bulk of limestone would be required for cement industry of say unit capacity of 0.2 million tonnes, full mechanisation would not be possible in all cases. Nevertheless the requirements of earthmoving, dressing, handling and conveying equipment would be substantial.

Bauxite.—The requirement of bauxite is likely to increase from about 0.5 million tonnes to 1.0 million tonnes. The requirements in this case also would be largely earthmoving equipment along with dressing, handling and conveying equipment.

Copper Ore.—Apart from the development programme already in hand at Khetri the main activity and investment would be in regard to Kolihan and Rakha mines (to augment capacity by 1 million tonnes) whose requirements have been listed in Annexure VIII. The requirements comprise a number of common items such as earthmoving equipment, drills. compressors, motor generators, conveyors, crushers etc. The more specific items are haulage cars, service and haulage locomotives, skip loaders loaders, cages, hoists. These items are stated to be somewhat similar to those used for underground coal mining. As the requirements are not large and as CMMP, Durgapur, will have substantial surplus capacity, the Working Group suggests that NMDC should discuss their requirements with details of specifications and phasing etc. with CMMP, Durgapur to enable the latter to supply their requirements.

Lead and Zinc.—In addition to the development of mining at Zawar the production of lead and zinc metals is expected to be based mainly on imported concentrators.

Lignite.—It is proposed to mine 7.0 million tonnes of lignite in a second mine at Neyveli to be developed during the Fourth Plan. The requirements of machinery are already listed in Annexure IV and comprise mainly of earthmoving machinery, drilling equipment and conveyors.

Categories of Equipment

It would be seen from the description of equipment required for mining of minerals other than underground coal that the equipment would broadly fall under the following categories:

- 1. Earth moving.
- 2. Drilling.
- 3. Size reduction machinery.
- 4. Washing, screening and vibrating equipment.
- 5. Conveyors.

Earth Moving and Drilling Equipment

Items (1) and (2) have been covered earlier in the report. Earth moving equipment is also required in a number of other fields such as dam construction, road building and construction work, site levelling for industrial projects etc. it is not intended to make any specific recommendation. The Working Group would however like to mention that the earthmoving industry has yet to be developed and early steps need to be taken that the requirement of mining industry *inter-alia* others are adequately met. The requisite ancilaries for this industry would also need to be developed simultaneously. The other categories of equipment are discussed below:

Size reduction Machinery

These constitute mainly (a) ball mill and tube mill (b) jaw crushers (c) hammer mill (d) gyro or cane crushers and (e) roll crushers.

Ball mills were included in the original manufacturing programme of CMMP, Durgapur, but later the item was dropped when it was anticipated that some of the items could be produced by the proposed second plant. While considering the scope of supply for Coal Mining Machinery from Durgapur, we have taken into account that it would supply ball mills aggregating a total tonnage of 240 tonnes for underground coal mining. The figure of 23,000 tonnes of anticipated supply per annum includes this figure for the ball mills. Ball mills are also included in the manufacturing programme of HEC, Ranchi.

This item of equipment is required for various other industries also such as cement plants and ceramic plants etc. and is being manufactured by the producers of cement plant and other heavy engineering machinery. However, atleast so far as the requirements of ball mills for mineral industries are concerned it would be desirable to investigate whether the item could more suitably be taken up to be manufactured at CMMP, Durgapur, instead of HEC, Ranchi whose capacity for metallurgical equipment would be in any case far from adequate to meet the demand. This would be, of course, conditional on Durgapur Plant having the requisite plate forming and other machining and welding facilities for such a manufacturing programme as envisaged according to its original project report.

With regard to jaw crushers, the 7 units in the private sector understood to have been licensed to produce this item are already indicated above. In our view, the capacity licensed, if developed fully and allowed to have the facility to add balancing equipment whenever required would be sufficient to meet the demand. Attention will however, have to be paid in regard to the heaviest types of jaw crushers and to make provision for the special steel castings required by the manufacturers of this item.

The position with regard to capacity licensed for Gyro or cone crushers is not available. An assessment of demand for this item specifically could not be made. Cone crushers would be required for iron ore and limestone dressing for steel plants. The position regarding demand and creating of sufficient capacity will have to be examined immediately.

Hammer mills for use by various industries and 2 roll crushers for coke and coal are included in the manufacturing programme of HEC within a capacity of 3,150 tonnes which includes roller screens, reversible hammer crushers, 2-roll crushers and ball mills. The above items of machinery are required for other users also such as cement plants and are included in the manufacturing programme of private sector units for this equipment.

Washing and Screening Equipment

An idea of the diverse type of equipment required under this head can be had from details furnished for iron ore dressing crushing and screening equipment as per Annexure VIII. The capacity for the manufacture of these items is existing with washery manufacturers as mentioned under 'Washery Requirements'. HEC, Ranchi has included the manufacture of roller screen 125×125 mm, with eccentric discs and roller screening machine (twin type) 1,650 mm, Elecon and Tata Frazer Robins have also included this line of equipment in their manufacturing programme. The latter would also be set ting up design and engineering facilities in this field. In the opinion of the Working Oroup the design and engineering involved in manufacture and co-ordinated supply of a complete plant is a more complicated problem. There would be scope for duplicating the design and engineering facilities particularly since arising of ore fines and their use will be on a much larger There is expected to be an increasing trend to wash scale. limestone for use in steel industry. Apart from a total of about 5 washing and screening plants valued Rs. 12.5 crores for iron ores required by NMDC over the Fourth Plan period large quantum of equipment will also be required by the steel plants themselves for their captive mines. Washing and screening equipment will also be required increasingly for limestone, stone grits for construction purposes etc. It is expected that fuller data will be provided by the Working Group on beneficiation of ores and minerals. Earlier we have recommended that the coal washery manufacturers should diversify their production. This would be a suitable range of items for such a diversification.

Conveyors

(a) Coal Mining Machinery Project, Durgapur, has a provision to manufacture about 10 to 12,000 tonnes of chain conveyors. It has not been possible for the Working Group to make a procise estimate of demand for chain conveyors. But it was felt that this capacity would suffice to meet the demand of such conveyors from mining industry.

(b) Belt Conveyors.—The demand for belt conveyors as assessed for the mining industry as well as for major users is indicated below:

CMMP, Durgapur, has a provision to produce 22,487 tonnes of chain and belt conveyors of which 50% capacity is expected to be used for belt conveyors. It is further noted that the trend is to use belt conveyers of greater widths and it should be possible, therefore, for CMMP, Durgapur to produce within its overall plant capacity over 12,000 tonnes of belt conveyors.

We have also been furnished with the licensed capacity for belt conveyors by the D.G.T.D. as per Annexure IX. It would be noted that the total licensed capacity for conveyors aggregates a value of Rs. 764 lakhs. It is understood that over 70% of this capacity could be assumed for belt conveyors, which would approximate about Rs. 530 lakhs. On the basis of discussions with the representative of D.G.T.D. it was agreed that we may safely assume a figure of Rs. 400 to Rs. 450 lakhs (without belt) worth of belt conveyors capacity to materialise in the private sector in the latter part of the Fourth Plan period. It was also agreed that assuming a value of about Rs. 4,000 per tonne the capacity likely to materialise in the later half of the Plan period in the private sector would amount to over 10,000 tonnes of belt conveyors.

The total capacity for belt conveyors thus, would be over 20,000 tonnes and would be adequate to meet the demand for this equipment as envisaged. It takes into account that some of the units which have been licensed for a very small capacity would only be catering to specialised demands for engineering and chemical industries. It was noted that Elecon Engineering Company which specialises in coal handling plants and is already licensed to produce conveyors worth about Rs. 120 lakhs may be shortly permitted to expand its capacity for belt conveyors to Rs. 250 lakhs. It should be, therefore, possible for this industry to meet *inter-alia* the demand for the belt conveyors for thermal plant as well.

Investment in creating capacity for mining and drilling cquipment

The main investment in the sector of mining machinery and drilling rigs would be against the following:

- (a) Spill over of expenditure of CMMP, Durgapur.
- (b) Setting up of a design and engineering bureau for coal washing and other similar equipment.
- (c) Spill over and expansion of Tata-Frazer-Robins.
- (d) Expansion of Elecon.

The spill over of expenditure of CMMP, Durgapur, is indicated at Rs. 2.4 crores of which Rs. 2.2 crores would be the foreign exchange. There will be an additional spill-over

on township of about Rs. 1.5 to 2 crores. It is likely that the actual spill over may somewhat exceed this figure. No cost estimates of the design and engineering bureau are at present available. As these would be mainly the expenses for setting up an organisation and not for creating manufacturing facilities excepting marginal, in the existing HEC plants, it is expected that the expenses on this bureau may not exceed about Rs. 2 crores. In case of Tata-Frazer-Robins the authorised capital is Rs. I crore. The Company may complete its investment programme of this order by 1965-66 but a provision for further expansion along with the expansion of Elecon may be of the order of about Rs. 2 to 3 crores. Thus the total figures would amount to about Rs. 8 crores. The figures of total investment taking into consideration a large number of industrial units in the private sector (excluding that required for earth moving and electrical equipment) may be taken of the order of about Rs. 15 crores. This would include investment required in creating additional capacity for well drilling equipment, cone crushers and probably some of the specialised items of ore dressing and screening plant. About 50 per cent of this investment may be the foreign exchange component including lump sum payments etc. for technical collaboration and know-how. Of Rs. 15 crores, about Rs. 6-7 crores would be the investment in the Public Sector.

Raw Material

It has not been possible to assess the requirement of rawmaterial for an industry covering such wide scope. It would be, however useful to indicate the requirement of raw-materials for the major unit in this industry namely CMMP, Durgapur. The requirement of important raw-materials available from the indigenous sources are indicated in the following table:

SUMMARY AND CONCLUSIONS

(i) The indigenous capacity for the manufacture of coal mining machinery would be sufficient to meet our requirements during and at the end of the Fourth Plan period. On the other hand, the manufacturing capacities established in the major public sector project namely Coal Mining Machinery Project (CMMP), Durgapur, will be in excess of the demand and will need to be diversified. A welcome feature is to divert about 7,000 tonnes of capacity (out of a total capacity of 45,000 tonnes) for washery equipment. (It needs to be examined whether this allocation of capacity is on the high side). The possible products which may be taken up by the CMMP, Durgapur as part of this diversification are: (a) re-inclusion of the production of ball mills (and it should be excluded from the manufacturing programme at HMBP, Ranchi), (b) electrical items like flame proof motors particularly of the integral type, gate-end boxes etc. should be produced at CMMP, Durgapur, making use of its existing foundry and matching capacity (c) production of items of machinery, specific to the copper mining which is of similar nature to that of under-ground coal mining.

(ii) There is need to create additional capacity for drilling rigs for tube wells to the extent of about 50 to 60 drilling rigs per annum. This may be either carried out preferably by diversification of the production programme of existing producers or by diverting the surplus capacity for the production of drilling rigs for oil drilling in HEC. Ranchi, if technically feasible.

(iii) The requirement of various kinds of drilling rigs seems to have been bunched by the user organisations for procurement in the course of one or two years during the Fourth Plan period. This should be properly phased as to give due weightage to the indigenous manufacturing programme.

(iv) ONGC should be persuaded to place orders for its entire requirements of drilling rigs with the HEC, Ranchi, which may then plan its production programme to suit ONGC.

(v) The progress of the earth moving industry is very vital to the mining programme and due care should be taken to ensure that the industry inter alia meets the needs of mining. Due attention needs to be given to the development of ancillary industries for earth moving equipment.

(vi) The position regarding the demand for cone crushers and creating of sufficient capacity for this item will have to be examined immediately.

(vii) Coal washery manufacturing by HEC should be on a sustained basis. It should strive to procure manufacturing licence for DSM cyclone as early as possible and it should also expedite the setting up of Design and Engineering Bureau for washery and allied projects which is under consideration.

(viii) The coal washery manufacturers should diversify their production in view of substantial excess capacity. They may take up the manufacture of washing, screening and vibrating equipment for ore dressing for all minerals. (ix) The capacity for conveyors likely to materialise would be sufficient to meet the demand during and at the end of the Fourth Plan period.

(x) The total investment in the industry for manufacture of mining and drilling equipment would be of the order of Rs. 15 crores of which about Rs. 6 to 7 crores may be the investment in the Public Sector. Further, the foreign exchange component of Rs. 15 crores may be about 50%.

(xi) It has not been possible to make an assessment of the requirement of raw materials, technical and non-technical personnel and the power requirements. However, these have been indicated for the major plant namely CMMP, Durgapur.
