This is a question of All India Madhya Pradesh: No comments. Rajastham: In Rajastham the Chambal Project forms a part of the irrigation branch and all the staff is borne on the cadres of that branch. The staff has been recruited for this work on this Project alone and all the men will in due course be entitled to be absorbed against permanent posts of the depart-ment according to their seniority and merit. Recruitment is at present made according to the rules of the State and the Public Service Commission has to be consul-

ted in the case of gazetted and certain class of non-gazetted establishment. All this results in delay but there is no alternative unless the recruitment rules are changed. There is now no difficulty in obtaining Civil Overseers and Assistant Engineers but there is serious shortage of mechanical personnel experienced in earthmoving equipment. Certain posts sanctioned by the Board some months back have not yet been filled up for want of suitable candidates. It will certainly simplify matters if recruitment of a Committee consisting of En10
