EDUCATIONAL DEPARTMENT.

Bombay Castle, 14th August 1886.

No. 1282 of 1886.

Rules laid down by Government under Section 24 of the Bombay District Municipal Act of 1873.

In accordance with the provisions of Section 24 of the Bombay District Municipal Act, 1873, the following rules prescribing the extent of the independent authority of Municipalities in respect of public education, and their relations with the Government Educational Department, which have been approved by Government, are published provisionally for general information, and will become absolute after one month from this date, if there is no reason to the contrary:

- The powers and duties of every Municipality in respect of the establishment and maintenance of schools may, subject to the reservations and conditions hereinafter contained, and subject to such alterations as may from time to time be made under the authority of Government on this behalf, be delegated to a Committee, which shall be called "The Schools Committee," and shall be constituted according to the rules made under Section 32 of the District Municipal Act Amendment Act (Bombay II. of 1884).

tion to be followed, and the rates of salary to be given to the various grades of masters in municipal schools, shall be those hitherto adopted, or which may hereafter be prescribed by the Educational Department under the authority of Government, for schools of a similar Provided that to meet local requirements, with the previous consent of the Director of Public Instruction, any Municipality may adopt such modifications as may be found to be In case of doubt necessary or expedient. as to the application of any principle or rule the decision of the Director of Pub-

lic Instruction shall be followed subject to an appeal to Government, whose decision shall be final and conclusive.

"The existing rule of admission, irrespective of caste, must of course be maintained."

Stipulation (c) and Section 7 (3) of English Act of 1870:—

"The school shall be open at all times to the inspection of any of Her Majesty's Inspectors."

- 3. Municipal schools shall, subject to the proviso in Rule 2, be provided for all castes and classes of the community, and shall be open to inspection and examination at all times by the Government Inspecting Staff. The Municipality shall in each case make suitable arrangements in communication with the Inspectors for the annual examination required by the Educational Department.
- In the annual accounts of every Municipality rendered under Section 90 of the Bombay District Municipal Act, VI. of 1873, there shall be a separate section under the head "Education." A copy of this section shall be forwarded yearly to the Government Educational Inspector of the Division as soon as possible after the accounts have been audited and passed.

- In this section shall be set forth in separate parts the accounts of receipts and expenditure,—
 - (1) for schools within the contract;
 - (2) for schools not within the contract but maintained or aided from the Municipal Fund with or without a Government grant;
 - (3) for any other educational purposes not included in the above, but coming under Section 24, clauses (15), (16) or (21) of Act VI of 1873.

In the accounts of receipts under Part I. shall be shown separately,-

- (a) the Government contract grant;
- (b) the fee-receipts of schools within the contract;
- (c) the sum assigned and paid to the Municipality under Section 47 of Bombay Act I. of 1884 which is to be expended on educational purposes under clause 2 of that section;
- (d) any other contribution made by Government or by a Local Board, and any other income received by the Municipality for expenditure on or for the benefit of the said schools, or accruing from the said schools;
- (e) the allotment made by the Municipality in the year of account from receipts of the Municipal Fund other than receipts under (a), (b), (c) and (d) for expenditure on or for the benefit of the said schools.

In the accounts shall be shown :-

- (1) balance (if any) of receipts for previous years unexpended and carried forward;
- (2) receipts and expenditure of the year of account under each head.
- If the Municipality or the Local Board claim any part of the balance as having accrued to their funds, the Inspector will submit these claims to the Director of Public Instruction with his observations, and the Director of Public Instruction will decide whether these claims can be admitted wholly or in part.
- 6. The accounts of receipts and expenditure under Parts I., II. and III. shall otherwise be rendered in such detail as may be set forth in a form of account prescribed from time to time by the Governor in Council.
- 7. Every member of a school establishment who has been or may be transferred from the Educational Department, and who is in receipt of a salary which would entitle him to pension under the Government Uncovenanted Service Rules, shall be deemed to be an officer lent to the Municipality within the meaning of proviso (j) to Section 32 of the Bombay District Municipal Act Amendment Act of 1884, and in all questions relating to pension, leave and pay and acting allowances the rules from time to time in force for the Government Uncovenanted Service shall be applicable to such officer.

In municipal schools those persons only shall be employed who hold certificates of qualification recognized by the Educational Department or who are already in receipt of pensionable salaries under Government, so long as such teachers are procurable. It shall be incumbent on every Municipality engaging

Stipulation (k) of Government a teacher as aforesaid to make provision for his pensionary rights, in accordance with the rules in this behalf from time to time prescribed by

Government, and such teacher shall be deemed to be an officer lent to the Municipality within the proviso (j) to Section 32 of the Bombay District Municipal Act Amendment Act of 1884. In filling up places of non-pensionable pay the Municipality shall give the preference to those who have passed an examination qualifying for the Public Service, or who have been useful teachers.

8. Subject to Rule 7, the appointment, promotion, punishment, suspension, and dismissal of all members of the establishments of municipal schools shall rest with the Municipality or the Schools Committee to whom such power may be delegated. Provided that no officer in receipt of a salary exceeding ten rupees per month shall be dismissed or have his salary permanently reduced without the previous sanction of the Municipality.

In order that the less advanced Municipalities may be relieved of responsibilities which they are not yet prepared to bear, any such Municipality may apply to the Director of Public Instruction, and on such application the administration of its schools in the matter of appointment, promotion, punishment, suspension and dismissal of all members of the establishments of Municipal schools may be conducted by the Govern-

As some misapprehension appears to exist regarding the proceedings to be taken under the Fugitive Offenders Act, 1881, (Statute 44 and 45 Vic., Cap. 69,) it is deemed expedient to republish the Statute, in continuation of Home Department Notification No. 215, dated the 12th February 1886, which published for general information an Order of Her Majesty in Council, wherein it is directed that, on and after the 1st day of July 1886, Part II.

Her Majesty's East Indian Territories, The Straits Settlements.

of the above Statute shall apply to the group of British Possessions mentioned in the margin.

- 2. In thus republishing the Statute, the Governor General in Council considers it desirable to invite the attention of all officers concerned to those of its provisions which relate to the issue and endorsement of warrants for the arrest of fugitive offenders. Thus it will be noticed that when a warrant has been issued in one part of Her Majesty's dominions for the apprehension of a fugitive offender from that part, a Judge of a Superior Court in another part of Her Majesty's dominions in, or on the way to, which the fugitive is or is suspected to be, is, for the purposes of Part I. of the Statute, empowered by Section 3 to endorse the warrant, and it is necessary that the proper endorsement should be effected before an arrest can legally be made thereunder. By Section 4 of the Statute a Magistrate of any part of Her Majesty's dominions is empowered, under circumstances therein described, to issue a provisional warrant for the apprehension of a fugitive. The corresponding provisions of Part II. of the Statute are contained in Sections 13 and 16 respectively, under which the necessary power in both classes of cases is vested in Magistrates. A summons requiring the attendance of a witness, issued by a Judge or Magistrate having lawful authority in this behalf in a British possession of a group to which Part II. of the Statute applies, may, under Section 15, be endorsed by a Magistrate in any other British possession concerned of the same group, and, when so endorsed, may be legally enforced. Section 26 of the Act further legally enforced. Section 26 of the Act further empowers the authority endorsing a warrant to name in the endorsement certain persons, who shall, in addition to the persons to whom the warrant was originally addressed, be authorised to execute the same.
- The Governor General in Council trusts that, when it is necessary to take action under the Statute in question, the provisions above referred to, as also all other provisions thereof, will be carefully observed.

SCHEDULE.

CHAPTER 69.

An Act to amend the Law with respect to Fugitive Offenders in Her Majesty's Dominions, and for other Purposes connected with the Trial of Offenders. [27th August 1881.]

Be it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal and Commons, in this present Parliament assembled, and by the authority of the same, as follows (that is to say)-

Short title.

1. This Act may be cited as the Fugitive Offenders Act, 1881.

PART I.

RETURN OF FUGITIVES.

2. Where a person accused of having committed an offence (to Liability of fugitive to be apprehended and returned. Liability of fugitive to be apprehended and returned. Act applies) in one part of Her Majesty's dominions has left that part, such person (in this Act referred to as a fugitive from that part) if found in another part of Her Majesty's dominions shall be liable to be approhended and returned in manner provided by this Act to the part from which he is a fugitive.

A fugitive may be so apprehended under an endorsed warrant or a provisional warrant.

3. Where a warrant has been issued in one part of Her Majesty's Endorsing of warrant for apprehension of fugitive. dominions for the apfrom that part, any of the following authorities in another part of Her Majesty's dominions in or

on the way to which the fugitive is or is suspected to be (that is to say)-

- (1) a judge of a superior court in such part; and
- (2) in the United Kingdom, a Secretary of State and one of the magistrates of the metropolitan police court in Bow Street; and
- (3) in a British possession, the governor of that possession,

if satisfied that the warrant was issued by some person having lawful authority to issue the same, may endorse such warrant in manner provided by this Act, and the warrant so endorsed shall be a sufficient authority to apprehend the fugitive in the part of Her Majesty's dominions in which it is endorsed, and bring him before a magistrate.

4. A magistrate of any part of Her Majesty's dominions may issue a Provisional warrant for apprehension of fugitive. provisional warrant for the apprehension of a fugitive, who is or is suspected of being in or on his way to that part on such information, and under such circumstances as would in his opinion justify the issue of a warrant if the offence of which the fugitive is accused had been committed within his jurisdiction, and such warrant may be backed and executed accordingly.

A magistrate issuing a provisional warrant shall forthwith send a report of the issue, together with the information or a certified copy thereof, if he is in the United Kingdom, to a Secretary of State, and, if he is in a British possession, to the governor of that possession, and the Secretary of State or governor may, if he think fit, discharge the person apprehended under such warrant.

5. A fugitive when apprehended shall be brought before a magis-Dealing with fugitive when apprehended: trate, who (subject tothe provisions of this Act) shall hear the case in the same manner and have the same jurisdiction and powers, as near as may be (including the power to remand and admit to ball), as if the fugitive were charged with an offence committed within his jurisdic-

If the endorsed warrant for the apprehension of the fugitive is duly authenticated, and such evidence is produced as (subject to the provisions of this Act), according to the law ordinarily administered by the magistrate, raises a strong or probable presumption that the fugitive committed the offence mentioned in the warrant, and that the offence is one to which this part of this Act applies, the magistrate shall commit the fugitive to prison to await his return, and shall forthwith send a certificate of the committal and such report of the case as he may think fit if in the United Kingdom, to a Secretary of State, and, if in a British possession, to the governor of that possession.

Where the magistrate commits the fugitive to prison, he shall inform the fugitive that he will not be surrendered until after the expiration of fifteen days, and that he has a right to apply for a writ of habeas corpus, or other like process.

A fugitive apprehended on a provisional warrant may be from time to time remanded for such reasonable time, not exceeding seven days at any one time, as under the circumstances seems requisite for the production of an endorsed warrant.

Return of fugitive by a fugitive has been committed to prison to await his return, or if a writ of habeas corpus or other like process is issued with reference to such fugitive by a superior court, after the final decision of the court in the case,—

 if the fugitive is so committed in the United Kingdom, a Secretary of State; and
 if the fugitive is so committed in a British

possession, the governor of that possession, may, if he thinks it just, by warrant under his hand order that fugitive to be returned to the part of Her Majesty's dominions from which he is a fugitive, and for that pupose to be delivered into the custody of the persons to whom the warrant is addressed, or some one or more of them, and to be held in custody, and conveyed by sea or otherwise to the said part of Her Majesty's dominions, to be dealt with there in due course of law as if he had been there apprehended, and such warrant shall be forthwith executed according to the tenor thereof.

The governor or other chief officer of any prison, on request of any person having the custody of a fugitive under any such warrant, and on payment or tender of a reasonable amount for expenses, shall receive such fugitive and detain him for such reasonable time as may be requested by the said person for the purpose of the proper execution of the warrant.

7. If a fugitive who, in pursuance of this part of this Act, has Discharge of person apprehended if not returned been committed to prison within one month. in any part of Her Majesty's dominions to await his return, is not conveyed out of that part within one month after such committal, a superior court, upon application by or on behalf of the fugitive, and upon proof that reasonable notice of the intention to make such application has been given, if the said part is the United Kingdom, to a Secretary of State, and, if the said part is a British possession, to the governor of the possession, may, unless sufficient cause is shown to the contrary, order the fugitive to be discharged out of custody.

Sending back of persons accused of an offence and returned in pursuance of apprehended if not prosecuted within, six months of acquitted.

is not prosecuted for the said offence within six months after his arrival in that part, or is acquitted of the said offence, then, if that part is the United Kingdom, a Secretary of State, and, if that part is a British possession, the governor of that possession, may, if he think fit, on the request of such person, cause him to be sent back free of cost, and with as little delay as possible, to the part of Her Majesty's dominions in or on his way to which he was apprehended.

9. This part of this Act shall apply to the Offences to which this part of this Act applies.

Solvent and to every offence, whether called felony, misdemeanor, crime, or by any other name which is for the time being punishable in the part of fler Majesty's dominions in which it was committed, either on indictment or information, by imprisonment with hard labour for a term of twelve months or more or by any greater punishment; and for the purposes of this section, rigorous imprisonment, and any confinement in a prison combined with labour, by whatever name it is called, shall be deemed to be imprisonment with hard labour.

This part of this Act shall apply to an offence notwithstanding that by the law of the part of Her Majesty's dominions in or on his way to which the fugitive is or is suspected of being it is not an offence or not an offence to which this part of this Act applies; and all the provision of this part of this Act, including those relating to a provisional warrant and to a committal to prison, shall be construed as if the offence were in such last-mentioned part of Her Majesty's dominions an offence to which this part of this Act applies.

10. Where it is made to appear to a superior

court that by reason of the trivial nature of the case, or by reason of the application for the return of a fugitive not

being made in good faith in the interests of justice or otherwise, it would, having regard to the distance, to the facilities for communication, and to all the circumstances of the case, be unjust or oppressive or too severe a punishment to return the fugitive either at all or until the expiration of a certain period, such court may discharge the fugitive, either absolutely or on bail, or order that he shall not be returned until after the expiration of the period named in the order, or may make such other order in the premises as to the court seems just.

Application of part of Act to group of British possessions to which, by reason of their contiguity or otherwise, it may seem expedient to Her Majesty to apply the same.

It shall be lawful for Her Majesty from time to time, by Order in Council, to direct that this part of this Act shall apply to the group of British possessions mentioned in the Order, and by the same or any subsequent Order to except certain offences from the application of this part of the Act, and to limit the application of this part of this Act by such conditions, exceptions, and qualifications as may be deemed expedient.

Backing of Warrants.

Backing in one British possession of a group to which this part of this Act applies a warrant has been issued for the apprehension of a person accused of an offence punishable by law in that possession, and such person is or is suspected

that possession, and such person is or is suspected of being in or on the way to another British possession of the same group, a magistrate in the last-mentioned possession, if satisfied that the warrant was issued by a person having lawful authority to issue the same, may endorse such warrant in manner provided by this Act, and the warrant so endorsed shall be a sufficient authority to apprehend, within the jurisdiction of the endorsing magistrate, the person named in the warrant, and bring him before the endorsing magistrate or some other magistrate in the same British possession,

14. The magistrate before whom a person so apprehended is brought,

Return of prisoner apprehended under backed warrant. apprehended is brought, if he is satisfied that the warrant is duly authenticated as directed by

this Act and was issued by a person having lawful authority to issue the same, and is satisfied on oath that the prisoner is the person named or otherwise described in the warrant, may order such prisoner to be returned to the British possesion in which the warrant was issued, and for that purpose to be delivered into the custody of the persons to whom the warrant is addressed, or any one or more of them, and to be held in custody and conveyed by sea or otherwise into the British possession in which the warrant was issued, there to be dealt with according to law as if he had been there apprehended. Such order for return may be made by warrant under the hand of the magistrate making it, and may be executed according to the tenor thereof.

A magistrate shall, so far as is requisite for
the exercise of the
powers of this section,
have the same power, including the power to remand and admit to bail
a prisoner, as he has in the case of a person apprehended under a warrant issued by him.

15. Where a person required to give evidence on behalf of the prosecutor or defendant on a charge for an offence possession of same group.

15. Where a person required to give evidence on behalf of the prosecutor or defendant on a charge for an offence punishable by law in a British possession of a

British possession of a group to which this part of this Act applies is or is suspected of being in or on his way to any other British possession of the same group, a judge, magistrate, or other officer who would have lawful authority to issue a summons, requiring the attendance of such witness, if the witness were within his jurisdiction, may issue a summons for the attendance of such witness, and a magistrate

in any other British possession of the same group, if satisfied that the summons was issued by some judge, magistrate, or officer having lawful authority as aforesaid, may endorse the summons with his name; and the witness, on service in that possession of the summons so endorsed, and on payment or tender of a reasonable amount for his expenses, shall obey the summons, and in default shall be liable to be tried and punished either in the possession in which he is served or in the possession in which the summons was issued, and shall be liable to the punishment imposed by the law of the possession in which he is tried for the failure of a witness to obey such a summons. The expression "summons" in this section includes any subpena or other process for requiring the attendance of a witness.

16. A magistrate in a British possession of a group to which this part of this Act applies, before the endorsement in

pursuance of this part of this Act of a warrant for the apprehension of any person, may issue a provisional warrant for the apprehension of that person, on such information and under such circumstances as would in his opinion justify the issue of a warrant if the offence of which such person is accused were an offence punishable by the law of the said possession and had been committed within his jurisdiction, and such warrant may be backed and executed accordingly: provided that a person arrested under such provisional shall warrant be discharged unless the original warrant is produced and endorsed within such reasonable time as may under the circumstances seem requisite.

17. If a prisoner in a British possession whose

Discharge of prisoner not returned within one month to British possession of same group. return is authorized in pursuance of this part of this Act is not conveyed out of that possession within one month-after

the date of the warrant ordering his return, a magistrate or a superior court, upon application by or on behalf of the prisoner, and upon proof that reasonable notice of the intention to make such application has been given to the person holding the warrant, and to the chief officer of the police of such possession or of the province or town where the prisoner is in custody, may, unless sufficient cause is shown to the contrary, order such prisoner to be discharged out of custody.

Any order of refusal to make an order of discharge by a magistrate under this section shall be subject to appeal to a superior court.

18. Where a prisoner accused of an offence

Sending back of prisoner not prosecuted or acquitted to British possession of same group. is returned in pursuance of this part of this Act to a British possession, and either is not prosecuted for the said offence

within six months after his arrival in that possession or is acquitted of the said offence, the governor of that possession, if he thinks fit, may, on the requisition of such person, cause him to be sent back free of cost, and with as little delay as possible, to the British possession in or on his way to which he was apprehended.

Where the return of a prisoner is sought or ordered under this Refusal to return prisoner where offence too trivial. part of this Act, and it is made to appear to a magistrate or to a superior court that by reason of the trivial nature of the case, or by reason of the application for the return of such prisoner not being made in good faith in the interests of justice or otherwise, it would, having regard to the distance, to the facilities of communication, and to all the circumstances of the case, be unjust or oppressive, or too severe a punishment, to return the prisoner either at all or until the expiration of a certain period, the court or magistrate may discharge the prisoner either absolutely or on bail, or order that he shall not be returned until after the expiration of the period named in the order, or may make such other order in the premises as to the magistrate or court seems

Any order or refusal to make an order of discharge by a magistrate under this section shall be subject to an appeal to a superior court.

PART III.

Trial, &c., of Offences.

Offences committed on boundary of two adjoining British possessions.

British possessions adjoin, a person accused of an offence committed on or within the distance of five hundred yards from the common boundary of such possessions may

the common boundary of such possessions may be apprehended, tried, and punished in either of such possessions.

21. Where an offence is committed on any

person or in respect of Offences committed on ourney between two Briany property in or upon tish possessions. any carriage, cart vehicle whatsoever employed in a journey, or on board any vessel whatsoever employed in a navigable river, lake, canal, or inland navigation, the person accused of such offence may be tried in any British possession through a part of which such carriage, cart, vehicle, or vessel passed in the course of the journey or voyage during which the offence was committed; and where the side, bank, centre, or other part of the road, river, lake, canal, or inland navigation along which the carriage, cart, vehicle, or vessel passed in the course of such journey or voyage is the boundary of any British possession, a person may be tried for such offence in any British possession of which it is the boundary:

Provided that nothing in this section shall authorize the trial for such offence of a person who is not a British subject, where it is not shown that the offence was committed in a British possession.

22. A person accused of the offence (under Trial of offence of false swearing or giving false known) of swearing or evidence. Known) of swearing or making any false evidence, for the purposes of this Act, may be tried either in the part of Her Majesty's dominions in which such deposition or evidence is used, or in the part in which the same was shown, made, given, or fabricated, as the justice of the case may require.

Supplemental provision as to trial of person in any place.

The place of trial of a person accused of an offence, that offence shall for all purposes of and incidental to the apprehension, trial, and punishment of such person, and of and incidental to any proceedings and matters preliminary, incidental to, or consequential thereon, and of and incidental to the jurisdiction of any court, constable or officer with reference to such offence, and to any person accused of such offence, be deemed to have been committed in any place in which the person accused of the offence can be tried for it; and such person may be punished in accordance with the Courts (Colonial) Jurisdiction Act, 1874.

Where a warrant for the apprehension of a person accused of an Issue of search warrant, offence has been endorsed in pursuance of any part of this Act in any part of Her Majesty's dominions, or where any part of the Act provides for the place of trial of a person accused of an offence, every court and magistrate of the part in which the warrant is endorsed or the person accused of the offence can be tried shall have the same power of issuing a warrant to search for any property alleged to be stolen or to be otherwise unlawfully taken or obtained by such person, or otherwise to be the subject of such offence, as that court or magistrate would have if the property had been stolen or other-wise unlawfully taken or obtained, or the offence had been committed wholly within the jurisdiction of such court or magistrate.

Where a person is in legal custody in a Removal of prisoner by British possession either in pursuance of this Act another. or otherwise, and such person is required to be removed in custody to another place in or belonging to the same British possession, such person, if removed by sea in a vessel belonging to Her Majesty or any of Her Majesty's subjects, shall be deemed to continue in legal custody, until he reaches the place to which he is required to be removed; and the provisions of this Act with respect to the retaking of a prisoner who has escaped, and with respect to the trial and punishment of a person guilty of the offence of escaping or attempting to escape, or aiding or attempting to aid a prisoner to escape, shall apply to the case of a prisoner escaping while being lawfully removed as aforesaid, in like manuer as if he were being removed in pursuance of a warrant endorsed in pursuance of this Act.

PART IV.

SUPPLEMENTAL.

Warrants and Escape.

26. An endorsement of a warrant in pursuance of this Act shall be signed by the authority endorsing the same, and shall authorize all or any of the persons named in the endorsement, and of the persons to whom the warrant was originally directed, and also every constable, to execute the warrant within the part of Her

Majesty's dominions or place within which such endorsement is by this Act made a sufficient authority, by apprehending the person named in it, and bringing him before some magistrate in the said part or place, whether the magistrate named in the endorsement or some other.

For the purposes of this Act, every warrant, summons, subpœna, and process, and every endorsement made in pursuance of this Act thereon, shall remain in force, notwithstanding that the person signing the warrant or such endorsement dies or ceases to hold office.

27. Where a fugitive or prisoner is authorized to be returned to any part of Her Majesty's dominions in pursuance of Part One or Part Two of this Act, such fugitive or prisoner may be sent thither in any ship belonging to Her Majesty or to any of her subjects.

For the purpose aforesaid, the authority signing the warrant for the return may order the master of any ship belonging to any subject of Her Majesty bound to the said part of Her Majesty's dominions to receive and afford a passage and subsistence during the voyage to such fugitive or prisoner, and to the person having him in cutody, and to the witness, so that such master be not required to receive more than one fugitive or prisoner for every hundred tons of his ship's registered tonnage, or more than one witness for every fifty tons of such tonnage.

The said authority shall endorse or cause to be endorsed upon the agreement of the ship such particulars with respect to any fugitive prisoner or witness sent in her as the Board of Trade from time to time require.

Every such master shall, on his ship's arrival in the said part of Her Majesty's dominions, cause such fugitive or prisoner, if he is not in the custody of any person, to be given into the custody of some constable, there to be dealt with according to law.

Every master who fails on payment or tender of a reasonable amount for expenses to comply with an order made in pursuance of this section, or to cause a fugitive or prisoner committed to his charge to be given into custody as required by this section, shall be liable on summary conviction to a fine not exceeding fifty pounds, which may be recovered in any part of Her Majesty's dominions in like manner as a penalty of the 17 and 18 Vic., c. 104.

Escape of prisoner from custody.

Becape of prisoner from custody.

or otherwise, out of the custody of a person acting under a warrant issued or endorsed in pursuance of this Act, he may be retaken in the same manner as a person accused of a crime against the law of that part of Her Majesty's dominions to which he escapes may be retaken upon an escape.

A person guilty of the offence of escaping or of attempting to escape, or of aiding or attempting to aid a prisoner to escape, by breach of prison or otherwise, from custody under any warrant issued or endorsed in pursuance of this Act, may be tried in any of the following parts of Her Majesty's dominions, namely, the part to which and the part from which the prisoner is being removed, and the part in which the prisoner escapes, and the part in which the offender is found.

Evidence.

29. A magistrate may take depositions for the Depositions to be evidence, and authentication of depositions and warrants. It was accused of an offence in like manner as he might take the same if such person were present and accused of the offence before him.

Depositions (whether taken in the absence of the fugitive or otherwise) and copies thereof, and official certificates of or judicial documents stating facts, may, if duly authenticated, be received in evidence in proceedings under this Act:

Provided that nothing in this Act shall authorize the reception of any such depositions, copies, certificates, or documents in evidence against a person upon his trial for an offence.

Warrants and depositions, and copies thereof, and official certificates of or judicial documents stating facts, shall be deemed duly authenticated for the purposes of this Act if they are authenticated in manner provided for the time being by law, or if they purport to be signed by or authenticated by the signature of a judge, magistrate, or officer of the part of her Majesty's dominions in which the same are issued, taken, or made, and are authenticated either by the oath of some witness, or by being sealed with the official seal of a Secretary of State, or with the public seal of a British possession, or with the official seal of a governor of a British possession, or of a colonial secretary, or of some secretary or minister administering a department of the government of a British possession.

And all courts and magistrates shall take judicial notice of every such seal as is in this section mentioned, and shall admit in evidence without further proof the documents authenticated by it.

Miscellaneous.

30. The jurisdiction under Part One of this Provision as to exercise of jurisdiction by magistrates.

Act to hear a case and commit a fugitive to prison to await his return shall be exercised,—

- In England, by a chief magistrate of the metropolitan police courts or one of the other magistrates of the metropolitan police court at Bow Street; and
- (2) In Scotland, by the sheriff or sheriff substitute of the county of Edinburgh; and
- (3) In Ireland by one of the police magistrates of the Dublin metropolitan police district; and
- (4) In a British possession, by any judge, justice of the peace, or other officer having the like jurisdiction as one of the magistrates of the metropolitan police court in Bow Street, or by such other court, judge, or

magistrate as may be from time to time provided by an Act or Ordinance passed by the legislature of that possession.

If a fugitive is apprehended and brought before a magistrate who has no power to exercise the jurisdiction under this Act in respect of that fugitive, that magistrate shall order the fugitive to be brought before some magistrate having that jurisdiction, and such order shall be obeyed.

It shall be lawful for Her Majesty in ras to making and Council from time to Power as to making and revocation of Orders in time to make Orders for the purposes of this Act, and to revoke and vary any Order so made, and every Order so made shall, while it is in force, have the same effect as if it were enacted in this

An Order in Council made for the purposes of this Act shall be laid before Parliament as soon as may be after it is made if Parliament is then in session, or, if not, as soon as may be after the commencement of the then next sessions of Parliament.

Power of legislature of British possession to pass laws for carrying into effect pass any Act or Ordin nance-

- (1) For defining the offences committed in that possession to which this Act or any part thereof is to apply; or
- (2) For determining the court, judge, magistrate, officer or person by whom and the manner in which any jurisdiction or power under this Act is to be exercised;
- (3) For payment of the costs incurred in returning a fugitive or a prisoner, or in sending him back if not prosecuted or if acquitted, or otherwise in the execution of this Act; or
- (4) In any manner for the carrying of this Act or any part thereof into effect in that possession,

it shall be lawful for Her Majesty by Order in Council to direct, if it seems to Her Majesty in Council necessary or proper for carrying into effect the objects of this Act, that such Act or Ordinance, or any part thereof, shall, with or without modification or alteration, be recognized and given effect to throughout Her Majesty's dominions and on the high seas as if it were part of this Act.

Application of Act.

33. Where a person accused of an offence can, by reason of the nature of the offence, or of the Application of Act to offences at sea or triable in several parts of Her place in which it was Majesty's dominious. committed, or otherwise, be, under this Act or otherwise, tried for or in respect of the offence in more than one part of Her Majesty's dominions, a warrant for the apprehension of such person may be issued in any part of Her Majesty's dominions in which he can, if he happens to be there, be tried; and each part of this Act shall apply as if the offence had been committed in the part of Her Majesty's dominions where such warrant is issued, and such person may be apprehended and returned in pursuance of this Act, notwithstanding that in the place in which he is apprehended a court has jurisdiction to try him:

Provided that if such person is apprehended in the United Kingdom, a Secretary of State, and, if he is apprehended in a British possession, the governor of such possession, may, if satisfied that, having regard to the place where the witnesses for the prosecution and for the defence are to be found, and to all the circumstances of the case, it would be conducive to the interests of justice so to do, order such person to be tried in the part of Her Majesty's dominions in which he is apprehended, and in such case any warrant previously issued for his return shall not be executed.

34. Where a person convicted by a court in any part of Her Majesty's Application of Act to convicts, dominions of an offence committed either in Her

Majesty's dominions or elsewhere is unlawfully at large before the expiration of his sentence, each part of this Act shall apply to such person so far as is consistent with the tenor thereof, in like manner as it applies to a person accused of the like offence committed in the part of Her Majesty's dominions in which such person was convicted.

35. Where a person accused of an offence is in custody in some part Application of Act to removal of person triable in of Her Majesty's domini-ons, and the offence is one for or in respect of more than one part of Her Majesty's dominions.

which by reason of the nature thereof or of the place in which it was committed or otherwise, a person may under this Act or otherwise be tried in some other part of Her Majesty's dominions, in such case a superior court, and also, if such person is in the United Kingdom, a Secretary of State, and, if he is in a British possession, the governor of that possession, if satisfied that, having regard to the place where the witnesses for the prosecution and for the defence are to be found, and to all the circumstances of the case it would be conducive to the interests of justice so to do, may by warrant direct the removal of such offender to some other part of Her Majesty's dominions in which he can be tried, and the offender may be returned, and, if not prose-cuted or acquitted, sent back free of cost in like manner as if he were a fugitive returned in pursuance of Part One of this Act, and the war-rant were a warrant for the return of such fugitive, and the provisions of this Act shall apply accordingly.

36. It shall be lawful for Her Majesty from time to time by Order in Application of Act to foreign jurisdiction. The Honourable the Chief Justice and Judges are pleased to direct that the following be substituted for Section 24 at pages 140 to 143 of the High Court Circulars:—

24.—RULES FOR THE EXAMINATION OF CAN-DIDATES FOR THE OFFICES OF SUBORDINATE JUDGE, OF PLEADER OF THE HIGH COURT, AND OF DISTRICT PLEADER.

The Honourable the Chief Justice and Judges of Her Majesty's High Court of Judicature are pleased, in supersession of all former orders on the subject, to lay down the following rules for the examination of candidates for the offices of Subordinate Judge, of Pleader of the High Court, and of District Pleader:—

Rules.

1. An examination of candidates for the offices of Subordinate Judge and Pleader of the High Court and of candidates for the office of District Pleader will be held annually in the month of February or March, or at such other convenient time as may be determined by the High Court, on a date of which due notice will be given in the Government Gazette. There will be two standards of proficiency, the examinations for which will be held simultaneously, but with different papers for each standard. Candidates for the offices of Subordinate Judge and Pleader of the High Court

must pass the examination according to the Higher Standard; candidates for the office of District Pleader must pass the examination according to the Lower Standard.

- 2. The examinations will be conducted by a Committee appointed by the Honourable the Chief Justice and Judges of Her Majesty's High Court. Each candidate desiring admission must submit, in writing, a separate application addressed to the Registrar of the High Court, Appellate Side.
- 3. Any subject of the Empress, desirous of qualifying himself for any of the above offices, is entitled to be examined at any such examination, provided he has not been prohibited from appearing by any former Committee, and provided he shall, on or before the first day of February preceding the examination, have transmitted to the Registrar with his application satisfactory certificates to the following effect:—
 - (a) that he is a subject of the Empress, together with the place of his birth, and his exact age, which, at the date of the examination, must be more than twenty-two years,
 - (b) that he can speak, read and write, with ease and correctness, one of the vernacular languages which are used in the District Courts of the Bombay Presidency, viz. Maráthi, Gujaráti and Kánarese, and also that he has passed the Matriculation Examination of the University of Bombay,
 - (c) that he is of good moral character, dated not earlier than the 1st October immediately preceding the examination, and
 - (d) a fee of Rs. 10, for which a receipt will be furnished by the Registrar. (The fee will be returned if the candidate's certificates are not considered satisfactory. If the candidate before the beginning of the examination satisfy the Registrar that he is unavoidably prevented by sufficient reasons from presenting himself for examination, the fee will be reserved, and will be available for the next examination.)
- 4. The certificates mentioned in para. 3 may be signed by a District Judge, by the First Judge of the Court of Small Causes at Bombay, by the Principal of a College or other Institution recognised by the University of Bombay, by a Professor of the Government Law School, by the chief Judicial, Executive, or Political Officer of the British Government in a district outside the limits of the Bombay Presidency or Native State, or by the Registrar of the High Court.
- 5. A candidate who has once been admitted to the examination under these or previous rules will, subject to the provisions of Rule 13, be allowed to appear again on production only of the certificate of good moral character required under Rule 3 (c), and on payment of the fee required by Rule 3 (d).
- 6. In cases in which the eligibility of a candidate in respect of age or character appears doubtful, such inquiries as may be necessary will be made by the Registrar for consideration and decision by the Honourable the Chief Justice and Judges.

- 7. The Registrar will publish, in the Government Gazette, under the orders of the Honourable the Chief Justice and Judges, at a reasonable time before the date fixed for the examination, a list of the candidates whose applications have been admitted.
- 8. The examination will be conducted in writing (and if necessary viva voce also) in the English language, want of proficiency in which, as shown in the candidate's answers, will be held to disqualify him.
- 9. In each Standard six papers will be set to the candidates, as follows: the maximum number of marks obtainable is shown opposite each subject:—

I.—Hindu and Mahomedan Law ... 100
II.—The Laws of Civil Procedure and
Limitation 100
III.—The Law of Contracts and Torts... 100
IV.—The Law of Specific Relief, Transfer of Real Property, Mortgage and Trusts 100
V.—The Law of Evidence, Registration and Stamps. 100
VI.—Criminal and Police Laws ... 100

10. In addition to the Acts and Regulations, and the Reports of the High Courts, the following Text-books are recommended, the examiners however not being in any way confined to these Text-books in setting their questions:—

Mayne on Hindu Law and Usage. West and Buhler's Digest of Hindu Law.

Macnaghten's Principles and Precedents of Mahomedan Law.

Field on the Law of Evidence in British India. Cunningham's Commentaries on the Indian Evidence Act.

Cunningham's Commentaries on the Indian Contract Act.

Collect on Torts.

Smith's Equity Jurisprudence or Snell's Principles of Equity.

Broome's Legal Maxims.

- 11. In order to pass the examination according to either Standard, the candidate must obtain at least 30 per cent. of the marks obtainable in each paper and 60 per cent. of the aggregate number of marks obtainable in all the papers.
- 12. A list of successful candidates, arranged in the order of merit, in the Higher and Lower Standards, respectively, will be published (in the Government Gazette) under the orders of the Honourable the Chief Justice and Judges.
- 13. If the Committee are of opinion that any candidate has come up for examination without due preparation, they may prohibit his appearing at the next examination.
- 14. Each candidate who has passed the examination according to the Higher Standard will, on application and on payment of the stamp duty prescribed by law, be admitted as a Pleader of the High Court. Each candidate, who has passed the examination according to either standard, will, on application and on payment of a fee of Rs. 5, receive a sanad authorizing him to practise in the Courts of such one District of the Bombay Presidency as the Honourable the Chief Justice and Judges may think fit.

- 15. Nothing in these rules shall interfere with any rule which has been or may be made for the admission of Graduates of the University to the office of Pleader, or shall prevent the appointment, as Subordinate Judge, of any person who has already held the office of Munsif, or has passed the examination for the office of Subordinate Judge or High Court Pleader under the rules of 13th August 1869, 19th December 1876, and 2nd October 1878.
- 16. The Honourable the Chief Justice and Judges may, in consideration of the particular merits of an applicant in the public service or other special reasons, dispense with any of the rules hereinbefore prescribed as to the qualifications for admission to the examination.
- 17. These rules will come into force on and after the 1st January 1887.

TREASURY ACCOUNT DEPARTMENT.

I have the honour to communicate the following instructions in regard to the recovery of the Income Tax due by Government Pleaders on the amounts of fees drawn by them from the Government Treasuries and those received by the District Sub-Registrars as Registrars of Pársi marriages:—

1. Each Government Pleader receiving salary from Government should append to his monthly salary bill a memorandum showing the amount of fees drawn from the Treasury in the month for which the salary bill is preferred and should deduct Income Tax from his whole "salary" which according to the definition of the term in the Income Tax Act includes "fees."

- 2. Subordinate Government Pleaders do not receive any fixed salary from Government, but are paid fees in Government cases. The amount of their fees is generally small, but when the aggregate amount drawn in a month reaches the taxable limit, the Income Tax due on the whole amount of the fees drawn during the month should be recovered from the first bill presented after the limit has been reached and from all subsequent bills cashed in that month. To enable Treasury Officers to make these deductions a memorandum should be attached to each bill showing what fees have been drawn up to date in the month in which the bill is presented for payment.
- 3. The amounts of fees received by the District Sub-Registrars for the registration of marriages amongst Pársis (which they are allowed to retain without passing them through the public accounts) should be noted by them on their monthly pay bills, and tax due thereon included in the Income Tax deduction from their pay bill.
