PREFACE

This book as all those familiar with the first edition will realize is not merely a revision of the text on this subject published in 1925 by Miss Monroe and her sister, Mrs. Stratton, but a completely re-written and in many respects new and different discussion of the subject. At Miss Monroe's request the publishers made no new printing of the old text after October, 1932. So many changes had occurred in the food market by that time and so many new problems had come to the forefront that she believed a thorough-going revision was essential before more copies were made available. Unfortunately, however, Mrs. Stratton was unable to assist in the re-writing and Miss Monroe's regular work made it impossible for her unaided to make the extensive revision planned. For this reason Miss Kyrk and Mrs. Stone were asked to collaborate in the undertaking.

In its general plan this edition follows the old text; the first part deals with the market, the second with the major groups of foods found in the market. All those planning to use the book should note that it is not a book on meal planning or on food selection from the nutritive standpoint. It deals entirely with the economic aspects of food purchase. Its study, it is hoped, will suggest the way to the more economical purchase of any type of dietary and will indicate what features of the present market promote and which obstruct intelligent selection. Part II will probably be of the greater practical value to the individual buyer. The subjectmatter of Part I, however, is such that it is hoped that not only food buyers but those interested in marketing and price problems in general will find the discussion of value.

A special word should be said to those who may use the reading lists given at the end of each chapter. In many cases the supplementary readings suggested were chosen from a long list of possibilities. Their probable availability in the small library was the main basis for the selection.

In keeping with this policy of making the reading lists short, highly selected, and readily accessible only printed material easily obtainable was included. Mimeographed material, privately printed pamphlets and leaflets, were not usually included. The result was the exclusion of some excellent material dealing with current issues. The teacher should therefore acquaint herself with the organizations, governmental and private, that are putting out such material and provide the students with it.

Another responsibility that the users of this book must assume is keeping the factual data in it up-to-date. Laws, administrative rulings, and trade practices change; new studies reveal new trends. The book will not be long off the press before revisions will be in order. In spite of repeated checking corrections especially in Part II will also undoubtedly be necessary from other causes. The authors will appreciate information in regard to errors of fact that are discovered.

The authors wish finally to record their indebtedness to Rosa Biery Andrews for the able assistance given in the preparation of Part II. Without her intelligent and careful work not only would the publication have been delayed but many significant points would have been overlooked.
