Poultry Sector in India: Growth and Importance

Introduction

India's roots lie in agriculture and presently the agricultural sector accounts for about 30 per cent of the Gross Domestic Product and supports two-third of the labour force. The overriding objective of our Agricultural Price Policy is to achieve food self-sufficiency (i.e. availability of adequate food-grains from domestic production) so that the state can ensure food security for its population. Thus, although food-grains fulfil the basic need of feeding the population, focus must also be directed towards quality diet by enhancing the intake of animal proteins such as eggs and meat. Arising mainly out of this need, the poultry sector is now gaining importance in the country. Poultry products can also be an important source of export earnings for the country.

1.1 Importance of Poultry Sector:

Poultry eggs and meat are important sources of high quality protein minerals and vitamins to balance human diet. Poultry farming is also an integral part of our agricultural economy and contributes to rural development. Depending on the farm-size, layers (for eggs) and broilers (for meat) can be the main source of family income or can provide subsidary income and gainful employment to farmers throughout the year.

A notable aspect about poultry is that it is an efficient converter of low-fibre feed stuffs, unfit for human consumption, into highly nutritive animal protein food. A dozen eggs can be produced on 2 kgs. of feed. Also, poultry house litter accumulated over a period of 9-12 months, is a balanced organic fertilizer, containing 3 per cent nitrogen, 2 per

cent phosphorus and 2 per cent potash. It has been estimated that 40 birds kept on deep litter for about a year, produce about 1 tone of manure, which provide the full fertilizer needs of one hectare of paddy or maize, two hectares of sorghum or half a hectare of intensive vegetable cultivation.¹

Poultry to-day also offers promising prospects for exports. The basis for this optimism is India's entry into processing and further processing of poultry and eggs.

There is also a growing preference for ethnic chicken delicacies in international market.

1.2 Growth of Poultry Industry in India:

Commercial poultry production in India is about 30 years old. Table 1.1 gives us an idea about the growth of Poultry Industry in India. It can be observed from Table 1 that egg production which was 2881 million in 1961, increased to 23,300 million in 1990 i.e. eight times, making poultry the fastest growing sector of Indian agriculture. India is now the sixth largest producer of eggs in the world. This egg production comes from 74 million hybrid layers and 76 million desi layers.

The rearing of broilers has also made much headway, from a negligible output of 4 million in 1971 to 30 million in 1980 and 190 million in 1990. Thus while the seventies saw a spurt in egg production, in the eighties there was a manifold increase in broiler production. The nineties promise to be that of poultry processing.

However, as mentioned earlier that, although India is the world's sixth largest egg producer, it's per capita consumption (availability) is poor-less than 30 eggs per year. The situation is worse still for poultry meat — about half a kilogram. Even if we aim at a modest target like the nutritional standard, recommended by the Indian Council of Medical

Research, of consumption of 180 eggs and 11 kg meat per person, per year, the industry needs to grow at the rate of 25 per cent in the layer segment and 50 per cent in the broiler segment to attain this level of consumption standard, by the end of this century². However, this is only for domestic purposes. For exploiting the export market, the growth rate will have to be higher.

Further, egg consumption has hardly made any significant inroads in the rural areas. As a matter of fact, more than 75 per cent of eggs and meat produced are consumed by only ¼ of the population, residing in the urban areas of the country. Typically, the per capita per annum consumption of eggs in Bombay is 210 in number and in Calcutta 250 in number as against a national average of about 26. In a typically Indian village, the number is not more than 10. The availability and affordability both are limiting factors in consumption of eggs in rural areas.

The overall picture, however, that emerges from a glance of the poultry sector in India is that poultry production has made a spectacular progress evolving from a backyard venture to full-fledged commercial agro-business. This change has been made possible through a complete sophistication in the fields of production, breeding, quality feeds, pharmaceuticals, modern poultry vaccines and equipment's. Egg productivity which was of the range of 90 to 100 eggs per bird, has reached a level of 250 to 280 eggs per bird. The average live weight of broilers of 8 weeks has increased from 1 kg. to 1.7 kg.

To provide further impetus to the poultry sector, the Government removed the import of grand parent stocks from the negative list of imports and reduced the duty on their imports from 110 per cent to 30 per cent. In the 1989-90 budget, it exempted from tea, 33.33% of the profits of poultry farming and breeding. The Union Government also identified poultry development as one of the thrust areas in the 8th Five Year Plan.

1.3 State-wise Distribution of Poultry Population:

Table 1.2 presented below indicates the regional distribution of poultry population in the country.

It can be observed from Table 1.2 that the Southern region dominates the poultry scene in case of both, broilers and layers and in the Southern belt the state of Andhra Pradesh reals first in layer and broiler population. The Northern region has the second largest poultry population which is mainly concentrated in Punjab and Haryana. In the Western belt. 75 per cent of layer population and nearly 80 per cent of broiler population is concentrated in Maharashtra.

Besides, eggs being produced by hybrid layers, even desi birds add to the egg production but their productivity is of course substantially lower. Thus, while hybrid layers produce about 260 eggs per bird in one cycle, the indigenous bird hardly lays 40 eggs in one cycle. Table 1.3 below shows the egg production from hybrid layers and indigenous birds for 1994.

Thus, 88 per cent of the egg production comes from hybrid layers although their population is about half the total layer population.

Table 1.4 indicates the state-wise egg and broiler production.

From Table 1.4, it can be observed that, among all the states in India, Andhra Pradesh ranked 1st in production of eggs, followed by Tamil Nadu and Maharashtra. In fact these three states together, contribute to nearly half the egg production in the country. Again with respect to broiler production Andhra Pradesh ranks 1st, followed closely by Maharashtra. Both these states together contribute to 35 per ent of the country's broiler production. Karnataka, Punjab and West Bengal, each contribute to 8.7 per cent. Of the country's broiler production, while Tamil Nadu's contribution is 7.6 per cent.

The overall conclusions that emerge from Table 1.4 is that while Andhra Pradesh predominates in both egg production as well as broiler production, Tamil Nadu ranks second in egg production while Maharashtra ranks second in broiler production.

1.3 Poultry Management:

A state-wise analysis of the poultry sector, indicated its growth and importance in different parts of the country. In states such as Andhra Pradesh and Maharashtra, it is better developed because of higher demand for poultry products, greater availability of poultry feed ingredients, satisfactory government support and relatively better enterprenership of farmers to try and diversify their agriculture.

Poultry farms, as is well known are set up for production of eggs and poultry meat (broilers). In the case of layers, chicks reach maturity after 20 weeks when they begin to lay eggs and continue to do so for the next one year. Broilers also occupy an important place in poultry industry. The broiler production is a fast growing segment and popular segment due to minimum capital investment and space requirement and quick returns as chicks are ready for market in seven to eight weeks. In the case of broilers, the rate at

which the feed is converted into meat is an important measure of efficiency. The factors affecting efficiency of feed utilization are environmental temperature, genetic potential for growth, nutritional adequacy and diseases. The factors that affect the profitability of a broiler operation are: feed conversion ratio, live body weight, mortality and rate per kg.of live weight.

Presently, birds are reared mainly under deep litter system, cage system or controlled environment housing system.

Chicks up-to 8 weeks require 45 sq. inches of cage floor space. Growers upto 16 weeks require 54 sq. inches of cage floor space. In case of overcrowding, birds are likely to get diseases. Laying birds require 72-75 sq. inches of cage floor space.

In the deep litter system, birds are reared on floor with litter material such as rice straw, rice husk or saw dust which remains in the poultry house for a fairly long period of time. Litter is also a poor conductor of heat and on deep litter the birds feel cool in summer and warm in winter. Deep litter is a method of saving the labour to clean sheds and providing efficient room for birds.

However, the practice of housing birds in deep litter is being replaced by cage system because of certain advantages. Firstly, double the number of birds can be accommodated and hence the shed size would be reduced to half; there is vitually total elimination of deep litter diseases like Coccidiosis. Experiments have also shown that birds in cages consume less feed per day, while laying efficiency is also increased as farmers often achieve up-to 2 to 3 extra eggs hen-housed.

Besides deep litter and cage system, there are also environment controlled houses, where constant temperature can be maintained for bird's comforts. Environment control, if used, can save a lot of space for raising poultry. For example, one can almost double the number of broilers produced in an environment controlled house than in a conventional house. Environment controlled houses are especially useful during hot weather. When the temperature exceeds 30 degrees C and above. However, cost-effectiveness of environment control for commercial poultry has yet to be established.

1.4Automation In Poultry Farming:

Good poultry husbandry and management are conducive for better egg and meat production. Flocks that are continuously subjected to severe management deficiencies cannot attain their performance goals.

In India, in the early eighties, as the poultry sector gathered momentum, in some of the big farms, the need was felt to install mechanical devices, which could help to increase productivity.

The first system to be mechanized was feeding, followed by watering. To-day one sees nipple drinkers and automatic pan feeding systems on broiler farms and chain or hopper feeding systems on layer farms. With the use of automatic feed system, the feed wastage is eliminated. All birds get feed at the same time. Feeding can be put on a time clock, so that birds can get fresh feed. Automatic feeding also helps birds to convert feed better. Similarly, with automatic watering, birds have access to fresh water which contributes to their balanced growth and production. The automatic feeding system, has distinct advantages over manual feeding and watering. Manual feeding takes too long to

make feed available to birds at the same time, resulting in uneven growth, poor development of birds, less of production in layers and poor weight gain in broilers. Further, feed wastage while filling feeders is there and feed is expensive. Water can also be one of the major sources of disease transmission. If manually provided, birds can get into the water resulting in contamination.

Automatic feeding and watering systems are the two most essential features in the modernization of poultry houses. The other areas of automation are:

- (a) Drinking
- (b) dosing of disinfectants/medication
- (c) lighting
- (d) feeding
- (e) vaccination
- (f) egg collection
- (g) egg grading
- (h) control of environment
- (i) removal of litter
- (j) bird weighing
- (k) bird catching
- (1) equipment to monitor the above

Further equipment is also available for 'brooding' the chicks. The term brooding means 'to heat'. Brooding refers to the rearing of day-old-chicks to an age of 6 to 8 weeks, protecting them from chilled weather and giving them a good growing start by inducing in

protecting them from chilled weather and giving them a good growing start by inducing in them a power of adjustability to new environment. Brooding again can be natural or artifical. Natural brooding is the natural process of rearing of chicks by a hen. This method is in practise in villages where poultry is raised in the form of backyard poultry. Desi hens provide warmth to their chicks by keeping them under their wing and protect them from chilling. This method needs no investment and very little care by the farmer. This method is however, not feasible in case of large-scale operation. Further, if a hen is sick, the disease may get transmitted to the chicks.

In case of artificial brooding, chicks are reared without the hen and instead brooding equipment is resorted to. The objective of brooding equipment is to provide a suitable temperature to chicks from the day-old stage up-to the time they are able to adapt and regulate themselves to the environment. Brooding equipment exists in the form of heaters or thermometers which provide warmth to the room. Good brooder temperature results in better growth.

It can therefore be observed that automation in poultry industry has shown progress. Of-course, any automation on the farm will naturally require well-trained personal. The main constraint to automation besides high cost however is its reliability on power supply which is quite erratic. However, a one time investment in automation has the following advantages:

- a) dependence on labour is avoided;
- b) labour costs are reduced considerably;

- c) provides round the clock freach water and feed, leading to better feed intake, bird health and consequently higher production;
- d) reduction in wastage of feed and water.

1.5 Approach To Poultry Development:

As mentioned earlier, poultry farming helps to close the 'protein gap' and meet nutritional standards of the population. Poultry development is thus important to any country, whether it is a developed or a developing nation. Also, poultry development can be promoted through a wider range of strategies, depending upon the resources that a This has led to the development and existence of two types of country possesses. industries. Like in most other fields, in poultry industry too, there are two types of poultry farming. The industrialized and the primitive or the traditional which can also be known as Commercial vs backyard poultry. Industralized poultry is generally characterized by practices like environmentally controlled housing and automation while traditional poultry farming is labour-intensive and less adaptive to modern innovations. The strategy adopted by each country, depends upon its socio-economic conditions, needs and problems which vary from country to country. For example, controlled housing may be a necessity in areas where extreme climatic conditions prevail, like North America and Middle East. But in parts such as Asia where the climate is more or less equitable, this could be drain on scarce resources. Similarly, complete automation cannot be avoided in countries where human labour is in short supply and expensive. But in developing countries which are normally over populated, and where poultry farming is not just a means of mass food production but an important source of mass employment, automation can only have a

limited role, to the extent that it does not take away one's source of livelihood. The world's poultry industry thus accomodates both types of farming - the industralized and the traditional. The very sophisticated industries cater to the needs of urban areas and export markets and low capital-intensive and labour-intensive industries cater to rural markets and more importantly generate employment opportunities. Thus, we have the example of an underdeveloped nation such as Bangla Desh, which is yet at the stage of backyard farming. This village-based poultry production in Bangla Desh is considered sustainable as most of the basic feed stems from scavenging, and the feed supplements which are needed for increased production are mostly home-grown grains and by-products. Also, this strategy provides high quality protein and cash income to the rural poor familias. On the whole, most of the poultry production in Bangala Desh is from indigenous birds which have an average egg production of around 35-45 eggs per year. The other extreme example with complete automation in poultry farming is USA. In the USA, with a layer population of 240 million in 1988, there were just 1,668 farms. About 64 per cent of the birds were owned by 58 companies. It is also estimated that by 2000 AD, 80 per cent of the birds will be owned by just 25 or fewer firms. As against this, India, with a layer population of 150 million and broiler population of 210 million (1992) has I lakh poultry farms and employs nearly 7 lakh people. By the year 2000 AD, we expect the employment potential to go up to nearly 3 million. Again, in Bangla Desh, out of a total of 40 million layers, barely 200 farms are classified as commercial enterprises having flock strengths ranging from 500 to 25,000 birds, which means that the majority of the production comes from backyard farms, having less than 500 birds.³

The point that emerges from the above discussion is that — it is good to have an industry that provides food to millions, But it is, better to have an industry which does the same thing and at the same time provides employment to millions of people. It is in this content that traditional poultry farming continues to have relevance in the developing world. The China, the largest egg producing country in the world, is again an example of traditional poultry farming, where 80 per cent of the birds belong to local breeds and only 20 per cent to improved breads. The yield per layer of local eggs is merely 120 eggs per year. Thailand, is again an example where 98 per cent of the poultry-producing units are small traditional farms.

The overall picture with respect to the world poultry scene is that both industrialized as well as traditional poultry co-exist and are complementary to each other.

1.6 Approach To Poultry Development In India:

As in most of the developing world, the poultry sector in India continues to be dual in character; the backyard small farms which are the extensive small scale sector and highly labour intensive, where poultry production represents not only a source of revenue but also a saving that can be readily mobilized. In this system, poultry birds usually scavenge around the owner's house or in food-crop fields. Besides, there is also the intensive or large-scale sector, where the poultry production units are highly automated and conducted on commercial scale. However, the extensive small scale units assume importance in India in view of our socio-economic conditions viz. Providing supplementary income and employment in rural areas especially to marginal and landless farmers.

Since traditional poultry farming has relevance in India, the Government of India has placed enormous emphasis on the development of the small sector and has treated poultry farming as one of the "thrust areas" in the country's five year plans. Further, in the eighth five-year plan, the major allocation to-wards poultry was to be utilized for promoting small production units under the Integrated Rural Development programme. These small production units normally have capacities as low as 100-200 birds almost in the backyard of the entrepreneur and looked after by himself or his family. These small traditional units function in complete contract to the intensive sector which have a high degree of technical competence and have established breading farms of international standards, vaccine production units, high tech incubators, ultra-modern processing units etc. Most of these developments have come about through private enterprise.

Thus, while poultry farming has achieved technical competence in India, it is still the traditional sector which is pre-dominant. While a part of the poultry sector is organized and has assumed the dimension of industrial production in terms of scale, it is the unorganized sector which consists of thousands of small farms scattered all over the country with small scale of operation which characterize the Indian poultry scene. Even though the scale of operation of each unit is small, their collective contribution is very significant at national level to the poultry industry.

Keeping in view the fact that, traditional poultry and backyard farming which fall in the unorganized sector of the poultry industry, is still prominent in India, a study has been undertaken dealing with this aspect i.e. the role of unorganized sector in poultry development and its economics.

As mentioned earlier, in India the poultry industry is dual in character comprising of highly automated units as well as backyard farms. Another way to describe this dual characteristic is to classify the poultry sector into the 'organized sector' and the 'unorganized sector'. In this context it would perhaps be relevant to define the unorganized sector. The concept of the unorganized sector is however a debatable issue. It is sometimes defined as the sector which is not recorded under any factory legislation. It can be noted that "the establishments which employ 10 or more workers and use power and the establishment which employ 20 or more workers without using power, are required to register themselves under the Factories Act, 1948. They are hence known as factories and fall under the 'organized sector' and come under the coverage of the Annual Survey of industries. The rest of the establishments come under the "unorganized sector". The unorganized sector consists of 'unregistered units with unpublished data base.

A more meaningful use of the concept of unorganized sector is its identification with pre-capitalist structure of production while organized sector is related to capitalist structure. In this sense, the unorganized sector is comprised of own account workers, and also casual labour employed in establishments. The latter do not have access to the benefits of social security. The unorganized sector is also characterized by low capital intensity, low level of productivity, low level of formal schooling, intermediate technology, preponderance of family labour etc.⁵

As mentioned earlier, in India the traditional poultry sector still assumes importance and keeping this in mind, we have undertaken a study on "Economics of

Poultry Development and Role of Unorganized sector". Our study would be with reference to the state of Maharashtra.

Chapter II

Status of Poultry Sector In Maharashtra

It was observed in the previous chapter, that among all the states in India, Maharashtra ranked second in broiler production and was close to Andhra Pradesh which had highest broiler production. In other words, Maharashtra's contribution to the broiler production of the country was 17.09 per cent, while the contribution of Andhra Pradesh was slightly higher i.e. 17.82 per cent. Most of the other states lagged far behind these two states in broiler production. Again, with respect to egg production, compared to other states, Maharashtra was in the forefront and ranked third in the country.

From the above, the importance of Maharashtra, to the poultry sector of the economy can be understood.

2.1 Poultry Population in Maharashtra: (With special reference to Layers)

The state of Maharashtra has 40 hatcheries, out of which 34 are in the private sector while 6 are in the Government sector. Further, in the private sector, 8 are layer hatcheries while 26 are broiler hatcheries. The Department of Animal Husbandry, Government of Maharashtra, collects data on poultry population in Maharashtra. The total number of poultry households surveyed, in order to estimate the poultry population was 24870, as per the 1992 Livestock Census. In the Livestock Census, data are available for each district (taluka-wise) on total poultry birds i.e. cocks, hens and chicks. This data is available separately for deshi and improved birds. Further, as the number of layers is estimated and average number of eggs laid per layer per year collected, the annual egg production is accordingly estimated.

The Livestock Census does not clearly specify the broiler production. The production of broilers is a relatively recent phenomenon, started as a novelty in early seventies, with the introduction of hybrid strains from poultry breeding farms in other countries. Broilers are specially bred birds for table purposes and are produced on a commercial scale by hatcheries. In order to obtain the figures on estimated production of broilers, which are produced by commercial hatcheries we have referred to other sources.

2.1.1 Growth of Poultry Population In Maharashtra:

The poultry Population in Maharashtra is showing an increasing trend and can be observed from the Table I.

From Table I, it can be observed that there has been a phenomenal increase in poultry population during the period 1982 to 1992 and the increase was of the order of 39 per cent. The same was the case with layers and the layer population increased by 59 per cent during the period 1982 to 1992. The noteworthy feature regarding the poultry population is that over the years the share of deshi fowls is decreasing and that of improved birds is increasing. While the share of deshi birds in the total poultry population was 82.6 per cent in 1982, its share came down to 71 per cent in 1992. There was 174 per

cent increase in improved poultry fowl between 1982 to 1992 and 103 per cent increase in improved layers during the same period. In fact this trend can be observed since 1961 and is shown in Graph I. In 1961 while deshi birds constituted 98.32 per cent of poultry population, its share declined to 71 per cent in 1992. All this goes to say that backyard poultry raising though still common to-day is being accompanied by improved varieties.

Backyard rural poultry units still have an important role to play as these semiintensive units produce eggs at an insignificant cost. Perhaps, the cheapest egg that is
produced is the one laid in the backyard by a hen feeding on nothing specific. However,
backyard poultry does not result in as many eggs as the intensive system. While the laying
percentage is 31.24 per cent in case of deshi layers, it is 72.13 per cent in case of improved
layers. Thus while intensive poultry units can produce as much as 270 eggs per layer per
year, the village poultry units may be expected to yield, atleast 60-70 eggs per bird, per
year. But, as already mentioned, this method is still popular, because the cost of
production is virtually negligible as the birds are not fed with specially formulated feeds
for higher production.

2.1.2 District-wise Poultry Population In Maharashtra:

After looking at the growth of poultry population in Maharashtra, a look at its district-wise share would perhaps be useful, in order to observe the poultry pockets of the state.

In Table II we have shown the district-wise distribution of poultry fowls while Table III shows the percentage share of each district in the state total.

From Table III, it can be observed that maximum poultry concentration is in Pune district and is of the order of 12.59 per cent. Followed by Pune is Ahmednagar with a relatively less poultry population and accounts for 7.89 per cent of the state total. Nasik, Sangli and Solapur account for 6 to 7 per cent of the state's poultry fowls. In most other districts, the poultry population is less than 6 per cent.

In case of layer population again, Pune's share is relatively higher and accounts for 16.22 per cent of the layer population in the state. The other districts i.e., Satara, Sangli, Solapur which follow Pune have a layer population ranging between 8 to 9 per cent. In most other districts it is 3 per cent or less. The same trend is observed with respect to deshi and improved layers.

Therefore the main conclusion that emerges from the district-wise data on poultry population in Maharashtra is that Pune has a maximum share in the poultry sector of the state and its share is significantly higher than that in other districts.

2.1.3 Egg Production In Maharashtra State:

As mentioned earlier, Maharashtra rank's third in the country's egg production and almost 11 per cent of the egg production of the economy comes from Maharashtra.

Table IV indicates the egg production in Maharashtra since the last eight years.

From the above table it can be observed that the total egg production has increased by 45 per cent. While the production of deshi eggs increased by 28 per cent, that of improved eggs increased by 62 per cent. As we have already discussed, this is because improved layers have a much higher laying percentage than deshi birds. Also, the share of deshi eggs which was 51 per cent in total egg production in 1988-89, came down to 46 per cent in 1995-96.

The increasing trend in egg production by improved layers can also be observed in Graph II. While the contribution from deshi layers was 45.6 per cent, that of improved birds was 54.4 per cent in 1995-96.

2.2.1 District-wise Egg Production in Maharashtra State:

After studying the contribution of Maharashtra state to the egg production of the economy, the district-wise study on egg production would enable us to observe the main egg producing districts. Of-course, we have already observed the district-wise poultry population in Table II and III. Naturally, the districts having higher layer population would be the major producers of eggs. This can be observed from Table V.

From Table V, it can be observed that out of a total production of 26028.77 eggs in Maharashtra in 1995-96 the share of Pune region is 14950.14 eggs which means that Pune again contributes 57.4 per cent to the state's egg production. Again in Pune region, it is Pune district which has maximum production of eggs. Pune district alone contributes 20.27 per cent to the state's egg production while its share in the Pune region is 35.3 per cent, followed by Sangli which has a relatively lower share of 23.2 per cent.

After Pune region, it can be observed that Nasik region ranks second in egg production and contributes to 16 per cent of the state's egg production. Although Nasik again occupies the second rank, its production, as observed is much lower than that of Pune region. The contribution of Mumbai region is 11 per cent while Aurangabad and Nagpur region each contribute 6 per cent to egg production. Amravati region has the lowest share and only 3.2 per cent of the egg production comes from this region.

Out of the total layers in the state, 66 per cent are deshi and they contribute to 45.6 per cent of egg production. The improved birds which are 34 per cent i.e. half the population of deshi birds contribute to 54.4 per cent of the eggs.

2.2 Broiler Production In Maharashtra:

The contribution of broilers to the poultry sector has been rising more rapidly than that from eggs for the economy as a whole. The production of broilers which was virtually negligible in 1971 (about 4 million) increased to 275 million in 1994 and the state of Maharashtra has a major role to play in the contribution towards of broiler production.

As we already know Andhra Pradesh and Maharashtra are the two main states in the country where broiler production is concentrated. Both the states have a parent-stock of 465 million.

As in the case of egg production, even in case of broiler production, Pune region seems to have maximum concentration of broilers. While the district-wise data on broiler production is not available, the data is available region wise and is presented in Table VI.

Table VI indicates that broiler production is concentrated in Pune and Bombay.

Perhaps, this is true because almost the entire stock of broilers produced are consumed in cities and towns, leaving the vast demand in rural areas to be met by desi birds.

2.3 Poultry Population In Pune District:

In the preceding sections we studied the share of Maharashtra in the poultry sector of the economy and observed that its contribution is quite significant. Further, in terms of layers and broilers Pune district in Maharashtra has a leading share. Again in Pune district, layer and broiler farms are concentrated only in a few talukas.

Table VII indicates the poultry population of Pune District as per 1992 livestock census. It can be observed that Mawal taluka has maximum poultry population and 28.4 per cent of Pune's poultry is in Mawal taluka. Next in rank is Haveli which has a share of 15.50 percent. In case of a few talukas such as Indapur, Daund, Junnar and Purandhar, the share ranged between 5 to 9 per cent while in case of other talukas it was less than 3 per cent.

Recognizing the importance of poultry in Maharashtra, a study has been undertaken to study the economic viability of these poultry units. The sample of our study is focussed on Pune District, which as we observed is a major poultry pocket in Maharashtra.

Chapter III

Objectives & Methodology

In the previous two chapters we observed the importance of the poultry sector in the economy and also Maharashtra's share in it. Further, the poultry sector, as already discussed comprises of organized and unorganized units. While the organized sector consists mostly of large-sized urban farms making use of highly automated equipment and assuming the dimension of industrial production in terms of scale, the unorganized sector comprises of thousands of small farms with small scale of operation and using traditional technology.

In a country like India, in view of it's socio-economic conditions, traditional poultry still has a role to play and cannot be easily replaced by industrial farming. This is because in developing economies, poultry farming is not just a means of mass food production, but an important source of mass employment and hence automation can have only a limited role to play. Hence in such economies, local breeds, low cost feed formulations using locally grown ingredients and low cost housing of birds is preferred.

Recognizing the importance of traditional poultry in India, an attempt has been made to study the economics of poultry units belonging to the unorganized sector using mainly traditional technology. The study is related to the state of Maharashtra.

It must however be noted in the very beginning, that the study initially aimed at covering both layer and broiler farms. However, during field visits, difficulty was observed in obtaining data for layer farms, while data on broiler farms was more readily available. The present study thus concentrates more on broiler farming, while layer farming is only touched upon on the basis of the very limited data available.

3.1 Objectives

More specifically, the broad objectives of our study are:

- 1) To assess the economic viability of the broiler and layer units,
- 2) To estimate the cost of production of broilers and eggs,
- 3) To estimate the reasons for losses, if any,
- 4) To recommend implications for policy.

3.2 Methodology for Broiler Farming:

In what follows, we have outlined the method used by us for assessing the economic viability of broiler farms.

3.2.1 Selection of Districts for Sample:

It was observed in the previous chapter that in Maharashtra, total poultry population was highest in Pune district. Further, in Pune district, the poultry population was observed to be maximum in Mawal taluka (28.4 percent), followed by Haveli (15.5 percent). In the other talukas of Pune district, the share of the poultry population was relatively low.

In order to study the economics of broiler farming, we therefore selected Pune district and the talukas selected were Mawal and Haveli. Most of the poultry farms were however in Mawal taluka.

3.2.2 Sample Size:

As mentioned earlier, our study is related to the unorganized sector and hence the broiler farmers were relatively small. Our sample consisted of 48 units, mostly concentrated in Mawal taluka and the flock size in each unit ranged between 50 to 5000

birds. The distribution of sample according to flock size can be observed from the following table:

From Table 3.1, it can be observed that among the sample units, more than half the units were in the flock six of 500 to 1499 birds.

3.2.3 System of Rearing Broilers:

There are two systems of rearing broilers. They are the "all-in-all-out" system and the "relay" system. In our sample all the units were reared in the all-in-all-out system of the deep litter type wherein one batch was reared together until the eighth week (one cycle) and a new flock of fresh chickens were to be introduced only after disposing off the previous batch, already reared. In the relay system, the broiler farms maintain several age groups of birds on the farm at the same time. The birds of different age groups have to be kept in different sheds. This is to prevent infection from travelling from the older to the young birds, which might be possible, if mixed age groups are housed in the same shed. The advantage of this method is that the farmer is assured of a more regular flow of income.

However, as mentioned above, all units in our sample followed the all-in-all-out system. Although, this method assures income only after a gap of two months, it saves the farmer from maintaining different sheds. In the all-in-all-out system, normally 5 batches i.e. 5 cycles of birds are reared annually, after which the poultry shed is to be completely disinfected and left vacant for two months before stocking a fresh batch of birds

3.2.4 Methodology for Data Analysis:.

For working out the economics of broiler units, costs incurred were grouped into fixed costs and variable costs.

- 1) Fixed Costs: Fixed costs included depreciation on building and equipment and interest on capital.
- a) Depreciation of fixed assets: Poultry farms with deep litter system were constructed with kutcha floors, brick walls, and thatched roofs. Some farms used asbestos sheets for roofs. The side walls of the poultry shed was covered with wire mesh. Paddy husk was normally used by the farmers as litter. The life of a poultry shed was taken to be 15 years. The depreciation rate was therefore taken to be 6.7 percent on these structures.
- b) <u>Depreciation on Equipment</u>: The equipment in poultry farms comprised of feeders for birds, waterers, brooders, debeakers and lanterns. The life of these was taken to be 5 years and depreciation was charged at 20 percent per annum.
- c) <u>Interest on fixed assets and working capital</u>: Interest on fixed assets and working capital for purchase
 - of birds was charged at the rate of 12 percent as per NABARD guidelines

- 2) Variable Costs: Variable costs include operational expenses like cost of Day-Old_Chick (DOC), feed, litter, veterinary aid, maintenance of shed, electricity charges etc.
- 3) Gross Income: The gross income from the broiler farms consisted of income from the sale of a broiler and income from the sale of gunny bags and manure.

Data on fixed and variable costs as well as gross income was collected from the sample farms by means of a questionnaire addressed to them.

Economic Viability of Broiler Farms:

In order to derive the net income of the broiler farm, the data on costs as well as gross income have been tabulated in the following manner:

Cost of Rearing Broilers, Gross Receipts and Net Income For Per Bird, Per Cycle

Particulars:

A. Variable Costs:

- 1) Cost of Day-Old-Chick
- 2) Cost of feed
- 3) Veterinary Aid
- 4) Electricity charges
- 5) Labour charges
- 6) Litter Charges
- 7) Miscellaneous expenses

TOTAL VARIABLE COSTS

B. Fixed Cost:

1) Depreciation (shed and equipment)

2) Interest on capital investment

TOTAL FIXED COST

C. Gross Receipts:

1) Sale of birds

2) Sale of gunny bags

3) Sale of manure

TOTAL GROSS RECEIPTS

D. Net Income: [C-(A+B)]

Gross receipts-Total Costs =Net Income

By tabulating the data in the above format, we obtained the net income per bird, per cycle. The field survey was conducted by us in June 1997 and the data collected by us was related to the most recent broiler cycle that had been completed.

Ofcourse a positive net income would indicate that the broiler business is a profitable one, while a negative income per bird indicates that the business is a loss making one. As there are normally 5 broiler cycles in a year in the all-in-all-out system, merely multiplying the net income earned in a cycle by 5 would give us only an approximate annual income as there are frequent fluctuations in prices of feed and also the sale price of broilers. Further, in a particular cycle the entire flock may get diseased and hence in this case there may be no income to the broiler farmer.

Cost of Production Per Broiler:

The cost of production of a broiler was arrived by the following formula:

 $Total \cos t \text{ of production-Income from manure}$ $Cost \text{ of production per broiler} = \frac{per \text{ bird}}{Weight \text{ of bird}}$

The cost of production per kg. of broiler can thus be compared to the sale price per kg.

3.3 Methodology for Layer Farming:

In order to study the economic viability of layer farming, we have adopted a methodology analogous to that adopted for studying broiler farms. However, our study on layer farming was subject to certain limitations, which we have outlined below.

3.3.1 Limitations on sample size:

As mentioned earlier, although a questionnaire was prepared by us to be addressed to the layer farmers, sample farms could not be obtained from Pune district. A number of layer farms had closed down, while in some farms it was quarantine period. It also appeared to us that farmer's preference is more for broiler farming than rearing layers for eggs. This is because in layer farming, the chicks reach maturity only after 20 weeks when they begin to lay eggs and continue to do so for the next one year. Hence during 20 weeks or for 5 months, the layer farmer does not receive any income. Also, since the birds continue to lay eggs for one year or so, incase of mortality of the flock due to disease, the farmer would lose the entire income he expects to get in the year from his flock, assuming ofcourse that he maintains only one cycle at a time (all-in-all-out system). A fresh flock would mean that he has to wait again for 5 months to get returns. In case of broilers however, there are quick returns to growers, as chicks are ready for market in seven to eight weeks. Perhaps, taking these factors into consideration, poultry farmers, at least in the unorganized sector, prefer broiler farming as compared to layer farming.

Further, studiesⁱ have also shown that production of broilers are comparatively more advantageous than producing eggs. In case of broiler farming, the NABARD study

showed that the farmer was able to cover his fixed cost in roughly one and a half year, while in case of layers (under the cage system) it took atleast three years. In case of deep litter system it was much more. Also, income per bird for the broiler farmers was above 100 percent that of the efficient layer farmers.

Again, the steep growth in broiler production is also reflected in the increased growth of broiler hatcheries in the country from 77 in 1980 to 281 in 1993, while the layer hatcheries number went up limitedly from 97 to 113 during the same time. Similarly, during this period, broiler parent stock in production went up by almost 700 percent, while layer parents went up by mere 33 percentⁱⁱ In Mawal taluka, as per the 1992 Livestock census, out of the total chick population, 91.2 percent were for meat and only 8.8 percent was for eggs.

Perhaps, from the above discussion, the farmer's bias towards broiler farming, rather than layer farming can be justified. Only, a very limited study on layer farms has therefore been undertaken.

3.3.2 Methodology:

As already mentioned, data related to unorganized sector, was not available, in Mawal or Haveli talukas of Pune district. Hence, we addressed our questionnaire to a poultry farmer, who was operating a huge layer farm with a capacity of one lakh birds. His farm however constituted a part of the organized sector, which is not the main theme of our study. However, even analysing the data sheet of a big poultry farmer could be useful to our study, as we can understand the economics of big poultry farms, the problems faced by them and the implications, if any , for the unorganized sector.

For the layer farm, to which we addressed our questionnaire, we tabulated the data in a similar manner as that tabulated for broiler farms. Accordingly, the net income for the layer farm was obtained.

Cost

Further we also calculated the cost of production per egg by the following formula:

Cost of production per egg =
$$\frac{Total\ cost - Income\ from\ culls,\ gunnybags,\ and\ manure}{Number\ of\ eggs\ produced}$$

Comparison of cost of production per egg, with its sale price gives us an idea on the margin earned per egg.

We thus used the above methodology, to study the economic viability of poultry farms.

Chapter IV

Economics of Broiler Farming

A broiler is a young chicken, usually six to eight weeks of age of either sex, that is tender meat with soft smooth skin and provides a good source of protein to the diet.

Broiler farming occupies an important place in poultry industry. The broiler industry is a fast growing and popular segment of poultry industry due to minimum capital investment and space requirement, easy and early start and quick return i.e. within 6-8 weeks.

4.1 Broiler Management:

The factors that determine success of a broiler operation are, choice of breed, quality of feed, efficiency of management and efficiency of marketing. A good strain should be selected as it will have good feed conversion, livability and fast growth. The broiler house should be constructed in a manner which provides good ventilation. Each bird in the deep litter type requires atleast one square feet of floor space as overcrowding results in poor performance, mortality and stress. The birds should also be protected from wind drafts. Further, adequate feeding space should be provided as insufficient feeding space restricts growth and impairs quality of the meat. The water should also be disinfected. Routine culling should be practiced and sick birds should be removed as they are a risk to the entire flock. Similarly dead birds should be removed immediately as they can spread diseases. It is also necessary to maintain the correct temperature as low temperature will result in high feed consumption while high temperatures will reduce feed intake and growth rate.

Finally, it has to be remembered that to keep the flock healthy and prevent birds from diseases a vaccination schedule should be followed. Vaccination is one of the most effective ways of preventing specific diseases by building up immunity in the birds. Further, in case of certain diseases such as Ranikhet and fowl pox against which no treatment is available, vaccination offers the only way for the farmer to protect his birds. Besides vaccination, the cleaning of poultry houses between the removal of a flock and the introduction of another flock is the most effective way of disease prevention and control. Disinfection, which is the process of destroying disease producing viruses, bacteria and fungi by various chemicals is very necessary in poultry farms. At times disinfestation which aims at destroying parasites may also be required.

Lack of efficient broiler management would result in high mortality. High mortality could be due to faulty brooding management, infections caused by bacteria and viruses and also feed deficiency. Mortality could also be due to extreme climatic stresses and disease outbreak, if any.

While efficient broiler management is the key to the success of broiler farming, other factors such as feed conversion ratio, live body weight and rate per kg live weight are equally important to make the broiler venture a successful one.

4.2 Economic Viability of Broiler Units:

The rearing of broilers in India, which was started in the 1970's made significant progress due to various factors:

- (a) Highly efficient broiler breeds, with high feed conversion ratios being available,
- (b) A crop of broiler takes hardly two months, hence there is a fast turnover of business,

(c) As chicken meat is often cheaper than other meat such as mutton and also fish, the consumption of broilers is popular, especially in cities and towns and broiler units have come up mainly near urban areas.

The economic viability of a broiler unit will depend upon the cost of production of the broiler as well the sale price. Getting a better return on the end product will also help to improve the profitability of the broiler farm. While cost of production depends mainly on feed costs along with other overheads, the sale price largely depends upon the market forces. The sale price is determined by demand and supply conditions and does not take the cost of production into consideration. It must however be noted here, that the cost of feed, day old chick and sale price of broiler are outside his control, but a good crop of broiler with high feed conversion ratio and low mortality depends largely on sound management practices. Even in case of same breed of birds and quality of feed, the feed conversion ratio may differ and in order to obtain higher live weight of the bird proper care must be ensured.

4.3 Economics of Broiler Units as Observed In the Sample Size:

As we mentioned in Chapter III, we obtained a sample of 48 broiler farms which were classified into 8 groups according to size. We then studied the economics of these units.

In Table 4.1 we have shown the total costs (i.e. the different elements of variable and fixed costs), the gross receipts and the net profit obtained by the poultry farmers having different farm sizes.

4.3.1 Total Costs:

The data in Table 4.1 indicate that in category I, which has the smallest farms ranging in size from 50 to 499 birds, the total cost was the highest. The variable cost per bird was Rs 4 to Rs 7 higher in this category as compared to farms of bigger size farms. In category V where farms were in the size group 2000-2499 birds, the variable as well as fixed costs seemed lowest and the total cost per bird was Rs 46.91. In all other farms the costs ranged between Rs 46.91 per bird and Rs 56.34 per bird.

Comparing category 1 (having highest cost) with category V (having lowest costs), it can be observed that while both groups have more or less same feed costs, the main reason for this difference was the labour cost. In case of category V while labour cost is barely Rs 0.95 per bird, it is as high as Rs 7.90 in case of category I. This very high labour cost was observed especially, in case of very small farms having barely 50 birds. In our sample, we had one small farm having 50 birds and the labour cost was reported to be Rs 18 per bird. As the farm size increased, the labour cost per bird seemed to reduce and was lowest, barely Rs 0.52 in case of farms having relatively huge flock size of as much as 5000 birds.

However, the more important point to be noted is that out of total variable cost which constitutes 93 to 96 percent of total cost, it is the cost of feed which is the single largest factor in the cost of producing a broiler. It can be observed from Table 4.1, that the cost of feed formed half the cost, or a little more in case of all farms. However, there are often variations in the purchase price of feed and the feed cost per bird across farms. While the feed cost was Rs. 25 per bird in category I and V, it was Rs 29.15 per bird in

category VI. The main reason for this difference in cost was because while most of the farms purchased feed at the rate of Rs 7 to Rs 8 per kg, we observed in our sample that there were certain farms which purchased feed at a low rate of Rs 6 per kg, while certain other farms which purchased feed at Rs 9.20 per kg. While feed prices do fluctuate, it is also true that feed prices do differ as different feeds have different formulations. Also at times farmers use locally available cheaper feed ingredients. However, it was nowhere observed in our study, that in case of costly feeds, the weight gained by the bird was higher. Hence since feed costs varied across farms and in some cases by as much as Rs. 3 per kg. there were naturally differences in total variable costs among different farm sizes.

Almost all farms purchased Day Old Chicks for Rs. 12 to Rs 13. In the selection of the chick, the critical factor should be quality and not cost. The poorer quality, lower yielding birds require as much labour, effort and other inputs as the high yielding ones. The purchase of a cheap chick is therefore not a method of reducing the cost of production. Infact, a poor quality breed may result in a low feed conversion or even mortality. The cost of Day Old Chick was around 26 percent of total costs in case of most farms.

It thus appears, that the cost of the feed and the bird together account for nearly 80 percent of the total cost. Infact, the .variable costs account for the main costs in broiler farming and constitute 93 to 96 percent of total costs. Veterinary costs range between 3 to 5 percent in all farm size groups. Since all the broiler farms surveyed by us were of the deep litter type, naturally litter material such as saw dust, paddy husk, straw etc. entailed expenses. This was normally 2 to 3 percent of total costs.

The fixed costs formed barely 4 to 6 percent of the total costs. Interest on capital constituted the major portion of fixed cost. The data collected by us, indicated that poultry farmers used own land and own capital for the construction of poultry sheds. The cost of construction of shed for each poultry farmer varied widely depending upon quality of construction, size and ofcourse year of construction. The poultry farmers had hardly automated their farms and hence equipment cost was negligible.

The overall conclusions related to the cost incurred by poultry farmers, indicates that out of total costs, the variable cost constituted 93 to 96 percent and hence had a predominant share in total costs. Again, out of total variable cost, it was the feed cost which

was the major item, followed by the cost of the bird. In case of fixed costs, it was the interest on capital which was the main item of expenditure.

It can be observed from Table 4.1 that per bird variable costs were highest in case of farms in the smallest size groups (i.e. category I) and was of the order of Rs 52.74 per bird. Infact, in case of one sample farm, which had only 50 birds, the variable cost per bird worked out to be Rs 66.60 per bird. This was because, as mentioned earlier, due to the high labour costs that it was incurring. In case of other farms, however, the variable costs ranged between Rs 45 to Rs 48 per bird.

4.3.2 Gross Receipts:

As already discussed, the income from a broiler farm is obtained from three sources viz. (1) from the sale of birds, (2) from the sale of gunny bags and (3) from sale of manure.

Again, the income from the sale of birds depended mainly on two factors i.e. the sale price of the bird and the weight of the bird. A higher live weight would ofcourse fetch a higher income as compared to a bird with a lower feed conversion. Further, if the birds have a high mortality rate to that extent their income is lowered. In our sample it was observed that most of the birds had mortality ranging around 5 percent. Sometimes farmers place more chicks than the shed can comfortably hold and this results in high, unhealthy stocking density i.e. overcrowding. If not set right, this can result in early mortality of birds. Further, despite all possible precautions, diseases do occur. Hence, the farmer must be alert to detect the first symptoms of a disease for its timely treatment. However,

individual treatment of a bird is rarely economical and prevention of diseases through proper health care should be the main aim of a poultry farmer.

The data presented in Table 4.1 indicate that the income obtained from the poultry farms ranged between Rs 55.5 per bird to Rs 61.84 per bird. The main item of income for the broiler farmer was ofcourse from the sale of the bird. Obviously, a higher sale price, which is determined mainly by demand and supply conditions in the market, would fetch a larger income to the poultry farmer. In our sample it was observed that the sale price of a live bird ranged between Rs 34 to Rs 40 per kg. This was the farm gate price prevailing during the period of our survey i.e. June-July 1977.

Regarding weight of the bird, it was observed that most often the weight of the live bird ranged between 1.5 to 1.7 kg. It was nowhere observed in our sample, that large farms have a higher feed conversion as compared to small farms. Overall, our data revealed that both large and small farms have similar feed conversion ratios and achieved similar sale prices for their birds. The receipts obtained from sale of birds constituted 95 to 96 percent of the gross receipts of the poultry farm.

Besides, the farmer also obtained a small portion of his income from by- products of poultry business i.e. manure. Poultry droppings can be used to enhance the productivity of agricultural lands. This is particularly true because the birds are fed on feeds rich in different elements. The nutrient content of poultry manure is known to be richer than farmyard manure. In the deep litter system, it was observed that 33 to 40 birds can produce about one tonne of manure in one year. The poultry farmers in our sample indicated that they sold one tonne of manure for Rs 400. This manure which was a by product of rearing

broilers thus proved to be an additional source of income. Further, the poultry feed purchased by farmers comes in gunny bags and the empty gunny bags again have a resale price. These gunny bags can thus be disposed off and bring some marginal income to the farmer.

The data collected from the sample farms indicated that the income from sale of gunny bags constituted 1 percent of income, while that from sale of manure constituted 3 percent of gross receipts.

4.3.3 Net Profit in Broiler Farming:

We have already discussed the cost (i.e. variable and fixed) involved in broiler rearing. Further, we also observed the gross receipts earned by the poultry farmer through different sources, the main one ofcourse being from the sale of the bird.

The net profit to the poultry farmer would naturally be the total costs deducted from the total receipts. The net profit earned by different farms is shown in Table4.1. The net profit earned in different size groups of farms varied widely ,between Rs 2.68 per bird to Rs 11.34 per bird. In our sample of 48 farms, only 3 farms incurred losses. One farm was operating at a very low level of production with a farm size of only 50 birds. This farm as mentioned earlier, had very high labour costs of Rs 18 per bird as compared to hardly Rs 1 to Rs 3 in the case of farms having 500 or more birds. These high labour costs resulted in a loss of as much as Rs 10.66 to the farmer. In another instance, a poultry farmer with a flock size of 1000 birds made losses of Rs 0.90 per bird. While costs incurred by the farmer were reasonable and in tune with what other farmers incurred, this farmer reported a relatively low live weight of 1.4 kg (while in case of most other farms

the live weight of the bird was 1.5 to 1.6 kg) and also a relatively low sale price of Rs 34 per kg. The income earned by the farmer was thus only Rs 47.78 per bird against the group average of Rs 59.04 per bird. Obviously, this resulted in losses to the farmer. In case of this farm it was observed that the floor space per bird was 0.8 sq. feet, while in case of most other farms the birds had atleast 1 sq. feet of floor space. Even a slight overcrowding of birds can cause stress related problems, impairing its growth.

However, most other poultry farmers made profits. The data reveal that in category III, IV and V the farmers earned as much as Rs 11.3 per bird. We could perhaps say that that the performance of category III is best, because out of our sample of 48 farms, 14 farms fall in this category. A number of farms earned more than Rs 11 per bird and infact in case of one farm, the net profit per bird was Rs 21.64 per bird. Two farms in this category earned Rs 18 per bird and only one farm showed losses as it showed low feed conversion. (Appendix A.4.6)

In case of category IV and V only two farms were found maintaining the flock size 1500-1999, and 2000-2499 respectively. Perhaps, more farms in this flock size showing similar performance would strengthen our conclusions.

In case of category VI having flock size 2500-2999 birds, net profits seemed low. All farms in this category purchased feed at a cost of Rs 9.20 (while in case of other farms it ranged between Rs 6 to Rs8 per kg). This high feed cost naturally escalated the variable costs, while there was no observation regarding birds in this category gaining more weight. Infact the reverse situation was observed, where birds in this category achieved a weight of 1.4kg to 1.5 kg while others normally weighed 1.6 kg to 1.7 kg.

Although quality of feed does play an important role in the weight gain of the bird, other factors such as the temperature, stress, etc. are also responsible for the weight of the bird. The lower profits were made by the farm due to high feed costs and lower feed conversion ratios.

Again, relatively large farm sizes having birds ranging above 3000 showed profits of Rs 8 per bird.

The overall conclusion from our sample size showed that smallest farms had lowest net profits. The net profit increased with farm size upto a limit of maintaining 1500 birds. Thereby the net profits remained constant but showed a sharp fall in case of farms maintaining between 2500-2999 birds. The net profits again increased for farms maintaining 3000 to 5000 birds.

4.3.4 Conclusions:

From the previous sections, we observed the economics of broiler farming. While arriving at the conclusions of our study, we have to keep in mind that these conclusions are based on a small survey covering 48 farms in mainly Mawal taluka of Pune district. Further, the study observed only one broiler cycle and therefore estimating the farmer's income annually from one broiler cycle may not give accurate results. This is because poultry production is a delicate business, dealing with tender birds and profitability depends upon several factors. Hence the economic viability of poultry production is always an element of uncertainty. While a farmer may have a good crop in one cycle, his flock may get diseased in another, thus disrupting his flow of income. Infact, during our field survey, a number of poultry farms had closed down for disinfection and general

cleanliness, as flocks had been diseased. Ofcourse, this risk applies not only to poultry farming, but to any other crop as there are often instances of low yield or damage to the entire harvest due to bad weather, unseasonal rainfall or infestation by pests. Yet, there are certain features which are unique to poultry. For example, poultry birds require the same labour to feed them everyday as they are very sensitive to change in labour which may cause loss of appetite and hence impair growth. Further, birds being a biological production can be exposed to stress and the maximum expression of stress results in mortality from fright of shock, even though no injury is involved. The process of poultry farming may actually induce stress in birds. For example, when birds move from the brooder house to growing pens, they may be under stress. Again, stress may be induced due to reaction from vaccination, overcrowding, noise ,strangers, debeaking etc. Stress may be a physical, chemical or emotional factor and can only be partially corrected by medical aid.

To recapitulate, the profitability on poultry farms like any other business depends upon cost of production and sale price of birds. Among the elements of cost, the main cost is that of feed and the day old chick, which together constitute 85 percent of the variable costs, while labour, litter, vaccination etc. constitute the rest. The sale price of the broiler depends upon demand and supply and does not take into account the cost of production. The demand is subject to fluctuations due to various reasons such as:

- 1) Climate: The demand tends to drop in summer and increase in cooler months.
- 2) Religious festivals: During certain religious, there may be a fall in demand, as people tend to abstain from non-vegetarian diet, thus lowering the price.

3) Availability of other sources of meat and fish and their price: If other sources of meat and fish are available and are cheap, the demand for broilers may fall.

Even a small change in the per kg cost of the broiler can change his net income. Thus while factors such as cost of feed (the main input) and sale price are often out of his control, good management and a proper marketing strategy may help the farmer to improve his profitability. Our sample showed that farmers mostly sold their broilers to local traders. If middlemen's margins could be reduced, the farmer could get a better return.

The main conclusion that emerged from our study is that broiler farming is an economically viable business. Farmers operating in all size groups made profits, although profits were lower in small sized farms having 200 birds or so. Farms maintaining a flock size of 1000 to 2499 birds showed maximum profits while profitability was a little lower in case of relatively bigger farms having 3000 to 5000 birds. Thus our study does not conclude that largest size farms in the sample had maximum profits with lowest costs and highest receipts.

4.4 Cost of Production Per Kg of Broiler:

The cost of production per kg of broiler was arrived at by deducting the income from manure and gunny bags per broiler, from the total cost of production per broiler, and dividing this figure by the weight of the bird. In other words, the following formula was used:

Cost of Production per kg of broiler = (Total cost of production per bird - income

from manure and gunny bag) / (Weight of
the bird.)

From the data collected by us we have computed the cost of production per kg of broiler for each farm category. This can be observed from Table 4.2:

The data in Table 4.2 indicates that the smallest size farms had the highest cost of production of a broiler which was Rs 33.11 per kg. However, in case of farms having 2000 –2499 birds, the cost of production per kg of broiler, on an average was Rs 27.72 per kg. In case of one sample farm (Appendix A.4.7) the cost of production was Rs 24.88 per kg which seemed to be the lowest in the entire sample. Bigger farms with a capacity of 3000 to 5000 birds had a cost of production of Rs 30 to Rs 31 per kg.

Taking an average of all farms with flock size ranging from as low as 50 birds to as high as 5000 birds indicates that the cost of production of a broiler is Rs 30.5 per kg

while its sale price is Rs 38 per kg. This suggests that production of broilers on the whole is a profitable venture.

Chapter V Economics of Layer Farming

We have already discussed in Chapter II, that out of the total layer population in Maharashtra, as revealed in the 1992 Livestock Census, 72.5 percent constitute deshi layers, while only 27.5 constitute improved varieties. The share of deshi layers is therefore pre-dominant in the total layer population. However, the share of improved varieties is gradually gaining importance, if we consider that in1961, layer population of improved varieties constituted only 1.68 percent of total layers and hence poultry farming for the purpose of egg production came only from deshi birds. However, since 1961, the share of improved varieties is slowly making a way for egg production. As we already know, the laying percentage in case of improved varieties is far higher than that of deshi breeds and while improved layers have a laying percentage of 72.13, in case of deshi birds, the laying percentage is 30 percent.

5-1 Egg production from deshi layers:

For a long time to come, the traditional sector (where deshi layers are used for egg production) is likely to represent the largest part of poultry production. This would be so, despite their very poor level of performance as regards laying and growth.

The traditional sector is mostly maintained at the backyard of the farmer and in this form of production, the farmer maintains small flocks that wander freely, scavenging for their food and also some home grown inputs. They lay afew eggs, and these are smaller in size than eggs from the commercial sector. The expenditure involved in rearing these birds is virtually nil, and hence the sale of these eggs entails a net income to the family. In many developing countries, this system is still responsible for a large

proportion of the eggs that are produced. Infact, in China, the largest egg producing country in the world, 80 percent of the birds belong to local breeds and only 20 percent are improved breeds. The 'local breeds yield just about 120 eggs but yet have relevance in the present day in view of the subsidary income and employment opportunities that they generate to the rural farm sector.

The overall conclusion seems to be that deshi birds are playing a dominant role in egg production and the cost involved in rearing them is negligible. This is because the birds do not feed on concentrated feed formulations, nor are they vaccinated against any diseases. The eggs produced by these birds, although smaller in size and fewer in number, generate a net income to the layer farmer. No wonder rural poultry is here to stay.

5.2 Egg production from commercial and semi-commercial farms:

While deshi layers are contributing to egg production in their own way, improved varieties such as White Leghorn, Australorp, Rhode Islands Red etc. are often maintained in commercial farms for higher egg production. In case of these breeds, the birds cannot fend for themselves and feed cannot be confined to home grown inputs. These birds require well formulated and concentrated nutritional feeds at regular intervals, without which they would record a drop in egg production. Further, these birds have to also be vaccinated for disease protection. Infact, layers have a vaccination schedule, where the birds, like broilers are vaccinated for Marek's disease immediately at the day old stage. Besides, vaccination schedule upto 16-18 weeks has to be administered, failing which, the birds are likely to get infected and there would be a drop in egg production. Infact, it could also lead to mortality. Any drop in egg production, can adversely affect the

economics of commercial poultry operation. Besides nutritional balance in feed and disease protection, other practises such as adequate lighting, debeaking, culling and sanitary measures should be administered. Scientific management would improve layer performance and contribute to increase in egg production. Any increase in egg production would obviously increase the profitability of the farm.

5.2.1 Economic viability of layer farms:

As we already mentioned in chapter III, our study was confined to Mawal taluka in Pune district. In this taluka, we were unable to find any layer farms in the unorganized sector. The Livestock census of 1992 indicated that 70 percent of the chicks (below 5 months) for egg purposes were deshi birds whereas 99.8 percent of the chicks for meat purposes were improved varieties. Possibly, this could be the reason for the availability of broiler samples, which were more easily obtained as to the virtual non-availability of layer farms.

However, during the field visit we came across a big layer farmer maintaining a flock of as much as 1 lakh layers of improved varieties. This farm of course belonged to the organized sector. The study of organized sector farms is not the main theme of our study, but nevertheless we collected the information available from this farm. The study of the economics of layer farms in the organized sector could help us to understand its viability and also the problems faced by these farms. This would enable us to understand the difficulties that would occur to small farmers in the unorganized sector and hence the reasons why they shy away from layer farming. Layer farming for the small farmers is therefore restricted quite often to deshi birds as rearing of these birds requires no scientific management.

Layers have a long cycle of about 17 months, and a female chick reaches maturity at 20 weeks after which it is termed as a hen and begins to lay eggs for a period of one year. During this period, on an average, an improved layer lays around 264 eggs, although this figure is subject to fluctuations. At times a layer can lay as much as 327 eggs during the laying period, while at times, layers lay below their average performance level. The laying percentage also fluctuates with the season as the birds perform better in winter. In summer, the birds are prone to stress and this may result in a fall in egg production. Egg production may also drop due to disease in the bird or any nutritional imbalance in the feed.

In Table 5.1 we have made an attempt to study the economics of a layer farm (in Mawal taluka). This farm as already mentioned was a big farm with a layer capacity of 1 lakh birds. The birds were reared in the cage system. The layer farm was set up in 1971 and the owner who inherited the layer farm was not on an optimistic note. This is perhaps revealed by the data in Table 5.1. We collected the data for the most recent completed layer cycle in June 1997.

From the table, it can be observed, that out of total variable costs, feed costs were the major item. While chick and grower mash—constituted 16 percent of the variable cost, the feed cost at the laying stage was the largest single factor, in the total variable cost and formed 74 percent. During the laying stage, the layers consume 42 kg. of feed, (roughly 125 grams per day)—but their consumption at the chick stage i.e. (below 20 weeks)—is 9 kg.

Further, out of total cost, variable cost formed 98.3 percent. The fixed cost was barely 1.73 percent of total cost.

The laying capacity of the layer was 265 eggs during the laying period. These eggs were sold to traders at a price which was 5 percent lower than the rate set by the National Egg Co-ordination Committee (NECC). This was to compensate the trader for his transport cost. The NECC fixes the prices of eggs daily and producers sell eggs at these prices to traders. In the sample farm, the price at which the eggs were sold were Rs1.17 and 86 percent of the gross receipts were obtained from eggs.

Once the bird's egg laying capacity is saturated, it is sold as a culled bird at the rate of Rs 30 per bird. This rate of course fluctuates and attimes fetches a higher price. The demand for these culled birds is mostly from hotels, and they require excessive heating for cooking as they are not tender meat.

Again, as in the case of broilers, manure is a by-product of poultry farming and the manure obtained from each bird fetches Rs 14. The gunny bag in which the feed is purchased also have a resale price which is a marginal income to the poultry farmer.

The overall analysis however shows that the net income per layer, per cycle is even less than a rupee and amounts to Rs 0.72 paise. The net income over variable cost is however Rs.7 per layer. The study on layer farming thus reveals that the farmer had a very low profit margin. This was so, even when the farmer reported that his feed cost was Rs 6.5 per kg as against the normal cost of Rs 8 per kg. As we have already observed, feed is the main element of cost in egg production. Large farmers often prepare their own feed, and hence reduce its cost. They purchase the necessary feed ingredients in bulk (especially maize) immediately after post-harvest period, when prices are low and at times they also have their own feed mixing units. They can therefore reduce the cost of feed and also monitor the quality of feed ingredients. The main source of income to the farmer was ofcourse from eggs, which again have fluctuating prices. The prices of eggs are determined mainly by "supply and demand" situations which keep on changing. The prices tend to drop in summer or during religious festivals when there is less demand. Any favourable turn in prices could increase his profits provided there is no simultaneous increase in feed costs. Again, the farmer earns income from the sale of culled birds. The prices of these birds are subject to fluctuations and range between Rs 30 to Rs 40 per

bird. Our sample farmer reported that he had sold the culled bird for Rs 30 per piece. Any rise in the price could increase the profitability.

5.2.2 Cost of production per egg:

The cost of production per egg ,was arrived at, by deducting the income from culled birds, manure and gunny bags from the total cost per bird. This figure was then divided by the number of eggs produced per bird.

In case of our sample farmer we can therefore calculate the cost of production per egg:

- a) Total cost per bird: Rs 361.49
- b) Income from manure, culls, and gunny bags: Rs 52.61
- c) Number of eggs per layer:265
- d) Cost of production per egg: Rs1.16

The cost of producing an egg worked out to be Rs1.16 and as we observed the sale price of each egg was Rs 1.17. Thus there was virtually no benefit in producing eggs for the layer farmer.

5.3 Layer farming: A Re-view of Literature:

The data we analysed on layer farming was related to only one farm. Naturally, conclusions drawn on the basis of one farm cannot be readily accepted. Hence, since there were no more sample farms which we could study, a brief re-view of literature highlighting the important findings of layer farms was undertaken.

NABARD had conducted a number of studies in different parts of the country to study the economic viability of layer farms. The findings of these studies could perhaps help to strengthen our conclusions.

The study related to Andhra Pradesh (Krishna district)¹, showed that only 38 out of the 65 sample units showed positive returns while the remaining 27 made losses. The study suggested that taking all 65 sample units together, the units experienced a negligible net revenue of Rs 0.21 paise per layer, per cycle. These results are in tune with our findings, which indicate that layer farmers have negligible returns. The study also showed that units with more than 1500 layers showed better returns as they experienced higher egg production, longer egg laying period and lower mortality of birds. This perhaps suggests that bigger units had better management.

The NABARD study related to Madhya Pradesh ii (Indore district), indicated that all 20 units which it observed, showed profits. Feed costs were lower in case of large farmers as they made large purchases of important feed ingredients such as maize, immediately after the harvest period. This reduced their cost of production and hence increased their profits. The study concluded that layer poultry farming is a viable activity.

In Pune district of Maharashtraⁱⁱⁱ, the NABARD study observed that 5 units out of 32 were incurring losses. The units incurred losses due to low yield of eggs, higher rate of mortality and poor quality of birds. In poultry farming, although one has to economise on costs, selection of good breeds that will perform well is important even though they may cost more. The study in Tamil Nadu^{iv} again showed that there were loss making units and some were viable only at the margin. The overall conclusions of the study were that there was uncertainty and risk involved in poultry farming.

The NABARD study in Gujarat^v indicated that while all units could cover their variable costs, some were not able to cover total costs. The losses were due to the fact that the laying percentage of birds was low, feed was purchased from commercial feed

manufacturers at a higher price and poor management. However, viable units received as much as Rs18.70 per layer cycle.

Besides, the NABARD studies, a couple of other studies such as one by IIM Ahmedabad, i and another by Bank of India i studied layer farming. Both the studies noted that poultry farming is a viable business and the IIM study advocated it as a subsidary occupation to supplement incomes of the rural poor.

Thus various studies showed different findings, mainly because many factors influence the commercial viability of a poultry farm.

5.4 Conclusions:

To recapitulate, the main findings of our study indicate that economic viability of layer farming depends on various factors. In a nutshell, the profitability of layer farms depends upon cost of production, sale price of eggs and other by products and also on scientific management of farms.

As we have already observed, out of the total cost of production, the feed cost constitutes the single biggest element in poultry farming (around 90 percent), the balance being the procurement of chicks, labour, medical aid, and miscellaneous expenses. Naturally, any saving on feed account would lower the cost of production. However, no compromise should be made on quality of feed. Feed quality has a very important role to play in the laying percentage of the bird and standard formulations containing energy sources, protein sources, minerals and vitamins are expected to give a hen housed production of around 290 eggs, with consumption of 40 kg in 52 weeks. Hence, any reduction in quality is likely to reduce the laying percentage of the bird and every drop in egg production would reduce the profitability of the layer farm. The farmer, therefore in

his attempt to economise on feed costs should not affect the quality of feed formulations. However, large farmers do have an advantage in reducing feed costs. They purchase ingredients economically and in bulk, soon after harvest when prices are low and prepare the feeds in the farm with the help of nutritionists. Bulk purchases at low prices help the farmer to lower the feed cost. Infact, the NABARD study in Indore district showed that economies of scale were enjoyed by the large farmers, particularly in the cost of poultry feeds, where they saved roughly about 10 to 15 percent over readymade feed formulations. This helped to increase their profitability.

Again the commercial viability of the layer farm depends largely upon the sale price of eggs. The price of eggs which are fixed on a daily basis by the NECC are determined chiefly by the market forces. The demand and supply as we know are subject to fluctuations. In summer the price of eggs tend to come down due to seasonal fall in demand. In hot climates the heat stress has a depressive effect on feed consumption. The reduced feed intake adversely affects optimal egg production and further erodes profitability. Finally, the feed prices also tend to rule high as the primary ingredient of poultry feed i.e. maize and soya are agriculture based and summer being a lean season, the prices of these ingredients tend to shoot up. Again, due to heat stress, the poultry farmer may also face mortality of birds which not only terminates egg production but also reduces his income from the sale of culled birds. Income from culled birds also improves the profitability of poultry farms. The prices of culled birds are also subject to fluctuations and any favourable turn in their prices increases the farmers income.

Besides feed prices and sale price of eggs and culls, proper scientific management, goes a long way in making a poultry unit commercially viable. A good strain that will

perform well must be selected although it may cost more. There must be ample fresh air, proper lighting arrangements in the shed and overcrowding must be avoided. If birds are not fed adequately, they will record a drop in egg production and at the same time feed wastage must be avoided. Vaccination and debeaking must be administered and unsuitable birds should be culled. External parasites should be kept out of the farm. If poultry farming is not done in a scientific manner, it could lead to the out-break of disease and result in a low profit-high risk venture.

CHAPTER VI

Summary and Conclusions

The prime objective of India's Agricultural Price Policy has always been to achieve self- sufficiency in foodgrains, so as to ensure food security to its teeming millions. However, while foodgrains fulfil the basic need of feeding the population, focus must also be directed on quality diet, by enhancing the intake of animal proteins such as eggs and meat. While the Indian Council of Medical Research recommends an annual consumption, per person of 180 eggs and 11 kg. meat the actual consumption is way below this requirement. The per capita, per annum consumption (availability) of eggs is less than 30 eggs while in the case of poultry meat, it is barely half a kilogram. All this only goes to say that the poultry sector has an important role to play in balancing the protein requirements of human diet.

Besides poultry farming is also an integral part of our agricultural economy and contributes towards rural development. Income from eggs and meat can be the main source of family income or can provide subsidary income and gainful employment to farmers throughout the year. Also, poultry manure, which is a byproduct of poultry farming serves as a balanced organic fertilizer, useful for cultivation.

Further, like many other fields, in poultry industry too, there are two types of poultry farming: the traditional and the industralized sector. To the extent that poultry industry is highly automated and conducted on a large scale, exports of poultry products have potential and can be an important source of foreign exchange earnings. This is made possible because of the availability of good hybrid birds, quality vaccines and latest technology on management. Infact, the country is in a position to export not only eggs and broilers, but also poultry feeds, sophisticated poultry equipment, poultry medicines, poultry vaccines and possibly poultry technical know how.

From the above, we have observed the importance of the poultry sector, its prime contribution being "to close the protein gap and meet the nutritional standards of the population". Again, we know that development of this sector can be promoted through a wide range of strategies. For example, industralized poultry is characterized by practises like environmentally controlled housing and automation, while traditional

poultry is labour intensive and less adaptive to modern innovations. Both these strategies of poultry development have their own role to play they co-exist and are not competitive to each other. However, it is the extensive small scale units which assume importance in India, in view of the socio-economic conditions faced by the country. These small-scale, semi-intensive units, naturally belong to the unorganized sector of the economy. A study of such units and their economic viability would enable us to understand the contribution of the unorganized sector to poultry development.

The concept of the unorganized sector however is a debatable issue. It is defined as the sector which is not recorded under any factory legislation, consisting of unregistered units with unpublished data base. A more meaningful definition of the concept of unorganized sector is its identification with pre-capitalist structure \mathcal{O}_{I}^{d} production. The unorganized sector is comprised of own account workers and also casual labour employed in establishments. In other words, the unorganized sector is characterized by low capital intensity, low level of productivity and pre-ponderence of family labour.

The large scale existence of the unorganized sector is an important feature that characterizes the Indian economy. Therefore one dimension of the unorganized sector, i.e. the poultry sector has been taken up for study...

Our study on "Economics of Poultry Units in Unorganized sector" relates to the state of Maharashtra. Among all the states in India, Maharashtra ranked second in broiler production and was close to Andhra Pradesh which had highest broiler production. In other words, Maharashtra's contribution to the broiler production of the country was 17.09 percent, while the contribution of Andhra Pradesh was slightly higher i.e. 17.82 percent. Again, with respect to egg production, Maharashtra was in the forefront and ranked third in the country. The contribution of Maharashtra to the poultry sector of the country is therefore no doubt significant.

Further, the poultry population in Maharashtra, over the years showed a phenomenal increase and during the decade 1982 to 1992, the increase was of the order of 39 percent. The noteworthy feature regarding the poultry population is that over the years, the share of deshi fowls is decreasing and that of improved birds is increasing. While the share of deshi birds in the total poultry population was 98.32 percent in 1961, and 82.6 in 1982, it's share came down to 71 percent in 1992. From these figures, it

can be observed that improved poultry is very gradually increasing it's share in poultry population. The fact however remains that despite the fact that improved birds are gaining importance, desi fowls are still pre-dominant as their share is almost three-fourth in the poultry population of Maharashtra.

Backyard rural poultry units still have a significant role to play despite the fact that, desi layers, have a very low laying percentage of about 30 percent while in case of improved birds the laying percentage is 72.13. The desi fowls are mostly maintained at the backyard of the farmer and in this form of production, the farmer maintains small flocks that wander freely, scavenging for their food and also receiving some home grown inputs. They lay few eggs and these are smaller in size than eggs from the commercial sector. The expenditure involved in rearing these birds is virtually nil and hence the sale of these eggs entails a net income to the family. In many developing countries, this system is still responsible for a large proportion of the eggs that are produced. Infact, in China, the largest egg producing country in the world, 80 percent of the birds belong to local breeds and only 20 percent are improved breeds. The local breeds yield just about 120 eggs but yet have relevance in the present day, in view of the prime or subsidary income and employment opportunities that they generate to the farm sector.

While deshi layers contribute to egg production in their own way, improved varieties such as White Leghorn, Australorp, Rhode Islands Reds, etc, are often maintained in farms, even by small farmers, for higher egg production. In case of these breeds, the birds cannot fend for themselves and feed cannot be confined to home grown inputs. These birds require concentrated well formulated nutritional feeds at regular intervals, without which they would record a drop in egg production. Further, these birds have to also be vaccinated for disease protection, failing which could lead to mortality of birds, . Overall, improved layers do require scientific management, and any lacuna on this part would result in a drop in egg production or mortality which altogether would terminate egg production. On the whole, improved layer rearing if carried out with proper care and management could result in high laying percentage and therefore a good source of income to the poultry farmer.

Yet another dimension of poultry farming and perhaps a more important one, is that of rearing broilers. A broiler is a young chicken, usually six to eight weeks of age of either sex, that is tender meat with soft smooth skin and provides a good source of protein to the diet. The broiler production is a fast growing one and a popular segment of poultry industry due to minimum capital investment and space requirement, easy and early start and quick return i.e. within 6-8 weeks (the cycle of a bird's life in broiler farming is only 8 weeks). Since there are quick returns to growers in case of broilers, in case of layers the bird is ready to lay only at 20 weeks,. Therefore there appears to be a preference for farmers for broiler rearing as compared to layer farming.

Given the importance and presence of a number of poultry units in the unorganized sector, we took up a study on poultry farming, related to rearing of both broilers and layers. More specifically, the main objectives of our study was: 1) to assess the economic viability of both layer and broiler units 2) to estimate the per kg. Cost of production of broiler and the cost of production of an egg 3) to observe the reasons for losses, if any.

As we have already mentioned, our study is confined to the state of Maharashtra. Again, in Maharashtra, we selected Pune District, where total poultry population was highest in the state. Further, in Pune district, the poultry population was observed to be maximum in Mawal taluka, followed by Haveli. In the other talukas of Pune District, the share of the poultry population was relatively low. Accordingly, sample farmers from Mawal and Haveli talukas were selected for the purpose of our study.

While we succeeded in obtaining 48 units of broiler farms in Mawal and Haveli talukas, finding small scale layer farms in the unorganized sector proved less successful. The Livestock census of 1992 indicated that in Mawal, out of the total chick population, 91.2 percent were for meat and only 8.8 percent were for eggs.

As we already mentioned, in layer farming, the chicks reach maturity only after 20 weeks when they begin to lay eggs and continue to do so for the next one year. Hence during 20 weeks or for 5 months, the layer farmer does not receive any income. Also, since the birds continue to lay eggs for one year or so, in case of mortality of the flock due to disease, the farmer would lose income for the year, assuming ofcourse that he maintains only one cycle at a time (i.e. all in all out system). In case of broilers of however, there are quick returns to growers as chicks are ready for market in seven to eight weeks. Perhaps, taking these factors into account, poultry farmers, atleast in the

unorganized sector prefer broiler to layer farming. Infact this bias to-wards broiler farming seems to be an all India phenomena, looking at the steep growth in broiler hatcheries and also broiler parent stock. While broiler hatcheries in the country increased from 77 in 1980 to 281 in 1993, the layer hatcheries number went up limitedly from 97 to 113. Similarly, during this period, broiler parent stock in production went up by almost 700 percent while layer parent stock went up by a mere 33 percent. Broiler farming as we mentioned, having a quick turnover, seems to be more attractive. Studies, including ours, have also shown that it is more remunerative.

Due to various difficulties encountered in obtaining sample layer farms, our study is focussed mainly on broiler farms. With respect to layer farms only a very limited analysis was conducted.

The study on broiler farming was related to 48 farms all of deep litter type, having different capacities ranging from a flock size of 50 to 5000. All units were reared in the "all in all out" system, wherein one batch was reared together until the eighth week (one cycle) and a new flock of fresh chickens were to be introduced only after disposing off the previous batch, already reared. These farms were divided into 8 categories depending upon their size. We collected data on per bird, per cycle, fixed and variable costs. The data were collected in June 1997 for the most recent completed cycle. Again the gross receipts of the broiler farmer, from one bird, one cycle was estimated. The total costs deducted from gross receipts indicated the net income, per bird, per cycle, for a broiler unit. In a similar manner, the net income per layer, per cycle was also estimated. The layer cycle ofcourse, as already mentioned was much longer than the broiler cycle. The cost of production of a broiler (per kg.) and that of an egg was also calculated.

The data related to costs indicated that taking into consideration all farms, the variable costs constituted 93 to 96 percent of total costs. Again out of total variable cost, it is the cost of feed which is the single largest factor in the cost of producing a broiler. The cost of feed formed half the cost or a little more in case of all farms. There were however variations in the cost of feed between farms. This difference in cost was because while most of the farms purchased feed at the rate of Rs 7 to Rs 8 per kg, we observed in our sample, that there were certain farms which purchased feed at Rs 6 per kg, while certain others purchased at Rs 9.20 per kg. While feed prices do fluctuate, it

is also true that that feed prices do differ as different feeds have different formulations. Also, at times farmers use locally available, cheaper feed ingredients. However, it was nowhere observed in our study, that in case of costly feeds, the weight gained by the bird was higher.

Almost all farms purchased Day Old Chicks for Rs 12 to Rs 13 per bird. The purchase of a cheap quality chick is not a method of reducing cost. Infact, a poor quality breed may result in low feed conversion or even mortality.

The cost of the feed and the bird together accounted for nearly 80 percent of the total cost. Labour, veterinary aid, litter, fixed cost and miscellaneous costs accounted for the balance. Our sample showed that labour costs were highest in case of smallest farms and as farm size increased, labour cost reduced. The per bird variable cost ranged from Rs 45 to Rs 52.74.

The fixed cost formed barely 4 to 6 percent of total cost. Interest on capital, constituted the major portion of the fixed cost. Fixed cost per bird ranged from Rs 2 to Rs 3.6.

The gross receipts obtained from the broiler farmer were ofcourse mainly from the sale of the bird. In addition the farmer received marginal income from the sale of gunny bags and manure, which is a by product of poultry farming.

Regarding, income from the sale of the bird (which constituted 95 percent of the gross receipts), it was dependent on two factors:1) the sale price of the broiler 2) the weight of the bird. The sale price of the bird depended upon demand and supply conditions. The demand is subject to fluctuations due to various factors such as climate, religious festivals and availability of other sources of meat and fish, and their prices. Warm climates and religious festivals often bring about a fall in demand for broiler meat. This may again be true if other sources of meat and fish are cheaply available.

Regarding weight of the bird, it was observed that most often, the weight of the live bird ranged between 1.5 to 1.7 kg. It was nowhere observed in our sample that relatively large farms have a higher feed conversion as compared to small farms. Overall, the data showed that both large and small farms have similar feed conversion ratios and achieved similar sale prices for their birds.

The gross receipts of the broiler farmers in our sample ranged between Rs55.5 to Rs61.84 per bird. The major income was from the sale of the bird while a marginal income earned was from sale of manure which is a by product of poultry rearing. Again the gunny bags in which the feed was purchased had a resale value and this again fetched the poultry farmer a small income.

The net profit earned in different size groups of farms varied widely, between Rs2.68 per bird to Rs11.34 per bird. In our sample of 48 farms, only 3 farms recorded losses. The smallest farm in the sample, having a flock size of only 50 birds incurred losses due to very high labour costs. In another farm, while costs incurred were nominal, low live weight of the bird and low sale price resulted in the unit being a loss making one.

The data indicated, that smallest farms made the lowest net profits in view of their high labour costs. Farms having a flock size of 1000 to 2499 earned as much as Rs11.3 per bird. Farmers in a bigger size group of 2500 to 2999 earned a much lower net profit of Rs 4.78 per bird. All farms in this category purchased feed at a cost of Rs 9.20 (while in case of other farms the cost of feed ranged between Rs6 to Rs 8 per kg). This high feed cost naturally escalated the variable costs, while there was no observation that, the birds in this category gained more weight. High feed costs and relatively low feed conversion resulted in lower profits.

Again relatively large farms, having birds ranging from 3000 to 5000 birds showed profits of Rs 8 per bird.

The overall conclusion from our sample size showed that smallest farms had lowest net profits. The net profit increased with farm size upto a limit of maintaining 1500 birds. Thereby the net profits remained constant but showed a sharp fall in case of farms having 2500 – 2999 flock size. The net profit again increased for farms maintaining 3000 to 5000 birds.

The conclusions of our study are ofcourse based on a small sample, covering only one taluka. Further, the sample estimated the farmer's income only from one broiler cycle. The income of the poultry farmer is however subject to fluctuations. Poultry production is a delicate business, dealing with tender birds and profitability depends upon several factors. Hence, the economic viability of poultry production is always an element of uncertainty. While a farmer may have a good crop in one cycle,

his flock may get diseased in another, thus disrupting his flow of income. While this risk may be true to any crop, where the entire harvest may be damaged due to bad weather, or infestation by pests, there are certain features which are special to poultry. For example, poultry birds require the same labour to feed them everyday as they are very sensitive to change in labour, which may cause loss of appetite and hence impair growth. Further, birds being a biological production, can be exposed to stress and the maximum expression of stress—results in mortality, due to fright from shock even though no injury is involved. The process of poultry farming may actually induce stress. Again, stress may be induced due to reaction from vaccination, overcrowding, noise, strangers, debeaking, etc. Stress may be a physical, chemical or emotional factor and can only be partially corrected by medical aid. As already noted, the possibility of birds being exposed to stress—can restrict their growth and thus in the process reduce economic viability.

Thus for a broiler farmer, while cost of feed and sale prices of broiler are often out of his control, good and scientific management may go a long way in improving his profitability.

Finally our study on cost of production per kg of broiler showed that, taking across all farms, while the cost of production of a broiler was Rs30.5 per kg, its sale price was Rs 38 per kg. This suggests that production of broilers, on the whole seems to be a profitable venture.

As regards layers, we have already mentioned that a very limited study was carried out due to inavailability of sample farms. The result of our study however showed that, as in the case of broilers, feed constituted the major cost. While chick and grower mash constituted 16 percent of the total variable cost, the feed cost at the laying stage (i.e. after 20 weeks) was the single largest factor, in the variable cost and formed 74 percent. During the laying stage, the layers consume42 kg of feed (roughly 125 grams per day) but their consumption at the chick stage is 9 kg.

Out of the total cost, the variable cost formed 98.3 percent. The fixed cost was barely 1.73 percent of total cost.

The main source of gross receipts for the layer farmer was ofcourse from the sale of eggs. The farmers normally sold the eggs at a rate which was 5 percent below the NECC rate. While 85 percent of his gross receipts were obtained from eggs, in case

of layer farming, again two by products emerged: culled birds and manure. After the laying period of the layer is over, the culled bird is sold at a price depending on market forces. This serves as an additional income to the poultry farmer and 8 percent of his gross receipts are obtained from this source. Again, poultry droppings are a good source of manure and serve as one more source of income. Finally, the gunny bags in which feed are purchased serve as a marginal income to the layer farmer.

Our overall analysis however shows that, the net income per layer, per cycle is even less than a rupee and amounts to Re 0.72 paise However, the net income over variable cost is Rs 7 per layer. This suggests that a layer farmer works on very low profit margin. A number of studies, in different parts of the country had been conducted by NABARD. The studies showed various findings: while some layer units had very good economic viability, there were several others that were loss making ones.

Layer farming, like broiler farming is a very delicate and risky business. Layer farming however has a bigger gestation period and one completed layer cycle is around 17 months while in case of broiler farming it is barely 6 to 8 weeks. The commercial viability of the layer farm, again depends upon cost of production, sale price of eggs and sound management. Since cost of feed accounts for around 90 percent of the cost, any saving on this account would naturally lower the cost of production. Big farmers sometimes have this advantage as they purchase ingredients, economically and in bulk, soon after harvest, when prices are low. They prepare the feeds in the farms with the help of nutritionists. Bulk purchases, at low prices help to lower his feed cost. The farmer ofcourse, in his attempt to lower feed prices should not compromise on quality. Any compromise on quality would result in drop in egg production.

The commercial viability of the layer farm again depends upon the sale price which is subject to fluctuations depending upon demand and supply. In summer, the price of eggs, tend to come down due to seasonal fall in demand. Further, the heat stress has a depressive effect on feed consumption, which reduces the egg laying capacity of the bird. Also feed prices are high at this time. However, any favourable turn in egg prices and also that of culled birds raises the profits of the layer farmer.

The cost of production of an egg in our study indicated that while the production cost of an egg was Rs1.16, its sale price was Rs1.17. There was virtually no benefit in producing eggs for the farmers.

The overall conclusion of our study, highlights the fact that, in poultry business, broiler farming seems to be a more profitable venture than layer farming and there also seems to be a preference among farmers for rearing broilers than layers.
