## NOTES AND NEWS

Segregation In Estcourt Market

HE Estcourt Municipality holds two markets a week-on Wednesday and Saturday. Hitherto there has been no restriction controlling the intermingling of Europeans and Indians, and the goods have been auctioned and sold to the highest bidder irrespective of colour. Last week, however, new arrangements came into force, and the Indians were portioned off to a section of their own apart from the Europeans, who were purchasing in front of a long table where the auctioneer was selling, which we are informed was only about nine to ten feet away from the Auctioneer. Indians are now driven away about twenty five to thirty feet. The number of Indian buyers who purchase on the market and hawk the fruit and vegetables to householders is about 40 and it is due to them that the market is able to get a good revenue. There was considerable resentment against this action of the Council but the poor hawkers have had to submit to the humiliation, imposed upon them. While some of the councillors are in sympathy with the Indians others we understand have gone to the length of declaring that they did not want the B---Indians to buy at the market at all. wanted the housewives to buy direct from the market. This is a typical instance of the methods employed to deprive Indians of their means of livelihood and to squeeze them out of this country,

How Indian Licences Are Refused

Durban City Council, sitting as an appeal board last week heard the following six appeals against the decision of the Durban Licensing Officer, Mr B. R. Lagerwall. In five of the appeals the Licensing Officer's decisions were upheld, and in the sixth the decision which was against the grant of a general dealer's licence, was amended to grant a refreshment room licence: Papa, General Dealer's Licence, in respect of premises 297/299 Randles Road, Durban; C. P. Naik, Refreshment Room and General Dealer's Licences in respect of premises 11 and 13 Etna Lane, Durkan; Refreshment Room licence was granted. Ramchuran Bhagwan, General Dealer's Licence

in respect of premises 28, Sydenham Road, Durban; Mahomed Abed, Native Eating House and General Dealer's Licences in respect of premises 104, Queen Street Durban; (Granted); Henry Thomas Nurse Tea Room an I General Dealer's Licences for premises 66/72, Sydney Road, Durban; Valoo Manikam Muthu Achary, General Dealer's, Tea Room and Milk Licences in respect of premises 389, Umgeni Road, Durban.

From the above it would appear that five of the six were Indian applicants who had applied for licences in Indian areas and they were all refused with the exception of Mahomed Abed by the licensing officer whose decision was upheld by the Fown Council. When we once refused to view with favour on the grounds of principle the idea of colonisation scheme for Indians outside South Africa where they would receive better hospitality we remember how we were taken to task by the Natal Advertiser for talking about principles when the question of butter and bread was involved. We would now like to point out that this is a question where Indians are deprived of their bread and butter. But is anything done for them-either by the Press or by the political bodies or by the Agent or by the Government?

Mr. Kemp's Suggestion

Mr. H. H. Kemp in the course of a letter addressed to the Durban City Council recalls the Capetown Round Table Conference of 1927, between the Governments of the Union and of India, at which it was agreed that when the time for the revision of the existing licensing laws arrived the Union Government would give due consideration to the suggestion made by the Government of India that the discretionary powers of local authorities might reasonably be limited. During the past few months, Mr. Kemp adds, Durban City Councillors have commented in favour of a Board being appointed in substitution of the Council to consider appeals from the Licencing Officer. He also draws attention to the observation of Mr. Justice Krause that "many Municipal Councils were unfit to consider the question of issuing licences because in most cases they were prejudiced. I suggest, therefore," Mr. Kemp writes, "that

the Council may well invite the Govern ment to indicate its position in the matter of its undertaking and as set out in the Capetown Agreement of 1927, and to state whether it is its intention to appoint a Union Commission to deal, inter alia, with this part of the question of the composition of the licensing boards when the whole of the question of the licensing laws of the Union are revised."

We agree with Mr. Kemp that it is high time that steps were taken to change the licensing laws so that they are not worked injustly against the people.

Government's White Labour Policy

Every Native or Indian sailor on the Harbour tugs of Durban will in the near future be replaced by a European sea-man, drawn perhaps, from some other part of the country. For the past halfcentury Indian seamen have formed a feature of Government port life in Natal Now, in pursuance of the Government's declared "White labour" policy, men who have served the Port tugs for 26 years will be told that they can accept labouring tasks in the sheds and on the wharves at drastically cut wages or be paid off with a gratuity. Twenty two Indians and many Natives are involved in the change. The South African Indian Congress made representations to the Administration and was informed that its request would receive consideration. Of the 22 men concerned, several have served in the tugs for 26 years and the shortest period of service is 11 years. Some time ago when there were five tugs in Durban, two were sent to another port and the Indian firemen were given other jobs in the sheds and other places at 40 per cent less pay. Originally there were 4,000 Indians employed on the railways in Natal there are now only 300 to 400 Indians.

### Indian Question In South Africa

Commenting on the speech of the Agent of the Government of India The Leader (Allahabad says:—Among the grounds on which Indian are considered unfit for self-government, is their attitude towards the depressed classes. But it has been acknowledged even by those who cannot be accused of being in League with Indian political leaders

that whatever little powers the Montagu scheme conferred on Indians they have been utilized among other things for promoting the interests of members of the depressed classes. In the case of South Africa, however, the fact that Indians are ill treated is not considered a disqualification. Indeed while more

and more disabilities have been imposed on Indians on the one hand, greater and greater powers of autonomy have been conferred upon South Africa on the other. And yet among the grounds on which war was declared against the Boers in 1899, one was the ill treatment of British subjects, including Indians,"

### 'Advertiser's' Homily

TE little thought we would have to perform the unpleasant task of referring to the use of the term coolie once again. We should not have cone so had it not been for the uncalled-for rebuke by the Natal Advertiser. We know there are some amongst us who glory over the feat they have performed in seeking the aid of a European contemporary to run down their own brethren. But we feel inclined to suggest that any Indian with an iota of self respect in him will without doubt take exception to what our contemporary has written. Before we come to the actual subject we would like to express our surprise that in an advanced country like South Africa, where the slightest ban on the freedom of speech and thought is so strongly resented, a paper like the Natal Advertiser, which has otherwise the reputation of being liberal in its views, should deny that freedom to a section of Indians to whom South Africa, however unhospitable it may be, is their only home. Last Sunday's mass meeting was by no means a small one. The hall was packed containing over 800 people, and we make bold to say that more than four times the number, though they did not attend the meeting were, nevertheless, silently resenting the reference made by the Agent of the Government of India to the term "coolie." Yet this meeting was not considered by our contemporary of sufficient importance to be reported though it obviously did merit a leading article to rebuke so many people for giving expression to their feelings on a question that they considered wrong. A report of such a large and genuine meeting was not published by our contemporary though its reporter was present at the meeting; and yet if any reports were sent to it by other sources though they may not be genuine would have received due publicity. If journalistic etiquette permits such prejudice our contemporary should know better than ourselves. From a common sense point of view, however, it does not seem to us to be permissible. Our contemporary dared to do this, backed by authority, to Indians, who were after all "coolies," who had no power to overthrow that authority.

But might it not be pertinently asked if it would have dared to ignore the voice of so many people of its own race without its Editor running the risk of being hung on the sour apple tree. We doubt very much.

But we have to thank our friends of the Congress for this draught of humiliation, who quite obviously do not take offence at being called coolies or treated as coolies. Enough said.

Coming to the point, our contemporary warns us against exalting a matter of terminology into an affair of first class political significance. We would like to point out that the political issue in South Africa in so far as Indians are concerned is nothing else but the way they are looked down upon and the treatment that is meted out to them,

Let us first discuss the term "coolie" in itself. The Agent General maintains that there is no stigma attached to it. In the dark days of slavery the slave owners were accustomed to calling their slaves in a way which in these days of enlightenment would undoubtedly appear most offensive. An un touchable in India who is commonly known as Dheda was not considered to be an offensive term all these years and no stigma was considered attached to it. But that term is now considered most offensive and it has been replaced by the term Harijan. Then the terms "Kaffir" or "Nigger," though they are still being used by people who we would call uncouth, there is not the least doubt that those terms are offensive to the Natives and the Europeans as well as Indians of the cultured class generally address them as Natives and rarely ever as "Kaffirs" or "Niggers," Similarly, knave is a term for a labourer but would a European labourer tolerate being called a knave? Or do we ever hear his compatriots addressing him as a knave? Never to our knowledge. Well then how could it be argued that the term "coolie" has no stigma attached to it. We are past the days of darkness and in these days of enlightenment dignity is attached to labour and hence there must be a dignified mode of addressing a labourer.

Coming now to the term as it is applied to Indians in South Africa, ever since Indian labourers were brought

to this country Indians were generally known, addressed and treated as coolies. Mahatma Gandhi was perhaps the first cultured Indian to land here, though of course there was a better class of Indian traders and also educated colonial borns present. What did Mahatma Gandhii find? He found that notwithstanding all his culture, in the eyes of the Euro pean he was nothing more than a coolie. He was termed in the European Press at the time as the "coolie lawyer." He had to undergo untold sufferings im attempting to assert his right's as as cultured Indian gentleman. The law affecting the Indian labourers at the time was kn wn as the law affecting the coolies. As a result of the illtreatment meted out to Indians and the deprivation of their trading rights emigration of further Indian labourers was stopped from India and it was after assurances were given of better treatment that it was once again resumed and it was then that the term coolie from the law was altered to Indian. Our Agent-General is perhaps not awares that in the schools in this country their term Indian is being taught to children as denoting the Red Indian of America and coolie as denoting the Indian front India. Hence it is that the school children are often heard shouting coolies to Indians. We would like to remind our contemporary here that! Indians are not so hyper-sensitive as it paints them to feel hurt at this insolences on the part of the school children. They overlook it as being the result of illbreeding. But Indians do certainly resent being wilfully addressed as coolies by those who know better. We know, however, that there is a growing cul tured class among the Europeans who are thoroughly ashamed of their compatriots who act thus; and this gesture was magnificently shown when Mr Sastri was given a taste of such treatment at Klerksdorp when he came to this country as the first Agent of the Government of India.

It should be noted here that our present Agent is a sport and would perhaps strongly object to our protestations if he were by chance put to similar treatment. That is however by the way.

Well, we have tried to prove that the term coolie in itself is an offensive term and that in the sense it is used in South Africa it is most offensive not only to Indians here but is an insult to the whole of India. And the torrent of protest would not have been so strong if the Agent of the Government of India, in the very responsible position that he

holds in South Africa, would not have thoughtlessly uttered the words he did. We sincerely wish he had not done so.

As for the Natal Advertiser's homily, being acquainted as we are to a small degree with Western etiquette we do think it was altogether out of etiquette on the part of our contemporary to have launched out to give pious advice

in what was purely our domestic this, "that you Indians are coolies and as such you must respect authority whether right or wrong." Theretcan be no greater humiliation and it is this humiliation against which Indians have to fight in this country and no sacri-

fice is too great in doing so. In treating matters. If there was one note re- this subject as we have done we wish sounding from the whole article it was - to make it clear that we are not championing the cause of the Colonialborn Indians We consider this to be a question of national importance and whether it were the Congress or any other body we would have taken the same stand.

# PROTEST MEETING IN DURBAN

## STRONG EXCEPTION TAKEN TO AGENT'S UTTERANCES

A MASS MEETING of the Colonial Born and Settlers' Indian Asso-, ciation was held last Sunday afternoon at the Victoria Picture Palace, Durban, to voice their protest against the reference of the Agent of the Government of India to Indians being called Coolies and against racial staff segregation in Sastri College

Advocate A. Christopher presided over a very large gathering.

#### President's Speech

Mr. Christopher in the course of his speech said they had assembled to make a protest in the strongest possible terms against the Agent of the Government of India, Sir Syed Raza Ali, who, in a speech that he had delivered at Newcastle recently stated that Indians! introduced to this country were "Coolies". and that there was no stigma attached to the application of the term "Coolie" to. Indians. In fairness to the Agent he informed the meeting that on Sunday morning the Agent had telephoned to his house while he was out and gave a fuller report of his speech. The Agent's version was the same as that which appeared in Saturday's Advertism. In the Advertiser's version the Agent is reported to have said that those who were introduced into Natal from India were "Coolies." That he said was a stern fact. He further said that they asked for coolies and got coolies. Mr. Christopher deplored that the Agent should have made such a statement for that was an unwarranted insult to those who were introduced to this country and their descendants who were to be found all over South Africa. The term coolie meant a labourer who toiled daily for a daily wage or did odd jobs on hire such sa porters. Those who came under the indenture system were men recraited from different classes of Indian life. Every caste was represented among them. Persons who had family differences and those who were subject to financial diffioulties and those who were suffering owing to economic conditions in India were the ones who fell easy prey to the recruits. How could the Agent then eay that it is a atern fact that those who were introduced under the system of indenture were coolies. The Indian

community of South Africa had always objected to the term used by the European and Mr. Christopher therefore felt that the Agent had hurled an insult on those who came under indenture and their descendants. Mr. Christopher then touched upon the staff segregation at the Sastri College and upon the lower grade. of salary to the Indian Teachers engaged there. He deplored the segregation of a mixed staff that teaches the same students. This policy is bound to effect the morale of the students who should be taught under conditions of equality amongst the staff. The salary that the Indian Teacher receives is less than half of what the European receives. Here again there is discriminations. How can we then expect the better type of Indian Teachers to accept service at the Sas ri College.

Among the other speakers were Messrs. P. B. Singh, C. R. Naidoo, V. K. Pillay, D. S. Chetty and several others.

The following resolutions were passed: "That this mass meeting of Colonial. born and Settler Indians strongly resents the speech of the Agent of the Govern-. ment of India delivered at Newcastle, in which he is reported to have said that, as those introduced into Natal from India were "coolies," there was no stigma attached to the term.

"In view of the determined stand that the Indians have always taken against the application of the term 'coolie' to Indians this meeting strongly feels that this is a gratuitous insult by the Agent to the Indians who were introduced into South Africa and th ir descendants, and protests to the Government of India against the action of its Agent in South Africa,"

"That this mass meeting protests against the racial staff segregation in Sastri College and the inferior status of Indian teachers engaged therein, who are placed on a lower grade than their European co-teachers. Such inferior treatment of Indian teachers cannot be without effect upon the morale and outlook of the students, and such discrimination is not only unfair to the Indian teachers but is also bound to re-act against the better type of teachers taking service under such conditions."

Another resolution protested "against the method of collecting moneys in South Africa for the Parsee airmen and for other purposes in India from time to time in preference to supporting financially essential social and educational movements in South Africa " A fourth appealed "on behalf of Indian relief workers to the Durban Municipality for an increase in their rate of pay, at present 2s. 6d. a day with a five-day week."

#### The Agent's Explanation

The following explanation was sent to Mr. Christopher by phone by the Agent of the Government of India, Sir Syed Raza Ali, prior to the meeting :-

Replying to a remark from Mr. A. I. Kajee, the Agent said:

"My friend, Mr. Kajee, referred to coolies. If anyone called me a coolie I would be delighted."

"Even stand him a drink," shouted someone in the audience.

"I might. It depended on how it was meant. I might be called the headman of the 'coolie-gang.' (Laughter.) For without a sense of humour life would not be worth living. And without humour one could not live for more than three months in this country.

The people who originally came out to Natal were labourers, or to use the Indian term, coolies. That is a stern fact. What gives offence is how the word coolie is said. The meaning of the word is an agricultural labourer, nothing more or less. It carries no stigma. As working men Ramsay Macdonald, J. H. Thomas, and the leader of the Labour Party, Major Attlee, are coolies. The descendants of these Indian labourers are now in the third and fourth generation. They are educated men who conform to the requirements of western standards. Why call them coolies?

"I put the concrete case of the Indians of South Africa. You wanted coolies and you got coolies. What I ask you to recognise is what the descendants of the coolies had done. I drew your attention to the tremendous progress that they had made. Let me mention the progress of education and of the large increase of the number of schools where they are receiving education. In this direction progress has been very great

# TRANSVAAL UNITED PARTY

### SUGGESTS BOYCOTT OF ASIATICS.

A T the Transvaal Provincial Congress of the United Party on Dec. 4 at Pretoria there was a heated discussion by delegates against supporting Asiatic traders and allowing them to employ Europeans.

Mr. J H. Hofmeyr, Minister of the Interior, referred to an agreement into which the Union Government had entered some years ago, by which it agreed not to proceed with the Class Areas Bill, and in which the Indian Government agreed on their part to assist in a scheme of repatriation of Indians. They could not say that the Indian Govern. ment had not carried out its obligations. The Congress must not now ask the Government to take steps contrary to an agreement to which it had put its signature. If they did so they must advance reasons which the Union Government could give to the Indian Government to ask for a revision of the agreement.

A considerable number of Indians were part of the Union's permanent population, and as such must be given the chance of making an existence. That was the attitude taken up by the Government in 1926, and endorsed by the representatives of both big Parties at the Conference in 1933.

That the marriage laws be consolidated by Parliament in such a way that marriages between Europeans and non-Europeans should be made illegal, and that if such a marriage was contracted outside the Union the parties be prohibited from coming back to this country was a resolution adopted by the Congress.

Resolutions were moved asking the Government to prohibit intermarriage between Europeans and Natives, Coloured persons and Asiatics

Mr. Hofmeyr said that while there was no specific prohibition anywhere in

the Union against mixed marriages, in the Transvaal and the Orange Free State there was no procedure to enable mixed marriages to be solemnised. In Natal and the Cape there was a set procedure, with no colour bar But there was a tendency to exaggerate the number of mixed marriages. Last year there were only three in the whole of the Union The problem was a complex one, and the Government was paying due attention to it. The difficulty was to prevent these mixed marriages taking place outside the Union and the parties coming to the Union.

Commandant'A. P. Visser said that the solution lay with the people, not with the Government. If people continued to sell or let ground to Asiatics and refused to boycott their shops, the fault was their own, 'People who sold land to Natives and Asiatics and patronised their shops must be ostracised. If such a boycott were carried out for one year no Asiatic or Native could exist.

# MR. R. J. DU TOIT ON COLOUR BAR

IN a statement with regard to his resignation from the United Party and his reasons for taking this step, Mr. R. J. du Toit, M.P. for 'Maitland, said that he joined the United National Party under the impression, and in the belief, that the rights and privileges of all members of the former South African Party, irrespective of race, colour and creed, would be safeguarded and maintained in the United National Party. This viewpoint was strenghthened and confirmed by the Programme of Principles jointly issued by General Hertzog and General Smuts which was subsequently adopted by the United National Party at its Bloemfontein Congress last December as the Programme of Principles of the United National Party and which states, inter alia: "It seeks to unite in political co operation all who, whether hitherto members of the Nationalist or South African Parties or standing outside both these Parties are prepared to endorse the Party's aims and principles."

Unfortunately, said Mr Du Toit, he had not read "all Europeans" into meaning of "all," which is what appears to have been intended. Otherwise he personally would not have joined the Party when it was first formed, as he

was definitely opposed to the inclusion of any form of Colour Bar in the Party Constitution, nor would he have informed and assured the non-European members of the former South African Party at all meetings which he addressed that they would have the same rights and privileges as members within the United National Party which they had enjoyed as members of the former South African Party.

The resolution carried at the United Party's Port Elizabeth Congress was in his opinion unwarranted, unnecessary and unjust and an insult to hundreds of former loyal non-European Party supporters. Clause One, he explained, introduced the Colour Bar into rural constituencies. Clause Two provided that subject to certain qualifications non-Europeans might be enrolled as Party members, "it being clearly understood that such qualifications shall mot be regarded as operative until approved of by Congress."

This in effect meant that, unless a a further Congress was held prior to the

pending "Provincial Council elections next year and non-Buropean member-ship was approved thereat, no non-European member would have the right to exercise his vote at election meetings for the nomination of United National Party candidates. He could read no other meaning into the word "operative,"

Clause Three, he went on, allowed consideration to be given to the forming of a separate organisation of the Party for non-European voters. Here again the principle of the Colour Bar was introduced.

Mr. Du Toit said that he had been advised that by remaining within the Party he could help bring about a change of view and feeling with regard to these decisions. He stated that he had carefully considered his action but in view of Mr. Pirow's definite statement that the resolution had the approval of the party leaders, General Hertzog and General Smuts; that Congress had passed the resolution by an overwhelming majority; that Nationalist propaganda to create prejudice in rural areas against inclusion of non-Euro-

peans as Party members in Urban constituencies would be intensified resulting in a still greater majority at the next United National Party Congress in favour of the Party Colour Bar; that he was not prepared to go back upon the assurances he had given to his non-European Party supporters; and that. Congress had sacrificed the principle of

justice and fairplay for a political expedient he was left with no option but to resign from the United National Party.

He very much recretted being forced into his present position, but he hoped that as a result the Party leaders would realise that his action was both a protest and a warning against the ratification of a decision which precluded him and many others from remaining members of the United National Party and he trusted that immediate steps would be taken to have the Port Elizabeth decision rescinded to ensure that equal justice, national unity and true co-eperation for which the United National Party claimed to stand,

# CHRISTIANITY AND THE COLOUR BAR

colour bar in the Church and that our European congregations are doing something to assist the work of the mission in the diocese or in their locality," said Dr. Fisher, Bishop of Natal, recently.

In the two former Dutch republics the English principle of equal civil rights for white and black found no place. One of the motives which induced the Boers of 1836 to trek out of the Cape Colony was their disgust at the establishment of such equality by the British Government. The Dutch looked upon the native population as existing solely for their benefit and resented and still resent the efforts which the British Government made to secure for the blacks equal civil rights and adequate protection. The attempt to deprive the Cape natives of the franhise is the outcome of that deep-seated and

almost ineradicable prejudice. The Grondwet (fundamental law) of the Transvaal Republic declared in 1858, and declares today, that "the people (meaning the Afrikaans-speaking people) will suffer no equality of whites and blacks, either in State or in Church." Democratic republics are not necessarily respectful of what used to be called human rights and neither the principles of 1789 nor those of the American Declaration of Independence find recognition among the Afrikaans-speaking people The Dutch Reformed Church professes to teach the precepts of Christ, to preach His Gospel. The Bantu listen and reply: "You have perverted the truth!" And behold the sad spectacle of a backward Bantu race teaching the haughty dominant race and the true principles of its religion.

It is a cause of astonishment to note how the Africans have measured nominal Christanity, how clearly they have made distinctions between the Christianity of Christiandom and the Christianity of the Bible, and how keenly

their rebukes are often administered. The colour bar and other vicious laws are traceable to men who profess the Christianity of Christiandom and not of the Bible.

The Chrstianity of the Bible recognises no colour bar. It says: "Do not to thy neighborr what is distasteful to thee." Peter said, "Of a truth I perceive that God is no respecter of persons, but in every nation (the Bantu naion included) he that feareth Him and worketh righteousness is acceptable to Him." God "hath made of one blood all nations of men," declared the great Apostle Paul. Mankind is one family. Each member of the human family is a human brother to every other human being. All are children of one father. Adam, a son of God, to whose joint care the earth with its fullness was committed by God as a stewardship. All are, therefore, beneficiaries of the divine provision. With the exception of the Dutch Reformed Church, all the Christian Churches do not recognise a colour bar in the Church.

# A LESSON FROM JAPAN

OUR countrymen interested in rural uplift and village industries would be interested to learn from the following true story as to how Japanese, villagers are attempting reconstruction of their villages and, improving their economic conditions. The example may serve as a golden lesson to many of, our enthusiastic villagers.

Here is the story as translated from a Japanese vernacular paper:

"Three years ago this month the debtridden village of Mitsuho, in Shimo Ina,
Nagano, consisting of 402 households,
went on the water waggon in an effort
to economize. Inspired by the doctrine
of self help then being preached by
Premier Saito, the village elders induced
all the households to agree to three dry
years and to apply as much of the re
sulting savings as possible to their
debts. Results announced on Tuesday,
according to the Asabi, indicate a
measure of success beyond the expecta-

tion of those who promoted the scheme. Approximately £30,000 having been saved to date, most of it has been devoted to paying off debts.

"The period of abstention and economy will formally end on August 1 next, but so thoroughly bent on the plan are the villagers that preparations are being made to extend it for an additional term of five years, in order that the financial foundation may be obtained for a 100 year programme to make Mitsuho an ideal village. Promoters of the century programme idea point out that continued abstention and saving for five more years should make avail able a fund of £100,000 for the village. This would be left in the postal savings for a full century, during which, the

idealists believe, it should increase to something like £190,000 with compound interest. Such a sum would pay off any debts that might exist after 100 years and the remainder would be used for the establishment of cultural and other institutions. To handle the investment, it is proposed to organize a society named the Mitsuho-Mura Paradise Construction Association.

"Mr. Zoshu Hayashi, then the village headman, and Mr. Jiro Hayashi, then his assistant, were the moving spirits, so to speak, in getting the villagers to undertake the original three-year prohibition programme. Mr. Jiro Hayashi was especially effective as an example as he was previously known as Mitsuho's heaviest consumer of the commodity. The project has had several indirect results, among them being a general improvement in the houses, which are now in a better state of repair, and a marked decrease in the matter of brawls."

# South African News In Brief

Who Will Be The Next Governor-General

MR. N. C. HAVENGA, the Minis er of Finance, is likely to be offered the Governor-Generalship of the Union of South Africa, according to a report emanating from the Rand. It is asserted that the Government has already arrived at a decision in the matter. and that the appointment if made, will take effect from the date of the expiration of the period of office of the present Governor-General, the Earl of Clarendon, in two years' time. No official statement so far has been made on the subject, beyond the announcement made by the Prime Minister in September that the "time is arriving" for the appointment of a Union national se Governor-General.

#### The "Coolie" Controversy

We have received several letters in reply to an attack made in Indian Views on us for having criticised the speech made by the Agent of the Government of India, Sir Syed Raza Ali, wherein he was reported to have stated that there was no stigma attached to the term "Coolie," While we very much appreciate the sympathy and encouragement the writers have given us we do not propose to give publicity to their letters in our columns since the subject referred. to in the letters has not appeared in this journal. The right place to send the letters would be to the journal responsible for the attack. Ed.—1.0

#### Durban City Council's Anti-Asiatic ... Move

A step towards creating a Licensing Appeal Board on the lines of the Valuation Roll Appeal Board was taken last Tuesday by the Legislation Sub-Com. mittee of the City Council. Its recommendation will go before the full Council. The sub-committee considered various resolutions submitted to it by Standing Committees during the year. One was on the preservation of European areas. It was agreed to get approval for the draft clause which was included in the Extended Powers Ordinance, 1933, and deleted by the Provincial Council. The clause reads that "if the owners of any two or more contiguous areas of land within the Borough of Durban lodge with the Town Clerk notarial declarations restricting the future transfer of their land to persons of a class to be specified in the declaration it shall not be lawful for any such land or part of it to be transferred to any person not belonging to such class without the approval of the Town Council" It was as a result of the Indian community's protest that the above clause was deleted and it is now Council." sought to reintroduce it, The leaders of the community should take cognisauce of the fact.

#### Old Age Pensions

A Union Act of Parliament provides that every white (European) person and every coloured person (not an Asiatic or an aboriginal native) may receive the benefit of an old age pension provided he or she (a) has reached the age of 65 years, (b) is domiciled in the Union. (c) is resident in the Union at the time of making application for the pension, and (d) has been a British subject for five years and has ordinarily been resident in the Union for I5 out of 20 years immediately preceding the date of the application, and (e) has means not exceeding prescribed amount. maximum rate is £2 10s. a month for Europeans and £1 10a, for coloured persons. The amount in any particular case is assessed by the Commissioner of Pensions, and is such that, taking into account the applicant's other means, the total shall not exceed £54 a year in case of Europeans and £36 in the case of coloured persons. Indians are excluded from this Act and as reported in our last week's issue a sum of £5,000 would be put on the estimate next year for the indigent and old-

#### How Mr. Andrew Wier's Gift Is To Be Used

The Indian Hopial Advisory Committee propose the erection of a clearing station and dispensary for indigent Indians and have requested the City Courcil to provide a site for the purpose. A gift of £5,000 was made to the Indian community for a hospital for indigent Indians by Mr. Andrew Weir some time ago. It is felt by the Indian Hospital Advisory Committee we understand, that as such accommodation is provided at the Congella non-European hospital, the gift would be better used by building a clearing station and dispensary. The Medical Officer of Health, Dr. Gunn, and the Estates Manager, Mr. Mallinsou, consider that a site in Beatrice Street next to Full Gospel Church is suitable. After considering the financial aspect the Finance Committee referred the request to the Public Health Committee for report.

#### £13,153 Indian Barracks

Sketch designs for barracks to accommodate 50 Indian families on a site adjacent to the existing barracks at the Umbilo Stone Depot will be submitted by the City. Engineer to the Public Health Committee of the Darban City Council. The estimated cost of the scheme is £13,153. In regard to the accommodation required for 75 single Natives, the City Engineer suggests that quarters be provided for them on a site adjacent to the existing Dalton Road Native Barracks, as it would be undesirable to erect Native barracks in proximity to the Indian quarters already mentioned.

#### "Good News Telegrams"

A system of "good news telegrams" has been introduced in the Union Post Offices from Monday December 9. To many people the receipt of a telegram is a terrifying matter and the buff envelope is examined in fear and anxiety. But now a special onloared envelope of gold with a decorative royal blue and red border, bearing at the top the inscriptien "Good News Telegram" in both languages has been introduced. The additional charge will be one penny. Any telegram can be enclosed in a "good news" envelope. All that is required is that the sender should indicate that he wishes this to be done and pay the fee.

### 'Die Volkstem' On Thrashing Case Referring to the recent Potgletersrust

thrashing oase, Dis Volkstem emphasises that townspeople should make allowance for country dwellers who are constantly faced with the stark realities of the relationship between White and Black, and for the provocations and temptations arising from the fact that the Backveld has not always the best Native material to deal with. At the same time it would be a sad day for South Africa, the paper declares, when magistrates would have to consider the possible effect of their findings on their own positions or prospects before imposing a sentence for what in the case mentioned was inhuman treatment of a Native lad. The danger from such a state of affe'rs becomes real when public men who should know better lack what seems to be the necessary political courage to defend the Courts against demonstrations that reflect no credit on the fairmindedness or the good sense of those who take part in them.

## A Native Gun-man In Dundee

While on his w.y home at about eight o'clock on Dec 3, an aged Indian. Kaloo, was assaulted by a native at Glencoe, who later drew a revolver and fired seven shots at three young Indians who pursued him. Kaloo, it is alleged, had been accosted on the railway line near the level crossing at Glencoe by the Native, with a request for money. Upon the Indian stating that he had no money, the Native struck him across the head with a stick. Answering the Indian's cry for help, three young relatives gave chase and eventually cornered the Native at the level crossing on the Glencos-Waschbauk road, where the Native drew a revolver and fired a shot. No one was hit. A chase across the veld and through several fences took place, four more shots being fired at the pursuers, who were only a few yards behind all the time. Eventually one Indian, just as he was about to seize the Native while the latter was getting through a barbed wire fence, received two wounds in the thigh from two further shots. The chase then ended, but a report was made to the police, who are now scouring the Waschbank valley. The injured Indian, H. Bugwandeen, is in the Swedish Hospital in Dundee, but is not in danger.

#### South Africa's Public Debt.

South Africa owes £274,115,400 18s. 8d. in public debt. Although this is a decrease of £196,163 2s. 6. on last year's figure, it is much more than double the Union's debt in 1910, which was £116,036,978. The net debt per head of the European population is £129 2s. 1d., and the annual debt charge £5 19s. 1d. If the non-European population were converted on the basis of four to one European, the net debt per head of the population would be £69 10s. 11d.

#### Magistrate On Suspended Sentence

"We get Natives brought here day after day," said Mr. F. R. Barratt the Magistrate in a fraud case at the Durban Police Court, "and very rarely does anybody come into court and plead for a suspended sentence for them, although I sometimes give it to them, but as soon as a White youth appears we immediately get clamours for a suspended sentence."

#### Durban At Empire Exhibition

Durban Corporation has agreed to guarantee £10,000 for the City's stand at the Empire Exhibiton at Johannesburg next year. This decision was arrived at by the City Council on Monday on the understanding that, in anticipation of the support of the local commerce and industry, the Council's expenditure in this connection will not exceed £6,000. The Chamber of Commerce and the Chamber of Industries will be invited to nominate two representatives each to join the Council's sub-committee. Provision will be made in next year's Municipal estimates for the net expenditure of £6.000.

Intruder In General Smuts's House

At last a tribute has com; from one European Paper the Natal Advertiser in its issue of December 5 says:— Whether our community is to-day as airminded as some people would like it to be is a question folk may answer for themselves. It is certain however, that it is more air-minded than it was a couple of weeks ago, and for this the three visiting Indian airmen have to be thanked. They have done what no European pilots have yet done in this part of the country. One can almost think of these Indian aviators as a happier variant of the Pied Piper of legend; chanting the children away to fairyland but then bringing them safely back again to their waiting parents when the unforgettable odyssey ended. No doubt the Mayor and Council, many of whom were guests up aloft of the flying men, thanked Mesers. Singh, Dalal and Puckhanavala for what they have done for Durban. But the reall, imperishable thanks subsist in the remembering hearts of hosts of little ones to whom sirmen and planes will long be a waking dream too glorious to be released from the clutched grasp of recollection,

Indian Hawkers On Strike

The Estcourt Indian fruit and vegetable hawkers boycotted the Borough Market last week. This arose out of a number of innovations that were introduced by the Town Council including a rearrangement of the tables and standing accomodation for thos, attending the sales. Under this scheme the places for Europeans and non-European buyers were set apart. The new arrangement however did not work because the European buyers crowded in on to the non-Europeans and displaced them. The Indians thereupon, as a mark of protest left the market hall in a body. The potentiality of the Indian purchases were evident when after their boycott fruits and vegetables were sold at incredibly low prices. Boxes of papawe, for instance, realised 1d. while large casks of banauss were sold for 1/-. The market suppliers definitely suffered a severe loss due to the Indians action. The Council has however, altered their new arrangements and old order maintained, in so far as the standing accommodation is concerned, this brought about satisfaction to the Indian buyers, and the last mid-week market was filled to capacity with Indian bayers who as usual bought their requirements in bulk paying high prices.

#### "Our Real Job Is In India"

At a reception given in his honour in London which is described as being one of the largest and most impressive offered in recent years to any Indian visitor, Pandit Jawaharlal Nehru said: "The real job of India," lies said: in India. It is our job, and it is absurd to expect others to undertake it. We must look at it from our viewpoint. But nevertheless, it is an immense consolation and encouragement to us to realise that in England and elsewhere we have countless friends standing for what they and we consider to be a righteous cause." Continuing, Pandit Jawharlal said that he experienced difficulty in expressing himself after his long seclusion and even if he wished to discuss the Indian situation that was almost impossible for he had left India in such a hurry as to have no chance to pick up the threads of what had happened. Moreover it seemed to him years since he had conversed with his old colleagues, whose common experience was that they rarely met each other for "if one was out, the other was in''' (laughter),

Referring to world happenings the speaker said it appeared to him so strange at the moment, that, probably, the only true perspective could be obtained by standing on ones head. (Laughter.) He did not consider any suffering and service on his part as a sacrifice, because there really was no sacrifice in doing the job one wanted. The sacrifice was on the part of India and her millions, but although they still had to cross the desert and fill the waters with their tears their cause must prevail. Cheers.)

#### A Good Retort

In a recent speech at Madras, the Most Rev. the Metropolitan of India tried to refute Mahatma Gandhi's views says the *Indian Express* (Madras), about conversion by asserting that only a change of heart brought about by allegi

ance to Jesus Christ can bring about peace and end international strife. A speaker at the Y. M. C. A. Athenæum gave the retort courteous by suggesting that the proper place to start evangelism, is west of Suez and the proper objects of such evangelism, the professed Christians of Europe. The Christian Missionaries of India must be utterly lacking in a spirit of humour when they talk about the miraculous effects of conversion at a time when Italy, the centre of Catholia Christendom, is engaged in a most unjustifiable and brutal outrage on a weak country and Germany, the home of Protestantism, is engaged in reducing her highly cultured Jewish population to the position of Indian untouchables. The Missionaries seem to be generally unaware of the saying of their master that one should not complain of the mote in another's eye forgetting the beam in one's own. If all the Catholic Missionaries in India start for Italy and the protestants for Germany, it would be a convincing demonstration of the power of evangelism. As it is, the Christian Missions in Asia and Africa are merely agencies for the spiritual demoralisation of the politically conquered countries.

#### The White Delegation

Commenting on the absence of an Indian on the Empire Forestry Conference held recently in South Africa The Leader (Allahabad) says: A statement issued by the director of public information explains that the Government could not depute more than one representative on account of financial stringency. We recollect that when the Government restored the cut in salaries it was announced that the finances had improved. But even supposing that there is such a financial stringency, why could not the one delegate sent by the Government of India be not an Indian? As regards provincial representation, the director of public information says that the provincial Governments who agreed to send representatives, had no suitable Indian officer to recommend. Will the director of public information convey the information to the department of Education that as long ago as 1917 the Public Service Commission recommended in regard to the recruitment of the scientific and technical services that a determined and immediate effort should be made to provide educational facilities in India so that those services should eventually be recruited entirely in India? What have the authorities concerned been doing all this time if they are not able to furnish one single suita le Indian who could represent

India at the Forestry Conference? We hold the opinon that by sending an exclusively white delegation to South Africa the Government have done a great disservice to India regarding whose culture and civilisation there is already so much misunderstanding in South Africa. It would have been better if no delegation had been sent at all.

### Viceroy-elect's Daughter Assaulted

The London correspondent of The Statesman says:

Lady Anne Hope, eldest daughter of the Marquess of Linlithgow, India's Viceroy elect, had an unpleasant experience while motoring alone from Stirling to Linlithgow. She stopped near Grangemouth and asked a workman standing on the Roadside to direct her to the Edinburgh-Linlithgow road. The man saying, that he was going that way jumped into the car and directed her down a side road. Then he sprang at her throat, thrust her out of the car and drove off. Lady Anne Hope made for the nearest police station and the car was found later by the police abandoned at a distance of 200 yards from the scene of the incident, Apart from theshock Lady Anne Hope was uninjured.

#### Indian Colonization Centenary.

Mr. T. K. Swaminathan, Editor of the Indian Colonial Review, has been deputed by the Indian Colonial Society to visit. Mauritius in connection with the celebration of the Indian Colonisation Centenary. After completing his work in Mauritius, he will visit Seychelles, Reunion, Madagascar, East and South Africa, the West Indian Colonies of Jamaica, and Trinidad, British, and Dutch Guiana, Canada, Fiji, Indo-China. and other lands practically covering all Indian settlements. He will study the condition and status of Indians in these places with a view to bringing about a closer and more intimate acquaintance of Indians at home and abroad for promoting the material and cultural uplift of Indians scattered all over the world.

#### Habibullah Becomes Nawab

The Maharaja of Travancore held a grand State Durbar on the eve of his twenty-third birthday recently and among the titles Nawab was conferred on Sir Muhammad Habibullah who is an ex-Member of the Madras Government and ex-Member Viceroy's Executive Council has been Dewan of Travancore since March 1934. Sir Habibullah headed the Government of India delegation to the first Round Table onference which resulted in the Capetown Agreement.

#### Earthquake Shocks In India

#### Communal Rioting At Lahore

Three were killed and 25 seriously injured says a Reuter's message from Lahore, as a result of serious communal rioting in the city. British and Indian troops were called out to restore order. A curfew order was promulgated and the Royal Scots, assisted by the 14th Punjab Regiment, were patrolling the city, pulling away sticks, swords and other weapons from the hands of rioters. The entire police force was picketing the city under the guidance of European officers. The police fired two shots on Saturday night to disperse a mob. A police officer, unable to control the mob, fired two more shots on aturday morning, but nobody was injured.

# 'ADVERTISER' DEFENDS THE AGENT

The Ndid! Advertiser writes the following leading article under the caption "A" Foolish! Protest" in its issue of Monday, December, 9:—

NCE again it is necessary to remind certain sections of the Indian community that, however commendable may be the spirit which moves them to such courses, the tactics they are adopting in making known their sectional differences are calculated to hurt rather than to improve their coliditions in this country. A little while ago, the Agent, speaking at New castle, said a very wise thing when he deprecated the growing habit of certain of his own people to take offence at the application of the word "coolid" to the podrer Indian in our midst. He told his heard's what the word actually means in" the widespread form employed in India. He reminded them that, in actual fact, the first people brought to this country from India actually were of the coolie class, and he' besou ht them not to add to their many problems in South Africa by exalting a matter of terminology into an affair of first class political significance.

But any stick, it seems, is good enough to beat a dog with! Yesterday a mass meeting of Indians was hild in this town when "strong resentment" was expressed at the Agent's Newcastle speech which was described as "a gratuitous insult to the Indians who were introduced into South Africa and their descendants." The resolution furthermore protested to the Gove nment of India against the action of its Agent in this country.

Well-wilful men will have their way, and our friends of the Colonial-Born Association are sometimes extremely wilful! There is such a gulf between the Agent's wise and sagacious attitude towards a widespread, even if erroneous terminology, and the hypersensitive point of view of the protestors that nothing will ever bridge it. In this case, what do the Colonial born expect? Do they want people to stop using the word 'coolie"? If this is their aim they are going the wrong way about it. A great many people do not use the word; we think an increasing number; because all those who have liberal and humane views on the Indian question are careful not to add to the grievances, imaginary as well as real, that the In lians suffer. But those who use the world purposely and con temptubusly are not likely to be dis tressed who i they watch their victims getting hat under the collar about it, and putting their own Agent in the prisoners nox because he speaks sensibly

and tolerantly about it. Surely it should be manifest to the meanest intelligence (and much Indian intelligence is far from being mean) that the only way to persuade people to abandon a word that they employ as a term of contempt is to show them that the victims of that word are deserving of something better than contempt. Every boy who has graduated in the school playground knows that the school bully only uses certain epithets towards his victoms so long as he sees them squirm under the same. Once they treat him with disdain he ceases his silly and profitless methods. If our Colonial Born friends, will insist on making a first class issue of this matter; if they will insistaon! holding up their own Agent to public opprobrium because he speaks sensibly and understandingly about a subject that is outside the scope of political action; then a section of the European community will continue to employ the term, and the ZAT of the Indian continue to be wounded. More important still, the Government of India, which must accept the point of view of its Agent rather than that of his detractors, will increasingly realise how difficult it is to help a community in its real grievances that is so bent on magnifying imaginary ones.

# The Sporting World

#### Tribute To Indian Sportsmen

66 CYPHER" in the Natal Advertiser writes:—Of all the tributes paid to the memory of H. B Cameron I do not think there was a more appealing one than the wreath sent by "The Young Muslim C.C." of Durban; this coming on top of the garlanding of Wade, Siedle, Dalton and Nonrae by the Indian cricket community on their return. These are spontaneous actions brought about in the very tracet spirit of sportsmanship. The Oriental in many ways may be different from the Occidental. His outlook may be different, but fundamentally he has the same ambition—to be a sportsman.

#### Spirit Of Sportsmanship

One of the most painful inciden's in my official connection with sports, the same writer says, occurred when I was a member of the council of the South African Amateur Athletic and Cycling Association some 23 years ago. We were collecting money for the 1912 Olympic Games, in which South Africa did so extremely well. We received a donation of £50 from the Johannesburg Chinese community. The letter covering the gift was worded somewhat as follows:--" Al--though we are not permitted to enter the Wanderers Grounds and see your athletes in action, we are sending you this cheque in the spirit of sportsmanship." I believe this action of the Chinese community had the effect of removing the anti-Asiatic embargo which the Wanderers Club had laid down."

It should be noted however with regret that once again there is a move to close the Wanderers to non-Europeans.

#### Opinion Abroad

The Sunday Express says:-When the Indian spoor team played in S.A. a couple of years ago, they astounded everyon by the calibre of the football.

Recently an Indian hockey team toured Australia and New Zealand and once more astounded the home sides by their ability. They won every one of the games they played.

The side contained only three Europeans. Members of the team, discussing their success, attributed them to their own possession of and the Australians lack of-anticipation. They accounted for this because they were not coached and had to teach themselves. By this means they learned to watch opponents better and at the sam , time to keep their eyes on their own men, who were better positioned.

The feet of native football players are as iron. The people of India and Afghanistan also play football in their bare feetand teams of English soldiers find them "easy meat." The sturdy Gurkhas are passionately fond of the game; they play it for hours on end in any temperature with surprising vim and skill. When British troops are playing among themselves in India, thousands of natives closely watch the play, note all the moves-and then practice them assiduously. What a native football player most admires in British play is the ability of a man to kick the ball without stopping it first. A great weakness of most native footballers is their imbility to give a "first-time" kick.

### Things In General

The Control Of The Liquor Traffic

Dr. F. G. Cawston writes :-

WHILST recognising shortness of food as a serious cause of tuberculosis, the sale of inferior liquor is responsible for the disease among the natives of Mozambique and among the poor of all races in the Union. Immigrants from countries where wines are made are unlikely to appreciate the importance of the Islamic law of abetinence from intoxicating liquor. The use of wine would appear to be intimately associated with the religion of the Jews and the large number of persons of Jewish origin who are now entering the Union will render the control of liquor drinking an ever-present one. Persons who use alcoholic in moderation in their own homes will not readily appreciate the harm associated with its consumption by others. The profit derived from the sale of even nuwholes..me beverages would seem to constitute a serious problem, and public opinion against illicit liquor-drinking in towns would seem to be too weak for the recommendation of the police to be accepted without question. All who have the interest of this country at heart and do not favour any one section to the detriment of others must realise that far too large a proportion of alcohol is being consumed by persons who have no right to obtain it and by others who cannot take it with the moderation required. Arguments for the employment of alcoholic beverages in wine-growing districts do not necessarily apply to other parts and, whatever support moderate drinkers can glean from the Bible for the use of wines in their homes, total abstinence is in entire conformity with the principles of Christianity in this and other lands.

#### New Nairobi Stamp Issue

An interesting change will take place in East African itamp issues on January 1. The currency of Zanzibar is being altered from the rupes to the East African shilling and cent. denomination and as a consequence all the pretage stamps of the Protectorate will be altered. It is unlikely, however, there will be any radical changes in design and the head of the Sultan will figure as before in the values.

Privy Council Appeals

The Judicial Committee of the Privy Council was anxious to make it clear that they did not desire to encourage appeals from the Supreme Court of any one of the Dominions, or to enlarge the class of case in which such appeals were entertained, said the Lord Chancellor in announcing the decision of the Committee in granting a petition seeking leave to appeal from a decision of the High Court of Aus ralia. The Lord Chancellor added says a Reuter's message from London that a prima facie decision of the Supreme Coart of Australia or other Dominions was final. In order to justify the grant of special leave to appeal against such a decision there must be a case involving some difficult question of law or fact, and it must be a matter of great public interest and importance.

મે થાેકુંજ ધાર્યું હતું કે કુલી શખ્દના પ્રયેણની ચર્ચામાં કરી ઉતરવાની ક્રજ અમારી િઉપર આવી દુ:ખદ 'નાટાલ એડવટ્રીઇઝર' જો વૃષ્ણમાંગી પડશે. શીખામણ આપવા કુદી પડેલું નહિ હાતે તા ં અમારે તેમ કરવું નૃક્ષિ પડત. અમે જાણીએ ' છીએ કે આપણામાના કેટલાક ભાઇઓ છે કે જેઓ પોતાના ભાષ્ટ્રેઓને <sub>(</sub>ઉતારી પાડવાને એક युरापीयन भात्रती सहायता भेणववानु अहहभर સિંહ કર્યા બદલ જતે શાળાશી લઇ રહા હશે. પરંતુ અમારે કહેવું જોઇએ કે કો પણ હીંદી કે જેનામાં સ્વમાનનો છાંટા પણ હશે તે 'સ્પેડવર્ટીઇઝર' ની ટ્રીકાની સામે અપવાદ લીધા વિના નહિજ રહે. અમુને તાજીબી થાય છે કે સાઉથ આદિકા જેવા એક સુધરેલા દેશમાં જ્યાં વિચાર અને વાણીની સ્વતંત્રતા **ઉપर रुदेश पृथा अर्धिश मुधाना सामे सफत** વિરાધ દર્શાવવામાં આવે છે તેમાં 'નાટાલ ં એડવર્ટાઇઝર' જેવું મત્ર, કે જે બીજી રીતે ઉદાર મત ધરાવતું હાવાના પ્રતિષ્ટા ધરાવી રહ્યું છે, ते हीं श्रीकाती सेंध वर्ण, हे कीने गमे तेवं અસત્કારી છતાં સાઉથ આદ્રિકા સિવાય બાજાં એક વતન નથી, તેને એ સ્વતંત્રતા ભોગવતા રાેકુ છે. ગયા રવીવારતી માસ મીટીંગ કંઇ ન્દ્રાની નહેાતી. આદ્સા ઉપર માણસાથી હાલ ચીકાર ભરાઇ ગયા હતા. અને અમે હિંમતથી કહી શકોએ છીએ કે તેના કરતાં ચાર ગણા હીંદાઓ એ માટીંગમાં તેઓએ હાજરી ન દ આપેલી હોવા છતાં હીંદ સરકારના એજન્ટે "કુલી" શબ્દ વિશે કરેલી ઉક્તિની સામે માનસિક વિરાધ દર્શાવી રહ્યા હતા. તેમ છતાં એ માટીંગ 'એડવર્ટાઇઝર' ને તેના હેવાલ પ્રસિદ્ધ કુરવા જેટલા અગલની નહિ જણાઇ. તે ક તટલા વધા લોકોને જે વસ્તુ તેઓને બાડી જેણાઇ તેના સંબધમાં, પાતાની લાગણી વ્યક્ત કરવા બદલ દેપકા આપનારા એક અત્રક્ષેખ લખી નાખવા પુરતા, તે અગુસની જુણાક છે ં એવાં માટી માટીંગનો હેવાલ પાતાનો લોપોર્ટર માટીંગમાં હાજર હાવા છતાં 'એડવટાલઝરે.' પ્રતિહ નહિ કર્યો છતાં જે અન્ય સ્વલેવી કંઈ પણ રીપાર્ટ માકુલુકામાં આવેલા હોય તા તેનાં વજીક નહીં હાય તાે પણ તેને પ્રસીહિ મળી શકે છે.

પત્રકારિત્વનો શિષ્ટાચાર આવી જાતના દેશની છુટ મુકે છે કે કેમ એ તા ભાદ વધ 'એડ-વર્ટાઇઝર' અમારા કરતાં વધારે સારીરીને જાણે, પરંતુ સાધારણ અક્કલની દ્રષ્ટિએ જોતાં અમને નથી લાગતું કે એવી છુટ તે આપતા હોય. ભાઇખધ 'એડવટીઇઝર' થી આ પગલું સત્તાના ચાય નીચે રહીને સત્તાને ઉડાવી દેવાને અસમ**ર્ય** એવા હીંદીઓની સામે લેવાની ધૃષ્ટતા થઇ શકી. પરંતુ અમે પુછવાની રજા લક્ષ્મે છે છે કે જો તેટલાજ યુરાપીયનોએ એવા વિરાધ દર્શાવેલા હાત તા શું તેઓના અવાજની તંત્રીનો ખાંમા થઇ જવાનું જોખમ ખેડ્યા વિના તેનાથી ધૃષ્ટતા થઇ શકત ખરી કે? એ વિશે અમને ધણીજ શંકા રહે છે. પરંતુ આ અપમાનના પ્યાલાને માટે કામે કોંગ્રેસના આપણા માત્રાનેજ આભારી થવાનું છે કે જેઓને દેખાતી રીતે પાતાને કુલી કહેવામાં આવે કે કુલી જેવું વર્તન બતાવવામાં આવે તેમાં કશું અપમાન નથી લાગતું.

હવે મૂળ મુદ્દાપર આવીએ. 'એડવર્ટામઝર' હીંદાઓને ચેતવણી આપે છે કે એક શખ્દાયંની બાબતને તેઓએ મહાન રાજદારી અગત્ય આપા નહિ દેવી જોઇએ. અમારે કહેલું જોઇએ કે આ દેશમાં હીંદાઓને માટે રાજદારી સવાલ જો કંઇ પણ હોય તો તે જે રીતે તેઓની તરફ હલકી નજરે જોવામાં આવે છે અને ગેરવર્તા હક બતાવવામાં આવે છે તેજ છે.

પ્રથમ તા આપણે "કુલી" શખ્દનોજ વિચાર કરીએ. હીંદ સરકારના એજન્દ સાહેલ કહે છે કે એ શબ્દમાં કશું અપમાન છેજ નહિ. ગુલાયાના અ'ધકારના દિવસોમાં ગુલામા રાયનારા લોકા પોતાના ગુલામાને જે રીતે યોલાવત્તાને ટેવાયેલા હતા તે રીત આંજના સુધરલા જમાનામાં અપમાનભરેલીજ ગણવામાં આવે છે. હીંદના અસંજને કાધારણ રીતે "ઢેડા" તરીકે એાળખવામાં આવે છે. એ શબ્દ આટલાં વર્ષો થયાં અપનાનભરેલી ગણાતા નહોતા અને તેમાં કશું હિણ્યત ગણવામાં આવતું નહોતું. પરંતુ એજ શબ્દ આજે અપમાનભરેલી ગણાય છે અને તેના બદલામાં "હરિજન" શબ્દ દાખલ કરવામાં આવ્યો છે. આ દેશમાં તેડીવાને માટે "કાકર" અને "તીયરે" ત્રાબદો એ કે

અણઘડ ક્ષેણે તરકથી આજે પણ વપરાય છે છતાં. તેડીવાને એ શબ્દો અપમાનભરેલા લાગે છે એ વીષે જરાયે શંકા નથી. અને સંસ્કૃતિ પામેલા યુરે.પીયના तेभक् હીંદીએા કહીનેજ **બાલાવે છે**. નેટીવેા "કાકર" કે ''નીગર" નો ભાગ્યેજ પ્રયોગ થાય છે. એજ પ્રમાણે અંપ્રેજીમાં "નેવ<sup>ુ</sup>" શબ્દ મજીરને માટે છે. પરંતુ જો કાઇ ધુરા-પીયન મજુરતે "તેવ" શબ્દ્યી પોકારવામાં આવે તા તે બીલકુલ સહન નહિજ કરે. તેમ કાંઇ યુરાપીયનો તેઓને "નેવ" કહી બાલાવતા સાંભળવામાં આવ્યા નથી. સારે હવે "કૂલી" શબ્દમાં અપસાન નથી. એવી દલીલ ચકજ કેમા શકે! અધકારનો જમાનો આપણે પસાર કરી ' છીએ. આ સુધરેલ જમાનામાં બજીરીમાં માન સમજવામાં આવે છે અને તેવી મજૂરને માટે પણ માનભરેલીજ સંજ્ઞા 'હોવી' જોઇએ.

હવે "કલી" શખ્દોા સાઉથ અપ્રિકામાં હોંદીઓ માત્રે જે રીતે ઉપયોગ થાય છે તે તપાસીએ. હીંદુસ્તાનયી આ દેશમાં મજુરાતુ પ્રથમ દાખલ કરવામાં .સ્તવ્યા ત્યારે કોદીસોતે. સામાન્ય રીતે કુલી કુકી બાલાવવામાં આવતા હતા અને "કુલો" તરીકેનો વર્તાવ મળતા હતા. મહાત્મા ગાંધીજી આ દેશમાં આવનાર પ્રથમજ સંસ્કૃતિ પામેલાં હીંદી હતા. જો કે તે વખતે હોંદી વેપારી વર્ગ વધારે સારા હતા તેમ સુશિક્ષિત કાલાે નીયલ બાર્ના પણ હતા. મહાત્મા ગાંધીજીએ અહિ આવી શું જોયું ? તેઓએ જેવું કે ગમે તેવા સ'સ્કૃતિ પામેલા હેાવા છતાં યુરાપીયનોની નજરમાં તેો તેઓ કેવળ કુલીજ હતા. યુરાપીયન વર્તમાનપત્રોમાં તેઓને "કુલી લાયર" તરીકે ઉદ્દેશવામાં આવતા હતા. એક સુસંસ્કારી હોંદી મહસ્ય તરીકે પાતાની હુક સ્થાપવામાં તેઓને અનેક દુરમા સહેવાં પડ્યાં હતાં. હીંદી મજુરાને લગતા તે વખતના કાયદા કુલીના કાયદા તરીકે એાળુખાતા હતા. આ હીંદીઓ તરકની ગેરવર્તા હકતે લીધે, અને વેપારના હકા છીનતા ક્રેવામાં આવ્યાથી હોં દૂરતાનથી વધુ હોદી મજીરા માેકલવાનું ક્ષાંધ થયું હતું અને ભવિષ્યમાં હીંદીઓ તરક સારી વર્ત છુક બતાવવામાં આવશે એવી ખાત્રી મળ્યા **બાદજ મ**જુરા માેકલવાનું કરી શરૂ કરવામાં આવ્યું હતું. અને તે વખતે કાયદામાંથી, કુલી શબ્દ કાઢા હોંદી શબ્દ વાપરવામાં આવ્યો હતેા.
