## NOTES AND NEWS

**WE** tender our apologies to the readers of *INDIAN OPINION* for the reduction in pages of reading matter which will continue to be so for the next few weeks. For reasons unavoidable we have had to do this.

### "Cultural" Segregation

South Africa is evidently aiming to occupy a position which would be unenviable. Segregation, which in so far as South Africa is concerned, is a pass word to any one desiring an entry into Politics, has spread its tentacles to culture also. Recently a request has been made by the Peninsular Joint Committee of the *Federasie van Afrikaanse Kultuurverenigings* to the University of Capetown that Coloured students should be segregated. The matter has been referred to the Council of the University for consideration, but it would appear that it is not likely that the Council will make a move, at any rate for the present, in the direction of segregation. It is pointed out that the number of coloured students is so small that extra expense would not be justified and the students who pay the same fees as the students are entitled to the same tuition. Cultural World would be surprised to learn that South Africa has sunk so low as to ask for segregation in culture also.

### A Plea For Tolerance To Jews

Speaking at Johannesburg in support of the candidature of Mr. M. Kentridge, the Minister of Mines, Education, Social Welfare and Labour, the Hon. J. H. Hofmeyr, said "it is very necessary that in South Africa we should have Jewish South Africans of the calibre of Mr. Kentridge in Parliament, especially to-day, when we have the official opposition directly and indirectly to preach the evil doctrine of anti-Semitism. "If you want freedom for yourself, you must be prepared to be tolerant towards others. To preach this doctrine of anti-Semitism is a blot on the good name of South Africa."

No betrayer sentiments could have been expressed by Mr. J. H. Hofmeyr. The purified nationalists who claim to have under gone considerable sufferings and who know what suffering is, should not endeavour to persecute the Jews of the

country. In these days one forgets that "he that rules by sword shall perish by the sword."

### Women's Movement In India

Presiding at the 13th anniversary of the Sri Sarada Niketanam at Guntur, Mr. A. Kaleswara Rao, Chief Parliamentary Secretary of the Madras Government, observed that "a great women's movement is growing up in India. The women of Turkey have fought shoulder to shoulder with their men for achieving the freedom of their Motherland. As soon as freedom was achieved, the religious institutions that were a hindrance to women's progress were thrown away, purdah was completely discarded, and women were given equal political, social and economic rights with men. Similarly in India, we are passing through a social evolution. The old ideas of Manu that women should always be subordinated to men is given up and women are claiming equal rights with men. They have also gone to jails in thousands for getting freedom for getting freedom for India. As we get Swaraj, legislation will be passed to give equal property and social rights to women with men."

### Abyssinia Again

Abyssinia is in the news again. The world is in such a turmoil that one does not know where one stands. Each nation is keen on saving its own skin. Great Britain which should have been the arbiter in the Italo-Abyssinian dispute and which has already claimed to stand as the defender of smaller nations, has now entered into an agreement with Italy, the terms of which are:

(1) Britain will ask the member States of the League to recognise the conquest of Abyssinia by Italy.

(2) Both countries agree that the Mediterranean is vital to their interests.

(3) The two countries will exchange information regarding their fortifications in the Mediterranean.

(4) Italy will place no obstacle in the way of British administration in Palestine.

(5) Italy will withdraw a part of her troops from Libya.

(6) Both countries agree that the Suez Canal shall be kept open to all ships at all times.

And that, we say, is the last straw which will break the camel's back. We are pleased to learn that ex-Emperor Hailie Selasie will resist the Agreement.

### The Indian Eisteddfod

The Vernacular Session of the Indian Eisteddfod commences on the evening of Friday the 16 instant at the Carlisle Street Indian School, and will be continued the whole day on Saturday the 17th at the Sastri College. Saturday will be devoted to public speaking and musical competitions. The sponsors of the Eisteddfod inform us that the entries in the vernacular section are large, and the competitions will, in consequence, be highly interesting. They expect a large attendance at the sessions. Last week we had occasion to remark on the bad seating accommodation at the Carlisle Street Indian School. We are happy to state that proper arrangements have now been made for seating. The Eisteddfod has been providing us with excellent treat since the opening, and the adjudicators, both European and Indian, who have come forward to adjudicate without any remuneration, are to be warmly congratulated. A representative of this journal attended two of the sessions, and one thing that has struck him remarkably is the keenness that is being shown by the competitors. In public speaking the competitors showed that they had attained a standard which would be a credit to any community. Mr. C. R. Warriner, who is the President of the Indian Society for the advancement of music and art, is making the Indian Eisteddfod his life work, and he thoroughly deserves the thanks of the Indian community.

### The General Election

HERE is an old saying in the vernacular, which, when translated reads, "who cares whether Shri Rama reigns, or Ravanna reigns, for, we remain what we are." It is a saying that at once reveals the fatalistic turn of mind exhibited by the Indian. Applied to the South African General Election which is now in full swing, the saying very aptly gives one an idea of the position that the Indian finds himself in, in the present election.

Dispossessed of the franchise, we find ourselves in a peculiar position, for, having no say in the governance of the Country, we, must needs be content with whatever crumbs that are thrown at us. Whether the United National Party, the Purified Nationalist or the Dominion Party comes into power, we still remain an unfranchised community in the population of South Africa. Even the Natives of this country have some semblance of representation in Parliament. We can only pray that whichever party comes into power, it shows a sympathetic attitude towards our community.

We pointed out a few weeks ago, that what South Africa badly needed was a liberal outlook. We do feel that the Europeans of this country overdo their game of politics. To them politics, it seems, is the be all and end all of all things. Rather they should concern themselves more with pushing South Africa forward. It is in this game of politics that the Indian is made the pawn. It is fortunate, that in this General Election, the Indian question is

not a plank in any of the platforms of the various parties. Here and there, one does hear of some candidate going "all out" on the question. The other day we had an instance of one purified Nationalist Member suggesting capital sentence for mixed marriages. He, however, failed to say whether the capital sentence was to be inflicted on both. It was crass stupidity to make such a suggestion. But there it is, we cannot answer back. Nor can any European for that matter, for fear of being called a friend of the "coolie."

As we have said, no matter whatever party comes into power, we shall have to sit and watch. In the present cabinet we had in the Hon. Mr. J. H. Hofmeyr, an advocate of justice and fairplay for all, irrespective of colour or creed. His attitude of the Indian question has been the cause of several "upheavals" within the Cabinet. The fact that he had survived those "upheavals" against tremendous odds, bears striking testimony to his character. South Africa needs many more Hofmeyrs before the Indian community of South Africa can have its much deserved rest.

The South African Press is fully occupied in giving the fullest publicity to all what the parties have to say. The reports, sometimes, afford amusing reading, especially when the leaders vie with one another on the definition of words, or when they turn their old files to find what their opponents had said ten or even twenty years ago. How far does the average voter concern himself or herself with what is said by the leaders? In our opinion, what the voter wants to know is "which is the party that is going to deliver

the goods." The party that is more concerned in giving the country an intellectual exercise is certainly not going to deliver the goods. Viewed from the European standpoint, the United Nationalist Party has done more to stabilise South Africa which now enjoys a position of security in the world. We feel that having done so much for South Africa and her people, the United Nationalist Party deserves the warmest support of the voters. For the first time women are going to cast their votes. For all we know, it may be that women voters will hold the balance of power in South African politics.

Three parties have been in power since Union, the South African; the Nationalist and the United Nationalist Parties. None of these parties has exhibited any feeling for the Indian. Each party has had its share of anti-Asiatic legislations. And none has spared the Indian. We will continue to occupy the position of inferiority so long as we are denied the franchise. Recently the Natal Indian Congress presented a petition to the Natal Provincial Council urging the restoration of the Municipal franchise. That petition has been thrown out. The petition unfortunately was half-hearted, and did not have the backing of the people. By that, we mean that an appeal for the restoration of the franchise should be made not by way of petition signed by one or two persons, but it should emanate from the Indian community of Natal as a whole.

The result of the General Election will be known within a month. For ourselves, we shall be content to see the United Nationalist Party again leading the country. The occasion demands a united front for the Indian community and that is the only sure way of making a bid for the franchise.

# Things In General

## Lay-Out Of Warwick Avenue Area

STRONG opposition was voiced by Indian owners in the Warwick Avenue slums area when they met the Public Health (Slums) Committee to discuss the amended layout of Warwick Avenue area. The amendment from the original plan involved the creation of a transverse road between Acora Road and Etna Lane. As a result of the opposition the Committee decided to abandon the amended plan and resume negotiations on the basis of the original lay-out scheme. On Friday last the owners attended the final meeting with the Slums Committee to make final agreement regarding the alteration of their premises to satisfy the authorities.

## Slum Clearance In Durban

Durban's "Vile Spot No. 1"—Orient Lane, Mayville—is to be wiped out at an initial cost of £1,343. This is the price of expropriation of the 17 main sites in the area which the Corporation has to pay under the Minister's expropriation sanction, which was granted on January 14. Six Indian owners are involved. One is to be allowed to occupy an existing house for six months and another is to hand over the premises on July 1. The other properties pass into the hands of the Corporation on transfer. The City Valuator and Estates Manager, Mr. A. E. Mallinson, has been instructed to cause all unoccupied buildings to be demolished as soon as the tenants have vacated them.

## Natal Indian Youth League

The Natal Indian Youth League held its annual general meeting in the Hindu Tamil Institute Hall, Cross Street, Durban, on Sunday, April 3. The secretary outlined the activities of the League for the past year, the most important items being the League's lower rent campaign. It was stated that Indian tenants in Durban were compelled to pay excessive rents and that Indian landlords were taking advantage of their tenants. The report condemned the attitude of the landlords towards their tenants. The chairman, Mr. S. Rajah, endorsed the report. The treasurer's books reflected a credit balance of £3 10s.

## Mr. Justice Krause

Mr. Justice F. E. T. Krause, Judge-President of the Orange Free State Provincial Division of the Supreme Court, who retires on pension on April 29 on reaching the age limit, has been appointed by the Governor General to continue to act as Judge President of that Division until his permanent successor is appointed.

## Forty-seven Accidents In Durban Last Week

Forty-seven accidents in which motor vehicles were involved occurred in Durban between April 3 and 9 inclusive. In these, 12 people were injured, several of them seriously.

## A Well-merited Tribute

The new Agent-General for India in South Africa, Mr. Rama Rau, is due to arrive in May. "Whenever I hear of the appointment of a new Agent-General," says a colleague, "I always think of the first, Mr. Srinivasa Sastri. A great statesman and a greater scholar, he did much in his period of office about 10 years ago to awaken South Africa to the glories of Indian literature and philosophy. It was his practice to deliver lectures all over the country on these fascinating subjects and he was always assured of a packed house. He was one of

the best public speakers in English that South Africa has known, and it was a favourite quip at the time that none of the three best English public speakers in the country was of English extraction—Mr. Sastri, Mr. Hofmeyr and General Smuts. I always remember what is probably the shortest introductory speech on record. Mr. Sastri was delivering the first of a series of lectures at the University of Capetown and the chair was being taken by Professor Eric Walker, now Harmsworth Professor of Naval and Colonial History at Cambridge. "Ladies and gentlemen," said Professor Walker, "India has over three hundred million inhabitants and Mr. Sastri has been selected out of that number to represent them in South Africa. Mr. Sastri."

## Objection To Free School Books

On the agenda of the Transvaal Onderwysersvereniging Congress that was held in Pretoria from April 11 to 13 appeared 84 motion. One of the leading matters discussed was a motion that teachers who wish to stand for election to Parliament or the Provincial Council should be granted two months' leave without pay, and that their position should meanwhile be kept open for them. Another motion desires that teacher

shall be free to take part in politics outside their school hours. Yet another is directed against the issue of free books on the grounds that if parents had to pay for their children's books more care would be exercised by the pupils. It was also submitted that experience should count more in the appointment of principals so that heads of lower schools should be eligible for appointment to high schools even if they do not possess the necessary certificates. More attention is asked for classes for sub-normal pupils, and in this regard the Department is urged to appoint more psychologists or to make other provisions for the training of teachers occupied in this work.

Some 36 leading Europeans and Indians responded to the invitation of Mr. Nathoo V. Morar, on Wednesday afternoon the 30th March, the occasion being a farewell Tea Party in honour of Captain T. W. Hepburn M.O., District Commandant of Police and Mrs. Hepburn. After light refreshments had been served Mr. Nathoo V. Morar warmly thanked Mr. Hepburn for the fair and impartial manner in which he had treated the Indian community during his term of office in Dundee. In garlanding Captain Hepburn Mr. Morar hoped both Captain and Mrs. Hepburn would be spared for many years and would enjoy their stay at Boksburg, Transvaal, where they have been transferred. Mr. Morar took the opportunity of extending a welcome to Mr. H. Barrett, the new Resident Magistrate of Dundee and Mrs. Barrett who were present. Captain Hepburn and Mr. H. Barret suitably replied. Are these youths to roam the streets hawking fruits and vegetables? Must they seek for a living in the sugar estates? Or should they appeal to our benevolent Corporation to provide them jobs on

the relief work at the handsome wages of twelve shillings and six pence a week?

You ask "Will present day youth serve his community as the youth of yesterday" that answer is obvious, it lies in the youth himself, it is up to him, he is the best judge of the grave problem envisaging him, but what is really needed is good leadership and encouragement which we are sadly lacking and above all we ourselves are hopelessly divided, let us join hands, unite against a common enemy and the young men will flock to our banner.

There are numbers of young men who are enthusiast to come forward and do their bits, but lack of encouragement keeps them back.

Give the youth of to-day the encouragement to serve his community and even the greatest optimist among us will be astounded by the response.

If any riparian owner as aforesaid do not attend, either in person or by his agent, attorney or counsel, at the time and place abovementioned, such order will be made and proceedings taken as the Court may think just and expedient.

Any person concerned is required, in case he objects to the said Assessor, to give notice thereof in writing to the Registrar of this Court on or before the second day of May, 1938, failing which notice he will be held to waive all right of objection.

His objection must state the cause for which he objects which may be one or more of the following:—

- (1) Consanguinity or affinity within the fourth degree to any of the parties or to any person who has a personal interest in the result of the application.
- (2) Having directly or indirectly an interest in the result of the application.
- (3) For having previously deliberately expressed an opinion as to the merits of the application.
- (4) Personal enmity between any party and the Assessor.

It is further notified that within four and twenty hours after the lodging of his objection he, or some agent by him authorized in writing, shall lodge with the said Registrar an affidavit setting out the facts in support of his objection, failing which his objection will be disallowed.
