NOTES AND NEWS

HE following stirring message was sent to his fellow-countrym in India by Mr. C. R. Das just after his arrest:—

"This is my last message to you, men and women of India: Victory is in sight, if you are prepared to win it by suffering; it is in such agony as that through which we are passing that nations are born; but you must bear this agony with ortitude, with courage and with self-composure. Remember that so long as you follow the path of nonviolence, you put the bureaucracy in the wrong; but note by a hair's breadth from the path which Mahatma Gandhi has mapped out for you, and you give away the battle to the bureaucracy. Swaraj is our goal, Swaraj not in compartments, not by instalments; but Swaraj whole and entire. Now it's for you men and women, to say whether we shall attain the goal for which we are striving.

To my moderate friends I say this: Survey the history of the world from the beginning of all it ness. Has any nation yet won free tom by pursuing the path which you are pursuing? If the appeal should reach any waverer amongst you, I ask him to consider whether he will now stand on the side of India in her conflictor with the bureaucracy. There may be compromise in the matter of details, but there can be no compromise in the essential question that divides us from the bureaucracy, and if you do not stand by and for india, you assuredly stand for the bureaucracy.

"And othe students, I say this: You are at once the hope and the glory of India. True education does not consist in learning to add two and two make four, but ies in the service which you are prepared to give to the mother of us all. There is work to be done for the mother. Who amongst you, is prepared to answer the call?"

Appeal of Mr. S. Rustomjee against the decision of in. F. J. Clerk in his rase in a maection with the Point trouble will be heard, we understand, on February 9. The judgment will be awaited with interest by the Indian community.

The case of Mr. Ismail (1) a (President Natal Indian Congress), Mr. Manilal Gandhi and Mr. Sorabjee Rustomjee, who was re-arrested on the charge of obstruction at the wharf, is due to be heard on the 16th of February.

Reuter (Bombay) in a message dated Jan. 19, states:—The All-India Congress Committee, presided over by Mr Gapilli, passed a resolution postponing

civil disobedience till Jan. 31, urging the Government to create a favourable atmosphere by the raising of the embargo on the formation of Volunteer corps, public meetings and the release of political prisoners. Should this step be taken, the hartals and other activities of the Congress would cease.

Calcutta, Jan. 20, (Reuter.)—A state of excitement prevails among students in consequence of 50 arrests by the police, who dispersed three public meetings, attempted in a prohibited area by the Bengal Provincial Congress, in pursuance of the policy of civil disobedience. Those arrested include speakers of the Caliphate Volunteers. A number of students attended one of the prohibited meetings in consequence of which the University authorities suspanded the college's evening classes.

A Reuter's message from Lindon dated Jan. 20, states:—The firm policy of the Government of India has been upheld in the Legislative Assembly, at Delhi, which rejected by 53 votes to 33 a resolution recommending the abadonment of the Government's policy of repression; also by 52 votes to 33 an immendment condemning both the non-co-operators' aggressive policy and the Government's policy of repression, demanding the abondonment of the present policy and the release of all prisoners arrested in pursuance thereof, and asking for a round table conference.

A Reuter's message fro n Delhi dated Jan. 21 reliports that the Indian Council of State has negatived by 23 votes to 10 the motion by Mr. Sethna, advocating a joint session of both Houses to determine the lines for holding a conterence of all shades of political opinion in India Sir Mian Shafi, who is an official member of the Council, defended the Government's policy, and emphasised that Gandhi's attitude was impracticable. He maintained that it was useless to discuss a settlement with Gandhi unless he suspended his activities and requested a conference. The Government has announced that it is considering measures to deal effectively with intimidation.

A message from Delhi states that a Democratic Party has been formed to conduct the Opposition in the House of Assembly. Fifty members have joined the House of Assembly. Fifty members have joined the party, which has been divided into five groups, each group dealing with specified subjects like finance, health, communications, commerce, and foreign affairs. The party hopes to make an effective debut by passing a resolution condemning the Government's policy. The object of the party is to secure for India the status of a self-governing Dominion as early as possible, to which end it will carry on an anti-waste campaign, and endeavour to secure fiscal autonomy and the largest measure of provincial autonomy, the Indianisation of all services, and the adoption of every measure to bring about the complete responsibility of the Executive to the Assembly.

PROPERTY. . London, Jan. 18 .- Reuter .. understands . that the strictest secrecy has been maintained during the negotiations in connection with the status of Indians in East Africa, but it is believed little progress has been made hitherto, owing to Mr. Churchill being immersed in the business of handing over the government of South Ireland. As soon as this is fairly completed, it is anticipated that conversations will be resumed between Mr. Churchill and Lord Delamere, who is the protagonist of the European residents in Kenya, After this Mr. Churchill will probably see the Indian deputation which has been strengthened for the purpose of the negotiations, and will comprise Mr. Jeevanjee, an East African, Mr. Polak, a London barrister, and (Colonel Wedgwood (Labour M.P.). It is rehably stated that the demands of the Indians have been broadened to include besides equality in regard to voters, the test of any written or spoken language instead of English only, also no reservation of seats in the legislative body. In view of the position, considerable interest attaches to the East African dinner in London on Jan 27, at which Mr. Churchil will be the principal speaker.

earthe, 🤼 Nairobi, Jan. 17 (Reuter).—The following resolution was passed at a largely attended meeting of Indians:—
(1) "Request the Government speedily to put into practice the principle of equality of status enunciated at the last Imperial Conference respecting the Indians in the colonies, especially the Crown Colonies and Protectorates. (2) Conveying this opinion to the Secretary of State, that the delegation headed by Lord Secretary of State, that the delegation, headed by Lord Delamere, which is now in London, to submit the European standpoint does not represent the whole of the European opinion in Kenya. (3) Congratulating Mr. Griffith on the Irish Free State, and requesting Irish support of the Indian demand for [µll dominion Home Rule in India and the grant of equal rights to the Indians in the Colonies."

A Reuter's message from Delhi dated Jan. 18, states:—It was officially stated in the Council of State that 2,250 Moplahs had been killed, 5,727 sentenced to imprisonment, and many thousands of Hindus forcibly converted to the Islam religion. The military expenditure during the Moplah campaign amounted to 1, 500,000 rupees.

Why no figures as to the conversions of the Hindus

to the Islam faith have been given in the above message is surprising. Why, we wonder, is it put vaguely, many thousands of Hindus forcibly converted to the Islam religion! Is it a trickery to cause a split between the two sections whose unity seems to hurt the authorities? We think the time is long past to achieve that object. It is difficult to believe that the tie which was bound between the Hindus and Mahomedans as a result of the deed committed by General Dyer at the Jallianwalla Bagh would break by the fault of the Moplah's who were after all their misguided, brethren. We feel sure that the co-religionists of those who have had the misfortune of being forcibly converted will have the good sense to take them back to their own religion. But the above figures do not reflect so much upon the crimes of the Moplahs as they do upon the authorities who were, it not directly, indirectly responsible for the crim's and useless expenditure. Had the leaders not been prevented from entering the troubled parts to guide their brethren the crimes and expenditure would certainly not have reached the figures they are reported to have. But the authorities, evidently, were anxious to display the principle of "will you be governed by the pen or the sword?" And they will no doubt be credited for their performance by those who approve of their actions.

The same message further says:-The Legislative Assembly adopted, with acclamation, a resolution welcoming the Prince of Wales' visit and expressing confidence that the full measure of responsible government would not be long delayed, anticipating the day when India would take her proper place as an equal partner in the British Commonwealth of Nations.

. Whether this will be taken any notice of by the present India and under the present conditions is very doubtlul indeed.

REPRESSION IN INDIA

EUTER'S messages during the week in connection with the present sixty. : has caused a certain amount of dissatisfaction among the:Indians in this country who are watching with keen interest the movements in the motherland! They are somewhat surprised at the resolution passed by the All India Congress Committee presided over by Mr. Gaodhi. According to the resolution as reported to have been passed it would appear that civil disobedience would be postponed till Jan. 31, and that if the Government will raise the embargo on the formation of Volunteer corps and public meatings and will release the political prisoners the "hartals and other activities of the Congress would cease." That civil disobedience would be postbould is a thing that could be understood. Mr. Gandhi has already stated that that is a step which is to be taken after serious consideration and as a last resort, and that without the strictest adherence to non-violence that sten would prove greatly harmful rather than of any benefit. Under the circumstances and in view of the unfortunate riots that took place recently at Bombay if civil disobedience were to be postponed for another short period the step would not be considered to have been taken in the wrong direction. It Hartals were to be stopped even that would not be considered a wrong step. But what the people in this country are amazed at is that the Congress Committee should have decided to cause all its activities if Government were to withhold their

policy of repression. They cannot understand how the Congress could come to such a decision. The Congress would thereby be retracing its steps which would amount to an acceptance of their defeat. Even if to tothe nieds que su sew ail al ai rainciant ent repression how could the Congress cease its Swadeshe propaganda, the establishing of National schools and other institutions and the destroying of the drink gril. These activities are especial and according to Repter's afessage even these would be stopped by the Congress, which is most unbelievable.

Reuter's messages being so vague and uncertain especially with regard to India it is difficult to make out from them what the real situation is. Hence we are unable at present to exptent and opinion. Notwithstanding, however, if the situation as stated above is the true one then there would certainly be cause for disappointment, but we do not believe it to

On the other hand whilst, the All-India Congress Committee is reported to have passed the above mentioned resolution, in Calcutta civil disobedience seems to be quite strong and many more arrests are reported. And not rithstanding this resolution on the part of the Congress Committee the Indian Lagislative Assembly has by a majority of votes upheld the Government's repression policy and the Government are a considering measures to deal effectively with intimitation." Sir Mian Shah (official member of the Council) is reported to have emphasised that Mr. Gandbijg gtiftude, mas impracticable, and that "it was useless to discusse a settlement with Mr. Gandhi unless he suspended his activities and requested a conference." So fong as the Giverament de not suspend their police of repressing so long it is not likely that the Non-co-operators will cease their activities, and ultimately civil disobedience will also be added to their programme. INDIAN SITUATION

FROM AGHA SAFDAR

The following two letters were sent by Aght Saidar to Mr. Gandhi showing how the brave Punjable are being hampered and tried and proving themselves true, how the gal'ant Shikhs are delying the whole strength of the Government stupidly directed against its erate will noblest friends and supporters; and how all the Punjab leaders are working with one mind and how they are all keeping an unruffled temper in the midst of exceptional difficulty :---

At Amritsar, I hear from Girdharilal, there has happened something untoward. Shikhs were peacefully holding their public meeting when all of a sudden a few Sadhus appeared on the spot and began beating promiscuously with their iron sticks. The Sikhs remained non-violent and got a few persons injured. Simultaneously with the advent of the Sadhus there appeared the Deputy Commissioner along with police and military force on the spot. The Deputy Commissioner was permitted entrance. But the Shikh leader Gnani Sher Sinh refused official intervention and declined any help from the Deputy Commissioner. The position is said to be well in hand and no further violence is reported.

It is getting post-time. I am in hurry. It is just reported that the student maltreated by the police is

teeling well."

Nothing that I can add (says Mr. Gandhi), can enhance the beauty of the simple narrative given by the Aghasaheb. I have not altered a single word in the two letters. I bow in reverence to Lalaji and his comrades who refused even whilst under trial anything but gool food, and I tender my congratulations to Sardar Premsinh Sodhbans who conducted the meeting with such calm dignity in defiance of the magisterial order and in the face of the provoking presence of the police. I congratulate the young volunteer with his broken head. The serious afiray at Amritsar must await separate treatment when full details are available. There seems little doubt that the Shikhs have behaved with wonderful courage and restraint. When born fighters become non-violent they exhibit courage of the highest order. The Sikhs have historical evidence of such exhibition in their midst. They are now repeating their own history. Let me hope and pray that they will carry out the instructions of Sardar Khadagsinh to remain non-violent to the end, to become simple in their tastes to wear only

The following is a letter from the surviving Secretary of the U. P. Provincial Congress Committee Mr. Jairam Saksena received by Mr. M. K. Gandhi which we take it im Young India:—

Of all the local office-bearers of the U. P. Provincial Congress Committee I am the only unlartunate secretary who is yet out of jail. "It has therefore fallen to my lot to inform you of what recently tappened here.

The Provincial Congress Committee Office was scarcifed at about midnight and the registers of the U. P. Congress Committee, Executive Council and other subordinate bodies were taken away by the Deputy Superintendent of Police who conducted the search. Besides, the Khilafat Committee office and the houses of the gentlemen arrested were searched.

Lift have now started civil disobedience in Allhabad in an organised and systematic form. National volun-

teers are being briskly recruited. They have been divided into batches of a dizen volunteers each. They are placed under a captain whose orders the volunteers have to ob y implicitly. We have not published the names of our volunteers. Y sterday a batch of a dozen volunteers was sent out for a round in the city with national badges on their arms, singing patriodic songs and loudly announcing the fact of their being Congress and Khilatat volunteers They stopped for some time before the Kotwali, and there waited for arrest but though the Kotwal came out and listened to the announceme...t of the volunteers, none was taken in custody with the tesult that the batch after parading the streets of the city for some hours, came back to the Provincial Congress Committee Office most appointed and furious with themselves for not being able to join their lea ers in the juil. To day the same batch with another of a dozen volunteers paraded the town from one end to the other with badges on, openly enlisting volunteers for the national corps. It is now late in the evening and one of the batches has already returned from their round. No arrests took piace to-day.

Our volunteers behaviour has been admirable and the popular mind though considerably agitated yet is self-posse sed. The situation is completely well in hand. Our reserve of volunteers is quite sufficient for our present purposes, and enlistment is proceeding

apace.

We have filled up the v cancies in the Tow Cong. ess. Committee. The Provincial Congress Committee meets on the 13th instant, when we shall re-elect our valunteer Board in place of the one now woolly in jail; other office bearers will also be appointed."

The following is from a Labore co respondent:—

"The general atmosphere is very good. People are fearless and non-volent. The City Congres Committees are sending out volunteers to hold meetings in different parts of the town at the same hour, to read out the same written speech, and to sing the same song and disperse within ten or fifteen minutes. Yesterday (the 8th instant) twenty such meetings were held in twenty centres. On Tuesday last an attempted public meeting with Sardar Prem Singh in the chair was stopped by the Police surrounding Bandlau h Hall allowing none to enter. The people went back calmly but held a meeting all the same in an adjoining place. Some were arrested but let off after a short time. Fear of arrest or the jail is gone,"

THINGS CHAI SINK

(By Mr. M. K. GANDHI IN Young India)

To imprison those who, whither high or law, break the commandments, to treat them as common felous, to deprive them of their prison privileges, one can understand. I would not call that foul play. If you incur the wrath of one who is over you or who has you under his power for the time being, to be punished by him for your disobedience is what you expect. But if he humiliates you, if he makes your children do things you and they do not like and which you are no required in law to do, if he treats you like dut, it becomes unbearable. One learns tost in Coconada a Magistrate had the Swaraj and the Khilalat fligs pulled down, that he prohibited the use of such fligs for one week, that the children of a school were compelled to salute the Union Jack, that a distinguished. Professor in Calcu ta, going out in his acidemic costume and on the strength thereof going up to an officer to stop a wanton hunt of inoffensive man, was brurally assaulted for his innocent inquiry as to the cause of the hunt, that a party of brave culture I young men were kicked about by those who were their warders for the time These are thing that sink. These humiliations show that there is little change in the manuers of our

"masters." The O'Dwyerian spuit has not died out. Ot what use is it that Lord Ronaldshay sends for the injured Professor, soothes him and assures him that the thing will not happen again? What will not Lappen again? The Professor will not be assaulted? Of course he will not be during the present crisis. The Professor himself will not again presume upon his academic costume and challenge an officer very soon. But has the officer any respect for the Professor? The Brolessor did not seek relief for himself. He inter-ceded for injured humanity. Will Indian humanity be protected and resp. cted in future because of his Lordship's assurance? It is the habitual training given to the soldier that matters. He is converted into a vicious animal to be let loose on harmless people on given occasions. The Dases and the Azads have gone to gaol to prevent a repetition of such unmanly and brutal exhibitions. They have welcomed imprisonment in order that even the worst criminal may be protected against wanton injury, that even he may not have his self-respect wounded. They have not gone to gaol for any mechanical transference of power. The organic change they want, that Lala Lajpat Rai has been pining for for years, that has become the breath of life for the case loving Motilal Nehru and has made of him practically a Fakir, is not to be brought about by Lord Ronaldshay, however well-intentioned he may be in his apologies, nor by Lord Reading's smooth phrases and his personal care that officers and men might not overstep the limits of law. The organic change will be and an only be brought about by the suffering that has come to the people and for which thank God they find themselves prepared. A cautious friend in order to restrain my optimism tells me, that he suffering has only just begun, that for the end in view we must pay a much higher price still. He really expects that we shall have to invite a repetition of Jalianwalas and that instead of approaching the triangles of the crawling lan: tame tremblingly and veluctantly, we shall have now to walk to them cheerfully and with a steady-step and suffe. lashes for refusing to crawl. I assure the triend that my optimism has room for all these things and much worse that he can imagine. But I promise, too, that if India temains calm and unperturbed and does not retaliate even mentally—a very difficult process I admit and yet not so difficult in India's present exalted mood,—our v.ry preparedness and consequent absence of re-action will exhaust the brute spirit for want of nutrition, and Lord Reading, instead of talking big things to us, will himself adopt the human language of penitince and see ample occasion in the Ludian atmosphere for a new diplomacy. Whereas it we forget ourse ves and our pledge, we must be ready for. a thousand Jalianwallas and India being turned into vast shambles. The President-elect has prepared us for such a consumation. He is ure that we have shed the fear of the prison. He is almost certain probably from the experience of his brave son and his company that we will be prepared to undergo the ordeal of But he bids us give up the fear of deathe itself. If that time is in store for us, I hope that there well be non-violent non-co-operators enough in India, of whom it will be written:

'They suffered bullets without anger and with prayer on their lips even for the ignorant murderer.'

Well, if the reports are to be credited, two Assumese volunteers have been whipped, the volunteers of Lahore have meekly borne the wanton assults committed on them. This fight is not a joke. We have disciplined ourselves for the past twelve months and more, and we must now go through it the end. There is no turing back.
