NOTES AND NEWS

HE anti-Asiatic Ordinances recently passed by the Natal Provincial Council which are awaiting the assent of the Governor-General-in-Council have been subjected to much criticism both in England as well as in India. In the House of Commons, states a Reuter's message from London, Colonel J. C. Wedgwood (Labour) asked whether Mr. Churchill would do anything to prevent the enactment of three pieces of anti-Indian legislation recently submitted in the Natal-Provincial Council. Mr. Churchill replied that it was for the Union Government to decide whether assent be given to the Ordinances to which Indian organisations objected, if they were passed by the Provincial Council. Colonel Wedgwood asserted that the Ordinances had been denounced by both Indian and English newspapers in India, and he asked whether Mr. Churchill could not advise the South African Government. Mr. Churchill, in reply, said he refused to be led into a course of strile and triction with the Union Government.

Reuter (London) in 2 message dated July 10, states:-

The Times' correspondent at Bombay says sober Indian opinion is variously perturbed at the apparent prevalence of the anti-Indian views of the Colonial Office, and says Mr. Churchill's refusal to allow Indians to settle in the Kenya highlands is regarded as a breack of the resolution passed at the Imperial Conference. The Times of India denounces Mr. Churchill's refusal to intervene to prevent the sanctioning of three pieces of anti-Indian legislation in Natal, as "an exhibition of political cowardice and complete lack of sympathy with the races of the Empire."

POLITICAL COWARDIGE

OHE reply given by Mr. Churchill in the House of Common to a question put by Colonel Wedg-Wood in connection with the recent ordinances passed by the Natal Provincial Council will be viewed with the deepest regret by Indians in thit country. It was little expected that Mr. Churchill would be so blunt as to my that " he refused to be led into a course of swife and frieties with the Union Government." If this by the attitude the Colonial Office is going to adopt, British Indians resident in the Union will be left entirely at the mercy of the local Government. Under the circumstances the application of the term "British" to Indiana or India would be meaningless. Mr. Churchill seems to be more concerned about the Union Governsout being vered than the ill-treatment of a hundred and fifty thousand of His Majorty's British subjects by that Government. Buther than vering the Union Govenument he is prepared to let the latter "go to the dogs." But he seems to forget that it is not only the hundred and fifty thousand but the whole of India, on whom the the existence of the British Empire is largely dependent, that is being injured. The Times of India quite correctly describes the attitude of Mr. Churchill as "exhibiting political cowardies and complete lack of sympathy with the races of the Empire!" Non-co-operators in India are held to severe criticism by the so-called sober section representing the co-operators. But Mr. Churchill's reply has rendered the cause of the former all the more stronger and even the latter it has made to pause for a moment in amazement as to whether the ground they are treading in implicit faith is sould or is it going to give way and chia their destruction.

INDIANS IN KENYA

THAT OF BRITISH SINCERETY ...

. Mr. H. S. L. Polar's Interview

The position of Indians in Kenya Colony was the subject of a long interview which Mr. Henry S. L. Polak gave to a representative of the Associated Press of India at Simla recently. After explaining the difficulties that beset Indians in Kenya, Mr. Polak expressed his disappointment that Indian opinion seemed not fully alive to the enormous seriousness of issues involved, and warned that unless India carried on a sustained campaign, both on the platform and in the Press and through representation to the authorifies, the cause of Indians abroad might be irreparably fost. Mr. Polak is the Honorary Secretary of the Indians Overseas Association in London and is thoroughly acquainted with the latest developments in Kenya, being in constant touch with the Bast African Indian National Congress. Mr. Polak said that he last, visited Kenya in 1917. The population of Indians in that Colony lie estimated at 30,000, which was approximately four times the number of European settlers.

TRANSPER OF LANDS A.—I will state them one by one. First, that the power of the Governor to veto transfer of lands as between persons of different faces should be with-

drawn. This veto was conferred upon the Governor in 1915, when Indians were asked not to engage in political activities. The 1915 Ordinance was a distinct and deliberate breach of the pledge made to the Indian community by Lord Elgin in 1908, that His Majesty's Government would be no party to any legislation affecting the ownership of land in the then protectorate differentially affecting Indians. In the same despatch Lord Elgin said that for reasons of administrative convenience-a convenient phrase which was never defined-it was decided to confer original grants of Crown lands in the highlands to Europeans only. He was however silent on the question of land transfer. Practically all the Crown lands have been granted to Europeans. Thus, Lord Elgin's pledge to the Europeans, though it did not injure the Indian community, has been fulfilled. It would appear from Mr. Churchill's utterances, that what the Colonial Office is now anxious to do, is to further extend that pledge to the Europeans by prohibiting transfer of lands in the highlands, whilst at the same time breaking a contemporaneous pledge to the Indian community. Is has a differentiation and a breach of faith which the Indian community is not prepared to accept or condone, because it is one of the vital points, arising in the present controversy.

POLICY OF SEGREGATION .

The next matter in dispute is in connection with the policy of segregation. I need hardly mention that as a matter of course Europeans and Indians generally do not live in the same quarters because of difference in social customs. To this extent, therefore, there is already voluntary segregation between the two communities, but what Indians do take strong objection to is the endeavour on the part of Europeans to secure a statutory prohibition against them to reside or even trade in the areas which are described as European areas and which, of course, include the best parts of the existing townships. The Indian community cannot possibly accept any system of compulsory civilisation inherited by them. They have no objection to the system of voluntary separation, as at present prevails, but they do insist, and rightly, that those Indians who desire to reside in areas known as the "European quarters" and who are prepared to abide by general sanitary regulations and other bye-laws applicable to all classes and races alike, should have no restriction placed upon them in any way, merely because they are Indians. This proposal should, in my opinion, outirely meet the situation arising from differences in methods of life.

QUESTION OF FRANCHISE

The third complaint concerns the question of franchise. The entire adult European population is under the existing law automatically enfranchised, but no Indian has a vote. The Indian claim is that without depriving any of the existing voters of his fran-chise, law should be altered so that in future all persons, of whatever race possessing the necessary qualification, should be included in a general electoral roll. This would mean that for some years to come European voters would always be in the majority, but it would give a stimulus to Indians to qualify themselves to exercise the franchise in order to obtain in future an adequate representation of their interests in the local legislature.

AGAINST INDIAN INMIGRATION

The fourth point of controversy arises out of the attempt by the Europeans to close Kenya against Indian immigration. To my mind, though all other lesues are of primary importance, this is the most important of all. Presently what is being attempted is to establish in Kenya the same conditions as prevail in the Union of South Africa with which, as you are aware, I am from long experience very well acquainted. The Europeans feel that if they can cut off Indians from East Africa they will have succeeded in creating

what Mr. Churchill described as a characteristic British Colony. I have never yet been able to understand what he means by the phrase. There are all kinds of British colonies which differ in structure radically from each other. If the phrase means the characteristic methods of British administration, there is no seesanyable ground for complaint, but if it means that this Colony, like the self-governing Dominions, is to be made a preserve for the white men who are to be maintained in a position of perpetual domination ever other races, as seems to be the desire with regard to Kenya, then it is a clear breach of the underlying principles of equality. The resolution of the Imperial... Conference of 1921 is a challenge to India, declaring a that she has in fact, no imperial status, that her immigrants have no status even in regard to those parts of the British Empire which are under the immediate to jurisdiction of the Colonial Office. Mr. Churchill's speech at Kenya Club defines fundamental issues between Great Britain and India. Hitherto the general impression has been, and I must confess that until I studied the matter very carefully, it was one that I myself shared—that it was the self-governing Dominions that were the the principal culprits in the matter of differentiation against Indians, whother as immigrants or as residents. It was becoming increasingly clear having regard to constitutional developments, that there were genuine grounds for the position taken up by the Imperial Government that they should not directly interfere with a self-governing Dominion. But even there, it had to be recognised that Great Britain had just as great a right and responsibility to protect British subjects from India emigrating to or residing in these self-governing Dominions, through the usual diplomatic channels. as she would have undoubtedly exercised in regard to foreign countries, if those conditions prevailed there.

The case of Kenya, however, has thrown a treshight upon the situation and has made clear that British Government itself is responsible in a Crown Colony, ruled from Downing Street, for a policy of differential racial legislation and methods of administration in regard to Indians. The British case is all the worse when one remembers the fact that Indians in Kenya were prior emigrants and relations between India and Kenya are centuries old and when one finds Sir John Kirk, perhaps the greatest authority on the East African question, stating publicly, that but for the influence of the Indian traders, who had settled in Rast Africa, the British flags would not now be floating there. What Mr. Churchill says, in fact, is that it is not desirable that Indian culture should be allowed to continue to spread in East Africa, though British trade there owes its origin to the enterprise of Indian traders, and he has adopted the handy altruistic European cry that this is in the interests of the native population. Those who are acquainted with the relations of the average European planter with the natives of the country, will recognise how very flimsy, to say the least of it, is the argument that Europeans and Natives in East Africa have a common interest. It is a piece of characteristic hypocrisy, and the Indians in Kenya very strongly protest against persistent attempts to malign them and their relations with the native popul-

Q. What is the ulterior motive of Europeans in professing to make common cause with natives and trying to get rid of Indians?

A. The fact is that Buropean planters; as a class, are anxious to see that Indians and Watives did not make a common cause to establish the civil and political rights of non-Europeans, and they believe that if they can get rid at Indiane, they will be able safely to control the Native population, and will not have to accounter strong committee. have to encounter strong opposition to the main-

tenance of a position of recial privilege.

Q.—How do the relations between Indians and Natives stand and how do these compare with these between Natives and Europeans?

A.—The natives are on friendly terms with Indians, but they are ordinarily afraid of the European settlers.

TEST OF BRITISH SINCERITY

Continuing his parrative, Mr. Polak said :-- " I have considered that the case of Kenya is the true test of British sincerity with regard to doctrine of equality of citizenship for Indians abroad. The resolution passed at the last Imperial Conference is not happily worded, but those who are acquainted with the history of those negotiations, are aware that the principle of control of immigration, which was agreed to at the previous conference, applied only to the self-governing dominions and to India as a Quasi Dominion. Mr. Churchill and the colonial office are now under the stimulus of the Ruropean settlers in Kenya endeavouring to extend the principle even to Crown Colonies where any small European minority may demand for its own purpose and in the alleged interest of native population that Indian immigration should be prohibited whilst Ruropean immigration should remain unrestricted. That is an interpretation of the resolution to which I am sure India will not agree. We know that the very severse of the doctrine of equality of citizenship as regard Kenya is being postered by the Colonial Office. It would be interesting to know what steps the Colonial Office has taken to give effect to the principle of equal citizenship for Indians in the overseas Crown Colonies and Dependencies by the removal from the statute book of all enactments differentially affecting Indians or doing away with methods of administration imposing special disabilities upon them. I venture to hope that the Government of India will request the British Government to submit a categorical statement of the steps that have been taken to give effect to this principle in the terriories under the immediate jurisdiction of the Downing Street. There has been ample time for something to be done as it is nearly a year since the resolution was adopted with Mr. Churchill's signature appended to it.

OBJECT OF VISIT TO INDIA

Question:—What is the object of your visit to this country? Would you like to say anything about present day politics in India and would you particularly suggest a course India should adopt to secure redress to Indians abroad?

Answer:-I have come to this country in a private capacity not participating in any controversial political matters but I cannot refrain from expressing the atmost disappointment that for various reasons into these matters I need not go. But public opinion appears to have been diverted from the acute and vital problems which affect directly the question of India's status within the Empire and equally directly the welfare of Indian communities abroard. This attitude has greatly hampered all those who like myself are engaged in endeavouring to bring about a rapid and reasonable settlement of the Kenya controversy. It seems to me not to be useless and untrue to say that the acquisition by India of complete control over her own destiny should precede an attempt to secure justice for Indians abroad. Take the case of Japan which should meet all such arguments. Japan is a completely independent and aggressive country, but she in spite of her self-governance has not yet been able effectively to protect the interests of Japanese resident Status is not a matter that can be separated abroad. by water-tight compartments. There must be advance in status on all lines simultaneously and if there be a check along any lines of advance, it necessarily affects progress in other directions. I would earnestly implore Indian public opinion to concentrate here and now upon this question of Kenya. If the British Cabinet are induced by Mr. Churchill (and fortunately Mr. Montagu before leaving the Indian Office prevented this tragedy and I very hopefully feel that the Government of India and Lord Peel will also succeed in doing it;) to decide against India in regard to the

question of highlands and more particularly on the question of Indian immigration in Kenya, I am afraid, that irreparable disaster will have been done to Indo-British relations and Indian community in Kenya and other parts of East Africa will be faced with certain ruin and perpetual subordination of Indian interests at the hands of European settlers. It is, therefore, urgently necessary that public opinion in India should be concentrated upon the case of Kenya and that the Government of India's hands may be strengthened in the representations that they have continued to make to the Secretary of State on the subject.

NEED OF STRONG PUBLIC OPINION IN INDIA

Q.—I think public opinion is already sufficiently emphatic about the position of Indians abroad, but what else do you suggest should be done to make it more emphatic?

A.—I want a ceaseless campaign both in the Press and on the platform to show that India is alive to the gravity of the situation and that she would not have outsiders to imagine that she is apathetic. I suggest that a strong deputation should wait on the Viceroy and thus strengthen the hands of the Government and of public men in England who are helping India's cause.

Concluding, Mr. Polak uttered a word of warning; within next few months he said a decision one way or the other must be taken by His Majesty's Government and unless Indian opinion is alive to the enormous seriousness of the issues involved, a fundamental error may be committed having gravest possible consequences.—Bombay Chromeile.

THE PROBLEM IN EAST AFRICA

The Round Table for the last quarter deplores the race-hatred and intolerance that have obscured the main issues which are really economical and sentimental. The present situation is only of recent growth; and before the war the racial question was not much in evidence. With a tew minor exceptions, the Indian community consists mainly of shopkeepers, artisans and clerks with a sprinkling of lawyers, doctors, and other professional men. Though Indians from the Malabar coast have traded with Mombasa since the 15th century, they never, so far as is known, penetrated to the hinterland before the opening of the railway; and their trade with it was carried on through slave dealers and other desperadoes. The railway imported into the hinterland a number of coolies, clerks and contractors who were mostly repatriated.

The movement for equalising the status of Indians began during the war, when practically the whole white population was on active service. The idea of Indians having colonies of their own was suggested soon after the armistice, first broached by Sir Theodore Morrison; and then no enthusiasm was shown for the scheme by the public or the Press in India. The question of the equality of status for Indians in East Africa is not an isolated one; but Kenya is the Achilles' heel of the whole problem. Lord Milner's Commission published a report in 1920, which was tacitly accepted at the time, and according to which Europeans were to have a preserve of the Highlands and the Indians were to have two representatives on the Legislative Council; and the principle of segregation was upheld.

The one really strong point that the Indian can put forward is, not the miltary aid rendered by India in the war, but only his follow-citizenship. The first demand of the Indians is the right to hold any position, however eminent in the Civil Service and the local miltary forces; his second demand is for equal political franchise; and the third is to sequire land and property in the white highlands; and in his demand for the shollides of tegranation the Indian

is chiefly affected in his national pride. And lastly the Indians demand the right to enter the country in unrestricted numbers. The Indian question resolves itself into four main points—(1) absolute equality of each race (2) Segregation demanded by Eouropeans provided the restriction is not based merely on racial grounds (3) The Indiands' right to acquire lands in the white highlands, and (4) Indians' right to penetrate the country in unlimited numbers.

Finally there is the stand-point of the Negroes, the original inhabitants of the country; and there is the danger of the tribes becoming inculcated either with Pan-Isamic or with Pan-Negro doctrines. The greates danger to be avoided is to abstain from any semblance of racial arrogance.—Indian Social Reformer.
