SEVEN DAYS' IMPRISONMENT WITH HARD LABOUR SORABJEE DEPRIVED OF KASTI AND SADRA

ESSRS. Sprabjee Rustomjee, Manilal Gandhi, and Ismail Gora who were charged with obstructing the what last November on the occasion of the departure of the s. Karagela with the Christopher's South African Indian Sporting Contingent, appeared before Mr. Clark in the Criminal Court last Tuesday, Mr. Ismail Gora being defended by Mr. Stuart.

Rustomjee gave his own version of what occurred and said a crowd of Indians had gathered to see the Indian athlets off, and they were standing about 26 feet from the edge of the wharf. Claser to the ship was a group of Europeans, two of whom were on the gangway. When the Indians were asked to stand back, witness called the attention of the police to the Europeans, and asked why the Indians should be sent back, while the Europeans were allowed to remain. Presently the Indian crowd grew larger and the police were unable to move them back though they tried to do so. The accused was then arrested, and those who were standing by asked to be arrested also. The police witness alleged, said excitedly, "I arrest you all," and consequently they all followed Ismail Gora to the police station,

INTERRUPTED

Gandhi said he was holding conversation with friends on the boat, and was twice interrupted by the police, and pushed back. When he asked why he was pushed back, he was told it was not his business. He did not realise that he was obstructing anyone, and he resented the interference and refused to go back. "I was grieved to find," said the witness, "that the police officer did not know his duty. He wanted to assault me and I was on the verge of being assaulted when I politely told him his duty was not to assault me but to arrest me for having disobeyed his orders."

The prosecutor, Sergt. Phillips, pointed out that the accused were three of the leading Indians in the town, and if they disobeyed the police all the other Indians would follow suit. The case had been fought on the allegation of preference or favouritism shown by the police, but the evidence did not point this way, but rather the reverse, because a European was asked to stand back and complied with the request. When the police turned round, however, it was seen that Gandhi was right up against the edge of the ship. He asked the court to hold that the accused were guilty of obstruction. There was practically a riot at the Point on the day in question.

DIFFERENTIATION

Counsel for the defence urged the Court to find that there was differentiation, otherwise why should these Indians have pointed out to the Europeans, declaring their willingness to go back if the Europeans went back. These Indians recognised that they had as much right there as the Europeans and all this trouble had arisen for want of a little tact. The

Indians were most law-abiding, and were not likely to give trouble if it could be avoided. He submitted that the accused did not obstruct the wharf, there was not a tittle of evidence to support it, and as a matter of fact the proceedings were based on the wrong section of the law. This was a special occasion for the Indians, and they felt keenly the differentiation between Europeans and themselves, just because their skin was black.

Rustomjee declared that there was injustice shown, and if there had been no preferential treatment, he would not have been the one to submit to voluntary arrest.

Gandhi urged that he could not have been held to be an obstruction to the moorning attendant, because this official's duty commenced about midday, while he (Gandhi) was arrested about half-past nine. He purposely disobeyed the order of the police, but he was not charged with this. If he was an obstruction it was the colour of his skin only that was an obstruction. All the Indians asked was fair and reasonable treatment.

The magistrate, in giving judgment, said: "I have come to the conclusion. I must find all the accused guilty of the charge made against them. The sentence is that the accused each pay £5 or be imprisoned for seven days with hard labour."

Rustomjee and Gandhi refused to pay the fine and went to gaol. Ismail Gora said the fine.

MEETING OF PROTEST

Rawat's Hall was filled to overflowing as soon at the imprisonment of Messas Sorabjee Rustomjee and Manilal Gandhi became known to the Indian community and under the chairmanship of Mr. Bhawani D yal, Vice-President of the Natal Indian Congress. The following resolution was passed: "That an appeal be made to the Union Government to remove the racial restriction on the Durban Whari at the time of the departures of Indian Boats."

And on it coming to the knowledge of the Natal Indian Congress that the sacred shirt and cord had been taken away from Sorabjee Rustomjee by the prison authorities, a further neeting decided to make representations to the proper quarters for redress. The following wire was despatched by the Natal Indian Congress to the Governor G neval of the Union, the Prime Minister and the Minister of Interior:—

"Consequent upon the protesting of Parsee Sorabjes Rustomjee and Manilal Gandhi and Ismail! Gora against racial discrimination on Durban Whari at time of boats leaving for India they were yesterday sentenced by Magistrate Clark at Durban Court to pay five Pounds or seven days' imprisonment with hard labour for alleged contravention of section 174 Harbour Regulations. The Town Council of the Borough of Durbus, in selling as lessing any immovable property belonging to the said Borough, may, with the consent of the Administrator, make provision in the conditions. Sale or lesse as to the style, class or value of buildings to be erected thereon and for restricting the use of such property solely to purposes air estimates a resiness and for restricting the ownership or occupation thereof or both to and for prohibiting the ownership or occupation thereof or both by persons of European descent, Asiatics or Natives or persons of any one or more such classes, and may insert in the title deeds or lesses of any such property that conditions necessary to give full force and effect to such provisions and/or restrictions:

CIVIL DISOBEDIENCE AS RETALIATION

The following editorial note appears in Young India dated June: 22: ---

The great danger is all/movements is that at certain stages, men lose sight of the gaol and concentrate instead on something neaser. This leads naturally to enter of judgment and insidirection of energy. We set before us the attainment of Swaray as our aim; and suffering; as the means to achieve that aim. In the course of this suffering, the purest and the best among us have had to yield up their bodies to the custody of Swarament. Imprisonment is a necessary incident in every non-violent struggle against an opposing government. It is when we cheerfully undertake the privations of imprisonment that the moral situation we seek to create arises and liberates us. It is by the individual losing himself that the nation can gain its object

Men and women forget the goal when they refer to ther imprisonment of thousands of our vary best as as calamity. When they speak of the realers of these prisoners, and think out plans to achieve this object. they show that they have lost sight of the great purpose of our struggle. The plans to release prisoners, so long as they are in line with the main movement towards. the liberation of the nation, are quite permissible. But, when we begin to think more of the prisoners than of the main purpose, we are sure to be led. into error... Civil' Disobedience is a right and a duty for the attainment of our goal, but it is a mistake to talk about it as. a measure of retaliation against repression. Retaliation. has no place in a non-violent struggle Satyagraha can never win except by a moral victory. Retaliation, as it is intended only to cause trouble in answer to pain, is, but a counterfeit of Satyagraha. The effectiveness of Civil Disobedience or any other form of Satyagraha consists in the suffering undertaken by those who offer it and the moral force thereby created by reason of the. constitution of human nature; not at all in the omb irrassment or pain directly caused by our tactics. long as our civil disobedience is offered in anger or forthe purpose of directly injuring or embarrassing the Government, we create only greater irritation and. resistance and postpone the desired result. It is only when it is offered in the spirit of calm suffering that it. can effect its porpose, and in proportion as it is free from the admixture of feelings of hatred or ill-will, will the attainment of the object be speedier.

Neither can we reasonably expect that civil disobedience will result in a mitigation of repression. We embarked on this struggle knowing full well that the first and the direct fruits of our effort, if it did not flash in the part must be repression. There can be not effective, action without reaction. The reaction to serious popular effort directed against any Government is repression. Civil Disobedience in as much an it, would be an increased apposition on the part of the people to the will of the Government must bring on greater repression. Let there he no mistake about it, therefore, if we emback on civil disobadience, we do so with our eges fixed on the final goal and not in the hope of maigating the sumediate unfering. We cannot stop general repression or obtain the release of prisoners by such a step, except indeed by straining our chrait object. To bend the Government to our will by civil disobedience, we have to pass through greater repres-65n. Civil disobedience for immediately stopping the repression or for the release of prisuners, has then furno meaning. Apart from other conditions, minilidisobedience can be undertaken only, it we assure ourseives that we can cheerfully bear greater suffering and not in the hope of relieving our present suffering.

34 PANDIT MOTILALJI ON THE PRESENT INDIAN SITUATION

We reproduce from Young Louis mome sheautiful passages from the remarkable address of Pandit Motilalji at a public meeting of the citizens of kilsha-

bad on 12th June :-

Then we have the non-co-operators themselves exhibiting signs of impatience and some of them crying for a change of programme. These enthusiastic weakers do not find the humdrum business of actting their own house in order, to be sufficiently interesting and are hankering after something more exciting. Now gentlemen, I am not one of those who fight shy of all change under any circumstances. .On the contrary I would be the first to advocate a change as strongly as 1 can, provided the necessity for it is aleany made out. For the present, however, I am not in a position to express any opinion apon the point. I must take time to discuss the whole situation with prominent workers in the various provinces and acquaint myself. fully with the general lay of the position throughout the country before I can sote either for or against a change.

But I can quite sunderstand that we may have to adjust our sails to suit the varying winds, we may have to alter our course to avoid the shoals and breakers ahead, we may even have to drop anchor for a time to allow the gathering mists to clear up. But there can be no question of our altering cur destination or changing the good ship me have chartered for the voyage. Our destination is full Swarzjya and the good ship which is to carry us to that destination is non-violent non-co-operation. We cannot afford to leave this ship until we are actually in the harbour and then only to get to the shore. In other words we must adhere to non-qc-operation till we have actually attained Swarajya and resort to co-operation only in the matter of taking over the Government of our

secuntry in our own hands.

In the war we are engaged in, we have chalked out an entirely new line. We light with entirely new weapons unknown to history and can only have our own mistakes to profit by: It is up to us to admit those mistakes freely and take steps to see that they are not repeated. In this matter Mahatma Gandhi has set us a noble example which we should all follow; though I may without any disrespect, state that ou certain occasions Mahatmiji has in my opinion erred on the other side in freely admitting a mistake where A could see none. There is no doubt, however, that we have commuted mistakes. I shall not mirce matters in dealing with our shortcomings. Indiscipline and want of organisations are writ large on our movement. It is an admitted fact that ,no Government, however strong, can withstand successful nonco-operation. Most of the telements which make for the success are present in our own movement. There is no lack of men, there is no lack of willing sacrifice, there is no lack of public sympathy.

I have heard it said that the principal assertion of the Congress have these abandoned and could desobedience practically given up by the advance of the constructive programme laid down by the Burdeli resolutions. But to little e. flection will show that nothing of the kind has happened. Whe har abandoned any i.em of the non-cu-uponess gargramme? I challenge our adversaries to many from of any other Congress-men of note, where the stand nment of any single item has ever been suggested. Cond disobedience was, is and shall be our strong and irresistible weapon to be used with full effect when the someon prises. Its is sufficient warine with ordinary weapons, so also do our war of non-violent mon-co-operation with weapons peculiar to strell, you cannot use all weapons at all times. It will not do for instance to use a particular weapon against an opposing force unless that torce is well within the range of that weapon. Nor will it do to bong year best and strongest sweapon cints action before et in properly tested and tried. What has really bappened is this. Mahatma Gandhi who had every right tu capect that he was at the bead of a well-quipes army suddenly found a subble behind him either engament or badly, armed and a great number not even in their fighting uniforms. There was nothing for this but to soull a halt to prepare histories for the seed fight and. this is what he did. He has not as is assumed, disbanded his soldiers but that called a halt in the open field right in from of the opposing closer. And why? Simply to get better prepared for the very attack which our friends naively assume be has given up.

Then we have the fact of the arrest of Mikaina Ganchi being tellowed by an unbroken stransphere of peace and non-violence. A censider this to be our greatest triumph. But the Lioveroment and the Moderates have attributed it to the collapse of the whole movement. They are really sery hard to please. According to them if there is the least outbrest of violence anywhere due to any cause whatever, son-cooperation has failed. If there is no distribute at all under the greatest possible presocution and percetal atmosphere is strictly mainteined, non-co-operation has equally failed. Let us however look to the actual facts. In the year 1919 shortly before the movement was started, Mr. Gandhi was suddenly accested near D this and the result was an unheavel accommuned so far out as Bombay, Ahmedahad and the Panjoh. In the year 1922 when the movement was to full aways and the arrest was hourly expected, Mahana Gandhi was taken away from his own Ashram when he was surrounded by his disciples and admirers. There were thousands if out lass in the vicinity by whom he was held in the greatest reverence. And get there was not a stir. It was the same Wahama Gandhi and it was the same public on both occasions. If anything, Mahatm ji could claim a larger and more devoted following in 19 to than was probably the case in 1919. And yet all was peace and quier. Does any one imagine that there are not tens of thousands if not tens of millions, in the country who are until to lay dewn their lives for Manatrasji? I am cer ainly one of them. (A voice: 'We are also ready'). 'Yes, not only we but there are incr of others whe are ready as we are. Why, then, is it that no demonstration of any kind was made at the arrest of the great leader? The only treason is that the public had taken the lesson of non-violence to heart and were beat on following the instructions of Mahatmani which he had repeatedly given from many platforms and in the columns of Young India. There, brothers, are the brilliant successes we have had that there can be no gainsaying the fact that we have that with reverses also. These, as I have skeady said, have been due solely to indiscipling and wast of organisation. But reverses such as we have hed do not affect the final is ue. final is ue.
