QUESTION ON LICENSE BOARDS Mr. HULETT asked the Administrator: (a) Who recommended for appointment the rersons who form, the several Rural Licensing Board?; (b) Why were the Farmers' Associations and other similar organisations in the areas to be served by the Boards not asked to submit names for the consideration of the Administrator?

Administrator replied as follows: (a) The Magistrates in the principal contres of the licensing areas were appointed as chairmen of the Boards and all Megistrates throughout the Province (except Zululand) were asked to submit the names of qualified and suitable persons for consideration. (b) It was not considered desirable to consult any sectional organisations but nominations were received from certain public bodies.

The Dundee Licensing case—a report of appears in this issue—is one more instance of the un-fettered discretion vested in Licensing Authorities. There is no security for any Indian Trader-he might have been in business for 40 years as in this case or any number of years, he has but to make a purely technical error again as in this case by lodging his application in tlme but failing inadvertently o pay the fee, or any other technical error which prejudices nobody. And his license may be refused on the ground of no necessity or any other convenient ground. After being in business for forty years in one locality to be told that there is no necessity at the instance of another trader who has been about half that period in the same locality would be ironical in thought but when it is actually done, it is notonly unjust but cruel. Who can say that European Traders cannot have their own way against Indian Traders—there is the law to assist them.

DUNDEE LICENSE REFUSED

FORTY YEARS IN BUSINESS

After 40 years' trading as, a wholesaler and retailer in Dundee, the Natal Advertiser reports, an Indian merchant, H. J. R. Khan, has failed to convince the Licensing Officer that the renewal of his licence is necessary.

Application was made to Mr. J. H. Hardy, the Town lerk, in his capacity as Borough Licensing Officer, Mr. O'Hea appearing for the applicant for the renewal of Khan's licence in respect of premises in Wilson Street in what is known as the Asiatic area.

Khan, it appears, has been in India for the past 12 years, and according to his statement mismanagement by his employees, had brought his affairs to disorder, rendering it necessary for him to meet his creditors and enter into a composition with them.

An Oversight

During the interruption involved by these proceedings his manager, although lodging the usual application for renewal of the licence, omitted to call at the Town Office and take out last year's licence. Upon application being subsequently made for its renewal, Klere was informed that his licence had lapsed, and his application would be only treated as a new one.

Upon the application being made the Chamber

of Commerce stepped in and opposed it:

At the hearing the Chamber of Commerce was represented by Mr. J. W. Francis. Evidence was led by Mr. T. H. Y. Worthington, attorney for the trustee, the applicant, his son, A. K. Khan, and Wr. Adam for the licence; and from Mr. A. L. Williams, representing the Chamber of Commerce against this application,

No NECESSITY

3.92.23 . Mr. Williams, for the Chamber of Commerce, stated that he had been in business at Dundee for 23 years past and saw no need for the c ntinconce of the applicant's business that decreased 40 per cent. as compared with 1924, and there were plenty of traders to deal with what business there was An application by Karodia, Son and Nephew had been refused by the Licensing Officer and the Board of Appeal recently on the grounds of no necessity, and this application should be treated in the same way. He admitted that the applicant had been in business for many years before he commenced store keeping at Dun, dee, and that Karodia, Son and Nephew's application was in respect of a new business.

Advocate O'Hea pointed out that the applicant. had a long and stainless record; his creditors recognised that he had been a victim of his manager's mismanagement. They wished him to continue trading. He should in all justice he allowed to renew his licence and given the opport: viny to recover his sound business position.

Mr. Francis contended that after refusion Karodia, Son and Nephew's licence the Licensing

Officer could not consistently grant this one, which he was technically entitled to regard as an application for a new licence.

The Licensing Officer said that he accepted this view and refused the application.

INDIA AND AFRICA

(By Mr. C. F. Andrews In Young India)

To night we reach Aden and all the day long we have been making our way up the Gulf. The air that comes from the mountains of Arabia is fresh and cool. are close to the passage where the two continents of Africa and Asia nearly meet, and all through the coming days we shall have Asia almost within sight on the one hand and Africa on the other. Every time that I have crossed the Indian Ocean, I have felt more deeply the intimate connexion which exists by Nature's own law and choice between India and Africa. Yet we are told to-day by arrogant and insolent voices, that India has no place in Africa at all, but must be excluded from Africa not only in the South but in the East.

We have shut," says Major Grogan, in a well-known passage, "the front door from India into Africa at Durban; now we must shut also the back door into Africa at Mombasa." In equally insolent language, with a touch of b asphemy added, Lord Delamere has written

from Kenya:

"There is a wider aspect. Our concern for our homes in Kenya and the well-being of the native people does not blind us to the fact, that the danger (from the Indian) to the Empire and to Christianity is greater. If the East is permitted to penetrate Africa and the Trusteeship of the vart native population be transferred to other and alien hands, then gone is the dream of a series of Christian African States, created and linked together to the genius of British Colonisation. Australia, New Zealand, Canada and South Africa have all closed their doors to Indian immigration. All have seen the danger.—To those on the spot, the menace is apparent. To those at home, it is vague and indefinite. For this reason we desire investigation here. To sum up:-

(i) Is England to be marked with the stain of betraying the African native to Eastern rule?

(ii) Is the young growth of Christianity and Western civilisation to be supplanted by Eastern :/ :creeds and superstitions?

(iii) Is the pioneer and the man who is "up against the wilderness", in spite of solemn pledges, to be made the sport of political opportunism?"

(The Italics are mine.)

I turn from this passage, filled with rancour and hate and malice and all uncharitableness, to the picture which I have ever kept fresh in my own; mind of Mahatma Gandhi in his Ashram at Phoenix in South Africa. Let

me draw it over again :-

We had been occupied all day at the store yard of dear Parsee Rustomji's shop, at 110 Field Street, Durban. From morning till afternoon, Mahatmaji had been overwhelmed with the burden of a thousand cares. The whole compound had been full of Tamil women and children, who had come for help at the climax of the Passive Resistance struggle. He had soothed them by his words; he had ministered to them with his hands; he had prepared food for them; he had taken their little babies one by one and nursed them while a smile had made his face beautiful and a tender light had shone from his eyes. I had watched the scene, while waiting to be of any service, and the thought had come again and again to me of the passage which I love best of all in the Gospel Story :-

"They brought young children to Christ, that he shall bless them. But the disciples rebuked those that brought them.

"But when Jesus saw it, he was much displeased

and said: Suffer the little children to come me, and forbid them not; for of such is the dom of Heaven.

"Verily, verily, I say unto you, except a be changed in heart and mind, and become little child, he shall in no wise en er the Kins of Heaven.

"And he took the little children up in his and laid his hands upon them, and blessed them."

It was even so, with just such love and tender as that!-that I saw Mahatmaji, that morning, as took the little children up in his arms and blessed th I watched many a poor mother's face, coarsened by hard evil lite of the coolie 'lines', break into tender' as Mahatmaji took her own little child and laid her little baby in his arms and blessed it. Each mowent away radiant with joy.

As the day went on, I wondered how the strain con be kept up. There was no time, even to take food;

there was not a moment's rest.

Then, at last, Mahatma Gandhi told me to get reto go to Phoenix by train from Durban Station, will was close at hand. We reached Phoenix just as the was beginning to decline. The station master, a En pean, was a friend, and welcomed Mahatmaji back as We reached first of all an Indian so long absence. on the way and the store keeper ran out to greet him. noticed also that the Africans who were seased near store were full of respect and almost reverence for frail figure as he greeted them, bare-footed and bar headed, with his home spun peasant's garments. I scene, as we reached the brow of the hill, was one indescribable beauty, and the prace of it entered it my heart, bringing back to me the vision of Shantiketan itself.

I cannot tell a fragment of the story of that evening As it grew dark, we sat there in the moonlight togethe There was an African Christian woman who lived in the same compound with us and helped Mrs. Gandhi household matters. Her face was worn, but it w lighted up with a smile as Mahatmaji drew near. Th-Mr. Kallenbach came running up quickly, brimmir over with fun, carrying a child in his arms. The mother of Mr. West was there and Mahatmaji greeter her with reverent regard. But the tiny children in mediately laid their own claim to Mahatmaji, and h gave himself up to them with all his heart. A pai invalid Mahomedan boy claimed his attention most, an obtained the most love in re urn. It was very eviden how dear the sick child was to Mahatmaji. All through the evening the little one sat upon his knee and Mahatmaji would stoop tenderely to ask him whether h had puin. A Zulu girl came in from the Mission whwas loved by all. So the evening wore on. In thsilence of the night we sang our religious songs and prayed to our Father to bless all manyind. When I retired, after saying 'good night', my heart was very ful and tears not of pain, but of joy, came to my eyes. There, in Africa, I had found Christ, whom I had sought in vain in the proud churches which refused to allow any one except 'Waite' men and women to cross their threshold. I sat for a long time in silence at the end of that day, and the Gospel scene came back to me so fresh with new meaning that I could almost pictu e Christ moving about in the Ashram, sitting with us at our evening meal and joining with us in our worship of the Father of all mankind.

I turn to Kenya, and my mind recalls an early morning on the Railway, when I met Lord Delamere face to face, as I got out of the train and walked along the platform. He stared at me with a cold gaze. He must have known who I was; for the Indians of the neighbourhood had come with a garland of flowers to greet me. I could see him s anding near by and could divine his thoughts Here are some of them now before me, written down,—the words I have just quoted:—"There is a wider aspect", thus he writes,—"Our concern for our homes in Kenya and the well-being of the native

THE FATAL ACCIDENT IN ITALY TO MR. W. W. PEARSON

It has been exceedingly difficult for me, while the rews is still so recent, either to write or speak about the death of W. W. Pearson, who has been in re than a brother to me, during all my ife in Shantanketan. Later on, I hope to be able to do so more fully than I have yet done. Meanwhile I am publishing in the Modern Review this account given by his brothers and sister to his many friends in England which has been printed and circulated among them. I am certain that they would wish it to be circulated among his friends in India and elsewhere. It runs as follows:—

"On Tuesday, September 18, our brother, Willie, was travelling with an old Cambridge triend, Mr. Bateman, from Milan to Florence. They were alone in a compartment; at a station just before Pistoia (21 miles north of Florence) a passenger jumped into their carriage after the doors had been shut by the officials, and to save himself walking along he crowded corrid r to the restaurant car, he omitted to fasten the lower catch of the door, which in Italian trains is near the floor. The views were very lovely at this point. Mr. Bateman and Willie were talking together and then Mr. Bateman went to the corrider window t look at the view white Willie I oked out of the carriage window. When Mr. Bateman looked round a moment later the carriage door was open and Willie had vanished. The train was going at full speed and it was a long time before Mr. Bateman could get it stopped: when he did he could make nobody understand what had happened, as he could speak no Italian a d there was nobody in the train who understood any English in the meantime Willie was found unconscious by workin n on the line and was taken by them to a large Villa near at hand The owner of the Villa, Count Corsini, administered first aid and brought him round to consciousness again. He sent for the Miseracordia (Motor Ambulance) to take him to the Hospital in Pistoia. He was put in a private room, and next day an English nurse, wife of an Italian doctor, volunteered to nurse him. She was in the first place called in to intepret for the surgeons, and she at once made up her mind that she would not leave him night and day. Owing to h r position as wife of the Medical Officer of Health for Pistoia, she was able to do this and to procure for him all sorts of extras 1.

which were not provided by the Hospital itself. In this way he had every comfort and the most devoted and self-sacrificing nursing. He was far too ill to be examined, so it was impossible to ascertain the extent of his injuries, but it was feared that his spine was fractured and that there were internal injuries. His life hung by a thread for several days.

" In the meantime, after a little delay, the news had reached his relations in England, and a brother and a sister arrived in Pistoia on Saturday mirraing. By that time he had rallied considerably and there was even some hope that he might by a miracle pull through. But on Sunday he became worse again and he was getting steadily weaker. He was perfectly clear and conscious ull the time and made a hard fight for life, although in the end he was glad to go. On Tuesday moruing they started giving him morphia, and he slept under its influence until he passed peacefully away in the afternoon From the first he was beyond the aid of any surgeon however skilful, but he had everything that devotion and skilled nursing could do. Owing to the injury to the space his feelings were dulled: he suffered all the distresses of severe illness, but was never in acute pain, except when he had to be moved.

Everybody who came in contact with him seemed to realise the charm of his personality. Many came daily to enquire and see him, including the workman who picked him up and the Count who administered first aid. He used his very small knowledge of Italian to the full to express his gratitude to all those who did anything for him. He was his perfectly natural self to the very end, always thinking of other people, and unfailing in his cheerful ess and humour. His surgeon said he had never seen such bravery in his life. His unconscious faculty for winning peoples' affection was never more manifest than in that last week when maselfish and untiring deviation was lavished upon him by complete strangers.

"He was cremated in Pistoia on Wednesday, September 26th where his ashes remain until his family decides where ey are to rest permanetly." C. F. A.

When I asked if there was any likelihood of Gandhi being released to fore his six year's term expires, he replied emphatically:—

"Not while I'm here. Of course, my term expires in December. They can do whatever they like with him after I go back to England,"

After describing Mr. Guidhi's life in gaol Mr. Pearson proceeds:—

Mr. Gandhi's religious creed, as explained to me by his son, is based a on two things: truth and non-violence the is willing to dispense with all forms and ceremonis which the world calls religion, and retain these two basic principles.

According to his son, Mr. Gaudhi does not wish to be released from prison by the pressure of a popular demand, but only by the Government itself, when it has suffered a change of heart towards the Indian people. He will win his release by no promise to abstain from politics, but a romises to devote the rest of his life to the liberation of his country.

COMPARED TO CHRIST

I have described briefly the life of the Mahatma in flierd remains only to give the opinion of the mas, of Indian reople on the imprisonment of their ""sint ' and leader.

Whether Hindu, Moslem, Parsi, India is religious. or Sikh, it respects religion and knows the history of other religion. Consequently, India knows Christianity. And everywhere in India I have heard Mahatma Gandhi's imprisonment compared to the crucifixion of Jesus Christ.

Gandhi, they point out "climbed down to the depths of homan misery and woe, where men toil desperately and die miserably down to the dark places of sweat and tears." And like Christ, he found "that the mastery of the world waits upon him who is willing not to make others suffer, but to suffer himself. He wore a loin cloth that no man in all the land should be embarrassed by a poverty greater than his own. Great crowds of 25,000 to 75,000 followed the Weaver of Sabarmati as they did the Carpenter of Nazareth. Four times he was imprisoned, thrice beaten by the mobs, and once left in the gutter to die.

When Gandhi lay stricken in a South African hospital after an attack which had broken his arm, he was asked what legal procedure should be taken against his assailant, and he replied, "Why should I seek to injure or punish bim? The man did what he thought was right, risked his life for it. I believe in that man; I shall love in a end win him to me. " And be did.

THE ORUGIFIXION

An Indian Moderate who is a Christian, a national leader, and a friend and admirer of the English, made this graphic comparison between the trial of Jesus Christ and of Mahatma Gandhi;--

"When the Roman Pro-consul arrested and convicted the Carpenter of Nuzareth, Roman prestige was maintained, property and vested interests were protected, and the populace quieted down and forgot all about their momentary leader. The Pro-consul showed undoubted discretion. Roman prestige was at stake-Roman prestige, which for generations was the guarantee of

world peace.
"Not that the Roman Pro-consul was without a perception of the greatness of the accused. He had probably heard something of His teachings and character. The silence of Jesus, that Non-co-operator in excelsis, made a profound interession on the magistrate and he tried feebly to save the prisoner. But the 'system' had tied him hand and foot. He could only wash his hands in futility, and hand over the accused to the extreme penalty of the law.

"So the judge, uddressing Gandhi, the Weaver of Sabarmati said—"The law is no respecter of persons. Nevertheless, it will be impossible to ignore the fact that you are in a different category from any person I have ever tried, or am likely ever to try. Also, it would be impossible to ignore that in the eyes of millions of your countrymen you are a great patriot and a great leader, or that those who differ from you in politics look up to you as a man of high ideals and leading a noble and even a saintly life. I have to deal with you in one character only. It is my 'uty to judge you as a man subject to the law, who, by his own admission, broke the law and committed what to an ordinary man must appear to be a great offence against the State."
