We have been emphasizing for sometime now in these columns the necessity for the creation by Government of an Agricultural Bank, in order to provide credit facilities to those engaged in agricultural pursuits in the colony.

The Government and its advisers are so deeply interested in the preservation of themselves and the present status quo of the population that they have disregarded all suggestions in this direction; but we feel it our duty to return as often as possible to our demand on the Government for the creation of such an institution, as it would be one of the main levers to any future advaucement towards improvement in the general welfare of agriculture and those engaged in the industry, which is the mainstay of the colony.

### Indo-American Trade **Prospects**

New Delhi, Nov. 26.—In a review of stances, private trade may be willing to business conditions in America in September 1945, Mr. S.K. Kirpalani. India Government Trade Commissioner in New York, observes that 'despite the fact that the War Production Board and other Government agencies, with the exception of the Office of the Price Administration, have been rapidly getting out of the way of Industry reconversion is running into snage owing to aggressive demands of Labour for increased basic wages."

On the question of Indo-American collaboration, he observes that "generally speaking, manufacturers who have plans for establishing production in India in partnership with Indian nationals, do not propose to proceed further until the currency, exchange and tariff situation is cleared up. Meanwhile, they will seek opportunities to send individual representatives to India to survey the situation first hand. Manufacture of various consumer goods in India through American Indian collaboration remains a practical proposition, but opinion is hardening on the issue of major capital share resting with American partners."

India will benefit most, he observes in his report, from the technological advances made by America by obtaining the services of key technicians as and when this may prove feasible. For the present, however, practically speaking, no technicians are zvailable.

The report advises that, meanwhile, "every effort should be made to develop the export trade of India with this country by testing the markets for new products like silks, woodware, ivoryware, Brassware, and silver: ware and by exporting as large quantities as possible of commodities in which the Trade for cotton waste particularly hard waste, is already established."

According to the report, the market in second hand surplus machinery remains bright for spot purchases. "Two or three months hence the picture may change radically, for many other countries have a vigilant eye fixed on every promising opportunity that comes by."

Discussing current prospects for various Indian commodities, the report observes that as regards burlap, the foreign Economic Administration is contemplating turning over the purchase to private trade channels. The shipping position is likely to become easier but there is no present indication of the price and end use restrictions being removed. In the slightly altered circumtake up the purchase of burlap provided India can give an assurance that at least 190 million yards will be available for January-March shipment at prices within the ceilings which have been operative hitherto for American Government purchasce.

The demand for spices is fairly keen but a large consignment recently received was found to be heavily infested with wesvil, Importers are averse to placing further orders unless they are assured that the tumeric available in India is clean and in good condition.

Mechanically shelled cashewnuts from Brazil are beginning to arrive in New York. Some exports in the trade believe that with proper machinery, Brazil will will eventually be able to compete with self, to learn these strange corruptions, be-India. The situation is being watched.

As regards coir; it is felt that American importers would have benceforth no difficulty in picking up the quantities which industry may require from time to time.

Since the war had ended, the situation regarding American Navy's demaid for kapok has changed. Future purchases are not likely to be made from India both on grounds of quality and price. Indian kapok has a malodorous smell and the price rules round about 25 cents per pound. It is understood that Kapok is available from France and Ecuador at 15 or 16 cents a pound.

Some time ago there was a keen demand Importers would like to know the supply possibilities over the next six months and the probable export price range.

Interest has been evinced in certain quarters in the prospects of imports of Indian silk. This is a favourable moment to send in samples and quote prices and to test the market with the help of trial consignments.

There have been important enquiries regarding a wide range of arts and crafts products. Necessary information has been furnished, which will enable prospective importers to get in touch with likely suppliers in India,--

### Indian Languages In The Colonies

One of the most interesting studies is to note what may perhaps be called the tenscity of ludian languages to survive in the differout colonies abroad, where Indians are assembled in great numbers. The conditions for such a survival are often of the most precarious character, and I have known many examples in my travels from one colony to another where the youngergeneration has lost altogether the use of the Indian mother tongue.

In addition to the familiar language which may be spoken at home, there is only one lingua franca which in different forms and many corruptions holds its place with English as a common medium. This may rightly be called Hindustani, if that name may be used for a speech which no one would recognise as pure Hindi or pure Urdu, though both languages have gone to compose it. The corruption has chiefly bean caused by the introduction of pidgin' English. To give a single instance, instead of 'Main bimar ho gaya' we used to get in Fiji, Main 'sickman ho gaya' It was necessary, even for an Euglishman like mycause they are pronounced in such a manner that at first they are hardly recognisable.

In the old days of indenture, Indians in Fiji divided themselves into two categories, grimit-wala and khalas. A grimit-wala was one who came out under an agreement, or indenture. Khalas menut one who was free. The word 'free-man' had come into use as frequently as Khalas.

\* Such was the state of thrugs when I first visited Fiji along with Mr. W. W. Pearson, It seemed to us then, that the Indian languages would soon become altogether lost in a jungle of 'pidgin' English. But a quite remarkable revival bas taken place. Owing a great deal to the efforts of the Arya Samnj, and also to the pains taken by the inspector of Indian Schools, Mr. A. Macmillan, the Hindustani that is now learnt is simple and grammatical. Also in the Nadi District, where a large number of settlers from South India have made their homes, a special school for Tamil children has been maintained with splendid enthusiasm. I am not quite sure about the latest developments, but provision has been made to teach Tamil children their own lauguage and Urdu is taught in Muslim schools. Compared with what we found in 1915 an immense improvement can be recognised.

### Constitutional Recent Changes And Issues The Question Of Government For

On the 18th day of July, 1928, the Court of Policy and combined Court were abolished for a new constitution popularly referred to as the 1928 Constitution or 'Crown Colony Government.

### West india royal commission

A West India Royal Commission was appointed in August 1938, to investigate the Social and Economic conditions and matters connected therewith in British Guiana, Jamaica, Trinidad, and certain other West Indian Colonies, and to make recommendations. This Commission however felt they were bound to extend their enquiry into the political issues of and Constitutional Reforms for the Colonies chiefly because they found the people in these parts wishing to have a larger voice in their own affairs and because they felt the. political issues were closely bound up with the social and economic problems.

This commission, which can be said to be one of the ablest, if not the ablest and most well-balanced to visit these parts made a very thorough investigation of matters and their recommendations on the Constitutional problems like nearly all of their other recommendations were extremely satisfactory and welcome and promised drastic changes of far-reaching effect and importance.

I shall deal with a few aspects of these recommendations. Of first importance is the recommendation that Official represent tation in the Legislative Councils should be configed to the Colonial Secretary, the Treasurer and the Attorney General, and the resulting vacancies filled by nominations' which would "ensure that all import tant sections and interests of the community receive adequate representation".....

### 1928 CONSTITUTION AMENDED

This recommendation was implemented in this Colony by the amendment of the British Guiana Constitution of 1928. On the 12th. day of April 1943, these new changes in the Constitution came into force

and it can be said that they were a definite step forward towards Self-Government. All the eight nominated Official Seats were abolished and the Colonial Treasurer was added to the Ex Officio group. This there-fore created seven vacancies to be filled by nominated unofficial men. But the amended constitution only provided for 2 of these vacancies to be filled. These changes have put the elected group in the majority, although it is a small majority which can be offset by any two electives swinging over to the other side.

On this point I must comment that though I would prefer the seven vacancies to be filled by elected members i.e. that the elected group be increased to 21, I am at a loss to know why all the 7 vacancies were not filled by nominations in the spirit of the recommendations.

Is it because the elected majority might further be strengthened, or is it to still place Government as nearly as possible in the position it was before the 12th April 1943? · ;

We must be quite willing to concede that the imperial Government has spent and still spends considerable sums in the "de-velopment" of our Colony and therefore it would be in the interests of the taxpayer in Great Britain to see that the complete control of the colony is not transferred away-a fact which makes me feel that it would be a very very long time indeed before this Colony gets Self Government if at all.

So that, we see the further safeguard to the Imperial Government in that the Governor of the Colony remains vested by the amended Constitution with a very wide power, of veto of any measure which may be passed by any majority of the Court.

#### UNIVERSAL ADULT SUFRAGE

The next important recommendation on Constitutional matters is to be found in 28 (d) ." That in order to secure that the elected element in Legislative Councils shall be as truly representative as possible, the object of policy should be the introduction of Universal Adult Suffrage."

Universal Adult Suffrage should be intro-duced immediately while others felt it. This to my mind, was a glorious farce,

Committees were appointed in Jamaica, Trinidad and British Guiana among other places, and we have learnt that in Jamaica and Trinidad it was recommended and has been confirmed by the Secretary of States for the Colonies that Universal Adult Suffrage be introduced. General elections have already been carried out in Jamaica without any difficulty on Universal Adult Suffrage.

#### FRANCHISE COMMISSION OF 1941

British Guiana's committee (The Franchise Commission, 1941) appointed on the 26th May 1941, submitted as late as the 28th February, 1944, a majority rcommendation for a lowered Franchise only which was confirmed by the Secretary of States for the Colonies. Recommendation 28 (d) had enjoined further that 'such committees (Franchise Commissions) should keep in close touch with their counterparts in the other West Indian Colonies."

I am yet to learn whether our Commission kept in touch with Jamaica or Trinidad which granted U.A.S. and if they did, then the nature and extent to which they kept in touch.

#### U.A. SUFFRAGE DOOMED

The cause of Universal Adult Suffrage was doomed at the very outset through the personnel of the Commission. The views of some of them were already known while the lack of political experience and knowledge of the people by some and in-difference to the issue by others, didn't Orders And Enquiries Solicited. help matters. Paragraph 108 of the Fran-chise Report reads as follows "As a result of the continuous and repeated absences from meetings of several members of the Commission...we were deprived of the benefit of their help and advice in arriving at our decisions."

We all have vivid recollections of the whole enquiry and I venture to think that quite a few just appended their names to the seport without a full examination of the evidence, thus merely recording their personal vote, a vote, therefore, of no greater value than that of a witness but used nevertheless to turn the scales on one
