CLASH OF CULTURES

MAHATMA GANDHI SPEAKS TO EUROPEANS

by Mahatma Gandhi before the Federation of the Indian Chambers of Commerce in Delhi which will interest our readers in this country:—

I hope the English friends here will forgive me for addressing you in the national language. I recall on this occasion the War Conference in Delhi which was held in this very hall in 1918 and in which after some discussion with the Viceroy I consented to participate. But when I consented to do so I requested the Viceroy to permit me to address the Conference in Hindi or Hindustani. I knew there was no need to ask for this permission, but courtesy required that I should do so, lest my speaking in Hindi should shock the Viceroy. In this very same hall to-day I propose to follow the same practice. And I would suggest to members of the Federation that it is your duty to carry on your proceedings in the national language, looking to the fact that the members of the Federation are all Indians and that you are allowing yourselves to be influenced by the present national spirit. Whilst I was listening to the President's address with attention, I wondered whether in speaking in a foreign language he would succeed in making on you and on me the impression that he desired. In no other country, dependent or independent, was such an anomaly to be met with. In South Africa, which is a thinly populated country, there has been a long struggle for precedence between English and Taal (a dialect of Dutch) with the result that the English colonists had to yield to the brave Dutch in recognising Taal as the official language on the same footing as English.

Your President has dwelt at length on the insistence of the Englishmen that in any constitution which may be granted to Iudia the rights of Englishmen, especially of the English commercial and mercantile firms in India, should be safeguarded. The Congress has considered this question carefully. and I should like to state its position. It has been said that Indian Swaraj will be the rule of the majorit community, i. e., the Hindus. There could not be a greater mistake than that. If it were to be true, I for one would refuse to call it Swaraj and would fight it with all the strength at my command, for to me Hind Swaraj is the rule of all the people, is the rule of justice. Whether under that rule the ministers were Hindus or Musalmans or Sikhs, and whether the legislatures were exclusively filled by the Hindus or Musalmans or any other community, they would have to do even-handed justice. And just as no community in India need

have any fear of Swaraj being monopolised by any other, even so the English should have no fear. The question of safeguards should not arise at all. Swaraj would be real Swaraj only when there would be no occasion for safeguarding any such rights.

Not Prejudice But Clash Of Cultures

How is it that the insistence on equal rights by Europeans comes to us with a shock of surprise? How is it that it does not strike us as natural and legitimate? The answer puts me in mind of an incident in South Africa. You know that I fought General Smuts in South Africa for a number of years. With reference to the question of race prejudice and colour prejudice there he once told me a story which impressed me very much. "When I was about the same time as you studying in England," he said, "I had no race prejudice or colour prejudice against your people. In fact if we had known each other we should have lived as friends or brothers. Why is it then that now we have become rivals, that we have conflicting interests? It is not colour prejudice or race prejudice, though some of our people do ignorantly talk in those terms, but there is one thing which I want you to recognise. It is this. I may have no racial legislation, but how will you solve the difficulty about the fundamental difference between our cultures? Let alone the question of superiority, there is no doubt but that your civilisation is different from ours. Ours must not be overwhelmed by yours. That is why we have to go in for legislation which must in effect put disabilities on you." I understood what he said and recognised that we could not have any other standard there. I also appreciated the fear of being swamped in these days of swift communications. If, therefore, we want to live in South Africa, I said to myself, we must adopt their standard of life, so long as it was not against morality.

Let us try to understand the genesis of this talk of equal rights in the light of what I have said. With all deference I would tell the Englishmen that at the back of their insistance is their insistence on living their standard and civilisation. There is a wide gulf between our way of life and that of the Viceroy however good he may be. Our people, when they go abroad, adopt the manners and customs of those countries, but shed them as soon as they come back home, and if they retain them, they become strangers. It is a mercy that the Western way of life has not yet taken deep root in our country. But the fear at the back of the Indian's mind is lest he should be swamped by the onrush

of Western civilization. In this problem I invite the halp of all Englishmen who, if they choose to stay here, must live in conformity with our way of life and as the servants of our country. The same cause has been at the root of the clash between the Chinese and the Europeans and the Chinese and the Americans. I want our English friends to understand what I am saying. The whole trouble arises out of the Englishman's insistence on living according to his Western way of life and according to Western standards. I am quite aware that our civilisation has its blamishes untouchability is an indelible stain on Hinduism and I have called it estanie,—but I do not want to give Hinduism up. for the simple reason that I was born and bred in it. I would purge it of its blemishes. If then we contemplate examining so-called vested rights in the light of India's interest, it is not because of vital necessity, Their vested rights may not smother nascent indigenous enterprise.

Notes and News

PHE following is the text of a letter appearing in Pretoric News above the signature B. H. Allenberg :-

"Sir.—During the past considerable correspondence has appeared in your paper about the Indian monopoly on the Pretoria Market, yet when a European of good education tries to make a living on the Market, consumers appear to steer clear of him.

Surely for the majority of the people in Pretoria to pay cash for their fruit and vegetables is not impossible when such can be obtained cheaper than from the Indian, who, before retailing, in the in the

majority of cases buys from the Aelalic wholesaler.
One reply I received on asking a large club for their business was that as they had been dealing with an Indian for some time past, then did not feed disposed to make a change. This institution's business would alone provide the means of liveli-hood for one European. No wonder there is unemployment.

I should not like to think that the Indians had a strangle-hold of the vast pasjerity of Pretoria citizens, yet this does seem to be the case."

The above is a typical instance of how the conspiner is tormented by the selfish petty European trader who would without hesitation snatch the bread out of the very mouth of the Indian in order to satisfy his own greed. And the Government which exists on his vote has to sell its conscience and everthing that is expected of a good and givilised Government to win his vote.

Thun the Indian Social Reformer :-

Mahatma Gandbi has been alarmed by the outery raised by some Christian missionaries and anti-Indian noliticians over his simple statement on the proper attitude of a nationalist government to proselytising activities. He concludes his reply to one of them thus: In India under Swaraj I have no doubt that foreign missionaries will be at liberty to do their prosclytising, as I would say, in a wrong way. but they would be expected to bear with those who, like me, may point out that in their epinion the way is wropg." This, we need hardly say, is a complete retreat from his statement that he would ask missionaries who pursue the wrong method to withdraw. Mahatmaji, of course, must have good reasons for his change of front buf, for our part, we are sure that it will be the duty of a national governo ment to stop organised proselytising financed and directed from foreign countries. No European country would for a moment countenance the exorbilant pretensions put forward in the name of freedom of religion in this country. Spain is one of the oldest Catholic countries, but even the has found that the Bishop and the Auteoral cannot sub-sist apart from each other. We do not want to expel any priest, but surely it is not too much to ask that he should not employ quinine or the Royal Reader as a bait to draw people to his fold. Mahatmaji's revocation is all the more strange as thoughtful Christians are coming to see that he was right in his original statement.

should serve to dispel some of the misapprehensions under which men like Mr. Churchill seem to labour. Strong government" in their eyes is a panacea for all ills consequent on political discontent. Lerd frwin told such people that the calm that may be ensured by a policy of rathless repression, which is really what is intended to be conveyed by the above phrase, would be only superficial and would not last long. It is easy for any short-sighted administrator to achieve this result; only Lord Irwin, though he too had some repression to his discredit, does not like to belong to this category. Times are changing fast and those who hug repression as a sure remedy for political trouble are living in times which are long past. Lord Irwin took the opportunity to clarify the situation as regards constitutional safeguards. A class of British politicians is never tired of emphasising the indispensability of the proposed safeguards, unmindful of the reflection which their constant harping upon them throws on the capacity of Indians to look after themselves. Politicians of this class ought to give credit to Indians for realising that any disturbance of the existing settled order would affect them more vitally than any one else. As such it must be assumed in their case, that they will strain every nerve to prevent chaos overtaking their land. The ex-Viceroy, by emphasising this point of view, has rendered India a very valuable service. However, so far as the question of safeguards goes, as has been made clear more than once. Indian opinion will be prepared to have, safeguards, but only such of them as are proved to be in India's interest, "first and last," in Lord Irwin's words,

This is Mahatma Gannhi's position in relation to safeguards to which he will apply this acid test of India's interest. Indian interests have been subordinated to British ones for very long and the better mind of the British nation cannot blama Indian opinion if it now insists that safeguards distated solely by consideration of India's interest should alone be retained. Lord Irwin deserves praise for having so clearly explained the Indian viewpoint to the British public.

THE FIRST STEP

THE speech of the President of the Transvasi Indian Congress delivered at a meeting held in Johannesburg last Sunday and published elsewhere in this issue, is a clarion call to Indians to wake up. Of all the Provinces of the Union the cloud over the Indians in the Transvaal is the darkest. In the Transvaal out of a total population of 2,087,636 in an area of 110,450 square miles, Indians constitute a population of 19,405 according to the latest Union Year Book. It may have increased since and we may safely say it has gone up to 15,000 at the most. But so there must have been an increase in the general population. There can, there fore, be not much difference in the percentage. It must sound absurd to any one to be told that there is no room for such a small number of Indians in such a vant area to: be allowed to reside in peace and to eke out are honest living. But that is in reality the case. No new Indians can enter the holy precincts of that Province and yet the life of those who have already settled there for years is made as unbearable as Matters had somewhat improved after the long and hitter struggle which commenced in 1906 and ended in 1914 shortly before Mahatma Gandhi left these shores for the Motherland. The Transwall Indians did not, however, enjoy many years of quiet since then, for the anti-Asiatic element had always been rife there and the trouble soon commenced with the begy of "Sammy trying to oust the White Man" and with measures being taken to prevent him from doing so first by the Municipalities, then by the Provincial Council and lastly by the Union Parliament. As a result we have had delegations from India, Commissions to enquire into the position and a Round Table Conference. But we are still as wa were—perhaps driven a little more backwards.

This, in brief, is the tragic tale of the Transmal Indians and they have had resson to be shocked at being still further laden with legislation depriving there, of the bard right of existence that they possess. Unlike the other Provinces the right to trade is the only right they postess in the Transvest and that too on a limited scale. They can neither reside wherever they like in the Transvael not can they own landed property. Their only means of livelihood is to trade. As pointed out by the President of the Transvaul Indian Congress, the New Licensing (Control) Ordinance confers upon License sing Committees of the City, Maniaipel. Village and Town Councils and Health Boards powers to refuse applications without assigning any recens for closing so and their word will be final. This is a flagrant breach of the Capetown Agreement in which it was agreed that the Union Government would "give all due consideration to the suggestions made by the Government of India Delegation that the discretionary powers of the local authorities might reasonably be limited in the following way, (1) the grounds on which a licence may be refused chanks but laid down by statute, (2) the reasons for which a licence is refused should be recorded, (3) there should be a right of appeal in cases of first applications and transfers, as well as in cases of reliewals, to the courts or to some other impartial tribunal." view of this we cannot believe that the new Ordin nance passed by the Transyaal Provincial Council would be assented to by H.E. the Governor-General. As this matter vitally concerns the Capetown Agreement, the Agent of the Government of India, we have every hope, will do his very best to prevent the measure from coming into operation.

The President has also drawn attention to the treacherously barsh administration of the Immigration laws in the cases of minor children who are being deported owing to some foolish errors unconsciously made by their ignorant adult relatives. Yes, one can write volumes on the Immigration difficulties that Indians have to suffer and the humiliations that they have to undergo in that

These are two main difficulties the Transval Indians in particular have to suffer and generally Indians in all the Provinces are subjected to and there are micor instances of humiliations that the Indian has to put up with in almost every department every day in the course of his daily liferal matter which no Round Table Conference will ever be able to remedy but our own consciousness and the readiness to sacrifice our whole being than to suffer to lose our self-respect alone can remedy.

While some of the greivances above mentioned affect the Transvaal Indians and they will, therefore, have to be more concerned about them and to make a move on their own these questions will at the same time have to be taken up by the Indian community as a whole. The situation is grave and impossible for any self-respecting community to bear any longer. If, still, the community wishes to wait for the Round Table Conference to bring them the required redress they may do so. But it will be a wise course to be prepared for the worst. The first step in that direction will be to make our organisations financially strong. The President of the Tanavaal Indian Congress big very rightly pointed to the need of funds. The system of going out collecting when the contingency wises

is absurd, and utterly unbusinesslike. In this connection the community should know their own responsibility. They should know that any redress they wish to have made in public matters the only correct and effective course is to do so through their organisations. And in order that those organisations may exist the community should make it their business to support them. In order to do so every Indian should without being asked send as much subscriptions as he could afford to their respective Provincial bodies until the officials of the bodies declare that they have sufficient funds to carry on their work. If our countrymen are really concerned about their status in this country let them prove their sincerity by making it their business to see that their organisations are at least not lacking in so far as funds are concerned.

Transvaal Indian Congress

· Protest Against Fresh Grievances

A meeting of the Transvaal Indians was held in Johannesburg under the auspices of the Transvaal Indian Congress on Sunday June 21. Mr. Gardi the president was in the chair.

Chairman's Speech

The following is the text of the chairman's

speech:-"Once again it becomes my disagreeable duty to call your attention to fresh grievances to which our unfortunate people have been compelled to submit, and once again you will be crying to high heaven "How long, Lord? How long?" There is seemingly no limit or end to the humiliation to which it is thought possible to subject us. Being voiceless and regarded as unworthy to be consulted in regard to our own fate, we are, of course, treated as a people of no account whose only rights are to do as they are told and be thankful for any crumbs that may be allowed to come their way.

Licensing Control Ordinance

"The most recent attack launched against us takes the form of Transvaal Licensing Control Ordinance. This has not as yet been published, although it has been passed and approved. If, however, report speaks truly, this Ordinance purports to confer upon Licensing Committees of the City, municipal, village, and town councils, and health boards powers so wide and so unchallengeable as to make the position of Indian traders perilously unsafe. One example will suffice. Applications may, I have every reason to believe, be refused without assigning any reason at all for such refusal. You will not need me to remind you of the difficulties with which Indian applicants for trading licences are invariably confronted and how refusals of applications—based in reality upon racial and colour antipathy,—are camouflaged so as to fall under one or other of the authorised grounds. Again and again, we have been driven to the courts at roinous cost, to secure justice and protection from spoliation. But what if recourse to the courts be now denied us? Because I have the strongest reasons to believing that this is exactly what we have to expect in the near future. You will have to decide what course of action—not mere talk or protest, but action—is to be adopted to meet and repel this new danger.

Immigration Laws Harshly Administered "The next matter to which it is my duty to invite your attention and opinion is what I have no

hesitation in describing as the cruelly harsh and unsympathetic administration of the immigration laws against helpless Indian children. Recent examples of this have been brought to my notice, examples, the details of which I prefer to leave to the speakers entrusted with the relevant resolutions. I shall, for my part, content myself with remarking that while we Indians are painfully enough familiar with war made upon us as a community, we find it difficult to speak with moderation when every possible advantage is seized upon by the authorities to effect the deportation of helpless children scarce out of babyhood, because of some foolish mistake made by an adult relative. Even those children who have been born here, baving a right that cannot be denied by any civilised Government, are. treated as prohibited immigrants and are deported.

The Round Table Conference

"We are all of us awaiting with some anxiety the result of the Round Table Conference to be held at the beginning of next year. We realise that the conference in question will probably determine our fate, and that the success or failure of our protagonists will be synonymous with life or death for us, perhaps more particularly for us of the Trans-

"'Coming events cast their shadows before,' and while we have no desire to create an atmosphere of pessimium, we should be foolish were weato underestimate the gravity of our position, to lose sight of the avowed policy of the Government of the Union in regard to us and to overestimate the powers of the Government of India to secure for us the desired relief. Let us, however, not fail to urge the Government of India to delegate none but the best and most influential men to the conference, and a resolution to this effect will be duly submitted for your adoption.

Tarred With The Same Brush

"If we are wise we shall so put our house in order that should the worst happen, we shall not be taken by surprise. Allow me once again to remind you that the enforcement of existing statutory disabilities including the most recent enactments that are virtually in suspense pending the conference, must inevitably make life in this country utterly intolerable. Hoping for the best, we must be prepared for the worst, and the time has, I submit, now arrived for us to prepare for the contingency. Let us, then, solemnly resolve to shirk no sacrifice the near future may demand of us. Funds must be collected, that is one form of sacrifice, and it must be whole-hearted and not niggardly. Remember that if we have to struggle at all, the struggie will be one of our very existence.

"I urge you to give this important matter your immediate attention—to do it now. If what I am asking of you is too much, then in common honesty let us throw up the sponge and confess ourselves to be miserable cowards and unworthy of regard as sons of India. Let me also add that my remarks apply to my brothers of South African birth equally with my brothers of Indian birth. In these matters we stand or fall together. Who seek to draw nice distinctions between the two sections are deceiving themselves, and each other. The Government fails to make any such nice distinctions. In its eyes, we are all tarred with the same brush; in its nostrils the one section is as offensive as the other. Therefore, there are not two Indian causes to be fought for, but only one.

Proposed Treaty Between Union and India There is yet one observation I feel called upon to make. We hear talk of possible treaties between the Union of South Africa and India, treaties for the advancement of commercial intercourse between

The idea of treaties presupposes the two countries. equality as existing between the parties treating. It so, are treaties possible between the Union and India as long as Indians resident in the Union are

legislated against as undesirables?

Finally, you will, I hope, forgive my reminding you that I do not speak as one who has no stake in this country, and that if sacrifices have to be made. my own must needs be one of no smaller proportions. It is this fact that I think entitles me to call upon you to respond to my appeal and I do so in complete confidence that you will answer the call with your whole heart and with the courage and determination of brave resolute men."

Resolutions

The following resolutions were then unanimously

adopted:-

(1) This meeting hereby places on record its protest against the removal or weakening of any of the safeguards that presently protect Indian applicants for trading licences against discriminatory treatment on the score of race, colour, or incon-

venient competition.

This meeting respectfully but carnestly (2)appeals to the Minister to direct the Immigration Department to temper the severity of its attitude towards cases where the claims of little children are discovered to be open to attack owing to mistakes or blunders made by adult relatives, and also the rights of colonial-born Indians to enter and reside The meeting ventures to, urgo the in the country. giving of a little more consideration to the equities of such cases, even though the strict letter of the law favours the department.

This meeting desires through the S.A.I.C. to respectfully invite the attention of the Agent of the Government of India to the observations of the Chairman on the subject of the Round Table Conference and ventures to hope that the Agent will see

fit to communicate same to his Government.

Colour Bar In Britain

Mr. H. S. L. Polak, chairman of the Executive Committee of the Joint Council to Promote Understanding between White and Coloured People in Great Britain, writes as follows in the Munchester Guardian :-

Sir,-My colleagues of 'The Joint Council to Promote Understanding between White and Coloured People in Great Britain' will have shared the grateful appreciation with which I read your article on 'Colour Sense in the British Empire,' commenting upon Mr. David Freeman's valuable contribution to the Contemporary Review. If anything could more emphatically point the moral of your remarks it would surely be the announcement in a newspaper to-day that, owing to the refusal of London hotels to receive him as a guest, Mr. Roland Hayes, who is not only a great negro but a great artist, has been ont to the maximum of inconvenience and humiliation in securing accommodation here, due to the fact of his race and colour.

I know from my own experience how difficult many of my Indian friends, distinguished citizens in their own country, or their relatives, bave found it, especially in London, to obtain suitable accommodation, except in the most expensive hostelries, on similar grounds. These grounds are not always acknowledged, and all kinds of flimsy excuses are put forward by hotel managements, flat owners, estate agencies; and boarding-house keepers for their

refusals of suitable accommodation for respectable and well-behaved Indian guests. The problem becomes still more sente in the case of colonred students from British overseas territories. The result is but too often either the generation or the intensification of a strong sense of racial bitterness and anti-British feeling.

I can corroborate from my own knowledge Mr. David Freeman's statement that coloured British travellers on foreign steamers habitually receive better treatment, in every respect, than they do on the British lines; and I may add, from very unpleasant perconal experience, that British Europeans fraternising with the British coloured fellow-subjects are almost equally ostracised by British travellers, not only on the British boats but even on the foreign ones as well. This has been especially noticeable on eastward voyages to India. So unpleasant have things been, over a long period of years, that of late I have made a practice of travelling eastwards and home by foreign rather than by British boats, in order that I might have to endure, both in my own person and in that of my Indian friends, the minimum of inconvenience, discourtesy, and supercilionsness.

The ill-will between India and Britain has been enormously accentuated by individual experiences such as those above referred to; and, if the information that my Committee has is correct, it would seem that the relations between Africans and our people here are likely to be considerably compli-cated by a multiplication of similar instances of racial and colour prejudice. Round-lable conferences will andoubtedly do much to restore mutual confidence between Britain and India; but it will be au ill service to the cause of international and inter-racial brotherhood if hotel and boarding-house keepers bere, and British travellers, especially on British steamers, frustrate these efforts at reconciliation and forget the duty that they owe to promote good feeling and a better understanding between white and colour in the British Commonwealth.

Gandhi Under Fire

Preloria News writes as follows :-

The battles of Colenso and Spion Kop are being refought in the newspapers to-day with the object of proving or disproving that Mahatma Gandbi was present at them and came under fire. This quaint controversy has arisen in England, spread to India, and is now in danger of extending to South Africa, for already two Pretoria witnesses have volunteered their testimony. A subject that excites interest in three Continents can hardly be dismissed as trivial; but it only derives importance from the personality of the chief figure in the case. In his biography of his friend the Mahatma, the Rev. C. F. Andrews apparently had stated that Gandhi, as a member of the Indian Ambulance Corps, served with the British troors in the Anglo-Boer War and was under fire at Colenso and elsewhere. In making this statement Mr. Andrews was merely repeating something that appeared in print twenty years ago. this time it attracted the notice of the fiery Colonels who read the Morning Post, and it has been hotly assailed. At least one distinguished officer seems to have grown almost apoplectic at the very idea that such a man as Gandhi was assisting the British troops at that time. There seems to be no doubt, however, that Gandhi was actually in the field. He arrived in South Africa six years before

the war broke out, and in 1899, when he was thirty years old, he played a leading part in enrolling the Indian Ambulance Corps, 1,000 strong, and in petting its services accepted by the Imperial authorities. Whether Gandhi and his fellow stretcherbearett ever in fact came under fire we are not prepared to argue—it seems a futile point in any byent—but that they rendered valuable service to the troops at this time is not open to question.

Gandhi and Missions

Jects, sind there was a crowded audience.
Applause greeted Mr. Andrews statement that when he was in India as a missionary he would have when he was in India as a missionary he would have nothing to do with the compulsory attendance of Hindin or Mosleim students when Bible teaching was being given. He had made the stand at the college it which he had taught at Delhi in 1904, for he felt which he had taught at Delhi in 1904, for he felt which compulsion was a breach of freedom of conscience and that no Christian should impose it. He discovered one of his Hindu students was obeying the letter of the rule by attending, but he stuffed his ears with cotton wool so that he should hear none of the teaching.

It was against such missionary methods that Mr. If and his was protesting. But there has been a change of heart since the beginning of the century," said Mr. Andrews, "and I hope there is nothing of a compulsory character in the work of any missions in India. The fact that it is now the custom to have a conscience clause is a victory, not against missions basis.

Even in religion this aggressiveness is practised. We want to ram our religion down people's throats instead of winning them. This is seen in some ports of missionary work, but it was the method condemned by Christ when He said. "Ya pornpass sea and land to make one proselvis." Aftesionaries should be the servents of all. They must go to India in the spirit of humility, love and seevice, to learn humbly rather than to teach arro-

service, to learn humbly rather thus to teach atro-santly.

"If you se out to India in the spirit of 'teaching the benighted heethen' what you know, then I say with all seleminity that is not the Spirit of Christ." and Mr. Andrews. "We have to learn from Militatina Chibith! Rabilibranath Tagors, from China thid other Rasisin likids, where voices are telling us we fill fibt indefeated the Master rightly. They say to its 'We have had to suffer and have been humbled and we know what Christ ineans in a way, you who rais and dominate in the West do not understand."

Mr. Andrews said he was perfectly certain Mahaima Gan thi's words regarding missions had not been rightly understood in the papers in this country. He had learnt to follow the Sermon on the Mount not in words but in deeds and practice Living as he does how could he wish the Spirit of Christ to be banished from India? Of course he doesn't, but he does not want the spirit of anti-Christ, of violence, domination, pride and aggression. It we go out as missionaries we must learn to be meek and lowly of heart."

Classes in English, Business Correspondence, Bookkeeping, Typewriting, Business Methods, Short-hand and Afrika and are held from seven to hine on the evenings of Monday, Tuesday, Wednesday and Thursday. The Lecturers have all had long experience in their various subjects and the Education Department has kindly allowed the students to meet at Sastri College, the magnificent building devoted to the higher education of Indians during the day, and thus they have at their disposal the most the to-date equipment. In addition twelve new type-writers have been provided especially for this work. For a moderate fee a young man can learn how to

We sincerely wish that at least some of the best qualified applicants will find some apportunity in future to carry on higher studies in German universities, through the support of Indian adnosticulated and cultural organizations or through the generosity of wealthy Indians, interested in the welfare of the people. There are stready a few findian scholars in Berlin and Minich, who are supported by the Geveriments of Mysore, Barods and Hydratud States. We bleedely wish that the pumpler of distinguished lighten scholars to flayman universities will increase every year; and this will aid the cause of promotion of cultural co-operation

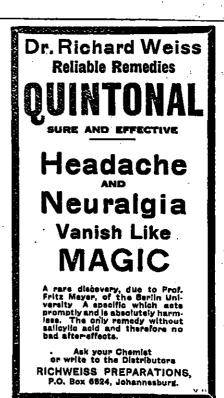
