Notes and News

A Threat?

An important piece of news has been transmitted, y the Parliamentary correspondent of the Natal Mercury from Capetown which amounts to a threat to the Indian community. Time does not permit us to reproduce it in full in this issue. We hope to do so in our next week's issue and also to deal with

the Government to take legislative steps to tackle the Indian mensee without further temporising and delaying. Hence, in raising difficulties before the colonisation scheme, the Indian community is merely hastening the demand by the public for alternate steps, such as the Class Areas Bill, which were held in abeyance in 1928.

That the Indian problem constitutes an increasingly schous mensee to the European community becomes more obvious every day to those who are in touch with the situation, and unless leaders of Indian opinion in South Africa display a little more vision they may easily hasten retaliatory measures.

GROSSLY MISINFORMED

N the course of a leading article in its issue of 7 . Jan. 11, on the question of the Natal Indian, the Natal Advertiser, while deploring the forma-i " tion of a Colonial-Born and Settlers' Indian Association, suggests that "it was brought into being atthe outset because its authors, felt that the Souther African Indian Congress did not reflect vigorously enough the opposition of the Natal-born Indian to the purpose of the Indian Colonisation Inquiry Committee." We must say that our contemporary has been grossly misinformed. The differences, with the Congress were for its inconsistency, and, The Congress leaders had let the, autocracy. community down perhaps unintentionally, it might be said, when they agreed to the first Capetown Agreement which was based on the principle of reducing the Indian population of the Union to its irreducible minimum. Much has been spoken of the Assisted Emigration Scheme-how it was an improvement on the original Repatriation Scheme, how it was a purely voluntary scheme and how it was possible for the repatriated Indian to return to the Union again after the expiry of one year and within the period of three years of his departure from the Union. For five years the working of the scheme was watched, the Congress having their hands tied. While the scheme was voluntary in name there were other forces, such as, economic, pressure brought about by throwing Indians out of , employment and the general depression. These ... worked against the Indian which drove him to take ,, advantage of the inducement of the big honus and a free passage only to find himself thrown in a country utterly strange to him. 'The condition of the repatriates in India was investigated into by Congress leaders and both the Governments of the Union and of India were condemned by them for ever bringing such a scheme into being. But while inducements were offered to those who chose to be repatriated in the form of a bonus and free passage. 41 inducements were also offered to those who chose > to remain in this country in the form of some ... promised concessions if they agreed to the assisted emigration scheme, in other words, to sell the birthrights of their own brethren.

The findings of the Congress leaders of the evils of the assisted emigration scheme were placed before the leaders in India including Mahatma Gandhi who, commenting on their report wrote at the time (June 4, 1931) inter alia

"But it is no use crying over spilt mile. The labours of the framers of the report will not have been in vain, if attithe time of the revision of the Capetown Agreement thin ... rights of the poor labouring Indian, population, are not all bartered away for doubtful concessions to the other Indian

settlers. The position taken up by the latter is unassailable, and should depend on its own merits. The settlers themselves should therefore refuse to be party to any bargain. which would compromise the rights of the less favourably stated brethren. South Africa can easily absorb and amodate the existing Indian population."

There could be no clearer statement as to the duty of the Congress leaders from one whom they profess to recognize sud revere as their great leader.

Notwithstanding that, and notwithstanding the fact that they themselves had thundered from public platforms that they would never countenance the selling of the birthrights of their brethren for a mess of pottage they have persisted in identifying themselves with an Enquiry Committee, whose object is to explore the possibilities of a colonisation scheme for settling South African Indians outside the Union and to find out how many Indians would participate in such a scheme, thus flouting the epinion of those very people who did not wish to be let down again for the second time. he are crue.

Thus the Congress has been guilty not only of inconsistency but also of flouting public opinion. The Colonial' Born and Settlers Indian Association owes its existence, therefore, to the high-handed autocracy of the Congress leaders who represent themselves only and a few others who perhaps find it profitable to be with them.

Much as we regret the present split in the community there was no possible way of avoiding it so long as there was a third party in the country to take

long as there was a third party in the country to take long as there was a third party in the Transvall where sides. There is a split even in the Transvall where there is the Congress as well as the Commercial Association. Uptill recently the Congress had suiked because the Agent ignored its voice and helped in the creation of and sided with the Commercial Association. A similar situation has arisen in Natal, and in both the cases the Agent has by his artful methods won ever the Congress officials to his side and both have taken unto themselves the reponsibility of serving the commanty against its will. The Congress has no right whatsoever to claim to represent South African Indians.

Infectious

What surprises us most, however, is that the in-, consistency of the Congress should have been so infectious as to have infected even our afternoon contemporary. Not very long ago when we condemned, on principle. and dides of a colonisation scheme, on the ground that the motive ... Africa in every sense of the term. The Indian has underlying it was to reduce the Indian population of the Union, our contemporary took us to task severely, suggesting that we should leave all talk of principle saide and look at the question from a strictly practicel and bread and butter point of view and that it was far better to send Indians to some ether country where they might find better hospitakty rather than seeing them miserably situated in South Africa. We find it now considering the Congress statement, which advances no new arguments, to be "an expression of a quite legitimate point of view" and suggesting to us that far wiser would it have been for us to have trusted that the Congress of the right time would have

voiced unequevocally general Indian resistance to any colonisation proposals whatsoever !"

But then again the Congress too has been consistently inconsistent. Its statement is full of inconsistencies. In one place it says that "the whole history of our community here warrants the assumption that any such scheme is intended to reduce our numbers." In another it says that "the desire to seek a new country and new homes as in the past are mainly from thickly-populated countries where the struggle to exist has turned men's thoughts in the direction of new outlets. No such desire has ever been evinced by the Indian community in South Africa, nor is it reasonable to expect such a desire to arise in a country that is spursely populated," and it expresses the strong feeling that the solution of the Indian problem is close to the hand of the Europeans in South Africa. This is certainly not consistent with its co-operation with the Enquiry Committee. It would have been quite legitimate for the Committee, for instance, to have said : " We know all that but we want you to help us in looking for another suitable country where we can settle South African Indians." It would be interesting to know what reply the Congress leaders would have given to such a question. But it has, of course, left a loop hole even for that by saying that the present was the werst possible time to consider and examine possibilities of colonisation on a large scale.""The inference is that it would support it on B smaller scale.

Quite obviously the strong opposition on the part of the Colonial Born and Settlers Indian Association has put the Congress slightly off the hinge.

The Real Solution

There can be only one real solution of the Indian problem in Natal and that is to face it with a sense of fairplay and justice. The Indian was brought to this country and was used to its advantage. It would not be human to throw him away like an orange after having sucked it dry. His descendants must be considered part and parce of the Union's population and should be afforded every opportunity to become nationals of South never sepired for dominating South Africa. What he asks is the right to live like self-respecting human beings and the opportunity to eak out a living honoarably. This is not asking too much, nor is it difficult to give, if only the ruling race were to evince a little more of the spirit of generosity and less of that false sense of race superiority which in in the long run is never going to pay. Mr. B. M. Narbeth's Protest

Sir.—You have on various occasions honoured me by referring appreciatively to my work in connection with the Indian Technical Education Committee. It is quite true that I am deeply interested in the welfawe of the Indian scople in South Africa as I am also anxious to see all improvement in the relations between the Indian and the European people in this country, for it is only by mutual goodwill and understanding that real and lasting progress can be made.

For these reasons I have been greatly concerned to see paragraphs appearing in INDIAN OPINION which can error only to allegate European sympathy while serving no good purpose to the Indian community.

In your issue of January 12th there are two entirely misleading paragraphs quoted from maether journal but evidently with editorial approval.

journal but evidently with editorial approval.

One of these paragraphs assigns "The Cause of India's Poverty" to the large salary received by the Vicercy of India. Although I do not think any intelligent Indian or European reader would accept this view of "The Cause of India's Poverty" it may be that many unthinking people wiff awallow the suggestion without consideration, and it may be desirable therefore to refer further to the matter.

The paragraph concerned compares the salary of the Viceroy with that of the Printsh Prints Minister, the former being about four times as great as the latter. But the Viceroy occupies a very different position and status from that of the Prime Minister. He is there, as his title indicates, in place of the King-Emperor, and his salary should therefore he compared with that of the King and with those of the Indian Princes and rulers. In comparison with the income of many an Indian Prince, the Viceroy's salary is small, and it represents an almost infinitesimal fraction of the wealth of India. Further, the Viceroy's salary is not hourded up or sent overseas, but spent is the country going into circulation amongst the people and giving employment to many.

A fertile cause of poverty in India is the notorious practice widely adopted there of hourding gold. Te must be admitted, however, there is one sense in which some of the poverty in India is due to British rule. The Government of India has stopped internecine warfare by the peace of good government, it has practically put an end to periodic famine by irrigation and other public works, and it has reduced plague and disease to a minimum by introducing sanitaty reforms in urban and rural areas. These three factors, war, famine and disease served formerly to reduce the population of India from time to time by counties millions. Now that those millions are allowed to live the consequent rapid increase in the population of the Indian Continent introduces the gravest problems problems which cannot be immediately disposed of by a stroke of the pen or even by the best of Governments. The poverty due to excess population is thus in a sense partly due to the measures adopted by the Government to preserve the peace, prevent famine and reduce disease in the It must not be fergotten, however, that the wealth and health and population of India have by these same means been increased almost beyond comprehension. The root-sauses of poverty in India lie elsewhere—but that is not my subject just now.

I note that you characterise as "sublimely true"

the suggestion that the introduction of the Bible and Christianity into South Africa has robbed the Natives of their lands. I should prefer to describe each an insinuation as a foul libel on our mission-aries and on Christian people who sent them. Had it not been for Christianity and the Rible the plight of native Africans would have been in the small distribution worse than it is. There has not been enough of the Bible and Christianity in dealing with the Natives.

One is impelled to sak has the Indian decreased by in South Africa not easingly grievimens of its way without going out of its way to import fieldless statements from abroad to fement ill-will in this country and so to increase its own troubles? In this

The countenance given by Indian Opinion to such deplorable micropresentations of fact in those I have dealt with makes the task of those of these Indian and European—who are seeking to improve the lot of the Indian in South Africa and to develop better relations between the reces, infinitely more difficult, for it serves only to exacerbate where we are seeking to ameliorate those conditions.

I should like to appeal to the leaders of Indian opinion in Natal to seek to terminate this rapidly growing tendency to sow dissention and ill-will and to cultivate better relations both amongst themselves and with the other elements of our South African community.

[Norm,-We fully appreciate Mr. Narbeths feelings. Any person who is righteous himself will abhor even to believe that there could be any unrighteousness. Mr. Narbeth has taken exception to the Viceroy's large salary as being the extrae of India's poverty." Of course it would be wrong to say that it is the only cause. But eminent concernists and even Mahaims Gandhi has ineluded that among the most important items that we responsible for India's poverty. India is ruled not by the Viceroy but by Downing Street. We do not therefore see that the Viceroy's position is different to that of the British Prime Minister. But the fact that one has to remember, whatever may be said about the riches of the ruling Princes and of the habit of hourding, is that indie's average income is one-exteenth of that of Great Britain and yet the Vicercy's many is almost four times as great as that of the British Printe Minister, and let in not be forgotten that after his five years term he is entitled to a life-long pension which is also paid by India. It should sho be rementered that the Indian Civil Service is the most expensive in the world. "What good the British Coverament has done for the benefit of India to a d'batable question and we would not like to enter into a discussion of it here. The next point to while? Mr. Narboth has taken exception to is that Christians have brought the Bible to the Native and deprived him of his hand. Is there in any south about it that the present Christian Government is adopting and Ohristian methods in dealing with the Native question? Are not Christians advocating the throwing out of employment of hatives to make room for Europeans to solve the employment question. How will it help the Native by enatching away the bread out of his mouth and preaching to him the. Gospel? All honour to those true. Christians who are fighting for the legitimate rights of the Natives. But they are exceptions to the general rule. It is certainly not our purpose to foment ill-will in this country nor to antagonism the European friends who are working for our good. But truth will never be hi iden however much you may try to hide it. It is to to every true Christian not to recent it but to face it courageously and to fight for it. Ed. LO.

Congress Resolution At Capetown

THE EDITOR, INDIAN OPINION

Sir,—I wonder where "the officials of the Congress" and the "delegates from the provinces" saw or heard the "unwarranted and vilifying attack" made upon Kunwar Sir Maharj Singh, Agent to the Government of India in South Africa by a section of the Indians at a meeting in Durban recently." Are the members of the S. A. I. C. justified in construing a reading of facts (which happens to be differnt grom their own predilections) and a resolution passed to that effect by a section of Indians at Durban as an "unwarranted and vilifying attack" upon the Agent? I am also a pro-congress-man but I cannot understand the attitude and justification of the resolution passed by the Executive Committee of the S. A. I. C. at Capetown.

I remember perfectly well that in 1932 both the Annual Conference of the S. A. I. C. held at Johannesburg, and the Conference of its constituent body, T. I. C. strongly and vehemently denounced the A. L. T. Act and passed a resolution without an utterance of a single discordant note, refusing to co-oporate with the A. L. T. Act Commission appointed under that Act. What happened then? All the Indians, whether congresswalls or not, witnessed with some amazement, a spectacle of the Agent acting as the guide, philosopher and friend of a new organization (in opposition to congress). That organization is known as the Transvaal Commercial Association to which the Agent, gave his blessings and he identified himself with it in order to cooperate with and help the A. L. T., Act Commission in its work of reporting, ear-marking and recom-mending certain segregated areas where the Indians can have their legal rights to confine themselves in for the purpose of trade as well as residence. It is well-known to everyone what then , was the attitude of the S. A. I. C. and its Executive members. But now we are pubicly informed by the S. A. I. C. that even that part played by the Agent must be looked upon as an example of "untiring and selfless services in the cause of the uplift of the Indian community.". And do not forget that the very same commercial Association is not going to support individual cases of poor people who form a large majority in Transvaal. Now where lies an "un-t warranted and vilifying" attack upon the Agent when a section of Indians in Natal express the opinion that the Agent has divided the community and that he has lent his weight to and supported a minority?

No one can mistake which way the popular wind blows especially in Natal. In the prevailing circumstances the officials of the S. A. I. C. (sometimes referred to as unpopular, unleading leaders whom the majority of people do not believe in) cannot but say Agent Saheb Behet Achchha Sarakari Amaldar Hai.

When the Agent can hear such nice sweet words said about himself, why should he take the trouble to go to Natal and personally witness and hear the expression of popular opinions of the majority of the Indian people especially when their-very-life-and-death-problem-of-colonisation-had-to-be-discussed. Indeed sweeter are the words of those who say without rhyme or reason Yea Yea instead of Nay Nay to whatever the Agent does. A CONGRESSMAN

Towards A Deadlock

In the course of an editorial headed "The Natal Indian Deadlook" the Natal Advertiser writes;

"We have felt for years that the Indian population in South Africa has been moving remoraelessly towards a final deadlock; and we dread that dead-lock because it will harm South Africa more than it will harm the Indian in our midst. There are solvents to the problem; solvents that, if they are little better than expedients, at least would help to clear the air, reduce the menace of Asiatic numbers in any one part of the Union, and, to this extent, relar the racial tension that makes Natal to-day an area charged with possibilities of very grave inter-Imperial repercussions. But not only is South Africa as a whole not inclined to discuss these expedients. There is no political organisation, nor apparently any natable religion to the second tion, nor apparently any notable political leader in the country disposed to pursue any of these partial solvents, or do other than let the matter drift as it has drifted for a score of years. A man might take any one of the Parliamentary groups at random and ask it for a policy on the Indian question in Natal. He would ask in vain. Even if the Colonisation Inquiry Committee represents a policy, it is a policy of despair!

The great majority of South Africans, if asked what should be done about the Indian question in Natal, would doubtless reply, "Let it alone Let it solve itself. Let Natal and its Asiatics stew in their own juice." Well—suppose in the long run this is the nation's attitude towards the matter; where does a man suppose such a course will end? If the Indian, confined to Natal is given what If the Indian, confined to Natal, is given what every man of any colour is entitled to—education and a reasonable chance of self-expression—then the time is not far distant when he will be a far greater challenge than he is to-day to the European seeking employment in this Province. If, on the other hand, his helotry is intensified; if he is more and more made a child of the ghetto; if he is denied any outlet for his many qualities of mental and physical industry; his numbers and his degradation will increase in parallel ratio. Depressed, he will inultiply; therein merely exemplifying a social phenomenon noticed in all the ghettos of the world. Nor is this all, or even the worst. The worse his condition, social, political or exemplify in in this country, the tical or economic, is in this country the more is his "cause" likely to be a political issue between a self-governing Indian Dominion that will not be slow to test its prestige in the British Commonwealth by defending its nationals oversea, and a South African Dominion jealous of its own self-governing powers. For the last word in the matter is this word "national". The Indian is either a South African national or else he is a national of India. Some country or other must own him. He cannot be, like Topsy, a creature that just "spect it growed." This aspect of the matter is probably not lost on those who decide our respective Imperial destinies. But it is one towards which public opinion, both in Natal in Strong disapproval was expressed by the delegates towards which public opinion, both in Natal in from the provinces at the "unwarranted and particular and in South Africa in general, seems vilifying" attack made upon Kunwar Sir Maharaj at present blankly indifferent!

Colonisation Enquiry

S. A. I. Congress's Statement

That long awaited statement of the S. A. I. Congress was presented to the Colonisation Enquiry Committee, appointed to explore the possibilities of a Colonisation scheme for settling South African Indian outside the Union and to find out to what extent Indians would participate in such a scheme, at Capetown on January 9.

After relating the history of Indian immigration and quoting elaborately from the reports of the India Commission in Natal in the year 1886, and the Clayton Commission of 1907, the Congress directs attention to the obligation that Natal owes to its Indian population and proceeds to refer to the gradual change that has taken place in the attitude of the European population towards the indians.

"We have been at some paine," it is submitted, "to give the history of our community in this country, as far as we are able, to present a picture of our position to-day, because we think it essential to explain to the committee the back-ground and atmosphere which influences us in the conclusion we draw regarding the possibility of colonisation from South Africa.

"A very large majority—certainly more than 80 per cent.—of the Indians now in South Africa are colonial-born descendants of the immigrant Indians. Their ancestors came to this country not with any spirit of adventure but on account of the adverse economic and social conditions prevailing in the vast country like India, and at the special invitation of the Europeans. The majority of them were drawn from Madras and Bengal Presidencies and among the poorer peasant class. This type of Indian is fast diminishing and in the course of a decade or so will have almost, if not entirely, disappeared.

"The prepondering element to-day, consisting of the colonial-born Indians, are such that to all intents and purposes they are South African-born, both in their character and outlook, having come in contact with Western influence and civilisation. Their national character and aspirations are gradually being lost, the knowledge of their mother tonge is dying out and their mode of dress and living is fast changing toward Western ideas. They are accustomed to the climatic conditions of South Africa, and the tropical climate would have the same disadvantages for them as for a European South, African."

The Congress frankly cenfesses its suspicion in its attitude to the colonisation scheme.

"The whole history of our community here warrants the assumption that any such soleme is intended to reduce our numbers, to get rid of those who would never have been here but for the insistent demands of the European population and without whom Natal could hardly have attained the present state of development and prosperity. But even if we set aside such suspicion we feel that logic compels us to the conclusions that a colonisation scheme of the kind now envisaged cannot be attractive to us."

So, for Indians in India, the Congress conceives of a land settlement scheme, but for Indians to leave their homeland in considerable numbers their must be a real inducement in the nature of a guarantee of profitable land.

land.

"As for South Africa," in the first place there are now about 150,000 male Indians engaged in agricultural pusuits. This number includes Indians of all ages. It is reasonable to assume that normally a man of 85 or more will be unwilling to uproot himself unless very special advantages are expected to accrue. The urge to travel and explore, the spirit of adventure; if, indeed, they existly briginally, have by this time vanished. We

abould be inclined to put the maximum age for the would-be colonist even lower, but if we set the maximum at 35, that must naturally decrease the numbers theoretically available for such a scheme. In the second place, we, who have been in South Africa and have lived here all our lives, know little or nothing of tropical conditions."

Different Standards

Apart from climatic considerations, there was another consideration of supreme importance. The Indians in South Africa had become accustomed to Western standards of life. On the other hand, a colony for Indians from India must be founded upon different standards from India must be founded upon different standards from those to which South African Indians were accustomed. It was difficult to see how Indians at present in South Africa could ever fit into such a colony; their habits of mind, their habits of dress, their general outlook were all different. It was, of course, true that in the past few years a number of Indians had left the Union for India, but they were exactly the people who were prepared to live in countries where Western standards did not prevail. The South African-born Indians who had gone would be found to be in a great majority of cases children who were accompanying Indian born parents. In addition there were economic causes at the present time that no country in the world would welcome a large influx of colonists. The present was the worst possible time to condaider and examine possibilities of colonisation on a large scale.

"Moreover, so far as we are aware," the statement continues, "the desire to seek a new country and bomes as in the past is mainly from thickly populated countries where the strangle to exist has turned men's thoughts in the direction of new outlets. No such desire has ever been evinced by the Indian community in South Africa, nor is it reasonable to expect such a desire to rise in a country that is sparsely populated, has vast tracts of undeveloped land and offers within its brundaries ample opportunity for its whole population. We feel strongly that the solution of the Indian problem; such as it is, lies close to the hand of the Europeans in South Africa. We have already shown that the Indian community must now be regarded as a permanent section of the population, and to fulfil the ideal of the Union of South Africa we are that the breaking down of the Provincial barriers, with permission to our community to disperse itself over the whole Union, will not only afford a valuable example of the true union of the Provinces, but will also dispel once and for all on account of our small numbers the bogsy of Indian invasion and Asiatio menace."

I think it is up to the Natal President to immediately get in touch with Dr. Godfrey and other leaders there who might be helpful in organising the scattered forces into one homogenous body. It seems, from the information received, that the Congress there is losing ground and is not functioning properly. If this is so, it would be a sad day for the Transvaul Indians to be drifting rudderless in the mid-ocean with doubte and difficulties and with no pilot to guide them to the shores. Their right to live in this land and with thousands at stake make it imperative to consolidate their strength in opposing any influence which might be brought about for their downfall. I hope the Natal and Transvaal leaders would meet together and chalk out their programme for action when the time arrives. Spentforces will be of no help. "

Relief Works

The other day the Town Council decided to reduce the pay of the relief workers to 2/6, from 8/per day. The chief argument brought forward for this reduction was that they do not wish to make the relief work more attractive than the ordinary work for which they paid about 2/8. I do not wish to go into detail over this as the case was well put by the Q. B. and S. I. Association, but what amused me a great deal was when I read the names of some of the Town Councillors whom the Congress had sent, voting for the reduction of the 6d. from the poor Indian relief workers' wages. I wonder what will they have to say to the Congress for this brave act, and what reply has the Congress to those voters who were asked to vote for Cupt. Rainnie and his company. How are the mighty fallen !

Xmas Tree In Barracks Breaking Up Functions

A Xmas tree was arranged in connection with the needlework classes run for women and girls in the Durban Corporation Barracks. The tree was gaily decorated with toys and gifts and hundreds from the Barracks flocked to the small hall to join the function.

Miss Clara Martin, a teacher, was the principal speaker and told the people how Mrs. A. Christopher, a member of the Technical Committee, had approached her to help in conducting the needlework classes for the benefit of the women and girls of the Barracks. She had readily agreed and had worked with Mrs. Christopher, Mrs. Jack Singh, Miss Lois Choonoo, Miss Samuels and Miss Juganathan.

There were over 85 women and girls who were attending these classes and had shown progress in their work. That it had been some return to her and her co-workers to notice the interest and pleasure they shewed in the classes. It was, she understood, but the beginning of other classes for women and girls by the Technical Committee who had in view their training for domestic service so that they not only may make good house-keepers but be a help to their families the breadwinner of which was in receipt of a bare subsistence wage.

The arrangements were in the hands of the wolunteer helpers who spared no pains to make this function—the first of its kind in the Barrackshappy occasion for those who see so little of it, will

And to her and all donors, as well as to Mr. Du Cass, the Compound Manager, the thanks of the Committee are due. , There was also in the evening a Social arranged by the teachers of the Continuation! Classes for adults and boys in the hall of the barracks. These classes are attended by over 110 students, all workers in the Corporation. Mr. V. Vinden is the teacher in charge of these classes and has with kim Mr. Mathews and other volunteer teachers. The Technical Committee is endeavouring, to provide education for these workers to help them to improve their lot.

Mr. Vinden spoke in happy terms of the teachers who are helping him and of the students who rush to the classes from the work no matter how late they knook off their work. The students had done their bit towards getting up the social function and refreshments were served to the music and songs of the students.

Mesera Christopher, S. L. Singh, P. R. Pather and P. G. Naicker were present. There was also another social function in the Carlisle Street School where the Technical Committee was also conducting continuation classes. These were the first classes started by volunteer workers in the cause of Indian adult education with Mr. S. M. Moodley and other volunteer teachers. The work has been developing. In addition to the classes at the Barracke, classes for men and boys in technical subjects are being conducted by the Committee in the evenings in the Sastri College premises with Mr Buss. There is also a class for girls dn needlework in the same premises in addition to cookery classes for them in the Albert sicrest School premieen. Arrangements are being made to help.
