Our New Venture

Owing to insistent demands we have once more introduced Tamil and Hindi columns in Indian Opinion which were abandaned in 1905. It was owing to lack of adquate support that these languages had to be discontinued. In later years, however, the demand for them seems to have grown as there were papers published in both these languages by individual enterprise. In response to the urgent call upon us we have launched on this new venture not without additional financial burden. The life and growth of it is entirely depandent upon the amount of support given by the Tamil and Hindi communities.

Morning Market Tea Room

An amusing story is attached to the Tea Room in . the new Indian Morning Market which was recently opened in Warwick Avenue. The tea mom, it is understood, was originally to be given to the Indian Farmers Association for their sole benefit at. a rental of £10 per month. The representatives of the Squatters Association put in their claim for a share of the profits which might accrue from the tea room; and that they were made partners in this. concern. The farmers, however, would not agree. The result of this quarrel led the Corporation .to recognise neither of the bodies and the tea room is now put up for tender from the public. It is now learnt that the differences between the two Associations above mentioned have been patched, and are anxious to get the tea room. The Associations have little reason to complain if they find the tea room gone from their hands. It is now left entirely in the hands of the Market Master to use his good influences with the Town Council and to persuade it to give preference to the Farmers and Squatters Associations. We hope he will do so.

Some Interesting Figures at 1 . . A with BROWN

ACCORDING to figures prepared and published in the Natal Mercury the total number of original Indian immigrants remaining in Natal at December 31 is 31.101. It is interesting to note that of these Indians only 4,938 are younger than 40., There are 2,489 men and 1,528 women between 41 and 45; 4,897, men and 2,142 women between 46 and 50; 3,831 and 1,764 women between 51 and 55; 2,985 men and 1,616 women between 56 and 60; and 3.120 men and 1,794 women between 61 and 90. It is obvious. therefore, that the remaining indentured Indians will grow rapidly less in number through death alone. Over 13,000 have returned to India under the repatriation and assisted emigration schemes; and it is believed that when the last of the indenti tured Indians have died, or returned to India the stream of returning Indians, will practically cease. It was estimated in 1931 that there were 163,400 Indians in Natal, so that it will be seen that about 80 per cent. of them are South African-born. There' are 6.531 Indians in the Cape, 15,500 in the Transvaal and only 100 in the Free State. 10

BISHOP FISHER'S APPEAL

HE Bishop of Natal's appeal to Christian Churches published in our last week's issue and his appeal to the public this week is a distinct contrast to the general cry of the Europeans in Natal against the so-called Asiatic menace and the methods suggested to deal with it. "That the mentality which sees a menace in the progress and prosperity of the other races," the Bishop says, "will react most injuriously upon South African culture. . . That we stand to day before a momentous Choice—the choice between a future civilisation based upon moral principle and one resting upon oppression cloaked in the language of hypocricy." Bishop's appeal will no doubt go home to all true Christians but it will have no effect on the politicians of the type of Mr. Tielman Roos. The Bishop did not believe that differences of tradition and outlook, such as were always found when race met race, were inevitably a hinderance to harmonious working. Spirit of fairplay, equal standard of living, increased facilities for education for both boys and girls, said the Bishop, would provide the best conditions for that harmonious co-operation' between Indians and Europeans which was in the best interests both of the individual and of the country as a whole. The Indian community has been asking for nothing more. 4 When competition is fair " the Bishop very rightly says, " the result should be to raise the standard of efficiency and thus to promote progress to the benefit of the whole community. We in this country fully realise that we should adopt the western standard of living. We have welcomed measures that have been introduced from time to time which had for their object the establishing of that standard. But almost all such measures have been worked on racial lines. For instance the Wage and the Industrial Acts apply to all alike but Indians are not given equal opportunities under those Acts. While these Acts outwardly appear to be quite innocent they are designed with the object of squeezing out Indians. One sees this spirit in almost every Act. The whole object of the licensing laws, it would appear, is to keep the Indian out of trade. The patience of the Indian in this country is exercised beyond limit. The irony of it is that Indians who are British subjects are branded as foreigners and their condition is worse than the real; foreigners, British Empire nor even the South African nationality has any meaning for the Indian. The principles laid down by the Bishop of Natal are: gems and if they were to be sincerely followed there would certainly be no cause for any complaint either on the part of Europeans or Indians. We know how difficult it is for any member of the ruling race in this country to give expression to his thoughts frankly. But if all those who feel as the Bishop of Natal does were to express themselves fearlessly they would be doing the best service to the Christian faith.

To Europeans And Indians

SPIRIT OF FAIRPLAY, EQUAL STANDARD OF LIVING INCREASED FACILITIES FOR EDUCATION ADVOCATED

A speed for the spirit of fairplay, a more equal standard of living and increased facilities for sound education as a means of achieving co-operation between Europeans and Indians, and, thereby promoting the progress of the whole community, was made by the Bishop of Natal, Dr. Noel Fisher, in an address at a public conference on Race Relations in South Africa, held in Maritaburg.

It was sometimes assumed, said Dr. Fisher, that differences of tradition and outlook, such as were always found when race met race, were inevitably a hindrance to harmonious working. He did not believe that to be the case. It was true that when people were ignorant about each other and were afraid of the future there was the kind of atmosphere in which dissension and strife were easily born. It was not variety, but mutual ignorance and suspicion which was the real obstacle to right relations. So far from differences being a hindrance they might greatly enrich the life of a country, though only in so far as each race sought to represent its nationality at its best. European and Indian alike had much to contribute to the common good,

These were days of keen competition, and when those who competed were of different race, a fresh cause of bitterness was introduced. As it was impossible to eliminate competition, it was necessary to free it of its worst features.

"May I insist," said Dr. Fisher, "that oc-operation is more fundamental than competition? When competition is fair, the result should be to raise the standard of efficiency and thus to promote progress to the benefit of the whole community. But it is essential that competition should be on fair and equal conditions. On the one hand, no one should be handicapped by artificial restrictions. But again no one should gain an unfair advantage owing to an uncivilised standard of living, enabling him to undersell his neighbours; nor by helng able to pay We must lower wages to those whom he employs. press for fairplay, and for equitable conditions of employment that competition may be on a fair basis. as between the two races.

With a view to an improved standard of living and a larger measure of understanding and mutual appreciation, the benefits of sound education must be placed within the reach of all. That did not mean that all would be educated to the same level, but that each should receive the kind and degree of eincation which corresponds to his capacity and requirements. He believed that it was as important to educate the girls as the boys, for they were the future mothers, and on them depended the character of the homes.

If one could bring about those three things—the spirit of fairplay, a more equal standard of living and increased facilities for sound education—much would be done to provide the best conditions for that harmonious co-operation between Indians and Euro-

peans which was in the best interests both of the individual and of the country as a whole.

There were many difficult problems, political, economic and social, which had to be solved. Europeans were demanding, as they had a right to do, the safeguarding of their Western civilisation and standards of life which they regarded as essential. Indians, on the other hand, were demanding as they had a right to do, a recognised position in the life of the

country and opportunities for progress. It was inevitable that politics should enter largely into the question and that efforts should be made from time to time to alter and adjust the laws of the land. He urged the exhibition of patience for which the East was famous and to trust the wisest leaders. Hasty and uncontrolled speech by European or Indian usually set back the hands of the clock.—Natal Mercury.

PROMISES THAT WERE NOT KEPT

INDIAN REPATRIATES FROM SOUTH AFRICA, From

Mr. P. Bharat Singh's Activities

Bangalore, Jan. 9.

AHATMA GANDHI was to-day interviewed by Mr. P. Bharat Singh, representative of the Colonial Born and Settlers' Indian Associaciation of Natal, on the question of repatriation and assisted emigration of South African Indians.

Interviewed by the Indian Express (Madras) about the present state of Indians who have come from South Africa to this country under the above schemes Mr. Singh stated as follows:—

"I have been deputed by the Colonial Born and Settlers' Indian Association of Natal to investigate the conditions of the Indians repatriated from South Africa under the repatriation and assisted emigration schemes. At Calcutta I visited Arra, a suburb of the second largest city in the British Empire. where about 400 returned emigrants from various colonies are living in miserable circumstances. I saw about 20 repatriates from South Africa. I understood there were many more but as my visit was totally unexpected, a large number had gone out of the camp. What I have seen at Arra cannot bear description. Men, women and children are living in a disgraceful condition. They are illfed, ill-clothed, and many of them are fever-stricken as Arra is a noted malaria centre. The tragedy of the whole thing is that Government who are a party to the repatriation of Indians from South Africa, have not carried out their promises of looking after these unfortunate people.

At Madras I learnt that Mahatmaji, whom I was most anxious to meet, was at Bangalore, and I took the opportunity of going there. I have still to carry out my investigations in Madras. The Colonial Born and Settlers' Indian Association, whom I represent and who have deputed me to carry out these investigations is entirely opposed to repatriation, assisted emigration and colonisation, In connection with the latter, the Government of South Africa have appointed a Committee to explore the possbilities of finding another country to settle the Indians at present in South Africa. My Association has declared in unequivocal terms our opposition to the above scheme. Protest meetings have been held throughout Natal, and a large majority of Indians are behind our attitude of non-co-operation with the Government on this Commission.

My countrymen would perhaps be surprised to learn that since the repatriation and assisted emigration schemes were put into force, about 30,000 Indians have left South Africa, and from my in-

vestigations so far, a huge majority of them are leading very miserable lives in this country.

At Calcutta had it not been for the noble work of Mesers. H. K. Mukerjee and Pandit Benarsidas Chaturvedi, the plight of the returned emigrants would have been more pitiful. Through the former's instrumentality, Mesers. Birla Brothers of Calcutta have been supplying food, clothing and medicine for about 400 emigrants for the last four months."

Letter To The President of the Mr. Bharat Singh writes to the President of the Colonial Born and Settlers' Indian Association from Karachi, Jated Jan. 22, 1934:—

My cable re the condition of repatriates from South Africa could not have caused, much, surprise for we have known for years past, that their condition in India was far from satisfactory, Nobody in South Africa, however, has a true knowledge of the appalling state of affairs here. During the course of my investigations at Calcutta and Madras L have seen sights which I shall never forget. It is no exaggeration when I say that thousands of our people from South Africa are unemployed in India, while hundreds are really starving, diseased and homeless. They are in tatters and bear no resemblance to the once sturdy Indians of "Natal." have wished, oh how I have wished, that those who have been responsible for this precarious scheme could have been with me during my investigations. Children run about naked, young Colonial-born youths of between 16 and 22 years of age are in a pitiable condition. They came to me in large numbers in Madras and pleaded I can still hear their pleadings—that something should be done to enable them to return to South Africa. They were compelled to come to India with their parents and since then have never been able to secure jobs of any kind. India's economic condition to-day cannot bear description and it is a tragedy that more repatriates are coming from South Africa. I implore you to do all you can to stop this. Extensive propaganda is necessary—and not another Indian should be allowed to return to India under this abominable scheme. We owe a duty to our people there and we must apprise them of the conditions existing in India. I have obtained statements from various repatriates at Calcutta and Madras and have also taken some snaps. On the journey back to South Africa I hope to prepare a detailed report which I shall present to our Association. I am leaving India by the Kenya

sailing from Bombay on the 21st February and hope to reach Durban on the 14th March.

Let me wree again that the position of repatriates here is very serious and distressing. From what I can make of it. We cannot do anything except to agitate for Government assistance to our people here. But whether our voices would be heard by those in power is a matter for conjecture. I certainly do think they will assist. What we must aim at is to prevent further repatriation at all costs.'

The Rt. Hon. Lord Charles Percy de Villiers eldest son of the first Chief Justice of the Union of South Africa, Lord de Villiers died suddenly at Stellenbosch on Saturday night Feb. 10. Lord De Villiers who was in his 63rd year entertained Prince George to tea on Thursday afternoon and seemed in his ordinary health even on Saturday. The Hone Arthur de Villiers heir of Lord De Villiers, was overcome with grief when informed by Reuter of his father's death. Kupido-Kid Return Fight

Kupido Goes Full Distance

OVER 4,000 boxing enthusiasts drawn from all races as well as both sexes, congregated on Saturday night, February 10, to witness the big and much-talked-of return fight between Mottee Kid Singh of British Guiana, U.S.A. and England, and Arthur Cupido, the Coloured Western Province Champion.

A pleasing spectacle, too, was the number of Indian women who, decked in colourful sares, came to see the fight—so keen and universal was the interest taken in this classic contest. The Natal Boxing Board of Control was also fully represented and chose the judges and referees for the various fights.

Mottee Kid Singh vs. Arthur Cupido

The star bout of the evening came on just before the interval. By this time the Town Hall was packed to capacity; all available standing room was also fully occupied. Arthur Cupido (9st. 5lbs.) and Kid Singh (9st. 2lbs.) were given a thunderous ovation as they glamorously stepped into the ring. Mr. Jock Stephens was in charge of the fight.

The fight opened evenly; Kid being more energetic took the initiative and tried to force matters but Cupido's ringeraft as well as side and crouched stance prevented Kid from getting too close to his opponent. Towards the end of this round Kid landed a well-timed right.

The second round was a round of classic fighting. Kid twice nearly got his piston-like punches working but Cupido, realising the weakening effect of these soon extricated himself from danger.

In the 3rd round Cupido was showing signs of tiring and quite frequently leaned on Kid and even took the initiative at times to prevent Kid from attacking. In the 4th round Kid did very little fighting; it was apparent that he was out to tire his opponent.
