# A: (CONTAGIOUS DISEASES)

AETURN to an Address of the Honourable The House of Commons. dated 24 June 1908;—for,

RETURN "in respect of each cantonment or other place where soldiers are stationed in India, showing,—

- (1) Whether there is a hospital to which women suffering from venereal disease are admitted, and whether such hospital has been maintained continuously during recent years;
- (2) In the event of there being no hospital, whether women suspected of or found to be suffering from venereal disease are, or have been during recent years, turned out of the cantonment;
- (3) Whether, at any time during recent years, women have been periodically examined by the Army medical officers, or by Native hospital assistants, or by any other persons, acting under official sanction; if not, in what way is it ascertained that they are suffering from venereal disease;
- (4) Whether such examinations are, or have been, in effect made compulsory by the threat of expulsion from the cantonment if the women do not voluntarily attend for the purpose when required to do so;
- (5) How many women have been turned out of the cantonment under the powers of expulsion possessed by the cantonment authorities; and how many of such expulsions have been in connection with venereal disease, and how many for other diseases;
- (6) Whether any kind of passes or tickets are, or have been, granted to women (a) permitting them to reside in the cantonment, or (b) recording their attendance at medical examinations."

# EAST INDIA (CONTAGIOUS DISEASES).

The following are the articles of the Cantonment Code referred to in the accompanying Return:—

Power to remove Brothels and Prostitutes.

- 174.—(1.) The cantonment authority may, by notice in writing, prohibit—
  - (a) the keeping of a brothel; or
  - (b) the residence of a public prostitute in the cantonment or in any specified part thereof.
- (2) Whoever fails to comply with a notice issued under subsection (1) shall be punishable with imprisonment for a term which may extend to eight days or with fine which may extend to fifty rupees, and in the case of a continuing failure, with an additional fine not exceeding five rupees for every day after the first in regard to which he is convicted of having persisted in the failure.

Exclusion of public Prostitutes from Regimental Bazaars.

175. No public prostitute shall be permitted to reside within the limits of any regimental bazaar situate in the cantonment.

Power to call upon Person suffering from Infectious or Contagious Disorder to attend at, and remain in, Hospital or Dispensary.

203. If the medical officer in charge of a hospital or dispensary maintained or aided under section 196 has primâ facie grounds for believing that any person living in the cantonment is suffering from an infectious or contagious disorder, he may, by notice in writing in the form set forth in Schedule II., or in any similar form, call upon such person to attend at the hospital or dispensary at a time to be specified in the notice, and not to quit it without the permission of the medical officer in charge, unless and until such medical officer is satisfied, by examination (if necessary), that such person is not in fact suffering, or is no longer suffering, from such disorder.

Provided that, if, having regard to the nature of the disorder, or the condition of the person suffering therefrom, or the general environment and circumstances of such person, the medical officer considers the attendance of such person at the hospital or dispensary inexpedient, he may dispense with such attendance and take such measures or give such directions as he may think fit and proper.

Explanation.—In this section, the expression "infectious or contagious disorder" includes venereal disease.

Power to exclude from Cantonment Persons refusing to attend at, or remain in, Hospital or Dispensary.

204.—(1) If the medical officer in charge of a hospital or dispensary maintained or aided under section 196 reports in writing to the commanding officer of the cantonment that any person, having received a notice as provided by section 203, has refused or omitted to attend at the hospital or dispensary, or that such person having attended at the hospital or dispensary, has quitted it without the permission of such medical officer, the commanding officer of the cantonment may, if he thinks fit, by order in writing, direct such person to remove from the cantonment within twenty-four hours, and prohibit him from remaining longer in, or re-entering it without his permission in writing.

(2) Whoever, having been prohibited under subsection (1) from remaining in or re-entering the cantonment, fails to remove from or re-enters it without the permission in writing of the commanding officer of the cantonment, shall be punishable with imprisonment for a term which may extend to eight days or with fine which may extend to fifty rupees, and, in the case of a continuing failure, with an additional fine not exceeding five rupees for every day after the first in regard to which he is

convicted of having persisted in the failure.

Removal and Exclusion from Cantonment of Disorderly Persons, &c.

- 210.—(1) The cantonment magistrate may, on receiving information that any person, whether resident in or frequenting the cantonment,—
  - (a) Is a disorderly person, keeping or frequenting a common gaming-house, a disorderly drinking-shop, or a disorderly house of any other description, or
  - (b) Has been convicted more than once, either within the cantonment or elsewhere, of an offence punishable under Chapter XVII. of the Indian Penal Code (XLV. of 1860), or
  - (c) Has been convicted, either within the cantonment or elsewhere, of any offence punishable under section 156 of the Army Act (44 & 45 Vict. c. 58), or
  - (d) Has been ordered, under Chapter VIII. of the Code of Criminal Procedure, 1898 (V. of 1898), either within the cantonment or elsewhere, to execute a bond for his good behaviour,

may make an order in writing, setting forth the substance of the information received, and issue a summons requiring the person to show cause why he should not be required to remove from the cantonment and be prohibited from re-entering it.

(2) Every summons issued under subsection (1) shall be accompanied by a copy of such order as aforesaid, and the copy shall be delivered by the officer serving the

summons to the person served by the same.

(3) The cantonment magistrate shall, when the person so summoned appears before him, proceed to inquire into the truth of the information received, and take such further evidence as he thinks fit; and, if upon such inquiry it appears to him to be necessary for the maintenance of good order that the person should be required to remove from the cantonment, and be prohibited from re-entering it, the cantonment magistrate shall report the matter to the commanding officer of the cantonment, and, if the commanding officer of the cantonment so directs, shall issue a notice in writing requiring the person to remove from the cantonment within a time to be specified in the notice and prohibiting him from re-entering it without the permission in writing of the commanding officer of the cantonment.

# General Power of Removal and Exclusion from Cantonment.

211.—(1) The commanding officer of the cantonment, if he thinks it expedient to exclude any person from the cantonment, whether with or without assigning any reason therefor, shall send to the cantonment magistrate an order in writing to that effect, and the cantonment magistrate shall cause a copy of the order to be served on the person, together with a notice in writing requiring him to remove from the cantonment within a time to be specified in the notice and prohibiting him from re-entering it without the permission in writing of the commanding officer of the cantonment.

Provided that no such order as aforesaid shall be made—

- (a) Where the only reason for making it is that the person—
  - (i) Is disorderly, or
  - (ii) Has been convicted of an offence punishable under Chapter XVII. of the Indian Penal Code (XLV. of 1860), or section 156 of the Army Λct (44 & 45 Vict. c. 58), or
  - (iii) Has been ordered under Chapter VIII. of the Code of Criminal Procedure, 1898 (V. of 1898), to execute a bond for his good behaviour; or
- (b) Unless the commanding officer of the cantonment thinks that the presence of the person in the cantonment is dangerous to good order or military discipline.
- (2) A copy of every order made under subsection (1) shall forthwith be sent by the commanding officer of the cantonment to the General Officer of the Command.

And for the better effecting the purposes of this Our Commission, We do by these Presents give and grant unto you, or any three or more of you, full power to call before you such persons as you shall judge likely to afford you any information upon the subject of this Our Commission; to call for information in writing; and also to call for, have access to and examine all such books, documents, registers and records as may afford you the fullest information on the subject, and to inquire of and concerning the premises by all other lawful ways and means whatsoever:

And We do by these Presents authorise and empower you, or any of you, to visit and personally inspect such places as you may deem it expedient so to inspect for the more effectual carrying out of the purposes aforesaid:

And We do by these Presents will and ordain that this Our Commission shall continue in full force and virtue, and that you, Our said Commissioners, or any three or more of you, may from time to time proceed in the execution thereof, and of every matter and thing therein contained, although the same be not continued from time to time by adjournment:

And We do further ordain that you, or any three or more of you, have liberty to report your proceedings under this Our Commission from time to time, if you shall judge it expedient so to do:

And Our further will and pleasure is that you do, with as little delay as possible, report to Us under your hands and seals, or under the hands and seals of any three or more of you, your opinion upon the matter herein submitted for your consideration.

Given at Our Court at St. James's, the first day of November, one thousand nine hundred and thirteen, in the fourth year of Our Reign.

# STOPPAGE FROM PAY WHEN SUFFERING FROM VENEREAL DISEASE.

When sent to hospital at home for treatment for Venereal Disease, the man becomes subject to hospital stoppages from pay after spending 30 days in hospital.

This is not, technically speaking, a punishment, but is a provision of the Regulations applicable to men who have to be sent to hospital for any disability for which they are responsible. The rate of stoppage is laid down in the King's Regulations, Article 1425, viz., 10d. a day when pay is not less than 1s 7d. a day, and 8d. a day if less than 1s. 7d., except in the case of Boys, who are only mulct to the extent of 4d. a day. A.B.'s and Stokers, for example, would therefore be subject to the highest rate of stoppage.

The infliction of this stoppage does not affect the payment of Separation Allowance to wives and families.

#### APPENDIX D.

NOTE ON THE LAW RELATING TO COMMITTALS TO INDUSTRIAL SCHOOLS, REFORMATORY SCHOOLS AND BORSTAL INSTITUTIONS.

#### INDUSTRIAL SCHOOLS.

. Children under the age of 14 can be sent to Industrial Schools and ordered to be detained until the age of 16. The Managers of the School can release the child on licence before the expiration of the period of detention, and this power is freely exercised. Children committed to Industrial Schools (except children committed for mere truancy) remain under the supervision of the Managers of the School till the age of 18, and while under such supervision can be recalled to the School for a period not exceeding three months, if recall is necessary for the protection of the child

Children can be committed to Industrial Schools either (a) because they are living in surroundings likely to encourage criminal habits (for example, "found begging or found wandering and having a parent or guardian who does not exercise proper guardianship," or "in the care of a parent or guardian who, by re-son of criminal or drunken habits, is unfit to have the care of the child," &c., &c.), or (b) because the child has himself committed an offence punishable in the case of an adult by penal servitude or a less punishment.

REFORMATORY SCHOOLS.

Youthful offenders between the age of 12 and 16 can be sent to Reformatory Schools. The period of detention specified in the order must be not less than three and not more than five years, and must not in any case extend beyond the time when the youthful offender attains the age of 19. The Managers of Reformatories have power to release inmates on licence before the expiration of their sentence, and most inmates are licensed about the age of 18 unless there are special circumstances making continued detention desirable.

Youthful offenders can only be sent to Reformatory Schools on conviction of an offence punishable in the case of an adult by penal servitude or imprisonment.

#### BORSTAL INSTITUTIONS.

Offenders between the age of 16 and 21 can be sent to Borsta! Institutions for a period of not less than two and not more than three years. On the expiration of sentence the young person remains under the supervision of the Prison Commission for one year. While under supervision he may be recalled to the Institution if the Prison Commissioners are of opinion that recall is necessary for his protection, and any person so recalled may be detained for a period of not more than a year, notwithstanding that the period of supervision has expired.

An offender can be sent to Borstal in three ways:-

- (1) If he is convicted on indictment of an offence for which he is liable to be sentenced to penal servitude or imprisonment.
- (2) If he is summarily convicted of an offence for which the Court has power to impose a sentence of imprisonment for one month or upwards without the option of a fine, and if it is proved that the offender has been previously convicted of an offence or has failed to observe the conditions of a probation order. In such a case the Court of Summary Jurisdiction can remit the case to Quarter Sessions with a view to sentence of detention in a Borstal Institution being passed.

Under either procedure a sentence of detention in a Borstal Institution can only be passed if, "by reason of the offender's criminal habits or tendencies or association with persons of bad character," it is expedient that he should be subject to a period of instruction and discipline.

(3) Youthful offenders convicted of escaping from a Reformatory School or of committing a breach of the rules of the school may be sent to a Borstal Institution by a Court of Summary Jurisdiction, and such a sentence supersedes the sentence of detention in the Reformatory School.

# RESTRICTION OF UNQUALIFIED PRACTICE.

The following are the disabilities and penalties imposed upon unqualified practice in some of the principal Dominions and British Possessions whose Medical Acts have come to the knowledge of the Medical Council, mainly through the good offices of the Colonial Office. The quotations are from the Acts as they appear upon the Council's Minutes, unless otherwise stated:

#### DOMINION OF CANADA.

#### ALBERTA.

' AN ACT TO AMEND THE MEDICAL PROFESSION ACT." (Assented to December 20, 1911.)

- "3. The said Act is further amended by adding thereto as Section 63A the following:-
- "'63A. Any person shall be held to practise within the meaning of Section 66 of this Act who shall (a) by advertisement, sign, or statement of any kind, allege ability or willingness to diagnose or treat any human diseases, ills, deformities, defects, or injuries; (b) or who shall advertise or claim ability or willingness to prescribe or administer any drug, medicine, treatment, or perform any operation, manipulation, or apply any apparatus or appliance for the cure or treatment of any human disease, defect, deformity, or injury; (c) act as the agent, assistant, or associate of any person, firm or corporation in the practice of medicine as hereinbefore set out, provided always that this section shall not apply to the practice of dentistry or pharmacy, or to the usual business of opticians or vendors of dental or surgical instruments, apparatus and appliances.
- "'(2.) Nothing in this Act shall prevent private persons from giving necessary medical or surgical aid in times of urgent need, providing that such aid be given without hire, gain or hope of reward.'
  - "4. Section 56 of the said Act is repealed, and the following substituted therefor:
- "4. Section 56 of the said Act is repealed, and the following substituted therefor:—

  "66. If any person, not registered pursuant to this Act, either directly or indirectly practise or profess to practise medicine, surgery, midwifery, osteopathy or homeopathy, or if any person registered in respect to one class of practice shall practise in respect to another class, he shall, upon summary conviction thereof before a Justice of Peace, forfeit and pay for the first offence a penalty not exceeding fifty dollars, for the second offence a penalty of not less than fifty nor more than two hundred dollars, and for a third or any subsequent offence to a penalty of not less than two hundred nor more than three hundred dollars. hundred dollars
- "'Provided that the provisions of this section, as far as they refer to the practice of midwifery, shall apply only to the territory included within the limits of any incorporated city, town or village having a resident registered practitioner therein."

#### BRITISH COLUMBIA.

#### "MEDICAL ACT, 1898."

"55. Unregistered Persons not to Practise.—It shall not be lawful for any person not registered to practise medicine, surgery or midwifery for hire, gain or hope of reward.

"63. Penalty for Unregistered Person for Practising.—If any person not registered pursuant to the Act,

for hire, gain, or hope of reward, practise or profess to practise medicine, surgery or midwifery, or advertise to give advice in medicine, surgery or midwifery, he shall, upon a summary conviction thereof before any Justice of the Peace, for any and every such offence pay a penalty not exceeding one hundred dollars.

# "MEDICAL ACT, 1898. AMENDMENT ACT, 1905."

"2. Section 63 of Chapter 9 of the Statutes of 1898, being the 'Medical Act, 1898,' is hereby amended by adding thereto the following sub-section:

"'Penalty for Unregistered Person Practising for or in the stead of a Registered Practitioner.—

(2) If any person not registered under this Act contracts with any person registered under this Act to practise medicine or surgery for him or in his stead, both parties to such contract shall be liable, upon summary conviction before any Justice of the Peace, to a penalty not exceeding one hundred dollars and not less than twenty-five dollars."

#### MANITOBA.

## "MEDICAL ACT" (Not in Minutes).

"Section 62: Prohibited from Practising.—It shall not be lawful for any person not registered under this Act, for hire, gain, or hope of reward, to practise medicine, surgery, osteopathy, or to treat or profess to treat another, or to prescribe or recommend any drug, medicine, appliance, application, operation or treatment for any injury to, or any physical or mental ailment of, or any disease, infirmity or deformity of another, but this section shall not apply to the sale of glasses for the correcting of visual errors

"In every prosecution under this section proof of registration shall be upon the person prosecuted."

# "THE MEDICAL PROFESSION ACT."

"Section 64.—No person unregistered or under suspension under this Act shall practise medicine, surgery or midwifery for hire, gain, or hope of reward, and if any person not registered or unrece suspension as aforesaid pursuant to this Act for hire, gain, or hope of reward practises or professes to practise or advertise to give advice in medicine, surgery or midwifery, or who shall furnish medicine or treat any disease or ailment by medicine, drugs or any form of treatment, influence or appliance for hire, gain or hope of reward shall be guilty of an offence, and upon summary conviction thereof be liable to a penalty not exceeding one hundred dollars.'

# NEW SOUTH WALES.

There is no prohibition of unqualified practise. "The Medical Practitioners Act, 1912," Section 11, imposes a penalty on unqualified persons assuming professional titles, and Section 12 provides under penalty that any person advertising that he treats disease must state his full Christian name and surname in every advertisement and upon any house referred to in the advertisement.

Advertise or hold himself out, directly or indirectly, by any name, word, letter, title, or designation, whether expressed in words or by letters, or partly in one and partly in the other (either alone or in conjunction with any other word or words, or by any other means whatsoever), as being entitled or qualified, able or willing to practise medicine or surgery in any one, more or all its branches, or to give or perform any medical or surgical service, attendance, operation or advice.

"And every person who, for himself or as assistant, servant, agent or manager, does or permits any act, matter or thing contrary to this section or any part thereof, shall be liable for each and every such offence upon conviction, to a penalty not exceeding fifty pounds nor less than two pounds and all costs of suit.

"Nothing in sub-section (1) contained shall prejudice or affect the lawful business or occupation of a

chemist and druggist, or of a pharmaceutical chemist, and nothing in this section contained shall prejudice or affect the lawful business or occupation of a dentist registered under 'The Dentists Act, 1894.'

"24. Every person who shall exhibit or publish, or cause, permit, or suffer to be exhibited or published any letter, circular, placard, handbill, card, or advertisement of any kind whereby any person advertises or holds himself out contrary to any part of section twenty-three, or attempts so to do, shall be liable for each and every such offence, upon conviction, to a penalty not exceeding ten pounds.

"Provided that this section shall not apply to any newspaper proprietor or printer publishing such advertisement before written notice from the Registrar that such advertisement is contrary to some part of

the said section.'

#### NEW ZEALAND.

#### "THE MEDICAL PRACTITIONERS ACT, 1914."

"23. Penalty for wrongfully using name or title of medical practitioner.—Every person commits an offence and is hable to a fine of five pounds for each day during which the offence continues who, not being registered under this Act, practises medicine or surgery, or any branch of medicine or surgery, under the style or title of a physician, surgeon, doctor, licentiate in medicine or surgery, bachelor of medicine, or medical practitioner, or under any name, title, addition, or description implying that he holds any diploma or degree in medicine or surgery, or in any branch of medicine or surgery, or is otherwise specially qualified to practise medicine or surgery, or any branch of medicine or surgery

#### "THE QUACKERY PREVENTION ACT, 1908."

"2. Every person commits an offence who publishes or causes to be published any statement which is intended by the defendant or any other person to promote the sale of any article as a medicine, preparation,

or appliance for the prevention, alleviation, or cure of any human ailment or physical defect, and which is false in any material particular relating to the ingredients, composition, structure, nature, or operation of that article, or to the effects which have followed or may follow the use thereof.

"3. A statement shall be deemed to be published within the meaning of this Act if it is inserted in any newspaper printed and published in New Zealand, or is publicly exhibited in view of persons in any road, street, or other public place, or is contained in any document which is gratuitously sent to any person through the Post Office or otherwise, or which is gratuitously delivered to any person or left upon premises in the occupation of any person.

the occupation of any person.

"4. Every person who commits an offence against this Act is liable, on summary conviction before a magistrate, to a fine not exceeding one hundred pounds in the case of a first conviction for any such offence, and not exceeding two hundred pounds in the case of a second or any subsequent conviction.

"5. If any person causes any statement to be inserted, in breach of this Act, in a newspaper printed and published in New Zealand, the printer, publisher and proprietor of that newspaper shall severally (and without excluding the liability of any other person) be deemed to have published that statement in breach of this Act, and shall be liable for an offence against this Act accordingly."

## UNION OF SOUTH AFRICA.

In respect of every conviction after the second the punishment shall be a fine not less than fifty pounds nor more than one hundred pounds, or, in default of payment, imprisonment with or without hard labour for a period not exceeding six months, or such imprisonment without the option of a fine, or both such fine and such imprisonment"

Notes.—The law specifically refers to "girls" in Hungary, Netherlands, Spain and Sweden. other countries it refers to children or young persons of either sex.

Netherlands —The law of 1911 (clause 248) punishes with two years' imprisonment anyone who is to sexual intercourse with him by gifts or promises, by abuse of authority, by violence, threseduction, a minor of good conduct. This apparently refers to both sexes, and to any age under t legal majority, viz, 23 years.

Spain.—The seduction or abduction of a virgin under 18 is severely punished with two to years' imprisonment.

# LEGISLATIVE DEPARTMENT.

Paper No. I, Opinions from Local Govern sections 362 and 366 of the Indian Penal Code was referred, have considered the Bill and the paper noted in the margin, and have now the honour to submit this our Keport, with the Bill as amended by us annexed thereto.

We consider that the Bill as referred to us requires alteration in two main respects. In the first place, we think that clause 2 goes beyond the purpose for which the Bill was introduced by amplifying the definition of abduction in such a manner as to make it applicable to every case of abduction and not only to those with which the Bill is concerned. More especially we observe that if abuse of authority in certain circumstances constitutes abduction, a guardian who matries his ward against her will might become punishable under section 360 pf. the Indian Penal Code. In the second place, the Bill, in providing that the age at which the consent of a girl is to become material for the purposes of the offence with which the Bill deals shall be 16, does not give effect to the Convention to the follest extent which is possible. We see no reason why effect should not be given to the Convention in regard to offences committed against girls imported from a foreign country. At the same time we are, with one dissentient, of opinion that the age in the case of offences in the commission of which no act has been committed outside Jadia should not exceed 16 years.

These conclusions involve a casasting of the Bil and we have accordingly recommended what is, in form though not in substance as new Bill, to the provisions of which we proceed to refer in greater detail

2. Clause 2 .- Section 366 of the Indian Penal Code already. panalises the procunition of a women where such procuration amounts to abduction. It thus covers the requirements of the second arnole of the International Convention, except in so far as the definition of abduction in section 362 of the Code does not include within its terms intimidation or abuse of authority. The paragraph which we propose to add to the section by clause 2 of the Bill recommended by us has the effect of including intimidation and abuse of authority within the definition of abduction in reason where that offence is perpetrated for the purpose of procuration.

Clause 3. - Section 366 of the Code also covers the case of the procuration of a girl, under 16 unless the has no guardian or the offence is committed by, or with the consent of, the 16 unless she has no guardian or the offence is commuted by proposed and proposed to provide for by the insertion of a new section 566A in the Code. This new section follows closely the wording of the addition which was proposed to code. to section 360 by clause 3 (1) of the Bill as introduced.

The case of girls importal from a foleign country we propose to deal with by the insertion of a new section 316B in the Cole. We are unsuimously of opinion that the requirements of the Convention will be substantially met by penalising the importation of girls from a foreign country. At the same time we have so worded the clause as to prevent its being made a dead-letter by the adoption of the course of importing the girl first into an Indian State,

So The Bill was published in the Gazette of India, dated the 30th September, 1922.

4. In view of the fact that practically the whole of the opinions received on the Bill related only to the question of the age of consent in the case of girls domiciled in India, we think that, although we have recast the Bill, its essential provisions have not been so aftered as to require the re-publication of the Bill, and we recommend that it be passed as now reducted by us.
