

PARAGRAPH 58 OF THE HONOURA[BLE] COMPANY'S LETTER BY CATHERINE.

FOUTHLY: TOUCHING THE TRADE OF INDIA IN GENERAL & [THERE]IN ANY TRANSACTIONS WITH THE [COUN]TRY GOVERNMENT.

Wee have in the two foregoing heads told you what wee are informed as to the peo[ple] and our pepper settlements supplying great quantity of Pepper to private persons ships and wee suffering by want of the Charty party Tonage for our Own, or our Ships waiting a great while for itt and all the while lying on Demorage, wee hope by the change wee think absolutely necessary to make this will be mended hereafter however that wee may have a better Account of these Settlements and the Trade of them wee have resolved that so soon as our affairs will permitt itt and you shall think itt for our Service, Mr. Strutt be sent down by you to inspect and Examine the account of Carrwar, Callicutt, Tellicherry and Anjengo and all matters relating thereto and to bring you back his report, do you Give him a proper Commission now that may Enable him to make his Examination Effectuall and to oblige all our Covenant Servants there to yeild him suitable respect and answer all his Enquirys, and for a better Guide therein do you draw up proper instructions for his [Mana] gement the Nature and particulars of them [you] will be best Judges because of your frequen[t corre]spondence which will afford proper [...] sufficient subjects to Enlarge upon but [.] things let him strictly Examine there accounts wherein he is a good Judge as the Bombay accots. Evidenced and see how they are kept up laying down proper regulations when he finds it necessary, let him take notice how the Ex[change] bears between the severall species of Gold or silver supplyed them and the sorts of money current at Each place and at what wee remember severall years ago Sr. Nicholas Waite Charged Mr. Harvey and Mr. Adams with Greatly abusing us in undervaluing the chequeens sent [him] and putting down less in the account then they [really] put them of for, give him great charge to make [dili]gent Enquiry at what price Each Species is paid away and which sorts are most or least for our [advantage] to send thither and to Examine well whither [the] accounts of weights, measu

any, the Dutch import Great quantity yearly and they are too wise to hold on a loosing Trade: let him inform himself what sorts or [quantity] of India or China Goods will vend at all or any of those Settlements and at what price from year to year, let[him] when at Anjengo be very inquisitive what quantity [of] all sorts of measured Goods may be procured there or in the Neighbouring Country both as to quantity and price of Each species and bring up samples with him but remember to take none that are less than yard W[ide] or rather 18 or 19 nails wide, if they are under 20 nails [10] yards are reckoned a peice of Callico at the Custom House if full twenty nails or more wide six yards is Esteemed a peice and if cut 8 or 9 nails wide yet 10 yd. is Esteemed a peice and because some part of the Customs are charged on Callicoes by the peice you will Easily discern why wee would have no narrow cloth let him Enquire when the cloth can be whitend, and what quantity Done in a Year, let him be very carefull to learn what Dutys, Customs, or presents are realy paid at Each place and how much of [every] sorts [of] Goods procurable or imported, what are the amount of all Charges Generall of all sorts a year and the totall of Each Item at Every Factory and how far by the best Observation he can Make he thinks they may be retrenched, let him Enter Down in a particular account of the state of our buildings at Each place in what Condition they are how many Warehouses and of what Dimensions what Conveniences for our Covenant Servants what quantity of Soldiers, Peons or other Servants at Each place and what they stand us in a [need] and whether there is need of so many or [whether] not, what Gunns Mounted and of what [...] If any of people at said settlements [...] amiss let us know of itt and do you write them wee shall look upon itt as an indignity offered ourselves but then give him a Caution that he Carries it civilly and respectfully wherever he Comes, and give them no just handle for quarelling, order him to put down from time to time in writing in the nature of a Journall an account of all his proceedings, Enquirys, observations and Directions at every place. If he has an Opportunity by any of our shipping during this Examination, let him send us a Coppy of that Journall, if not when he returns to Bombay and has made his report to you do you send us a Coppy with your observations upon all or what parts thereof you think necessary. Tell him if he acquits himself with fidelity, impartiality and ingenuity in this Negotiation as he will have the honour to be shall not want the reward due to his Trouble, therein, let him have such assistance under him from you as shall be thought Necessary.

at your perill. Keep your ship Clear and in a [good] posture of Defence that you may not be surprized by pyrates or other Enemys on the Coast, Wee wish you a prosperous Voyage and safe return to

COMMISSION & INSTRUCTIONS given by the Honourable William Aislabie Esq^r Generall &c^a. Councill of Bombay To the Worshipfull Stephen Strutt Esq^r. Deputy Governour of Bombay.

The Honourable Court of Directors having thought it necessary to order and appoint you by their Generall Letter to us by ships Catherine and Thistleworth dated the 27th. March 1714 as soon as their [affiairs] would permit to embark on one of their ships to Examine inspect and [review] their severall Settlements and [trade] and all matters relating thereto at Carwarr, Tellicherry, Callicutt and Anjengo and to make report of [your] Enquirys, Notices, observations and Exam[nations] as should occurr to you att all or any of [...] in a proper Diary or Journall which you must punctually minute and sett down for the true information of our Honourable Masters, wee have for that End and purpose and in Complyance with their orders resolved and agreed to send Down the ship Catherine with you and Mess. Charles Parkyns Benjamin Chaplin and Edward Tay for your better assistance and forwarding your Negotiations at the severall factorys down the Coast and as the acquitting your self with fidelity impartiality and ingenuity in this affair will be a further and more weighty recommendation of [your] abilitys to our masters at home so you need [...] of in due time an incouraging reward for all the pains and trouble you shall be att. The Honnour will not only be Entirely owing to your prudent Management but a future benefit both to our masters and yourself will assuredly arise thereby, the severall remarks and observations you are to make att their factorys are principally these that follow.

You are to Examine stricktly into their accounts and see that all your Entrys be duely and fairly kept laying down such regulations as you find Necessary and Directing them to be sett down in a Good intelligable manner and reprehending their Omissions and Commission of such matter as you find Culpable, Enquire also into the original of their Debts on their Books, what may be Esteemed Good, and what not, by whose means, or neglect is the Default of payment whither Connived at or Carelessly passed over by the Chiefs from time to time and what possibility there may be of recovering all or any part of such Debts, let this be thoroughly [search't] into and remarkt with your opinion thereon and to be sure put them in mind of sending up Coppys of their accounts for the last year and any other which wee have not received.

2^{dly}. You are to take notice how the Exchange bears between the severall species of Gold and Silver supplyed them and the sorts of money Curr^t. att Each place and to see that Chequeens or any other species of money received by them be not underated in their accounts but truly charged as paid away that the Company may not be abused as formerly they have been by their Chiefs, and make Diligent Enquiry at what rate each species is paid away and what are more or less advantagious, what may be the occasion of the rising or falling of any species and what further necessary for our future Government as to species.

[3^{dly}.] Examine well whither the accounts of weights, measures and Coins correspond with the advice they have formerly given us thereof, and wherein they differ and inform yourself of the true rate of weights &c². with the English.

[4thly.] Bee very Diligent to gett the best information you can of the quantity of Pepper procurable at Each Factory annually, and at what price, what may occasion its Dearness, whether it is monopolized by the Country people or Europeans or better Enquire also what other goods may be purchased prope[rly] [for] Europe Markets as to quantity and price and [what] Dutys or Customs are paid thereon, att Callicutt[...] mons used to be bought and those very [...] profitt [...] England but of late their badness and dear[ness] Discouraged the Company from writing for any if you can purchase a small quantity cheap and of a good sort wee leave it to you to provide so many as you think necessary for a tryall in England, The Dutch carry Home annually a great quantity who certainly find they get money by the Bargain.

[5^{thly}.] Inquire also what sorts & quantitys of India or China goods will vend at all or any of our Settlements and at what prices from year to year, when the most proper season for importing such goods whether there is any Dependance on the Market as to the quantity and price if such goods are brought in due Season.

[6thly.] Att Anjengo you are more particularly to Inquire what quantitys of all sorts of [measured] goods may be procured there or in the neighbouring Country both as to quantity and price of each Species and bring up with you samples of Each Species remembering to take none less than yard wide or neither 18 or 19 nails and 18 yards long. Inquire also where the cloth can be whitened and what quantity done in a year with the charge thereon, the pretence of fearing impediment from the Dutch in future investments and in whitening cloth is as strong Enough to Deterr the factory at Anjengo from such an undertaking and if the Queen and Poolas should be swayed by them then it is time to whiten itt at Bombay you must strenously press the whitening cloth there because the advantage is great and if well done will yeild 20 to 40 or 50 \Re cent more than it has already and because the Company are informed that Papseils, Nicanees, and Brawls and Guinea stuffs are to be made there and that they should save a great deal of money and loss of time, try whither the informance be true whither in part or in whole which if it once sett on foott an Experiment [with] proper directions of samples with the price of all or any of said goods to be sent up ? the first opportunity that the Company may know whether it's worthwhile making another Tryall thereto and inquire whether any quantity of land can be gott there in order to raise plantations of pepper and whether it is feasable and worthwhile Endeavour to know if the Chinting of Goods at Anjengo can be Effected or not or if due Encouragement were given whither the [painters] could not be prevailed with to settle there for [that purpose] what would be the charges thereof and what Benefitt would arise [thereby], lett us also know why the Cotton yarn cannot be whitened there, what would be the charge, or what is the occasion it can't be done, the country people pretences of not being used to do it is very frivolous and what a little time and Experience will [break] through as to the provision of Cowries from the [Maldivees] by way of Anjengo so earnestly and frequently recommended by the Company you are to acquaint the Chief and factors there that wee have designed the Ann for that voyage with a stock of about 4000 bales of Mangulore Rice and 6000 Rupees Specie which wee take to be sufficient to purchase 70 or 80 Tons of Cowries and that they may Ex[pect] her in a few days after your Arrival wth. them that they may be sure to Employ the messeng[ers] they last year sent or some capable per son [...] Munro be the Supra Cargo for whom let them [draw out] proper instructions and cautions for [his move]ment that he be not deluded by the treachery and artifices of those people, this is all wee can say in relation to that affair they must be better judges thereof att Anjengo so the greater care is incumbent on them the Honourable Company have ordered in their [investment] 8000 peices of Anjengo cloth viz., of 38 fanams 4000 of $27\frac{1}{2}$ Fanams 4000 but withall complain of their dearness from 20 to 30 Rupees # carge and would have none sent without

such [an abatement] as your stock is but small towards providing such a quantity yet in case of such an abatement and you have stock give orders for as many peices of such sort as [...] they can pay for.

7thly. Att Callicutt and Tellicherry you are more immediately to search and Examine into the causes and grounds of those open assaults, assassinations and indignities attempted, and carreid on against our Fort att Tellicherry, what should raise such jealouses & Fears in the Country people and Nayors as to give us Disturbance after so peacable a settlement amongst them, be very cautious to know whether these ill Designs are fomented encouraged and set on foot by the Dutch whether any Europeans as well natives as Indians are associates or seemingly run over to the Natives and by that means have inculculated [sic] base principles amgst. them of our Endeavour to Enslave them or such like and let us know what satisfaction can be Expected for their late affronts what force necessary to overa we and bring them to reason, and what methods proper to keep them in a due obedience, in case you suspect the Dutch concerned therein (as wee have great reason to believe they are) draw up a narrative of their proceedings as well as Can or give the [...] Chief &ca. Directions so to doe and gett all the information Testimonialls and Originall Letters from the Country princes and all other matters of Fact and Corroborating Circumstances you think Warrantable that such actions may be well and substantially proved flat upon them and to the purpose and not a bare assertion only inquire also the ways and means they have practised to Engross the pepper trade of the Mallabar Coast the artifices they have used to gett [them] and their Briberies towards the Samorines Minis[ters] gett as good knowledge as you can learn of their works fortifications there the quantity of pepper &ca. [they] proc-[ured] [...] other Notices you think worthy your observation att Callicutt adjust the affair of Captain Perrins with Mr. Adams taking care to see the same fairly [stand] and the balance thereof paid into the Companys [...] for the benefitt of the owners and that they may have justice done them, what papers and accounts rela[ting] thereto that have come to the Generalls hands for your [further] Direction will be delivered to you by him.

[8thly.] [Bee very carefull to learn] what Dutys or customs or [presents] are really paid at Each place and how many [of every] sort of goods procurable or [exported] what are the amount of Charges Generall of all sorts a year and the totall of [such] Item att every factory and how far by the best observation you can make they may be retrenched, be very partic[ular] also in Entering down the state of all Edifices, buildings and fortifications at Each place in what Condition [...] what [...] what number of Officers Soldiers, Peons or other servants at Each place and their monthly Charges and whether they stand in need of so many and wherein what Guns mounted and of what size and sorts, what ammunitions small arms and stores necessary at Each place for its Defence, of all which give us a plain account in your Journall with all other things that occurrs worthy your notice.

9^{thly}. For Carwarr wee have sent ten bales of Cloth for a tryall of such colours as they formerly wrote for. Inquire what quantity they can dis[pose] of in a year its prices or any other manufacture.

10^{thly}. Herewith you will receive the Generall Letter to the Viceroy of Goa which you are to deliver relating to the ship [Monsoon taken by a] Savage pirate and [re]taken by a portuguese frigatt [...] Carwarr [...] in the year 1706, you are to press him to have her restored to the English Owners or [satisfa]ction made for on the Sollicitation of the Supra Cargoe and [...] it was adjusted that she should be delivered to the owners on their paying some charges for [retaking], you will receive all the information sent out of [...] and authority to receive ye. [...] following the [...] by the Nightingall in [...].

[11thly] Bee very [curious] and [inquire what] quantity of Europe manufacture may be annually sold att all or any of our factorys with the prices and Coulours of Cloth and perpets, and all other manufacture.

[12thly.] For the more effectuall putting an end to the troubles at [Tellicherry] as well as prev[enting] [...] provision [...].

Cardamoms, the Honourable Company have wrote for 5 Tons to be sent them yearly, but none procured since the [Arrival] in 1708, because those bad yet the [Dutch] got those that are good and Cheap and would not [follow] such a trade, Unless beneficiall, therefore if good and [Cheaper] than Usuall to purchase some.

I gave him a Chequeen in a paper shaking of hands and desire the Countenance of his friendship and acquainted him the Honourable Company had sent me to look into yr. affairs, by which he might see how they intended a good [&] Merchantile Correspondence between them and their queen to which he answered (Mr. Cowse being our interpreter) that nothing should be Wanting on his part and waited on us to the Waterside very affable and pleasant and perswaded me to stay for a present of plantains &c². which when receiv^d. putt off and fired 13 Gunns to his health he being at the Waterside, at present there is no queen settled, there being a Heiress, but in febuary [sic] it is the anniversary time and they must settle the throne, the boat I went up in Mr. Courtney built breadth about 12 foott and length about 30 foott rowing with 16 Oars or paddles very fitt to goe up & down these Rivers and will Carry 18 or 20 passengers very Compleatly, and oblige the poolas or any principall persons when the Companys affairs require them aloft and theirs alow by Carrying either baggage-

They not having English Weights and not time to Compare wth. mine Ordered them to send all small weights &c2. of this place up to Bombay that we might compare them.

Therefore thought it most materiall to make the best of my way to the No ward and if they should answer the notes as should shall have full insight to regulate upon.

8TH. WEDNESDAY. Went ashore and perused Sundry of Captain Perrins accounts relating to ship Crown only, the other ships being sent to the other Coast before his death. The Ballance appearing 21922. 1. not signed and Mr. Prestwich's hand

writing, also Captain Perrins will to two Jungadoes Poyara Cana Croop and Carumbala Cundapa Croop his trustees and heirs in case of his Wife and Sons decease and Messrs. Adams and Prestwich were to assist them the latter wrote this will, Delivered them the pallankeen & furniture brought down for my own use they not having any one of the Companies.

Agreed with Noquedah Mahumud Cosson to take on freight to Suratt 80 Canisters of Java sugar thirty five Elephants teeth and four bales of Agala wood he paying 14 R P Candy all Esteemed 34 Candy is R 476 and 4½ fanams P Rupee is 2023 fanams paid into the Honourable Companies Cash here. ith Evening came off

10TH. FRYDAY. In the morning went ashore perused sundry of Captain Perrins accounts Enquired for their book M, Mr. Adams said they were behind hand he not

having any one to keep them up but himself and he being obliged to attend the 1714 Tellicherry affairs hindred him then I asked for their books L But they informed me DECEMwere att Tellicherry for they could not find them.

- Mr. John Bendall deceased leaving about 2400 R. behind him and not any Directions about a [tomb] agreed wth. Mr. Adams (his trustee) that they build a small tomb over him, presed them to hasten the pepper off also to draw out answers to the memorandums but Mr. Adams said he beleived he could not do itt before I sailed and said the pepper Came in but slowly from the Country in the Evening Came off.
- SATURDAY. Received a letter from Mr. Adams wth. - 12TH. SUNDAY. An order to the Captain to receive on board what sugar &ca. should be sent aboard by Noquedah Mahumud Cosson, the Captain assuring mee wee shall have room enough for the Companys and this freight otherwise would not take it in.

Went ashore in the morning, Mr. Alex Christe Surgeon here formerly at Bombay informing me the Honble Company refused paying his half pay in England for the time he served at half Pay at Bombay Hospitall for want of a Certificate. I gave him one the time from January 8th. 1708/9 to the 30 of June 1711, in the Evening came off, no pepper
 - 15th. Wednesday. No pepper.
- 16TH. THURSDAY. Severall of the sailors absenting themselves from the ship these 3 or 4 days, I wrote Mr. Adams &ca about them, to whom they had made Complaint yt. they were starved and abused by the Captain &ca. but they never gave the least notice of such abuse and Examining the stewards books find they have rather larger allowances than in the former Commanders time and for Correction I have not seen any one punished since been on board but business done wth. silence and Calmness, this Evening they came off to me making the foregoing Complaint I quitted them and permitted them to goe ashore for their Cloths but they did not return till 4 days No. 23. to their Duty, I had wrote hi[m] to send them to Tellicherry as Soldiers but that he No. 23. thought not adviseable.

The Recovery arrived from Cochin and a small Bengall ship (Anne) from thence with ophium &ca. which is now a meer Drugg here tho' this is the principall mart for itt, Mr. Burniston informing the Recovery was full and that she had not near what she was let out for aboard, vizt. 400 Suratt Candy, I ordered Mr. Perkins and some of the officers to survey her and that Mr. Burniston and Captain Gayney Give a manifest of all goods aboard which being done by the manifest appears 341 Can. Cochin of pepper and 93 Candy of Bettlenutt freighted and 25 Ca. pepper Captain Gayneys too large a priviledge, together 459 Candy makes Suratt Candys of 22 maund 301 ½ and the ship may reasonably be Esteemed at 550 Candys so if the Error must be in the quantity of ballast not certain to be known till Unladen, the ship full and uncapable of lading any more.

Examining Tellicherry muster Roll observe the officers pay is more than at Bombay which, acquainted must be altered to Bombay pay.

17. FRYDAY. Went ashore. Mr. Adams acquainting mee that the small Room Joyning to the Factory which he built since his marriage was not charged the Company requested it might to which agreed.

The pepper coming but slowly in and the time running on so fast I pressed Mr. Adams to know what time it might be on board intending to sail wth. what had gott rather than delay a proportionall time for the rest, he informed mee would be

- 8. Acco^T. Demands of Sundry persons (who have made M^T. Adams their attourneys (whose letters I saw) on Cap^T Perrins Estate amounting to Rup^S. 11990.5 principall. The House M^T. Adams says Cost him abo^T. 16000 fanams [being] so chargeable by many whimsicall Alterations but that he could get but 2000 now for itt, indeed it is but a very ordinary building

Received attested Coppy of Mr. Prestwich's Will, wherein he leaves his Wife sole Executrix and heir, Mr. John Bendalls Will leaving Mr. Adams his trustee and his mother all, The sale and money found by him as P inventory about Rups. 2400.

A letter to the Honourable Company Ditchfeild wch. he thought had sent to Bombay in wch. as to the house at Chittoa he says t'was the Honble Companys house but went in the Lingvisters name the house is not on the Company's books, so it is not probable they paid for itt, yet always Esteemed the Companys, because went in their name and how could it be otherwise when made use off by their Servants & it seems odd to mee the Lingvister should build the house when he needs only have fathered it, so that Dispute about Chittoa has been at best upon ground that the Samorine could not answer to the Dutch that perhaps he might keep them out if the house was Esteemed our Lingvisters, and if he would declare wee should have a factory there contrary to what his ancestors promised the Dutch. It might be worth while to assist him on good security and hardly neither for the pepper is

the better to the Northward and sufficient being well supplyed to produce more than the proportion of 4—five hundred tons ships & annum.

Perused Muster Roll of Soldiers in Tellicherry Fort, Europeans 71 and topasses No. 31. 60, 131 whereof 41 Europeans and 16 Topasses I landed going down. Their monthly pay is 5173—13 Tellichery fanams or £129. 6. 10 and informing The Topasses were more serviceable than Europeans recommended to them to Garrison the fort wth. such and send the Europeans up to Bombay.

The Soldiers never having been in Europe Dress Lieutenant Luke sent up to Mr. Burnisston to Bombay to gett such cloth as was proper at the Companys price meaning as the officers at Bombay had it for clothing their Companies contrarily Mr. Burniston invoiced it as sold Merchants and the money being [to] be paid in Callicutt he refused payment at said rate [there] fore as it was for Soldiers in the service as they appear the better being Equipt like Europeans I ordered the Lieut. to cloth them and would send fresh Invoice from Bombay.

The Effect of my pressing Mr. Adams to answer the memorandums were some words of heat that he would not write the Generall Letter to Bombay only noting what laded, that he had fully informed mee of all matters whatever I demanded, I told him if he refused answering the Letter (as there might be many necessarys to inform not Come to my knowledge I would write him an order to doe it and that as to informing me fully of affairs he had done it occasionally in Discourse regardless of the memorandums wh[...] him he must answer as I had required in writing and that not heedlessly at length he promised he would, said was in a Continuall Hurry with Tellechery affairs and the natives coming to him for Justice on all occasions and the ship being here so hope t'was execuseable, i'th Evening came off informing intended to sail the 22d. Wednesday; they bringing their pacquet off ship saluted at arrival aboard.

21. Tuesday. Received a letter from them inclosing Coppy of what prepared 21. Tuesday. Received a letter from them motosing coppy of the for Bombay and wrote them answer signifying severall things they had omitted and No. 32. that they alter those words which lessens my Demands and make their answers Compleat for still they insisted they had fully Complyed with all my Demands, that they should request a Continued Order to the Commanders of Europe shipping (as I had told them before) that for every 100 Ca: of pepper they ship they may Deliver a Chest of treasure [which method may prevent Charge of shipping going down and save time and that they write for Europe cloth &ca. for tryall] which I put them in mind of before, also of assisting the Samorine-Conclude and returned it to them

Off leaving Callicutt he said he beleived in a twelve months Tellechery would be settled [so] as it might be done and a factor, Serivan and two or three Navors only reside here to keep our right, That he beleived Could in 3 years time if supplyed yearly procure 1000 Tons of pepper they being building a wall from the foot of the hill, the fort is on round Northward to the Waterside I advised the Continuing thereof this will take in a large spott of ground in which are severall houses already and will Encourage merchants to come when they find they are protected and bring a small revenue of Taxes and Customs, likewise that they build a small armory and Hospitall in the fort, a porcu[...]tus for the gate way he says Cant be Done. advise him to return the men received from Madrass.

Off assisting the Samorine to retake Chittoa Mr Adams says he was present at a generall Councill held by the Samorine and his Chief Officers abot. that affair that the Samorine Demanded 100000 fanams to be lent by the English that he said would have done it, would the Samorine have made over the Callicutt Customs for security and have taken the field on that Occasion, that his Servants should have paid them in the field as their forces required itt, that he would have done this of himself, if the Generall &ca. should not approve of it in the Companys name, but this oversett by one of his Generalls who resolutely said his Majesty should find Chittoa streetts run with Blood before he left itt and advised him against anv assistance Especially pawning the Customs for security, there came very creditable information the fort was not above half finished and there lay a dutch ship of about 400 tons at Cochin since gone there with Chunam and ammunition for that place. Since pepper

8TH. SATURDAY. Chased three Groabs with a ship in tow off S^t. Georges Island for about 6 Hours and Coming within Gunn shott fired abroad side but did not observe any Damage they did not fire one Gunn, on Tacking to stand after them wee lost Ground and they went from us and so left of Chase believe them Malwanners & that the ship was from the norward about 300 Tons very light.

9TH: SUNDAY. In the Evening anchored in Goa Road under Alquarda ships Riding here a large Europe portugueze about 70 Gunns laden home a Europe ship of 40 Guns hired for Bengall they being much in want of Course peice goods for Consumption of the place a Cruiser of about 30 Gunns the fort S^t. George and Recovery.

10. Munday. Wrote to Padre Monoell d Sa. No. 7 and the Vice Roy No. 8 about the monsoon not thinking it adviseable to goe up to the Citty from the answers received at Carwarr for not having substantiall Testimonyalls and only a bare report that the Matter was otherwise I could Expect but the same answer besides knew not how the Vice Roy would receive mee therefore sent Mr. Perkins wth. itt to him.

Gave the Moorman a pass and English Coulours to hoist in Case absent from us he mett Angrias Grab, in the afternoon Wrote Mr Perkins to get leave of the Vice Roy to sail this is always Customary when they anchor under their Gunns.

11TH. TUESDAY. Received the arrack and Gave the Captain Orders to make the best of his way to Bombay and that he went Consigned to the Generall and Councill, ith afternoon the Vice Roy came down and Dispatched the ship for portugall, the English saluted him which the forts returned, ith Evening Mr. Perkins and the Rest returned and broth me a letter from the Vice Roy No. 9 and Manoell d Sa No. 10. The Vice Roy was mighty Courteous and Expressed a mighty desire of a good Correspondence wth the English, Wrote the Vice Roy a letter in behalf of Richard Opey that was Cast away in a ship of theirs coming from Batavia and saving some money the Captain and others took itt from him.

12TH. WEDNESDAY. Early this morning sailed wth. the land breeze wth. the Recovery, fort St. George & Moorman.

13TH. THURSDAY. Gave a pass to a Shybarr that came up wth. us belonging to Cambay and English Coulours, perused her portugueze pass.

Att packing the ship at night two of the seven sailors that run away att Callicutt being very mutinous I put them in Irons till come to Bombay and Gave the Captain a paper under my hand relating the [re to] to show at home.

I Rejoyce that your Excelencys health be Equall to your wishes which God preserve to you Extensive years as my whole desire is.

Mr. Nightingall has represented to us that in the year 1706 he and Mr. Sheldon were owners of a ship Called the Monsoon on a Voyage from Bengall to the Malabar Coast but was taken by the Savajees in the River of Carwarr, and as the Portugueze had notice of itt they fitted out a frigatt which retook her and Carried her into Goa upon which the Supra Cargo and a padre Employed by ye. owners sollicited in a Court of Justice for restoring Said Ship web. was determined in Court to be Delivered up upon paying the Expence of taking her from the Savajees.

I hope your Excy. upon Consideration of what I have represented will send to receive the said Expence of our Chief at Carwarr and to Deliver him up the ship wth. all the Goods she had in her or her Value as registred in your Court, as this matter is so plain and Clear I doubt not your Excelencys Justice pray Give me Occasion of serving your Excelency whose person God preserve many years Bombay Castle 23 October d: 1714.

I Esteem highly that you would be pleased to Give me this occasion wherein I might show the Great Desire I have to serve you, for want of a personall acquaintance is not a sufficient Cause to hinder me in my hearty Desires when there is another more prevalent which is the Great inclination I have towards the English Gentlemen amongst whom I have many friends and whereas on this occasion you Give me s^r. the advantage of a new one I am now him that is most interested and concerned in your service.

ffor as much as I am now absent from Goa I could not deliver the Letters my self to his Excy. the Vice Roy however they were Delivered by a very safe hand as by the answer I now return by the Bearer will testifie, by which you will see the result of this business as to which I Judge according to the Letter you wrote me that you have not all the Notices and advices relating to that affair for it is Certain it was never designed that the Owner should have Given to him the half of that Estate or Cargo albeit this was not the cause of the Vessells being kept here at Goa wth. his Goods.

This Vessell (as is notorious and well known) was taken by the Savajees near Anjediva and was 13 days in their hands and sailing on their Voya. near to the Lattitude of this place the most Excellent Caetano d Mello sent three men of warr who took her from the Enemy for so long they had her in their power and were carrying her away with a Convoy of five pallas and abot. 20 Galvats and this being the Reall of the Case it is necessary now that you Give the Reason and alledge the Right wherefore should be Restored and then I will doe what you command wth. a Ready and willing mind, God preserve you Cortary 23 November 1714.

December 1714.

The Merchants Report of the taking the Monsoon the 12^{th} . February 1706/7 by the Girrea Savajees.

This day the Aurenzeb sailed out of Carwarr Harbour to Mangulore at which time the Girrea Savajees with 4 Groabs and 35 Galvats (Nillu Purboo Generall of the fleett) lay in bed Cove, she mett the Monsoon o[ff] Anjediva and told Mr. Wilcox Supra Cargoe the news the night they Kept Company together till they Came off Call[...]con Captain Edwards offered to see him off Cape Raymas but he said he did not fear them about midnight Captⁿ. Edwards parted Company Early in the morning the Savajees came out of the Cove and Engaged the Monsoon for three hours at which time he surrendered they brought him to the Cove next day Mr. Mildmay wrote off to Nillu Purboo and he delivered up all the Europeans, they said they had very little ammunition on board having but 18 [shots] after the Engagement Mr. Mildmay immediately wrote to the Vice Roy this news, the Savajees kept the Monsoon 4 days in Bed Cove they went out wth. a design to Carry her to Girrea but off Goa they had a strong northerly Wind that they Could hardly Carry sail at which time Came out from Algorida 1 Frigatt, 1 Groab, 1 portugueze merchant and a fighting munchua the Savajees put afore the wind and the Portugueze Chased them they run the ship ashore in bed Cove in the night and left her having plundered her of 4 Bales of Cloth the portugueze fired Random shott all that night next morning seeing no body aboard they lightned her & hauled her off the Savajees would fain have perswaded the Rajahs people to fire upon the portuguez which they refused, the portuguese the same day Carried the Monsoon to Goa the Savajees had her in possession 9 days this is all the Merchts know of this matter Carwarr 4th. Janry. 1714/5. To Padre Manoell D Sa' [Jesuitt] Att Goa.

I received your kind Letter and am very thankfull for the offers of your friendship therein Contained all that att present I can Desire is that you wod. procure a Coppy of all the papers Relating to said affairs and transmitt them to me at Bombay or to the Chief att Carwarr but believe there is more opportunitys from hence the quick Dispatch of this ship for Bombay is so necessary that I have not time to pay my Respects to the Vice Roy as intended therefore desire you would give my most humble service to him in any thing I can be serviceable to you at Bombay pray Give me opportunities of showing you the Readiness I am in.

If I had notice sooner of your Lordships being at our Barr I should not been [sic] wanting in coming and paying my respects but this I send to beg pardon because this was the first news and I am afraid I shall not be able now to pay my Respects as I much Desired.

About the business your Lordship recommended I did all I could to follow your Lordships Order but as I could not doe any thing in the matter without a Gra[b] from his Excelency I asked his Leave but as these Cases are to be determined by a particular Council viz^t. of the Attourney Generall &c^a. for the Kings Right and all the papers being remitted to portugall, I beleive it impossible to send you a Legard [sic] & Judiciall Evidences of the process because they are wanting for Reasons I have before Given [you] however all the information I can Gett shall remitt your [sic] and I will propose to his Excelency and put him in mind of all that you have Desired or Ordered me Esteeming much any opportunities of serving your Lordship In [Goa].

Received your Honnours Letter of the 23^d. of October the 2[n^d.] of November and I Esteem to see thereby that your [Ho]nour enjoys perfect health.

Whereas the portugueze live not in India on privateering but to preserve that Respect they knew how to deserve and heroes to Obtain well may your Honnour perswade your self that there was some just motive for my not delivering up or restoring that ship your Honnour mentions to me and if this business had not already affected the Court of Lisbon 'tis Certain I would have had due regard to your Honn's. representation punctually to have performed your Desire but I shall not be Wanting this monsoon to put the King, my master in mind what may relate to the Direction of this matter so as that by the next Monsoon I may be able to answer your Honnour in Due form that you may remain satisfied notwithstanding your Honnour may not Deserve this Kindness In as much as all the English Gentlemen residing in ASIA do wholly forgett to maintain the Good correspondency there is between the two Crowns in Europe and your Honnour is not Ignorant that matters of state are of more weight and importance then any particular Conveniency and therefore in this Respect your Honnour should have Considered and not to have sold arms or ammunition to our Enemies, not to speak of some succour or supplys your honnour undiscoveredly have Given them as itt was last summer in the battle I gave the Arabs at the Port of Suratt who were antecedently advised, by an English Frigatt that seperated from my fleett and afterwards they Supplyed them with some Gunners, and the same happened when a frigatt of ours fought with all Angrias fleet they were succoured and assisted by two English ships that were then in Calabby treating of a peace w^{ch}. your Honnour to this day preserves with this Enemy & in no wise will forbear nor have regard to my Complaints it being a few days ago I was advised by the Generall of the North that in Bombay they would not sell a [few] shott of a small weight which they sollicited for [...] the winter season did not admitt that they might be sent for from Goa whereas to all people and at all times that specie is Exposed to sale, I would be very Glad to have an Occasion to pleasure your Honnour or to be serviceable to you because that in all things and [on] Every occasion I shall be very Ready to Effect the same. God preserve your Honnour many years Goa 21st. November 1714.
