CHAPTER I.

General and Political.

2. The area of the State is 397 square miles.

The population of the State, according to the Census of 1921, is 43,285.

The gross revenue of the State, based on the average of the past 5 years, amounts to Rs. 2,24,994.

The State pays an annual tribute of Rs. 9,600 to the British Government and its relations, with the paramount power, continue to be cordial as before.

Family.

3. My name is Malojirao Mudhojirao Naik Nimbalkar. I am a Treaty Chief and a First Class Sardar. I am 30 years old and a Kshatriya by caste. Myself, Shrimati S. Ranisaheb, Yuvaraj Pratapsinh *alias* Bapusaheb, daughter Sarojinidevi *alias* Akkasaheb and second son Vijayasinh *alias* Shivajirao, all enjoyed good health during the year.
