


The placement cell in GIPE is functioning in a vibrant manner and growing in strength from year to year. As the coordinator I sincerely believe that the ultimate test of what we teach has to be evaluated by the market. This evaluation process can be two fold: those who opt for higher studies must be found to be competent by the institutions where they apply and the recruiting organizations must find it worthwhile to take in our students.

The most important things in this evaluation process are the strength of syllabus, standard of teaching and of course individual performance. About the first two it can be said that the structure of the syllabus is such that the number of compulsory papers has been kept to the minimum while optional papers cover a wide range of topics. The basic idea behind such a frame is that students must have a freedom of choice and they must be conversant with different areas of Economics, once they complete their master degree.

Faculty specialization in the institute is represented by the Agro Economic Research Centre and Population Research Centre. Students offering any of these optional courses have the additional advantage of keeping themselves updated about the latest developments in these areas. For other papers also teachers very often talk about their own findings while illustrating a particular point. In order to encourage this tendency to investigate recently a thesis paper has been added in the M.A. course.

The Gokhale Institute of Politics And Economics (GIPE) is held in high esteem among the academic fraternity since 1930 for generating high quality research and scholars. The institute offers a Full-Time, Two Year Masters' Programme in Economics, which is unique in terms of its course structure.

The Program offers students Six Compulsory courses, (including Macro Economics, Micro Economics, Econometrics and Development Economics) and twenty optional courses of which students are required to choose any ten. This allows students to either specialize in one of the many branches of Economics, or diversify their knowledge. Financial Economics, Advanced Econometrics, Labor Economics, Industry And Its Organization, Environment Economics are some of the optional courses which are offered.

The Deemed University status granted to the institute by the University Grant's Commission allows the Syllabi to be updated regularly in line with the domestic and international developments in Economics and related fields.

The institute also houses centers in Population Research and Agricultural Economics. These research cells have done pioneering research. Students opting for the optional courses on Population Studies & Agricultural Economics benefit from the knowledge base of these centers and the experience of in-house researchers.

The institute is also a venue for various seminars and lectures delivered by eminent economists and scholars on contemporary and academic economic issues, which expose the students to new ideas and viewpoints.

The optional Master's Thesis course offered gives the students an opportunity to carry out independent research under the guidance of our distinguished faculty. Being a course unique to the institute, it helps to hone the research skills of students and enables them to put their theoretical knowledge to practical use. This experience is useful for students going into the job market as professional experts often encounter challenging projects which require novel solutions.

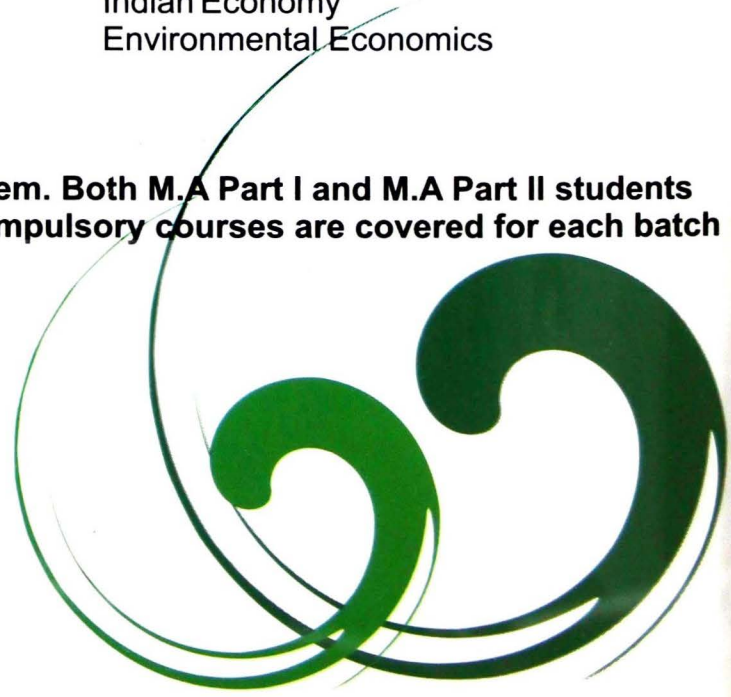

The institute follows a rolling semester system. Both M.A Part I and M.A Part II students are offered the same optionals, while the compulsory courses are covered for each batch over the course of 2 years



The Institute enjoys the autonomy of a deemed university and regularly updates its syllabi. It follows a unique 'top-down bottom-up' approach to its pattern of teaching and learning. Our compulsory courses ensure that students receive a thorough grounding in theory and use of basic economic tools applied to analyze any situation in economics and related fields. Furthermore, the M.A.Economics course at G.I.P.E. includes a varied plethora of optional papers. Each paper in itself provides a holistic approach to its subject matter. Besides teaching detailed analysis of the concerned paper, our expert faculty ensures that students are well aware of the linkages between the subject matter of the various papers. Students can choose a combination of 10 optional papers [of the 21 offered to them] as per their own interest and aptitude. Thus, they can choose either to diversify or concentrate their knowledge in one or many branches of economics.

The tight schedule of each semester along with the comprehensive internal assessment system of assignments, term papers and tutorials ensure that they learn to work within prescribed time frames. The teaching curriculum encourages students to pursue original research as well as refer to scholarly journals and works by eminent national and international scholars and field practitioners.

An idyllic student faculty ratio [3:1] allows the students to interact with the faculty on a more personal front and be guided in the development of their ideas and thoughts. Students also gain from seminars and conferences hosted regularly by the Institute, as well as from the numerous research scholars who frequent the library and the Institute.

Our library, one of the best in Asia, offers students ready access to numerous books, journals and original articles. It has a diversified collection of works in social sciences spanning over the last two centuries, which are available to the students.

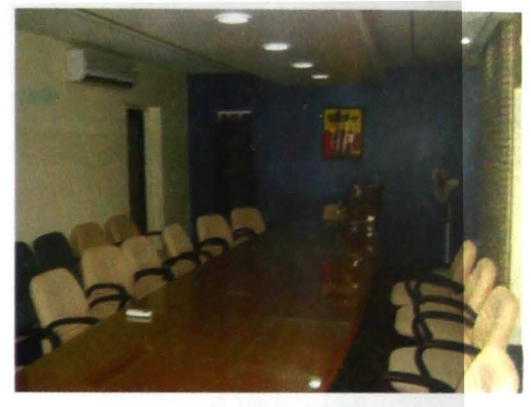
Students have the opportunity to learn and apply the latest software packages in Econometric techniques, taught through a diploma course equipping them with an analytical edge.



The Gokhale Institute of Politics and Economics is situated on an idyllic three-acre campus in the heart of Pune city. The campus also houses the headquarters of the Servants of India Society. The campus is a unique blend of traditional and contemporary cultures, with the old world charm palpable in most of the architecture, together with ultra modern facilities provided in state of the art Conference and Seminar rooms, located in the UGC and main MA buildings respectively.

Library

The Dhananjayrao Gadgil Library instituted in 1905, located on the campus is renowned for being the largest library of its kind in the city and one of the most comprehensive in Asia. It houses over two hundred and seventy thousand books, journals and periodicals. In addition to the above, the Library has the distinction of being the depository for the World Bank, the International Monetary Fund, the United Nations, as well as the legislative proceedings of the Canadian Government, in addition to the legislative proceedings of the Maharashtra State Government and the Central Government. Spread over three floors, the Library maintains a separate section for the MA students, consisting of a vast collection of books and other reference material on Economics and other fields that any post graduate student would treasure. Housed for the most part in a structure designed in 1987 by the internationally renowned architect Christopher Charles Benninger, the library also maintains the online servers of the Institute. The erstwhile Main Building of the library now houses the Library's collection of rare manuscripts, some of which date back to the 16th century. In addition, the Old Reading Hall is used as an archive for the Lok Sabha debates.

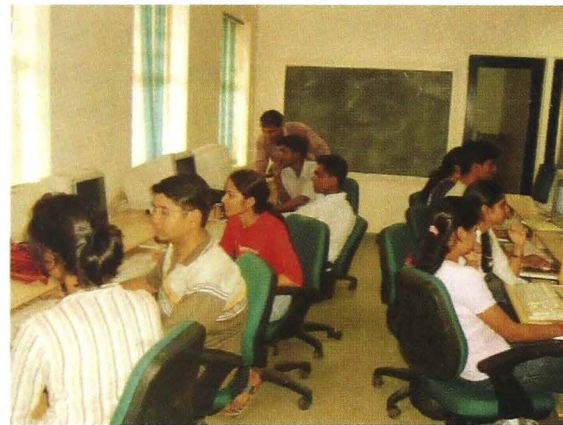


The Statistical Department

In addition to playing host to the Statistical research team at GIPE, which aids faculty members, researchers and students alike with their statistical tasks, the Statistical Department also houses the Statistical Museum, a collection of vintage computers, calculators, and other tools of the trade.

Computer Center

The computer centre at the Gokhale Institute is housed in the Statistical Centre. Equipped with over fifteen computers, it provides student's access to the Internet and latest statistical packages. The computer centre along with being used regularly as part of the curriculum is also used by the students to look up online economic journals to supplement classroom learning. Students are also encouraged to make extensive use of the computer centre for their own projects and the Masters' Thesis course.



Hostel and Staff Quarters

The GIPE hostel (Boys & Girls) and staff quarters are located at a distance of roughly 1000 meters from the institute. The large alfresco area and a strategic location provides students a peaceful environment to follow up on their class work and also a huge range of activities including volleyball, table tennis, cricket and badminton to disport. The close proximity of the staff quarters and the hostel allows the students to interact with the faculty on a more personal basis, thus working to their advantage.

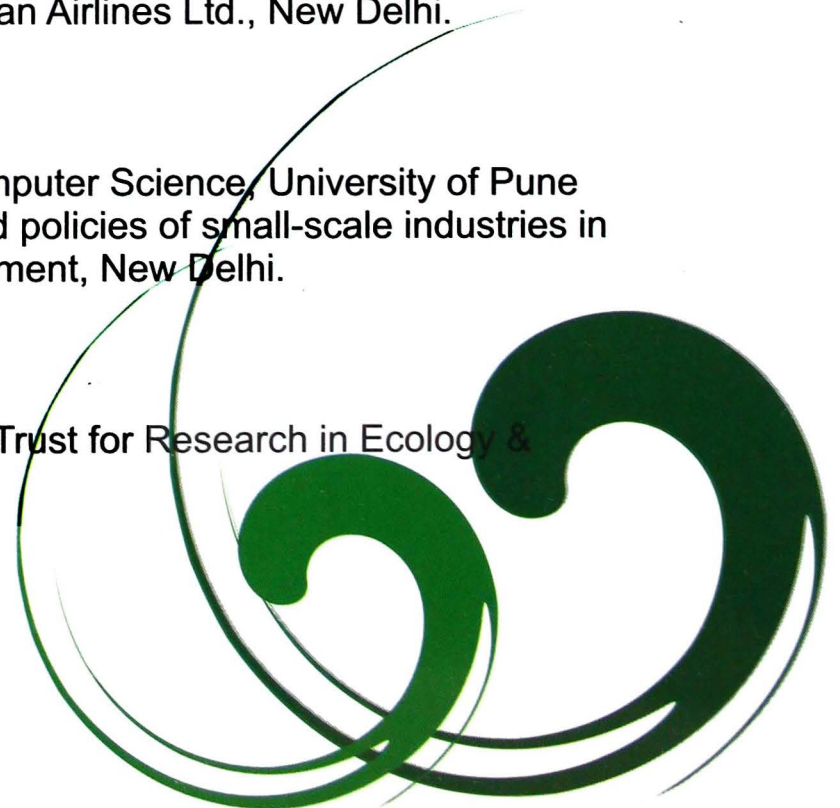

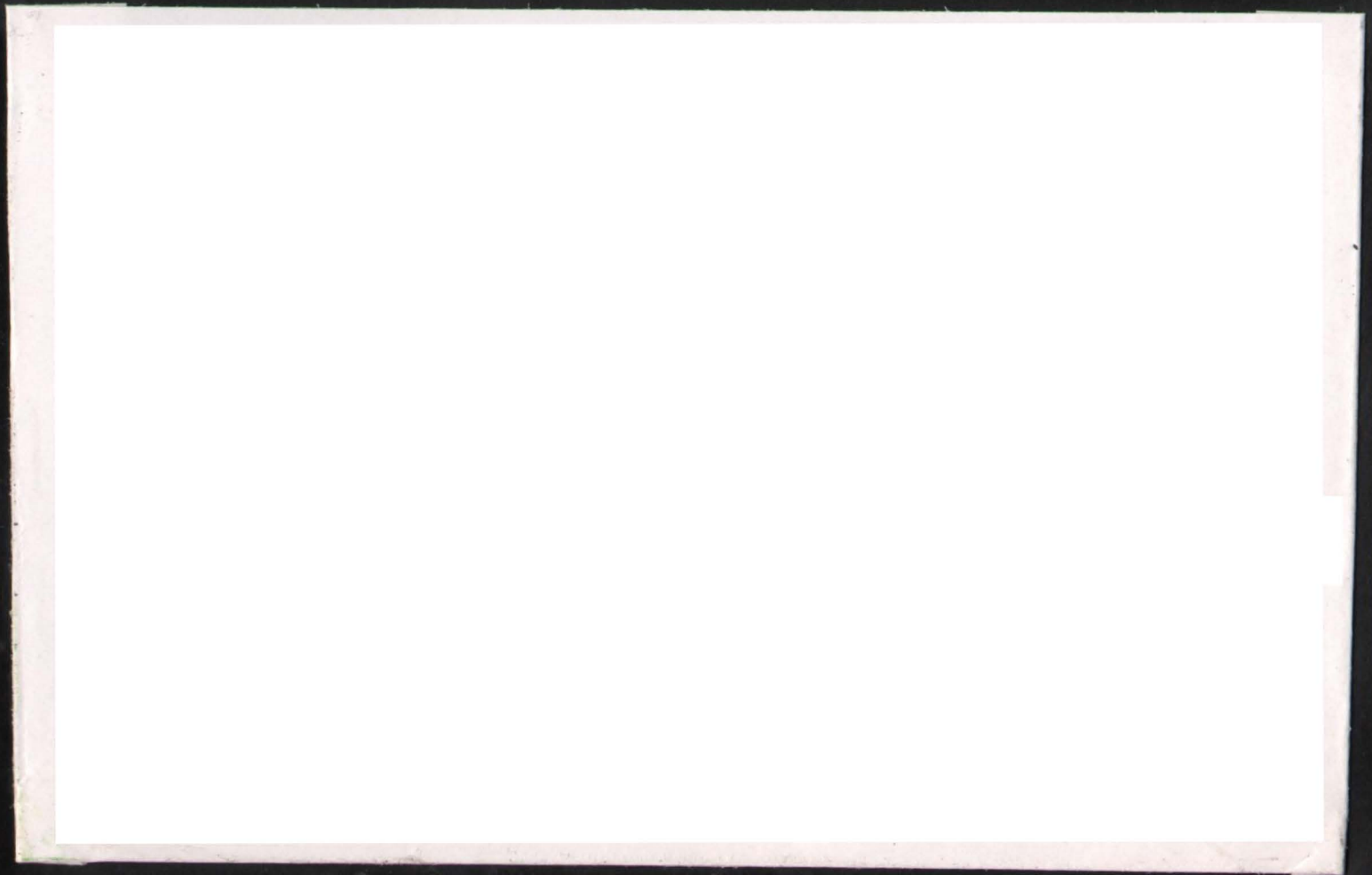
