Although opposed to the XXIII Clause of the Rules for the management of the Post Office Department, appended to the Post Office Act, the system of giving credit to parties at the Post Office and interchanging accounts at the end of the month was tried as an experimental measure, but as it has been productive of much inconvenience and great irregularity, it is abolished, and the former plan reverted to of requiring immediate payment of postage from this date.

As there still continues to be considerable misapprehension as to the right of parties addressing me as Post Master General, or the Deputy Post Master General in Letters either "on Service" or "Bearing" on subjects relating to their private affairs, it is hereby notified to all concerned, that such Letters will in future be returned to the senders "Bearing" this practice being at variance with the LIX. Clause of the Rules for the management of the Post Office, appended to the Post Office Act, which requires, that all such Letters be "Post paid."

No. 758 of 1840.—The following appointment is made :—

26th Regiment Native Infantry.

Date of Appointment.

Lieutenant and Brevet Captain R. H. Goodenough, to be Quarter Master and Interpreter in the Hindooostane language, vice Wilson promoted 1st November 1840.

No. 759 of 1840.—The following temporary appointment is confirmed :—

Lieutenant Douglas Hamilton of the 21st Regiment Madras Native Infantry, to act as Adjutant to the detached Wing of that Corps proceeding to Suttara.

No. 760 of 1840.—The following order is confirmed :—

An order by Lieutenant Colonel Payne, dated the 3rd instant, appointing Captain Wenn to act as Quartermaster to the 13th Regiment Native Infantry, during Lieutenant MacDougall's absence on leave at the Presidency.

No. 761 of 1840.—The Honorable the Governor in Council is pleased to appoint Captain Hallett, to relieve Captain Johnstone, Madras Establishment, of the Commissariat duties at Belgaum, and Lieutenant Hartley, to take charge of the Deputy's Office at the Presidency, during the absence of Captain Davidson.

No. 773 of 1840.—Under instructions from the Government of India, it is hereby declared, that the Pay of all Regimental Followers permanently attached to European and Native Corps, and all fixed allowances drawn by Officers and Men of the said Corps, which are at present paid in certain districts with deductions on account of the difference between the Company's Rupee and the former Local Currencies, shall be considered to be fixed in the Company's Rupee.—All Local Establishments and all allowances not generally payable at all the Military Stations, will continue to be paid as heretofore.

The Honorable the Governor in Council is pleased to republish for general information the following Proclamation by the Right Hon'ble the Governor General of India in Council:—

FORT WILLIAM,

FINANCIAL DEPARTMENT.

THE 11TH NOVEMBER, 1840.

PROCLAMATION.

The Governor General in Council is pleased to notify, that from and after the 11th day of November 1840, in respect to the Mint of Calcutta, and from and after the 1st day of April 1841, in respect to the Mints of Fort Saint George and Bombay, those parts of Act No. XVII. of 1835 which were suspended by Act No. XXXI. of 1837, directing that certain Silver Coins issued from the Mints within the Territories of the East India Company shall bear on the Obverse the Head of the Reigning Sovereign of the United Kingdom of Great Britain and Ireland, will be again in force; and that the Device of the Silver Coins which shall be coined from and after the said dates respectively in the Mints of India, in conformity with Acts XVII. of 1835 and XXI. of 1838, will be as Act No. XVII. of 1835 requires, viz.

On the Obverse—The Head of Her Majesty Victoria with the words

VICTORIA QUEEN.

On the Reverse—The denomination of the Coin in English and Persian in the Centre, encircled by a Wreath, and around the margin the words

EAST INDIA COMPANY.

1840.

The Coin will be milled on the edge, with a serrated or upright milling like the Rupee now Current bearing the Head of His late Majesty William IV.

An engraving of the Victoria Device is hereto annexed for the information of the Public.

The Weight, Standard, Fineness and Value of the Company's Rupees, as defined in the Act, are here repeated.

Weight—180 grains Troy, or one Tolah.

Standard Quality—Eleven twelfths Silver, one twelfth Alloy.

Value—The same as the Company's Rupee of 1835, the Madras, Bombay, Furrukabad, and Sonat Rupee, and equal to fifteen sixteenths of the late Sicca Rupee.

The other Silver Coins authorized to be issued from the Government Mints by Act No. XVII. of 1835 and Act No. XXI. of 1838, viz. double, half and quarter rupees, and two anna pieces, will bear in all respects a due proportion to this Rupee.

The Governor General in Council hereby directs, that all Magistrates, Collectors and other Public Officers will promulgate this Proclamation throughout their respective Districts; and that a translation of it be affixed in a conspicuous place at every Public Treasury.

Money Changers, Shroffs, Podars and others, should be required to take notice of the Provision in Act No. XVII. of 1835 against clipping, filing, punching or otherwise defacing the legal Coin. The Silver Coins issued from the Mints of Government under Act XVII. of 1835 if not cut, clipped, marked, or otherwise wilfully impaired are legal tender for their full value until by gradual wear they have lost two per Cent of their Original Weight.
