The following Act, passed by the Legislative Council, received the assent of the Right Honorable the Governor General on the 14th November 1856, and is hereby promulgated for general information :-

ACT No. XX. of 1856.

An Act to make better provision for the Appointment and Maintenance of Police Chowkeydars in Citics, Towns, Stations, Suburbs, and Bazaars in the Presidency of Fort William, in Bengal.

Whereas it is expedient to make better provision for the appointment and

maintenance of Police Chow-Preamble. keydars in cities, towns, stations, suburbs, and bazaars in the Presidency of Fort William, in Bengal: It is enacted as follows :-

I. Regulation XXII. 1816, Regulation VII. 1817, Section VI. Regulation III. 1821, and Section IV. Regu-Laws repealed.

IV. For the purposes of this Act, the Local Government may define and declare Government may define limits of cities, towns, &c. the limits of any city, town, suburb, station, bazaar, or union, and all occupiers of houses within any such city, town, suburb, station, bazaar, or union as aforesaid, or within such limits as shall be so defined as aforesaid, shall be liable to be assessed or rated according to the provisions of this Act for the purpose of maintaining the Chowkeydars appointed to be maintained in such city, town, station, suburb, bazaar, or union.

V. If any house be let out in portions to different persons, or be let out to or Houses let to lodgers, how occupied by lodgers or travelto be assessed. to be assessed. lers, the person who shall so let the same, or who shall receive the rents or payments

from such persons or lodgers or travellers, shall, for the purposes of this Act, be deemed to be the occupier of such house.

The Local Government, on the report of the Magistrate and Commissioner of Circuit, shall determine in each case whether the tax to be levied shall be such assessment or such rate.

XI. If the tax be an assessment according to the circumstances, and the pro-Limitation of tax.

perty to be protected of the persons liable to the same, the aggregate sum to be raised by such tax shall not exceed the average rate of two annas per mensem for each house, and the amount assessed in respect to any one house shall not be more than the pay of a Chowkedar of the lowest grade. If the tax be a rate on houses and grounds, it shall not exceed five per centum of the annual value thereof.

XII. For the purpose of making a rate under this

Rate how to be ascertained.

Act, the annual value of the

houses and grounds liable to the rate shall be computed and ascertained upon an estimate of the gross annual rent at which the same might reasonably be expected to let from year to year. Grounds used for purposes of trade shall be liable to the rate, but grounds used for the purpose of cultivation or for depasturing cattle shall not be liable.

XIII. The Magistrate may, at his discretion, exempt

from the assessment or rate, or may relieve from the payment of his assessment or rate, any occupier who may be unable from poverty to pay the same.

each such city, town, or other place as aforesaid, or, when he may see fit to divide any such city, town, or place into convenient divisions, for each division thereof, and shall issue a sunnud of appointment, specifying the names, residence, business, or other description of the persons appointed, and the period for which the appointment is made. Every punchayet shall consist of three or five respectable persons residing or carrying on business in or near to any such city, town, or other place, or in or near to any such division thereof. The decision of the Ma-gistrate in such cases shall be final, and no objection shall be taken to any assessment or rate, nor shall the liability of any person to be assessed or rated be questioned in any other manner or by any other Court.

XXV. If the persons appointed a punchayet, or a majority of them, refuse, or omit, for a period of fifteen days after the receipt of an order from the Magistrate,

to perform the duties required of them, the Magistrate may himself make or revise the assessment or rate, and may enforce the same as if it had been made or revised in the first instance by the punchayet. Provided that

XXVI. No person shall be bound to act on a punchayet unless he shall re-Residents only bound to act on a punchayet.

XXVII. Every punchayet shall be appointed for the period of one year, and

years after the expiry of previous service; but nothing in this Section shall prevent any person from being appointed to serve on a punchayet at any time whatsoever with his own consent.

XXVIII. If a majority of the persons assessed or rated in any district for which a punchayet shall be movable only on application of rate-payers. writing to the Magistrate for the removal of any

member of the punchayet appointed for such district, the Magistrate, if he think it expedient, may remove such member from the punchayet.

The Magistrate shall take from every Tax Collector or Darogah such security for the due disposal of the sums collected by him as may be thought necessary.

Contingent expenses. purchase of stationery, in providing badges, dresses, and weapons for the Chowkeydars, and for any other contingencies that may seem to him necessary.

XXXVI. After paying the wages of the Chow-

keydars, and defraying the charges specified in the three last preceding Sections of this Act, the Magistrate may,

XXXVII. The Tax-Darogahs shall prepare, from

XXXVIII. On the 10th of each calendar month, or so soon after as possible, To collect assessment.

the Tax-Darogah shall proceed in person, or through some one of his office establishment, to collect the amount due for the current month from each person subject to the tax; and for all sums so collected, the Darogah shall grant a receipt. Provided that, with the sanction of the Commissioner of Circuit previously obtained, the collection may be made quarterly instead of monthly ; and in such case, the amount due for each quarter shall be collected in the last month of that quarter.

XXXIX. The Tax-Darogah shall remit to the Magistrate, in such manner as the Magistrate shall direct, To remit collections to the Magistrate.

trate may issue a warrant to the Tax-Darogah, authorising him to levy the whole or any part of the demand by distress and sale of any goods and chattels belong-ing to the defaulter, or being at any time upon the premises in respect of which the arrear is due; and the Magistrate's order as contained in the warrant shall be final.

XLIV. The Tax-Darogah shall make an inventory of all goods and chattels

shall fraudulently conceal, remove, or dispose of any of his property, for the purpose of avoiding a distress un-der the provisions of this Act, or shall knowingly assist any other person in so doing, shall be liable, on conviction before a Magistrate, to a penalty not exceeding fifty Rupees.

XLIX. The Magistrates shall receive and try all Magistrates to try com-plaints against Tax-Darogah complaints preferred on oath or solemn affirmation against of extortion, &c. any Tax-Darogah, or other person appointed under this Act, for extortion, malversation, or other misconduct in the discharge of his duty. On proof of any such offence, the Tax-Darogah or other personas aforesaid shall

be liable to dismissal from office, and to imprisonment, with or without labour, for a period not exceeding six months, and may also be compelled to refund any money corruptly or unduly exacted or received, and to deliver up any effects which may have been illegally distrained or sold, or the value thereof, or in default, and until such delivery or refund be made, shall be liable to further imprisonment, with hard labour, for not more than six months. thing in this Section shall be

taken to prevent the Magistrate from committing any Tax-Darogah or other person as aforesaid for trial before the Sessions Court, or to limit the power of the Sessions Court in regard to the punishment of such offences under the general law.

L. The Chowkeydars, and the Jemadars and In-

Powers, duties, and liabilitics of Chowkeydars, Jemadars, and Inspectors.

spectors appointed under this Act, shall exercise all the powers, and perform all the duties, and be subject to all

the liabilities of Police officers, as prescribed in the General Regulations of the Bengal Code or Acts of the Government of India for the time being in force, so far as such powers, duties, and liabilities are not inconsistent with, or otherwise expressly provided for by this Act. The Chowkeydars and the Jemadars and Inspectors are in all respects subordinate to the Police Darogah of the Thanna within the limits of which they may be employed.

LI. Every Chowkeydar appointed under this Act shall wear a badge with a number, and the name of

Chowkeydars to wear badges. the city, town, place, or division for which he is appointed, engraved thereon.

LII. Every Chowkeydar and every Jemadar and

Inspector appointed under this Act shall have power, Duties of Chowkeydars : without warrant, to apprehend and convey immediately,

To apprehend offenders. ting any heinous offence, or whom he shall have just cause to suspect to be about to commit or to have committed a heinous offence, or against whom a hue and cry shall be raised.

ACT NO. XXII. OF 1856.

An Act for Establishing a Toll on Boats and Timber passing through the Kurratiya River in the District of Bogra.

Whereas it is expedient, with a view to afford facilities for the internal com-merce of the districts of Di-Preamble.

nagepore, Rungpore, and Bogra, to adopt measures for the improvement of the navigation of that part of the Kurrativa river, which lies within the district of Bogra, and whereas any measure which may be adopted for this purpose will necessarily occasion a considerable outlay at the first, and an annual expense thereafter, and it is just and reasonable that, to defray the same, a moderate toll should be levied on all boats, timber, rafts, and floats passing through or within such part of the said river; and whereas it is expedient to encourage individual enterprise, and the employment of private capital on works of public utility; It is enacted as follows :---I. Tolls, at the rates specified in the Schedule

Tolls may be levied on the Kurratiya,

annexed to this Act, may be levied on all boats, timber,

rafts, and floats, children, rafts, and floats, passing through or within the aforesaid part of the Kurratiya river, at such stations or places as the Lieutenant Governor of Bengal may from time to time appoint. The said tolls shall be levied by such persons, and under such rules, as the said Lieutenant Governor may direct; and all such rules shall be duly notified in the English and Vernacular Gazettes for public information.

excuse, delay to report the detention of any boat, timber, raft, or float, to the Deputy Collector or other officer as aforesaid, or shall demand or receive as toll any larger sum than is authorised by the Schedule annexed to this Act, shall, on conviction before a Magis-trate, or other officer exercising the powers of Magistrate, forfeit a sum not exceeding two hundred Bupees.

V. For the purpose of carrying out the objects of this Act, the Lieutenant Government may authorise any person to carry out objects of Act,

To execute, in the name and on behalf of the Company, all deeds, receipts, and other documents they may think necessary, and for that purpose to use, when necessary, the Company's seal;

To refer disputes to arbitration, and compromise any debts or claims ;

To draw, accept, make, and endorse any Bill of Exchange or Promissory Note, and also to raise upon the security of the assets of the Company from time to time any requisite sum or sums of money; and the drawing, accepting, making, or endorsing of every such Bill of Exchange or Promissory Note as aforesaid on behalf of the Company shall have the same effect with respect to the liability of such Company as if such Bill or Note had been drawn, accepted, made, or endorsed by such Company in the course of carrying on the business thereof ;

To do and execute all such other things as may be necessary for winding-up the affairs of the Company and distributing its assets,

LXXXIX. There shall be paid to the official liquidators such salary or re-muneration, by way of per-centage or otherwise, as the Court directs.

2. Liquidators shall be appointed for the purpose of winding-up the affairs of the Company and distributing the property.

3. The Company in general meeting may appoint such person or persons as it thinks fit to be a liquida-tor or liquidators, and may fix the remuneration to be paid to them.

4. If one person only is appointed, all the provisions herein contained in reference to several liquidators shall apply to him.

5. When several liquidators are appointed, every power hereby given may be exercised by any two of them.

The liquidators may, at any time after the pass-6. ing of the resolution for winding-up the Company, and before they have ascertained the sufficiency of the assets of the Company, or the debts and liabilities in respect of which the contributories are liable, call on all or any of the contributories to the extent of their liability to pay all or any sums they deem necessary to satisfy the debts and liabilities of the Company and the costs of winding it up; and they may, in making a call, take into consideration the probability that some of the contributories upon whom the same is made may partly or wholly fail to pay their respective portions of the same.

7. The liquidators shall have all powers hereinbefore vested in official liquidators, and may exercise the same without the intervention of the Court.

8. All books, papers, and documents in the hands of the liquidators shall at all reasonable times be opento the inspection of the shareholders.

When the creditors are satisfied, the liquidators shall proceed to adjust the rights of the contributories amongst themselves, and for the purposes of such adjustment they may make calls on all the contributories to the extent of their liability for any sums they may deem necessary, and they may, in making a call, take into consideration the probability that some of the contributories upon whom the same is made may partly or wholly fail to pay their respective portions of the same.

10. As soon as the affairs of the Company are fully wound-up, the liquidators shall make up an account showing the manner in which such winding-up has been conducted, and the property of the Company disposed of; and such account, with the vouchers thereof, shall be laid before such person or persons as may be appointed by the Company to inspect the same; and uponsuch inspection being concluded the liquidators shall proceed to call a general meeting of the shareholders for the purpose of considering such account; but no such meeting shall be deemed to be duly held, unless two months' previous notice, specifying the time, place, and object of such meeting, has been published in the manner specified in Section XCIII. of this Act.

11. Such general meeting shall not enter upon any

business except the consideration of the account; but the meeting may proceed to the consideration thereof, notwithstanding the quorum required by any regulation of the Company to be present at general meetings is not present thereat; and if, on consideration, the meeting is of opinion that the affairs of the Company have been fairly wound-up, they shall pass a resolution to that effect, and thereupon the liquidators shall publish a notice of such resolution in the manner specified in Section XCIII. of this Act, and shall also make a return to the Registrar of Joint-Stock Companies of such resolution, and on the expiration of one month from the date of the registration of such return, the Company shall be deemed to be dissolved.

XCVI. The registration of Companies shall be conducted as follows ; (that is to Registration. say,)

The local Government may, after the sanction of 1. the Governor General in Council to the creation of any such offices, from time to time appoint such Registrars, Assistant Registrars, Clerks, and servants as it may think necessary for the registration of Companies under this Act, and remove them at pleasure.

2. The local Government may make such regulations as it thinks fit with respect to the duties to be performed by any such Registrars, Assistant Registrars, Clerks, and servants as aforesaid.

3. The local Government may from time to time determine the place or places at which Offices for the registration of Companies are to be established : Provided always, that there shall be at all times maintain-ed in each of the three Presidency Towns of Calcutta, Madras, and Bombay at least one such Office, and that every Company whose registered Office is within any Presidency shall be registered in that Presidency,

Every person may inspect the documents kept by the Registrar of Joint-Stock Companies ; and there shall be paid for such inspection a fee of one Rupee for each inspection; and any person may require a copy or extract of any document or any part of any document, to be certified by the Registrar, on payment of two annas for every hundred words of such copy or extract; and such certified copy shall be prima facie evidence of the matters therein contained in all legal proceedings whatever.

5. There shall be paid to any Registrar, Assistant' Registrar, Clerk, or servant that may hereafter be em-ployed in the registration of Joint-Stock Companies, such salary as the local Government may, with the sanc-tion of the Governor General in Council, direct.

6. Whenever any act is herein directed to be done 5

to or by the Registrar of Joint-Stock Companies, such act shall, until the local Government otherwise directs, he done to or by the keeper of the records of the Supreme Court of the Presidency in which the registered Office of the Company is situate, if such registered Office is situate within a Presidency; otherwise by the keeper of the records of the Supreme Court of the Presidency of Bengal.

In the case of a Company registered under the said Act, if such Company is not intended to be registered as a limited Company, a list showing the names, addresses, and occupations, of all persons who, on the day of registration, are holders of shares in the Com-pany, with the addition of the shares held by such persons respectively, distinguishing each share by its number.

If such Company is intended to be registered as a limited Company under the provisions of this Act, the above list shall be accompanied with a statement specifying the following particulars :-

The nominal capital of the Company, and the number of shares into which it is divided ;

The number of shares taken, and the amount paid on each share ; and

The name of such Company, with the addition of the word " Limited" as the last word thereof;

3. In the case of any other Company duly consti-tuted by law previously to the passing of this Act, and consisting of seven or more shareholders, if it is not intended to be registered as a limited Company, there shall be delivered to the Registrar of Joint-Stock Companies such list of shareholders as is hereinbefore mentioned, and also a copy of any Law, Royal Charter, Letters Patent, Deed of Settlement, or other instrument constituting or regulating the Company;

4. If any such Company as last aforesaid is intend-ed to be registered as a limited Company, the above list and copy shall be accompanied by a statement specifying the following particulars ; (that is to say,)

TABLE B.

REGULATIONS FOR MANAGEMENT OF THE COMPANY.

SHARES.

1. No person shall be deemed to have accepted any share in the Company unless he has testified his accept-ance thereof by writing under his hand, in such form as the Company from time to time directs.

2. The Company may from time to time make such calls upon the shareholders in respect of all monies unpaid on their shares as they think fit, provided that twenty-one days' notice at least is given of each call, and each shareholder shall be liable to pay the amount of calls so made to the persons and at the times and places appointed by the Company.

3. A call shall be deemed to have been made at the time when the resolution authorising such call was passed.

4. If before or on the day appointed for payment any shareholder does not pay the amount of any call to which he his liable, then such shareholder shall be liable to pay interest for the same at the rate of 5 per cent. per annum from the day appointed for the payment thereof to the time of the actual payment.

5. The Company may, if they think fit, receive, from any of the shareholders willing to advance the same, all or any part of the monies due upon their re-spective shares beyond the sums actually called for; and upon the monies so paid in advance, or so much thereof as from time to time exceeds the amount of the calls then made upon the shares in respect of which such advance has been made, the Company may pay interest at such rate as the shareholder paying such sum in advance and the Company agree upon.

6. If several persons are registered as joint holders of any shares, any one of such persons may give effectual receipts for any dividend payable in respect of such share

7. The Company may decline to register any trans-fer of shares made by a shareholder who is indebted to them.

8. Every shareholder shall, on payment of such sum not exceeding eight annas as the Company may pre-scribe, be entitled to a certificate, under the common seal of the Company, specifying the share or shares held by him, and the amount paid up thereon.

9. If such certificate is worn out or lost, it may be renewed, on payment of such sum, not exceeding eight annas, as the Company may prescribe.

10. The transfer books shall be closed during the fourteen days immediately preceding the ordinary general meeting in each year.

TRANSMISSION OF SHARES.

11. The executors or administrators or representatives of a deceased shareholder shall be the only persons recognised by the Company as having any title to his share.

12. Any person becoming entitled to a share in consequence of the death, bankruptcy, or insolvency of any shareholder, or in consequence of the marriage of any female shareholder, or in any way other than by transfer, may be registered as a shareholder upon such evidence being produced as may from time to time be required by the Company.

13. Any person who has become entitled to a share in any way other than by transfer, may, instead of being registered himself, elect to have some person to be named by him registered as a holder of such share.

14. The person so becoming entitled shall testify such election by executing to his nominee a transfer of such share.

15. The instrument of transfer shall be presented to the Company, accompanied with such evidence as they may require to prove the title of the transferror, and thereupon the Company shall register the transferree as a shareholder.

FORFEITURE OF SHARES.

16. If any shareholder fails to pay any call due on the appointed day, the Company may, at any time thereafter, during such time as the call remains unpaid, serve a notice on him, requiring him to pay such call, together with any interest that may have accrued by reason of such non-payment.

17. The notice shall name a further date, and a place or places being a place or places at which calls of the Company are usually made payable, on and at which such call is to be paid: it shall also state that, in the event of non-payment at the time and place appointed, the shares in respect of which such call was made will be liable to be forfeited.

18. If the requisitions of any such notice as aforesaid are not complied with, any share in respect of which such notice has been given may be forfeited by a resolution of the Directors to that effect.

19. Any shares so forfeited shall be deemed to be the property of the Company, and may be disposed of in such manner as the Company thinks fit.

20. Any shareholder whose shares have been forfeited shall, notwithstanding, be liable to pay to the Company all calls owing upon such shares at the time of the forfeiture.

INCREASE IN CAPITAL.

21. The Company may, with the sanction of the Company previously given in general meeting, increase its capital.

22. Any capital raised by the creation of new shares shall be considered as part of the original capital, and shall be subject to the same provisions in all respects, whether with reference to the payment of calls, or the forfeiture of shares on non-payment of calls, or otherwise, as if it had been part of the original capital.

GENERAL MEETINGS.

23. The first general meeting shall be held at such time not being more than twelve months after the incorporation of the Company, and at such place as the Directors may determine.

24. Subsequent general meetings shall be held at such time and place as may be prescribed by the Company in general meeting ; and if no other time or place is prescribed, a general meeting shall be held on the day of in every year, at such

place as may be determined by the Directors.

25. The abovementioned general meetings shall be called ordinary meetings; all other general meetings shall be called extraordinary.

26. The Directors may, whenever they think fit, and they shall, upon a requisition made in writing by any number of shareholders holding in the aggregate not less than one-fifth part of the shares of the Company, convene an extraordinary general meeting.

27. Any requisition so made by the shareholders shall express the object of the meeting proposed to be called, and shall be left at the registered office of the Company.

23. Upon the receipt of such requisition the Directors shall forthwith proceed to convene a general meeting: if they do not proceed to convene the same within twenty-one days from the date of the requisition, the requisitionists, or any other shareholders holding the required number of shares, may themselves convene a meeting.

29. Seven days' notice at the least, specifying the place, the time, the hour of meeting, and the purpose for which any general meeting is to be held, shall be given by advertisement, or in such other manner, if any, as may be prescribed by the Company.

30. Any shareholder may, on giving not less than three days' previous notice, submit any resolution to a meeting beyond the matters contained in the notice given of such meeting.

31. The notice required of a shareholder shall be given by leaving a copy of the resolution at the registered office of the Company.

32. No business shall be transacted at any meeting, except the declaration of a dividend, unless a quorum of shareholders is present at the commencement of such business, and such quorum shall be ascertained as follows: (that is to say,) if the shareholders belonging to the Company at the time of the meeting do not exceed ten in number, the quorum shall be five; if they exceed ten, there shall be added to the above quorum one for every tive additional shareholders up to fifty, and one for every ten additional shareholders after fifty, with this limitation, that it shall not be necessary for any quorum in any case to exceed forty.

33. If within one hour from the time appointed for the meeting the required number of shareholders is not present, the meeting, if convened upon the requisition of shareholders, shall be dissolved: in any other case it shall stand adjourned to the following day at the same time and place; and if at such adjourned meeting the required number of shareholders is not present, it shall be adjourned sine die.

34. The Chairman (if any) of the Board of Directors shall preside as Chairman at every meeting of the Company.

35. If there is no such Chairman, or if at any meeting he is not present at the time of holding the same, the shareholders present shall choose some one of their number to be Chairman of such meeting.

36. The Chairman may, with the consent of the meeting, adjourn any meeting from time to time and from place to place; but no business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.

37. At any general meeting, unless a poll is demanded by at least five shareholders, a declaration by the Chairman that a resolution has been carried, and an entry to that effect in the book of proceedings of the Company, shall be sufficient evidence of the fact, without proof of the number or proportion of the votes recorded in favour of or against such resolution.

38. If a poll is demanded in manner aforesaid, the

same shall be taken in such manner as the Chairman directs; and the result of such poll shall be deemed to be the resolution of the Company in general meeting.

VOTES OF SHAREHOLDERS.

39. Every shareholder shall have one vote for every share up to ten; he shall have an additional vote for every five shares beyond the first ten shares up to one hundred, and an additional vote for every ten shares held by him beyond the first hundred shares.

40. If any shareholder is a lunatic or idiot, he may vote by his Committee; and if any shareholder is a minor, he may vote by his guardian, or any one of his guardians if more than one.

41. If more persons than one are jointly entitled to a share or shares, the person whose name stands first in the Register of shareholders as one of the holders of such share or shares, and no other, shall be entitled to . vote in respect of the same.

42. No shareholder shall be entitled to vote at any meeting unless all calls due from him have been paid, nor until he shall have been possessed of his shares three calendar months, unless such shares shall have been acquired or shall have come by bequest, or by marriage, or by succession to an intestate's estate, or by any deed of settlement after the death of any person who shall have been entitled for life to the dividends of such shares.

43. Votes may be given either personally or by proxies : a proxy shall be appointed in writing under the hand of the appointor, or, if such appointor is a corporation, under their common seal.

44. No person shall be appointed a proxy who is not a shareholder, and the instrument appointing him shall be deposited at the registered Office of the Company not less than forty-eight hours before the time of holding the meeting at which he proposes to vote; but no instrument appointing a proxy shall be valid after the expiration of one month from the date of its execution.

DIRECTORS.

45. The number of the Directors, and the names of the first Directors, shall be determined by the subscribers of the memorandum of association.

46. Until Directors are appointed, the subscribers of the memorandum of association shall, for all the purposes of this Act, be deemed to be Directors.

POWERS OF DIRECTORS.

47. The business of the Company shall be managed by the Directors, who may exercise all such powers of the Company as are not by this Act, or by the articles of association, if any, declared to be exercisable by the Company in general meeting, subject nevertheless to any regulations of the articles of association, to the provisions of this Act, and to such regulations, not being inconsistent with the aforesaid regulations or provisions, as may be prescribed by the Company in general meeting; but no regulation made by the Company in general meeting shall invalidate any prior act of the Directors which would have been valid if such regulation had not been made.

DISQUALIFICATION OF DIRECTORS.

48. The office of Director shall be vacated-

If he holds any other office or place of profit under the Company;

If he becomes bankrupt or insolvent;

If he is concerned in or participates in the profits of any contract with the Company;

If he participates in the profits of any work done for the Company :

But the above rules shall be subject to the following exceptions: that no Director shall vacate his office by reason of his being a shareholder in any incorporated Company, which has entered into contracts with or done any work for the Company of which he is Director; nevertheless he shall not vote in respect of such contract or work; and if he does so vote, his vote shall not be counted, and he shall incur a penalty not exceeding Five hundred Rupees.

ROTATION OF DIRECTORS.

49. At the first ordinary meeting after the incorporation of the Company, the whole of the Directors shall retire from office; and at the first ordinary meeting in every subsequent year, one-third of the Directors for the time being, or if their number is not a multiple of three, then the number nearest to one-third, shall retire from office.

50. The one-third or other nearest number⁶ to retire during the first and second years ensuing 'the incorporation of the Company shall, unless the Directors agree among themselves, be determined by ballot : in every subsequent year the one-third or other nearest number who have been longest in office shall retire.

51. A retiring Director shall be re-eligible.

52. The Company, at the general meeting at which any Directors retire in manner aforesaid, shall fill up the vacated offices by electing a like number of persons.

53. If at any meeting at which an election of Directors ought to take place no such election is made, the meeting shall stand adjourned till the next day, at the same time and place; and if at, such adjourned meeting no election takes place, the former Directors shall continue to act until new Directors are appointed at the first ordinary meeting of the following year.

54. The Company may from time to time, in general meeting, increase or reduce the number of Directors, and may also determine in what rotation such increased or reduced number is to go out of office.

55. Any casual vacancy occurring in the Board of Directors may be filled up by the Directors, but any person so chosen shall retain his office so long only as the vacating Director would have retained the same if no vacancy had occurred.

PROCEEDINGS OF DIRECTORS.

56. The Directors may meet together for the despatch of business, adjourn, and otherwise regulate their meetings as they think fit, and determine the quorum necessary for the transaction of business: questions arising at any meeting shall be decided by a majority of votes: in case of an equality of votes the Chairman, in addition to his original vote, shall have a casting vote; a Director may at any time summon a meeting of the Directors.

57. The Directors may cleet a Chairman of their meetings, and determine the period for which he is to hold office; but if no such Chairman is elected, or if at any meeting the Chairman is not present at the time appointed for holding the same, the Directors present shall choose some one of their number to be Chairman of such meeting.

58. The Directors may delegate any of their powers to Committees consisting of such member or members of their body as they think fit : any Committee so formed shall, in the exercise of the powers so delegated, conform to any regulations that may be imposed on them by the Directors.

59. A Committee may elect a Chairman of their meetings: if no such Chairman is elected, or if he is not present at the time appointed for holding the same, the members present shall choose one of their number to be Chairman of such meeting.

60. A Committee may meet and adjourn as they think proper: questions at any meeting shall be determined by a majority of votes of the members present; and in case of an equal division of votes the Chairman shall have a casting vote.

61. All acts done by any meeting of the Directors, or of a Committee of Directors, or by any person acting as a Director, shall, notwithstanding that it be afterwards discovered that there was some defect in the apſ

pointment of any such Directors or persons acting as aforesaid, or that they or any of them were disqualified, be as valid as if every such person had been duly appointed and was qualified to be a Director.

62. The Directors shall cause minutes to be made in books provided for the purpose—

1. Of all appointments of Officers made by the Directors;

2.° Of the names of the Directors present at each infecting of Directors and Committees of Directors ;

3. Of all orders made by the Directors and Committees of Directors ; and,

4. Of all resolutions and proceedings of meetings of the Company, and of the Directors and Committees of Directors.

And any such minute as aforesaid, if signed by any person purporting to be the Chairman of any meeting of Directors, or Committee of Directors, shall be receivable in evidence without any further proof.

63. The Company, in general meeting, may, by a special resolution, remove any Director before the expiration of his period of office, and appoint another qualified person in his stead : the person so appointed shall hold office during such time only as the Director in whose place he is appointed would have held the same if he had not been removed.

DIVIDENDS.

64. The Directors may, with the sanction of the Company in general meeting, declare a dividend to be paid to the shareholders in proportion to their shares.

65. The Directors may, before recommending any dividend, set aside out of the profits of the Company such sum as they think proper as a reserved fund, to meet contingencies, or for equalising dividends, or for repairing, or maintaining the works connected with the business of the Company, or any part thereof; and the Directors may invest the sum so set apart as a reserved fund upon such securities as they, with the sanction of the Company, nay select.

66. The Directors may deduct from the dividends payable to any shareholder all such sums of money as may be due from him to the Company on account of calls or otherwise.

67. Notice of any dividend that may have been declared shall be given to each shareholder, or sent by post, or otherwise to his registered place of abode, and all dividends unclaimed for three years, after having been declared, may be forficited by the Directors for the benefit of the Company.

68. No dividend shall bear interest as against the Company.

ACCOUNTS.

69. Once at the least in every year the Directors shall lay before the Company in general meeting a statement of the income and expenditure for the past year, made up to a date not more than three months before such meeting.

70. The statement so made shall show, arranged under the most convenient heads, the amount of gross income, distinguishing the several sources from which it has been derived, and the amount of gross expenditure, distinguishing the expense of the establishment, salaries, and other like matters; every item of expenditure fairly chargeable against the year's income shall be brought into account, so that a just balance of profit and loss may be laid before the meeting; and in cases where any item of expenditure which may in fairness be distributed over several years has been incurred in any one year, the whole amount of such item shall be stated, with the addition of the reasons why only a portion of such expenditure is charged against the income of the year.

71. A balance-sheet shall be made out in every year, and laid before the general meeting of the Company; and such balance-sheet shall contain a summary of the 6 property and liabilities of the Company arranged under the heads appearing in the Form annexed to this Table, or as near thereto as circumstances admit.

72. A printed copy of such balance-sheet shall, seven days previously to such meeting, be delivered at or sent by post to the registered address of every shareholder.

AUDIT.

73. The accounts of the Company shall be examined, and the correctness of the balance-sheet ascertained by one or more Auditor or Auditors to be elected by the Company in general meeting.

74. If not more than one Auditor is appointed, all the provisions herein contained relating to Auditors shall apply to him.

75. The Auditors need not be shareholders in the Company: no person is eligible as an Auditor who is interested otherwise than as a shareholder in any transaction of the Company; and no Director or other officer of the Company is eligible, during his continuance in office.

76. The election of Auditors shall be made by the Company at their ordinary meeting, or, if there are more than one, at their first ordinary meeting in each year.

77. The remuneration of the Auditors shall be fixed by the Company at the time of their election.

78. Any Auditor shall be re-eligible on his quitting office.

79. If any casual vacancy occurs in the office of Auditor, the Directors shall forthwith call an extraordinary general meeting for the purpose of supplying the same.

80. If no election of Auditors is made in manner aforesaid, the local Government may, on the application of one-fifth in number of the shareholders of the Company, appoint an Auditor for the current year, and fix the remuneration to be paid to him by the Company for his services.

81. Every Auditor shall be supplied with a copy of the balance-sheet, and it shall be his duty to examine the same, with the accounts and vouchers relating thereto.

82. Every Auditor shall have a list delivered to him of all books kept by the Company, and he shall at all reasonable times have access to the books and accounts of the Company; he may, at the expense of the Company, employ accountants or other persons to assist him in investigating such accounts, and he may in relation to such accounts examine the Directors or any other officer of the Company.

83. The Auditors shall make a report to the shareholders upon the balance-sheet and accounts; and in every such report they shall state whether, in their opinion, the balance-sheet is a full and fair balancesheet, containing the particulars required by these regulations, and properly drawn up so as to exhibit a true and correct view of the state of the Company's affairs; and in case they have called for explanations or information from the Directors, whether such explanations or information have been given by the Directors, and whether they have been satisfactory; and such report shall be read, together with the report of the Directors, at the ordinary meeting.

NOTICES.

84. Notices requiring to be served by the Company upon the shareholders may be served either personally, or by leaving the same, or sending them through the post in a letter addressed to the shareholders, at their registered places of abode.

85. All notices directed to be given to the shareholders shall, with respect to any share to which persons are jointly entitled, be given to whichever of the said persons is named first in the Register of shareholders; and notice so given shall be sufficient notice to all the proprietors of such share.

1. Tenders of GOLD OF SILVER BULLION will be received from individuals at the Bombay Mint, between the hours of 10 A. M. and 3 P. M. daily (Sundays and Holidays excepted), provided the parcel of Gold is of not less than Fifty Tolas weight, and of Silver One thousand Tolas weight, and provided it be of a malleable quality, adapted for coinage.

2. Bullion or Coin must be tendered by the proprietor in the following form, lithographed copies of which will be supplied on application at the Mint :---

beg to tender for coinage, at the Mint rate, the undermentioned Bullion, for which you will have the goodness to grant me a Certificate, payable at the Treasury at Twenty days' sight after the Bullion has been received and registered, and its actual out-turn value ascertained at the Mint.

3. All Gold and Silver Bullion and Coins that may be tendered to the Mint for coinage must be melted and cast into Bars by the Mint Premelting Establishment, prior to their being received or assayed.

4. No transfer of Bullion from the name of one proprietor to that of another can be permitted after it has once been tendered to the Mint. No Bullion can be withdrawn previous to registry, except sweepings and spillages of Bullion actually melted, without the payment of a fee of Rupees two for each Pass prepared for the purpose.

5. It is to be understood that, until the Bullion or Goin has been thus delivered at the Mint Scales in the Bullion Receiving Room, it is in the custody and at the risk of the importer, to whom, however, every facility shall be afforded for securing it in the Bullion Strongholds.

6. On the receipt of the Assay Report, an account current, which has been verified by the Assistant Bullion Keeper, showing the produce of the Bullion or Coin with reference to its weight and value, after deducting the authorised amount of Mint Duty, of Refining and of Premelting charges, shall be submitted to the importer for his examination and signature, when a Bullion Certificate on the General Treasury, prepared in the Mint Master's Office, shall be delivered to him, authorising the holder to receive the amount at (20) twenty days' sight. 7. The Seignorage on Gold Bullion or Coin shall be at one per cent. of the standard value. The Seignorage on Sicca Rupees shall be one per cent. There shall be no Seignorage on short weight Madras, Furruckabad, or Company's Rupees.

The Seignorage on all other descriptions of Silver Coins and Bullion shall be two per cent.

8. The Refinage charge on Silver below six dwts. in assay worse than the Indian Standard shall be at the rate of 4 per cent. per dwt. of worseness. The Refinage charge on Gold shall be at the rate of one-half per cent. for every five carat grains of worseness below the Indian Standard.

9. The Premelting charge on Gold shall be at the rate of Company's Rupees three and annas twelve per one thousand tolas of Standard Gold, and on Silver at the rate of one Company's Rupee per one thousand standard tolas.

10. Importers of Bullion or Coin shall be at liberty to withdraw the same after registry, within the day following the receipt of the Assay Report, but at no later period, on payment of an Assay fee of four Rupees for each Assay of Gold, and two Rupees for each Assay of Silver; and the Premelting charges above mentioned in the event of the Bullion tendered having been premelted.

11. Should Bullion, after being premelted, prove to be brittle, and not adapted for coinage, it shall be returned to the proprietor, and passed out of the Mint, under a written Pass signed by the Mint Master, and by the Assistant Bullion Keeper, and the proprietor shall pay the charge for premelting the same at the prescribed rate calculated on the gross weight in tolas.

DIRECTIONS

FOR APPROACHING THE SAND HEADS IN BOTH MONSOONS.

SOUTH-WEST MONSOON.

The South-West Monsoon may be considered to commence on the 15th March, on which date the Pilot Vessels take up their, station near the buoy on the Pilot's Ridge as described below. The South-West Monsoon is over by the end of September.

2nd.—False Point Light House is in latitude 20° 1914' north, and longitude 86° 47' east; and a buoy is placed in 211 fathoms on the Pilot's Ridge, in latitude 20° 4914' north, and longitude 87° 42' east: the buoy therefore bears from False Point Light House north 59° 49' east, true, and distant 592 miles.

3rd.—A vessel, therefore, after making the Light House at False Point (in passing which she ought not to go into less than 10 fathoms) should bring it to bear about west-south-west 10 or 15 miles distant, when she will be in 11 or 12 fathoms; then steer east-north-eastward, when the soundings will gradually increase to 23 fathoms on the eastern edge of the Pilot's Ridge: she should then regulate her course so as to keep between the Ridge and 27 fathoms, when, by attention to the lead and nature of the soundings, course and distance run from the Light House, it is almost impossible to avoid making the Pilot Vessels, as their cruizing ground is immediately to the northeast of the Light Vessel stationed during the South-West Monsoon in close proximity to the buoy on the Ridge.

4th.—The soundings to seaward of the Pilot's Ridge are, in general, a greenish or olive-coloured mud, with occasionally a few bits of broken shells mixed with it; whilst those on the Ridge are of a shelly sand, or minute gravel, of a reddish or rusty brown colour.

5th.—Vessels approaching the station are earnestly warned to be careful in avoiding collision when communicating with either the Light, or supplying Pilot Vessels ; and, on making the former at night, they are strongly recommended to heave to, at a proper distance, till day-light, by which measure they will avoid the probability of passing the supplying Pilot Vessels in the darkness of the night.

6th.—The Eastern Channel Light Vessel is in latitude 21° 4' north, and longitude 881° 14' east, and therefore bears from the buoy on the Pilot's Ridge north 63° 26' east, true; and distant 324 miles. The Eastern Channel Light Vessel, from the 15th March to the 15th September, burns a blue light every half hour and a maroon every quarter hour during the night, commencing at 7 r. M.; and her standing light is a plain light.

7th.—The Pilot's Ridge Light Vessel shows from the 15th March to the 15th September a plain standing light, and burns a blue light every hour, and a maroon at the intermediate half hours.

8th.—It is important to observe the difference as to the blue lights and maroons shown by the Eastern Channel and the Ridge Light respectively, as, if this is attended to, a vessel, out in her reckoning, or uncertain of her position, cannot possibly mistake one for the other.

THE NORTH-EAST MONSOON.

9th.—This monsoon, which constitutes the fine season in the head of the Bay of Bengal, is considered to commence in October and end in the beginning of March. During this season the

Pilot Station is about the Outer Floating Light situated in the Eastern Channel as above, and vessels coming in should make directly for that mark. The Pilot Vessels cruize in the day-time spreading east and west of, sometimes a little to the southward of, the Light Vessel; and at night anchor in positions not far from her. At this season she shows a maroon or torch-light every half hour and a blue light every hour.
