SUMMARIES OF CONSTRUCTIONS OF INCOME TAX ACTS XXXII. AND XXXIX. OF 1860.

No. 111.

Society,

Religious and Charitable, Government Securities belonging to, though held in the name of a private individual, exempted from Income Tax.

Act XXXII. of 1860, Section CXXXIII.

Under Section CXXXIII., Act XXXII. of 1860, certain Government Securities, though standing in the name of a private individual, were exempted by the Governor General of India in Council, on the recommendation of the Political Agent at Kattywar, from the payment of Income Tax, on proof that they belonged to a Religious Institution and were assigned for charitable purposes.

A similar application in favor of other Government Securities also standing in the name of a private individual, but belonging to an Educational Institution (a private Girls' School at Rajcote) was refused.—(Financial Department Order, No. 5922, dated 18th May 1861.)

II .- The Receipt will be drawn in favour of the remitter only, who will transfer it to the payee by a crossed entry on the face of the document. No Advice will be issued for Transfer

III .- Payment will be made on presentation at the Treasury indicated in the Receipt, either in cash or by a transfer credit to some account to be noted by the remitter on the back of the Receipt. Each Receipt will bear the signatures of two Officers of Government, the drawer and the remitter, and further protection will be afforded by the printed form on water-marked paper. The Payee's receipt on the back of the document will be a final acquittance to the Treasury Officer drawn upon. At the close of every month, a list of Transfer Receipts issued during the month, giving numbers, dates, and amounts, will be forwarded by the drawer to the drawee, for check with his register of payments.

IV .- The same form of Receipt will be used whenever practicable for the settlement of transactions between Executive Officers of the Military Department within the limits defined by

the President of the Military Finance Department.

V .- For all privilege remittances, Civil and Military, now allowed to Officers and Establishments, and for all remittances on account of Service Funds, under the orders in force, non-negotiable Transfer Receipts, with a separate annual series of numbers of each Treasury drawn upon, will be issued in the following form :-

VI.—Privilege Transfer Receipts will be issued in favour of the party named by the remitter, only at the time of payment of allowances and in liquidation thereof, and not in exchange for Cash separately tendered. The cancellation of Transfer Receipts, both for Service and privilege remitances, will be effected under the Rules provided for the cancellation of Bills of Exchange.

VII.—The Transfer Receipts for Privilege Remittances of Military Officers, and of the European and Native Soldiers, will be issued by Pay-masters exclusively, and in no case by a Civil Treasury.

VIII.—The Remittances of Military Officers will be made in the form of Transfer Receipt for Privilege Remittances above prescribed. The Family Remittances of Sepoys will be made in the following form, with a distinct annual series of numbers for each Treasury drawn upon:—

IX. Every Commanding Officer will forward to the Pay-master of the Division, with the monthly abstracts of his Corps, a requisition for the Transfer Receipts required. The Pay-master on the issue of pay, will forward the required Transfer Receipts to the Commanding Officer, who Drafts.

X.—A remittance list of Transfer Receipts issued for Privilege Remittances of Officers will be forwarded on the day of issue by the Drawing Officer to the Drawee as an Advice; and this list will also serve as a Check Register, in which the payment of such Receipts will be duly noted. XI.—A separate remittance list in the same form for Sepoys' Remittances will be forwarded on the day of issue to the drawee.

XII.—Payment of Privilege Transfer Receipts will be made only after receipt of the Remittance list. The acknowledgment of the payee will be taken on the back of the Receipt, which will then form a voucher for the charge in the Disbursing Officer's Account Current.

XIII.—Scroys' Remittance Receipts will be current for six months only. Remittances unpaid at the expiration of six months from the date of the Receipt will be cancelled in the Remittance list recorded in the Office of the Treasury drawn upon, and if presented after that period payment will be refused. The uncurrent Receipt must be returned to the drawer for the issue of a fresh Receipt, or for the refund of the amount, as may be required.

XIV.—In the Monthly Cash Accounts of Treasury Officers, the issue and payment of Transfer Receipts will be exhibited under the heads of "Public Service Remittances," and "Privilege Remittances," respectively. The Transfer Receipts bearing the acknowledgments of the payees must accompany the Disbursing Officer's Treasury Account, with a list of sums paid under each of the above heads, showing by whom drawn and the No. and amount of each Receipt, and a total corresponding with the aggregate amount, entered in the Account Gurrent.

XV.—The existing arrangements will continue for Supply Bills of Exchange issued to the Public or to Officers of Government in their private capacity; but all transactions of this nature will be exhibited in future in the Treasury Accounts under the uniform head of "Supply Bills," in lieu of the heads now employed.

It is thought that some withhold their assistance through the notion that reports of the single casualties coming now and then under their observation could but little affect the Returns; but it ought rather to be borne in mind, that the accuracy of the Returns depends on the correct reporting of all single cases, for of such only the aggregate is made up.

REPORT ON THE FAMINE OF 1860-61.

SECTION I.

DESCRIPTIVE DETAILS.

From Colonel R. BAIRD SMITH, C.B., On Special Duty,

To WILLIAM GREY, Esquire,

Secretary to the Government of India, Home Department.

Dated Roorkee, the 25th May 1861.

Sir,-I have the honour to submit, for the consideration of His Excellency the Viceroy and Governor General in Council, the following Report on the general condition of those parts of the North-Western Provinces and the Punjaub which are now suffering from drought, and of which I have recently completed an inspection tour.

2. Chart No. 1 attached hereto, shows the route taken by me through the suffering Districts. On it are also noted the number of days I was able to devote to inquiries at each important point. Districts were invariably traversed in the day-time, so that as much as possible might be seen of the condition of their crops and people. It being necessary, with limited time and means of observation, to judge of certain points by samples only, care was taken to select such samples as should be as characteristic as possible of the points concerned. To examine personally, for example, all the bad parts even of one District, was plainly impracticable, but to see some of the very worst parts of the suffering Districts was essential to my object; and to meet this want, sample-localities were chosen and carefully inspected. With the people themselves I held the freest possible communication, extending my inquiries among all grades; from the labourer I found working toilfully at his well, to the Native gentleman of large property. The nature of found working toilfully at his well, to the Native gentleman of large property. The nature of my service in these Provinces through so many years had thrown me specially in contact with the agricultural classes, and nearly all the localities visited by me now had been familiar to me in past years, so that I was well able to contrast their actual with their previous condition. From the District Officers of every District, I received the amplest and most cordial aid, all their abundant stores of local knowledge and experience being freely tendered for my use. I sought evidence also from European gentlemen having property of their own in the suffering Districts; from Officers on the Railway works whose daily duties kept them in the midst, of some of the Districts where the pressure was heaviest; from Officers of the Irrigation Department who had many opportunities, as they carried new lines of water channels through the most parched tracts of the country, of judging of the actual state of the people from personal observation; from Officers in charge of special relief works; from traders having wholesale dealings with the farmers, and from all others with whom I had opportunities of communicating, whose evidence had any special value. Such statistical statements as I found it necessary to ask for have been freely supplied; and, on the whole, I believe that the broad basis on which the conclusions I shall have to state are founded, give them fair claim to accuracy and confidence. The investigation of so large a subject is, however, a matter of very great difficulty; and though I have perfect confidence myself in the general soundness of the judgments I have formed, I cannot expect them to be accepted by others without some such details as I have just given of the sources whence the materials for them have been drawn.

- 3. In speaking hereafter of the districts where the drought has been most severely felt, I propose to call them collectively the Famine Tract; meaning thereby the whole area within which extraordinary measures for the relief of the population from the effects of dearth of food have been necessary. There are several districts bordering on the Famine Tract where suffering has been considerable, and where even some means, beyond those ordinarily used to lighten such pressure, have been resorted to; but the suffering is not such as fairly to bring these localities inside the Famine Tract proper, and I have accordingly excluded them. Again there are bordering Districts in which extraordinary relief measures have been used to a very large extent, and heavy local expense incurred, although there is not a single inhabitant of those Districts probably who has suffered from the pressure of want due to the drought. The strain on them has arisen exclusively from their having become the recipients of part of the population of the Famine Tract, forced into them by the grievous pressure in the homes they had abandoned. This is particularly the case with the Districts on the Grand Trunk Road in the lower Section of the Doab; and though they have had a magnificent harvest generally, and their own people are in comfort and prosperity, they have yet had to support, and most generously they have supported, a large mass of pauperism. Such Districts are, of course, excluded from the Famine Tract proper.
- 4. As thus limited and defined, the Famine Tract is very distinctly marked. It is represented in Chart No. II. attached to this report, and its boundaries may be thus briefly described. Nature has provided for its sub-division into three separate sections by physical differences of surface, climate, and peculiarities of sub-soil, so characteristic, that adoption of this natural division is equally necessary and convenient.
- 5. These Sub-divisions are,—1st. The Western, which lies wholly on the right bank of the River Jumna. It includes the Cis-Sutlej Districts of Umballa and Thanaesur, within parts of which the want of water has told very severely. The richly irrigated District of Paneeput and the Northern (Pergunna) Sub-division of the Delhi District have virtually escaped all injury by reason, firstly, of their being traversed by the Western Jumna Canal; next of the continued drought having relieved them from the broad areas of swamp by which they are ordinarily infested, and having turned these useless lands into productive fields; and last, of the low damp valley lands bordering the Jumna having been also dried so as to become culturable, and to give an abundant produce. These resources have sufficed to mitigate pressure where it may have shown itself, and over by far the largest part of the area indicated they have guaranteed wealth and abundance. South of Delhi, and along through its Southern Sub-division, through the Bullubgurh lands, and over nearly the whole of the District of Goorgaon, the misery of the people shows deepest and darkest of any part of the whole Famine Tract. It is this part of the Western Section of the tract which gives it its most definite characteristics. Under even the best circumstances, having a rain-fall never rising beyond two-thirds, and often falling below one-third of that in the Districts of the Doab, and while thus deficient being also most uncertain and precarious, its ordinary condition is a sort of chronic drought. Its soil is generally so light as to feel sensitively the want of rain; its sub-soil waters are very liable to be brackish; the depth of the water-table of the country, or the stratum to which wells must be carried down to secure a continuous supply, is generally very great; a considerable portion of the area is of bleak and barren rocks or deep ravines; the drainage is under indifferent control, and the rivers sometimes run as wild as those of the Pontine marshes or the Tuscan Maremma. The country was greatly harassed and disturbed during the mutiny from its vicinity to Delhi, and its complete occupation for long by the mutinous troops. Altogether it might have been expected that in a drought so bitter as the present, this part of the Famine Tract would, from natural, political, and also in some measure from social causes (certain sections of its population being very turbulent and unmanageable), show a deeper shade of suffering than elsewhere, and such has no doubt been the case.

Passing beyond Goorgaon, the Western Section leaves the Punjaub and enters the North-Western Provinces, including the whole of that part of the District of Muttra which lies West of the River, and here too the suffering has been very intense, though relief has been sought by the people in spontaneous emigration to an extent unequalled perhaps in any other District. It then takes in Agra, including, however, only one Sub-division (Pergunna) named Furrah. Westward of the River, and on the Southern boundary of that Sub-division, the Famine Tract West of the Jumna terminates. Below this line the pressure is not so great as to require any extraordinary expedients, except at the City of Agra itself, which is in an exceptional position, lying just on the very boundary line of the true Famine Tract. The Jumna on the East, and the base of the Himalayas on the North, complete the boundaries of this section.

6. 2nd .- The Central Section lying wholly between the rivers Jumna and Ganges, presents a very different aspect to the foregoing. Under ordinary cicumstances it is one of the richest sections of these Provinces. Having a large proportion of its landed proprietary belonging to tribes known for their devotion to, and skill in, agricultural pursuits, its cultivated area has been progressively encroaching on its waste lands ever since the public demand was permanently settled. The latest measurement shows that in periods varying from 12 to 5 years rather more than half a million acres of new land had been added to its productive area. Falling away from the base of the Himalayas with a gentle and continuous slope its surface presents none of those rugged features so common in the Western Section of the tract. Its hydrography is regular, as might be expected, from the regularity of its fall and surface. All its drainage is gathered into definite channels; wastes of swampy land are rare; the great boundary streams receive and carry off its surplus waters; and, excepting in the extreme North, water is usually in its right place as the slave of man, and not his tyrant. The soil is generally good, often of the richest kind. The level of the water bearing stratum, which is so infinitely important to the agriculture of the section, is high, and of late years has, over broad areas, been raised higher by the influence of percolation from the canals of irrigation and their numerous channels. In means of artificial irrigation, this section far surpasses any other part of the Provinces. Its Districts are plentifully studded with masonry wells, and what is perhaps even more important, they possess in the vicinity of the sub-soil water to the surface, and the general tenacity of the sub-soil itself, facilities for the multiplication of temporary wells to an extent only limited by the quantity of labour available for sinking them. In such a time as the present such facilities imply to all, except the worst cultivating tribes, security from actual want at any rate, if not more. The ordinary rain-fall ranges from 30 to 36 inches, and in favourable years is so distributed, that about four-fifths of the whole falls between June and September, or the early part of October, and the remaining one-fifth between October and March. The most characteristic feature of this section, in reference to irrigation, however is the large canals by which it is traversed. These have not reached a tithe of the development that waits them, as the various channels under construction are brought to completion, although, even now in their incomplete state their action for good, both as insurances against loss of produce and stimulants to increased production, has been energetic in the highest degree.

So favoured then with a preponderance of agriculturists who rise to face their difficulties with a vigorous industry, with a plentiful rain-fall, supplemented by a great mechanism of artificial irrigation in the forms of permanent or temporary wells and large canals; with physical conditions all well adapted to insure a healthy agricultural progress; intersected too by the best roads known in India, and thus open to receipts of food from distant parts, it might have been anticipated that when a period of heavy pressure came, this Central Section would develope a power of resistance proportioned in some degree to these, its great and manifold advantages. Such a power of resistance has, I believe, been shown in remarkable intensity, as I shall have occasion to prove more definitely hereafter; and heavy as the sufferings in some parts of the section have been, they would have been very much heavier but for the mitigating causes just indicated.

The boundaries of the Central Section are—on the North the base of the mountains, on the East the Ganges, and on the West the Jumna. The Southern boundary line crosses the Jumna at Agra, and includes two Sub-divisions (or Pergunnas) of that District on the left bank of the River, called respectively Khundowlee and Ferozabad. It then traverses part of the Mynpooree District, where it also includes only two Sub-divisions named Shekoabad and Moostaffabad; continuing Eastward, it strikes on the Northern boundary of the District of Futtehgurh, and follows it until it meets the Ganges. It thus includes the following Districts of the Upper Doab falling within the Agra and Meerut Divisions:—

Two Sub-divisions of the Agra District.

Two Sub-divisions of the Mynpooree District, Allygurh.

Five Sub-divisions of the Muttra District, Boolundshuhur, Meerut, Mozuffurnugger, and Saharunpoor.

7. 3rd.—The Eastern Section lying entirely on the left bank of the River Ganges, and having special characteristics quite as marked as those of either of the other two sections, falls exclusively within the Province of Rohilkund, and includes three Districts of that Province, viz:

Budaon.

Moradabad.

Bijnour.

Here the sub-soil water is so near to the surface, that artificial irrigation is used to a comparatively limited extent. The rain-fall is large, generally from 36 to 40 inches; the climate perennially much more moist than it is Westward of the Ganges. The soil retains moisture well; and is in other respects generally good, producing Sugar and Rice, the great staples of the Province, in rich abundance. Food grains other than rice are grown only for internal consumption, and not always in sufficient abundance for that. As illustrative of the most marked distinction between the agricultural condition of the Central and Eastern Sections of the Famine Tract, I may note from a return now before me, that while the former possesses fully 70,000 masoury wells, or the equivalents of such wells, the whole Province of Rohilkund is represented as having less than

Officers in charge of special relief works; from traders having wholesale dealings with the farmers, and from all others with whom I had opportunities of communicating, whose evidence had any special value. Such statistical statements as I found it necessary to ask for have been freely supplied; and, on the whole, I believe that the broad basis on which the conclusions I shall have to state are founded, give them fair claim to accuracy and confidence. The investigation of so large a subject is, however, a matter of very great difficulty; and though I have perfect confidence myself in the general soundness of the judgments I have formed, I cannot expect them to be accepted by others without some such details as I have just given of the sources whence the materials for them have been drawn.

- 3. In speaking hereafter of the districts where the drought has been most severely felt, I propose to call them collectively the Famine Tract; meaning thereby the whole area within which extraordinary measures for the relief of the population from the effects of dearth of food have been necessary. There are several districts bordering on the Famine Tract where suffering has been considerable, and where even some means, beyond those ordinarily used to lighten such pressure, have been resorted to; but the suffering is not such as fairly to bring these localities inside the Famine Tract proper, and I have accordingly excluded them. Again there are bordering Districts in which extraordinary relief measures have been used to a very large extent, and heavy local expense incurred, although there is not a single inhabitant of those Districts probably who has suffered from the pressure of want due to the drought. The strain on them has arisen exclusively from their having become the recipients of part of the population of the Famine Tract, forced into them by the grievous pressure in the homes they had abandoned. This is particularly the case with the Districts on the Grand Trunk Road in the lower Section of the Doab; and though they have had a magnificent harvest generally, and their own people are in comfort and prosperity, they have yet had to support, and most generously they have supported, a large mass of pauperism. Such Districts are, of course, excluded from the Famine Tract proper.
- 4. As thus limited and defined, the Famine Tract is very distinctly marked. It is represented in Chart No. II. attached to this report, and its boundaries may be thus briefly described. Nature has provided for its sub-division into three separate sections by physical differences of surface, climate, and peculiarities of sub-soil, so characteristic, that adoption of this natural division is equally necessary and convenient.
- These Sub-divisions are, -1st. The Western, which lies wholly on the right bank of the River Jumna. It includes the Cis-Sutlej Districts of Umballa and Thanaesur, within parts of which the want of water has told very severely. The richly irrigated District of Paneeput and the Northern (Pergunna) Sub-division of the Delhi District have virtually escaped all injury by reason, firstly, of their being traversed by the Western Jumna Canal; next of the continued drought having relieved them from the broad areas of swamp by which they are ordinarily infested, and having turned these useless lands into productive fields; and last, of the low damp valley lands bordering the Jumna having been also dried so as to become culturable, and to give an abundant produce. These resources have sufficed to mitigate pressure where it may have shown itself, and over by far the largest part of the area indicated they have guaranteed wealth and abundance. South of Delhi, and along through its Southern Sub-division, through the Bullubgurh lands, and over nearly the whole of the District of Goorgaon, the misery of the people shows deepest and darkest of any part of the whole Famine Tract. It is this part of the Western Section of the tract which gives it its most definite characteristics. Under even the best circumstances, having a rain-fall never rising beyond two-thirds, and often falling below one-third of that in the Districts of the Doab, and while thus deficient being also most uncertain and precarious, its ordinary condition is a sort of chronic drought. Its soil is generally so light as to feel sensitively the want of rain; its sub-soil waters are very liable to be brackish; the depth of the water-table of the country, or the stratum to which wells must be earried down to secure a continuous supply, is generally very great; a considerable portion of the area is of bleak and barren rocks or deep ravines; the drainage is under indifferent control, and the rivers sometimes run as wild as those of the Pontine marshes or the Tuscan Maremma. The country was greatly harassed and disturbed during the mutiny from its vicinity to Delhi, and its complete occupation for long by the mutinous troops. Altogether it might have been expected that in a drought so bitter as the present, this part of the Famine Tract would, from natural, political, and also in some measure from social causes (certain sections of its population being very turbulent and unmanageable), show a deeper shade of suffering than elsewhere, and such has no doubt been the case.

Passing beyond Goorgaon, the Western Section leaves the Punjanb and enters the North-Western Provinces, including the whole of that part of the District of Muttra which lies West of the River, and here too the suffering has been very intense, though relief has been sought by the people in spontaneous emigration to an extent unequalled perhaps in any other District. It then takes in Agra, including, however, only one Sub-division (Pergunna) named Furrah. Westward of the River, and on the Southern boundary of that Sub-division, the Famine Tract West of the Jumna terminates. Below this line the pressure is not so great as to require any extraordinary expedients, except at the City of Agra itself, which is in an exceptional position, lying just on the very boundary line of the true Famine Tract. The Jumna on the East, and the base of the Himalayas on the North, complete the boundaries of this section.

6. 2nd.—The Central Section lying wholly between the rivers Jumna and Ganges, presents a very different aspect to the foregoing. Under ordinary cicumstances it is one of the richest sections of these Provinces. Having a large proportion of its landed proprietary belonging to tribes known for their devotion to, and skill in, agricultural pursuits, its cultivated area has been progressively encroaching on its waste lands ever since the public demand was permanently settled. The latest measurement shows that in periods varying from 12 to 5 years rather more than half a million acres of new land had been added to its productive area. Falling away from the base of the Himalayas with a gentle and continuous slope its surface presents none of those rugged features so common in the Western Section of the tract. Its hydrography is regular, as might be expected, from the regularity of its fall and surface. All its drainage is gathered into definite channels; wastes of swampy land are rare; the great boundary streams receive and carry off its surplus waters; and, excepting in the extreme North, water is usually in its right place as the slave of man, and not his tyrant. The soil is generally good, often of the richest kind. The level of the water bearing stratum, which is so infinitely important to the agriculture of the section, is high, and of late years has, over broad areas, been raised higher by the influence of percolation from the canals of irrigation and their numerous channels. In means of artificial irrigation, this section far surpasses any other part of the Provinces. As illustrative of the most marked distinction between the agricultural condition of the Central and Eastern Sections of the Famine Tract, I may note from a return now before me, that while the former possesses fully 70,000 masonry wells, or the equivalents of such wells, the whole Province of Robilkund is represented as having less than

1,000. In Bijnour and Moradabad not a single well seems to be employed, or to be recorded as employed in agriculture, and Budaon has all the wells there are in the country. The only little canal the Eastern Section possesses is in Bijnour, and it has, I believe, fallen almost into disuse since the mutinies.

This remarkable moisture of climate and soil has not been wholly destroyed even by the protracted drought. The produce of the year has still felt its influence, and will be fully 2-5ths of that of an average year. Further, the existence of numerous low lying river valleys, where ordinarily swamps abound, but which now are just so dry as to be good pasturage or culturable land, and extensive forest tracts on the North, outside and inside the lower ranges of the Himalayas, supplying places of refuge to the population, have tended greatly to mitigate the intensity of suffering in each of the Districts under notice.

The River Ganges forms the Western boundary of this section, the Southern and Eastern are the corresponding boundaries of the Budaon, Moradabad, and Bijnour Districts, and on the North it is defined by the outer ranges of the Himalayas.

8. Having now fixed the outer borders of the Famine Tract, and sketched generally the characteristic differences of the three sections of which it is made up, I beg to refer to Appendix No. 1. for a variety of statistical details of interest connected with it. I need not load the body of my Report with these, as they can be referred to by all desiring to consult them. It is sufficient to give the following summary here in round numbers:—

9. In further illustration of points affecting the Famine Tractin its totality, Charts Nos. III. and IV. have been compiled; the first showing in each District for which such results could be procured, the average rain-fall of a good season in contrast with the actual fall of 1860-61, and the second showing the average prices of food-grain under like conditions.

10. The impressions received from the external aspect of the famine tract depend mainly on the special localities from which they may have been derived. Nothing could be less uniform than this aspect. Nearly all through the more Southerly part of the Western Section the desolation is scarcely relieved by even the appearance of culture. In the Trans-Jumna Subdivisions of Agra and Muttra, included in this section, there seemed at first sight to be no cultivation. The monotonous brown tints of the untilled soil suppressed everything else. It was only by some inquiry it could be learnt that even in this great waste there was cultivation in plots round the villages, and round the wells remote from the villages. In Southern Delhi and Goorgaon, the country between the Kootub Minar and the station of Goorgaon had been repeatedly marched over by me in all directions during ordinary seasons, and the contrast was truly startling over fifteen or twenty miles of country, where I had been accustomed to see wide expanses of gram chiefly, but also of wheat and barley growing with excellent promise; there was not a blade of green produce to be seen, excepting in the bed of some dried-up tank or along the narrow valleys of rivers, or near the sparsedly spread wells; yet to have taken this dreary scene as a type of all Goorgaon would have led to error. Within the limits of a District, parts of which are thus desolate, there is an area of cultivation close upon 150,000 acres in extent, which is secured in each harvest, either by irrigation from wells, or by lying so low as to retain moisture for long periods, or if not so secured, has still returned some fruits for the labor expended upon it. The people who are to be sustained by the produce of this land, number about 650,000 souls, and not even the lowest estimate of that produce can prove that it would be insufficient for its object, if only it could be conveyed to those who need it, or if they could be so placed as to be able to purchase their share of it. But the area secured or productive, material though it is, and so far as mere supply of food is concerned, sufficient as it may be to meet the emergency, is still only about one-third the ordinary breadth of cultivation in the District, and thus about two-thirds of the ordinary supply of agricultural labor is cast loose on a market where it is absolutely without value. The differing degrees of intensity with which different parts of the famine tract have suffered, is one of the points requiring the most careful discrimination, if serious practical blunders both of impression and action are to be avoided.

The observer, passing across the Jumna into the Central Tract, again runs just the opposite risk of altogether under-estimating the true intensity of the pressure from the famine. So plentiful are the means of irrigation, that many miles may be travelled in each of the Doab Districts with rich crops on both hands. So carnest and active have the industrious classes of cultivators

been, that all their usual appliances for culture have been strained to the utmost. The peculiar call of the husbandman at the well was to be heard as continuously during the night as during the day. No men on earth could have faced a great calamity with a sturdier resolution, or on the whole with better success; for by the timely and generous aid of Government in lightening helpfully the pressure of its public demand upon all such villages as really needed that aid, there has been as yet very little collapse among proprietary communities of the better farming tribes or castes. In short, so marked have these results been, that I have been repeatedly assured by English gentlemen, who were doubtless speaking on the basis of their own personal observation, that there had been no real failure of the crops, and that they had marched through considerable sections of Districts, without seeing signs of any serious suffering.

These conclusions were perfectly compatible with a limited range of observation. Even in the bad Sub-divisions of Agra and Mynpoorie, which first come under notice on entering the Central Section, and which are well known to have suffered most bitterly in parts, there are conditions that go a considerable way in mitigating the pressure. Ferozabad and Khundowlee have about 256 villages, but out of this number only about half are so bad as to need aid by remissions of revenue. Mr. C. G. Mansel, in his Settlement Report, draws special attention to the excellent qualifications of the cultivators in the Northern part of Ferozabad, but there is at the same time a large intermixture of such tribes as Goojurs, Brahmins, and Kayths, who are notable for their incompetence in agriculture, and who form rather more than 50 per cent. of the population of the Sub-division. In Khundowlee half the population are Rajpoots, very uncertain cultivators; but there are many Jat villages, and a visitor to them would be pretty sure to find a fair show of cultivation even at the present time, since the general proportion of cultivation secured by irrigation is about 40 per cent. Again in Mustaffabad and Shekoabad, the suffering sections of the Mynpoorie District, the present Lieutenant Governor of these Provinces says of the former:-"It is distinguished by fertility of soil, very general irrigation, and great agricultural prosperity; the only exception, and that a partial one, to the superiority of soil and the universality of "irrigation just noted is found in the Southern Section, where in some villages unproductive " Bhoor' (pure sand) lands, with all their concomitants of imperfect irrigation, abundant 'kans' " (a destructive and almost ineradicable weedy grass), and inferior cultivation. These are the " estates in which the symptoms of the past drought (that of 1837) are alone apparent to any con-" siderable extent; the almost universal irrigation in other parts having greatly mitigated the evil " and distress which, in less favored localities, were so prevalent and overwhelming." And of Shekoabad the same authority says :- "Though inferior as a whole to Mustaffabad, it is by no "means unproductive or ill-favored." Its Northern Section is described as easily irrigated and inhabited by a race of cultivators rivalling the Jats or the Jhadouns of Ferozabad and Khundowlee; its Central Section as decidedly inferior, and its Southern Section as so bad that four-fifths of its revenue was justifiably remitted in the famine of 1837. Beyond these Sub-divisions, the District of Mynpoorie has not suffered at all, and the facts that the proportion of cultivated area secured by irrigation, ranged at the time of the settlement of the Land Revenue in 1840, from about 50 to 80 per cent., and has since been increased, not only by natural extension but to some extent by the influence of the Etawa terminal of the Ganges Canal, well serve to explain this immunity.

- 11. Continuing northward, the District of Allyghur presents the same chequered aspect. Even more richly endowed in the aggregate with means of irrigation than Mynpoorie, it shows some of the best in close contact with some of the worst of the localities influenced by the drought. Such sub-divisions for example as Jullalee, where, under ordinary circumstances, the irrigated area is over 60 per cent. of the cultivation; Moorsan, where it is 82 per cent.; Sasnee, where it is 91 per cent., or Mackerah, where it varies from 57 to 65 per cent., there is not only no real suffering but some prosperity, and this is especially the case in those sections which are profusely intersected by the distribution channels of the Ganges Canal, from which about 100,000 acres are reported to have been watered during the period of drought.
- 12. But in this district there is, perhaps, the worst, or certainly one of the worst tracts in the whole Central section, that, namely, formed by the sub-divisions of Khyr, Chundos, and Tuppul. So universal was the repute of its desolation, that I selected it as one of those interior localities which it was expedient for me to see, and certainly it would be difficult to exaggerate the forlorn dreariness of its appearance. Usually it is, in parts at least, a fertile country, but when I traversed it in March, a few scattered plots of culture represented the broad fields one was accustomed to ride through. The country seemed denuded of inhabitants, and the emigration had been extensive. Relief-houses were established at Khyr and Tuppul, and at the former place I saw three or four hundred of the most pitiable objects eye could look upon, receiving daily rations of food. Yet even in Khyr, Chundos, and Tuppul the prospect was not one of unmitigated misery. The ordinary aggregate area under culture in the three subdivisions is about 160,000 acres, and of these rather more than a third, or about 64,000, have means of irrigation. There had been no serious failure of these means that I was aware of, but they were scattered, and many villages had no share, or but an inadequate share in them. Here, as elsewhere, from a cause obvious on the mere statement of the preceding figures, it was the laboring classes that were thrown out of nearly two-thirds of their usual field of employment, and on them the burden fell. Those having actual rights of proprietorship or tenancy in the lands have found it practicable to sustain themselves very generally, but the men whose capital is only their thews and sinews have sunk into pauperism, or in many cases I fear into their graves.

- 13. The same general law of intermixture of good tracts with bad tracts prevails in the upper districts of Boolundshuhur, Meerut, Moozuffernuggur, and Saharunpoor; and as it seems very important to a just appreciation of the true influence of the drought on the people, that the limits of such intermixture should be at least approximately defined, I have had Chart No. II. compiled, to show the comparative area of these contrasted portions of each district. The general area of the Famine Tract is marked by a light shade of color. The area of these interior tracts of greatest intensity is indicated by a very dark shade of the same color. The eye can judge at once, with these helps, of the comparative distribution of good, or more truly comparatively good and miserably bad. There is no tract marked black within which the sufferings of the people have not been most cruel. The characteristic is one which will always prevail, and has doubtless been commonly noticed before; but it is liable to be overlooked, especially by those at a distance from the Famine Tract, or having only a superficial knowledge of it. It is important, however, not merely as one of the marked features of the Famine Tract, but as directing our special attention to those localities where measures permanently remedial are most pressingly required. In round numbers the area of greatest intensity is to that of the Famine Tract generally as about one to three.
- 14. It is impossible, however, to be satisfied with the simple statement of the existence of these marked internal contrasts within the Famine Tract. To give some definite and sufficient explanation of their causes seems essential. Two features—one of physical, the other of moral origin—will be found in almost every instance to characterise the tracts in which the Famine has pressed with its utmost intensity. First, nearly all these tracts are marked by high surface levels, raising them much above the average level of the sub-soil water in good tracts. This difference is sometimes due to increased height of the surface soil levels, and sometimes to depressions of the water-table levels; but the existence of a seriously increased difference in such cases is uniform. Second, the same general uniformity will be found to prevail in reference to the moral qualities of the proprietary bodies who have possession of the land, and the influence of race, and the qualities distinctive of race that seem to be as hereditary as more substantial property, will invariably be recognised as most powerful agencies in marking out the limits of the worst parts of the Famine Tract. I have now before me a Chart showing in different colors the status of proprietary occupation in the Famine Tract, and in following the colors, marking the possessions of such tribes as Goojurs, certain clans of Rajpoot descent, Rangurs, some classes of Brahmins, Khyats, and the like, these tracts are found (as from the turbulence, the indolence, or the incompetence of their possessors, it was to be expected they should be found) in the darkest tract of the Famine. Race and its influences constantly modify physical conditions; for isolated estates held by Jats, Aheers, or proprietors of other good tribes, in the very heart of a bad tract, will constantly be found in tolerable cultivation, and at least the utmost made of their poor resources that human industry could make of them. No such efforts are ever made by the tribes who have no natural genius for a
- 15. Although the two causes just specified stand out more prominently than any others, they are not the only ones that influence the demarcation of the good and bad sections of districts. The general action of the Talookdaree system, so far as it has been permitted to exist in the Central Section of the Famine Tract, has been on the whole beneficial, and has tended to enlarge the limits of good tracts. Large proprietors can afford to do more than merely pay Government revenue. They can afford to help their tenants, and in most instances they have not neglected that duty. I had pleasure in making the personal acquaintance of some Native gentlemen who had been remarkably unselfish in this respect, and while held to the strict terms of their covenant with Government, and allowed no remissions, did grant such remissions as they thought were required to their sub-tenants. Of course, as among ourselves under like conditions there were bad as well as good landlords, but on the whole I believe the large proprietors have acted with justice in most instances, and in some with generosity. As regards the public revenue, there cannot be a doubt of the value of the class. I never conversed with a single District Officer on the prospects of his District income that he did not congratulate himself on having numerous large land-holders, or lament that he had so few, as the case might be.
- 16. Another cause tending to intensify the sufferings in tracts possessed by turbulent tribes, has doubtless been the heavy pressure of penal fines, with which most have been punished for their atrocious conduct during the disturbances of 1857 and 1858. Secunderabad in Boolundshuhur for example is mainly possessed by Goojurs, a notorious race, and is one of the blackest spots in the whole of the Famine Tract. My attention having been specially directed to it, I visited the locality, and found it quite as bad as Khyr in Allyghur. But the pressure was increased in Secunderabad by the Goojur tribe having been fined the large sum of £45,000, of which about half had been collected, and half hung in terrorem over them, while their property had well nigh perished under the drought. They are not a tribe who have many claims on our sympathies, and probably the best thing that could happen for society would be that they should cease to be proprietors of lands they misuse, and take their fitter place as day-labourers. But the calamity of the present Famine has no doubt in their case been greatly aggravated by the heavy pressure of this mulci, and as other tribes, or the same tribe in other equally bad localities, have been similarly dealt with, the influence of this cause has been considerable.

- 17. I am not aware of any instance within the Central Section in which it can be said that the Government Land Revenue demand has intensified the pressure. For an ordinary and average succession of seasons, the districts of the Upper Doab are lightly assessed. Many Sub-divisions of them which are traversed by canals, and have long used canal irrigation, have doubled their annual gross produce since the last settlement. Their assessment is now therefore of course unnaturally low, and inasmuch as it has been by no expenditure of their own that this enhancement of produce has been secured, it might be said that their assessment is unjustly low. However as a general rule applicable to the whole section, the assessment is reasonable, and has not tended to aggravate the sufferings of the people, because prompt relief has been given in every case in which a just claim for it has been found to exist, and the best proof of the relief having been real and substantial, is the limited extent to which proprietors having even the humblest class of rights in the land, and capacity to use those rights, have as yet sunk under the effects of the drought. There are some very vital questions however which are raised by this reference, but they will be much more conveniently discussed at a more advanced part of this report, and I do not enter upon them at all at present.
- 18. The aspect of the Eastern Section of the Famine Tract is similar to that of the two other sections, in so far as the mixture of localities of very unequal intensity is concerned. But the appearance of the country is somewhat different. Agriculture depending here mainly on a power of retention of moisture in the soil, or a natural dampness of climate not entirely destroyed even by the drought, the breadth of land under cultivation has not so much diminished as that the produce has fallen much below the average. For example, in a comparative statement of the total produce of the District of Moradabad, kindly supplied to me by the Magistrate and Collector, Mr. J. Strachey, I find that while there is a difference between the areas cultivated in average years, and during 1860-61 of only about 50,000 acres, there is a difference in the produce of no less than about 140,000 tons; the areas being to each other as 57 to 53, while the weights of produce are as 70 to 30, showing a trifling falling off in breadth of culture, but a most serious one in grain produced. This is just what might be expected from the physical conditions under which farming there is carried on, and it was noticeable that while you might see in travelling many fields of grain, they were all very thin and poor.

The spots of greatest intensity in this Section are mainly determined by the race of the cultivators. The physical conditions of all are pretty much alike, excepting of course in the localities of special refuge to which allusion was formerly made. It is only in Bijnour where the pressure of the Government Land Revenue is supposed to be oppressive, and where a revision of that demand will doubtless follow the experience of the present time. Emigration from this Section has been on a considerable scale, but limited, as before, mainly though not exclusively to the labouring classes or artizans dependent on these classes.

- 19. These general details, with the help of the Charts and Tables, will, I trust, be quite sufficient to give a reasonably exact view of the main characteristics of the Famine Tract, and the internal distribution of its smaller areas of greatest intensity, and I may now go on to other questions to which my attention has been directed.
- 20. I would first dispose of the question of the sufficiency of the available supplies of grain for the support of the people within the Famine Tract. I think it is wholly unnecessary to burden this subject with elaborate calculations. Certain broad general considerations will probably determine it more satisfactorily than in any other way. There can be no doubt as to the abundant supplies in the Districts surrounding the Famine Tract. The free flow from them into the markets there, even before the spring harvest became available, showed that grain was then plentiful. The spring harvest has everywhere, beyond the influence of the drought, been rather above than below the average yield. Within the tract itself between two-fifths and three-fifths at least of the cultivated area will be found to yield crops of variable quality, but generally good, excepting under such an aggravation of the drought as we need not anticipate at present. And so far as mere supply of food is concerned, such a proportion would be in itself almost a guarantee against any absolute deficiency. Reinforced by the surplus produce which would instantly begin to pour in from the outside on any great rise of prices, as past experience has amply proved, the combined quantities would, I feel confident, keep the markets at least sufficiently supplied to make a real dearth of food altogether improbable. On this point I must say that as yet I do not see the faintest grounds for anxiety. And even if our hopes of a favorable rainy season should be disappointed, the practical question will then be, not so much how to get food, as how to get the starving people to the food, or the food to them in the cheapest and most expeditions way. If the spirit of private speculation should fail in bringing sufficient supplies to market, other means will doubtless be used, but that food itself will fail us even under the worst contingency, I consider so unlikely that I do not think it needful to dwell longer upon it. It may however be observed that having had occasi
- 21. The methods of relief adopted within the Famine Tract for the mitigation of the sufferings of the people form the next part of the subject to which attention may be given.

In all countries and in their best conditions, there is ever a large mass of permanent pauperism which the community is bound to sustain either by moral or by legal obligations. helpless from disease, age, infirmity, or other causes, make up for the most part this painful aggregate, and on the occurrence of any such calamity as the present, these paupers give the earliest signs of its existence. Living precariously at all times, the general pressure contracts even their very uncertain means of support, and they are the first claimants for relief. Their numbers are soon swelled however as the pressure grows more intense by those whose strength has failed them; women possibly deserted by their husbands and left with infant children; children similarly deserted by their parents or left orphans, and many others who from different causes are reduced to helplessness. These then, the helpless poor, form the first great section of the sufferers to whom attention is imperative. In speaking of them as helpless, it is not meant that they are absolutely incompetent to any personal efforts, but only that they are not fit for out-door labour.

The other great class is the able-bodied poor, meaning thereby all those men, women, and children, who are competent to out-door labour, and can be employed on works. The able-bodied however are no more capable of full work than the helpless are incapable of any, the gradations of strength in both being of course many. The systems of relief for those two great classes, having distinctive features, may be described separately.

22. The helpless poor were rightly made the special charge of the European and Native community, and the organizations for their relief were formed exclusively on the basis of voluntary and non-official efforts. The local Government laid down certain broad general rules for guidance, and supported its right of interference by contributing donations equal to the amount of private subscriptions. But considerable freedom had been left to local action, and as the natural result, general rules had been variously interpreted.

It may be proper to state here that I shall describe the system of relief for the helpless poor, not as it may appear in printed papers, but from general observation of it, as I saw it in actual work in about twenty separate localities scattered throughout the three sections of the Famine Tract.

Relief from hunger by the supply of cooked food is the main characteristic of the system, and I saw but one or two instances of its being departed from in the course of my inspection. At Futtehghur, rations of uncooked food were being issued, and at Delhi I found money was distributed at one of the places of relief, paupers coming twice weekly and receiving a sum, graduated according to the number of the family, for their support during the intermediate time. Unhappily the latter plan is so provocative of abuses, notwithstanding the most anxious care to prevent them, that I do not think it ought ever to be resorted to. In fact it is as a corrective of, or a preventive to abuses, that the supply of cooked food works so well, and excepting in very special cases, and under very peculiar circumstances. I am satisfied it should be rigidly adhered to. I found an absolute unanimity on this point among Native Committees, and as all personal details connected with the food are left exclusively to them, the plan has not in my experience been the subject of a single complaint.

A District Committee supervises the details of distribution, members taking it in turn to be present when food* is given out. The task is la-

* Rations vary, but the following are averages :-

borious, and not wholly free from danger, as infectious diseases, such as small-pox, are very common. The time occupied is never less than about two hours, and is sometimes twice as much in large stations. Nothing could surpass the hearty zeal and earnestness with which these supervising duties were generally performed and carried on as they have been through the whole

of the hot season, the strain has been most cheerfully accepted by the European Community, while some of the very best local plans for relief I have seen have owed their efficiency, I am happy to be able to record, to the intelligence, personal interest, and unwearied industry of the Native Members of Committees. This was specially the case at Moradabad, where the best or-Native Members of Committees. This was specially the case at Moradabad, where the best organized Relief House I saw during my inspection exists, and I do but echo the judgment of the Magistrate, Mr. J. Strachey, in saying that the practical working out of the whole scheme, of which he supplied the leading principles, was due exclusively to the Native Committee, and pre-eminently among them to the Chief Native Judge, Syud Ahmed Khan, a gentleman whose devotion to this work has been admirable, and whose knowledge of the political economy of famines was singularly exact and sound.

There was of course an infinite variety in matters of detail in the systems practised in different Districts. At the time I saw most of the Relief Houses, they were only taking form, and mistakes were occasionally noted. These were pointed out wherever the opportunity was given, in kindly consultation with the Committees or their executive members, and the recommendations generally made by me can be judged of by reference to Appendix No. II. in which they will be found thrown into specific form. It need only be said here that the characteristics of a safe and effective system of relief for the helpless poor seem to me to be mainly these:—

1st.—Relief by cooked food only; the nature of the food, however, being cautiously adapted to the physical strength of the paupers.

2nd.—Either a careful system of selection by the personal inquiries of competent Sub-Committees or permanent residence within the Relief House, should be conditions of continuous relief. No conditions need be attached to casual relief, excepting evidence of suffering from hunger, about which there is rarely any risk of error.

3rd.—The principle that all who can work shall work in ways suited to their capacity should, be carried out as much as possible with permanent paupers. A Relief House gradually developed into a true workhouse, where the totally helpless are cared for and supported, while the partially helpless are occupied in such light work as they are accustomed to, or are fit for, is the most satisfactory form the relief of this class of paupers can assume. I have seen it in action only at two places, Moradabad and Roorkee, but I have reason to believe that the principle is now adopted in other stations also, and should the necessity for continuous relief be protracted, the plan will probably become general.

4th.—Relief should be interpreted liberally, and be made to include relief from nakedness as well as hunger, and from disease by medical treatment and hospital comforts.

5th.—Cautious extension of out-door relief in the cases of female paupers of respectable position, by whom appearance in public would be felt as an intolerable degradation. When practicable, appropriate labor may be required in exchange for food.

6th.—The extension of Relief Houses throughout the interiors of Districts, especially in the sections of greatest intensity wherever European or reliable Native supervision can be secured. Without such supervision the action of detached places of relief is liable to much abuse, and involves great waste of means. Respectable Native supervision, with only occasional European control, may however be trusted, and the relaxation of the first orders of Government, making the continuous presence of Europeans indispensable, has no doubt been beneficial.

It is not practicable at the present moment to give an accurate statement of the extent of the relief system for the helpless poor, as the returns of the District Committees are still incomplete. But in Chart No. V. will be found the distribution of Relief Houses so far as known to me on the 30th April, and a general approximate estimate of the number of helpless poor relieved. This estimate must be considered as subject to future correction when returns are completed.

Up to the 30th April 1861, it would appear that 26 Central and 75 District Relief Houses have been established in the Famine Tract, and in Districts bordering on it, and that on the average 80,000 are relieved daily at these places. The rate fluctuates considerably from day to day, and in April, the ripening of the spring crop drew many out of the Relief Houses, and took them to their village fields to reap and house the harvest. The number may be expected to increase again from May onwards to July, and if the coming rainy season should prove favorable, the pressure will begin to lighten from August. By October next, it will be possible to suspend the system generally, and allow the people gradually to relapse into their ordinary course of life. If the rain should not be favorable, an alarming increase of intensity in suffering through all classes must be looked for, and the number of helpless poor will be deplorably augmented.

23. For the relief of the able-bodied poor, a series of "special relief works" have been organized, both in the North-Western Provinces and the Punjab, on principles much the same but with details varying according to locality and other circumstances.

The primary condition of admission on these works is, that applicants shall not be so help-less as to be unfit for ordinary labour in digging, carrying, and the like. If they are so helpless, they properly fall under charge of the agents for relief of the helpless poor, but they would be improperly placed on special relief works. Some confusion of thought is apt to arise on this point, and it is well to notice it. Officers in charge of special relief works find men, women, and children reach them so grievously exhausted, as to be utterly useless for some time afterwards. It is of course essential that these poor creatures should have all needful help, and should not be sent away. But the means of helping them should be provided from the fund supplied for the helpless, and not from those provided for the able-bodied poor. No Officer, having to deal with such a case would ever find the slightest difficulty in procuring the means of supporting them till they were fit for work, either from the District or Central Committees. It is only an act of justice towards Government to meet such a demand, inasmuch as Government has liberally subscribed towards the sustenance of the helpless by doubling all private subscriptions, and ought not to be again taxed for the same class by having to pay for them on special relief works also.

All people then willing to give labor in exchange for wages are admitted on these works. The wages given are calculated at the lowest rate needful for subsistence, and for that only. Profit on labor that is not wanted, but is a mere drug in the market, is wholly out of the question. It is in a pecuniary sense even at least a very expensive method of working, for the average capacity of the workers is much below that of ordinary laborers, and the cost of work so executed must always be high. But no middle course exists between employing those people and maintaining them. They certainly cannot support themselves, and it is better far to accept the high rates of work consequent on their employment than to let them subside into the class of helpless poor or die. It is clear that on special relief works no specific rates can possibly be fixed. They must range from very nearly the entire cost of subsistence to the rates due for

ordinary labor, according to the comparative working capacity of the people employed, and may at any time show fluctuations dependent on this capacity alone, and thus be wholly beyond the control of the Officer in charge. Some Officers have tried to work within limiting rates, but it is only practicable to do so systematically by overlooking the fact, that wages on special relief works are subsistence wages only, and cannot be retrenched for short work without starving the work-people. It is remarkable, however, how well and cheaply, amid all the difficulties of the case, an energetic Officer can execute special relief works. But this comparatively satisfactory result cannot be obtained by reducing wages. It depends on close personal supervision, on the careful adjustment of tasks to strength in the formation of working parties, so that the strong and the weak may each have just the kind or quantity of work they are best fitted to do. In this way the best may be made of the system, but at best it will never be an economical one. It however returns in labour a sensible proportion of the cost of maintaining the people, and what is perhaps of more importance, it teaches them to continue reliance on their own capacity to work as their best means of subsistence, and maintains their self-respect by keeping them above the position of helpless paupers.

The wages allowed are $1\frac{1}{2}$ annas, or about $2\frac{1}{3}d$. for each man; 1 anna ($1\frac{1}{4}d$.) for each woman; and half an anna ($\frac{3}{4}d$.) for each child. A man, his wife, and three children can thus earn four annas or about six-pence a day, on which the whole party can so subsist as to have their capacity to work fairly maintained. The same can be done on each separate wage, though of course family groups fare best.

The work-people are ordinarily organized in gangs of 500 each, to which a separate cash-keeper and series of petty officers are attached. They live usually in light sheds on the works; have grain shops moveable with them; occasionally, as on the Hill Road through the Sub-Himalayas, where 17,000 or 18,000 people are gathered into one place, Officers of the Civil Department reside on the spot to maintain order, ensure supplies, and the like while the Engineers attend to the works only. On one of the relief works payment for labor was at first made in flour uncooked, but this soon brought on such a system of rude barter that it was wisely abandoned, and a subsistence money wage substituted. Men had to buy fuel with a little flour, salt with a little more, and so on with other petty purchases, and the small merchants who are always the most convenient channels for such transactions, were put to so much inconvenience by these barterings, that they refused to work. The less our systems of relief derange the ordinary machinery of society, and the more they can be made to dovetail themselves into it, so to speak, the better they will always be found to work.

The chief "Special Relief Works" authorised are the following :-

I have given these numbers only from general information, not from the accounts, but the result is, I believe, approximately correct.

In reviewing this plan of relief, I am satisfied that it has proved a most healthy and satisfactory success. The worst parts of the Famine Tract have been traversed by long lines of works, or by smaller detached works to which the suffering people have freely resorted. They have left them too, whenever the ordinary farming work of the country required their presence. The effect produced on all the working parties by the call for labor to cut the spring harvest was most marked. About half the number left, and having been absent about a fortnight or three weeks, they began again to return, and very soon restored the previous strength of the parties. There was thus a healthy sympathy between the working of the plan and the general wants of the country. No real inconvenience was caused by the withdrawal of so much labor, as such proportion of it as was wanted by the farmers, spontaneously met their call, and was only employed by Government when there was no employment for it elsewhere.

The pecuniary burden has, however, been a heavy one on the State. It is estimated that the entire cost of special relief works, great and small, throughout both Provinces, will not be less than about £250,000.

- 24. The ordinary operations of the different Departments employed in executing public works throughout the Famine Tract, have supplied an additional means of relief, of which the influence has been extensive. Labor being paid for there on the usual terms, they are resorted to only by work-people capable of full work, and they thus form the final link in the chain of relief. The Relief House paupers, when sufficiently restored to be fit for out-door labor, are drafted off to special relief works, and when still further restored, so as to be fit for full work, they may earn full wages by passing off to one or other of the ordinary public works of the country. The East Indian Railway, which passes right through the heart of the worst part of the Central Section of the Famine Tract, and the numerous channels under construction by the Irrigation Department, are the most prominent and most useful of these works. It is difficult to estimate their entire effect, but it will not be far wrong to say that they give daily employment in all parts of the suffering Districts to between 40,000 and 50,000 people.
- 25. By the combined action of this machinery of relief, suffering that is visible and tangible, or that declares itself openly and seeks help, may be, and in large measure is, met and mitigated. But there are forms of suffering which as yet no part of our relief system has reached, or, as at present constituted, can reach. I have already alluded to the cruel suffering of certain tribes in the Famine Tract whose low qualifications as cultivators make their lands as little useful in supporting them as they can be. But in addition to such habits, these men have a pride of race and family that keeps them away alike from our relief houses when helpless, and our relief works when capable of work, and they deliberately prefer to remain in their wretched villages and die, rather than either to seek for charity or to work on public works. Such has been the uniform experience hitherto in the Districts where these tribes of Rajpoot descent, Goojurs and others of the same type, predominate. We totally fail in administering help to them, and of the sad mortality among them there can I believe be no reasonable doubt; yet how to meet this case is extremely difficult. Help in the way of temporary or permanent relief from demands for land revenue is willingly accepted, and has been largely given, but to relieve people from a tax only, when nearly all the produce of the land on which they ordinarily live has perished, is a mere shadow of relief. The reputation of these people for common honesty is unhappily so low that even their headmen cannot be trusted to distribute relief among them, and for supervision in any systematic way the ordinary District agency is quite inadequate. It is possible perhaps that the funds of the Central Committees, now so ample, might be drawn upon to meet the expense of such an addition to the ordinary District agency as would suffice to ensure these people being relieved in their own villages to such an extent as would save them alive. As a general rule, and under ordinary circumstances, it may be right that if a man will not work, no more shall he cat; but it is hard to reconcile ourselves to the belief that it can be right to leave men, women, and children to perish in the miseries of famine, because the adults of the race are under the dominion of perverted feelings. I have accordingly addressed the President of the Central Committee at Agra, among whose members are gentlemen who know well from personal knowledge the peculiarities of the races I am referring to, and have sought for this distressing subject their careful consideration.
- I have now exhausted the subject of forms of relief administered by the general community or by the State, but there remain some details to be given of those spontaneously adopted by the sufferers themselves. Among these by far the most important, or more accurately the only important one, has been emigration. In all times the population of India has been notable for its mobility under pressure, whether personal or fiscal. A population crushed under a bad Government, seeks relief by migrating to a province under milder rule, and similarly, when crushed under a bad season, it almost intuitively seeks the same form of relief. Even before any special arrangements for their relief had been made, the people of the Famine Tract had adopted their traditional course, and were streaming out of the bad districts into those more or less near in which the crops had been good, and food grain was cheap. This exodus assumed a double direction. In one case it poured towards prosperous districts of our own or of adjoining foreign States lying entirely beyond the Famine Tract. In the other it flowed from the bad to the good; from the darkly to the lightly shaded portions of suffering Districts, as shown in Chart No. II. The determining causes in the former instances were probably only the known cheapness of food and the fair chance of work. In the latter brotherhood feelings and the claims of a common clanship came largely into play; thriving villages, in the well-irrigated parts of the Famine Tract, receiving their brethren from the suffering parts, giving them a share of the culturable land of the estate to work upon, and so to earn their food. In many cases, however, where means did not exist for any considerable extension of cultivation, the reception of clausmen told injuriously on the ordinary village laborers, whose work was transferred to the new comers, while they were themselves compelled to seek employment on relief, or public works, or possibly to emigrate. It would be of interest to trace these outer and inner movements of the unsettled population, but to do so with any approach to accuracy would need long and careful inquiries in each District, which cannot at present be made. The inner movement would illustrate very strongly an indirect benefit due to extensive irrigation. It creates the ability in times of pressure like the present, to shelter a population far greater than usual, and to give

them employment remunerative to all concerned. New lands are brought under cultivation, or old lands are more elaborately tilled than usual, and it is a fact noticed universally in the harvest just cut, that either as a consequence of much virgin soil having been broken up, or much land hitherto without water having received it, or much more labour than ordinary having been applied in tillage, its yield has been of unusual bulk and weight. The result is no doubt due to the interior emigration I have alluded to, and the additional stimulus it has supplied.

Although it may not be practicable, however, to measure with accuracy the actual extent of these movements, some information has been supplied to me which admits of an approximation being made to it. Muttra may be taken as a type of the Districts from which the emigration has been greatest. It was one of the first things which struck me on entering the Famine Tract, about the middle of March last, that almost every traveller or family group I spoke to on the road reported that they had left the Muttra District, and, as before mentioned, the sufferings of the people there have been very bitter. The following table, supplied to me by the kindness of the Magistrate, Mr. H. D. Robertson, shows from local inquiry the actual extent of the emigration from the different Sub-divisions of the District:—

According to the last census of these Provinces, the total population of the District was 862,000, so that under the present grievous pressure, about 10½ per cent. of the people have left their homes. A considerable part of this emigration flowed doubtless into our own Districts, perhaps one-third of the whole was so disposed of. But from local accounts the remainder took the general direction towards Central India, and has been temporarily absorbed there. There were no local works in the Muttra District, or any other means employed to check the tendency to emigration, and the movement may be regarded as purely spontaneous. In other Districts of the Western Section, considerable efforts were made to find temporary employment for the people on the spot. The ratio of out-flow there was therefore probably a good deal less. But still that out-flow, by general agreement of authorities, was considerable, and would probably not be over-estimated at 3 or 4 per cent. on the total population of the affected Districts, or in round numbers about 80,000, of which more than one-half was likely to be a mere interior movement.

Again, Meerut and Allyghur may be taken as types of Districts in the Central Section of the Famine Tract, where extensive areas of irrigation for numerous relief-works or other means of local employment greatly checked the tendency to emigration beyond the District. The following Return has been supplied to me by the kindness of Mr. Sapte, the Magistrate of the District, and though it is accompanied by a special warning that it is to be received with caution, it may be taken as a rough approximation to the truth:—

Assuming that the returns from the two Districts were made with equal care, and that consequently, though absolutely they may be somewhat incorrect, yet that they may be relied on for comparative results, it would appear that the special relief works in the Meerut District have reduced the extent of emigration by about 2 per cent, on the total population. Excepting as regards these works, the general condition of the two Districts was pretty much the same. Both have the Railway in progress through them, and both have canals and considerable areas of irrigation from wells. The Allyghur emigration is reported to be confined almost exclusively to the labouring classes and artisans, especially Native weavers. Part of it probably flowed towards the Bolundshuhur Branch Works, or the Works in the Meerut District, but most of it no doubt passed beyond the Famine Tract altogether, towards Oude, and our own Southern Districts, or towards Central India

Knowing the comparative conditions of each of the remaining Districts of the Central Section, I have made out the following Statement, giving a general view of the probable extent of emigration throughout its entire extent within this Section:—

Moradabad represents fairly the state of the Eastern Section, and though I have no detailed statement of the emigration from that District, it was estimated for me by the Magistrate, from local inquiries, at about 50,000 in all, or about $4\frac{1}{2}$ per cent. on the total population, apparently a fair approximation. This would give for the entire Eastern tract an emigration of—

Of which the whole is probably exterior to the Famine Tract, but all to Districts of our own adjoining it, as those of Rohilkund which have escaped the drought, and Oude.

Summing these results, and taking round numbers, the following would roughly represent the total emigrational movement:—

Of which about one-tenth has flowed into foreign States, six-tenths into our own Districts outside the Famine Tract, while three-tenths have been from some parts of the tract to others.

With the exception of thus transferring themselves in search of food and work, the people did nothing else for themselves, as in truth they could do nothing else. Our famines are rather famines of work than of food; when work can be had and paid for, food is always forthcoming; but people whose power to labour is annihilated at their homes, can only seek to re-establish it elsewhere, as the working population, both agricultural and artisan, have so largely, and, I believe with reference to a great majority of them, so beneficially done. Although prepared for a movement of considerable magnitude, the results, as thus shown, go, I acknowledge, beyond my expectations.

I anticipate no permanent injury however to the Districts whence this emigration has taken place. Temporary injury it must cause, of course, as other effects of the drought and dearth do, but a recurrence of regular seasons will be followed by the return of a very large proportion of the wanderers to their own villages. Among them, as I have already said, the number of proprietors of land is comparatively small.

26. A loss that is likely to tell more heavily on the farmers than even the temporary loss of manual labor, is the loss by death of their plough and well-bullocks. The scale of their loss has been very large, and it is increasing day by day. From every Section of the Famine Tract I receive intelligence of growing mortality among these animals, and the gravest fears are expressed in consequence. In the Meerut District, it is believed that fully one-half of the farming cattle have already died, and it is known that the rate of mortality is increasing. Such a state of things implies great paralysis of work in the bad tracts, whatever the nature of the season may be, and may well cause very deep anxiety. Ordinarily, the farmer maintains cattle for his wells and ploughs, with other work, at the rate of about one pair for each four acres under cultivation, and as the Section of the Meerut District, over which the drought has almost annihilated the crops, is about four-tenths of the whole, the total number of bullocks for farming purposes at the beginning of the pressure was probably about 80,000 pairs. Of these, 40,000 pairs, more or less, are reported to have gone, and of the remainder the mortality is now said to be greater than ever. Even the loss believed to have been already sustained, however, in this single District, cannot be replaced, but at an outlay of at least 10 lakhs of Rupees, or £100,000.

As very nearly the same general proportion of bad tracts to good runs throughout the Central Section Districts, the loss to the agricultural community there, in cattle only, can scarcely be less, and may possibly be more, than about 50 lakhs, or £500,000.

In the Eastern Section, the loss is probably much less from the large extent of forest or river valley pasturage available; but in the Western Section, where no such advantages exist, the mortality has been even greater than in the Doah, and the accounts I have received from the Delhi Districts are truly deplorable, as the increasing losses of cattle there are described as causing extensive abandonment of villages by the people. The entire loss therefore from this cause is not likely to fall under about 75 lakks of Rupees, or £750,000.

These men, and the sufferers who still cling to their villages, have fought their fight bravely and well; and I earnestly hope that some help may be given them in such forms as will be most effectual in helping them to help themselves. Nothing could do so more effectually than aid in replacing their lost cattle, or in general help towards the resumption of their usual work, and the Central Relief Committees could not better do their work, in my judgment, than by coming forward to lighten this crushing burden.

27. I have received from a number of the Districts in the Famine Tract comparative statements of their produce in ordinary years and in 1860-61, of which an abstract only need be given here. Such details are always open to considerable doubt, but without them it is almost impossible to form any definite conception of the actual effect of such a drought as the present, and of the extent to which it has affected the resources of those who have suffered from it. So long as they are accepted for what they are, as roughly approximate estimates, they are useful.

From the Sharunpoor Table it appears that the produce of the land this year has fallen below that of an average year by about one-third, and that the value of this difference may, at the usual prices current in common seasons, be estimated at 15 lakhs of Rupees, or £150,000. This heavy loss has been borne, however, not by the whole District, but by a section of it, only three-tenths of the area, and having less than that proportion of the population. In the remaining seventenths the possession of means of irrigation and the high prices have made the position of the farmer usually a profitable and prosperous one.

The Moozusterauggur Statement, having been prepared for 1859-60, does not admit of comparison with the others. It illustrates, however, very clearly the pressure in the year immediately, preceding the samine priod, and shows that even then the bad parts of the district had lost about two-fifths of their ordinary produce of food grain, representing a loss in money of about 7 lakhs-of Rupees, or £70,000, while in the current year the loss in the same section, taken in about half the district, was probably 12 lakhs of Rupees, or £120,000. Of course, the same general rule-holds in reference to the influence of irrigation and high prices here as elsewhere.

Proportionately, the results in Meerut are much the same as those in Sharunpoor, the produce lost having been one-third, and the loss concentrated within four-tenths of the total area of the district. Meerut is, however, larger and richer, and the money value of its loss would be about 18 lakhs of Rupees, or £180,000.

Allyghur has suffered more severely. From the figures supplied, its loss of produce during the famine year has been rather more than four-tenths (4.3) of its average annual production. The money value of the produce thus lost from the drought would be about 25 lakhs of Rupees, or £250,000.

The statements from Boolundshuhur and that part of Muttra which lies Eastward of the Jumna have not yet reached me. The former, situated as it is between Meerut and Allyghur, will most probably show results much the same as they do, and its loss may be assumed at about 12 lakhs of Rupees, or £120,000. Of the five sub-divisions of Muttra, one only is included by the Collector in the very bad section of the district, although it would appear from the statement of emigration that their loss of population exceeded that of the part of the district excluded in the Western Section of the Famine Tract. For the present I assume that in Eastern Muttra there has been no loss other than that of population.

In the bad part of Mynpoorie rather more than half the area usually cultivated has been thrown out of cultivation during the famine period, and in the like part of Agra the same proportion obtains. The loss of produce in both Districts may safely be estimated at about 11 lakhs of Rupees, or £110,000.

The total loss of agricultural produce in the Central Section may therefore be approximately calculated at from 90 to 100 lakhs of Rupees, or £900,000 to £1,000,000. To a very large section of the people in the Famine Tract the loss has been absolute, as the small patches of cultivation they may have been able to maintain would barely suffice for their own sustenance.

Turning now to the Eastern Section, I find that the actual loss of produce in the Moradabad District is estimated at nearly 4 millions of maunds, an ordinary year's production, being about 7 millions, and that of the present year only 3. The numbers indicate a loss of property to the community during the famine period of nearly 40 lakhs of Rupees, but that loss has not fallen wholly on the District, inasmuch as the smaller quantity of produce obtained has been sold at famine price, and the actual loss is about 12 lakhs, or £120,000. This loss has, however, been very unequally distributed, and the bad sections have in reality suffered to a much graver extent than this average statement would indicate. Their great loss has been balanced by the greater gains of their neighbours in the better sections, and about 20 lakhs, or £200,000, would probably be a moderate estimate to make of the loss in the aggregate area of the worst section of the district. Bijnour might similarly be taken at 12, and Budaon at 15 lakhs, making the whole loss for the Eastern Section between 45 and 50 lakhs, or from about £450,000 to £500,000.

In the Western Section, and more especially in its Southern parts, I fear the loss will prove to be much greater. I have not yet the means of making any estimate for the part North of Panceput, but South of Dehli fully two-thirds of the area cultivated in ordinary years have failed this year to yield any produce at all. The loss thus sustained throughout the four Southern districts, or parts of districts, may be computed at about 60 lakhs, or £600,000. The Northern districts will raise this to about £800,000; but I doubt much if this represents the full loss West of the Jumna, as, though not so hard pressed as the others, I am aware that in Rohtuk, Hansi, and Hissar serious losses have been caused by the drought.

If the aggregate of these losses throughout the Famine Tract be taken at 3 millions sterling, it will, I believe, be under the truth, and a verification of the approximate accuracy of this estimate may be obtained from independent considerations. The whole remissions of the Government revenue, in aid of landed proprietors who have borne the loss just indicated, will amount altogether to about 40 lakhs of Rupees. Assuming the Government revenue to represent, as on the average it does represent, about one-eighth of the gross produce of the land, the above scale of remissions would indicate a loss over the entire Famine Tract of about £3,200,000, or say 34 millons sterling. That the truth lies somewhere near these numbers seems therefore a reasonable conclusion, though no claim to strict accuracy can be made for them.

28. There remains but one point further to notice in this section of my Report, and that is the mortality attributable to the famine. For any estimate of this, having even the slightest claim to confidence, there are no materials in existence. No regular records of deaths in Districts have been kept. Those communities who have refused all aid from our relief-houses or orks might have died by hundreds without tecord being made. I have strong personal evidence that in such communities many deaths did occur, but numerical statements of them are not to be had. It is only the deaths of immigrants into Districts, or of people who are without families or friends, that are reported by the Police. Of general vital statistics in India we know nothing to guide us in trying to come to conclusions, and we cannot even test by them the pretensions of such statements as may be made. It is believed that the average rate of mortality among the Native population is high, but what it really is is quite unknown. Some isolated instances, however, give painful indications of the mortality that has occasionally prevailed. In the small sub-division of Bullubghur, in the Delhi District, I find that up to the end of January 1861, 1.371 men, 778 women, and 704 children, or 2,853 are reported to have died from starvation alone, being about 4 per cent of the entire population. The Superintendent of the Relief Works at Agra informed me that on first starting his works the mortality from starvation used to be about 8 or 9 daily; that this decreased to 6 or 7 after the first fortnight, and that after a month it had fallen to 4 or 5, at which rate it was almost constant. The works had been in progress about six weeks when I saw then, and the total mortality had been about 500, or about 4 per cent. on the strength. In the immediate vicinity of Boorkee, about 200 persons are known to have died from want of food or from disease directly induced by hunger. In the district of Meerut, about 7,000 deaths are reported up to 30th April, but among these are many from other causes than actual starvation. The ordinary mortality of such a district, containing as it does rather over a million of inhabitants, is not likely to be less than from 2,500 to 3,000 monthly, and at a time like the present many deaths from ordinary diseases are not unlikely to be reported by the Police as deaths from starvation. The general condition of the population of the very bad Districts however may be judged of from the following description by Dr. Cutcliffe, Civil Surgeon, of those received into the hospital of the Meerut Relief House. In speaking of their personal state, he says—"they were one and all starving, and the majority were skeletons from atrophy. This was "not an hospital for sick only, but for starving people attacked by disease.

"That famine has been prevailing in the District is a fact patent to all. The people sore"pressed for want of natural aliment endeavoured to support life by eating wild fruits and
"vegetables procurable at the expense of toil in gathering them. They had suffered not only
"from simple deficiency of food, but from deficiency of digestible material; from having eaten
"as substitutes for proper nutriment, vegetables and substances acting injuriously upon them.

"But they were not only ill-nourished and poor blooded. They were also suffering from "great nervous depression both before and after admission into Hospital; before, from social "calamities, loss of homes, of relatives and of friends, from the dark prospect of the future and "the disseverance from the ties of village life, (ever dear and deep-rooted in the mind of the "rustic,) with its freedom and petty independence; and after, from the conviction of their being "enclosed in a poor-house surrounded by suffering in every form, to-day perhaps witnessing the death of a child, and expecting to-morrow that of their wives, and only hoping that their own " might soon follow. From the first to the present time the great mental depression of the sick "in hospital has been most remarkable, and many instances have occurred of men who refused "to take food on the plea that they did not desire to live, either because their villages had been "in part deserted, and their families scattered, or that they had lost their children or nearest rela-"tions, or sustained in some way or other some severe trial of the affections, and had suc-"cumbed to despair. Many had wandered about the country after leaving their villages, and " had been exposed to the vicissitudes of the climate, fainting under the heat of the sun by day, " and shivering from the cold by night, from which indeed they were ill protected. Many people "thus found were sent into hospital by the Police, and some in the last stages of disease arrived "only to die. From the mortuary abstract of February we find that, out of 162 deaths in that

"28 died on the first day of admission.

"28 died on the second day of admission.

"27 died on the third day of admission.

"19 died on the fourth day of admission.

"60 survived over the fourth day, and were affected by and died "subsequently of Chronic Diarrhæa, Dysentery, and Lepra.

"From the abstract of March-

"37 died the day of admission.
"57 died one day after admission.
"80 died two days after admission.
"23 died three days after admission.
"26 died four days after admission.
"41 died five days after admission.
"69 died six days after admission.

"being a total of 333 died within six days of admission, or about three-fourths of the whole "deaths of this month." The total number from January to March was 630; of discharged cured 1,249, with 649 more remaining in hospital.

These are very mournful details, but in the present instance they are somewhat lightened by the thought that deplorable though the mortality has been, yet that twice as many have been recovered from the terrible condition in which they were found than have sunk under it. The most piteous effect of the case seems to me, however, to be in its suggestiveness. This is a sample brought into light of those sufferings which in many communities are carefully concealed, and which are endured even unto death sooner than that compromise of caste or tribal feelings can be tolerated.

At present then, it seems vain to attempt to arrive at the true general mortality. That it has been great no one can doubt who has gone, as it has been my duty to do, from District to District, and has seen the abject wretchedness to which the people of the bad sections were reduced. Long before I read the Medical Report just quoted from, the aspect of deep depression common to all the real sufferers by the famine had struck me everywhere. I am familiar of course with the bearing of Natives generally under suffering, and know them to be often easily borne down by it; but I have never before seen such an aspect of desolate despair as many of these men presented, all of whom, till this great calamity struck them down, had evidently been able to support themselves and their families by honest and independent toil in husbandry or otherwise. Hereafter, when it is possible to examine carefully into village records, a general statement approaching the truth may possibly be prepared, but just now that is impossible.

29. I have now completed the descriptive section of this Report, and have tried to convey to Government, as faithfully and accurately as my capacity permits, the general impressions I have received from the different aspects of the famine. I have endeavoured to define, in so far as the available materials would allow, its boundaries, and to indicate the causes of those broad contrasts that are to be found within them. The systems of relief in action have also been reviewed, and it has been shown that, at about 100 separate centres not fewer than 80,000 helpless poor have been fed and otherwise relieved. As these crowds are being constantly changed by the passing onwards of many, at first helpless, to work as they gained strength, and from other causes, it is probable that at least 250,000 persons in all have felt the substantial benefits of this part of the relief system. It has further been shown that through the agency of special works of relief, about 140,000 more have been supplied with the means of subsistence, and to this average number too the succession of persons no doubt makes a sensible addition. By relief houses, relief works, and employment on ordinary public works, not fewer than half a million of the population must have benefited directly. The spontaneous relief sought in emigration has influenced nearly half a million more; and if account be taken of those tribes who have hitherto struggled on without accepting other relief than that from public demands on account of land, revenue, the great body of sufferers can scarcely be less than from 14 to 14 millions.

The expenditure incurred in various forms, including among them the remissions of Government Revenue which have been or will be granted, falls not much short of three-fourths of a million sterling.

The adequacy of the supplies of grain in Districts adjoining the Famine Tract, and in the Tract itself, to meet any demand likely to be made upon them, has been adverted to, and attempts have finally been made to estimate approximately the losses caused to the proprietary communities in the bad Sections of the tract by the influence of the drought. These have been estimated approximately at about three millions sterling. Heavy however as those losses have been, and most pitiable as are the personal miseries by which they have been aggravated, I believe that, should the drought now cease, and favorable rains be had, a strong re-action among the depressed proprietaries will early take place. They will need help, and doubtless help will be given to them with the same generosity as heretofore, but their future condition seems to me now to rest on the cessation or continuance of the drought. Another rainless year will prostrate utterly, I fear, the whole body of the poorer landed proprietors within the bad Sections of the Famine Tract, and the stamp of the calamity will not be effaced through many years of dreary struggle. To anticipate at this time what the future season may be is impossible. All that can be said is, that so far it has been most irregular; that utimely winds are prevailing; that, rain is falling out of season, when it is almost useless for agricultural purposes, while it is very mischievous in damaging by premature floods the works of irrigation, to which so large a portion of the people are looking for water. These irregularities may as well indicate, however, a season of excessive as of defective rain-fall. The season immediately following the great drought of 1837 was one in which rain fell to excess, but these general analogies can give no real assurance, and we can but wait and hope, admitting that for the moment the prospects of the future are justly a subject of very deep anxiety.

- 30. The remaining section of this report will detail the remedial measures which, for future protection against the calamity of drought, seem to me to be required in this part of the country. It will deal with questions of irrigation, communications, and fiscal system, some of which assume forms of exceeding complexity and difficulty. The collection of the information necessary to enable me to place them clearly before Government, will take some time, but as much of it is already under preparation, I trust it may not be long before I am able to complete this enquiry.
- 31. In closing this section, I venture respectfully to express my grateful sense of the facilities given to me in collecting information by the Honorable the Lieutenant Governors of the North-Western Provinces and the Punjab, and also to acknowledge the aid received from the Agra Central Committee.

A PROCLAMATION.

VICTORIA R.

Whereas We are happily at Peace with all Sovereigns, Powers, and States:

And whereas Hostilities have unhappily commenced between the Government of the United States of America and certain States styling themselves the Confederate States of America:

And whereas We, being at Peace with the Government of the United States, have declared Our Royal Determination to maintain a strict and impartial Neutrality in the Contest between the said contending Parties:

We therefore have thought fit, by and with the Advice of Our Privy Council, to issue this Our Royal Proclamation:

And We do hereby strictly charge and command all Our loving Subjects to observe a strict Neutrality in and during the aforesaid Hostilities, and to abstain from violating or contravening either the Laws and Statutes of the Realm in this Behalf, or the Law of Nations in relation thereto, as they will answer to the contrary at their Peril:

And whereas in and by a certain Statute made and passed in the Fifty-ninth Year of His Majesty King George the Third, intituled "An Act to prevent the enlisting or engage-"ment of His Majesty's Subjects to serve in a Foreign Service, and the fitting out or equip-"ping, in His Majesty's Dominions, Vessels for Warlike Purposes, without His Majesty's "Licence," it is amongst other things declared and enacted as follows:—

"That if any natural-born Subject of His Majesty, His Heirs and Successors, without the Leave or Licence of His Majesty, His Heirs or Successors, for that Purpose first had and obtained, under the Sign Manual of His Majesty, His Heirs or Successors, or signified by Order in Council, or by Proclamation of His Majesty, His Heirs or Successors, shall take or accept, or shall agree to take or accept, any Military Commission, or shall otherwise enter into the Military Service as a Commissioned or Non-commissioned Officer, or shall enlist or enter himself to enlist, or shall agree to enlist or to enter himself to serve as a Soldier, or to be employed or shall serve in any Warlike or Military Operation in the Service of or for or under or in aid of any Foreign Prince, State, Potentate, Colony, Province, or Part of any Province, or People, or of any Person or Persons exercising or assuming to exercise the powers of Government in or over any Foreign Country, Colony, Province, or Part of any Province or People, either as an Officer or Soldier, or in any other Military Capacity; or if any natural-born Subject of His Majesty shall, without such Leave or Licence as aforesaid, accept, or agree to take or accept, any Commission, Warrant, or Appointment as an Officer, or shall enlist or enter himself, or shall agree to enlist or enter himself, to serve as a Sailor or Marine, or to be employed, or engaged, or shall serve in and on board any Ship or Vessel of War, or in and on board any Ship or Vessel used or fitted out, or equipped, or intended to be used for any Warlike Purpose, in the Service of or for or under or in aid of any Foreign Power, Prince, State, Potentate, Colony, Province, or Part of any Province or People, or of any Person or Persons exercising or assuming to exercise the Powers of Government in or over any Foreign Country, Colony, Province, or Part of any Province or People; or if any natural-born Subject of His Majesty shall, without the lave and Licence as aforesaid, engage, contract, or agree to go, or shall go to any Foreign State, Country, Colony, Province, or Part of any Province. or to any Place beyond the Scas, with an Intent or in order to enlist or enter himself to serve, or with Intent to serve in any Warlike or Military Operation whatever, whether by Land or by Sea, in the Service of or for or under or in aid of any Foreign Prince, State, Potentate, Colony, Province, or Part of any Province or People, or in the Service of or for or under or in aid of any Person or Persons exercising or assuming to exercise the Powers of Government in or over any Foreign Country, Colony, Province, or Part of any Province or People, either as an Officer or a Soldier, or in any other Military Capacity, or as an Officer or Sailor or Marine in any such Ship or Vessel as aforesaid, although no Enlisting Money or Pay or Reward shall have been or shall be in any or either of the Cases aforesaid actually paid to or received by him, or by any Person to or for his Use or Benefit; or if any Person whatever, within the United Kingdom of Great Britain and Ireland, or in any Part of His Majesty's Dominions elsewhere, or in any Country, Colony, Settlement, Island, or Place belonging to or subject to His Majesty, shall hire, retain, engage, or procure, or shall attempt or endeavour to hire, retain, engage, or procure, any Person or Persons whatever to enlist, or to enter or engage to enlist, or to serve or to be employed in any such Service or Employment as aforesaid, as an Officer, Soldier, Sailor, or Marine, either in Land or Sea Service, for or under or in aid of any Foreign Prince, State, Potentate, Colony, Province, or Part of any Province or People, or for or under or in aid of any Person or Persons exercising or assuming to exercise any Powers of Government as aforesaid, or to go or to agree to go or embark from

any Part of His Majesty's Dominions, for the Purpose or with Intent to be so enlisted, entered, engaged, or employed as aforesaid, whether any Enlisting Money, Pay, or Reward shall have been or shall be actually given or received, or not; in any or either of such Cases, every Person so offending shall be deemed guilty of a Misdemeanor, and upon being convicted, thereof, upon any Information or Indictment, shall be punishable by Fine and Imprisonment, or either of them, at the Discretion of the Court before which such Offender shall be convicted."

And it is in and by the said Act further enacted,-

"That if any Person, within any Part of the United Kingdom, or in any Part of His Majesty's Dominions beyond the Seas, shall, without the Leave and Licence of His Majesty for that Purpose first had and obtained as aforesaid, equip, furnish, fit out, or arm, or attempt or endeavour to equip, furnish, fit out, or arm, or procure to be equipped, furnished, fitted out, or armed, or shall knowingly aid, assist, or be concerned in the equipping, furnishing, fitting out, or arming, of any Ship or Vessel, with Intent or in order that such Ship or Vessel shall be employed in the Service of any Foreign Prince, State, or Potentate, or of any Foreign Colony, Province, or Part of any Province or People, or of any Person or Persons exercising or assuming to exercise any Powers of Government in or over any Foreign State, Colony, Province, or Part of any Province or People, as a Transport or Store Ship, or with Intent to cruise or commit Hostilities against any Prince, State, or Potentate, or against the Subjects or Citizens of any Prince, State, or Potentate, or against the Persons exercising or assuming to exercise the Powers of Government in any Colony, Province, or Part of any Province or Country, or against the Inhabitants of any Foreign Colony, Province, or Part of any Province, or Country, with whom His Majesty shall not then be at War; or shall, within the United Kingdom, or any of His Majesty's Dominions, or in any Settlement, Colony, Territory, Island, or Place belonging or subject to His Majesty, issue or deliver any Commission for any Ship or Vessel, to the Intent that such Ship or Vessel shall be employed as aforesaid, every such Person so offending shall be deemed guilty of a Misdemeanor, and shall, upon Conviction thereof upon any Information or Indictment, be punished by Fine and Imprisonment, or either of them, at the Discretion of the Court in which such Offender shall be convicted: and every such Ship or Vessel, with the Tackle, Apparel, and Furniture, together with all the Materials, Arms, Ammunition, and Stores, which may belong to or be on board of any such Ship or Vessel, shall be forfeited; and it shall be lawful for any Officer of His Majesty's Customs or Excise, or any Officer of His Majesty's Navy, who is by Law empowered to make Seizures for any Forfeiture incurred under any of the Laws of Customs or Excise, or the Laws of Trade and Navigation, to seize such Ships and Vessels aforesaid, and in such Places and in such Manner in which the Officers of His Majesty's Customs or Excise and the Officers of His Majesty's Navy are empowered respectively so make Seizures under the Laws of Customs and Excise, or under the Laws of Trade and Navigation; and that every such Ship and Vessel, with the Tackle, Apparel, and Furniture, together with all the Materials. Arms, Ammunition, and Stores which may belong to or be on board of such Ship or Vessel may be prosecuted and condemned in the like Manner and in such Courts as Ships or Vessels may be prosecuted and condemned for any Breach of the Laws made for the Protection of the Revenues of Customs and Excise, or of the Laws of Trade and Navigation.'

And it is in and by the said Act further enacted,-

"That if any Person in any Part of the United Kingdom of Great Britain and Ireland, or in any Part of His Majesty's Dominions beyond the Seas, without the Leave and Licence of His Majesty for that Purpose first had and obtained as aforesaid, shall, by adding to the Number of the Guns of such Vessel, or by changing those on board for other Guns, or by the Addition of any Equipment for War, increase or augment, or procure to be increased or augmented, or shall be knowingly concerned in increasing or augmenting, the Warlike Force of any Ship or Vessel of War, or Cruizer, or other armed Vessel, which at the Time of her Arrival in any Part of the United Kingdom, or any of His Majesty's Dominions, was a Ship of War, Cruizer, or armed Vessel in the Service of any Foreign Prince, State, or Potentate, or of any Person or Persons exercising or assuming to exercise any Powers of Government in or over any Colony, Province, or Part of any Province or People belonging to the Subjects of any such Prince, State, or Potentate, or to the Inhabitants of any Colony, Province, or Part of any Province or Country under the Control of any Person or Persons so exercising or assuming to exercise the Powers of Government, every such Person so offending shall be deemed guilty of a Misdemeanor, and shall, upon being convicted thereof upon any Information or Indictment, be punished by Fine and Imprisonment, or either of them, at the Discretion of the Court before which such Offender shall be convicted."

Now in order that none of Our Subjects may unwarily render themselves liable to the Penalties imposed by the said Statute, We do hereby strictly command, that no Person or Persons whatsoever do commit any Act, Matter, or Thing whatsoever, contrary to the Provisions of the said Statute, upon Pain of the several Penalties by the said Statute imposed, and of Our high Displeasure.

And We do hereby further warn all Our loving Subjects, and all Persons whatsoever entitled to Our Protection, that if any of them shall presume, in contempt of this Our Royal Proclamation, and of Our high Displeasure, to do any Acts in derogation of their Duty, as Subjects of a Neutral Sovereign in the said Contest, or in violation or contravention of the Law of Nations in that Behalf; as for Example, and more especially, by entering into the Military Service of either of the said contending Parties as Commissioned or Non-Commissioned Officers or Soldiers; or by serving as Officers, Sailors, or Marines on board any Ship or Vessel of War or Transport of or in the Service of either of the said contending Parties; or by serving as Officers, Sailors, or Marines on board any Privateer bearing Letters of Marque of or from either of the said contending Parties; or by engaging to go or going to any Place beyond the Seas with Intent to enlist or engage in any such Service, or by procuring or attempting to procure, within Her Majesty's Dominions at home or abroad, others to do so; or by fitting out, arming, or equipping any Ship or Vessel to be employed as a Ship of War or Privateer or Transport by either of the said contending Parties; or by breaking or endeavouring to break any Blockade lawfully and actually established by or on behalf of either of the said contending Parties; or by carrying Officers, Soldiers, Despatches, Arms, Military Stores, or Materials, or any Article or Articles considered and deemed to be Contraband of War, according to the Law or Modern Usage of Nations, for the Use or Service of either of the said contending Parties, all Persons so offending will incur and be liable to the several Penalties and penal Consequences by the said Statute or by the Law of Nations in that Behalf imposed or denounced,

And We do hereby declare, that all Our Subjects, and Persons entitled to Our Protection, who may misconduct themselves in the Premises will do so at their Peril and of their own Wrong, and that they will in nowise obtain any Protection from Us against any Liabilities or penal Consequences, but will, on the contrary, incur Our high Displeasure by such Misconduct.

Given at Our Court at the White Lodge, Richmond Park, this Thirteenth Day of May, in the Year of our Lord One thousand eight hundred and sixty-one, and in the Twenty-fourth Year of Our Reign.
