



PREAMBLE

Extracts from the original Preamble to the Constitution of the Society written by the illustrious founder the late Gopal Krishna Gokhale, in 1905.

For some time past the conviction has been forcing itself on many earnest and thoughtful minds that a stage has been reached in the work of nation-building in India when, for further progress the devoted labours of a specially trained agency applying itself to the task in a true missionary spirit are required. The work that has been accomplished so far has indeed been of the highest value. The growth during the last fifty years of a feeling of common nationality based upon common traditions and ties, common hopes and aspirations, and even common disabilities has been most striking. The fact that we are Indians first, and Hindus, Mohammedans, Parsees or Christians afterwards is being realised in a steadily increasing measure, and the idea of a united and renovated India marching onwards to a place among the nations of the world, worthy of her greatpast, is no longer a mere idle dream of a few imaginative minds, but is the definitely accepted creed of those who form the brain of the community - the educated classes of the country. A creditable beginning has already been made in matters of education and of local self-government; and all classes of the people are slowly but steadily coming under the influence of liberal ideas. The claims of public life are every day receiving

wider recognition and attachment to the land of our birth is growing into a strong and deeply cherished passion of the heart. The annual meetings of Congresses and Conferences, the work of public bodies and associations, the writings in the columns of the Indian press-all bear witness to the new life that is coursing in the veins of the people. The results achieved so far are undoubtedly most gratifying, but they only mean that the jungle has been cleared and the foundations laid. The great work of rearing the superstructure has yet to be taken in hand and the situation demands on the part of workers devotion and sacrifices proportionate to the magnitude of the task.

The Servants of India Society has been established to meet in some measure these requirements of the situation. Much of the work must be directed towards building up in the country a higher type of Character and capacity than is generally available at present, and the advance can only be slow. Moreover, the path is beset with great difficulties; there will be constant temptations to turn back; bitter disappointment will repeatedly try the faith of those who have put their hand to the work. But the weary toil can have but one end, if only the workers grow not faint-hearted on the way. One essential condition of success in this work is that a sufficient number of your countrymen must now come forward to devote themselves to the cause in the spirit in which religious work is undertaken. Public life must be spiritualised. Love of country must so fill the heart that all else shall appear as of little moment by its side. A fervent patriotism which rejoices at every opportunity of sacrifice for the motherland, a dauntless heart which

refuses to be turned back from its objects by difficulty or danger, a deep faith in the purpose of providence which nothing can shake-equipped with these, the worker must start on his mission and reverently seek the joy which comes of spending oneself in the service of one's country.

The Servants of India Society will train men, prepared to devote their lives to the cause of the country in a religious spirit and will seek to promote, by all constitutional means the national interest of the Indian people. Its members will direct their efforts, principally towards (1) creating among the people by example and by percept, a deep and passionate love of the motherland, seeking its highest fulfilment in service and sacrifice; (2) organising the work of political education and agitation, basing it on a careful study of public questions and strengthening generally the public life of the country; (3) promoting relations of cordial goodwill and co-operation among the different communities; (4) assisting educational movements especially those for the education of women, the education of backward classes and industrial scientific education; (5) helping forward the industrial development of the country; (6) the elevation of the depressed classes.

Report for 1990-91

Introduction

The Servants of India Society was founded by Gopal Krishna Gokhale on June 12, 1905. Its objects are the training of national missionaries for the service of India and the promotion by all constitutional means, of the interest of the Indian people without distinction of caste or creed. The members of the Society are pledged to give throughout their lives the best that is in them to the cause of the country in all secular fields. The circumstances in which the Society was founded and the objects, which the Founder had in view in founding it, are explained in the preamble he wrote to its constitution in 1905, extracts from which are given in the preceeding pages. The Preamble has been a source of inspiration to the Society during the eighty-six years of its existance.

Organisation

The Headquarters of the Society are at Poona, where the members meet every year in June for its annual session. The Society has branches in Madras, Bombay, Nagpur, Allahabad and Cuttack.

Shri. S. S. Misra and Dr. R. G. Kakade were elected President and Vice-President of the Society respectively. Shri S. S. Ajgaonkar was elected Secretary of the Society. shri S. S. Misra, Dr. R. G. Kakade, Shri. S. S. Ajgaonkar and Shri. P. K. Dwivedi continued to be Senior Members of the Society's branches at Cuttack, Nagpur, Bombay and Allahabad respectively. The Madras Branch was looked after by the Headquarters. Shri Damodar Sahoo, Shri. A. N. Misra and Shri. M. M. Dhanore were elected members of the Council.

TRIBAL AND BACKWARD CLASSES WELFARE WORK

UTTAR PRADESH

The tribal work in state U.P. has been divided into two zones.

1. Eastern Zone - Mirzapur and Sonebhadra

2. Western Zone - Haridwar, Bijnore, Nainital, Lakhimpur, Kheri and Gonda.

Shri P. K. Dwivedi continued to be Senior member. Shri A. N. Misra was incharge of Eastern zone.

Education Work for Tribals

The Society maintained 14 Primary Schools in Sonebhadra district and 2 primary schools in Mirzapur district. All these schools have their own buildings and are regularly inspected by the concerned department. In tribal belt of Northen U.P. 13 primary schools were managed by Bazpur centre of the Society. Out of 13 schools 8 are in Nainital, 2 in Bijnore and 3 in Haridwar district. All schools are recognised by Basic Shiksha Parishad. The total number of students in 29 schools is 2390.

Five Junior High Schools are being run by U.P. branch at Daupolia, Mazarabidhi, Siltham, Muirpur and Salkhan. All students of these schools are mostly from poor families and results of the schools are above 90 percent.

High Schools for tribals - is being run at Siltham (Sonebhadra) for higher secondary classes. 154 students

are learning in this high school.

Ashram school for girls is maintained at Khaliyari in Sonebhadra dist., in which 45 SC and 5 non SC. girls are learning. Along with education, facilities for free lodging, food, clothes are also provided. The Society is maintaining two Ashram Schools to eradicate illiteracy of the tribal girls, one at Bazpur for Buxa community and other at Chandan Chowki for Tharu Community. Total 160 tribal girls are learning in these schools. Society maintains two Ashram Type Schools for Boys at Siltham (Sonebhadra) and Khantara (Mirzapur). There are 150 inmates in these A. T. S. The total expenditure for A. T. S. Khantara was Rs. 1,68,562/- and for Siltham was Rs. 2,21,215.20 during the year.

With financial aid from U.P. state the Society maintains two Harijan and Adivasi hostels at Muirpur and Salkhan for 78 SC students. Hostels for tribal students number five in western zone of U.P. and are situated at Bazpur (Nainital) palikalan (Lakhimpur) Chandan Chowki (Lakhimpur), Tulsipur (Gonda) and Panchperwa (Gonda).

The total number of students is above 250. SC Boys Hostel is being run at Ghuwas (Sonebhadra). The total number of inmates is 30.

Type-writing Institute for 20 students is maintained at Bazpur (Nainital) with total expenditure during the year of Rs. 16,300/ only. With financial aid from Govt. of India the Society maintains three Harijan and Adivasi Typewriting Institutes. 94 SC. trainees took benefit of these institutes this year.

Shri Dinesh Misra organised tribal conferences at

Chandan Chowki in Lakhimpur-kheri district to highlight the burning problems of the Tharu community. He has devoted most of his time for tribal welfare.

ORISSA

Shri Ramakanta Lenka managed the following Tirbal Welfare work of the Rayagada centre under the guidance of Shri M. S. Sahoo.

- 1. Thakkar Bapa Ashram
- 2. Four Primary Schools
- 3. Tailoring Training centre
- 4. Maternity centre
- 5. Balwadi centre (2 Nos)

The similar activities are also being run by Choudwar Centre of Orissa. Mr. Gangadhar Sahoo organised free medical camps in various villages where our pre-schools are running. Free medicines were distributed to the patients on behalf of the centre. Thakkar Bapa Ashram of Rayagada centre accomodates 75 SC. and ST school going students. The Rayagada primary school is being run for 260 students.

MAHARASHTRA

Mr. Ulhas Rajadnya has been working among Thakar tribals of Rayagad District of Konkan area of Maharashtra. The stress has been given on organising them. Many meetings and Shram Dan camps were organised to create physical assets like roads, wells for public purpose.

Tree Plantation programmes in Khandala Ghat in the ranges of Sahyadri mountain was orgainsed in which tribals also participated. A medical assistance and Health Education

-

Scheme is also being run by Ulhas Rajadnya for three years, which has benefited one thousand rural and tribal persons.

Shri Dhanore frequently visited 15 villages of Kannad taluka of Aurangabad dist. inhabited by tribals to acquaint himself with their problems. Shri Dhanore secured 132 bullock-carts for tribals through bank-loan. Due to his efforts 12 families could get 3 acres of land for cultivation.

MEDICAL

ORISSA

Orissa unit runs Saraswati Sahoo maternity centre at Choudwar which was inagurated on 10/1/89.

Shri Damodar Sahoo organised medical relief camp in different villages with the help of eminent physicians. He also distributed medicines to the patients.

Shri Gangadhar Sahoo organised free medical camps in various villages where our pre-schools are running. He also organised a special free medical camp at Kakhadi Panchayat, for treating diarohea infected people.

Shri Ramakanta Lenka organised a health check-up and free medicine distribution camp in the Sirikona village in which physician checked 200 patients.

MAHARASHTRA

Shri S. S. Ajgaonkar was a member of the supervising Committee of Bal Bachbai Kanji Charitable Allopathic Dispensary and Ayurvedic dispensary of the League. Shri R. G. Kakade was a trustee of the trust for Integrated Medicines, Health and Population.

Mr. Ulhas Rajadnya is running Health Education and Medical assistance scheme in Karjat Block of Rayagada District.

Mr. Ulhas Rajadnya has arranged six medical camps during the year under report. Mr. Rajadnya admitted few serious cases of Nephorotic Syndrom in Wadiya Hospital, Bombay and of uterus-Cancer in Sasoon Hospital, Pune.

UTTAR PRADESH

With the financial aid from U. P. Ayurvedic Department, the Society maintained one Ayurvedic dispensary at Tikuria centre through which 164 new patients took benefit this year.

Mr. A. N. Misra was in charge of this activity.

DISTRESS RELIEF

MAHARASHTRA

Shri Kakade continues to be Hon.Secretary of the Maharashtra Association for the Relief and Eradication of Famine.

Shri Ulhas Rajadnya helped the Slum-dwellers of Lonawala City whose hutments were destroyed in floods. ORISSA

Shri Damodar Sahoo attended the relief work which was conducted by Shri. P. K. Samal, labour and Employment, Govt. of Orissa, for the victims of riots between two communities on 24th March 1991.

Shri Damodar Sahoo distributed sarees to the tribal ladies and winter clothing to the patients suffering from Leprosy in the Choudwar Municipal area.

Shri Madhusudan Sahoo, as a chairman of Banabashi Bikash Trust, distributed about Rs. 9000/- for different relief activities during the year.

Shri Madhusudan Sahoo is also active as Secretary of trust "Shashwat Mangalam".

WOMEN WELFARE AND CHILD DEVELOPMENT

UTTAR PRADESH

Working Women's Hostel

To provide residential facilities on nominal rent Shri Dwivedi managed a working women's hostel for working women who come from different parts of the country and work in different offices in Allahabad.

To provide proper guidelines for the betterment of living Shri Dwivedi organised 4 awareness programmes for rural women in Nainital and Bijnore district. Shri Dwivedi also constituted several Mahila Mandal Kendra and Charcha Mandal under awarenss programme for the awakening of the rural women.

Shri Dwivedi is very much cautious to provide proper care to the tribal children as they are neglected by their parents. Shri Dwivedi organised 4 health camps for tribal children at Kanpur, Mandpur, Moulapuri and Mayagaon.

Women's Welfare Centre with financial aid from the Govt. of India (Ministry of Welfare-Sch. Cell) the Society maintained 5 women's welfare centres which are located at Patna (Robertganj tahsil), Bidar Mahavriya, Kundah and Kůdari (all in Sonebhadra district)

MAHARASHTRA

The women Resources and Development centre extended assistance to women in distress to help them to fight out their legal matters, to help them to seek legal advice, to get reconciliation with their family members.

Shri Ulhas Rajadnya has also been in favour of reconciliation and has extended his co-operation to the needy families for that. Three cases were settled amicably and in cheerful atmosphere with the help of officers of family court.

Shri Kakade continued to be a member of the Managing Committee of the Mahila Seva Mandal. The Mandal runs a Rescue home for women in moral danger, a hostel, a school and a Udyog Section.

Shri S. S. Ajgaonkar as a Vice-President of the social Service League has started creche to serve the needs of employed women. Shri S. S. Ajgaonkar is associated with Vidya Vinay Sabha which conductrs 'Gurukul' residential school at Tungarli, Lonavala, Taluka Mawal.

ORISSA

The Koraput division of Orissa is managing a Maternity centre and it covers tribal villages. During the period under report the mid-wife has conducted 39 deliveries (38 ST & 1 SC.) attended 33 pregnancy cases (33 ST) and distributed medicines in the villages to 349 patients for minor ailment. (340 ST. 3 SC, and 6 other castes)

The Rayagada centre is managing two Balwadi centres in the villages Barixola and Advasi Sani with a view to take care of SC / ST children with the financial assistance from Bhartiya Adim Jati Sevak Sangh, New Delhi. About 80 children get the benefit during the year and they are given supplimentary Nutrition for 27 days in a month.

EDUCATION

MAHARASHTRA

Dr. R. G. Kakade is giving guidance to following institutions :-

- a) Shri Kakade continued to be a member of the Board of Management of Gokhale Institute of Politics & Economics. He was a representative of the Trustee-Society on the Internal Management Committee and Selection and confirmation Committee of the Institute of Politics & Economics. He attended all meetings of I.M.C. and SCCOM.
- b) He continued to be chairman of the Kanara Welfare Trust in Ankola (Kanara Dist.)
- c) Shri Kakade was re-elected Hony. Treasurer of Maharashtra Association for the cultivation of science.
- d) Shri Kakade continued to be a Chairman of Padmashri
 Dr. Vikhe Patil Foundation, Pravaranagar in Ahmednagar dist.
- e) Shri Kakade continued to be a Chairman of the Academy of Education and Youth Service.
- f) Shri Kakade attended all meetings of the Governing Body of the Vidya-Jyoti School for slow learners.

Shri S. S. Ajgaonkar is giving guidance to following institutions :-

- a) Shri Ajagonkar continued his work on the education committee of the Social Service League, Bombay.
- b) Shri Ajaonkar continued to be a member of the Mafatlal Gagalbhai Textile Institute supervising committee of the Social Service League.
- c) Shri Ajgaonkar was a member of the league's supervising Committee for six industrial schools for women. At present 4 courses are taught in these schools.
- d) Shri Ajgaonkar was actively associated with N. M. Joshi Social Workers' training class of the League.
- e) Shri Ajgaonkar was a member of the Board of Management of Gokhale Institute of Politics & Economics.
- f) Shri Ajgaonkar was also a member of Governing Body of Vidya-Jyoti Institute of Education.

Shri Ulhas Rajadnya is actively working with following Institutes :-

- a) Mr. Ulhas Rajadnya continued to be Executive council member of Satpuda Shikshan Prasarak Mandal and helped the mandal in its administration.
- b) Shri Ulhas Rajdanya continued to be E. C. member and Secretary of Human Resources and Rural Development Centre Pune. Shri. Dhanore had started seasonal schools to provide education to the children of migrating labourers.

UTTAR PRADESH

Shri. P. K. Dwivedi devoted most of his time for educational advancement of the rural and tribal people living in five districts of north western U. P. Shri P. K. Dwivedi continued to be secretary of Shiksha Prasar Samiti, Bazpur. Shri Dwivedi is the life member of the managing committee of Adarsh Kanya Junior High School, Bazpur. To impart better education to children up to Vth standard, Dr Kunzru Nursery and Primary school is being run for 343 students with the help of 18 qualified teachers and 4 Ayas. Shankar Prasad Nursery School at Siltham is being run with Society's own fund. There were 34 students during the year under report.

ORISSA

Shri Madhusudan Sahoo was engaged in imparting moral education in middle schools and secondary schools of Orissa continuously for the 8th year. He has so far conducted 458 meetings including class-room talks and large gatherings and has met around 58.400 students. Shri Madhusdan Sahoo feels confident that in long run his project will show some guidlines in the subject "moral education in Secondary Schools." Shri Ramakanta Lenka continued to be the President of the managing committee of Bari Girls High School and Bari M. E. School of Balasore district.

TAMILNADU AND KERALA

The Society's Branch office in Tamilnadu is located at No. 16, Karpagambal Nagar, Mylapore, Madras. Shri P. N. Gopal Rao is the Manager of the Branch. The Society has building at Maynoor where Society intends to start new activity. At Nirgacimund (Udagmandalam District) the Society runs Thakkar Bapa Gurukulam for Todas and Kotas, Tribal Children of the Nilgiris in Tamilnadu. The five schools in Kerala, namely Devdhar U. P. School Nediyiruppu, Devdhar L. P. School Karulai, Devdhar L. P. School Pulliyil, Gokhale U. P. School Mudadi and Sastriar U. P. School Chalode situated in the interior of Malapuram and Nilamber forest areas continued to function satisfactorily as in the past, serving the educational needs of the Backward classes and Mopla Muslims. K. Viswanathan Nair, Society's Attache is in charge of the schools.

NEDIYIRUPPU

The place is about 30 kilometers from Calicut on the Calicut Manjeri Road. This school has three classes i. e. from 5th to 7th standards with Seven divisions. Majority of students and teachers were from SC community.

CHALODE

This is the place where Shri. Viswanathan Nair, attache of the Society resides. It is about 60 miles south east of Calicut. To reach this place one has to take a bus from Nediyiruppu to Nilambur and then to village Poo koo tampadam. From there one has to ply by private vehicle to Chalode. The school is situated on a ground having an area of 3.5 acres. The school has open-air theatre for conducting meetings and cultural activities. The school has seven standards from I to VII. There are male and female teachers in the school.

KARULAI

The place is about 3 kilometers from chalode. The school is situated at an elevated place. The school has four standards from I to IV. There are scheduled castes and trible students in the school.

PULLIYIL

The School is on elevated grounds. It has four standards. B. s & girls from scheduled castes and scheduled tribes study in the school.

MUDADI

This place is about 60 kilometers north of Calicut on the Calicut-Badagara Road. To reach the school from the Bus stop one has to walk about 2 kilometers. The school is situated on the hill surrounded by cashew and coconut trees, which give annual income to the school. The school has open-air theatre to conduct meetings and cultural programmes. The school has seven classes.

All these five schools from the different villages are not burden to the Society and are run with public participation. ince the time of visit of the late Shri. G. K. Deodhar to Calicut when the Malabar was in grip of epidemics Deodhar Memorial Rehabilitation Trust was started. These schools are outcome of these trusts. The people hold Deodhar in great esteem and great respect for the Society and its activities.

SOCIAL SERVICE

MAHARASHTRA

Dr. R. G. Kakade continued to be chairman of Pune District Probation and Aftercare Association which conducts two remand homes for boys, a remand home for girls and a child guidance centre for problematic children in Pune. $\hat{L} = 2$

Dr. R. G. Kakade continued to be a member of the managing Committee of the Society for the welfare of the Physically Handicapped at Wanavadi. Dr. R. G. Kakade attended as member of the Executive Committee of the Navjeevan Mandal which aims at solving the problems of released prisoners with a view to facilitate their rehabilitation in the Society. Shri Deshmukh was the Secretary of Navjeevan Mandal.

Dr. R. G. Kakade continued to be a member of the Managing committee of the David Sasoon Infirm Asylum. Dr. R. G. Kakade continued to be the managing Trustee of the late Justice Mahadeo Govind Ranade Charitable Trust.

Shri S. S. Ajgaonkar was a member of the Health Committee of the Association for Social Health in India. He was re-elected the Vice-President of Social Service League. Association's activities are carried in predominently working class areas.

Shri S. S. Ajgaonkar continued to be a member of the Social Service League - Gymnasiym Committee. Shri S. S. Ajgaonkar was also a member of the Library Committee of the League.

Apang Margadarshan and Punarvasan Kendra

The Kendra helped the crippled solve their various problems relating to educational, physical, psychological, social, economic, etc. matters under the guidance of the experts in the related fields.

A team of crippled was sent by the kendra to participate in the athelatic meet competition at Bombay and Delhi.

The Kendra collected work orders on behalf of the crippled who could thereby be gainfully employed. One of the worker has been selected as best worker and received award from the President of India.

Shri Neve attended all meetings of Rashtriya Apang Vichar Manch. The Manch tries to create awareness among disables.

Shri Neve attended meetings of Human Resources Development Centre. The centre is doing Adult Education and Rural Development work in this area.

Shri Neve as Hon. Secretary of Shri Dajisaheb Dnyan Vistar Sanstha attended meetings of the Managing Body of the Sanstha. The sanstha arranged discussions on various topics during the year.

Shri Ulhas Rajadnya helped a lot to organise a Youth Camp at Village Bavdhan. Sixty college students constructed a road and a drainage system for the village. Mr. Rajadnya also worked as a Youth trainer and delivered two lectures on skills of social work. Shri Ulhas Rajadnya helped National Federation for the Blinds to raise funds by organising musical concert.

UTTAR PRADESH :

Shri Atma Nand Misra continued to be member of the Executive council of the All India Seva Samiti.

ANDHRA

Shri. S. S. Mistra supervised the activities of the G. C. Home at narasannapet in Srikakulam dist. of Andra Pradesh. This Institute which was started in 1945 has grown steadily and till 1973 it was serving 45 male orphan childeren in the age group of 6 to 16. After the State Govt. stopped its grant from June 1973, there was a setback. But the institution has been receiving boarding grants from the State Govt, of Andhra and the last instalment of this gradt amounting to Rs. 8000/- has been received during the year. The A. P. State Social Welfare Advisory Board, Hyderabad was pleased to Sanction a further grant of Rs. 2000/- to our institution for this year 1990-91. During the year under report there were 20 inmates. This institution is providing besides free boarding the lodging, clothing, soaps, tution fees and books. Each boy is supplied with a cot, bedlinen, mosquito net, stainless steel plate, cup and tumbler. Independence Day, Republic Day are celebrated. Sports and games facilities are provided to inmates.

ORISSA

Shri Madhusudan Sahoo was the chairman of the Banabashi Bikash Trust which has been founded at Baliguda in Phulbari district by Shri Biswanath Patnaik, a Sarvodaya leader of Orissa.

Shri Madhusudan Sahoo was able to organise the school days friends in an association called '1950-Chhatra-Sangh.' A fund was created to give annual awards amounting to Rs. 100 each to meritorious students of the Baliguda High School.

RURAL DEVELOPMENT

To develop the nation, we will have to develop our villages. Our Central Govt. also realised to full-fill minimum needs of the villagers through rural development schemes. To solve the problems of the villagers we have to work on gross root level. Only attractive slogans can not solve the problems.

Shri Dwivedi has classified his work under the following heads:

Meetings & Seminars

Shri Dwivedi organised a tribal conference at Chandan chowki in the month of Feb. 91. Shri Dwivedi organised four rural camps and collected much informations regarding their problems and visited different govt. departments for the solution. Shri Dwivedi organised charcha Mandal among Buxa Community.

Adoption

Shri Dwivedi has already adopted 'Mahtosh More'' in his adoptation schemes of rural development. He met Chief Development officer, Nainital and discussed about the residential problems of the Bangali people.

For the educational development Shri Dwivedi has started Balwadi school in Mahtosh More. The development efforts are being done in favour of Mahtosh More.

The Mazara Bidhi is declared the Adersh Harijan Village

of the Nainital district. Roads, Electritiation, Primary School Junior High School, Primary Health Centre and Community Hall everything is there. The villagers are appreciating the co-operation of the Society for their development.

Demonstration

Really demonstration is very very essential to approach the rural teachnology among villagers. Shri Dwivedi has started different type of demonstrations at Bazpur and Chandan chowki.

Fishery demonstration Farms

A fishery demonstration farm is developed at Bazpur in the premises of Buxa Hostel, Only to provide practical knowledge to the tribal people. This year total income from the farm was Rs. 7,500.00 only.

During the year Shri. Dwivedi earn an amount of Rs. 2,000.00 from water unit.

Paddy Demonstration

During the year Paddy demonstration was well organised by the hostel supdt. at Chandanchowki with the help of A. D. O. Ag. The total income from the paddy was Rs. 5,430.00 only.

MAHARASHTRA

Shendurjana Bazar

Shendurjana Bazar centre which was opened by the Society fifty six years ago, continued to function actively under R. V. Neve.

Shri Kakade continued to be Hony. Treasurer of the Deccan Agricultural Association. The editor of its journal, the Shetki and Shetakari, is not keeping well for the last 5-6 months. Shri Kakade has been attending to the work of the Association and the journal, in his absence. A preliminary meeting with the officials of the Agricultural Directorate has decided to held a state-level Agricultural and Rural Development conference. The dates and the venue of the Conference will be decided soon.

Shri Dhanore started during the year under report, the Government of India's Kisan Nursery Scheme for the first time to help afforestation schemes in Aurangabad district. So far he has prepared 50,000 soplings of trees which agriculturists in 19 villages are going to be used for plantations on waste lands. Before starting this schemes Shri Dhanore organised meetings of farmers and explained to them the need and importance of afforestation from the national point of view. He secured financial assistance from the Bharatiya Agro Industries Federation (BAIF). On behalf of the Society he has been working as an organisor and Guide of the BAIF's project.

With the financial help from the BAIF Shri Dhanore

also implemented in 10 villages the Government of India's scheme of National Environment Awareness Camps. The Scheme children, farmers and others about the necessity of protecting natural resources like land, water, forests, flore and feuns to maintain balance amongst them all and thereby preserve environment balance.

During the year under report Shri Dhanore organised at Sangvi and Garkheda to provide training to women in preparing handicraft articles from sisal fiber. He provided training to 28 women, helped them in securing loan from banks to start their own business and to become self-supported.

Shri Dhanore continued to be the Hony. Secretary of the Pralhad Smarak Wachanalaya at Deoni which is considered and known as the best rural library. He also continued to be the chairman of the Devgiri Multi-Purpose service Co-Purpose service Society and tried to provide as much loans as possible to farmers for development purposes.

ANNUAL REPORT 1990-91

The Gokhale Institute of Politics and Economics is one of the oldest research and training institutes in Economics in the country. It was founded on 6th June 1930 from an endowment offered to the Servants of India Society by the late Rao Bahadur R. R. Kale, Member of Legislative Council from Satara. The Servants of India Society, founded by late Shri Gopal Krishna Gokhale, are the Trustees of the Institute. The Institute is registered under the Societies Registration Act, 1860 and the Bombay Public Trusts Act, 1950.

(35)

The objective of the Institute is to conduct research into the economic and political problems of India and to train research workers in these subjects. Under the pioneering leadership of late Professor D. R. Gadgil, the founder Director of the Institute, the Institute set standards for high quality research and training in a variety of fields of economics.

In 1990-91, twelve studies were completed in various areas such as agricultural economics, demography, planning etc. A number of studies in these areas and other areas such as macroeconomics, monetary economics, transport, adult literacy were in progress during the year. The members of the research staff published 19 research papers and monographs during the period under report. The research staff also participated in several national and international conferences/Seminars, delivered lectures in other institutions/organizations and continued to work on various committees appointed by the Central and the State Governments and by other public agencies. Some staff members visited other countries for research studies. Four scholars and academicians from foreign countries visited the Institute and gave seminars,

Apart from the work on various research projects, the members of the research and teaching staff were engaged in the teaching programme for the M. A. course in Economics. They also continued to guide Ph. D. research students during the year under report.

There were 41 students in the M. A. class in the Institute. Six teacher fellows under the UGC Teacher Fellowship Programme, continued to work in the Institute on their research.

*

Twelve students were awarded the M. Phil. degree and one student Ph. D. degree in Economics by the University of Poona during 1990-91.

Under the P. V. Pandurangi Prize Endowment, the Pandurangi Prize was awarded to Smt. Malika B. Mistry for her M. Phil. dissertation entitled 'Hindu-Muslim Fertility Differentials in India.'

UGC Sponsored Refresher Courses.

During the year 1990-91, the Institute continued to conduct the refresher courses in Economics for college and university teachers in Western Region of India sponsored by the University Grants Commission. The courses of three weeks duration each were successfully completed by the Institute in co-operation with the Academic Staff College of the University of Poona as per following details :
