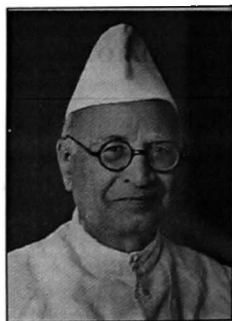

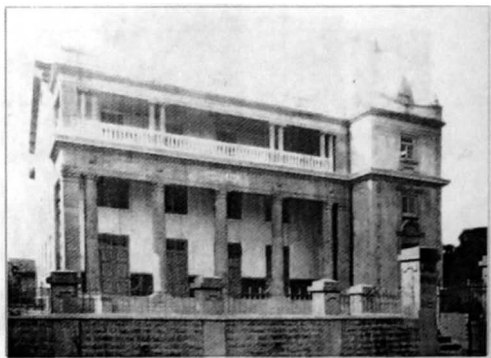

## PREAMBLE

Extracts from the original Preamble to the Constitution of the Society written by the illustrious founder the Late Gopal Krishna Gokhale, in 1905.

For some time past the conviction has been forcing itself on many earnest and thoughtful minds that a stage has been reached in the work of nation-building in India when, for further progress the devoted labours of a specially trained agency applying itself to the task in a true missionary spirit are required. The work that has been accomplished so far has indeed been of the highest value. The growth during the last 106 years of a feeling of common nationality based upon common traditions and ties, common hopes and aspirations, and even common disabilities has been most striking. The fact that we are Indians first, and Hindus, Mohammedans, Parsees or Christians afterwards is being realised in a steadily increasing measure, and the idea of a united and renovated India marching onwards to a place among the nations of the world, worthy of the great past, is no longer a mere idle dream of a few imaginative minds, but is the definitely accepted creed of those who form the brain of the community, the educated classes of the country. A creditable beginning has already been made in matters of education and of local self-government; and all classes of the people are slowly but steadily coming under the influence of liberal ideas. The claims of public life are every day receiving wider recognition, and attachment to the land of our birth is growing into a strong and deeply cherished passion of the heart. The annual meetings of Congresses and conferences, the work of public bodies and associations, the writing in the columns of the Indian Press—all bear witness to the new life that is coursing in the veins of the people. The results achieved so far are undoubtedly most gratifying, but they only mean that the jungle has been cleared and the foundations laid. The great work of rearing the



superstructure has yet to be taken in hand, and the situation demands on the part of workers devotion and sacrifices proportionate to the magnitude of the task.

The Servants of India Society has been established to meet in some measure these requirements of the situation. Much of the work must be directed towards building up in the country a higher type of Character and capacity than is generally available at present, and the advance can only be slow. Moreover, the path is beset with great difficulties; there will be constant temptations to turn back; bitter disappointment will repeatedly try the faith of those who have put their hand to the work. But the weary toil can have but one end, if only the workers grow not faint-hearted on the way. One essential condition of success in this work is that a sufficient number of your countrymen must now come forward to devote themselves to the cause in the spirit in which religious work is undertaken. Public life must be spiritualised. Love of country must so fill the heart that all else shall appear as of little moments by its side. A fervent patriotism which rejoices at every opportunity of sacrifice for the motherland, a dauntless heart which refuses to be turned back from its objects by difficulty or danger, a deep faith in the purpose of providence which nothing can shake equipped with these, the worker must start on his mission and reverently seek the joy which comes of spending oneself in the service of one's country.

The Servants of India Society will train men, prepared to devote their lives to the cause of the country in a religious spirit and will seek to promote, by all constitutional means the national interest of the Indian People. Its members will direct their efforts principally towards (1) creating among the people by example and by precept, a deep and passionate love of the motherland, seek its highest fulfilment in service and sacrifice; (2) organising the work of political education and agitation, basing it on a careful study of public questions and strengthening generally the

public life of the country; (3) promoting relations of cordial good will and co-operation among the different communities; (4) assisting educational movements especially those for the industrial development of the women, the education of backward classes and industrial scientific education; (5) helping forward the industrial development of the country; (6) the elevation of the depressed classes.

**VOWS:**

The country shall always be the first in my thought and I will give to her service the best that is in me.

In serving the country I will seek no personal advantage for myself.

I will regard all Indians as brothers and work for the advancement of all without distinction of caste or creed.

I will be content with such provision for myself and my family, as the Society may be able to make. I will devote no part of my energies to earning money for myself.

I will lead a pure personal life.

I will engage in no personal quarrel with any one.

I will always keep in view the aims of the Society, and watch over its interest with the utmost zeal, doing all I can to advance its work. I will never do anything, which is inconsistent with the objects of the Society.

## **REPORT FOR THE YEAR 2010-2011**

### **INTRODUCTION**

The Servants of India Society was founded by Gopal Krishna Gokhale on June 12, 1905. Its objects are the training of national missionaries for the service of India and the promotion by all constitutional means, of the interest of the Indian people without distinction of caste or creed. The members of the Society are pledged to give throughout their lives the best that is in them to the cause of the country in all secular fields. The circumstances in which the Society was founded and the objects, which the Founder had in view in founding it, are explained in the preamble he wrote to its constitution in 1905, extracts from which are given in the preceding two pages. The Preamble has been a source of inspiration to the Society during the 106 years of its existence.

### **ORGANISATION**

The Headquarters of the Society are at Pune, where the members meet every year in June for its annual session. The Society has branches in Chennai, Mumbai, Nagpur, Allahabad, Cuttack, Raygada and Kerala.

Shri Madhusudan Sahoo is the President of the Society. Shri A.C. Tripathy is the Vice-President of the Society. Shri M. B. Deshmukh is the Secretary of the Society. Shri S. S. Ajgaonkar, Shri R. V. Neve, Shri Damodar Sahoo, Shri Ramakant Lenka, Shri Gangadhar Sahoo, Shri A.C. Tripathy, Shri Dinesh Misra continued to be the Members of Mumbai, Nagpur, Cuttack, Raygada, Choudwar and Allahabad branches of the Society, respectively. The Chennai Branch was looked after by the headquarters. Shri A.C. Tripathy and Shri Gangadhar Sahoo were elected members of the Council.

Shri Madhusudan Sahoo was elected as the President of the Servants of India Society on June 12, 2009. In list of incumbency, he became the 10th President of the Society.

He tried to revive the old system of writing weekly letters. In place of weekly letters, writing of monthly letters have been introduced. He looked into the accounts of the Mirzapur Centre and advised to close down the centres for which Government grants were not forth-coming since 1998.

Being the ex-officio President of the Board of Management of the Gokhale Institute of Politics and Economics he presided over all the meetings which were held on dates 16.10.2010, 14.01.2011 and 26.03.2011. He presided over the 17th Convocation of the G.I.P.E. on January 14, 2011. In the said meeting, the Kale Memorial Lecture was delivered by Prof. Sukhadeo Thorat, Chairman, UGC.

Shri Madhusudan Sahoo was associated with Banabashi Seva Samiti, a NGO, which was founded in the year 1972 in the Kandhamal District of Odisha. Shri Biswanath Patnaik, popularly known as 'Ajna' in Odisha, who was a freedom fighter, a great Sarvodaya leader and a companion of Vinobaji during Bhoodan movement was its founder. He passed away on 27th March, 2009. Thousands of people from all parts of Odisha had assembled and took part in the funeral procession. We cannot even dream to rise to that height and become such a great social leader who had adored the hearts of adivasis in Odisha.

With the financial help from Govt. of India, Ministry of Tribal Affairs, Shastri Bhavan, New Delhi, Servants of India Society maintained two hostels for Tribal Communities for their educational upliftment in Balrampur District, Uttar Pradesh.

#### **1. THARU JANJATI BOYS HOSTEL PACHPERWA, BALRAMPUR**

The Hostel provides food, lodging, reading, writing materials, games and sports materials free of cost to the inmates. The inmates are provided with three sets of uniforms. The society has appointed a doctor to provide medical facilities to the inmates who visits once in a week and prescribes, the hostel required medicines as per the need.

#### **4. WORKING WOMEN'S HOSTEL ALLAHABAD**

As resident member of the U.P. Branch Center Sri Tripathi was looking the day to day management of Working Womens' Hostel. . The total income of the Working Women's Hostel was Rs. 11,00,000.00 and the total expenditure on maintenance of the Hostel was Rs. 5,32,147.50 only during the year under report.

#### **MAHARASHTRA STATE**

#### **SHRI M. B. DESHMUKH**

As the General Secretary of the Society, he looked after the day to day affairs of the Society's Headquarters Office at Pune. These included the maintenance and Administration of the Society property, day to day correspondence including correspondence from the branches of the Society and to look after the budget and accounts matters of the Society. He submitted the Income Tax return of the Society for the year 2009-2010. He submitted the Budget estimates of the Society to the office the Charity Commissioner, Pune for the year 2010-2011. He monitor the finances & disbursement of Grants to the Branches, maintained records at the headquarters. He also worked on the Building Committee and Finance Committee of the Gokhale Institute of Politics and Economics.

He had to devote considerable amount of time towards the court cases of the Socociety and the GIPE as well. This involved the studying of case papers, identifying and appointing the Advocates and briefing them about the cases and also attending the hearings in the Courts.

As a Society's nominated member on the Board of Management of the Gokhale Institute of Politics and Economics, he attended all meetings of this Board as and when they were called by the Director of the Institute

and actively participated in the proceedings. He also worked as a member on the Staff Selection Committee of the Gokhale Institute of Politics and Economics.

A number of decisions were taken in the Annual General Body Meeting and also in the Council meeting of the Society held in June, 2010 and he took necessary action to implement all the decisions taken in these meetings.

During the year under report, the University Grants Commission (Institutes Deemed to be University) Regulations 2010 was received in July 2010. These required revision of Board of Management and also Rules Governing the GIPE. He apparised from time to time all the office Bearers and Members of the Servants of India Society about these Regulations and ultimately the matter has been placed before the meeting Scheduled to be held in June, 2011. Alongwith the office bearers of the Society he met the concerned officials of M.H.R.D., Government of India, New Delhi and discussed it's implications.

At times as the contingencies arose, he attended the Society's Council meetings held elsewhere in the Branches. Besides the shouldered the responsibilities as mentioned below and carried them out satisfactorily.

This year also a distribution of medicinal kheer was done on the occasion of Sharad Purnima. As a managing trustee Shri Dwivedi organized as well as attended various

meetings of the Nyass. Shri Dwivedi also continued to be the life member and executive committee member of the Adarsh Kanya Intermediate College, Bazpur and attended its meetings held from time to time.

Shri Dwivedi continued to be the Council Member of the Bhartiya Adim Jati Sevak Sangh, New Delhi. On the occasion of Women's Day a conference was organized under the auspices of the Sangh which was attended by around one thousand balsevikas from all over the country. ## **CENTRE'S REPORT**

### **TRIBAL WELFARE WORK**

The Servants of India Society has played a crucial role in the welfare of the indigenous tribal communities of the Tarai region. The society has been active in Tribal Welfare since 1967. For the welfare of the Buxa and Tharu Tribal communities the Society started Buxa Boys Hostel at Bazpur

and other welfare schemes like Adult Education Centres, balwadis and Primary Schools. It also established hostels for boys at Lakhimpur Keri (Palia), Chandan Chowki, Balrampur and Gonda along with Ashram Type Schools at Bazpur, Palia and Chandan Chowki. Later on, Senior Secondary Schools were also established by the Society. All these schemes have helped in bringing educational advancement of the beneficiary communities.

These activities got appreciation in the year 1995 when it was reported in the National Planning Commission's Report which said that the Servants of India Society was doing 'Good Work' in the field of Tribal welfare. The Servants of India Society was also awarded the status of an 'Established Voluntary Organization' by the Ministry of Social Justice and Empowerment (2000) and Ministry of Tribal Affairs (2004). Since its establishment in 1969, the Buxa Boys Hostel has been playing a good role in the educational advancement of the Buxa and Tharu students of the Tarai region. The Buxa Boys Hostel is a residential Hostel which provides fooding, lodging, books, study material, sprts articles, school uniform etc. free fo cost to the inmates. The hostel is well equipped with 30 rooms (residential), a storeroom, a warden room, 10 latrines, 7 bathrooms etc. the student residential rooms are equipped with electricity supply and 24 hous water facility is also available in the premises. The premise is a lush green one with beatuful lawns and planted trees. A part time doctor is also appointed to take care of the health of the inmates.

This year the boys of the hostel were taken to Rishikesh and haridwar for an excursion. The hostel is run with the financial support of the Ministry of Tribal Affairs, New Delhi. The class wise strength of the Hostel is given below:

### BALIKA ASHRAM TYPE SCHOOL BAZPUR

Balika Ashram Type School is a residential school for girls, which provides education, fooding, lodging, clothing, study material, play material etc. without any fees to the inmates. This school is playing active part in educating the girl children and contributing to the female literacy of the country. The scheme is financed by the Ministry of Tribal Affairs (Govt. of

India). The school has permanent recognition from the Basic Siksha Parishad, Uttarkhand.

The school is equipped with enough residential rooms, 5 latrines, 5 bathrooms, a kitchen and warden room. Each residential room has proper electricity supply and each room is fitted with light bulbs and fans. 24 hou water facility is also available in the school. A new building for the school was constructed for the purpose fo classrooms. A part time doctor is also appointed for the medical supervision of the inmates. This year also the girls were taken for an excursion to beautiful sight of Mata Garjia Devi near the Corbett National Park at Ramnagar. Along with studies various cultural programs were organized from time to time in the school. Total expenditure on the school was Rs. 13,93,625.00

For organizing various ceremonies, the society maintained the Mandapam a marriage garden. This guest house along with a medium of social gathering is also for increasing the earning of the society. The total income during the year under report was Rs. 4,00,000.00 the total expenditure on taxes etc. was Rs. 1,93,467.00 during the year under report.

## **ODISHA STATE, CHOUDWAR CENTRE**

### **SHRI GANGADHAR SAHOO**

Shri Gangadhar Sahoo, during the year looked in to the regular activities of the units of the Choudwar Centre as assigned to him in close association with Shri Damodar Sahoo, Secretary, Odisha Branch.

Shri Sahoo, paid regular visits to the Creche Centres run by the Choudwar Centre of the Society in both the urban area of the Choudwar and rural belt of Tangi-Choudwar and Athgarh blocks of Cuttack district and Rasulpur block of Jajpur district. He monitored the smooth management of the said centres. The said centres are financed by the Bharatiya Adimjati Sevak Sangh, New Delhi and State Council for Child Welfare, Odisha. Through these centres, more than 800 children within the age group of one to six years from poor scheduled caste, scheduled tribe and minority communities are being provided with all-round care for their all-round development. These children are being provided with extra supplementary nutritious food, medical care and non-formal education through play way method in a nice homely atmosphere. Sixty nos. of well qualified and trained lady workers are engaged in those centres for caring and educating the small children. Shri Sahoo also organized several meetings and get together of the villagers of the Creche operation area, had discussions on the socio-cultural, economic and many other problems of those villages. Zonal committee meetings of the staff members are also organized in a regular basis which was attended by Shri Sahoo. During the year Shri Sahoo, organized several health check-up camps for mothers and children of the adopted villages. Many renowned physicians were invited to check health of the people of the villages. Free medicines were also distributed to the patients as per prescriptions.

During the year, '12 batches of training were organized in the Anganwadi Worker's Training Unit in which 257 untrained Anganwadi Workers of Various ICDS Projects of Odisha undergone training on the policies and management of ICDS Activities. In Anganwadi Helpers Training unit 30 batches training were also organized in which 1352 untrained helpers got training in

both orientation and refresher courses. Shri Sahoo personally looked in to the smooth management of both the training units along with took classes in various subjects related to ICDS activities.

Shri Sahoo continued to be the Joint Secretary of Gokhale Ideal College, Executive Member of Governing Body of Sardar Kharida L. N. M. E. School and member of Thermal Primaty School. He during the year visited several state Govt. offices and had discussions with high officials about the functioning of units of Choudwar centre. Shri Sahoo went to New Delhi three times, during the year and attended the general body meeting and special meeting arranged by the BAJSS, New Delhi.

Shri Sahoo, continued to be the member of Cuttack District Disaster Management and Mitigation Committee. He attended several meetings on preparation for disaster management and rescue operation system. The Choudwar centre of the society has been assigned the task of creating awareness among the people of 4 Gramapanchyats of Tangi-Choudwar block of Cuttack district on preparation and rescue system at the time of any natural calamity. Shri Sahoo, also, continued to be the leading member of the task force, formed to work at the time of any disaster.

Shri Sahoo organized National Pulse Polio programme, two times in the Choudwar Municipality area, in which 70 lady volunteers of the Choudwar Centre fed polio drops to the children within the age group of 0-6 years at their door steps. Totally 4,250 children were fed polio drops each time. National Filaria Eradication programme was also organized by the Choudwar centre, two times, during the year. With the leadership of Shri Sahoo, 100 lady volunteers distributed Di-ethyl Carbamazine Citrate tablets to more than 42,000 people of Choudwar Municipality areas during 3 days.

One day long awareness programme on adoption and rehabilitation was organized by the Choudwar Centre in collaboration with Catalysts for Social Action, Pune in which many reputed citizens like journalists, social workers, SHG group members and police officers were trained on adoption and rehabilitation. Shri Sahoo took lead role in arranging and managing such

programme.

Shri Sahoo actively participated in 145<sup>th</sup> Gokhale Jayanti celebrated by the Odisha Branch of the society. He also took active part in organizing 48<sup>th</sup> Death Anniversary of Padmashree Laxminarayan Sahu, the founder of Choudwar Centre and 37<sup>th</sup> Foundation Day of Sishu Sadan, Choudwar. He attended Bishuv Milan Utshav organized by the Prajatantra Prachar Samiti, Behari Bag, Cuttack. Shri Sahoo presided over the -meeting organized on the occasion of "Tribal Festival" in the village Berana in which many dignitaries of the state attended as guests. Shri Sahoo continued to be the honorary correspondent of "The Prajatantra", the leading Odia Daily News paper and sent regular reports on various problems of the locality, which were published in a regular basis.

Home at Narasannapeta being satisfied with the philanthropy of the local public here lead by Late Potnuru Swamybabu who was a reputed and a prosperous citizen of Narasannapeta. It was established in the year 1945 and it became a famous and welcome home for needy, neglected and destitute children.

In its long record of unstinted services it had its set back when it caught fire during Nineteen hundred sixties, since in the early years the Home was running under a shelter which was having a roof vulnerable to fire. Those were the testing times for G.C. Home which survived with the saving intervention by individuals like Late Sri Swamybabu and Late Sri L.N. Rao, Senior Member SIS the erstwhile and the A.P. Govt. As a result G.C. Home got a relatively well established dormitory with asbestos roof.

Sri P.S. Prasada Rao local Advocate took over as Hony. Secretary and under his able guidance G.C. Home revived. Since he left Narasannapeta in the year 2001 the incumbent Hony. Secretary has been functioning, with the assistance of Mr. R.K. Sahoo, the incumbent Warden of the G.C. Home. All the efforts and activities are known particularly to the generous well-wishers and donors. The strength of the inmates is now 19 and we hope to make it 25 to 30 next year. It would be my sincere duty to make a special mention of the contributions made by Sri U. Lingaraju who joined the management of G.C. Home as President of Local Management Committee which has been evincing keen interest in the alround development of G.C. Home. Mr. M. Ramamurthy a member of the committee is also working hard in association with Sri U. Lingaraju whose services are highly mention worthy.

It is our pleasant duty to acknowledge with grateful thanks to our local MLA Sri Dharmana Krishnadas for having sanctioned Rs. 1/00/000/- from his constituency development fund for establishing a protected drinking water supply scheme for G.C. Home with a successful bore well, a submersible water pump and necessary pipeline for proper distribution and with an over head tank which supplies protected water to the inmates of Gc. Home and water being supplied by the local civic body is being used for drinking by inmates. Action is now being further taken to duly sterilise the water for drinking. This novel scheme was fittingly inaugurated on 29<sup>th</sup> August, 2010 by our local MLA who was enthusiastically greeted for his noble action by the committee members and the inmates.

The Members of the local Management Committee undertook to construct an extension shed to Kunzru Hall in which cement benches for sitting and dining, which are fitted with ceramic tiles are organised. These were provided by an anonymous donor and the inmates are conveniently using this facility for dining. The committee is now planning to provide wash basins also for the inmates. The donation of the donor for tiles is estimated at Rs. 1/500/- . Another unidentified donor donated Rs. 4/087/- for white washing the asbestos roofed dining shed, Kunzru Hall, besides 3 latrines and two bath rooms. It is a gesture of concern by this donor and the committee thanks the donor. Besides, a narrow gate to the north of the main gate is constructed at a

cost of Rs. 12/500/- and this donor is also not identifiable. Furniture materials like three big tables, 2 small tables, 2 tables, 2 wooden chairs and one wooden Almarah owned by G.C. Home are given varnish painting by the same donor.

On 16<sup>th</sup> June, 2010 local Sri Satya Sai Seva Samithi donated cooking utensils costing Rs. 1000/- to G.C. Home.

On 10<sup>th</sup> July, 2010 local philanthropist Sri Simma Nageswara Rao and his better half donated 13 woolen blankets each costing Rs. 600/- to Gc. Home. Thanks to the donors.

These activities cost sizable amount and the total donation which includes the initial sum of Rs. 12,500/- comes to Rs. 24,620/-. These acts of this unidentified donor who insists on his confidentiality to be maintained are well appreciated and we pray for him. The products of this worthy investment is the addition of an open shed to the east of Kunzru Hall to keep the fire wood and the object is to use this as the kitchen to meet the contingency like disruption in gas supply.

Any casual visitor taking rounds of G.C. Home unfailingly and spontaneously raises his or her eye brows observing with a smile that how the management is able to maintain the premises so spotlessly clean. This is noted with satisfaction.

Besides our efforts for making some additions to the available infrastructure, we are continuing to give our focused attention to the fiscal aspects of G.C.Home. we thank the management of SIS for enhancing the annual grant to G.C.Home to Rs. 20,000/- to Rs. 25,000/- last year and to Rs. 30,000/- for the current year. We now appeal to SIS to please consider to enhance the annual grant to Rs. 70,000/- since we are planning to increase the present strength of 19 inmates to 30 inmates. With a long time perspective we launched the corpus fund account and the collections are now to the tune of Rs. 50,000/- under this head and adding the savings from our regular collections, the corpus fund has now gone upto Rs. 1,26,000/- and the entire amount is deposited in fixed deposits and we are aspiring to ever increase this

corpus to ensure the financial strength of G.C. Home.

Besides securing the fiscal position of G.C.Home, the committee is never oblivious of its main objective to focus its attention on the academic performance of the inmate children. To improve their academic standards we have recruited a qualified tutor who is regularly holding classes with the children and we are hoping that the children will take advantage of this opportunity. We are undertaking to review the academic standards of the children to ensure better future for them. We would be failing in our duty if we do not mention about the gesture of Sri Ashoka Tankala currently residing in United States happened to visit Narasannapeta on 4<sup>th</sup> March, 2011. He and his two brothers Dr. Harsha and Sri Kanishka are the recurring donors and he presented a cheque to clear the dues of all the three brothers for two years and he also donated a sum of Rs. 10/000/- for furnishing the dormitory with cotton beds and pillows. The committee appreciated his gesture. Mr. Ashoka expressed his satisfaction with the maintenance of G.c. Home.

The family members of Sri P.S. Prasada Rao our former Hony. Secretary majority of them being residents of USA currently continue to donate to Gc. Home on annual basis and they all have now formed into a Trust which has become one of the major donors to G.C. Home on annual basis.

To improve the resources of G.C.Home, Mr. Sri U. Lingaraju, President Local Management Committee and Sri M. Ramamurthy, Member, Local Management Committee under took a great mission to make personal visits and persuade the donors to give donations in kind if not in cash and the response is encouraging. A separate account is being maintained to keep track of the collections in kind noting their value in Rupees. The committee is very keen on building up corpus fund for Gc. Home. Besides Ashoka Tankala, Dr. RajKamal Tankala, who is also one of the recurring donors visited Gc. Home on 10<sup>th</sup> November, 2010 and personally paid his donation.

Sri T. Vijaya Bhaskar donated 10 mini solar lights ( study lamps) to the inmates, to attend to frequent power cuts. These lights are very useful to

the studying inmate children and we thank the donor.

G.C. Home is making firm and steady strides. We hope with the cooperation of all our well-wishers, the higher goals can be soon realized in serving more needy child.

## **GOVERNMENT OF INDIA SCHEMES**

The following Schemes were being run by the Society in Orissa, U. P. and Uttarakhand States which were funded by the Union Ministry of Social Justice and Empowerment and Ministry of Tribal Affairs.

### **Schemes of Ministry of Social Justice and Empowerment**

#### **A. U. P. State (Sonebhadra District)**

- 1. Primary Schools (Ten):** Ten Primary Schools were run by the Society which were located in the Sonebhadra district. These schools were financed by the Union Ministry of Social Justice and Empowerment (SCD-Division). All these Schools are duly recognized by the U. P. Education Department and are regularly inspected by the concerned Authorities.
- 2. Ashram School, Siltham:** The Ashram provides free residential accommodation, food, clothing oil and soap, reading and writing materials SC students. Thus, this has been functioning as a Hostel for SC Boys from its very inception but it is named as Ashram School because the Govt. of India (Ministry of Social Justice and Empowerment) has been sanctioning the scheme with this name.
- 3. Girl's Ashram School, Khaliyari:** The Ashram provides free residential accommodation, food, clothing, oil and soap, reading and writing materials to SC girls attached with the Ashram.

- 4. SC Boys Hostel, Ghuwas:** The Hostel provides free residential accommodation, food, clothing, oil and soaps, reading and writing materials to SC students in the Primary School, Ghuwas run by the Society.
- 5. Women Welfare Centres (Five):** These five Women's Welfare Centres were located in the Village Bidar, Mahuariya, Supachuwan, and Kudari in Dudhi Tahesil and in Village Barhaulti in the Robertsganj Tahesil of Sonebhadra district. Training in Tailoring, embriodory and Knitting by hand were being provided through these Centres to women attending these Centre.

#### **B. U. P. STATE (LAKHIMPURKHERI DISTRICT)**

- 1. Balika Ashram Type School at Paliakalan:** With the financial assistance from Ministry of Social Justice and Empowerment, Government of India, Balika Ashram Type residential School was maintained by the Society at Paliakalan in Lakhimpur Kheri district for educational advancement of girls belonging to SC community. During the Session 2010-2011, the Ashram School provided food, lodging, clothing, books and stationary and medical facilities to the inmates free of cost.

#### **C. U. P. STATE (MIRZAPUR DISTRICT)**

- 1. Ashram Type School, Khantra:** The Society maintained an Ashram Type School at Khantra in Mirzapur district which was funded by the Ministry of Social Justice and Empowerment, Government of India. The Ashram provided food, lodging, clothing and reading writing materials free of cost to SC Students.

#### **D. ODISHA STATE (RAYAGADA DISTRICT)**

- 1. Residential Hostel for SCs (Thakkar Bapa Ashram):** The Rayagada Centre of the Society maintained a residential hostel for
-

100 SC Students popularly known as Thakkar Bapa Ashram. The Ashram provided free boarding, lodging, educational facilities to SC Students. The Students were provided with necessary reading writing materials and intensive coaching to improve their standard of education. Facilities like indoor and outdoor game, oil and soap, uniforms and free medical assistance were also supplied to them. A group of students visited Puri, Konark in an educational excursion.

## **SCHEMES OF MINISTRY OF TRIBAL AFFAIRS, GOVERNMENT OF INDIA**

### **A. U. P. STATE (BALARAMPUR DISTRICT)**

- 1. Thar Jan Jati Boys' Hostel, Tulsipur:** The Society maintained a hostel for Tharu Janjati Boys at Tulsipur for educational advancement of Tharu ST Communities with the financial aid from the Union Ministry of Tribal Affairs. The hostel provided lodging, boarding, clothing, reading and writing materials, medical aid to the inmates free of Cost.
- 2. Tharu Janjati Boys' Hostel, Pachperwa:** The Society maintained a hostel for Tharu Janjati at Pachperwa in Balarampur district with the financial aid from the Ministry of Tribal Affairs, Government of India. The hostle provided free lodging, boarding, reading writing materials, medical aid, Uniforms to Tharu ST inmates.
- 3. Tharu Janjati Boys' Hostel, Chandanchowki (Lakhimpur Kheri district):** The Society maintained a hostel for 40 Tharu Janjati Boys at Chandanchowki in Lakhimpur – Kheri district for educational development of Tharu Communities. The hostel provided free boarding, lodging, reading writing materials, Uniforms, medical aid to the inmates free of Cost.

- 4. Balika Ashram Type School (ATS) at Chandanchowki (Lakhimpur Kheri district):** The Society runs a Balika Ashram Type School at Chandanchowki with the financial aid from the Union Ministry of Tribal Affairs for educational development of Tribal girls. The inmates of the ATS are provided with food, lodging, clothing, bedding, reading writing materials free of Cost.

#### **B. UTTARAKHAND STATE (UDHAM SING NAGAR DISTRICT)**

- 1. Buxa Boys Hostel, Bazpur:** The Society maintains a hostel for Buxa preemptive tribe boys at Bazpur in Udham Sing Nagar district with the financial aid from Union Ministry of Tribal Affairs. The hostel provides free food, lodging, Uniforms, reading writing materials, medical aid to ST inmates.
- 2. Balika Ashram Type School (ATS), Bazpur:** The Society maintains a Balika Ashram Type School (ATS) at Bazpur in Udham Sing Nagar district with the financial aid from the Ministry of Tribal Affairs, Government of India. There are ST girl inmates in the ATS and they are provided with free food, lodging, reading writing materials, Uniforms, free of Cost. Free medical aid is provided to them through a medical officer, who visits the ATS twice a week. The ATS has got the basic recognition from the basic Sikhsya Parishad, Uttarakhand State.

#### **C. ODISHA STATE (RAYAGADA DISTRICT)**

- 1. Educational Complex for ST girls:** The Society is managing an Educational Complex for Tribal girls at Village Halua in Rayagada district with 100% financial aid from the Union Ministry of Tribal Affairs. The Educational Complex is running with a view to improving the tribal female literacy. The Complex provides the facilities of free boarding, lodging, Uniforms,

Cosmetics, reading writing materials, medical aids and medical Checkups to 60 ST girls. It has the facility for reading of ST girls upto Class – V. All girl students of the Complex went on an educational tour and visited Sri Jagmuth Temple, Puri Sea beach, Konark, Nandan Kanan Zoo, Planetorium and Lingaraj Temple at Bhubaneswar.

**ORDER UNDER SECTION 80G (5)(VI) OF THE INCOME TAX ACT, 1961**

**Read With Rule 11AA of The Income Tax Rules, 1962**

Donation made to the Society / Institution, namely, Servants of India Society, 846, Shivajinagar, Pune - 411 004, will be eligible for the benefit of deduction under section 80G of the Income Tax Act, 1961, in the hands of the donors subject to the limits and conditions prescribed therein.

3. If further renewal is required, an application in Form No. 10G should be made to this office by the Society / Institution along with:

- I) Statements of accounts for the last 3 years,
- II) Copies of acknowledgments of Returns of Income,
- III) Certificate under Section 13(1)(c) of the Income-tax Act, 1961, signed by all the Trustees, and,
- IV) List of donors of amounts of Rs. 500/- and above for the last 3 years.

3.1 Assessee has been advised to incorporate the following clauses in the Trust deed / Constitution / By Laws / Memorandum of Association and submit the revised deed by 20-11-2010.

- a) "Any amendment to the Trust Deed / Constitution / By-laws / Memorandum of Association will be carried out only with the approval of the Competent Income Tax authority, i.e., the Commissioner of Income Tax - III, Pune".
- b) "In the event of dissolution, the surplus assets / funds of the Trust / Institution, as would remain after discharging all liabilities, shall be transferred to any other public charitable institution having similar objects and also registered u/s 12A of the Income-tax Act, 1961; and the same shall not under any circumstances be distributed among the members".
- c) "The trust is Irrevocable".
