CHAPTER I

INTRODUCTION

1. Eackground

The problem of providing adequate wagon capacity on the Indian hallways has been severe for quite some time. In a more general context, the National Transport Folicy Committee " (NTPC, 1980) observed, "During the last decade in particular, the growth of transport capacity lagged behind requirements of the economy; so much so that difficulties and problems arose in almost every part of the country in regard to movement of essential commodities needed for industrial and agricultural development and for meeting the consumer needs of the community." And the Railways, being the principal mode of transport of goods and people over long distances, have found it difficultto meet the increasing requirements for railway services. --A major problem, it is felt, has been the shortage of wagons. Acquisition of new wagons every year has been more for replacement of old ones; there has been virtually no net increase in the number of wagons in the past few years. In fact, the wagon stock has gone down in recent years as a result of withdrawal from service of a good number of overaged wagons. As a result, it is argued that the supply of freight services has not grown in consonance with the demand for the same. However, as kao and Sriramen (1985) observe, such a facile explanation is inadequate primarily because the shortage of

wagons can be assessed only in relation to the demand for them. They note that since the demand for freight movements is variable over space and time, an allecation of warons which appears inadequate may turn out to be a surplus by proper and; efficient scheduling over space and time. It is further pointed out that the shortages in the availability of wagons have mainly resulted from the persistent deterioration in turnround time of wagons. This has been partly due to the sharp increase in the average lead of freight traffic from about 550 kms. in 1950-51 to about 750 kms. in recent years. The increase has been very substantial for certain commodity groups. As increase in the lead of traffic keeps a wagon on wheels for a longer time and therefore increases the number of wagons required to handle a given quantum of shipments. Greater the lead, the more number of times is a wagon subject to routine checks. These cause transit delays. Essides, it is also observed that policies regarding allocation of wagons. assignment to destinations, scheduling, etc., have all contributed to increased turnround times.

On the other hand, with the increasing diversion of high-rated traffic to road transport, the railways have been increasingly involved in the movement of bulk commodities like coal, eres, foodgrains, cement, fertilizers, mineral oils, etc. These commodities accounted for nearly 90 per cent of the revenue-earningtraffic in 1983-84 as against 58 per cent in 1950-51. And the bulk traffic is moved in block/unit

trains from the origin to the destination. The uni-directional movement of these commodities over long distances has contributed to a significant portion of the wagon movement being empty.

It is true that in order to sustain a set of traffic flows, a certain magnitude of empty movement is unavoidable. The number of wagons arriving with loads in any terminal area seldom coincides with the number required for shipments out of the area. Not all the incoming wagons are of the types suitable for the outward traffic. Thus, the railways are compelled to move empty wagons from points at which there is a surplus to points at which the vehicles unloaded may be inadequate to supply the needs of traffic likely to be offered. The basic problem then in freight operations is matching the demand for a specific type of transportation unit with the availability of these at other points on the system. This is to be achieved with the minimum amount of empty movement.

In the United States, nearly 45 per cent of movement is empty since the predominant movement of traffic is towards the east. This arises from the fact that most manufacturing takes place in the east and most farming and mining in the midwest and west; so bulk raw materials move east and compact manufactured items go west. The result is that empty wagons for western leading must be supplied from the east and a considerable amount of empty movement is brought about in the process. In India, empty wagon movement constitutes about annually 33 per cent of the total wagon movement on the railway network.

Alternatively, given the wagon stock and its efficient use there can still be limitations on their use due to the availability of track capacity. Additional traffic on saturated routes would only lead to diminishing returns in respect of overall wagon mobility.

Forecasts of freight traffic for the late eighties clearly indicate that the Mailways would be called upon to carry a much heavier volume of traffic in years to come. The annual freight demand by the mid-nineties is expected to be more than 400 billion tonne kilometers as against the present demand of 170 billion tonne kilometers. It appears

from production forecasts that the mining areas in the Bihar/ Bengal belt as also the industrial areas in the different parts of the country will continue to dominate in the future too. Thus the main brunt of the traffic increases will fall on the very routes which are already under pressure. The railways would surely like to strengthen and consolidate these critical routes which would yield immediate benefits before taking up new lines and conversions which have great popular appeal. However, even such a limited expansion of track capacity may market back the see the parkets not be feasible. The electrification of the main routes, which is being currently done rapidly, would probably help to some extent. But according to the Mailway Meforms Committee (Sarin Committee - 1983), renewal of track is to be given the highest priority. It is felt that inadequacy of investment, on renewals has resulted in the track getting !sick . According to the Committee, "the Railways had fallen into the habit of neglecting the maintenance aspect. However, since all the resources for track renewal, which is top priority, may not be available, the possibility of significant expansion of track capacity/line capacity would appear rather resote. wagon stock represents one of the major capital investments by the railways but it is an asset that is very poorly used in general. Under the circumstances described above.

there is an imperative need to aim at a better utilisation of existing wagon capacity. A major dimension of improvement that could be visualised in the sphere of empty wagon movement and management. This refers to the process of controlling the empty wagons from the time they are unloaded to the time they are placed for the next loading. It is often held that this aspect of wagon usage is handled rather inefficiently and that there is need for more attention and research directed towards better utilisation of capacity represented by such flows, with this view in mind, our primary objective is to conduct a preliminary study of empty wagon movement and management on the Indian Sailways. Such a study, it is to be emphasised, would not only analyse the problem from the point of view of the railways but would also look into certain aspects of developmental policies under the plans, which have been major influences on the emergence of empty flows on the network.

Kethodology for the study

In this section while we develop the methodology for the study, we will also seek I guidelines from the available literature to the extent it below us in formalising the methodology appropriate for our study.

To understand the legistics of empty flows on the network, it is necessary to examine the existing pattern of, empty flows. This would indicate their underlying characteristics. In his scholarly study, Thor Hultgren (1948) examined,

in brief, the empty component of car (wagon) movement in the context of property and depression in the United States. With the help of certain ratios, he observed that a cyclical increase in railroad (railway) traffic was usually accompanied closely by a growing movement of empty cars (wagons) and a decline in traffic by diminishing empty mileage, though swings in empty car-miles seems to be proportionately less than those of loaded car-miles / Thus / there is relatively more compty movement in a contraction and this is explained by changes in the composition of traffic. * For our purpose, a similar analysis would be helpful, though in a different context. For instance, we have observed that bulk commedities predominate in the total freight movement. It would be useful to examine the extent to which their increasing importance ever the years has contributed to the emergence of empty flows on the system. Some other pertinent questions that we wild look into are:

- (a) How have the shifting patterns of traffic from Metre Gauge to Broad Gauge affected this dimension?
- (b) De the trunk routes account for mest of such w
- (c) That is the influence of sempty movement on turn round time?
- (d) Now does the seasonal nature of movement of certain commodities result in considerable movement of empties?

(e) Further, it would be useful to examine the extent of utilisation of wagon capacity. A number of wagon utilisation measures have been proposed and are currently in use important among them being wagon kilometres per wagon day and net tonne kilometres per wagon day. The former is a measure of wagon mobility while the latter is a measure of goods series rendered on an average by each wagon per day. While these are useful measures, it is felt that there is a need to explicitly measure the utilisation of wagon capacity. Typically the average wagon needs to be examined from the point of view of loaded movement that is a part of the total movement and also of each wagon cycle (turn round time). In the course of their studies on Railway Freight Operations the Australian Bureau of Transport Economics made a survey of wagon utilisation (1977) on five major railway systems in Australia. In this context they have proposed certain measures of wagon utilisation which we propose to use in our study. This is done at two levels as follows:

1st Feasure

Capacity Used Tonnes of freight in transit
Capacity in transit
Tonnes of capacity in transit

This measure would give us an idea of the capacity used in transit. Greater the empty movement component, lesser, the capacity used.

2nd Feasure

Capacity used _____tonnes of freight in transit capacity available tonnes of capacity available

average wagon capacity wagon turn round time

This measure would also reflect the delays in yards; terminals; sidings, etc.

To answer some of these questions besides many others, it was necessary to look into the broad pattern of flows of bulk items. Data needs have been sought in the Annual Statistical Statements of the Sailway Board and Zonal Railway as also the Statements of Domestic Statements brought out each month at the Zonal level. Statements regarding atilisation of line capacity on various sections of the different sones in terms of loaded and expty flows have also been looked into. Above all, detailed discussions with officials in the Traffic Transportation, Planning and Economic cells have been held to give better insights.

Efforts to measure the magnitude of empty flows originating at various points from the point of view of their utilisation would indeed be a formidable task, considering

the magnitude of our railway network. For a preliminary study such as ours, such a comprehensive attempt is not a feasible proposition. Therefore, it was proposed to confine ourselves to a part of the network. We begin with the study of empty movements originating at the terminal at Pune. Pune is one of the major freight terminals on the Central Mailway network. The objective is essentially to examine the tennage associated with such flows so also the direction of movement. This would give us an idea of the existing pattern and availability of wagons at well-defined points of time. It this level of analysis, some of the relevant questions that could be conceptualised and examined are as follows:

- (a) What is the extent of backloading at present as compared to the available capacity?
- (b) How far is it possible to make use of this capacity in the form of available empties given the pattern of demand and variations in them?
- (e) Does the primary responsibility for empty wagon distribution lie at this local level? In other words, what are the present policies of assignment of empties to other points on the system?
 - (d) What is the extent of allocation delays which contribute to large scale idle empty wagon time at terminals?

To look into some of these issues, it was thought necessary to look into loading data as well as shipper order

data. Typically, a forecasting exercise based on either wouldunderestimate demand or overestimate shipper's requirements. ?

Data for consideration of these aspects were got from the

Manuals of Operating Statistics of Terminals published by the

nailway Board, and pther unpublished records of daily empty core
movements and detention at Pune.

The ultimate coat of moving freight is significantly of affected by the extent of empty movement. The units costs vary with the level of empty flows associated with the movement of particular commedities. The varying necessity for empty. haulage is considered together with many prior factors in the rate-making for the various commodities. The interesting question that arises is that regarding the adequacy of transport rates to covar this additional cost of empty haulage. Wherever there is imbalance in movement, there is an opportunity for carrying freight in empty wagons at low rates. When goods are carried in the predominant direction of movement, costs are high because every wagon load of freight implies the return of an additional copty wagon. To induce shipper to use the excess capacity represented by empty hauls probably requires, among other things, that rates reflect the costs by being lower where empty backhauls can possibly be used. Quoting low rates for backhaul in certain cases could permit the railways to get back traffic from the highways. Efforts were made to look into these aspects in discussions with officials in the costing cell of the kailway board. As

anticipated, not much headway has been possible in this direction. But we do intend to make some comments on the basis of available information.

Plan of the Report

In the following chapter, we analyse the various issues related to the railway network as a whole and also take up the analysis of wagon utilisation. In the third chapter, we take up the case study of the rail terminal at Pune and analyse the relevant issues. Chapter IV relates to the analysis of cost considerations within the limited framework of the study. The final chapter would give a summary of the findings and also our concluding remarks.

CHAPTER II

EMPTY FLOWS ON THE NETWORK - AN OVERVIEW

Our investigations of empty flows on the railway network begins with a micro-view of empty wagon movement on the Indian railway system. In this chapter we examine the various issues that have been raised earlier.

Trends in Loaded and Empty Wagon Kilometrage

The trends in loaded and empty wagon kilometrage (all gauges) and the corresponding propertions in total wagon movement are given in Table 1. The percentage of loaded to total wagon movement was around 69 in the early fifties which gradually rose to about 73 in the late fifties. Since then the percentage has been hovering around 67-68 per cent, except for a couple of years in the early seventies when it touched 70 per cent. A similar picture emerges even when the broad gauge and meter gauge sections are considered separately though the fall in the percentage of loaded movement has been much more in the case of the Broad gauge than on the Metre Gauge. These trends are given in Table 2.

At the aggregate level, it would be useful to examine certain other trends which indicate the increasing trend in empty movement. These are set forth in Table 3. When considering the net tonne kilometres per goods engine hour, we observe that the increase in these indices have not been

propertional to increase in freight traffic indicating (in terms of tonne kilometres, it has gone up from 37 million in 1950-51 to nearly 170 million in 1982-83, i.e. by 5 times.) imbalanced traffic, m lighter loads and increased .. amount of light engine hours. Once again it is observed that increases have been only half as much on the Broad Gauge as compared to the MetreGauge. The rise in net tonne kilometres per wagon day was higher in the years upto the 2nd Plan end, which could be explained by the introduction of higher capacity wagons. Thereafter, there was a downward trend except in 1976-77, 1977-78, and the past two years. This basically reflects the want of improvement in wagon mobility, excessive turn round time and imbalanced flow of traffic. The comparison of the gross average train load and the net everage train load shows an increasing trend in difference which again is a reflection of the increase in incidence of empty haulage.

Table 4 gives the trend in empty movement per unit of loaded movement and net tonne kilometrage performed per unit of total wagon movement. The aggregate figure moves down from .40 to .36 between 1950-5d and 1960-6l and thereafter shows an increase till 1982-83, when it is about .5l. Thus for every kilometre that a loaded wagon moves, it travels empty for about half a kilometre. Again, the services performed per unit of wagon kilometreage, from the point of

view of net tonne kilometres, does not show significant improvement. For every kilometre that a wagon moves, net tonne kilometres performed was about 11.5 in the fifties and hovered around 12.5 in recent times.

Factors Influencing Empty Wagon Movement

- 1. Shipping Pattern on the Network
- a. Incressing importance of bulk items

A good deal of empty movement takes place on account of traffic imbalance by direction; which is basically a function of the spatial distribution of supply and demand points' for shipments. Thus, the railways are compelled to move empties back from the unloading areas to supply the needs at the loading points. In India, we have considerable movement of bulk commodities over long distances. The increasing importance of bulk movement to the total movement has contributed to growing empty movement. The percentage of bulk to total has been steadily increasing from 55 per cent in 1950-51 to around 88 per cent in 1982-83. This trend is shown in Table 5. To cater to this changing composition of traffic, the rail movement has been sought to be achieved in block rakes/unitatrains, which is more economical especially when there is a large volume of traffic to be lifted. . Horeover, the average lead of freight traffic has been increasing sharply. It is observed that the average lead (for all commodities) has gone up from about 560 kms. in 1960-61 to about 750 kms. in recent years. The increase has been very substantial for certain commodity-groups. For instance, in the case of foodgrain traffic, the lead in increased from 760 kms. in 1960-61 to about 1250 kms. in 1982-83. In the case of cement it has doubled from about 360 kms. to nearly 740 kms. As for fortilizer traffic. > the lead went up from about 675 kms. In 1965-66 to about 1150 kms. in 1982-83. Even iron and steel traffic has a ... lead of about 1100 kms. in recent years as against: 700 kms. in 1960-61. Only in regard to coal traffic, the average :: lead has come down marginally to 570 kms. from about 650 kms. Such unidirectional movement of commodities (and thereby of loaded vagons since the rates have to be sent back empty to the loading points) results in a good deal of empty movement.

Component and the Gauge Problem

Another factor that appears to have contributed to increased empty movement is the falling share of goods traffic on the Metre Gauge sections with shifts to the Broad Gauge taking place. Although the MetreGauge sections amount for nearly 42 per cent of the total network, they carry only about 12 per cent of the total freight traffic. While its share in the total freight flows in terms of the

origin tonnage was around 25 per cent in the early fifties, its share has been steadily decreasing and is at present just a little above 10 per cent. Even when this aspect is considered in terms of the loaded wagon kilometrage, its share in the total has declined from 24 per cent in 1950-51 to around 14 per cent in 1982-83. Although the coverage of the MD network is not much less than that of the BG component in terms of the route kilometrage, most sections of the M are found confined to certain demakty populated areas of the north, the extreme west and south. Consequently, a good amount of traffic is of the local type and involve shorter distances than on the BG. But since these areas have not figured prominently on the industrial map of the country, it has resulted in a constant and large scale movement of goods such as foodgrains, agriculturel goods, manufactured items between the MJ and BU. This has also resulted in considerable empty movement of wagons in and out of the transhipment points. The same the same the There are nearly 100 transhipment points on the Indian railway system. Out of nearly 10,000 wagons loaded daily on the Metre Cauge, 47 per cent represent traffic moving within the MD area itself. While 21 per cent are loaded with traffic sent out of the MD eres 32 per cent represent traffic moving into the MS areas. Basically, the problem with regard to goods traffic at these points is that involving coordination in the availability and placement of loaded and empty stock on the two gauges. This problem arises mainly due to two factors :

- a) Difference in the carrying capacity of the wagons of the two gauges available for interchange of goods.
- b) Unbalanced movement of traffic necessitating empty haulage.

From the Broad Cauge (BG) to the Metre Gauge (MG), transhipment from 1 BG wagon would involve 1.5 MG wagons, while from the MG to the BG, 1 MG wagon requires .8 BG wagon. For instance, to effect transhipment from 50 BG wagon, 90 empty MG wagons would be required, while for 90 MG loaded ones, 72 BG empties are required. Whenever the traffic in the two directions is more or less belanced on MO, it will be necessary to feed BG empties. But traffic is not quite balanced at all transhipment points. In fact, it is observed that a good deal of empty movement takes place in " and out of the transhipment points. In the case of the 15 major transhipment points, it was observed (in 1982-83) that, on an average, around 15,000 wagons are sent back empty and about 10,000 empty wagons are received at these places on the BG side every month. On the MG side, the corresponding figures were 5,000 and 20,000 respectively. Thus, the existence of the gauge problem necessitates movement of empties to and from the transhipment points. Normally, when empties are constantly required at a particular transhipment point, it is useful to keep a close watch on movements on nearby sections. But more importantly, it is necessary to know the details of the stock that can be made available. It would then be possible to regulate movement of traffic such that no capacity is allowed to go waste. But the problem of synchronisation of an equivalent number of wagons of suitable types of the two gauges remains a formidable one. To the extent that detentions to wagons, are to be sweided, it should be possible to provide arrangements for releasing wagons and keeping goods stored until they can be worked away on wagons becoming available. This would, at least, eliminate working in empties for loading at these points.

c. Seasonal Movements

The seasonality of certain types of traffic flows is also an important reason for the emergence of empty flows on the network. This is specially true of commodities like foodgrains, fertilizers.

Preight flows and demand patterns on the Indian railway system also exhibit a sessonal effect. But this is true for most commodity groups and the phenomenon is more closely related to climatic considerations. Normally, nearly the whole of the country experiences the wet season between July and September and this is the slack season

It is possible that terminals maintain excessive inventories of wagons in their areas as a buffer against the uncertainties of the supply and demand levels. Where, cunreliability is the direct cause of the problem of utilisation since: wagons kept in inventory are for the most part unproductive. the Within the Indian railway system, the railway board is at the apexiof the decision making process, in It coordige nates the policy making as well as the executive functions. In addition, the hierarchical process consists of both: horisontal and vertical dimensions of control. The horisontal division is generally by functional areas such as investments in tracks and rolling stock, price policy, and operations and maintenance. The vertical control divides: some of these functions at the level of the central and la monal responsibilities. But as pointed out by one of their recent studies on Management Development Perspectives (1982). the devolution of powers to lower levels of authority is a more a facade than a reality. There has been an increasing trend towards over centralisation and increasing concern with day to day functions of Reilway operation and management. Naturally, policy and strategic planning occupy a back seat. in decision making. Zonal Railways in practice have been made to work as subordinate offices with daily accountable lity in operations. This applies equally well regarding the

sonal headquarters vis-a-vis the terminals in the area. We would have more to say about this aspect when studying the terminal at Pune.

3. Special Purpose Wagons

This aspect is closely related to the operational strategy as regards the bulk items is considered. These ... wagons are generally put into operation at the request of the shipper and results normally in better service to the shipper. At the same time these special fleets usually imply greater levels of empty backhauls for the railway because most of the commodities shipped in these wagons move only in one direc-On the positive side, these wagons permit faster loading topsloading, have greater capacity but these restrict flexibility in the distribution of empties on the network. On our railway system, with the growing importance of bulk items, the railways have been trying to adapt their supply to the emerging demands on the network. Earlier, practically all the goods traffic was being carried in general purpose wagons. But in the past two decades a number of new bogie wagons with emphasis on higher payload and facility for loading and unloading special types of traffic have been put into service. These include BOX, BCX, BOHX, BOY, MOXN, etc. While these constituted about 10 per cent of the total wagon stock in 1960-61, the proportion was about 60 per cent in 1982-83. Theoretically, there are specific uses for which these wagons are meant. But operationally, it is found that

designed for, they are from time to time used for other and purposes as and when possible depending on traffic needs.

For instance, foodgrain loading takes place in coal empties in the non-monsoon months, especially in Punjab. Rakes are carrying steel and from to the west bring back salt to the eastern parts. However, since it has often been observed that wagons are hauled as empties from various parts to the Bengal/Bihar coalfields even when sufficient traffic is and that wagons are hauled as empties from various parts to the sweiting clearance, such measures do not seed to be nature of any attempt absorbematically eliminate utilisation of empty flows.

Empty Flows on the Network

On preliminary observation, it is noted that almost, all the sections on the trunk routes and those leading out of the mineral belt in the east account for heavy empty flows. We noted in the first chapter that nearly three fourths of the freight traffic is concentrated on this part of the network. Moreover, with passenger services being provided on a large scale, these sections are acturated and espacity utilisation is as high as 90 per cent on most a sections. Thus, a good deal of capacity is preempted by empty flows.

The dominant flow of empty wagons is towards the assemblant solution and other mining areas in the eastern part of the country? The largest consentration of coal reserves is

In Bihar, West Bengal and Madhya Pradesh. In addition, coal reserves are also found in Orissa, Maharashtra, Assam and Andhra Pradesh. The southern states of Temil Madu, Karnataka, Kerala and Andhra get mearly 80 per cent of their coal requirements from the Andhra Pradesh coalfields. Thus, the empty flows on the major routes of Southern, railway such as the Madres-Cochin, Madres-Vijayawada routes are towards the A.P. Coalfields. From the vestern states of Maharashtra and Gujaret, which depend mainly on the Western coalfields in Maharashtra and the Central coalfields in Madhya Pradesh for their requirements, the empty flows are towards these coal areas. We can not possibly say more unless details of wagon types involved in the flows are available. While cross haulage in certain segments may be necessary to take care of the demand for special wagon types, it is of paramount importance to avoid cross running of empties at the same time. Every possible effort should be made to give loads to all empties which are being supplied to feed loading points. It would be useful to initiate detailed studies so as to give a better insight into this aspect of the larger problem of empty movement.

Relation between Empty Movement and Turn Round Time (Wagon Cycle)

Turn round time is defined as the average time taken by a wagon from the time it is loaded till the time it secures its next load.

Thus, each wagon goes through a sequence in the course of a single wagon cycle. On most railway systems, a major part of the wagon cycle is spent in terminals, yards, etc., while the time spent in transit is small. On the Indian railway system, nearly 82 per cent of the turn round tune of a wagon is taken up by detention in marshalling yards, terminals, etc., For example, in 1982-83, out of a turn round time of 12.6 days only 2.15 days were spent on transit (both loaded and empty). The rest of the time includes


time spent by an empty wagons for being loaded, despatched, etc.. (See Figure 1)

Basically, the turn-round time is a function of a whole series of factors: time spent in yards, terminals, transit time, etc.. It is only to be expected that though the empty component is not significant, any increase leads to an increase, however marginal, in turn round time.

In their study (1985), Rao and Sriraman observed that there is some sort of a trade-off between the turn round time and empty wagon movement. In the context of the analysis of operating policies, they considered, average loading, speed and empty movement inext (or scheduling of empty wagons) as policies available to the railways while the turn round time is exogeneously given in the sense that there is no possibility of manoeuvrability in that dimension, given the present efficiency of the system. The response of the railways to increased congestion and turn round time is to increase the average train load. But this may be reducing empty movement at the expense of the number of hours a train is on wheels during a day. The results are recorded below. The estimation was of the seemingly unrelated regression type (Zellner's SUEE).

While it is reasonable to say that the response to increased turn round time could come in the form of improved train loads or increased formation of bulk rapes, it is to be noted that such a response has had a positive effect on empty movement. From Table 7 and Figure 2 we note that the turn round time has been gradually increasing in the early years along with the increases in empty movement. But in the last decade or so, they have tended to swing in opposite directions.

The railways in their attempt to maintain the turn round time within reasonable limits have increased empty movements since additional m loadingsaffect the major components of the turn round time such as detention in yards, terminals, etc., much more than the empty movement's influence on the minor component namely, the transit time. In other words, operating policies are geared to the release of block rakes and directing them back to the unloading points and thus involving huge flows. Even this, it is to be

Utilisation of Wagon Capacity

In this section of the Chapter, we take up the measurement of utilisation of wagon capacity in the past two decades in terms of the measures proposed in the introductory chapter.

Before taking up the proposed measures, we consider the trends in measures currently in use. Figures for wagon kilometres per wagon day and net tonne kilometres per wagon day from 1950-51 to 1982-83 are given in Table 5.

It is noted that there is an initial rise in both dimensions showing a higher percentage increase upto the 2nd Plan. Thereafter, there is a downward trend till 1976 and 1977. Once again, there is a decline till 1980-81 after which they have registered improvements. A wagon in 1982-83 covered daily, on an average, 890/1 kms. while it 86.4

and the corresponding transit times for the loaded and empty components of the total lead. Table/19 gives the figures obtained for the two measures. These trends are presented graphically in Figure 3.

- - The first measure essentially gives the percentage of " tonne days of capacity provided by the wagons in transit which was used. We observe from the Table and the figure (that there have been significant swings in the utilisation. In the sixties, the utilisation varied between 52 per cent and 57 per cent. In the seventies, while utilisation in the earlier years was 55-56 per cent, there was a sharp fall to 50 per cent for a couple of years after which there has been a recovery though utilisation has not reached earlier levels. Vercould consider utilisation in conjunction with loaded and empty transit times (given in Figure 4). While loaded transit times have been gradually falling, the empty component has been rising steadily. In 1975-76 when empty transit time 🚓 reached a record level of 50 per cent of the total transit time, utilisation fell to 50 per cent, the lowest in any year of the period under consideration.

while the first measure is important from the point of view judging loaded movement in transit, the 2nd measure is more important in the sense that it analyses one component, namely, loaded movement as part of a magon cycle. It is noted that swings in this figure are virtually absent, although



utilisation has come down from about 11.5 per cent in the early sixties to between 8 and 9 per cent since the early seventies. This, no doubt, indicates very low utilisation but what is disturbing is that even this low rate is not being kept up. Since the loaded transit time component itself forms only about 10 per cent (1982-83) of the total wagon cycle, the low rate of utilisation is not surprising. But it is to be noted that this component formed about 14 per cent of the wagon cycle in the early sixties. Thus, even its limited significance in the wagon cycle has come down. But from an operating view point, when we consider the effects of additional loading on the non-transit component, the empty component assumes important, a point that we have emphasised earlier.

Summing Up

Throughout this chapter, the emphasis was on examining some of the major influences on the emergence of increased empty flows on the network of the Indian railway system.

Besides the growing importance of bulk items in the total traffic and the consequent operating strategies, the increased use of special wagon stock, the gauge problem has also been responsible for empty flows. It is also observed that there does appear to be a trade-off between the turn round time and empty movement. From an operating view point and taking into consideration the deleterious effects of additional loading (filling up empties in backhauls) on the turn round

time, it does seem reasonable to suggest that the railways would prefer to increase empty movement, while attempting to keep the turn round time within reasonable limits. A detailed analysis of empty flows on the network indicates heavy concentration of flows on major routes on which a significant portion of loaded flows occur, a good deal of cross flows of empties on certain segments of the network. Finally, analysis of wagon utilisation when looked at from the point of view of loaded movement in the wagon cycle (turnround time) indicates a low and declining utilisation of wagon capacity.

CHAPTER III

MANAGEMENT AT A NODE - A CASE STUDY OF THE PUNE TERMINAL

A terminal is an integral part of any railway network. Traffic flows originate and terminate in these. Wagons spend a good deal of their time in terminals, in loading, unloading, standing under load, shunting about, and awaiting despatch (in the adjoining yard). On the Indian railway network, there are more than 7000 terminals, ranging from large ones to small ones. But nearly 90 per cent of these handle only about 10 per cent of the total traffic. Even among the rest, only about 50 per cent of them handle a good deal, of the freight traffic involved. Pune is one of the major terminals on the Central railway zonal network. We now examine the relevant issues regarding empty movement at the terminal level. provide a background for the discussion of the various issues, it would be useful, initially, to look into the pattern of loading and unloading currently taking place. The data on the reasvant variables were collected from the Pune goods shed (terminal) and yard offices for the year 1983-84 (April-March).

Pattern of Unloading

The pattern of inward traffic can be understood from Table 12 which gives the monthwise receipts of commodities (major flows) received at the Pune terminal for the year

under consideration. Table 13, on the other hand, gives the monthwise receipts of types of loaded wagons received. These latter figures were obtained from the yard office and do contain a small element of 'through' loaded traffic.

It is observed that the inward traffic consists mostly of foodgrains, coment, stones and sand, fertilizers and general goods. There is a good deal of flow of petroleum products in oil tankers. But we do not include oil tank wagons in our analysis since they have necessarily to be sent back empty to the loading point at Bombay. This is the general pattern of traffic right through the year. When the total of inward receipts (monthwise) are considered, it is observed that there is a fall in receipts during the wet season. This reflects the lower level of activity on the railways in this season. Figures relating to other terminals also clearly reflect this feature. As observed earlier, there is roughly a twenty per cent decrease in freight traffic in this season. But in the case of cement, there is an upswing in receipts. When looking into Table 13, the same holds for certain types of wagons. But in the case of CRT's, BCL's, we note that there is an upswing. This again is a part of the general feature of work loadings in covered wagons to the various parts. From Table 13, it is noted that most of the inward movement is in the conventional C-type wagon : (4 wheeler) which still forms an important part of the total wagen stock and plays a significant role in traffic operations,

especially in transport of goods which come under the 'general' dategory. But given the limited availability of other special types, these are still being used for bulk movement, especially those that need covered supplies for loading. On the other hand, CRT's are water-tight 4-wheeler covered wagons having higher capacity for general goods, while BCI's are water-tight covered wagons (2 1/2 times a 4-wheeler) for carrying foodgrains, cement, etc.. There is a constant flow of cement from the Wadi/Shahabad factories in Andhra, Karnataka. These mostly occur in block rakes consisting master of BCE's and CRT's. Pondgrains are received in CRT's and C's from various parts. Wheat comes from Punjab, Haryana while rice somes from Punjab and Andhra Pradesh. Other grains such as pulses, cereals flow from Utter Predesh and Rejasthan. Fertilizers are mostly received from Broach in Gujaret and imports are had through the Bombay post.

Pattern of Loading

Table 14 gives the monthwise description of traffic (commoditywise) loaded at the Pune terminal. It is observed that the loading hardly touches 200 wagons a month on an average except February and March when loadings go up by about 100 wagons. A cursory glance into loading data in some of the earlier years gives the same picture. The outward traffic consists mostly of soap, waste paper, anions and sugar (in certain months only), railway material and general goods.

In Table 15, we have monthwise loading figures by wagon types.

We note that most of the loading (nearly 60 per cent) takes place in the ordinary C type wagon. Loading in KC's, BCX's and BOX's takes place to a much lesser extent. Goods coming under the 'general' category which fall under 'smalls' are normally despatched in C type wagons. This is true in the case of commodities like soap and waste paper which are sent to various parts of the country. Onions are sent in C's and CRT's while sugar is mostly loaded in CRT's and BCX's. Sugar is normally sent to Eihar, Orissa and Andhra Pradesh.

with the pattern of loading it follows that this results in a good deal of empties, being generated at this terminal.

Pattern of Despatch of Empties:

Wagons from the yard at Pune terminal are set forth in Table

also but a majority of despatches refer to those from the terminal area. Broadly speaking, most wagon despatches are of types C, CRT; KC, BCX/BCXT and BOX/BOXT. Besides, there are also some releases of BRH/BFU units which are special type wagons meant for transport of rails, steelbars/over-dimensional consignments.

; On an average, about 2000 wagons: (in terms of 4-cheelers) are sent every month from the Pune terminal area.. Apart from these despatches, there are also despatches, in piecemeal, of empties in various despatches. In the case of C type wagons, there is a dip in the despatches of empties in the wet months when the inward movements of these types of wagons are lower. On the other hand, the inward movements of special types CRT, BCIT, etc., are higher and correspondingly the despatches are higher than the previous period. It must also be noted that more than 85 per cent of the despatched wagons are of the a covered variety. Inward movements in these are mostly cement, foodgrains. These invariably return empty due to the lack of a 'typical' backload. Er Going further on empty despatches from the terminal, we get an idea of the empty despatches (block rate movement) regarding the direction of movement and immediate destination from Table 17. Nearly 55 per cent of the despatches are in the direction of Wadi, which is around 410 kilometres away. Mearly ene-third of the wagons heading towards Wadi is of the special type BCX/BCXT, etc.. These are mostly returning for

further loading in rake loads in the Wadi/Shahabad cement industrial area. About 23 per centief the total moves towards [hond and are then directed to Manmad at which to point they join the flow on the trunk routes. It is not known whether any significant loading takes place at Ahmednagar, for example, which is in the heart of the sugar belt. It should be possible to utilise these empty flows to despatch sugar to the north especially during the busy period. Another significant flow is towards Kalyan. From here, empties may be worked to Madi Bunder or to the Port Trust railway for loading imports. Empty flows in these three directions constitute nearly 90 per cent of the total empty movement, originating at Pune. Other points to which some empty, movement takes place are Miraj, Sholapur, Magpur, Trombay, etc.

Backloading vis-a-vis the available capacity in terms of empties

From the earlier tables, it is easily observed that back-loading constitutes a basis problem as far as the Pune terminal is concerned. But aggregate data on other terminals (21 major areas) also indicate a similar problem though in the case of a few terminals, a good deal of empties are also moved into the terminal area to satisfy loading orders. It is possible that the need for special types of wagons may are necessitate such a movement into a terminal.

But this may also be due to a certain temporal pattern of

immerd and outward movement which requires empties to be fed into the area. Table 18 gives loading and unloading figures for 21 major terminals. Column 4 indicates inward movement of empties into the various terminals.

Extent of about 2500 wagons in a month, the loading is only around 200 wagons on an average. A good deal of the incoming traffic is on G's while a significant portion of empty movement is also in G's (about 60 per cent of the total). Movement in GRT's occurs in a somewhat significant way only in the busy season although the inflow occur mostly in the slack season. Another ordinary type wagon KC is also used a good deal for loading. On the other hand, loading on special stock such as BCK, etc., is not at all important, while the inflows are m significant.

Although there is very little movement of empties
into Pume in block rakes, there is a good deal of piece
meal movement of empties in both directions on various
sections connecting Pume. This indeed constitutes an example
of cross flows that was earlier indicated with respect to
many segments of the railway network. A knowledge of the
time profile of such movement (even though insignificant)
could help in attempts to use empty flows. But this is a
part of the larger problem of rationalisation of empty flows
on the set work.

Pattern of demand vis-a-vis the property of the property

We observed that backloading seems to be a basic problem as regards usage of empty flows is concerned. We examined loading as compared to the available capacity. Another aspect of the problem is to look at it from the point of view of actual demands on the system. Recall that in the introductory chapter we had emphasised the need to base forecasting exercises (in the present context) on shipper order data as well as historical data on loadings. This would effectively remove biases (upward or downward) effected by these variables separately. It would thus be proper to look into the order data for wagons in order to examine the issue in the proper perspective. But it is not difficult to guess that the lack of demand is a major problem as far as the Pune terminal is concerned. This may not be true in the case of many other terminals. Huge flows of empties originating at some of these points may still be observed in spite of demand pressures. As already emphasised, the need for special vagons may be respondible for the cross flows. Moreover, e perational decisions, when tiewed from a macro-perspective, may dictate more empty running rather than attemptiat utilising comply flows. months. Again, a slumpis observed during the wet season. The other category of wagons that is in considerable demand is the conventional KC type wagons. Both these wagons are mainly used transport high valued manufactured items (as seen earlier). In the months of January, February and March, there is a demand for the CRT type of wagon. This is mainly intended to move sugar (levy and free) to various parts.

When it is not possible to satisfy demands for these wagons,

attempts are made to provide BCX's which are also engaged in transport of these items, even though indenting for these is not normally permitted. In our discussions, we came to understand that since CRT's and BCX's/BCXT's are in restricted movements, indenting is not allowed normally. But it is observed that indents for CRT's are made in the busy season for moving sugar and they are not always supplied. We also understand that there are times (especially the busy months) when there is enough material to be loaded in rake loads, it is not possible to meet these demands, on direction from the headquarters. This is another aspect of the problem which is more closely related to the problem of allocation and distribution of stock among the various competing users given certain priority specifications.

Assignment of Empties

Basically, there are a number of ways in which empty wagons could be assigned to areas where they are required for loading. In practice, this is determined by a host of institutional factors. A variety of mathematical programming models have been proposed to deal with the problem of assignment of empties on a railway network. The earliest was the one proposed by Beckmann et al (1956). This model was a simply one and involved minimizing costs associated with movement of empties between \$ representative points in the United States. Nore recently, more ambitious models have

been worked out by Herren (1973); Miller (1972); Mendiratta (1982). They have tested the models with the data and found the assignments by the models to be useful in minimizing flows. We do not, however, propose to go into such an exercise since the scope of our study is rather limited. It is hoped that a more comprehensive study of the problem in the framework of a modelling exercise can be taken up as part of the next phase of the project which would be undertaken on a much larger scale whence it would be possible to generate the enormous data that would be required for a modelling exercise. For the present study one would only deal with the general problem of decision making at the terminals as related to assignment of empties and the donsequent effects on operations.

In making these choices, they necessarily have to follow certain overall guidelines and constraints defined at higher levels. But a common observation has been that the burden on each of the decision making levels is disproportionated to the resources available with them to function effectively. Moreover, 1; is also observed that since responsiveness at any level is related to the demands on the system. And the railways being a virtual monopoly (with no effective competitive mode, cospecially in certain traffice), the performance does not normally correspond to the higher Topssible level; or, for that patter even to a level which takes care of the prevailing demands on the system.

the manager has virtually no control over certain types of wagons and their usage. We have already reported the case of demand for closed wagons of the CRT and BCX/BCT types which is difficult to cater due to restrictions on their movement. It is not possible to generalise, merely on the basis of experience at a single terminal. However, if this pattern of scheduling practices are so adopted with only the macro perspective in view while overlooking the micro viewpoint, it would not be possible to solve the problem regarding empty scheduling.

But even when this perspective is taken into consideration and acted upon, it is still not quite clear why the pattern of empty despatches has resulted in high detention times, given that they have to be moved to other points on the system, even when loads are being offered. Table 20 gives figures of detention to the average empty wagon for 10 day periods in 1983-84 at the Pune terminal. It is observed that more often that not, an empty wagon is kept waiting for more than a day before it could be despatched. It is also to be noted (Table 21) that this component of detention (empty detention) is often more than 50-55% of the total time spent at the terminal. One problem could be the difficulty in forming empty rakes in order to move them out. But this need not be a problem especially if 70-80 wagons are being released on an average from the terminal. Lack of adequate

motive power could also be a problem. But we understand that this is not at all a problem here. Our own impression in the matter is that the allocation and the consequent despatching processes are carried out on the basis of orders received from the zonal headquarters which in turn depend on the Railway Board for advice regarding allocation and despatch of empties. Here we must take note of an observation of a location and despatch study on mailway management perspectives (1982) that the

Board's preoccupation with day to day movement on a zonewise basis leaves it with little time being left for
important policy aspects of a long term nature and thus do
not get the sustained attention at the requisite intensity.

Conclusion

Pune terminal and also considering the demand aspect, back-loading of empties is a basis problem and thus a good deal of empties are generated here. detention involved in the case of empties awaiting despatch at Pune. Of course, no generalisations can be made. This, we feel, is due to the lack of an effective allocation process which invariably involves a highly centralised but apparently hierarchical set up which results in considerable delays in decision making.

CHAPTER IV

COST CONSIDERATIONS ...

The ultimate cost of moving freight is significantly affected by the extent of empty movement. The unit costs of transportation (say, costs per tonne kilometre, magon kilometre, sto.) are highly sensitive to the intensity of utilisation of magons and empty percentages. Moreover, unit costs vary with the level of empty flows associated with the transport of particular commodities. Thus, these considerations also need to be taken into account in the process of rate-making for the various commodities.

Costs of Empty Returns of

tion normally means that certain product mix costs such as the Costs of return line-haul cannot but arbitrarily be to assigned between specific movements and transportation services. Together with the constant, costs, the division and distribution of these joint, costs between particular elements or units of services, is, thus, held to be arbitrary at best. Since any specific distribution of these costs, is by accepted definition arbitrary, the least arbitrary method, it is normally agreed, consists of an average pro-rate charge to all revenue producing items. Again, the relevance of demand to differentiate the ability of buyers to absorb these costs

is deemed important. Thus, the consideration of these costs has invariably been submerged under the closk of the value of service principle, the guiding factor in rate-making on many systems.

On the Indian Railway system, the value of service principle adopted in rate-making tends to create higher freight-cost margins for high valued commodities. The volume of these items therefore tends to be low. On the other hand, the bulk movements of low-value freight do not offer adequate profit margins. When we consider the allocation of costs of empty returns, the tradition has been to levy an arbitrary pro-rate charge on different revenue-earning items. The empty return ratios for the various commodity groups which are taken into cost considerations on the Indian Railways are given in Table 22.

In our discussions with Board officials, we came to understand that these ratios are quite arbitrary and are reliable only to the extent that they are based on past experience of traffic flows on the network. While it is reasonable to expect that Coal, Iron-ore and POL products would have such high ratios, it is not easy to understand the low figures attributed to other commodities. This is especially so in the context of movement of these items in block rakes. However, we felt it necessary to check the feasibility of these ratios on the flows occuring on the network. For the year 1982-83, the loaded and empty flows associated with

the major commodity groups were calculated. This was done on the basis of the originating/terminating tonnage on the various Railway zones, the average load for the different groups and the average lead of traffic for these commodities. These calculations are presented in Table 23. Hearly 40 per cent of the empty flows can be attributed to the movement of raw materials to steel plants, steel products from steel plants and iron-ore fer exports. Foodgrains, fertilizers and coment account for about 10 per cent of the empty flows while POL products movement results in about a sixth of the empty flows. On accounting for the flows relating to non-revenue traffic also, we find that the total empty movement

This figure more or less corresponds to the actual flows in 1982-83. Thus, it appears that the ratios adopted for ratemaking seem to be reasonably good. These rates may be granted to promote back-hauls in recognition of specific and unique characteristics of the concerned traffic and operations thereby involved. Such a step would be prudent in the context of choice of location of a new economic activity requiring inter-regional movement especially since it would take into consideration the effect of the location of the new activity on balances in transport capacity. For instance, the location of a heavily importing industry may further worsen the existing imbalance. This will result in increased freight costs whereas the heavily importing industry may bring about balance if located elsewhere. Such an argument for discriminatory rates is also advanced by Miller (1977). In the context of attempting to simulate empty flows on the network in the United States, he observed that a good deal of movement of empties is towards the coalfields and felt that this movement could be utilised for the transport of, say, Ironore leading on the Eastern shores. To induce shippers

to use the excess capacity represented by empty back-hauls, he feels that rates must reflect the true marginal cost by being lower where empty back-hauls can be used. In many cases, low rates for back-hauls may enable the railways to get back the lost traffic from other modes. But such directional rates have been traditionally opposed as involving undue discrimination. However, such a stand can also be opposed on the ground that the value of service principle, the guiding factor in rate making, is basically discriminatory in mature.

CHAPTER V

SUMMARY AND CONCLUSIONS

SUMMARI

This preliminary study was motivated by the observation that the Indian Railway System has been, for quite some time, characterised by an acute and ever increasing shortage of wagon and track capacity. While expansion of · out track capacity is virtually ruled on financial considerations, an increase in wagon holding may not be useful unless line and power capacity could be correspondingly increased. Further, a rather detailed analysis of empty flows on the network indicates heavy concentration of such flows on the trunk routes which are also the main arteries for loaded flows, thus pre-empting a good deal of track capacity. Finally, an analysis of wagon utilisation when yiewed from the point of view of loaded movement in the total movement and also in the wagon cycle reveals a very poor utilisation of wagon espacity.

Perspectives on Further Research

We chose to undertake this preliminary study with a view to set up the framework for a more comprehensive study of empty movement and management on the entire system. In our opinion such a comprehensive study would require an exercise of the programming type which would. in turn, require a good deal of data for the major nodes of the system. This would, no doubt, be a formidable task. But in view of our experience of collection of relevant data at Pune, we feel that the task would be less burdensome. More importantly, it would be essential to incorporate the decision making process involved at, all levels within the framework of the programming exercise. But it is not enough having an information and a control system which provides for a knowledge of location of wits and ad hoc rules for allocation of these units. Given the information, such a determination, as Felton (1978) and emphasises, should be an economic decision. This aspect, and which is essentially behavioural in nature, is also to be included in the exercise. In the next phase of the work. we

expect to proceed along these lines. From the railways point of view, there is need for a thorough and comprehensive examination of the turn round time of wagons. And it is even more important to look into this aspect at a disaggregate level since there are wagons of different types that are engaged in the process of moving freight. With the non-transit component playing a significant role in the turn round time, it would be useful to initiate studies into the problem of excessive detentions at various terminals, yards, etc., which contribute in a major way to the poor utilisation of wagon, capacity, . We do hope to take up the dimension of turn round time also for detailed study in the next phase of our work. Also, in the context of consideration of costs and the related problem of rate-making, it is necessary to examine the effects of the pro-rata apportionment of empty movement on various streams of traffic and also look out for an alternative if the current practices is not satisfactory.

When examining the problem from the point of view of the economy, a number of issues could be visualised and looked into separately. An interesting one would be that relating to the location of major parts, movements through them and the hinterland that they serve. This would give us an insight into the efficiency of flows occurring from and to the prets. Similarly, in the context of location of major industries in an area, it would be useful to look into the potential demands on the system in the area and relate them

to the available capacity resulting from imbalances.

Concluding Remarks

To conclude, it is heartening to note that the Indian Railways are going in for a massive computerised. freight operations management system which is mainly aimed at facilitating and improving operational decisions in practice. However, it must be remembered that such a system could also serve as the basis for information for the conduct of large-scale studies such as the one that we have conceptualised.
