## FOREWORD

THE survey, the first volume of whose report is now being published, was initiated by a letter from the Kolhapur Municipal Borough inviting the Institute to undertake the work. At the time the invitation was received (December 1944) the Institute was facing its chronic problem of shortage of experienced staff. It could not, therefore, undertake to depute a member of its staff to Kolhapur as it had done when conducting the survey at Sholapur. The Institute, therefore, suggested the following plan of work to the Borough authorities. "The Institute would plan the survey, would supervise the work at all stages, would tabulate the data and would write the final report. The Institute will not, however, open a separate office at Kolhapur but will work through the Kolhapur Municipal Borough. A separate agency will have to be set up by the Kolhapur Municipal Borough itself for this purpose. The Institute would undertake to advise in the setting up of this agency and the recritment of its staff, would lay down the complete details of the plan of field work and would send a member of its research staf. say, once a month to Kolhapur to supervise the conduct of this work." This plan of work proved acceptable to the Kolhapur Municipal Borough and was, in the main, adhered to in its actual conduct.

The investigational establishment in Kolhapur was set up in June 1945 and its work finally wound up in March 1947. Mr. N. V. Sovani was in full charge of the work of the survey through all its stages and will be also responsible, in the main, for the reports. He has been assisted on the statistical side by Mr. V. M. Dandekar. Statistician of the Institute. The Chief Investigator at Kolhapur was Mr. W. C. Shrishrimal. As pointed out above, the survey was initiated by the Kolhapur Municipal Borough. The President and Councillors of the Borough and all important officers of the Borough evinced considerable interest and gave active help in the various investigational projects. The Kolhapur Durbar also extended to the survey its active sympathy. Above all, from the inception to its completion. the survey owes a great deal to Mr. J. P. Naik who was Hon. Secretary of the Reorganization Department. Kolhapur Municipal Borough, when the work was conceived, and was Development Secretary of Kolhapur Government when the work at Kolhapur was ended.

This publication represents the first volume of the report of the third socio-economic survey of an urban area in Maharashtra undertaken by the Institute. The full reports of the two previous surveys have not yet been published. Of the Poona Survey only one of the two projected volumes has been published and the Sholapur Survey is represented by the monograph on the Hand-Loom Weaving Communities and Industry. Railway which joins the
Southern Mahratta
Railway at Miraj.

## SECTION I: THE CENSUS STATISTICS

1. The Census Unit.-Since the first Census in $\mathbf{1 8 7 2}$ the figures regarding the population of the Kolhapur Municipal area and the Cantonment are separately available. The latter included the Civil Station, the Sudder Bazaar and the Infantry Lines. For the first time in 1901 the Census Report gives the population separately for Suburbs, in addition to the other two areas mentioned above. The Suburbs included the newly created ward of Shahupuri and other areas besides. The classification of area introduced in 1901 was followed in the 1911 Census Report. In 1921, however, the Census officer adopted a different classification. Figures were separately furnished regarding the populations of the Kolhapur Municipal area and Shahupuri, the Suburbs, and the Civil Station (formerly Cantonment). In compiling the 1921 Census returns this classification was adopted, but adjustments of the figures of 1911 and 1901 to this new classification were not made, either through oversight or carelessness. As a consequence, the Census Report for 1921 gives the population of the Kolhapur Municipal area and Shahupuri in 1911 as identical with that given by the Census Report of 1911 for the Kolhapur Municipal area alone. In 1931 the same classification was continued, the earlier figures for 1911 and 1901 having been left unadjusted as before. We had to adjust the figures to eliminate this discrepancy. This was possible because the Census Report of 1911 furnished the figures of the population of Shahupuri in 1901 and 1911. In Table 1, figures have been adjusted accordingly.
2. Historical.-The earliest estimate of the population of Kolhapur City is that made by Major Graham in 1852. According to him, in 1852 "the population altogether is estimated at 43,387 souls, calculated on a census taken of the living and checked by the returns of mortality." ${ }^{\prime \prime}$ This was divided into the various castes as follows: Brahmins 7,170; Jains 1,185; Lingayets 2,030; Marathas 21,278; other Hindu castes 8,105; Mohammedans 3,619. The classification of the population according to occupations was as follows: Sirdars
[^0]40; 1st class Inamdars 16; Petty Inamdars 500; Palace establishment 4.633; Artificers or Manual labourers 2.077; Manufacturers and those engaged in other occupations 2,336; Petty traders 2.735; Day-workmen 1.400; and others including 3,832 servants, pages, etc., 20,286 women and children and 100 Mangs and Ramosees. ${ }^{2}$

Remarking upon the general state of the town of Kolhapur at that time, Major Graham observed: "The town of Kolhapur is now greatly overgrown, exceeding in circumference a distance of four miles and a half, and totally disproportionate as a capital to the extent of territory; but in later times, the residence of a despotic Government, chiefs and officers flocked to the Court; and the numbers were further swollen by the royal army and the retainers required, according to the spirit of the nation, to be in attendance. About onetwelfth of the entire population of the State was thus huddled together in great discomfort, and as no sanitary measures were in force, the ravages of the epidemics were severe; and in the year $1824,8,000$ people were carried off during the short period of a fortnight." ${ }^{3}$
3. Movement of Population, 1872-1941. - The population of Kolhapur City increased by about 140 per cent during the period of 70 years between 1872 and 1941. Nearly three-fourths of this increase occurred, however, during the last two decades. Table 1 sets out the relevant data.

In 1872 the total population of Kolhapur City, including Sudder Bazaar and Infantry Lines, ${ }^{4}$ was 39,621 . The population of "Kolhapur Cantonment" in the same year was put at 1,412.5 Of the total population of Kolhapur, excluding Infantry Lines and Sudder Bazaar, 89 per cent were Hindus and 8 per cent Mohammedans. The ratio of females to males was 92 to 98.

Compared with Major Graham's figures for 1854, the 1872 Census tecorded a slight decline in the population. We do not know whether Graham's figure included the Cantonment population. If it did, the decline in 1872 can be put at

[^2]about 2.000 . The comparative decline of the royal court at Kolhapur after British occupation and the consequent reduction in the numbers of those dependent on it, partly foreshadowed by Graham, may account for this decline.

The population of the Kolhapur Municipal area, including the Suburban area, was put at 38.599 in 1881, and that of the Givil Station and Infantry Lines at $\mathbf{1 , 3 1 1}$. We believe that the latter two areas specified include the area formally designated as "Cantonment." The total population of Kolhapur (all areas) in 1872 was 41,033 and the 1881 figures, therefore, showed a decline of about $1.000^{\circ}$

At the next Census in 1891, the population of the Kolhapur Municipal area and the Suburban area together recorded an increase of more than $\mathbf{7 . 0 0 0}$. Already toward the close of the preceding decade the life in the town was becoming more enlivened and a sort of revival was getting under way. New buildings were rising in the town, prominent among these being the New Palace outside the town (1877-84), and the

[^3]Albert Edward Hospital (1881-84). The Rajaram College was started shortly after 1880. The old fort wall round the town was demolished and the moat round it was filled up. This was mainly done for fighting the overcrowding within the town wall, and to encourage people to build new houses outside it. The supply of drinking water in the town was very much improved by the construction of the Kalambe Tank (1881-83) in the vicinity of the town, whose water was brought into the town by a conduit. Pipe lines were also laid throughout the town. The drainage system was also improved and underground drains of stone were constructed in several parts of the town. A stone embankment was built zound a part of the Rankala lake in the vicinity of the town (187783). The capacity of the lake was increased and the original intention, in doing this, was to supply drinking water to the town from it. The idea was later given up. During this period the Shivaji Bridge, fording the Panchganga River, was constructed, and roads leading into the Konkan from Kolhapur were completed. This resulted in the growth of trade and traffic into and through Kolhapur and the town came into prominence as a gateway to the Konkan. Trade was further stimulated by the construction and opening of the Miraj-Kolhapur railway line in 1891. The conditions in the town were thus favourable for population growth. Of the total increase of about 7,000 recorded at the Census in 1891 , about 4,000 were males' and the rest females. The larger increase among males might have been due to the presence in the town of male immigrants attracted by its growing trade, etc.

In 1901, the population of the Kolhapur Municipal area and Shahupuri increased to 50,329 . The preceding decade was generally prosperous, but was marred by the outbreak of plague and the occurrence of famines toward its close. The Shahupuri ward was created in 1896. Kolhapur was growing in importance as a centre of trade, particularly after the opening of the Miraj-Kolhapur railway in 1891, and many traders were settling in the town. The conditions were thus favourable for an increase in the population, though they were adversely affected toward the close of the decade by plague and famine. It might be also noted that the net increase of population of about 5,000 in the Kolhapur Municipal area and Shahupuri was almost equally divided between the two sexes.

During the next decade, the population of the Kolhapur Municipal area and Shahupuri recorded a decline of about 8,000. The population of the Suburbs increased by a little less than 90 per cent, while that of the Civil Station and Infantry Lines remained stagnant. Commenting on the decrease of the population of the Kolhapur Municipal area, the Deputy Superintendent of the Census in 1911 wrote: "The decrease in population was due to the severity of the plague epidemics that have attacked the city repeatedly since 1901. The population in Shahupuri, a suburb of Kolhapur City, has, however, increased from 1,233 to 2,671 , the rise being due to the tendency of the citizens to erect houses with sufficient ventilation in the open air of the suburb and to the starting of the Shri Shahu Mills and other industries in Shahupuri." ${ }^{\text {T }}$

In 1921 the total population of Kolhapur recorded an increase. Almost the whole of this increase was confined to the Kolhapur Municipal area and Shahupuri. The population of the Suburbs showed a slight decline and that of the Civil Station and Infantry Lines, only a slight increase. The influenza epidemic of 1918-19 affected the population adversely. The total deaths recorded in Kolhapur city in 1918-19 increased to 2.665 from 1,628 in the preceding year. The decade was otherwise normal. The growth of population in Shahupuri was to be largely attributed to the growth of the trade of the town, which was largely concentrated in Shahupuri. ${ }^{8}$ The increase in the population was almost equally shared by both the sexes.

In 1931 the total population of Kolhapur recorded an increase of 30 per cent over that of 1921. The increase, as during the previous decade, was mostly concentrated in the Kolhapur Municipal area and Shahupuri. The decade 19211931 was free from epidemics. During this period many city development schemes were adopted and executed. Kolhapur was rapidly becoming a large centre of motor-bus transport in the Southern Maratha Country. Trade and industries in the town were also expanding. In 1928 the Shahu Spinning Mill was expanded and a weaving department was opened. Educational institutions in the town were also multiplying and the town was growing in importance as a place of education. The total increase of about 17.000 that occurred during this decade

[^4]was unequally shared among the sexes，females increasing，by 7，000 only．

At the Census of 1941 the population showed an im－ crease of 32 per cent．No detailed Census Tables have been published，because the tabulation of Census data was giverr up for reasons of economy in India．The comments have， therefore，also to be brief．The preceding decade was not free from epidemics like plague，but these were much milder than in previous decades．The economic conditions had beem depressed，but at the time of the Census in 1941 World War II was in the third year and business and trade in the town was brisk．

4．Birth－place．－Table 2 gives the classification of the population according to birth－place．

These are the only type of migration statistics compiled in India every ten years at the time of the Census．As migra－ tion statistics they are，of course，not of much use．Their shortcomings are well known and need not engage us here． The figures in Table 2 do not call for any lengthy comment． They show generally that the population of Kolhapur was largely home－born，the few outsiders being mainly derived from the surrounding territory of Kolhapur State and the Jagirs，the Konkan districts and the Belgaum and Satara districts．

5．Sex Ratio．－Table 3 gives the figures regarding the sex－composition of the population．

The figures for the Suburbs，the Civil Station and Infantry Lines and the Municipality have been given separately in the table．It is，however，not necessary to comment separately

on these figures. Only the aggregate figures for Kolhapur town, Suburbs and the Civil Station and Infantry Lines are commented upon in the following.

The figures for 1852 and 1872 cannot be explained satisfactorily. From 1881 up to 1931 there was almost a continuous decline of the male-female ratio. This might result from a steadily growing influx of male migrants into the town because of the growing trade and industries in it. Regarding migrations, as explained above, the statistics are insufficient to throw light on this particular problem. In 1941, however, the proportion of women in the total population recorded an increase. No explanation can be offered for this development.
6. Population by Religion.-Table 4 gives the population of Kolhapur City according to communities during 19111941.

As before, the figures for Kolhapur City as a whole are considered below. The figures of total growth show that as
compared with the growth of the total population during 1911-41, the most remarkable growth was among the Jains who increased by a little more than 300 per cent during the period. The Hindus showed a below-average increase, while the Mohammedans and Christians showed an increase slightly above the average. The movement of populations of Hindus, Mohammedans and Christians need not be commented upon, as they broadly conform to the general pattern of the movement of population of the city as a whole. The growth of the Jain population is a remarkable phenomenon. Most of this remarkable growth took place during 1931-1941. The explanation of this can be sought in two directions. It might be due to the natural increase of the population and/or to an influx of immigrants into the town. As regards the first, it is possible to say from the available figures that the age and sex composition of the Jains, as revealed by the Census of 1931, was more favourable to growth than that of the other communities. In 1931 the proportion of women between 15 and 45 years of age to the total women was 49.2 per cent among Hindus and 46.6 per cent among Mohammedans; it was 52.5 per cent among the Jains. So also while the proportion of married women between 15 and 45 years to total women in the Jain community was about 91 per cent, the proportion among Hindus was 85 per cent, and that among Mohammedans, 82 per cent. This might be interpreted as some evidence to show that the Jains might have increased at a faster rate than the other communities during 1931-41. This must be, of course, adjusted for the considerably lower sex ratio among the Jains than in the other communities. As regards migration, no detailed figures are available. Jains are a commercially-minded community and they are prominent in Kolhapur trade. The growing trade in the city, especially after the outbreak of World War II, might have attracted Jains from surrounding parts into it.
7. Age Composition.-Table 5 sets out the information regarding the age composition of the population in Kolhapur City.

These statistics, as all the age statistics in the Indian Census Reports, are defective in many respects. The ages are not usually returned accurately and there is a tendency on the part of people to report their ages as some multiples

of five．The age returns，therefore show concentrations at five－year－age intervals．For individual years，the age returns certainly give wrong information，but when arranged in classes of five or ten years，they give a fairly accurate picture of the age composition of the population．We shall have occasion to comment again on age statistics in Section III．

A few remarkable developments as revealed by the figures in Table 5 may be commented upon．Among the fe－ males in the age group $0-5$ years，there was a sharp decline in 1921．While the proportion of women in this age group to the total women was 13 in 1911，in 1921 it had dropped to 11 ，but had again increased to 14 in 1931．In the age group 40－60，the women show a sharp drop in 1931；the proportion of women in this age group to total women dropping from 17 per cent in 1911 and 1921 to 14 per cent in 1931．The proportion of males in the same age group also showed a decline in 1931，but the decline was，though slight，also to be found in 1921．Both these developments might be expected in the age composition of a growing urban centre，which，as it expands，attracts more and more young male and female immigrants，particularly the former．As a consequence，the proportion of the population in old age groups declines．As a counterpart of the decline among males and females of 40－60 years noted above is to be found the
increase in the proportion of males and females in the age group 15-40. The proportion of females in the age group 15-40 increased from 42 per cent in 1921 to 44 per cent in 1931, while that of males in the same age group from 43 per cent in 1921 to 47 per cent in 1931.
8. Age, Sex and Civil Condition.-Table 6 sets out the information regarding the age, sex and civil condition of the total population of the Kolhapur Municipal area, Suburbs and Civil Station. The population of the Suburbs and the Civil Station formed only a small proportion of the total population, and no purpose could have been served by treating the figures for all these parts of the town separately. They were, therefore, combined in a single table for comments.

A few broad features stand out from the figures almost immediately. The percentage of the married population in the total has remained almost unchanged around 45 during 1911 31. On the other hand, the percentage of unmarried population in the total increased from 38 in 1911 to 44 in 1931. while that of the widowed population decreased from 16 in 1911 to 11 in 1931. Though the percentage of the married had remained almost steady during 1911-31, there were some significant changes in the age distribution of the married population. Among married males in 1911 the percentage of those in the age group $20-40$ was 57 , and that of those in the age group $40-60$ years was 28 . In 1931 the percentages had changed to 60 and 26 respectively. Among married females the percentage of those below 15 years of age was 19 in 1911, and in 1931 this had declined to 11. The percentage of married women of the age group 20-40 was 17 in 1911 and 20 in 1931. These figures would broadly indicate that among females the tendency was toward the age at marriage rising duxing 1911-31.

The decline in the percentage of the widowed population during 1911-31 was very largely concentrated among females, and particularly among females below 20 years of age. The proportion among the female widowed population of those below 20 years of age was 4 per cent in 1911, and it had declined to 2 per cent in 193 I . This would broadly indicate that because of the decline in the number of marriage: below 15 years of age, many such females, who would have

been married and widowed in the natural course, were spared both the ordeals. This would thus largely appear to be the result of the rise in the age at marriage.

This development is also corroborated by a further analysis of the figures regarding the unmarried. The increase in the proportion of unmarried in the total population was again largely confined to the females, and particularly among females of $10-15$ years of age. Among the unmarried population, the proportion of those in the age group $10-15$ years was 16 per cent in 19.11, and it had increased to 24 per cent in 1931. We shall have occasion to comment in greater detail regarding this tendency toward a rise in the age at marriage up to 1931 in Section III.

In the total married population, the proportion of persons in the age group $15-40$ increased from 67 per cent in 1911 to 73 per cent in 1931. Among males it increased from 64 per cent in 1911 to 67 per cent in 1931, and among females from 70 per cent to 77 per cent during the same period. The proportion in the same age group among the unmarried population was 19 per cent in 1911, and had increased to 22 per cent in 1931. Among females it had increased from 4 per cent in 1911 to 6 per cent in 1931, and among males from 26 per cent to 31 per cent during the same period. This latter movement would suggest a rise in the age at marriage of males.
9. Age, Sex and Civil Condition of Communities.Table 7 summarises the data regarding the age, sex and civil condition in respect of Hindus, Mohammedans and Jains.

The sex ratio showed a continuous decline in all the communities during 1911-31. The number of females per 1,000 males declined from 890 in 1911 to 862 in 1931 among the Hindus, from 886 to 830 among Mohammedans and from 840 to 730 among the Jains. Among the two former communities the decline was only slight, that is, only about 5 points, during 191 $\mathrm{I}-2 \mathrm{I}$, the major part of the decrease occurring in the next decade. Among Jains these developments were in the reverse order.

Only some broad trends might be noted regarding the major age groups. The proportion of persons in the age group

$40-60$ showed a decline during $1911-31$ in all the communities, the largest decline occurring among Mohammedans. The proportion of the population in the age group 20-40 did not show any significant change during the same period among both the Hindus and the Mohammedans. But among the Jains the proportion increased from about 36 per cent in 1911 to 39 per cent in 1931 . Among the Hindus and Mohammedans the age group $15-20$ showed a slight increase during the period, but among the Jains a slight decline was recorded. A glance at the age composition of the three communities shows that there were only minor differences in this respect as between the Hindus and the Mohammedans. But the Jains displayed some significant differences. On the whole, the proportion of population in the age group $20-40$ was markedly higher among the Jains than among the other two.

As regards civil condition, it can be observed that the proportion of unmarried males had increased by about 6 per cent in all the communities during 1911-31. The major part of this increase had occurred during 1921-31. The proportion of unmarried females had also increased by about 6 per cent during the same period among the Mohammedans and Jains, but the increase was 8 per cent among the Hindus. The proportion of widowers in the total population showed a slight decline in all communities. The proportion of widows showed a rather sharper decline over the period in all communities. The decline was only 4 per cent among Jains, 6 per cent among Mohammedans and 7 per cent among Hindus.

## SECTION H: HOUSE SAMPLE POPULATION (1946)

1. The House Sample Inquiry.-In this Section information regarding the population of the city at the time of our survey is presented. This information is furnished by the comprehensive inquiry into the socio-economic life of the resident families in the city that was carried out by us and which was the pivotal inquiry around which the whole survey revolved. In making this inquiry, the methods and procedure followed were, with minor modifications, similar to those followed in the surveys of Poona and Sholapur previously carried out by the Institute. In selecting the sample for this inquiry, we took the house as the unit in preference to the family, mainly because no lists of families resident in the city were available to us.

Kolhapur City is divided into five wards. The total area within the municipal limits has been divided, according to the latest city survey, into 14.195 so-called "estates." Each "estate" is given a serial number and there is a separate series of such numbers for each ward. An "estate" may be a house, a tank, an open plot of ground, agricultural land, etc. In giving numbers to various "estates," the city survey looks mainly to the convenience of the record of land, etc., rights. All the houses in the city bear the numbers given by the city survey and these numbers are usually treated as house numbers. It is, however, obvious that every city survey number does not necessarily represent a house. For our purposes it was necessary to make a list of houses in the city which were mainly or partly used for residential purposes. It was not possible to draw up such a list from the city survey records. A Rent Survey was, however, in progress at the time our inquiry was being planned. The information collected in this survey was made available to us by the Kolhapur Municipal Authorities and from this we were able to prepare lists of house numbers which were used mainly for residential purposes. Temples, mosques, hospitals and houses used only for commercial purposes could be thus excluded from our list initially. In respect of Ward A, which had not till then been covered by the Rent Survey, similar information regarding houses was not available. It was collected by our junior investigators by visiting

every house in the ward．This was necessarily a hurried in－ quiry and had to be conducted in the course of two or three days．The information gathered was not，therefore，so thor－ ough as in the Rent Survey，and showed many gaps during the subsequent inquiry．As can be seen from Table 8，the largest number of substitutions of house numbers had to be made in respect of this ward．When the lists of residential house numbers were ready，every tenth house in them，be－ ginning with the first in each list，was marked for being in－ cluded in the sample．Of the total 14，195＂estates＂in Kolha－ pur City， 11,580 were found to be residential houses．Our sample included 1，160 houses．

The house numbers originally selected could not be ad－ hered to in all cases．Some of the houses were found to be non－residential，in some others there were no residents at the time of the survey，still others，because of a vast programme of city planning that was then actively under way，had been pulled down for road widening and construction of new roads．The numbering of houses was in many cases defective． In some cases even privies were found to have been given separate numbers．Also some of the numbers could not be traced．For all these，new numbers had to be substituted in the sample．For giving substitute numbers a definite pro－ cedure，as in the Poona Survey，was adopted．Where a par－ ticular house number had to be substituted，the one preceding it in the list was substituted；if even the latter was found to be unsuitable，the number next to the house number origi－ nally selected was substituted．Table 8 shows the number of house numbers thus substituted and the reasons for these substitutions．

The choice of the house rather than the family as the unit of the sample might have distorted our sample，in respect of resident families in the city，if the sampled houses had largely consisted of specially large units containing a large number of families of homogeneous types，that is，families be－ longing to the same caste or profession，etc．As can be seen from Table 9，this did not happen．Our sample was well dis－ tributed．More than half of the sample houses were one－tene－ ment houses．Houses having more than five tenements were slightly more than 3 per cent of the total houses in the sample．

As in the Poona Survey，the investigators were chosen from among the primary teachers of the city．In all， 26 in－ vestigators were recruited for the purpose．The houses to be covered by each one were allotted to him by the Survey Office． Usually an investigator was allotted the sample houses that were near and around his own residence，so that some knowl－ edge of the locality in which he was collecting information and of the residents thereof could be safely expected of him． This led to more correct entries in the inquiry schedules．The average number of schedules filled in by an investigator were 83．They were uniformly paid at the rate of eight annas per questionnaire correctly filled in．

The questionnaire used was almost the same as in the Poona Survey with a few modifications．A translation of it is given in Appendix I，together with the explanations and in－ structions given to the investigators．At a preliminary meet－ ing of the investigators on November 8，1945，the whole
questionnaire was explained to them item by item. All queries and doubts of the investigators were cleared. They were then asked to fill in a sample of ten questionnaires each, of any of the families of their acquaintance, and to return them to the Survey Office the next day. These were then critically examined. The mistakes that were detected were pointed out to the investigators at a second meeting on November 10, 1945, and all lingering doubts, etc., were again clarified. The work of the survey began during the subsequent week and each investigator was allotted his house numbers. One questionnaire for every family resident in the selected house numbers was filled in. As in the Poona Survey, the family was defined as "any group of persons living together as a separate economic unit." All the questionnaires were accepted at the Survey Office only after a careful scrutiny for consistency, adequacy and definiteness of information. Questionnaires failing to satisfy the tests laid down were referred back and correct information was again sought. Besides this, about 5 per cent of the sample houses were independently visited by the junior investigators of the Survey Office for checking the information contained in the questionnaires regarding the families in those houses. By this procedure it was possible to avoid a large number of mistakes, etc., and consequently the total number of questionnaires that had to be finally rejected was negligible.

A glance at the translation of the questionnaire used in this inquiry printed at the end of this Section, would show that the information collected by means of it covered a very wide range. All this information will be presented at appropriate places in the course of the series of volumes on the Social Survey of Kolhapur City. The present volume deals with population only, and the information on this item abstracted from the family schedules is presented here.
2. Comparison With the Census Statistics.-The information regarding the House Sample population can be compared with the 1941 Census information only in one or two respects because of the incompleteness of the latter; in all other cases the comparison can be made only with the 1931 Census information.

The total House Sample population was 10,590 . The House Sample included one-tenth of the residential housen in Kolhapur, but it need not be supposed to have necessarily
covered one-tenth of the total families or population in the city. Many house numbers had to be substituted for in the original list. But broadly speaking, we shall not be far wrong if we take our sample as covering one-tenth of the population in the city. Under this assumption, the total population of the city at the time of our survey might be put in the neighbourhood of 105,000 . As compared with the 1941 population of 95.904 , this might be taken to show an increase of about 10 per cent during the intervening 5 years. The sample population, however, does not include vagrants as well as the populations of institutions like hospitals, jails, etc., which are included in the Census enumeration. If a due allowance is made for this fact, the rate of increase of the population can be regarded as exceeding 10 per cent.

In the House Sample population the number of females per 1,000 males was 993 . It was 880 in 1941. The considerably higher proportion of females in the House Sample than in the Census population is not, however, surprising. As remarked earlier, the former does not include vagrants as well as institutional populations-population groups in which males are more numerous than females-which the latter does. The same phenomenon was also met with in the Poona Survey. ${ }^{1}$

Table 10 gives the distribution of the House Sample population according to age along with that of the 1931 Census population. It will be observed on a comparison of these figures that, while the first two age groups in the House Sample population show marked increases, the age groups 20-40 and $40-60$ record declines of 4 per cent and 2 per cent respectively. This is again not surprising if we remember the peculiarities of the House Sample population noted earlier. It should be noticed that the increases and decreases in the majority of age groups are more marked among males than among females. This would naturally result from the exclusion of predominantly male populations from the House Sample population. ${ }^{2}$

Table 11 sets out the information regarding the age, sex and marital condition of the House Sample and the 1931 Census populations.

The proportion of the unmarried in the House Sample population is much higher than in the 1931 Census popula－
tion. In 1931, 52.5 per cent of the males and 35 per cent of the females were unmarried. In the House Sample population these percentages were respectively 60 and 43.5. The magnitude of change in the case of both the sexes is almost equal and the direction of the change is also the same. There is a corresponding drop in the married population among males. The females recorded declines of only 5 per cent among the married and of 3 per cent among the widows. The proportion of widowers in both the populations is almost the same.

An examination of the age composition of the "married" and the "unmarried" in both the populations shows that the proportion of the unmarried among males in the House Sample population had sharply increased in the age group 0-15, while their proportion had declined slightly in the age groups 15-20, and more sharply in the age group 20-40. Taking into account the peculiarities of the House Sample as contrasted with the Census population, these figures would generally indicate that the proportion of the unmarried had increased in the earlier age groups. This is also seen from the statistics regarding married males. Among married females in the House Sample as compared with the Census population, the decline in the age group $5-15$ is marked. Generally, therefore, in the case of females also, the number of unmarried has increased in the earlier age groups.

Altogether these statistics indicate a general rise in the age at marriage among both males and females. A more extensive investigation and discussion of this phenomenon will be found in Section III.

Table 12 gives the classification of the House Sample and the 1941 Census populations by communities.

The proportion of various communities in the populations is seen to be broadly the same. While the percentage of Marathas in the 1941 Census population was 49.5, it was only 43.0 in the House Sample population. The difference is due to the different classification adopted in regard to the latter. In the House Sample population such artisan classes as potters (Maratha Kumbhar), carpenters (Maratha Sutar). etc.. who are generally classified in the Census as Marathas, were separately grouped and were not included in the Mara-

thas. Hence the smaller percentage of Marathas in the House Sample population. The higher percentage of Christians in the House Sample population cannot be satisfactorily explained.

## 3. Age, Sex and Civil Condition in Different Wards.-

 Table 13 sets out the information regarding the age, sex and marital condition of the House Sample population classified by wards.It will be at once obvious that the wards do not differ from one another very materially in regard to population, sex ratio, age composition or marital status. The variations as revealed by the table are only incidental to the random sample. This non-variability springs from the arbitrary character of the ward boundaries. The wards do not represent divisions of the city having any historical, social or economic significance. They are merely arbitrary divisions for administrative purposes and solely made to serve that convenience. No detailed comments are called for. Attention is directed to certain facts in the following: The sex ratio is lowest in E ward, being 950 females to 1,000 males, and highest in C, 1,020 females to 1,000 males. The total range of the variation is, however, relatively insignificant. The age distribution between different wards shows no marked differences. Only in the case of females in E ward, the age composition is somewhat different from that in the other wards. The proportion of females in the age group $15-45$ was 48.2 in this ward and only 43.2 in B ward, while it averaged 46 in the other three wards. No explanation for this can be of-

fered. The percentage of the total married, unmarried and widowed are closely similar in all wards. The percentage of unmarried males was highest, 63.4, in E ward and lowest, ;7.0, in B ward. The percentage of married fermales was high:st, 44, in E ward and lowest, 38, in A ward.

## SECTION II: THE FERTILITY SURVEY

1. Scope, Method and Procedure.-In planning the fertility survey an initial choice had ta be made between the two possible types of surveys. One type consists of the detailed recording of the fertility history of all women in the sample chosen irrespective of age. This amounts to the recording of the fertility performance. of all women during the whole of their reproductive period. The second type consists in gathering information regarding the fertility of women in the reproductive age groups, say 13 to 50 years, during a specific period of 2 or 3 or 5 years. The first type of inquiry is more useful in analysing and determining the various long term influences that determine and affect human fertility. On the other hand, it relates itself to a very extensive period; i.e. the information collected with regard to all the women in the sample chosen belongs to a period which might exceed 50,60 or even 70 years, as women of these ages are also eligible for inclusion in the sample. The averaging of the data for this extensive period might conceal much more than it might reveal. This is a serious draw-back of this type of inquiry. It is also more difficult to carry out as it is necessary to gather data relating to a very long period. People's memories are proverbially short and the possibilities of getting wrong information increase manifold if the data over a longer period than, say, the preceding 2 or 3 years, is attempted to be gathered.

We chose the second type of inquiry as more suitable, because it concerns itself with the fertility history of the period which is comparatively fresh in the memory of the people. The total number of questionnaires to be filled in is also reduced in this type of inquiry as, instead of all the women in the sample, information regarding women in the reproductive age groups only need be gathered.

We had to think beforehand of the difficulties that we might meet with in attempting this sort of survey. In the first instance we were not sure as to the response that we might get from the public. It was obviously necessary, in gathering the sort of information we wanted, to contact the women folk in the sample families. Women investigators were obviously
more suitable for this job. We were able to recruit 10 female primaxy teachers for this purpose. For ensuring public response to a certain extent, a committee of 7 women prominent in the social life of the city was formed to help us.

We had next to decide on certain measures for avoiding some of the difficulties that we feared would be encountered. The greatest difficulty we imagined (and correctly as experience showed) was with regard to the recording of individual ages. Experience in India showed that the recording of ages was all along very defective in all such inquiries. It was necessary to guard against this or alternatively, if it was inevitable, as it actually proved in the circumstances, to take steps to reduce mis-statements of individual ages as far as possible. - Here we were up against the fact that the people at large did not mis-state their age deliberately; the mis-statements arose out of sheer ignorance about their own ages. The people concerned did not know their ages. Their estimate of their own age ranged between 2 to 4 years on either side of the actual correct age. We could at best try to eliminate this range on either side. The questionnaire asked for information regarding the present age of the woman between 13 and 50, her age at marriage, the present age of her husband, etc. It was necessary for the success of the inquiry that these ages be recorded fairly accurately. With a view to help to determine and record correct ages, we decided to use a device which had partially been used by $\mathrm{D}_{\mathrm{r}}$. Kakade in the survey of the weaving communities in Sholapur. ${ }^{1}$ This was an attempt to revive the associative memories of the people. The common mass of people did not remember, or did not really bother to remember, the age at which they were married or the age at which the first child was born. These events, however, were subconsciously associated in their minds with certain public events in the city or in the neighbourhood. Thus, if the age at marriage of a woman was to be ascertained, she could be persuaded to try to remember whether her marriage or the birth of her first child was associated with any public event in the locality, and she would respond in some such way as, 'I was married in the same year in which X (some prominent person in the city) died." By thus reviving associative memories many

We prepared, with the aid of the committee of women mentioned earlier, a list of prominent events in the life of the city and its people during the preceding half century. Copies of this list were given to our investigators for ready reference. Many of them had frequent occasion to refer to the list and they reported that it helped them in many instances to fix correct ages and dates. This method, however, could not be expected to be a corrective for all mis-statements of age. It is of limited potentiality and we do not make any greater claims for it than it actually deserves. It was a useful method and it did serve as a corrective to mis-statements of age in several cases.

A translation of the questionnaire used for this survey is printed at the end of Section III, Appendix I. The questionnaire was devised to cover a period of 5 years preceding the inquiry. It sought to collect information regarding the fertility performance of women between 13 and 50 years of age. It recorded all births, incomplete, single and multiple, occurring during those 5 years, to women in the sample families who were between 13 and 50 years of age at the time of the inquiry. The sex of the child was noted in all cases as well as the rank of the delivery reported. Regarding each woman in the age group 13-50 years included in the sample, information regarding present age, age at marriage, education, marital status, profession and income was collected. In the case of the widowed, married and re-married women, information regarding the age, profession and income of husbands was also sought. The fertile period of the Indian female usually begins and ends earlier than in the West. It is usually taken to begin by about the thirteenth year and to end by about the forty-fifth year. ${ }^{2}$ The fertility questionnaire sought to gather information regarding women between the age group 13-50. The extension of the end-period by 5 years was necessary in view of the fact that a period of 5 years was sought to be covered by the questionnaire. If we had confined ourselves to women who were between 13 to 45 years of age at the time of the inquiry, that would have taken out of our purview women who were in the age group 45 to 50 in 1945 and in consequence the fer-

If we had confined ourselves to women who were between 13 to 45 years of age at the time of the inquiry, that would have taken out of our purview women who were in the age group 45 to 50 in 1945 and in consequence the fer-

[^9]tility data regarding those who were 45 years of age in 1941 . 1942, 1943 and 1944, would have been lost. The total information gathered would have been to that extent deficient. Regarding the families in the sample, the questionnaire sought to gather information about the total number of members in the family by broad age groups, the living space at their disposal, their income, their caste and subcaste, etc.

We had, as a part of the Socio-Economic Survey of the city, already launched an inquiry in regard to families in the city. This has been fully described in Section II. For the fertility inquiry we did not think of varying the sample. We allotted the house numbers that were selected for the other inquiry among the women investigators recruited for the fertility inquiry and instructed them to collect information regarding all the families resident in those houses. This decision was advantageous in two ways. Firstly, the fertility questionnaire could be made very much shorter and simpler than it would have been otherwise feasible because the information regarding the very same families was being gathered by means of a separate and a more detailed questionnaire. The fertility questionnaire, therefore, could confine itself to the barest minimum of information regarding the family and concentrate on the collection of data regarding fertility. Secondly, some of the questions contained in the fertility questionnaire were the same as in the House Sample questionnaire. The information was, however, collected by two separate agencies. They thus served as a check on each other and information on many a point in the two questionnaires covering the same aspects could be compared and the correctness or otherwise of the information ascertained. It should be remembered in this connection that the women investigators usually contacted and obtained information from the women folk of the family. The enumerator working on the family survey schedule, on the other hand, contacted male members in the family and got his information from them. The fertility survey covered the same house numbers as the House Sample inquiry. The fertility inquiry was launched two months after the House Sample inquiry began. During the interval, the vast programme of city development that was referred to in Section Il was in full swing. Many houses were being acquired and demolished and resident families were also
shifting on a rather large scale. As a consequence the fertility inquiry covered only 1.946 families, i.e., 168 families less than the House Sample inquiry. This was unavoidable. It should, however, be stated that all the families covered by the fertility inquiry were also covered by the House Sample inquiry. As a result the two samples differed to the extent of only 168 families.

The survey was launched at the end of December 1945. The women enumerators were invited to a preliminary conference where the questionnaire was fully explained to them. Each of them was asked to fill in 5 to 10 questionnaires as a sort of training. These questionnaires were examined critically the next day and the mistakes that were being committed were explained to each enumerator. The enumerators were paid at the rate of As. 4 per questionnaire correctly filled in. No questionniaire was admitted as correct unless checked for consistency, precision, etc. About 5 per cent of the questionnaires were re-checked by the Chief Investigator by revisiting the families in question. The survey was completed in June 1946. A total of 1,946 families was covered by it.

The data gathered were tabulated after being checked for internal consistency. This is a proper place for recording the deficiencies of the data that were gathered. Firstly, we were not successful in eliminating the usual lumping of age returns at 5 year age intervals. The information showed that the age returns were greatly biased in regard to such individual age years as $15,20,25$, etc. This defect of the data, however, did not arise out of any carelessness on our part. We had taken all precautions and, as noted previously, had done everything in our power to ensure correct age returns. As we have noted previously, the defect of the age returns really arose from total ignorance of the general mass of people regarding age. This is a common occurrence in India. In the Indian Census returns and even in a careful inquiry, as the one carried out by Dr. Rama Varma in Cochin, this lumping effect could not be avoided. It can be eliminated by various statistical devices and the data made to correspond much more to reality. All these steps have been described at the proper place.

Another defect of the data arose out of the limitations of our enumerators. The questionnaire, among other things,
sought information regarding living space. In many cases the enumerators had to make an estimate of the total area used by a family, when family members were not able to give the living space in some such commonly known measure as the "khan." The "khan" again did not mean, even approximately, the same amount of area in different wards of the city or even in the same ward. In the majority of instances therefore, in recording area the enumerators had to make estimates. The estimates that were actually made differed so widely from enumerator to enumerator that it was impossible to bring any uniformity into them. The information regarding living space, therefore, had to be written off as not reliable.

The first defect noted was not intractable and has been largely eliminated by well known statistical devices. The second could not be remedied in any way. All the information gathered on this point had to be rejected. The rejected information was not, however, of such a nature as materially to affect the total information collected regarding fertility and did not affect the success of the inquiry.

It would also be proper to note at this stage a side issue. The fertility schedule, among other things, also sought information regarding the practice of contraception among the women in the sample. The regular use of contraceptives was reported in 3 cases only. Even allowing for incomplete recording on this point, there is no reason to believe that contraception was practised to any significant extent in Kolhapur City. The fertility data presented in the subsequent pages, therefore, show fertility almost wholly unaffected by the practice of contraception.
2. Sample Women.-In the 1,946 families covered by the inquiry, there was a total of 2.825 women between the ages of 13 and 50 years. In 53 families no women between these ages were found. Table 14 shows the distribution of these women among different castes and age groups.

At the time of the inquiry, 328 out of the 2,825 sample women were unmarried, 390 were widows and 2.019 were married. The marital status of the remaining 88 was ambiguous. They included concubines, prostitutes, as well as women

indulging in other types of extra-marital relations. There were, also, a few divorced and deserted women among these.
3. Record of Births.-A total of $\mathbf{1 , 8 4 3}$ deliveries were reported as having taken place during 1941-45 among the . 2,825 sample women. In vital statistics "a birth means both the act of bringing forth a child or more (in case of twins, etc.) and the fact of a child being born." ${ }^{\text {s }}$ So that by the number of births is indicated either the number of total confinements or the number of children live-born. We have adopted the first definition in our analysis and every delivery has been taken to represent a birth.

Of the 1,843 births recorded, 458 were reported to have occurred during 1945, 338 during 1944, 389 during 1943, 322 during 1942, and 336 during 1941. For various technical and other cogent reasons, we decided to treat all the births occurring during the period 1941-45 as a whole instead of treating separately births occurring in each single year, for the calculation of specific fertility rates. The various statistical and other problems involved are discussed in detail in Appendix II, Note 1.
4. Eligible Women-If, however, births were to be treated as a whole for the calculations of the age specific fertility rates of married women, they could not be obviously related to the 2,019 women in the sample who were recorded as married at the time of the inquiry; for a number of them had entered matrimony some time during the five years covered by the inquiry and had consequently spent a part

[^10]of that period as unmarried．It was necessary to take into account only those who had got married before 1941 and who remained married throughout the five－year period（lst January， 1941 to 31st December，1945）covered by the in－ quiry．These may be conveniently described as eligible women．Even from among these it was necessary to exclude those who were separated from their husbands because of war service，etc．，for a considerable stretch of time during this period．Eligible women were thus women who were mar－ ried before 1941 and were not widows in 1945，those there－ fore who were open to the chance of pregnancy and delivery during all the five years covered by the inquiry．These and the births occurring among them duxing the five－year period could only be used for calculating the specific fertility rates of married women．In Table 15 the 2,825 sample women are classified by quinquennial age groups and by the different causes determining their eligibility in the above sense．

Of the 2,825 sample women， 686 were unmarried in 1940 ，i．e．，at the end of 1940 ，and therefore at the beginning of 1941 ，and 390 were widows in 1945．That group of 88 women of ambiguous marital status was a heterogeneous group and defied further classification．For this and other cogent reasons it was decided to treat this group as non－ eligible．In the case of two married women the husbands were reported to have been away on war service during most of the period covered by the inquiry．These two had，therefore， to be excluded．The total number of eligible women thus came to 1,659 ．

5．Age Distribution of Eligible Women．－The 1,659 eligible women are distributed by single age year groups ac－ cording to their ages at the time of the inquiry in Table 16.

The table shows the usual features of age returns in India．There is a heavy concentration at quinquennial ages such as $20,25,30,35$ ，etc．So also，though to a lesser ex－ tent，there is a certain bias in favour of even ages，like 18， 22．24，28，etc．As remarked earlier，this defective character of age returns was inevitable as it largely arose out of the vague ideas of the general run of people regarding their own． ages．For eliminating this defect the only practical remedy was to group the eligible women in quinquennial age groups． Any graduation of age returns was out of account as it created another indissoluble problem；for even though a more realistic age distribution of the eligible women could be ob－ tained by graduating the age returns，that could give no indi－ cation as to how the number of births was to be distributed among them．

6．Specific Fertility Rates．－As already indicated，we have derived the specific fertility rates by considering the total births occurring during the whole five－year period．Thus， for instance，to 192 women in the age－group 16－20 were born a total of 212 children during the five years．From this is worked out the average number of births per annum per 1,000 women．This specific fertility rate is attributed to age 16，that being the mid－age of the group in the mid－year of the investigation period，namely，1943．In the same man－ ner，from the total births occurring to women in the other age groups are derived the fertility rates attributable to ages 21，26， 31,41 and 46 respectively．These are set out in Table 17．For details regarding the derivation of these rates
reference is made to the Appendix II，Note 1．In Table 17, are also given specific fertility rates for Cochin and Travan－ core，for facility of comparison．

It should be noted that while the specific fertility rates in Travancore and Cochin are attributable to the mid－year of the various age groups，in the case of Kolhapur City，because of the five－year period covered by the inquiry，the mid－year of an age group is shifted 2 years backward from the normal one．Thus，while the specific fertility rate of 221 for the age group 16－20 is attributable to the age year 16 in Kolhapur， the specific fertility rate of 230 for the age group 15－19 in Travancore is attributable to the age year 17 ，the mid－year of the age group．

The specific fertility rates in Kolhapur display the usual features associated with specific fertility rates everywhere． A comparison with the Travancore and Cochin rates would show that the general levels of fertility in all the three are fairly close to one another．The pattern of the fertility curve in Kolhapur，however，conforms much more to that of Travancore．Both begin at a fairly low level and reach the peak，Kolhapur in the age group 21－25，and Travancore in the age group 20－24；then there is a gradual decline，which becomes faster and sharper after the 35 th year．In contrast， the Cochin fertility curve starts from a similar initial position as the other two，is almost steady over the three age groups between 21 and 35 years，followed by a decline which is not

[^11]as sharp or rapid as that in Kolhapur and Travancore. Why does the Cochin curve show a different pattern? It is difficult to answer the question. The Cochin rates show a suspicious degree of stability over the three age groups from 21 to 35 years. It is difficult to believe in fertility remaining so stable over these age groups. Whether the abnormality observed is due to any bias in sampling or any other cause is not known.
7. Single Age-Year Specific Fertility Rates.-From the quinquennial fertility rates given in Table 19, the specific fertility rates for each individual age were worked out by graphical interpolation. These are given in Table 18 which also embodies similar rates for Travancore.

8. Net Reproduction Rate.-The next step is to calculate the net reproduction rate for which it is necessary to
take account of mortality conditions. This is usually done by using a life table. In regard to Kolhapur, we could use the life tables of the Bombay Presidency prepared in 1931. In Table 19 the net reproduction rate derived by using this life table is presented.

If all the girls born today. surviving as per the life table rates at various ages, get married, the net reproduction rate in Kolhapur City comes to 1-15.

9. Factors Affecting Fertility.-We now proceed to analyse the effects of various factors which do, or are supposed to, affect the fertility of a population. Below we discuss the effect of nine such factors in respect of our sample. These factors can be grouped into two categories: (1) Sociobiological factors and (2) Economic factors. In the first category are included (a) The age of the mother: (b) The age of the father; (c) The duration of marriage; (d) The age at marriage and (e) The caste. In the second category are (f) Income; (g) Profession of the father and (h) Profession of the mother. These are discussed seriatim in the following:
(a) Age of the Mother: In computing the specific fertility rates, the only factor affecting fertility that is taken into account is the age of the mother. It is generally and rightly taken to be the most important factor, among all the others, that influence fertility. Yet, to what precise extent is the variation in the specific fertility rates due to the age of the mother? For this it is necessary to approach the problem from a slightly different angle, i.e., to analyse the variation in the number of births occurring to each woman in the sample during the period of investigation. In Table 20 the distribution of 1.659 women in the sample divided into quinquennial age groups and grouped according to the number of births occurring to each of them during 1941-45, is set out.

It would be observed that of the 1,659 women in the sample, about 40 per cent bore no child during 1941-45, 30 per cent had one child each, 26 per cent 2 and 5 per cent 3 children each. To 9 women, 4 children each were born during the period, and there was a single instance in which the woman had children at the rate of one per year. This variation we may now proceed to analyse into two components, one due to the fact that the women were of different ages and the other due to all other causes. This is presented in Table 21 in the standard form of the analysis of variance, and measures in a sense the influence of the age factor as against all the other factors affecting fertility.

It should be observed that the age of the mother is the most important factor affecting fertility and accounts for a large portion of the total variation in the specific fertility rates. In evaluating the effect of other factors on fertility, it is obviously necessary to eliminate the effect of the age of the

mother. This is sought to be done in the tables that follow by comparing the actually recorded number of children to groups of women distributed according to the other factor under consideration. with the number of children expected to be born to the same women if only their age composition is taken into account. The difference between the "observed" and the "expected" broadly shows the variation in fertility due to the other factor under consideration after the effect of the present age is eliminated. This difference, however, might be at times the result of the peculiarity of the particular sample chosen or what is technically known as sampling variation. The statistical procedure for evaluating this is to calculate the probability that the observed deviation between two series might have arisen from mere chance coincidenca In case such probability is found to be very small, it can be inferred that the observed differences are due to real effects of the factor under consideration rather than mere chance coincidence. A compact measure of the deviation of the observed series from the expected one is afforded by the statistical measure known as the Chi-square (goodness of fit of observation to theory). In the following discussion this measure has been used everywhere to test the statistical significance of variations in fertility rates arising from various factors. (See Note 2, Appendix II.)
(b) The Age of the Father: The age of the father is a factor which is known to influence fertility. The data furnished by the fertility inquiry at the 1931 Census in Travancore and Baroda showed that the larger the disparity of ages of the parents the fewer the children. ${ }^{8}$ The statement refers, it should be noted, not to children born during a specific period, but to all children born before the date of the inquiry.

Table 22 sets out the distribution of the 1,656 women in the sample according to the ages of their husbands and the number of observed and expected births occurring to them.

The Chi-square value definitely indicates that the age of the father significantly affects fertility. Both in the lower and higher age groups of husbands, the actual number of births are less than could otherwise be expected, while in the central age groups between 26 and 45 years they are markedly in excess. It might be, however, thought that the difference between the ages of the husband and the wife rather than the age of the husband is a more significant factor affecting fertility. With a view to testing the effect of this factor, the data in Table 22 are re-arranged in Table 23, which shows the distribution of the sample women in each age group according as their husbands are in relatively lower or higher age groups and the number of observed and expected births occurring to them.

The data show that if the husband is about the same age as the wife or is older than she by less than 5 years, the fertility tends to be lower than can be expected otherwise. If, however, the husband is older than the wife by 5 to 10 years, the fertility is observed to be higher than the expected. If, however, the husband is older by more than 10 years, fertility tends to be lower. Inability to deal with single age year groups makes it impossible to indicate more precisely the influence of this factor on fertility. ${ }^{7}$ Making use of our data, we now proceed to calculate fertility rates specific both for the age of the mother and that of the father or the age of the woman and the difference between her age and her husband's age. These are set out in Table 24. For details regarding methods reference is made to statistical Note 3 in Appendix II.

(c) Duration of Marriage: The duration of marriage is also regarded as a factor that affects fertility. In Table 25 our data are regrouped to facilitate the study of this phenomenon. It gives the distribution of eligible women in the sample by the duration of marriage and the observed and expected number of births occurring to them.

The data show that there is no significant correlation between fertility and the duration of marriage. ${ }^{8}$

(d) Age at Marriage: The age at marriage of a woman indicates the starting point of her active fertile life. The effect of the age at marriage on fertility can be of two types. It might affect the specific fertility rates, or the total fertility. The latter aspect has received much attention in India. An earlier or later marriage lengthens or shortens the active fertile period of a woman. It was observed in the fertility inquiry at the 1931 Census that the average number of children born to women married later than 20 years of age was larger than that of those married at earlier years. ${ }^{\circ}$ Our data have no direct bearing on this issue. They throw light only on the effect of the age at marriage on specific fertility rates. In Table 26 the eligible women in our sample are distributed according to their age at marriage and the "observed" and "expected" number of births occurring to them are given.

The value of the Chi-square indicates that the age at marriage does not affect fertility rates in any significant manner. In other words, if there are two women of the same age, but married at different ages, their fertility rates are not likely to differ.

The conclusion has an indirect bearing on the phenomenon referred to above, i.e., the total number of children born to women married at different ages. If specific fertility rates are not affected by the age at marriage, the total fertility of two groups of women married at different ages may differ because of the different age compositions of the two groups. If in the fertility inquiry at the 1931 Census, it was found that women married after 20 years of age had on an average a larger number of children than those who were married at earlier ages, this was probably due, it may be suggested, to the different age compositions of the two cohorts of women covered by that inquiry, i.e., the cohort of women married at ages above 20 years, may have had an age composition favourable to higher fertility than that of the other cohort. It is not possible to verify this suggested explanation as the Census Report does not furnish figures regarding the age composition of these two cohorts of women separately.
(e) Caste: Caste is a factor of immense sociological significance in India and its effect on fertility has attracted at-

tention．In Cochin，Dr．Rama Varma＇s investigations showed that the total fertility of different castes differed significantly． It is not，however，possible to test whether the differences in fertility between castes disclosed by this investigation are really significant in the statistical sense，because of the absence of detailed figures regarding the ages and number of women of different castes．For studying the influence of castes on fertility in our sample，Table 27 has been prepared．

Again the value of Chi－square indicates that the caste factor is not significantly correlated to fertility rates．This means that fertility rates of two women will not differ merely because they belong to different castes．Biologically speaking the fertility of different castes does not show any marked or significant differences．
（f）Income：From very ancient times it has been re－ marked that the rich have fewer children while the poor have more．Economic circumstance has also been observed as a S．S．K．F．－5
factor significantly affecting fertility in several fertility inquiries in the West as well as in India. ${ }^{10}$ In Table 28 the women in our sample are distributed according to the total income of their family and the number of "observed" and "expected" children is shown. Naturally women coming from the same family fall in identical income categories.

The value of the Chi-square. again shows that income does not affect fertility rates in any significant manner.
(g) Occupation of the Father: Fertility is also known to vary among different occupational classes. Table 29 shows the distribution of eligible women in the sample according to the occupation of their husbands and the number of "observed" and "expected" births occurring to them. The scheme of occupational classification is the same as that adopted for Poona and Sholapur Surveys. It is also being followed in this survey.

The following are the occupational grades as per this classification:

Grade 1: Unskilled Manual Work (domestic workers, sweepers, bidi workers, etc.)
Grade II: Skilled Manual Work (gardeners, weavers, carpenters, masons, washermen, barbers, cooks, etc.)
Grade III: Lowest Professions and Administrative Posta (primary teachers, nurses, astrologers, priests, peons, etc.)
Grade IV: Small Businesses (hawkers, small shops, small businesses, etc.)

Grade V: Highly Skilled and Supervisory Manual Work (fitters, motor repairers, goldsmiths, tailors, compositors, jobbers, etc.)
Grade VI: Clerks and Shop Assistants.
Grade VII: Intermediate Professions and Salaried Posts (Civil and mechanical engineers, overseers, secondary teachers, administrative posts such as sub-inspectors, sub-registrars, etc.)

Grade VIII: Medium Businesses (grain and grocery shops, prepared food and drink shops, agency business, repair shops, etc.)

Grade IX: Highest Professions and Salaried Posts (administrative officers, liberal professions-professors, doctors, lawyers, etc.)

Grade X: Owners of factories, large shops, etc.
These grades are arranged in an ascending order of social and economic importance. They broadly fall into three broad economic groups. Grades I, III and V—skilled and unskilled wage-earners (manual labour) : Grades IV, VIII and X—business (enterprise); Grade III, VI, VII and IX—professions and administrative work (services and salariat). The grades are not thus purely "skill" or purely "status" grades, but rather "skill-status" grades. Grades XI, XII, XIII are in a class by themselves. Grade XI contains Pensioners, Grade XII Beggars and Grade XIII Unemployed Persons. All unclassified persons are put into Grade XIV.

The value of the Chi-square in this case also shows that there is no correlation between occupation and fertility rates.
(h) Occupation of the Mother: It has been observed that the occupation of the woman, if she is an earner, influences fertility. ${ }^{1{ }^{1}}$ In Table 30 such women, i.e., earners, among the eligible women in the sample, are distributed according to whether they did manual or non-manual work and the number of "observed" and "expected" births occurring to them.

Again the absence of any significant correlation between the profession of the woman and her fertility is shown by the value of Chi-square.

The analysis made so far shows that, except for the age of the mother and the father, the other factors did not affect fertility rates in any significant manner. Broadly it indicates the absence of differential fertility among castes, income groups, professions, etc. This should occasion no surprise. Dr. Pearl observed after examining a large mass of data that "if it were not for the effect of contraceptive efforts and the practice of criminal abortion, together with correlated habits as to postponement of marriage, there would apparently be little or no significant differential fertility as between eco-

nomic, educational or religious classes of urban American married couples. ${ }^{12}$ In Kolhapur, where the various economic. social, etc. classes did not significantly differ as regards marriage habits, practice of contraception, etc., the absence of differential fertility would be only natural.
10. Sex of Children Born.-Of the Eotal births recorded in our survey during $1941-45,48$ per cent were female births. The question as to what factors determine the sex of a child has attracted considerable attention in India and a major part of the fertility data gathered at the 1931 Census as well as the 1941 Census were gathered with that aim. In the following we have tried to gauge the influence of three factors that are supposed to affect the sex of the child. These are (a) caste, (b) age, (c) order of delivery. The relevant data are set out in Table 31 . The influence of these three

[^16]factors on masculinity was tested for statistical significance. This showed that the variations of the sex-ratio among the children born was not correlated with any of these three factors in any significant manner.

11. The Age at Marriage.-The fertility schedule sought and obtained information regarding the age at marriage of all married and widowed women in the sample. As the sample consisted of women between $13-50$ years of age, this information could be used to throw light on the changes that might have taken place in the age at marriage between 1896 and 1933, a period of 37 years. Of the total 2,825 women covered by our inquiry, 328 were unmarried in 1945. Of the remainimg, omitting the small group of prostitutes, concubines, etc., and a few others in whose case the age at marriage was not reported, we have information regarding the age at marriage in regard to 2,396 women. (In the few cases of re-married widows, ages at their first marriages are considered.) Table 32 gives the average age at marriage in each age group and caste.

Considering all women together irrespective of their age, the average age at marriage is found to be nearly 13 years or 12.89 years to be exact. It can be observed that among the Brahmins the age at marriage was the highest. Jains came very near to Brahmins in this respect. Harijans had the lowest average age at marriage. Among the Marathas it was only slightly higher.

By the same method we might now study the movement of the age at marriage through time，i．e．，between 1896 and 1933．The figures clearly bring out the fact that there has been a very definite，though rather small，shift in the age at marriage over the period，though there is a slight recession toward the end of it．An analysis of variance showed that these movements in the age at marriage were statistically significant．The latter seems to be common to all castes and is particularly marked among Brahmins．It appears that this trend began，in the case of Brahmins，some time between 1925－30．It was not to be observed then among the other castes．It is not possible to adduce any satisfactory explana－ tion as to the cause or causes of this phenomenon．There is no reason why the correctness of the information regarding recent years should have been less than that regarding the earlier period．Generally it would appear that from the be－ ginning of this century till about 1930 the age at marriage among all communities，except the Brahmins as noted earlier， recorded a small but progressive rise．The magnitude of the increase was also roughly the same，about 3 years，among the different castes．

12．Births and the Rank of Delivery．－The question－ naire for the fertility inquiry also furnished for every birth re－ corded，the rank of delivery．The information gathered on this point is both interesting and instructive and is summarised here．For this purpose，in the case of women reporting more
than one delivery during the period, only the first of the reported deliveries is taken into account.

Of the total such deliveries recorded during 1941-45, 12.1 per cent were first deliveries, 20 per cent second deliveries, 19.3 per cent third deliveries, 18 per cent fourth deliveries, 10.8 per cent fifth deliveries, 7.4 per cent sixth deliveries and about 4.1 per cent seventh deliveries.

More than half of the first deliveries were concentrated in the age group -21-25 and 37 per cent occurred in the age group 16-20. Nearly 57 per cent of second deliveries were again concentrated in the age group $21-25$, while 21 per cent were found in the age group $16-20$ and 16 per cent in the age group 26-30. About 44 per cent of the third deliveries occurred to women in the age group 21-25 and about 32 per cent to those in the age group 26-30. Nearly 43 per cent of the fourth deliveries were lumped in the age group 26-30, a further 29 per cent and 18 per cent of them occurring in age groups $21-25$ and $31-35$ respectively. In the age group 26-30, occurred 42 per cent of the total fifth deliveries, 25 per cent occurring in the age group 31-35 and 17 per cent in the age group 21-25. In the age groups 26-30 and 31-35 were reported 40 per cent and 29 per cent respectively of the total sixth deliveries.

In the age group 16-20. 38.4 per cent of the total deliveries reported were first deliveries and 37 per cent second ones, 13 per cent third ones and 9 per cent fourth deliveries. In the age group 21-25, 16 per cent were first deliveries, 32 per cent second ones, 26 per cent were third ones and 17 per cent fourth deliveries. Third and fourth deliveries were 19 and 26 per cent respectively in the total deliveries occurring in the age group 26-30. A further 17 per cent were fifth deliveries. Fourth and fifth deliveries were about 20 per cent and 17 per cent respectively in the age group 31-35 and about 16 per cent were sixth and 10 per cent seventh deliveries. In the age group $36-40,18$ per cent were fifth deliveries, 14 per cent sixth ones, while 10 per cent each were third, fourth and eighth deliveries. In the age group 41-45. third and sixth deliveries were 21 per cent each, and fifth and eighth deliveries 10 per cent each. A case each of eighteenth and nineteenth deliveries was reported and both of them were in the age group 36-40.

13．Rank of Delivery and Fertility．－The number of previous deliveries of a woman under investigation might af－ fect her fertility and fertility might tend to decline with each successive delivery．${ }^{13}$ This can be tested by classifying women in each age group according to the number of their previous deliveries，i．e．，number of deliveries prior to the period un－ der investigation．If the number of previous deliveries to a woman does affect her future fertility，age specific fertility rates，made further specific for the order of delivery，should be expected to differ significantly．But we could not follow this method of analysis because of a deficiency in our data． In our inquiry，information regarding the order of delivery of every birth recorded was collected，but no information about the total number of deliveries that had occurred to women who reported no delivery during 1941－45 was re－ corded．Yet some light may be thrown on the point by at－ tacking the problem from a different angle．

If we classify the women in the sample according to the number of births occurring to each during the period of investigation，we find that 483 women reported only one delivery each during the period， 422 reporting two and 95 reporting three deliveries．In the case of all these 1,000 women the number of deliveries that had occurred to them previous to the period of investigation，could be calculated from the reported order of their first delivery during the period of investigation．This calculation shows that $2,17 \epsilon$ deliveries had occurred to these 1,000 women prior tc 1941－45．The average number of prior deliveries to womer in the various age groups can also be calculated．They are given on the next page．

If the 483 women reporting only one birth during the period of investigation are distributed into age groups anc the total number of prior deliveries to them is calculated bs the aid of the averages given above，we can find what mas be called the＂expected＂number of prior deliveries to these women．The calculation shows that 1,110 prior deliveries may be expected to have occurred to these women．In thi

calculation, it should be remembered that the averages derived from the prior deliveries of all the 1,000 women have been applied to 483 women with one delivery only during the period of investigation. The expected number of prior deliveries thus calculated presumes that the number of prior deliveries does not affect future fertility. In fact, however, the 483 women were reported to have had 1,175 deliveries prior to the period of investigation, a number greatly in excess of the expected 1,110 .

The results of this and similar calculations in respect of women reporting 2 and 3 births each during the period of investigation are presented below.

It will be seen that, in contrast to women reporting one birth during the period of investigation, in the case of women reporting two and three births each, the actual number of prior deliveries reported was less than that expected. To put the results in another manner, women with relatively more prior deliveries reported relatively fewer births during the period of investigation and vice versa. The above analysis clearly indicates that the number of children already born, at any rate above a certain minimum, tends to diminish future fertility.
14. Still Births, Untimely Deliveries, and Multiple Births.-Table 33 gives the still births, untimely deliveries
and multiple births occurring to the eligible women in the sample during 1941-45.

## APPENDIX I <br> INSTRUCTIONS TO INVESTIGATORS FOR FILLING HOUSE SAMPLE QUESTIONNAIRES

General: A list of house numbers to be covered during the inquiry will be supplied to the investigator. Separate questionnaires should be filled in for each resident family in the selected house. Investigators should immediately report cases of refusal to give information, a single house bearing more than one municipal number, etc.

Use one questionnaire for one family only. Information regarding every individual in a family must be entered in the questionnaire. Guests, temporarily staying with the family, should not be taken into consideration. Persons not related to the family and yet permanently staying with it should be treated as members of the family. Persons paying for their boarding and lodging with the family should be also classified as above and the fact should be noted in column 1 (p. 2) "relation.".

In case many persons are living together in one tenement and are jointly paying rent, the name of the person in whose name the lease stands should be entered against "name" (p. 1), and all others should be entered as "common tenants" in column 1 (p. 2), "relation."

Name: The name should be that of the head of the family (male or female).

Caste and Sub-caste: Undex this heading details of sub-castes should be given. In the case of non-Hindus, other sectional differences, if any, such as Catholic, Bohra, Pathan, etc., should be noted.

Earners: Persons continuously following some gainful occupation should be entered under this head. Persons not earning, for the time being, because of illness or a temporary lack of employment, etc., should also be treated as "earners."

Relation: Under this heading should be entered the relation of the person concerned to the head of the family.

Education (A) Earners: In the case of persons who have received some school education the standard up to

## Appendix I

## INSTRUCTIONS TO INVESTIGATORS

A list of house numbers to be covered by each investigator will be supplied to her. Investigators should immediately report to the Chief Investigator cases of refusal to give information, uninhabited houses, etc., so that substitute house numbers can be given to them. Use a separate questionnaire for each family.

Occupation: In recording the information regarding the occupation of the head of the family and the husband (Column 9) give details such as: carpenter in a furniture workshop, brass-and-copper smithy, clerk in the Agricultural Department, clerk, salesman or hamal in a retail or wholesale shop, etc.

Column 1: All women between 13 and 50 years of age in the family must be entered in this column. Do not write names; only enter the relation of each to the head of the family, such as wife, daughter, sister, daughter-in-law, sister-in-law, etc.

Column 5: This column is to be filled in only in the case of widowed or re-married women. In the case of divorced women enter the age at the time of divorce.

Column 8: To be filled up only in the case of married or re-married women.

Column 12-16: In these columns are to be recorded the deliveries, whether complete or incomplete, occurring to women between 13-50 years of age, during 1941-45. Record still and multiple births as also the rank of delivery in each case. In the case of completed deliveries, note the sex of the child and its age at the time of the inquiry; if the child is not living at that time, note the fact and also its age at the time of death, such as "son, dead, 8 months," etc. In the case of twins, etc., note carefully the sex of each child.

## Note 1：Derivation of Specific Fertility Rates

In the following is given the fertility record as obtained year by year for the 1,659 eligible women grouped in quin－ quennial age groups．

The difference between the total number of births in different years is rather striking，especially so between the years 1943 and 1945 on the one hand and 1944 on the other．This difference，unless satisfactorily explained，would be an indication of defective birth reporting．The reports were obtained in a single visit at the end of 1945，and the general impression that the above table conveys is that at least a few births which really occurred in 1944 were re－ ported as occurring in 1945．This appears very plausible in view of the fact that no attempt was made to obtain the dates or even roughly the months in which the births oc－ curred．On the other hand，the year 1943 does not seem to suffer from any such effects of foreshortening and，if any－ thing，actually seems to have gained a little as if from a re－ porting of a few births of 1942 as in 1943．This is certainly a somewhat intriguing picture．Finally，it appears not un－ likely that all births that occurred in 1941 and 1942 might not have been reported．This could happen through the omission of some of those births whose issues were not living in 1945.

Such are the possible defects in the birth reporting. Before we pass judgment on such a possibility, we may inquire as to whether there are any other causes which may create fluctuations in the annual fertility performance such as observed.

The first important fact causing differences between individual years is that the 1,659 women do not remain of the same ages throughout the whole five-year period. For instance, all the women are one year younger in 1944 than in 1945. Five years is a fairly long period to cause important differences in specific fertility of the majority of the 1,659 women. This factor alone, therefore, should cause some differences between the years.

In order to remove the effect of this factor, we first find out the average number of deliveries per 1,000 women of each age group, for each of the five years.

It is now possible to make due allowance for the fact that the women do not remain of the same ages for all the five years. The women in the age group 16-20 are seen to have 328 deliveries per $\mathrm{I}, 000$ of them, in 1945. Their midage in 1945 is 18 , so that the rate is attributable to this age. In 1944 they were all younger by one year, so that their mid-age then was 17 , and the rate 198 per 1,000 is attributable to that age. In this way, from the deliveries occurring to women of age group 16-20, we may derive specific fertility rates for ages 14, 15, 16, 17 and 18 from the record of years 1941, 1942, 1943, 1944 and 1945 respectively. Thus proceeding, we may derive fertility rates for all individual ages from 14 to 48 . These are given below.

If the factor under consideration, namely, change in age during the five year period was really an important

cause of the differences observed between different years, we would expect the specific fertility rates to give us a smooth and gradually changing series. Instead there are very regular ups and downs of the type, for instance, that the rates derived from the record of 1944 are consistently lower than those derived from either the 1943 or the 1945 record.

There is, of course, one defect in the above derivation of specific fertility rates which would prevent them to some extent from being a smooth series. There are 192 women who were of ages from 16 to 20 in 1945; or, more accurately, there are so many women who reported themselves as of these ages in 1945. There is no doubt that all of them were one year younger in 1944. It is highly questionable, nevertheless, whether, if the inquiry were actually conducted in: 1944 instead of in 1945, these same women would have' reported themselves as one year younger than they actually did in 1945. In so far as this is so, the procedure adopted' above attributes to the age returns an accuracy which is not their own.

There is. yet another reason, rather of a technical character, which may cause the type of fluctuations between years as are observed. It is a physiological fact of human reproduction that a woman is not and cannot be exposed to the chance of becoming pregnant while she is already pregnant. Roughly this amounts to the fact that a woman cannot normally deliver more than once during the course of a single
year. This fact results in giving her a much smaller chance of delivering in any calendar year, such as 1945, if she has already delivered in the preceding year. So far as the performance, year after year, of a single woman is concerned, therefore, we are bound to find marked variations from year to year. This inherent variation in the performance of a single woman tends to persist even in the collective performance of a group of women unless the group is very large. Consider, for instance, a group of women of a certain age of whom we expect, on specific fertility conditions, that fifty should deliver this year and forty-eight next year. Suppose now that by chance it happens that not fifty but actually sixty deliver this year. This happens and is termed the chance deviation from expectation. Such chance effects become less and less prominent in the collective performance of a larger group, the reason being that the individual chance deviations tend to cancel one another. In smaller groups, however, such effects are usual and consequently expectations are seldom exactly realised. In such a case, therefore, when sixty instead of an expected fifty deliver this year, it is almost certain that next year not forty-eight but a considerably smaller number will deliver.

Technically we say that the random errors in two adjacent specific fertility rates, derived from the performance from year to year of the same group of women, are negatively correlated, so that if the derived rate at one age happens by chance to be an overestimate, the same in the subsequent year is most likely to be an underestimate. We may expect the series of specific fertility rates derived from such data to show on this account a zigzag appearance with alternate ups and downs.

This is just the kind of variation that is observed from year to year. Thus specific fertility rates at $18.23,28,33$. 38,43 and 48 which are derived from the record in 1945 appear to be overestimates, and those for $17,22,27,32$, 37, 42 and 47 derived from the birth record in 1944 are underestimates, and further again those for $16,21,26,31$, 36,41 and 46 derived from the birth record in 1943 are overestimates. There is, however, one disturbing feature, namely, that all estimates of specir $c$ fertility rates at the several ages derived from the birth record of 1945 are over-

cause of the differences observed between different years，we would expect the specific fertility rates to give us a smooth and gradually changing series．Instead there are very regular ups and downs of the type，for instance，that the rates derived from the record of 1944 are consistently lower than those derived from either the 1943 or the 1945 record．

There is，of course，one defect in the above derivation of specific fertility rates which would prevent them to some extent from being a smooth series．There are 192 women who were of ages from 16 to 20 in 1945；or，more accurately． there are so many women who reported themselves as of these ages in 1945．There is no doubt that all of them were one year younger in 1944．It is highly questionable，never－ theless，whether，if the inquiry were actually conducted in 1944 instead of in 1945，these same women would have reported themselves as one year younger than they actually did in 1945．In so far as this is so，the procedure adopted above attributes to the age returns an accuracy which is not their own．

There is, however, one disturbing feature, namely, that all estimates of specir $c$ fertility rates at the several ages derived from the birth record of 1945 are over-
estimates. This is something which rarely happens due to chance alone. The conclusion, therefore, appears inevitable that at least a few births in 1944 have been reported as in 1945. The year 1943 also seems to have been affected by similar circumstances, though they are somewhat less satisfactorily understandable.

The fertility record separately for each year, therefore, appears to be not trustworthy, and we should be content to deal with it as a whole, that is, births recorded during the whole of the five year period as a whole. Undoubtedly the possibility still remains that some of the births actually occurring before the five-year period under investigation, might have been reported as occurring in the initial years of this period. Such results are nevertheless likely to be less serious, for, in the first instance; apparently it is the more recent years that seem to be more powerfully affected by effects such as foreshortening in reporting, and secondly, any such small effects as affect the earlier years are likely to be more or less offset by a possible omission of a few births in those years, due to the unfortunate circumstance that their issues were not living at the time of reporting. Moreover, when we consider the five year period as a whole, any such residual effects are averaged over five years, and hence affect the final fertility rates to a much less extent.

With a view to deriving the fertility rates from the record of the five-year period as a whole, we give below by quinquennial age groups, the number of women; total births occurring to them during the five years, and births to them per 1,000 married women per annum.

The only point that need be settled now is to which age year shall we attribute the specific fertility rate derived from the performance of the women, say. in age group 16-20. The ages were reported in 1945, so that the mid-age of this
-group of women in 1945 is 18. The mid-year of the five-year period under investigation, on the other hand, is 1943, in which year the mid-age of the group would be 16. This, therefore, is the age to which the specific fertility rate should be attributed. Hence the fertility rates given above are attributable to ages $16,21,26,31,36,41$ and 46 respectively. From these are obtained the specific fertility rates for single age years by simple graduation. These are given in Table 18.

Note 2: Use of Chi-square to Test the Significance of Factors Other Than the Age of Mother.

After the effect of the primary factor, namely, the age of the mother on fertility, has been assessed, the appropriate method to evaluate the effect of other factors such as the age of the father, etc., would be to introduce the two factors simultaneously into the analysis of variance and test whether the introduction of the additional factor materially increases the portion of the variation explained. Due to the fact that factors not under experimental control are seldom orthogonal such analysis for each factor usually becomes too laborious. A shorter method has, therefore, been proposed. We shall discuss this method with reference to one of the factors discussed, namely, the age of the husband.

We first group the women according to the ages of their husbands. If the age of the husband is unimportant as a factor influencing the fertility of a woman these groups of women should on an average have the same number of births, except for the fact that the age composition of the several groups is different. In order to allow for this difference in age composition, the women in each group are distributed according to their own age, and from the age specific fertility rates already derived is found the number of births that might be expected of them. The difference between this expected number and the actual number of births to these women is ascribable, apart from chance effects, to the factor under consideration, namely, the age of the husband.

For a test of significance, the Chi-square test is available and tests whether or not the differences between the expected number of births and the actual births are wholly explainable as merely chance effects. The applicability of this test in this connection may be seen when it is noted that
here, in effect, we distribute the total number of births, according to the age of fathers, and then compare this distribution with another distribution, expected on the null hypothesis that the age of the husband is unimportant as a factor influencing the fertility of the wife.

Note 3: Derivation of the age specific fertility rates made further specific for the difference between the ages of husband and wife.

Having found that the age of the husband or the difference between the ages of the wife and the hisband is an important factor influencing fertility, it becomes essential to make the usual age specific fertility rates further specific for this factor. This amounts to deriving the fertility rates specific for a particular combination of ages of the wife and husband. For this purpose it is necessary to distribute the women in a two-way table as is done in Table 22 or Table 23, and derive the fertility rates from the performance of the women falling in each sub-class of this table.

The number of women falling in each of the several sub-classes of the table is rather small, and in many cases too small, so that the fertility rates derived from them would be very much liable to error. We therefore presume a simpler situation, namely, that the effects of the two factors are additive, that is to say we presume, for instance, that the difference that it makes to the fertility of a woman according as the husband is of age 25 or 35 is the same whether the woman is aged 20 or 40 . Such hypothesis is apparently far from the truth in the case of the above factors, but should be nearer to it if imposed on the two factors, age of woman and difference between her age and that of her husband. We therefore work out the fertility rates, specific for the age of women and the difference between their and their husband's ages on the hypothesis that the effect on the fertility of a woman of the difference between her age and her husband's age is uniform whatever her age. In other words, it means that there is a certain effect on fertility of the age of the woman and a certain other effect of the difference between her age and her husband's and that these two effects simply add to produce the joint effect. Such a hypothesis is, therefore, usually referred to as the additive hypothesis.

On this hypothesis it is only necessary to obtain estimates of the effects of the two factors, and add them together to obtain the requisite specific rates. The estimates of these effects are available from the performance of the total women in the marginal classes of the two-way table and are, therefore, less liable to error, as the numbers in marginal classes are larger.

In deriving estimates of the effects of the two factors, note also has to be taken of the fact that the two factors are not necessarily orthogonal or independent, so that a part of their effects is confounded in the sense that it is ascribable to either of the two. It is necessary to apportion properly such confounded portion between the two. lest it may be doubly added when the two factor effects are added to obtain the joint effect. This has been done and the factor effects so derived are a little graduated in order to remove obvious chance effects.
