

READ—

The reports from the Commissioner in Sind and the Commissioners of Divisions on the working of the Municipalities in the Bombay Presidency during the year 1913-14.

RESOLUTION.—The number of Municipalities remained unchanged during the year, but the number of Notified Areas was raised from 21 to 25 by the constitution as ~~Notified Areas~~ Areas of Chikodi in the Belgaum District, Hungund and Muddebihál in the Bijápur District, and Karjat in the Kolába District. The Erandol Municipality in the East Khándesh District still continues to be superseded. The period of supersession of the Ahmedabad Municipality was extended for a further period of one year up to the 31st March, 1915. The Municipality has since been reconstituted with effect from the 1st April, 1915.

2. There was an increase of about 6,000 in the total recorded population resident in municipal districts. This increase occurred in the Central and Southern Divisions. In the former Division it was due to the extension of the boundaries of the Málegaon and Dharangaon Municipalities. In the same Division the limits of the Sholápur and Indápur Municipalities underwent extensions of a minor character. The increase in the case of the Southern Division occurred in the Belgaum municipal area, and was due to a revision of the census figures. Elsewhere the municipal boundaries and figures of population remained unchanged.

3. Triennial elections in the case of the Northern Division were held in the Municipalities of Parantij, Sánand, Dhandhuka, Ránder and Bándra, the new boards coming into office on the 1st April, 1914. The Ránder election aroused keen competition and led to litigation. In Bassein also a fair amount of interest was evinced at the general election. The franchise which had been withdrawn from this Municipality in 1899 was restored to it with effect from the 1st October, 1913. In the Central Division elections were held at Jalgaon, Savda, Párola, Yával, Amalner and Chopda in East Khándesh, at Dhulia in West Khándesh, at Wái and Sátára in the Sátára District, and at Bársi and Sholápur in the Sholápur District. In East Khándesh there was, generally speaking, very little competition among candidates and no appreciable interest in the elections was evinced by the voters, a state of affairs which was no doubt due to the general backwardness of the district and a want of appreciation of the benefits of local self-government. On the other hand, the elections in several wards in Dhulia were keenly contested and about 56 per cent. of the voters attended the poll. (In the Southern Division the triennial term of the municipal boards of Ilkal, Guledgud and Bágalkot in the Bijápur District expired during the year and fresh elections were held in the case of the first two Municipalities. Owing to the evacuation of the town on account of plague the Bágalkot Municipality was unable to hold its elections by the prescribed date;

when they were held they were uncontested. In Sind the term of office of 22 Municipalities including Karáchi expired during the year. The majority of the new boards were constituted with effect from the 1st April, 1914, but the Karáchi board was formed on the 1st October, 1913. In the case of the latter Municipality the elections were keenly contested. In the course of the year it was decided that the system of voting at municipal elections by secret ballot should be universally adopted, and the Municipalities have since been engaged in revising their election rules in order to give effect to this decision.

No change occurred in the constitution of the municipal boards of the Northern Division except in the case of the Kapadvanj Constitution of Municipalities. board, the reduction of one official councillor of which was counterbalanced by the addition of one to the number of nominated councillors. In the Central Division the number of nominated members of the Yeola Municipality was increased by one. In the Southern Division the reconstituted municipal council of Bijápur came into being on the 1st April, 1913, with an increase of six in the number of its elected members. In Sind, the constitution of the Karáchi Municipality was revised, the number of councillors being raised from 36 to 42, two-thirds elected and one-third nominated. Of the elected councillors 24 were returned by the rate payers, two by the Chamber of Commerce and two by the local Merchants' Association. The constitution of the Tando Adam board was also altered, two non-official councillors being added. In the Northern Division the total number of municipal councillors remained unchanged at 489. In the Central Division, the number was 812, in the Southern Division 501, and in Sind 364, as against 811, 495 and 356, respectively, in the previous year.

There was an almost general improvement in the attendance of councillors, both official and non-official, at municipal meetings Attendance at municipal meetings. in the Northern Division, but instances of failure on the part of individual councillors to attend two-thirds of the total number of meetings held still occurred in the majority of the Municipalities. As regards the non-attendance of councillors, the Surat Municipality continues to be a conspicuous defaulter, as many as 30 adjournments for want of a quorum having occurred during the year, a state of affairs which does not betoken a healthy administration. In the Central Division the total number of meetings held was 752, but no less than 134 or 17·8 per cent. of them proved abortive for want of a quorum. The Amalner Municipality distinguished itself in this respect, 17 out of its 32 meetings being adjourned for this reason, but Pandharpur ran this record very close. In the case of the Municipalities of the Southern Division the total attendance of councillors at meetings showed an increase from 62 per cent. to 65 per cent., while the number of meetings which were postponed for want of a quorum fell from 134 to 94.

4. Apart from the introduction, referred to elsewhere, of terminal taxation into several Municipalities, there is no Changes in the system of change of special importance to record in the matter of taxation. the system of taxation. Mention may, however, be made of the imposition of a dog tax in Poona and of a tax on hawkers and visitors' servants in the Malcolmpeth Municipality. The Ahmedabad Committee of Management revised their rules for the levy of water rates, sanitary cess, and conveyance and toll taxes. After prolonged negotiations the Belgaum Municipality and Cantonment have entered into an agreement for the levy of joint octroi. Octroi taxation has been introduced in the Nárgund Municipality of the Dhárwár District, and the Ahmednager Municipality has adopted a non-privy cess and general water-rate. The Hyderabad Municipality is still reluctant to introduce a house tax, though the state of its finances may eventually render such a measure imperative.

5. A noteworthy increase was recorded in the aggregate gross income of the Municipal income. Municipalities, the amount for the year under review being Rs. $125\frac{3}{4}$ lakhs as against $109\frac{3}{4}$ lakhs for the preceding year. Deducting the receipts under "Extraordinary and Debt", the net revenue amounted to Rs. 100 lakhs as against a previous total of 88 lakhs.

6. The increase of Rs. 1,86,000 under this head is shared by the whole Presidency, the Northern, Central and Southern Divisions and Sind contributing Rs. 83,000, Rs. 12,000, Rs. 49,000 and Rs. 42,000, respectively. In the Northern Division the increase was common to all octroi-levying Municipalities except Kalyán and Gogha and is attributed to the trade activity incidental to a year which was regarded as an auspicious one for marriages. It was most marked in Broach, where it amounted to Rs. 33,000. Surat and Ahmedabad come next with increases of Rs. 19,000 and 15,000, respectively. In the Central Division there were larger receipts in all districts except East Khándesh and Poona. The increases of Rs. 11,600 in the Sholápur District and of Rs. 4,500 in the Ahmednagar District are attributed to larger imports of articles of food and fuel. The absence of plague from Násik accounts for the increase of Rs. 5,000 there. On the other hand, a decrease of Rs. 12,700, for which no particular cause is assigned, occurred in the Municipalities of the Poona District. (In the Southern Division the main portion of the increase of Rs. 32,000 occurred in the Municipalities of the Dhárwár District and is attributable partly to the introduction of octroi in Nargund and partly to larger imports coupled with closer supervision in the other Municipalities of the district. In this connexion it is noteworthy that the figures for the Dhárwár Municipality for the last five years show a steady increase in its octroi revenue, which has risen in that period from Rs. 14,500 to Rs. 37,000.) In Sind, the increase was most marked in Karáchi where, despite the falling off of exports and the consequent diminution by over three-quarters of a lákh of the realizations from the one-tenth drawback, a general expansion of trade caused a net increase of Rs. 31,000. The effect on local prosperity of the improved working of the principal canals was visible in the substantial increase of octroi receipts on grain in Shikárpur, Garhi Yásin and Jacobabad.

7. The receipts under this head rose by Rs. 41,000, of which Rs. 26,000 and Rs. 17,000 were contributed by Sind and the Northern Division, respectively, these increases being to a very slight extent counterbalanced by a falling off of Rs. 2,000 in the Central Division. The increased income in Sind includes arrears of house tax amounting to over Rs. 13,000 recovered from the North-Western Railway in Sukkur and Kotri. In the case of Karáchi the credit for much of the increase is due to the municipal officers, who exerted themselves to secure the more careful preparation of the assessment lists. In the Northern Division there were increased receipts at Ahmedabad, Kapadvanj, Nadiád and Broach. With regard to Kurla the Collector of Thána reports that the house tax assessment list for the year of report was not ready until the close of the year, the outstanding amounts amounting to the large sum of Rs. 8,000, which represents more than double the year's total demand. The Collector should be requested, if he has not already done so, to call upon the Municipality to take immediate steps for the

recovery of these excessive outstandings. In the Central Division the decreases of Rs. 8,000 in the Sátára District, due to the absence of arrears for recovery, and of Rs. 3,000 in the Sholápur District were counterbalanced by slight increases in other districts. The reports received point to the existence in the case of several Municipalities of a system of house tax assessment under which the percentage on the rental value diminishes as the latter increases. Such a system is open to the obvious objection that it favours the more wealthy house-owner at the expense of the poorer, while at the same time it deprives the Municipality of legitimate revenue. District officers should examine the house tax schedules of the Municipalities in their jurisdiction with a view to the revision of any which are characterized by this defect.

8. Under the head of water rates there was an increase of Rs. 1,10,000 to which the Northern Division contributed Rs. 62,000, Water rates. the Central Division Rs. 19,000, the Southern Division

Rs. 16,000, and Sind Rs. 13,000. In the first named division the increase was general except for Bángra, the reasons assigned being better recoveries and the establishment of new connexions. A moiety of the increase of Rs. 27,000 in the case of Ahmedabad represents an adjustment entry on account of road watering charges which did not appear in the preceding year's accounts. In the Central Division substantial causes of increase were the prompt recoveries made by the Sholápur Municipality and the revision of the assessment lists at Pandharpur, while a minor cause was the new introduction of a general water rate in the Ahmednagar municipal area. In the Southern Division there was an increase in the case of the Dhárwár Municipality of Rs. 12,000 due to the completion of pipe connections in all parts of the town.

9. On the whole there has been some improvement in the collection of municipal dues, and the aggregate of the arrears for Recovery of municipal dues. recovery has been reduced slightly. The reduction would have been much more marked but for a set-back in the Central Division where the total balance of arrears rose by Rs. 9,000. The total for collection in the Northern Division under the head "taxes on houses and lands" amounted to Rs. 4,38,034, including Rs. 44,291 on account of the previous year's arrears. Of the former sum Rs. 3,96,376 were either recovered or written off during the year. This left arrears amounting to Rs. 41,658, a sum slightly in excess of the corresponding figure for the preceding year. In the Central Division, out of a total demand of Rs. 6,33,072, including previous arrears of Rs. 42,017, a sum of Rs. 50,960 remained to be collected at the close of the year, the proportion of collections to the demand falling from 92 to 91 per cent. Over one-third of the uncollected balance was in respect of house-tax, the arrears of which were particularly heavy in the case of Ahmednagar, Bhusával, Islámpur and Ashta. In Ahmednagar and Sholápur there were large outstandings on account of water rate. The former Municipality should pay particular attention to the recovery of its dues. In the Southern Division the figures of demand for the year 1913-14 and of the previous year's outstandings under the head of house tax were Rs. 1,35,350 and Rs. 29,400, respectively, while the total of the unrealized balances at the close of the year was Rs. 23,200, a distinct improvement on the preceding year's results. It is satisfactory to note that the arrears of the Municipalities of the Dhárwár District have been reduced from Rs. 18,200 to Rs. 9,600. In the case of the Gadag Municipality in particular the state of the collections, which was unfavourably reported upon last year, now shows an improvement, the proportion of arrears having fallen from 25 to 10 per cent. of the demand. But in Dhárwár itself and in Hubli there are still unduly large sums outstanding. In the Municipalities of the Ratnágiri and Kánara Districts also the proportion of arrears is excessive, the Honávar Municipality of the Kánara District, for instance, showing a percentage of as much as 62. Obviously the collection work of these Municipalities leaves much to be desired and the Commissioner, Southern Division, reports that the attention of the bodies concerned is being drawn to the urgent necessity of more vigorous action in this respect. In Sind the figures of demand for the year 1913-14 and of the previous year's outstandings were Rs. 1,36,824 and Rs. 9,516, respectively, the total of the unrealized balances at the close of the year being only Rs. 5,464, of which a certain proportion moreover represented arrears of house tax in respect of Railway buildings

the claim to which is still under consideration. The collection work in Sind compares favourably with that in the rest of the Presidency.

It is to be noted that in the case of the Central Division only does the information regarding the recovery of municipal dues extend to dues other than those on account of house tax. In future the information given under this head should not be confined to house tax collections only, for the prompt recovery of dues under all the principal heads of direct taxation which is levied periodically is a matter of importance.

10. There were increases of Rs. 46,000 and Rs. 23,000 under this head in the Central and Southern Divisions, respectively, Revenue derived from municipal property, etc. these being counterbalanced by decreases of Rs. 1,000 and 9,000 in the Northern Division and Sind.

11. The receipts under this head are chiefly made up of the grants given by Government to Municipalities for the improvement Grants and contributions for general and special purposes. of water-supply and drainage, for the opening up of congested localities and for educational purposes. During the year under review there were increases of Rs. 3,46,000, Rs. 3,69,000 and Rs. 1,78,000 in the Northern, Central and Southern Divisions, partly counterbalanced by a decrease of Rs. 1,91,000 in Sind. In the Northern Division, Ahmedabad was given a grant of Rs. 3,74,000 towards the extension of its water service in certain quarters of the city and in the suburbs. Bángra received a grant of Rs. 15,000 towards a hospital and Kalyán one of Rs. 12,500 for drainage works. The Sanitary Board allotted Rs. 4,468 and Rs. 6,007 to Godhra and Broach, respectively, for a meat market at the former place and for the Ganthi Bazaar scheme and a new burial ground for Mahomedans at the latter. In the Central Division, Ahmednagar, Sholápur and Jalgaon received grants of Rs. 3,75,000, Rs. 90,000 and Rs. 14,535, respectively, for their water-works. Sholápur was also the recipient of a grant of Rs. 15,000 for the laying out of building sites. Pandharpur and Sávda obtained grants of Rs. 14,725 and Rs. 20,000, respectively, for town improvements, and Bhusáwal Rs. 15,000 for the opening up of a congested quarter. Minor grants aggregating Rs. 4,280 were made to the Municipalities of Jejuri, Talegaon-Dabhade and Lonávla for various sanitary improvements. In the Southern Division, the Bijápur Municipality received Rs. 1,92,000 for its water-works, and the Municipalities of Belgaum, Hubli, Gadag-Bettigeri and Dhárwár were allotted Rs. 35,000, Rs. 34,500, Rs. 20,000 and Rs. 26,300, respectively, for town improvement schemes. A sum of Rs. 1,700 was granted to Byadgi for widening streets and providing masonry gutters. In Sind, the Hyderabad and Shikárpur Municipalities received grants of Rs. 20,000 and Rs. 3,500, respectively, for filling in old tanks; Lárkána was allotted Rs. 2,500 for constructing drains; Rátodero received Rs. 3,000 for paving streets, and Jacobabad Rs. 7,500 for improving its water-supply. But the previous year's grant of two lákhs to the Karáchi Municipality for the extension of its drainage system was not repeated, and this accounts for the net decrease of Rs. 1,91,000 in the total of the grants allotted to Sind Municipalities.

Grants from Government for educational purposes amounted to Rs. 5,67,000 during the year under review as against Rs. 5,63,000 in the previous year. In the Northern Division allotments from the educational building grant were made to the Municipalities of Bulsár, Kalyán, Bassein and Bhiwndi. The Kaira Municipality received a grant of Rs. 4,000 from the Sir David Sassoon Trust Fund towards the building of a hostel, and the Dákor Municipality a donation of Rs. 1,600 from Bava Ramdas Gokaldas for a girls' school. In the Southern Division a donation of Rs. 10,000 was received by the Mátherán Municipality from Mr. Singhanee for starting an English school. In Sind special grants-in-aid from Government for educational purposes showed a total increase of over Rs. 9,000. The amount includes an additional grant of Rs. 4,500 to the Karáchi Municipality for buildings, small special grants to Kambar, Sehwan and Rátodero, and one of Rs. 1,157 to Rohri in aid of secondary education. A re-assessment of the Government grant-in-aid to the municipal high school, with effect from 1912-13, gave Sukkur an additional Rs. 5,338.

In the Southern Division the contributions received from sources other than Government included one of Rs. 16,000 made by Khán Sáheb B. M. Patel to the Hubli Municipality for a maternity ward, and a sum of Rs. 3,000 collected by the cotton presses and factories at Hubli for medical purposes.

12. Out of the aggregate income of the Municipalities Rs. 59,65,000 were realized from municipal rates and taxes, as compared with Rs. 55,01,000 in the previous year, indirect taxation yielding Rs. 27,64,000 or 46·3 per cent. of the whole and direct taxation Rs. 32,01,000 or 53·7 per cent. The corresponding percentages last year were 46·9 and 53·1, respectively. The average incidence of taxation per head of population rose from Rs. 2·5·5 to Rs. 2·8·3, and that of income from Rs. 3·11·9 to Rs. 4·3·6. Karáchi had the highest incidence of taxation (Rs. 8·3·4) and Yamkaumardi in the Belgaum District the lowest (Rs. 0·3·10).

13. A series of frauds against the Karáchi Municipality in connexion with the payment of refunds of octroi on exports came to light during the year. It was discovered that it was of frequent occurrence for a merchant or firm on selling goods on which octroi had been paid to retain some or all of the octroi payment receipts. The Municipality had very improperly allowed a practice to grow up whereby refunds were paid in the case of grain exports, not on the strength of the octroi receipts, but on the ship-master's receipts showing the amount of grain shipped. In this way the octroi receipts on such shipments remained in circulation and were available for use as vouchers in support of refund claims for which the Municipality were not liable. These receipts acquired a market value and were being more or less openly sold. Eventually a firm was prosecuted criminally for attempting to sell such receipts and was sentenced to pay a fine of Rs. 200, and the fraudulent practices in question were summarily checked. Defalcations in connexion with the octroi revenue were discovered in Hyderabad.

The proportion of gross octroi revenue which is ultimately paid back in the form of refunds is very high in certain Municipalities and would appear to be a proper subject for investigation. In the Northern Division, the refunds paid by Ránder and Kalyán represent 55 and 42 per cent. respectively of their gross receipts. In Sirsi and Vengurla in the Southern Division the percentages are 43 and 46, respectively.

The average consumption per head of population of the principal dutiable articles, such as refined and unrefined sugar, oil and cloth, exhibits a remarkable excess over the prescribed standards, which, in the opinion of the Commissioners, require revision in view of the higher standard of living now generally prevalent. The excess of the *per capita* consumption of dutiable articles over the standards fixed by Government is, apart from special local circumstances, ascribed to causes more or less stereotyped, such, for instance, as the remissness of traders in applying for refunds on the re-exportation of taxed goods, and the consumption of a high proportion of such goods by persons residing in the immediate neighbourhood of the towns in which duty was paid and consequently participating to some extent in the advantages resultant from taxation.

14. The Municipalities of Ahmedabad, Nadiád and Ankleshwar have been selected in the Northern Division for the experimental introduction of a terminal tax on imports. The imposition of the tax for a period of two years with effect from the 1st April, 1915, or such subsequent date as may be practicable has been approved by Government in the case of the first two Municipalities, and the necessary rules and by-laws have been sanctioned. In the case of Ankleshwar the Commissioner, N. D., has approved provisionally the rules and by-laws framed by the Municipality. In the Central Division, the Municipalities which have been selected for the experiment in terminal taxation are Jalgaon, Dhulia and Ahmednagar and, in the first two of these, the system is already in force. Arrangements in respect of Ahmednagar are still under consideration. The

introduction of the system into the Lonávla Municipality, which had not hitherto levied octroi at all, has also recently been sanctioned by Government for a period of two years. (In the Southern Division, Hubli is the only Municipality which has expressed its willingness to introduce the system, but the arrangements for working it are still under consideration) In Sind, the Commissioner has issued instructions for the introduction of the system in the Municipalities of Sukkur, Lárkána and Umáarkot. The proposals made by the Karáchi Municipality for the adoption of terminal taxation have been approved by Government and rules and by-laws are being framed. Negotiations are also being carried on with the railway authorities with a view to collection of the duty on rail-borne goods by the railway staff.

15. The total expenditure of the Municipalities during the year under review was Rs. 1,19,33,000, a decrease of about Rs. 11,000 on the previous year's figures. Excluding the item of "Extraordinary and Debt", the expenditure amounted to Rs. 92½ lákhs against Rs. 98½ lákhs. The decrease in ordinary expenditure was therefore six lákhs.

16. The increase of Rs. 30,000 under this head was shared by the Northern Division (Rs. 1,500), Southern Division (Rs. 14,000) and Sind (Rs. 22,500), but was counterbalanced by a decrease of Rs. 8,000 in the Central Division spread over all the districts except Sholápur and Násik. Poona showed a large decrease of Rs. 13,600 mainly owing to the absence of certain extraordinary charges incurred in the previous year. On the other hand, an increase of Rs. 9,400 was caused in the Sholápur District by the revision of the pay of the establishments of the Sholápur and Pandharpur Municipalities. In the Southern Division part of the increase of Rs. 14,000 was due to revisions of establishment and to the enhancement of the pay of the Chief Officers of the Gadag-Bettigeri and Bijápur Municipalities. In Sind practically the whole of the increase in the cost of general administration and of collection occurred in the case of the Karáchi Municipality, which appointed an Assistant Chief Officer on a salary of Rs. 500—50—750 and additional establishment for two new octroi stations.

17. The expenditure under this head showed a large decrease of Rs. 6½ lákhs during the year under review, but in recording Public health and convenience. this fact it should be noted that the previous year's figures were exceptional, representing an increase of more than Rs. 8 lákhs over the expenditure of the year before.

18. The total expenditure in the Northern Division on water-supply fell off in respect of both capital outlay and establishment, Water-supply. repairs, etc., from Rs. 4,62,000 to Rs. 3,02,000. Among the chief causes were the stoppage of work on a large scale pending sanction to the comprehensive water works project of the Ahmedabad Municipality; the non-recurrence in the case of the same Municipality of the preceding year's extraordinary expenditure on new machinery, buildings and dams; a reduced expenditure on new pipes and hydrants in Surat; and the completion in

the previous year of the major portion of the work-shop at the water works at Ahmedabad. The water-supply in Ahmedabad is frequently inadequate during the hot weather, and various schemes for its improvement are under consideration. The difficulty arises from the fact that the river current continues to recede further and further from the supply wells in the river bed in which the water is collected. The Surat water-supply is also unsatisfactory, and the question of its improvement is now engaging the attention of the Mechanical Engineer to Government. The scheme for the supply of water to the Kalyán Municipality by the G. I. P. Railway Company has not been approved by Government, and the Commissioner has been requested to have an independent scheme for the town of Kalyán investigated and prepared by the Sanitary Engineer to Government. The improvement to the water-supply of Bhiwandi, for which the Sanitary Board have given a grant of Rs. 10,000, awaits the preparation of plans and estimates by the Sanitary Engineer to Government. In the Central Division, the Sholápur Municipality paid Rs. 2,14,000 to the Public Works Department for the improvement of its water works and the Dhulia Municipality Rs. 6,200 for the enlargement of the catchment area of the Dedargaon tank. The Municipalities of Ahmednagar and Lonávla incurred expenditure of Rs. 1,40,000 and Rs. 85,000 respectively on their water-supply schemes. There was an increase of Rs. 20,000 in the expenditure of the Pandharpur Municipality due to the payment of arrears of water charges according to the rate prescribed by Government. At Násik, on the other hand, the expenditure fell by Rs. 1,52,000 in consequence of the completion of the municipal water-supply installation. In the Southern Division, the amount spent on the Bijápur water works was Rs. 1,57,000 against Rs. 1,77,000 in the preceding year. These works were completed during the year. In Sind the capital outlay of the preceding year had been largely swollen by the cost of the Sydenham Reservoir constructed by the Karáchi Municipality and by heavy expenditure on the Hyderabad installation, items which have not recurred in the year under report. Out of the recorded increase of Rs. 37,000, Rs. 25,000 represent a payment by the Karáchi Municipality to its renewal fund, which cannot properly be described as expenditure. The increased expenditure by the Hyderabad Municipality which amounted to Rs. 7,000 was due to more extensive purchases of fuel, the clearance of the Gidu Settling Tank and the execution of repairs to buildings, etc. The Jacobabad Municipality spent Rs. 2,250 on the construction of a new well and the purchase of certain tube wells.

19. In the Northern Division the income of the Ahmedabad Municipality

Financial working of water installations. from water rates rose from Rs. 1,65,360 to Rs. 1,92,439, being made up of direct receipts to the amount of Rs. 1,33,571 and indirect receipts Rs. 58,868. On the expenditure side the amount rose from Rs. 1,45,060 to Rs. 1,57,092, the latter figure including Rs. 76,848 on account of interest and sinking fund and Rs. 8,000 towards the depreciation fund. There was thus a net profit of Rs. 35,347 as against Rs. 20,300 in the previous year. ²Surat made an income of Rs. 1,08,940 by the direct sale of water and Rs. 966 by indirect taxation. Working expenses amounted to Rs. 74,059, leaving a margin of profit of Rs. 35,847. ³Rander, which gets its water on payment from the Surat water works, cleared off its debt of Rs. 13,193 to the latter Municipality on this account. ⁴The Thána Municipality's total receipts from the direct sale of water and from taxation amounted to Rs. 6,158 and 1,931 respectively. After defraying an expenditure of Rs. 1,394 on working charges the Municipality earned a profit of Rs. 6,695. ⁵Bhiwandi's total income from water-supply amounted to Rs. 2,314, all of which came by direct taxation. The cost of upkeep was Rs. 563, which left a profit of Rs. 1,751.

In the Central Division the Ahmednagar Municipality incurred a capital outlay of Rs. 1,32,856 on the Pimpalgaon tank works. The direct receipts on account of water-supply amounted to Rs. 8,132 and the indirect receipts to Rs. 17,836. The expenditure, including the payment of a loan instalment, amounted to Rs. 35,124, the installation thus working at a loss of nearly Rs. 10,000. The Jalgaon Municipality had incurred up to the close of the year a capital expenditure of Rs. 3,25,790 on the Mehrun tank from which it

obtains its water-supply. The income from direct water charges was Rs. 11,521, and from indirect taxation Rs. 4,652, while the total expenditure during the year amounted to Rs. 17,213, the net result being a small loss. Dhulia derived a total income of Rs. 62,166 from its installation and spent Rs. 85,854, of which Rs. 39,116 were for the repayment of debt and Rs. 43,099 for capital outlay on raising the waste weir of the Dedargaon Tank.

With regard to the Southern Division, it was pointed out in last year's report that the income derived from the water works at Dhírwár amounted to only Rs. 11,500, while the expenditure in connection with the works was Rs. 35,000. This wide divergence between the figures of revenue and expenditure was mainly due to the fact that the town was not then connected with pipes. The position has considerably improved during the year, the total income derived from the water works having risen to Rs. 23,100, while the expenditure fell to Rs. 28,200. There is still, however, a loss of Rs. 5,100, but the Municipality point out that their octroi taxation has been specifically raised in order to meet this anticipated loss. At Hubli the accounts show that there was a loss of Rs. 10,900, but the President states that this does not represent an actual deficit, as the total expenditure includes a sum of Rs. 10,000 laid aside as a sinking fund deposit. The Municipality has drawn only Rs. 1,65,000 out of the loan of Rs. $3\frac{1}{2}$ lâkhs sanctioned and the works are not yet complete. The indirect income of the works at Bijâpur was Rs. 8,000, and the expenditure, including the instalment in repayment of the loan, amounted to Rs. 15,735. No revenue was derived during the year from direct taxation as the water cess and rate have been imposed from the year 1914-15 only. A scheme for the improvement of the water works of Alibág costing Rs. 26,500 has been sanctioned and the work is now in hand.

The attention of the Commissioner in Sind should again be invited to paragraph 5 of Government Resolution No. 4202, dated the 2nd July, 1912, and he should be requested to include in his next municipal administration report information regarding the financial working of the water installations in the province.

20. Ahmedabad, the only Municipality in the Northern Division possessing a drainage system, spent on capital outlay only Rs. 5,273 as against Rs. 31,780 in the previous year, the balance of the loan fund having been exhausted. On the other hand there was an increased expenditure of about Rs. 15,000 under the head "Establishments, repairs, etc." due to the payment of fuel bills outstanding from the previous year. Surat spent over Rs. 9,000 on constructing road-side gutters. The decrease of Rs. 50,000 in the case of the Central Division is due to reduced expenditure on the drainage works of Poona City. In the Southern Division the capital outlay expended was Rs. 19,600 against Rs. 37,600 during the preceding year. The expenditure incurred relates to the Municipalities of Rânebennûr (Rs. 6,500), Bijâpur (Rs. 6,700) and Gulegdud (Rs. 5,300). In Sind the decrease under 'Drainage, capital outlay' is accounted for by the fact that the Karâchi Municipality spent only Rs. 1,02,000 on the extension of its drainage system as against Rs. 2,40,962 in the previous year, including the Government contribution of Rs. 2,00,000. The high prices of coal and fuel generally in Karâchi raised the working expenses by about Rs. 21,000.

21. The bulk of the net increase of Rs. 17,000 in the Northern Division is made up of an adjustment entry on account of road watering charges in favour of water revenue in Ahmedabad, the purchase of fields at Nadiâd for storing manure, the payment of Rs. 800 to the Nadiâd sweepers by way of compensation for the loss of their rights to the town sweepings, and the employment of a mosquito destroying brigade in Surat. The Surat Municipality purchased land for a night soil dépôt. In the Central Division the head "Conservancy" exhibits a net increase of Rs. 4,500 resulting from the expenditure incurred out of the special grant sanctioned by Government by the Ahmednagar Municipality on acquiring lands to open up congested and unhealthy areas. The employment of additional establishment and the raising of the salaries of the existing staff in the Sholápur, Dhulia and Shirpur Municipalities also contributed to the increase.

In the Southern Division there was an increase of Rs. 7,000, which was partly due to the purchase of carts and animals and the construction of new latrines by the Gadag-Bettigeri Municipality and partly to a general increase of expenditure under this head by the Gokák, Athni and Nipáni Municipalities. In Sind the Hyderabad Municipality last year acquired land for a sewage farm at a cost of about Rs. 6,500. The non-recurrence of this item this year explains the greater part of the net decrease in expenditure under "Conservancy."

22. In the Northern Division the Act, which hitherto applied to Ahmedabad, Nadiád and Dohad only, was extended to Surat during the year. Except in Nadiád, where one prosecution was sanctioned, no action was taken Working of the Bombay Municipal Servants Act, V of 1890. under the Act. In the Southern Division the Act was made applicable to the Malcolmpeth Municipality during the year and its introduction produced a salutary effect. Neither here, however, nor in Sátára was it found necessary to have actual recourse to its provisions.

23. The total expenditure under this head in the Northern Division fell off by nearly Rs. 20,000, the Municipalities of Dákor, Broach, Surat, Bulsár and Bándra having curtailed their outlay on roads. Last year's subsidy to the Bándra Municipality for road construction and repairs was not repeated this year. In Ahmedabad a new steam roller was purchased, projected street lines in the suburbs were demarcated, and a site for the stacking of metal was acquired. In the Central Division there was an increase of Rs. 16,000 in the Sholápur District due to the new roads laid out by the Sholápur Municipality and of Rs. 8,800 in the Poona District on account of repairs to roads cut up by the drainage works in Poona City. These increases were counterbalanced by reduced expenditure in the East Khándesh and Násik Districts. In the Southern Division the expenditure was Rs. 1,53,000 against Rs. 99,000 in the previous year. The Bijápur Municipality spent Rs. 4,400 on special repairs necessitated by the visits of Their Excellencies the Viceroy and the Governor. It also purchased an eight ton steam roller at a cost of Rs. 6,800. (The whole of the grant of Rs. 56,300 (of which Rs. 30,000 were drawn in the preceding year) sanctioned by Government for the removal of congestion in Dhárwár was expended during the year by the Municipality and has been put down under this head of expenditure. The figures shown against Hubli for 1912-13 included the expenditure on the improvement of the town carried out by means of the Government grant of Rs. 23,185 sanctioned for this purpose. No such expenditure was incurred during the year under report, the Government grant of Rs. 34,500 drawn by them being apparently still unutilized.) In Sind all the larger Municipalities curtailed their expenditure on roads. Thus Karáchi shows a decreased expenditure of Rs. 33,000, of which Rs. 7,000 were incurred on the Machi Miani Improvement Scheme; Hyderabad Rs. 27,000; Sukkur Rs. 5,600; Shikárpur Rs. 11,000 and Jacobabad Rs. 7,000.

24. In the Northern Division, Ankleshwar, Jambusar, Ránder, Bulsár, Kalyán, and Bándra were the principal offenders against the rule that the whole of the proceeds of the wheel tax and of road tolls should be expended on the maintenance of roads. The first four of these Municipalities, not having furnished a satisfactory explanation of their default in this respect, have been called upon by the Commissioner to credit the surplus receipts of the year to a special fund for future expenditure on roads. The non-settlement of the amount of compensation for land acquired for road widening prevented the Godhra Municipality from spending the full amount which it had provided in the budget. In the Southern Division the defaulting Municipalities, a list of which is given in the margin, numbered thirteen. In the case of the Municipalities of the Belgaum and Bijápur Districts no reasons for non-compliance with the rule are forthcoming. The Collector of Dhárwár states that the Gadag and Navalgund Municipalities have promised to spend the balance next year and that, as regards Haveri, the whole amount of the tolls cannot usefully be spent on roads and the imposition of an octroi tax

and the reduction of the toll charges are therefore under consideration. The decrease at Alibág is said to be due to the fact that some of the municipal roads were in charge of the Public Works Department and that at Mahád to the heavy expenditure incurred on education. The President of the Panvel Municipality explains that the unspent balance is intended to be utilized in constructing masonry gutters. The attention of the Municipalities of Chiplun and Vengurla is being drawn to the standing orders on this subject.

25. In the Northern Division the expenditure under this head fell from Expenditure on buildings. Rs. 58,000 to Rs. 20,000 owing to the absence of extraordinary items of expenditure such as occurred in the preceding year. In the Southern Division the expenditure was Rs. 33,000 against Rs. 7,200 in the preceding year. Among the buildings constructed during the year were a dharamshala and cattle shed costing Rs. 17,000 by the Saundatti Yellamma Municipality, and buildings for peons, etc., at a cost of Rs. 9,000 by the Matherán Municipality. In Sind the Karáchi Municipality spent Rs. 45,000 on its new office buildings which are estimated to cost Rs. 7 lákhs in all. The net decrease of Rs. 36,500 is explained by the non-recurrence of certain extraordinary items of expenditure by the Karáchi and Hyderabad Municipalities, which figured in the previous year's programme.

26. The cost of public instruction amounted to Rs. 14,89,000 as against Public Instruction. Rs. 14,99,000 in the preceding year. There were decreases under this head of Rs. 44,000 and Rs. 7,000 in Sind and the Northern Division respectively, which were partly counterbalanced by increases of Rs. 33,000 and Rs. 8,000 in the Central and Southern Divisions. In the Northern Division the decrease was due principally to the non-recurrence of the previous year's exceptional expenditure on school-buildings. In the Central Division all districts except Násik, West Khándesh, and Sátara contributed to the increase of Rs. 33,000, which was due to the payment of Rs. 40,000 to the Public Works Department made by the Sholápur Municipality for remodelling one of their school-buildings. In East Khándesh there was an increase of expenditure owing to the Municipalities having made special provision for secondary education although their obligations in respect of primary education and sanitation were far from being completely fulfilled. In the case of the Southern Division, allowing for the exclusion of certain items of a non-recurring nature which occurred in the previous year, there was a general increase in the educational expenditure in the great majority of the Municipalities. In Sind the Karáchi and Hyderabad Municipalities spent less than in the preceding year on building schools. Kambar, on the other hand, spent an extra Rs. 3,350 on additions and alterations to school-buildings. The Lárkána Municipality improved the pay of its school masters to the extent of about Rs. 1,800 per annum. The Shikárpur Municipality made a grant of Rs. 5,000 to the new school-house which is being built for the Hopeful Academy.

27. In this category the following items of expenditure recorded in the divisional reports may be cited as being of interest. Minor heads of expenditure. In Ahmedabad the introduction of compulsory vaccination caused an increase of expenditure of about Rs. 1,800. The Nadiad Municipality spent Rs. 7,000 in providing convenient places for agriculturists to store their manure on. A grant of Rs. 3,000 was made by the Poona City Municipality for the construction of an isolation ward in connexion with the Veterinary Hospital. The Násik Municipality incurred expenditure on the provision of fly-proof safes in the meat market. Bijápur spent Rs. 9,800 on the purchase of corrugated iron sheets for supply to the poor on nominal rents, while Bágalkot bought mats and bamboos for Rs. 1,300 for the same purpose. In Sind the Karáchi Municipality incurred large expenditure on the improvement of its markets and slaughter houses and the provision of fly-proof carts for the conveyance of meat. In Sukkur Rs. 1,200 were spent on the purchase of iron pillars and chains forming a fence for a new public park. A new market was provided at Tando Allahyar. Increased expenditure to the total of Rs. 9,000 was incurred on medical institutions in Karáchi, Tatta and Sukkur.

28. There were increases in the charges under this head of Rs. 4,14,000, Rs. 1,84,000 and Rs. 1,70,000 in the Northern and Extraordinary and Debt. Central Divisions and in Sind, respectively, counterbalanced by a decrease of Rs. 1,97,000 in the Southern Division. In the Northern Division "Investments" rose from Rs. 4,27,394 to Rs. 8,89,347. Besides smaller investments by other Municipalities, Ahmedabad invested Rs. 8,24,200, Dakor Rs. 15,000, Rander Rs. 12,500 and Kurla Rs. 21,878. In the Central Division the loan of Rs. 91,000 advanced by Government to the Karad Municipality in addition to the Rs. 90,000 given as a grant-in-aid was deposited by that body in the Bank of Bombay as the money was not needed for immediate use; and the Pandharpur Municipality invested Rs. 15,000 in the same bank. In the Southern Division the Byadgi and Matheran Municipalities invested Rs. 5,000 and Rs. 10,500, respectively, in Government securities. The Hubli Municipality, after paying the necessary interest on its loan, paid Rs. 10,000 to a sinking fund. In Sind the large increase of three lakhs under "Extraordinary and Debt" is accounted for by the transfer to this head of special funds belonging to the Karachi Municipality which had hitherto been shown in the fund accounts only.

29. The result of the year's operations was an increase of Rs. 6,79,000 in the total closing balance, which was contributed Closing balances. to by the Northern Division (Rs. 1,64,000), the Central Division (Rs. 2,67,000), the Southern Division (Rs. 1,17,000), and Sind (Rs. 1,31,000). The aggregate closing balance of the Municipalities of the Presidency was Rs. 54,50,000.

30. The only Municipality of the Northern Division which is in debt to Liabilities of Municipalities. Government is Bandra. Of its total debt of Rs. 46,410 outstanding at the beginning of the year, the Municipality paid off Rs. 4,703, leaving a balance of Rs. 41,707.

In the Central Division the total liabilities at the end of the year amounted to Rs. 16,15,013, the amount of the instalments repaid being Rs. 89,805 inclusive of interest. The Municipalities of Igatpuri and Talegaon-Dabhade paid off the last instalments of their debt.

Loans from Government were taken up during the year by the marginally noted Municipalities for the purposes specified against them.

In the Southern Division ten Municipalities were in debt to Government. Their liabilities after deducting Rs. 26,773 paid during the year, now amount to Rs. 3,85,458.

None of the Sind Municipalities are in debt to Government.

31. The Accountant General's Local Audit Department audited the accounts of all the Municipalities with the exception Audit of accounts. of Borsad in the Northern Division, Bhingar, Vambori, Lonavla and Sangola in the Central Division, and Chiplun in the Southern Division. Serious irregularities were disclosed only in the case of the Municipalities of Ahmedabad, Panvel and Nipani. In the first-mentioned place a misappropriation of Rs. 894 from the departmental balances of rent and undisbursed pay was detected, and two municipal clerks were put on their trial with the result that one was sentenced to a term of three months' imprisonment while the other was acquitted. The full amount of the defalcation was recovered from the head of the branch for his culpably negligent supervision. In Panvel a large number of empty kerosine oil tins could not be satisfactorily accounted for, and the Collector states that a thorough inquiry is being made. In Nipani the irregularities were more serious, there being a considerable discrepancy between the cash balance and the accounts. The Municipal Secretary has in consequence been dismissed.

The Governor in Council notes with regret the dilatoriness shown by many Municipalities in the matter of remedying the irregularities and defects pointed out by the Local Audit Department. He has had occasion elsewhere to comment on this subject, and he trusts that the admonition and instructions which were then given will have the effect of securing greater punctuality and more serious attention on the part of the Municipalities when dealing with the reports of the auditors.

32. Thanks to the liberal policy of Government in the matter of loans and grants, most of the larger towns of the Presidency are now provided, or on the way to being provided, with a plentiful and fairly wholesome water-supply. But very few of them have yet been able to deal with the question of underground drainage, and this is now in the majority of cases the most pressing need with which they are confronted. Two other important requirements which are forcing themselves upon the attention of the more important Municipalities are the opening out to light and air of congested and insanitary localities, and the provision of hygienic school houses furnished with adequate playgrounds. In connection with the former there arises also the need of providing suitable sites for the accommodation of the displaced population, and this brings to the fore the question of town-planning. With regard to the smaller Municipalities very little progress has yet been made towards supplying the ordinary wants of an urban population, and in the majority of cases it will be found that such elementary requirements as markets, slaughter houses, dispensaries, tolerably good roads, street lighting, sanitary conveniences, surface drains, etc., are only very inadequately provided for.

Turning to the circumstances of individual Municipalities or groups of Municipalities, it is to be observed that good roads and a system of surface drainage constitute the principal requirements of the taluka towns of the Ahmedabad District. Dholera, Viramgaon and Dholka suffer for want of a supply of good potable water, but boring operations in the first two are in progress and promise to be successful, while the Sanitary Engineer has given his opinion that the water of the new bore in Dholka is potable and sufficient. The Ahmedabad Municipality has a settled programme of improvements, and active steps are being taken to supply the most pressing needs, viz., the improvement of the water supply, the widening of narrow roads and the opening out of congested areas. Metalled roads head the list of the wants of the Anand, Mahudha, Kapadvanj and Borsad Municipalities, which cannot with their own unaided resources take up the work. In Dakor and Nadiad streets and over-crowded quarters need to be widened and opened up. The Broach Municipality has appointed a committee to draw up a comprehensive scheme for the widening of streets and the provision of air spaces. Surat stands in urgent need of proper drainage and better drinking water, while another very important want is proper accommodation for its numerous primary schools which are now housed in crowded, noisy and ill-ventilated rented buildings. Rander and Bulsar require good roads and drainage, and flood protective works are wanted in the former.

In the Central Division the new water-supply scheme at Ahmednagar is well advanced and when complete will materially add to the general prosperity of the town. The question of an improved water-supply for Jalgaon is under consideration by the Sanitary Engineer. In Bhusaval the work of opening out of congested areas has advanced considerably and is being pushed forward. Sanitary improvements are being undertaken by the Savda Municipality out of the special grant of Rs. 20,000 made by the Sanitary Board; and in Amalner the construction of a large building costing about Rs. 30,000 for the vernacular school was commenced. An underground drainage scheme for the Dhulia Municipality has been finally drawn up, but its execution, which will cost roughly four lakhs, has had to be postponed during the continuance of the present financial situation. A site for a school playground at Nasik is being acquired out of the grant of Rs. 5,000 sanctioned by Government. In Poona City the execution of the combined water-supply and drainage project is proceeding satisfactorily and the insanitary Ambarkhana site has been turned into a garden. Schemes for the improvement of the water-supply and for the provision of underground sewerage for the town of Satara, estimated to cost

Rs. 2,43,000 and Rs. 3,75,000 respectively, are under the consideration of the Sanitary Engineer. In Sholápur improvements to the water-supply installation are in progress under the supervision of the Public Works Department.

As regards the Southern Division the Commissioner reports that it has been found necessary to draw the attention of the Dhárwár and Hubli Municipalities to the need of drawing up schemes for the provision of new building areas owing to the effect of the extensive town improvement operations recently carried out by these bodies. A comprehensive project of drainage for the city of Bijápur is under consideration, trial surveys for this purpose having been made by the Sanitary Engineer. The scheme for the supply of water to the town of Uran and the neighbouring salt manufacturing villages, estimated to cost about five lákhs, is now ready, but the financial question is still under discussion.

In Karáchi the most pressing needs are a suitable municipal office and council hall, the improvement of the water-supply and the street lighting, the extension of sewers and water mains, the construction of roads in the Machi Miani and Ranchore quarters, and the development of the Lyari quarter. The Municipality also requires to revise its building by-laws and its system of paying for set-backs in connexion with street improvements, while the preparation of a comprehensive town planning scheme should be taken in hand. As regards Hyderabad a water works improvement scheme including the installation of a high level service tank in the Fort Tower, a system of underground drainage, and the reclamation of tanks are among the most pressing wants of the Municipality. In the case of Sukkur the more urgent needs are the extension of the river-side bunder, the establishment of a fire brigade, and the construction of modern hygienic school houses.

33. Last year's budget contained an aggregate provision of Rs. 21 lákhs

Grants for sanitary and town improvement schemes. on account of grants to local bodies in connexion with sanitary projects. This sum consisted of the total amount available from the imperial recurring grant,

an allotment of Rs. 9½ lákhs from a large non-recurring grant received from the Government of India, and a provincial grant of one lakh. The second of these items is available for projects which do not involve heavy recurring expenditure, such as town improvement schemes, surface drainage works, the reclamation of tanks, etc., while the other two are intended to be devoted to important sanitary projects which entail an outlay spread over a number of years and considerable recurring expenditure for maintenance. For several reasons, however, the principal of which was the shortage of projects sufficiently matured for the allocation of funds to them, the actual disbursement of grants fell very far short of this substantial provision. The grants made are enumerated below :—

Besides the above grants, an allotment of Rs. 1 lákh was placed last year at the disposal of the Sanitary Board, who have been authorized by Government to make grants up to a limit of Rs. 10,000 for any approved Sanitary work. The amount was distributed by the Board to the Municipalities indicated below, the objects of the allotments being of various kinds:—

34. *Ahmedabad*.—The report of the Commissioner, N. D., contains the following observations regarding this Municipality:—

"The Ahmedabad Municipality whose affairs have attracted the anxious consideration of the Revenue authorities to a far greater extent than any other in the Division, is about to be restored to power. So well has the Committee of Management done its work that the new corporation will find ready for its use a complete set of revised rules and by-laws, a properly reorganised and adequately paid establishment, and a rehabilitated financial situation. It should be in a position to do effective work towards the improvement of conditions generally, especially if it has the help of a strong Municipal Commissioner.

The Committee of Management has come in for no small amount of vituperation because it has not at once set right all matters which needed attention. When its labours come to an end with the reconstruction of the Municipality, it would, it is now suggested, be no more than is due to it that public intimation should be given of the valuable services it has rendered in clearing the way for an efficient administration by the Municipality whose mismanagement brought about its own temporary extinction."

Since the above was written the Ahmedabad Municipality has been reinstated with a new constitution on a larger elective basis and with a Municipal Commissioner at the head of its executive. The Governor in Council has publicly acknowledged the highly meritorious work of reorganization achieved by the Committee of Management during the five years of supersession.

Broach.—The city was visited by a severe epidemic of cholera, scarcely a matter of surprise having regard to its extremely insanitary condition. The Municipality showed considerable energy in dealing with the situation, though it was with difficulty persuaded to take the very necessary step of temporarily removing the market from its highly insanitary surroundings. It is most desirable that the scheme of building a new market on the reclaimed Fatah Talao should be pushed on. The removal of the night-soil and rubbish dépôt to a less objectionable location is another matter which claims attention. The Municipality has accumulated a considerable balance and should be in a position to incur expenditure on effecting the very urgent sanitary reforms with which it is confronted.

Surat.—The Collector observes with regard to this Municipality that it is capable of doing better work than it has hitherto done and that it has procrastinated badly on more than one occasion when the interests of the town demanded that resolutions on important matters should be speedily arrived at and carried into effect. The most crying need is for a strong executive, as elaborate schemes of sanitary reform are likely to be a failure unless this requisite and a reasonable continuity of administration are secured. The appointment of a Municipal Commissioner for the City has now been made by Government with effect from the 1st June, 1915, and it is hoped this will result in a substantial improvement in the municipal administration and that the several important and urgent reforms and schemes which claim the attention of the Municipality will now be taken up and proceeded with in an expeditious

and businesslike manner. The Governor in Council has been unable to accede to the proposal that the major part of the cost of the sewerage and school housing schemes should be borne by provincial funds, and it will now be the duty of the Municipality to devise means for financing these projects aided by assistance from Government on normal terms.

Poona.—The administration of this Municipality in its various branches has on the whole been well conducted. The Collector reports that many of the councillors take a keen interest in municipal work and are really anxious to run the city well. In spite of certain obstructive elements, the co-operation of the Municipality in any useful scheme of improvement or reform can generally be relied upon. From the Commissioner's observations it appears that the municipal board is fully alive to the possibilities of town improvement. If it is practicable to carry through the admirable schemes now under preparation for a wide east-west thoroughfare and the development of the Bhamburda suburb, Poona City will in years to come acquire a character more in keeping with its status as the seat of Government and the capital of the Deccan.

Ahmednagar.—This Municipality is reported to have continued to do excellent work under its capable and enlightened President, Mr. Chitale. When the new water-supply project is completed, Ahmednagar should have a great future before it. Already important commercially, it should, by means of a good and plentiful water-supply, be assured of industrial development. But the town is extraordinarily congested, and although the Municipality has done what it could with the limited means at its disposal to open it up, the need for comprehensive improvement is urgent.

Násik.—This Municipality also has a creditable record. It is remarkable that it should have been completely successful, notwithstanding the size of the city, in arranging for the disposal of night-soil within the precincts of the city itself without causing the slightest nuisance in the way of smells or flies. Well-planned roads have been driven through some of the densest parts of the city, and these are well swept and well cared for. Credit is due to the board, to its non-official President, Mr. Hardikar, and in particular to the Chief Officer, Mr. Rede.

Sholápur.—The Commissioner remarks that the Sholápur Municipality has been fortunate in having had the benefit of capable Presidents, of a succession of Collectors deeply interested in the development and improvement of the town, of a most efficient Chief Officer, and, above all, of a substantial proportion of enlightened and intelligent citizens who are ready to co-operate in all schemes of public improvement. The result has been that much has been done in the way of opening out the old city, and, what is more important in the case of a rapidly expanding town like Sholápur, in laying out and developing the uninhabited areas over which the town will inevitably extend. The most serious problem in the near future is the increase of the water-supply which is essential to any further considerable extension of the town. Certain internal dissensions on the municipal council have proved to be only temporary, and the board is now reported to be working in peace and harmony and in the best interests of the city. In Ráo Sáheb Pitre the Municipality possesses a very valuable Chief Officer.

Dhulia.—The Municipality is well-to-do and shows exceptional vitality in all directions. The recent elections were keenly contested. The town is in possession of a fine water-supply which will be completely paid for by the end of the current year. The next important improvement in view is a sewerage system costing four lâkhs.

Karáchi.—With effect from the beginning of the new triennial period the constitution of the Karáchi Municipality was revised, the number of councillors being raised from 36 to 42, two-thirds being elected and one-third nominated. The wards have also been altered and rearranged. The question of the appointment of a Municipal Commissioner is under consideration.

Hyderabad.—The Commissioner in Sind reports that of the Sind Municipalities this is the one which gives most cause for anxiety. It has been drawing heavily on its capital, for its last budget has the effect of depleting the balance in hand by nearly two lâkhs of rupees. The tardy discovery of serious defalcations of municipal revenue indicates that the supervision of the subordinate staff has been inefficient, while the management of the water works has recently been the object of severe criticism.

35. With regard to the administration of the Municipalities in general the following extracts from the Commissioners' reports General remarks may be quoted :—

The Commissioner, N. D.—The municipal administration in the Northern Division is in a very fairly healthy condition on the whole, although it must be admitted that there are weak spots here and there. Undoubtedly the condition of things has largely altered during the last few years, so that in place of apathy we have a steadily increasing interest displayed in the conduct of municipal affairs. The withdrawal of direct official guidance, the appointment of non-official presidents and the extension of the electoral rights of the rate-payers have in no case been discredited. Everywhere may be observed a desire for the amelioration of the conditions under which the people live within municipal limits, although there is not everywhere an equally strong impulse to secure it, especially when private interests are affected.

The Commissioner, C. D.—Speaking generally the Municipalities of the Division have done a good year's work, and though complaints of want of interest in elections, irregularity of attendance on the part of councillors, over-caution in finance and a desire to impose the burdens of municipal taxation on non-residents or the poor are not wanting, the tenour of the district reports is on the whole encouraging.

The Commissioner, S. D.—The Municipalities have on the whole worked well and discharged their responsibilities satisfactorily. Lack of interest and apathy are reported in certain places but elsewhere there is an awakening of public spirit combined with an appreciation of their greater independence, and of the financial assistance rendered by Government towards improvements hitherto impossible. I have recently visited the towns of Dhárwár, Hubli, Ránebennur, Gadag and Bijápur in order to examine carefully their schemes of public improvement, and have been very favourably impressed with the keenness of the principal representatives of the Municipalities. Town improvement is a new science in this country, and experience must be bought. It is expedient, therefore, that the full price should not be paid from Government grants. Private benefactions for public purposes are beginning. Municipal meetings are more frequent and more regularly attended. A seat in an important Municipality is the subject of vigorous competition. In brief, it is undeniable that a new standard of civic life is being created and an impulse of local patriotism is being aroused in communities which have hitherto remained strangely inert.

The Commissioner in Sind.—It may be said generally that there has been a distinct growth of the civic spirit of recent years; elections are often keenly contested and the municipal boards have realised that they have been brought into existence for the convenience of the public.

The above expressions of opinion furnish gratifying proofs of the success of the policy, tentatively adopted six years ago, of granting to municipal bodies a larger measure of autonomy and popular representation than they had previously enjoyed, a policy which, in the opinion of the Governor in Council, has been amply vindicated by its results and must now be regarded as having definitely emerged from the probationary stage. The Governor in Council has accordingly now under consideration the question of the removal of certain conditions which appear to have tended to restrict the wider application of this policy.

Apart from these general considerations, His Excellency in Council is able to view with considerable satisfaction the record of the particular year under report. There has been a very noteworthy expansion of municipal revenues, and although, principally owing to the completion in the previous year of certain important projects, the expenditure has declined somewhat, yet there is general evidence of the recognition by municipal bodies of a higher standard of comfort, convenience and sanitation and of a sincere desire to make provision for meeting the obligations which this higher standard imposes. In no direction is this altered outlook more conspicuously manifest than in the alacrity with which the Municipalities are now taking up schemes for the widening of streets, the provision of open spaces and town improvement generally.
