PREFATORY NOTE.

Revenue, 1859-63.

MANY of these papers are of a routine nature largely references from and to the Financial Commissioner and are not of any very great interest.

Taxation is extended during this period, a tax on trades being introduced and also the Income-Tax. The latter appears to have been almost as popular then as it is now and there are many petitions against paying it and complaints against errors in assessment, etc.

In 1861-62 a very severe famine visited the country and Punjab suffered in common with other Provinces, particularly some of the Cis-Sutlej Districts. Very large sums of money were raised by public subscription, supplemented by Government grants, for the relief of the sufferers. In this connection there is an interesting letter from the then Lord Mayor of London, forwarding a cheque for £1,000 and mentioning that the total amount raised in London towards the Famine Fund had reached £1,08,000. The Fund in the Punjab was finally closed in 1863 when a balance of 3½ lakhs was made over to the Government of India.

In 1862-63 the province was visited by swarms of locusts which did much damage, and energetic measures had to be taken for their destruction.

The American Civil War was raging at the time and the consequent stoppage of the American cotton trade caused a big impetus in the cultivation of Indian cotton, Government lending active aid by the importation of seed, cotton presses, etc.

The Kangra Valley tea plantations became of importance during this period and there were also experiments in the cultivation of flax and indigo, the latter not very successful.

A number of the papers deal with the Customs Department which was then under the Punjab Government, the old preventive line in the South of the province being then in active operations. The Assistant Patrols appear to have been a rather rough crowd—about as unruly as the officers of the old Indus Flotilla—and there are frequent cases of dismissals and punishments.

Included in this series is a very interesting report on the Lahore Horticultural Society. This was started in 1851 and at first controlled two gardens—the so called Soldiers garden—near the mausoleum of Data Ganj Bakhsh—and another garden at Badami Bagh. In 1863 these were given up and the society moved to its present site.

It is interesting to note that the resultant reduction in the rent roll of Mozang was only Rs. 83.
