Message from the Director

The Gokhale Institute of Politics and Economics was conceived in 1930 by the Late Rao Bahadur R.R. Kale, M.L.C., as a centre for higher learning and research in economics in remembrance of the great Indian nationalist leader Shri Gopal Krishna Gokhale. The Servants of India Society is managing trust of the Institute. Since those days, it has evolved into a premier institute of advanced study in economics with faculty and alumni who have distinguished themselves nationally and internationally as academicians, policy-makers and consultants.

The Gokhale Institute has been widely recognized for its pioneering contributions in the subjects of Rural Development, Co-operation, Poverty Alleviation, Employment Guarantee, Crop Insurance, Planning, Federal Finance, Input-Output Economics, Agricultural Development, Irrigation and Demography and in several other areas related to the social and economic problems of India.

Our excellence as an Institute of higher learning has been recognized both in India and abroad. The Reserve Bank of India, the Ford Foundation, the Planning Commission and the Kamalnayan Bajaj Foundation have each instituted chairs for distinguished faculty in Finance, International Economics, Planning and

Development, and Industrial Economics respectively at the GIPE.

Although it is primarily a research Institute, it was recognized from its inception as a teaching institute as well, and its students were awarded the M.A. and Ph.D. degrees in economics of the University of Bombay and later the University of Pune. It received further recognition in 1993 when the University Grants Commission declared it to be a Deemed University.

An important aspect of our evolution as an Institute of Economics is the increasingly inter-disciplinary approach we now take to the subject. In accordance with this approach and to enhance our role as a Deemed University, we have launched two new masters programmes in Financial Economics and Agribusiness Economics from July 2011. In addition, the Institute has considerably expanded its Ph.D. programme to 37 registered students. The Institute has also initiated two student and faculty exchange programmes, one with the University of Goettingen and the other being the Ontario-Maharashtra-Goa programme with a consortium of seventeen Canadian Universities.

The Institute has pleasure in presenting the Annual Report of its activities for the year 2011-2012.

About the Institute

The Gokhale Institute of Politics and Economics is one of the oldest research and training institutes in economics in the country. It was founded on the 6th of June 1930 with an endowment offered to the Servants of India Society by the late Rao Bahadur R.R. Kale, Member of the Legislative Council from Satara. The Servants of India Society, founded by the late Shri Gopal Krishna Gokhale, are the Trustees of the Institute. The Institute is registered under the Societies Registration Act, 1860, and the Bombay Public Trusts Act, 1950.

The object of the Institute has been to conduct research into the economic and political problems of India and to train research workers in these subjects. Under the pioneering leadership of the late Professor D.R. Gadgil, its first Director, the Institute set the highest standards for quality research, teaching and training in a number of branches of economics.

Keeping in view the eminence of the faculty, the contribution the Institute has made in teaching, training and research in economics, availability of physical infrastructure and potential of the Institute, the Government of India, on the advice of the University Grants Commission, awarded the Institute the status of a Deemed University on May 9, 1993, the birth anniversary of the late Shri Gopal Krishna Gokhale after whom the Institute is named. The National Assessment and Accreditation Council, after a review to satisfy itself of the merits of the Institute has, with effect from January 08, 2004, given to the Institute grade A+ (score 90-95%) for a period of five years.

Research

The main thrust areas of the Institute, which have developed over the years, through financial assistance from various sources, are agricultural economics and rural development, population studies, input-output studies for planning and development, microeconomics, macroeconomics, monetary economics and finance, public economics and international economics.

Various ministries and public funding agencies, including the Government of Maharashtra and private foundations like Sir Dorabjee Tata Trust, financed the research activities of the Institute in its early years. Subsequently, in 1954, the Union Ministry of Food and Agriculture established, and has supported since then, the Agro-Economic Research Centre of the Institute. During the early fifties, the Rockefeller Foundation made a substantial grant, spread over several years, for the conduct of a research programme in rural demography. By the time this grant period came to an end, the Union Ministry of Health, which had given grants for conducting some specific demographic studies in 1954-57, decided in 1964 to strengthen and expand the research work on population by financing, on a continuing basis, a Population Research Centre as an integral part of the Institute. The Ford Foundation gave very

generous financial assistance for more than a decade beginning in the year 1956. Later, the Foundation, in collaboration with the Planning Commission, provided a separate grant for research and training in the areas of planning and development, mainly devoted to input-output studies. The Planning Commission has also given an endowment grant to the Institute to establish a chair and a unit for promoting teaching, research and informed debate on all issues relating to Planning and Development. The abovementioned chair is named the 'Professor D.R. Gadgil Chair of Planning and Development'.

In 1962, the University Grants Commission recognised the Institute as a Centre of Advanced Study in Agricultural Economics, and later, in 1964 as a Centre of Advanced Study in Economics. In 1977 the UGC, as a part of its Area Studies Programme, established a Centre of Study of the Economies of East European Countries. In the same year, the Reserve Bank of India instituted a chair of finance. In 1989, the Ford Foundation gave a generous endowment grant to fund a chair and to establish a section in international economics to carry out research activities in international economics and related subjects. This grant also included support for the post of a Librarian and for

acquisition of books and journals. Similarly, in 2005, the Kamalnayan Bajaj Trust has given a generous grant to fund a chair of economics.

The University Grants Commission, New Delhi, has sanctioned the Centre for Study of Social Exclusion and Inclusive Policy (CSSE & IP) in 2008 for a period of five years (coinciding with the Eleventh Five Year Plan Period) to carry out research and teaching in the areas of social exclusion, discrimination and inclusive policy (From April 2012, it was extended by another five years for the Twelfth Plan Period).

Teaching

The Institute was initially affiliated to the University of Bombay, conducting the M.A. Programme in economics and supervising the work of students working towards research degrees of that University. In 1949, with the establishment of the University of Poona, the Institute became a constituent recognised institute of the new University. Till 1993 the Institute functioned, for all academic purposes, as the Department of Economics of this University. With the decision of the University to establish a separate Department of Economics at its campus, the Institute, as a Centre of Advanced Study in Economics, was granted effective autonomy in 1986 in designing courses, teaching and examination of the M.A. degree in

economics. As stated earlier, the Institute has been granted the status of a Deemed University by the Government of India with effect from May 9, 1993. The Institute now awards its own M.A. and Ph.D. degrees in economics. After acquiring the new status, the syllabi of the courses offered at the Institute were thoroughly revised on the basis of the recommendations of a committee constituted for the purpose. Courses in the M.A. programmes of the Institute are being regularly updated on the recommendations of Board of Studies and Academic Council. At present the Institute offers three post-graduate programme, viz., M.A. (Economics), M.A. (Financial Economics) and M.A. (Agribusiness Economics).

Training

In April 1989 the University Grants Commission selected the Institute and extended assistance to it for conducting refresher courses in economics for in-service university and college teachers from the western region of the country. In 1994, a year after the grant of Deemed University status to the Institute, the UGC extended the

catchment area of the Institute for its refresher courses to the entire country. Since the inception of this scheme by the UGC, the Institute has been conducting UGC - sponsored refresher courses for university and college teachers as well as workshops for government servants and others from across the country from time to time.



Research Centres at the Institute

The Institute has three research centres established by the Central Government and University Grant Commission.

Agro-Economic Research Centre (AERC)

The Agro Economic Research Centre (AERC) Pune, was established by the Union Ministry of Food and Agriculture in 1954. It has been an integral part of the Institute right since its inception.

In 1962, on the basis of the quality and extent of work done by the GIPE, its professional reputation, its contribution to research in agricultural economics and its potentiality for further development, the University Grants Commission selected it as a Centre of Advanced Study in Agricultural Economics. Two years later the field of study of the Centre was expanded and it was redesignnated as the Centre for Advanced Study in Economics.

The Centre also conducts studies allotted to the Institute by various agencies such as the Government of Maharashtra, NABARD and Planning Commission, Government of India.

The AERC has completed about 160 studies since its inception. Its activities are Farm Business Surveys, Studies related to Irrigation, Watershed Management, Rural Electrification, Village Surveys, Rural Credit, Agricultural Tenancy, Cooperation, Droughts and Famines, Crop Insurance, Agricultural Marketing, Agricultural Exports, Poverty Alleviation, etc.

A large number of these studies have made significant contributions to the field of agricultural economics and agricultural development of the country. These studies have been widely recognized by policy-makers and academicians and serve as benchmarks of excellence in their respective fields.

Population Research Centre (PRC)

'Population Studies' at the Institute predate the formulation of population policy, establishment of the family planning programme by the Government of India and founding of Population Research Centres by it. The Institute has played a pioneering role in conducting demographic surveys in India.

A demographic survey of Kolhapur city in 1945 made a lasting contribution towards evolving and establishing a standardized methodology of demographic surveys. A research centre in demography was set up at the Institute in 1949. This was the first of its kind in the country. The Union Ministry of Health and Family Welfare had given grants to the Institute for conducting specific studies during 1954-57. In 1964, the Ministry decided to strengthen and extend the research work on population by establishing a Demographic Research Centre as a part of the Institute. In 1978-79, in pursuance of the recommendations of the Demography Advisory Committee, the Centre was re-designated as a Population Research Centre for the State of Maharashtra. It has earned the distinction of being included in the category of 'fully

developed' centres according to the norms of the Ministry of Health and Family Welfare.

In the 'fifties, when no information on demographic issues was available, the Centre started its work by conducting demographic surveys and thus contributed in a major way to the area of survey methodology. After the launch of the family planning programme at the official level, the Centre contributed by actively participating in the implementation of the sterilisation programme and by undertaking communication-cum-action studies. Evaluation of the after-effects of vasectomy camps and acceptance of the loop as an IUD gave valuable inputs about the methods of family planning.

Various dimensions of the family planning programme at its different stages, starting with its communication methods and including several of its other aspects such as compulsion during the emergency, adoption of spacing methods, maternal and child health, withdrawal of the targets, RCH approach of the programme, RTI/STI, client satisfaction and unwanted pregnancies have been

studied by the Centre. The work of NGOs in the field of family welfare has also been evaluated. In recent years, evaluation of the sterilisation bed reservation scheme, functioning of family welfare training institutions, ultrasound sonography centres and urban health posts has been carried out.

In the area of data collection on a wide scale, the Institute has independently carried out or participated in major surveys in 1980s and 1990s (NFMS, 1980; NFHS, 1992-93; and RCH Baseline Survey, 1998). Apart from evaluative and fact-finding surveys, many analytical studies are carried out. Recently a study on the cost of health care in

public hospitals in Maharashtra was completed. The Centre has just completed two rounds of a World Bank-sponsored research study on the quality of health care (client and provider satisfaction) in India/Maharashtra. The demography of India's tribal population is another recently completed research project. Currently, the Centre is involved in activities related to the strengthening of the Health Management Information System (HMIS), a new initiative of the Ministry to collect the district and facility level health data on a monthly basis.

Centre for the Study of Social Exclusion and Inclusive Policy (CSSE&IP)

CSSE&IP is a multi-disciplinary research centre established by the UGC in the year 2008 (as part of the Eleventh Plan) to carry out research and teaching in the areas of social exclusion, discrimination and inclusive policy. Its key objective is to conceptualize and define problems

related to discrimination, exclusion and inclusion based on caste, ethnicity and religion. It focuses on developing an understanding of the nature and dynamics of exclusion and discrimination at both theoretical and empirical levels.

Besides these three centres, the Institute also houses four prestigious Chair Professorships, viz.,

- 1. RBI Chair Professor of Finance whose unit conducts research and teaching in Monetary and Financial Economics (Funded by Reserve Bank of India).
- 2. D.R. Gadgil Professor of Planning and Development (Funded by Planning Commission of India).
- 3. Ford Foundation Professor of International Economics (Funded by Ford Foundation).
- 4. Kamalnayan Bajaj Chair Professor of Industrial Economics (Funded by Kamalnayan Bajaj Foundation).

- Two-Day International Workshop on "Simulated Structure of Organized Retailing in Food and Grocery: Implications on Consumers' Preference and Trade", organized Jointly by the Institute and International Food Policy Research Institute, New Delhi on January 24-25, 2012.
- 2. 16th International Conference of the Indian Input Output Research Association (IORA), India was held in the Institute on 6-8 March 2012. The Conference was inaugurated by Prof. Kirit Parikh, Chairman, Integrated Research for Action and Development and Former Member, Planning Commission, Government of India. In all, 53 papers were presented by 45 participants in the Conference spreading across VII Technical Sessions. The Valedictory Address was delivered by Prof. S.R. Hashim, Former Member of Planning Commission, Government of India. The Conference was attended by about 300 delegates. The Technical Sessions dealt with economic theoretical and inter-industry frameworks, economy-wide studies and emerging sectors impact studies to interindustry frameworks, and a brainstorm session on India vs. Maharashtra Regional Disparities to be bridged through implementation of the latest Finance Commission's recommendation. The presentation and discussions motivated further researches, and relevant findings of the studies were recommended.
- 3. The Institute organised the Data Dissemination Workshop on "Houselisting and Housing Census Data 2011 (Maharashtra)" jointly with the Directorate of Census Operations, Maharashtra, on March 29, 2012. About 150 participants representing university departments, research institutions, colleges, NGOs and government departments participated in it. The workshop was inaugurated by Prof. Rajas Parchure, Offg. Director. The key note address was delivered by Shri Ranjit Singh Deol, IAS, Director, Census Operations, Maharashtra. Dr. Medha Deshpande, Professor of Economics, SNDT University chaired the technical session. Presentations on various aspects of data on Housing Census 2011 were made by the researchers from the Institute, and officials from Directorate of Census Operations and NGOs. The workshop provided an opportunity for interaction among college teachers, researchers, NGOs, and Ph.D. students to deliberate upon various aspects concerning housing conditions in Maharashtra and the housing census data released by the Directorate of Census Operations. The workshop was sponsored by the Directorate of Census Operations, Maharashtra. The Population Research Centre of the Institute was instrumental in arranging the workshop.



- 4. On occasion of the Birth Anniversary of Dr. S.R. Ranganathan, GIPE Library organized a National Seminar on "Perspectives of Library and Information Science Research in India towards 2020" on August 09, 2011. More than 250 professionals including teachers and librarians from different parts of Maharashtra participated in it. 

Library Services

The Institute shares the Servants of India Society's Dhananjayarao Gadgil Library and has been mainly responsible for developing it during the last eight decades. It is considered to be one of the foremost specialised libraries in India in the fields of economics and related social sciences. It has 2,71,861 books and 370 journals and serials received on subscription, exchange, gift, and depository basis. It has completed its automation programme and Web OPAC linked from the Institute's website.

During 18 May – 30 June 2011, the stock verification of the entire collection in the Library was carried out and the data were updated accordingly on the library management system SLIM. It had also initiated the process of barcoding and pasting spine labels on the books and completed the same by March 2012.

In the month of December 2010, the Library started its Institutional / Digital Repository (IR) http://dspace.gipe.ac.in and by March 2012 more than 5,000 digitised books were made freely accessible online.

With a view to making known the addition of books to the Library and the contents of the latest journals received, two fortnightly lists, namely, Fortnightly List of Additions and Fortnightly List of Articles on India are brought out regularly and circulated in mimeograph form.

During the academic year 2011-2012, the Library subscribed to 370 periodicals which included 193 Indian journals and 177 foreign journals. The details are given below:

The Computer Centre

The statistical department helps the statistical research team at GIPE, which aids faculty members, researchers and students alike with their data analysis tasks.

The Computer Centre housed in the Statistical Department is well-equipped with hardware and software to support the research, teaching and training programmes of the Institute. A one-year Certificate Course on Computer Applications for Economic Analysis has been introduced for the past and present M.A. and Ph.D. students of the Institute to complement the training in economics received by them at the Institute. The students are equipped with the latest analysis/analytical tools such as STATA, EVIEWS, SPSS,

MATHEMATICA, etc., in a specially designed certificate course which adds value and insight to theoretical learning.

In the computer laboratory, students have access to the internet both for reference work and communication. The most up-to-date resources for these purposes are at hand as the Institute subscribes to superior resource websites such as Britannica, JSTOR, Indiastat, Springer link, etc.

Consultancy and guidance services in data processing in collaboration with the Indian Council of Social Science Research

In the Computer Section, facilities for data processing are available to researchers. The Institute offers consultancy and guidance services in data processing in collaboration with the Indian Council of Social Science Research.



Publications

The Institute has been regularly publishing a quarterly journal of economics in English, Artha Vijnana, since March 1959. This journal publishes results of research work carried out in the Institute as well as works of scholars from outside the Institute after a rigorous refereeing process. The journal achieved an important milestone in 2008 by completing its 50th year of continuous publishing. To celebrate the occasion, the Institute

brought out a Golden Jubilee Special Issue of the Journal (Vol. 50, No. 4, December 2008). The Institute also publishes research works in the form of working papers, books and mimeograph series. The R.B.R.R. Kale Memorial Lecture, organised by the Institute every year on the occasion of the Founder's Day, is published under the Kale Memorial Lecture Series.



Staff Quarters and Hostels

The Institute has its own residential campus, about 700 meters away with staff quarters for accommodating both teaching and non-teaching members of the staff. It has also hostel facilities for male as well as female MA / Ph.D. students.

Its strategic location with respect to the Institute and the city ensures minimum wastage of time and resources in commuting and provides the faculty members and students a peaceful environment in which to pursue their research or class work. However, the importance of recreation is also fully


